(57) **CLAIM**

The ornamental design for a sandal, substantially as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a sandal, showing one embodiment of our new design.

FIG. 11 is an elevational view of a medial side thereof.

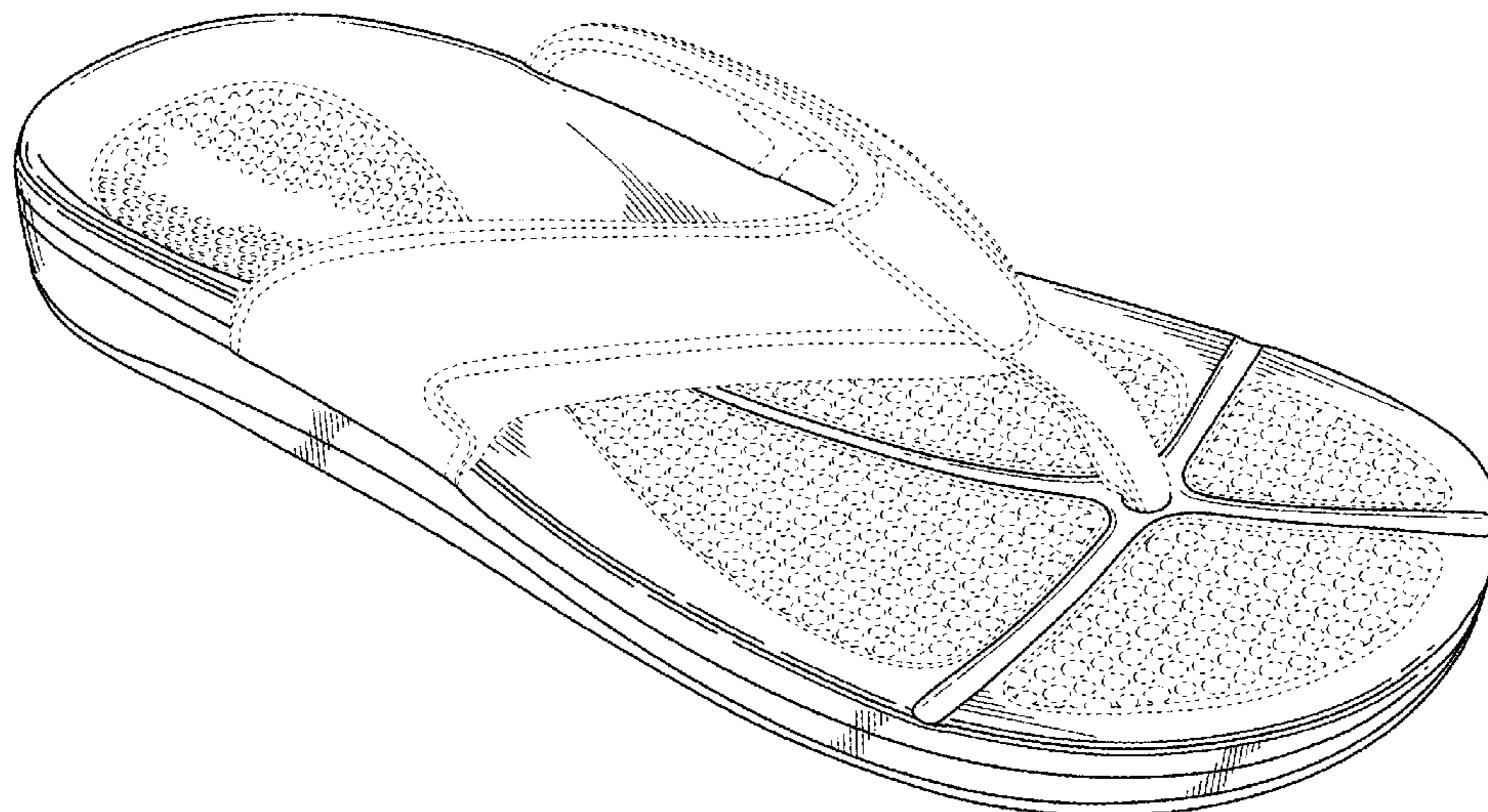
FIG. 12 is a bottom plan view thereof.

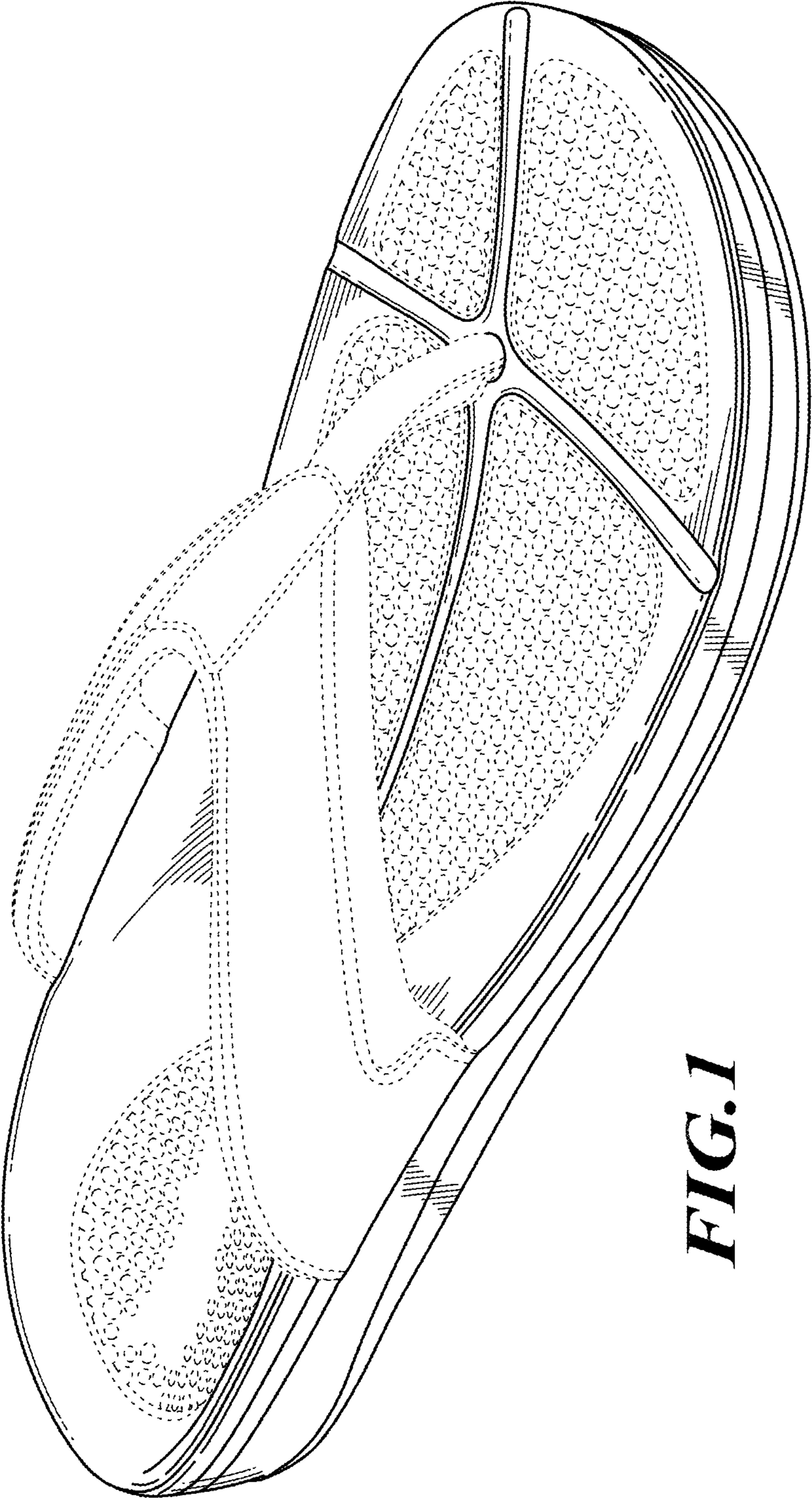

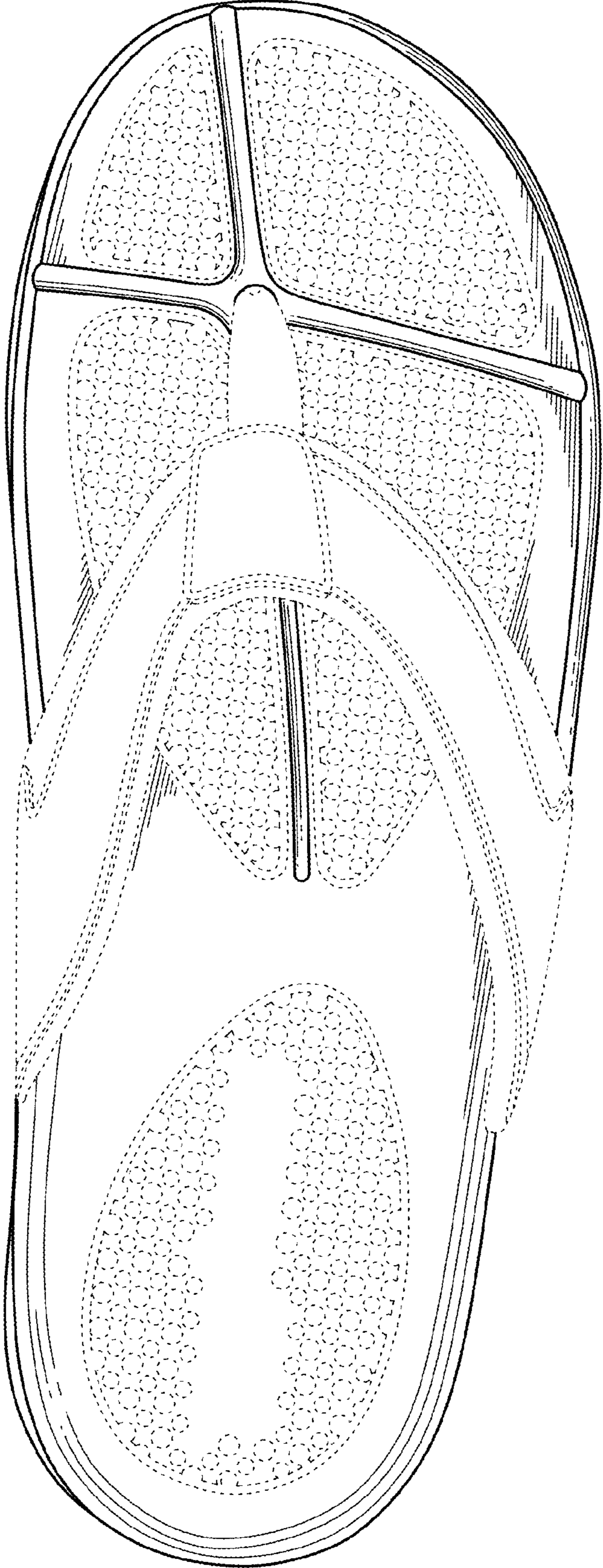

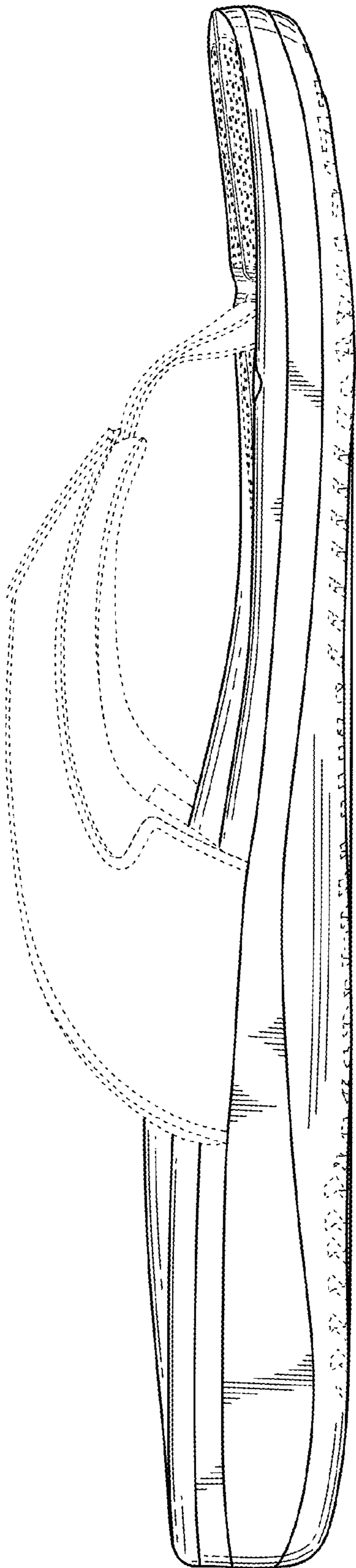

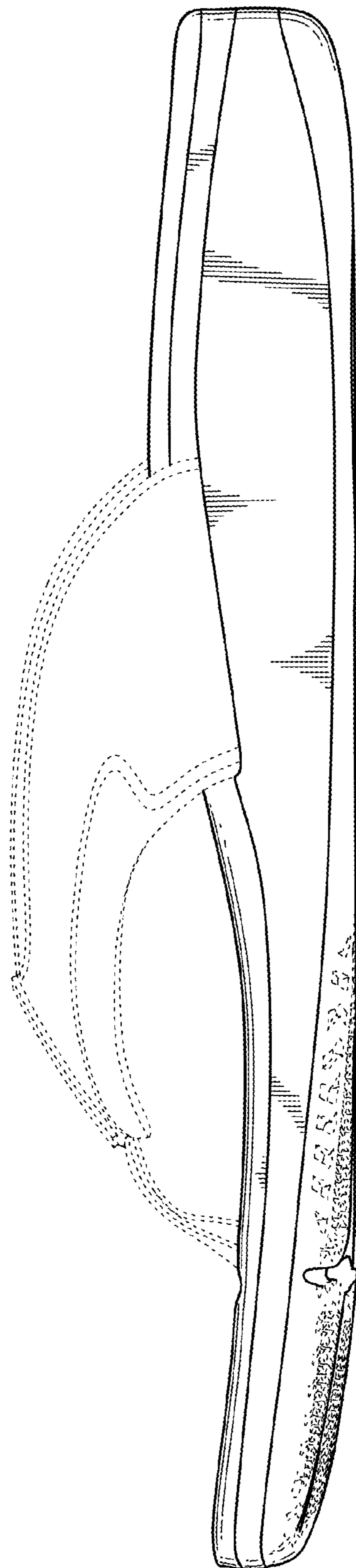

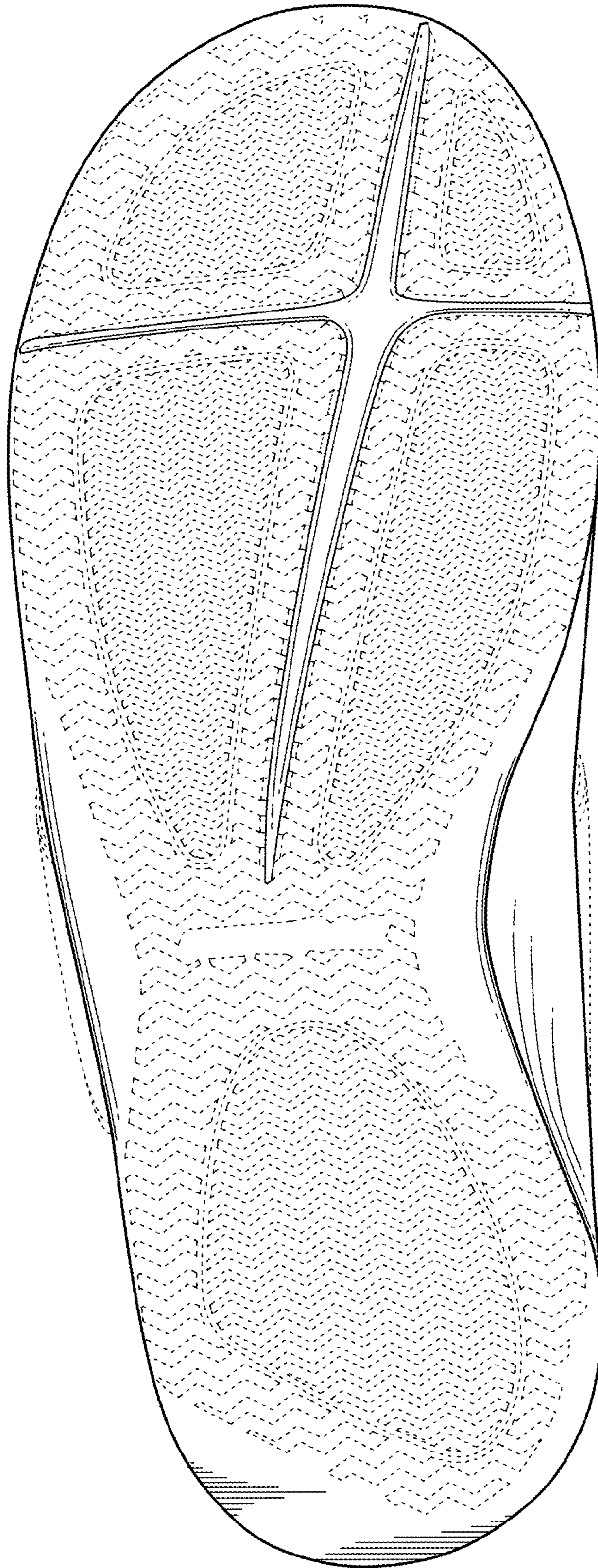

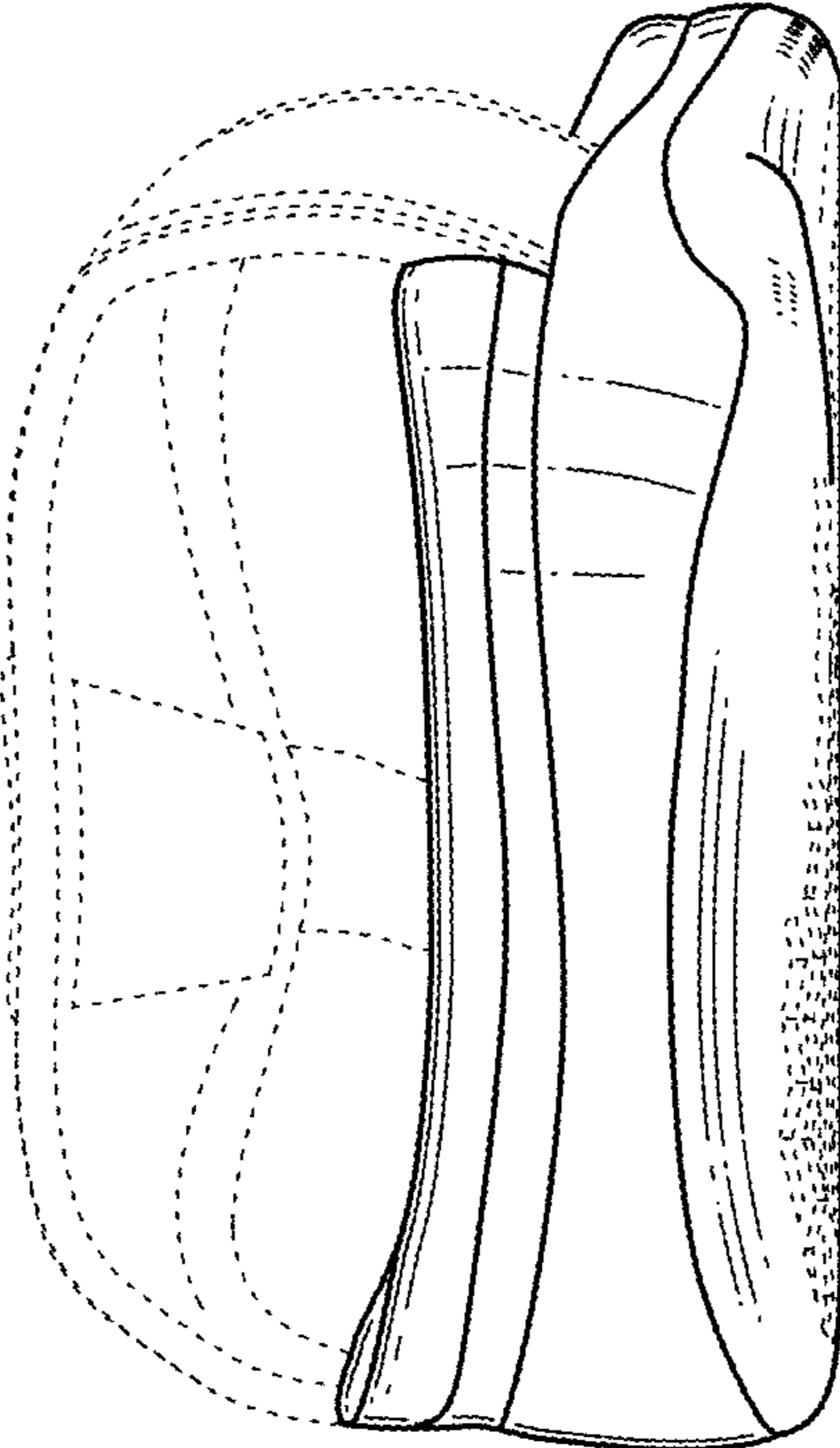

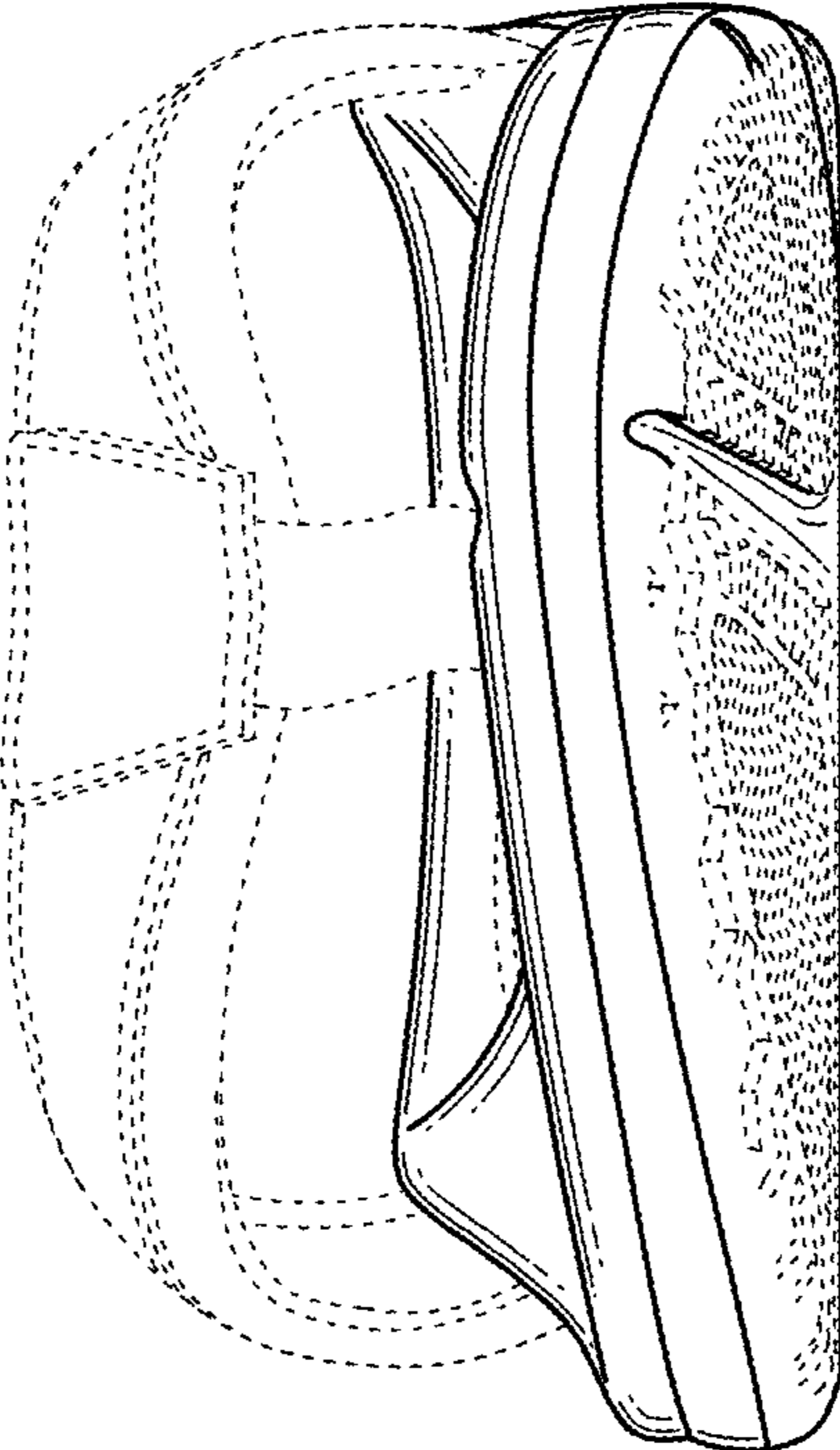

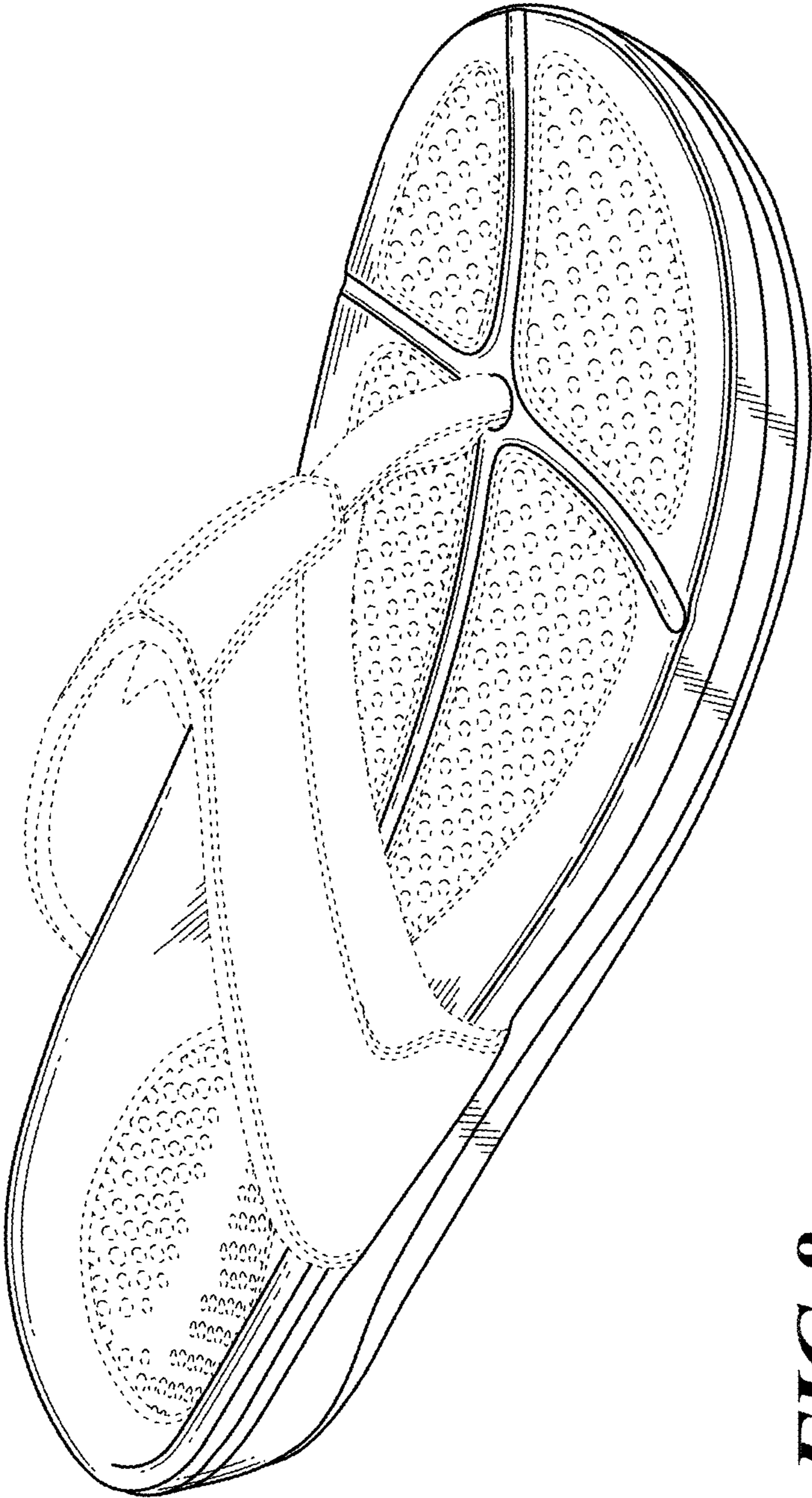

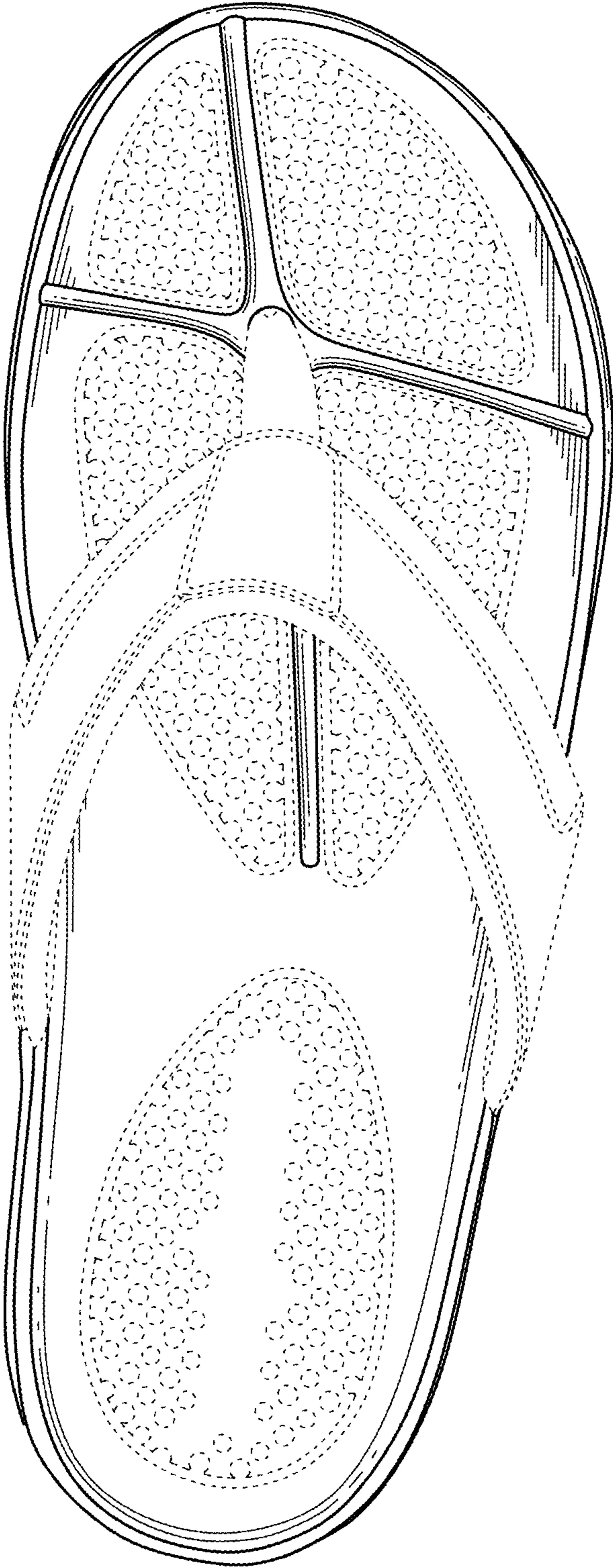

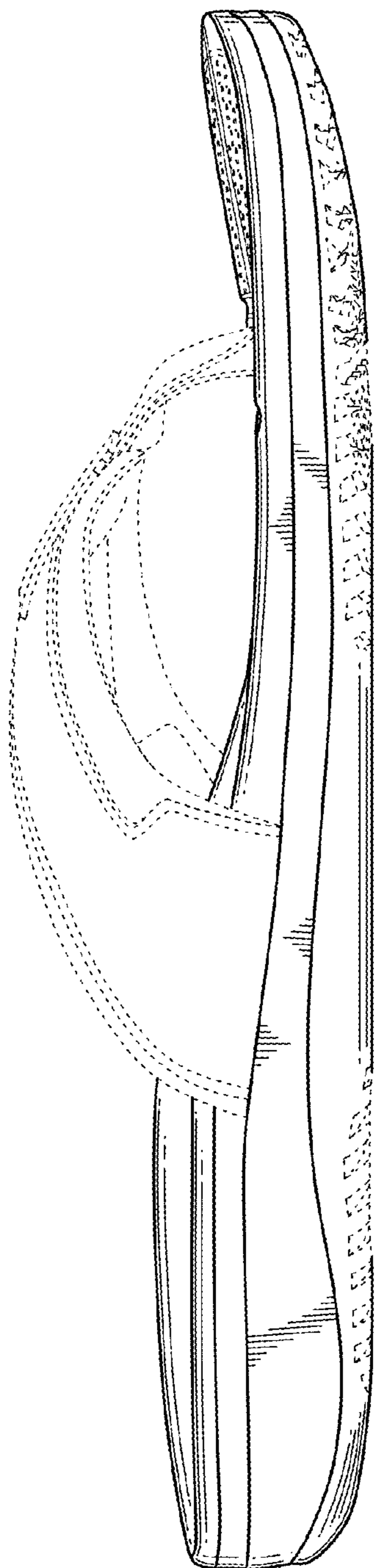

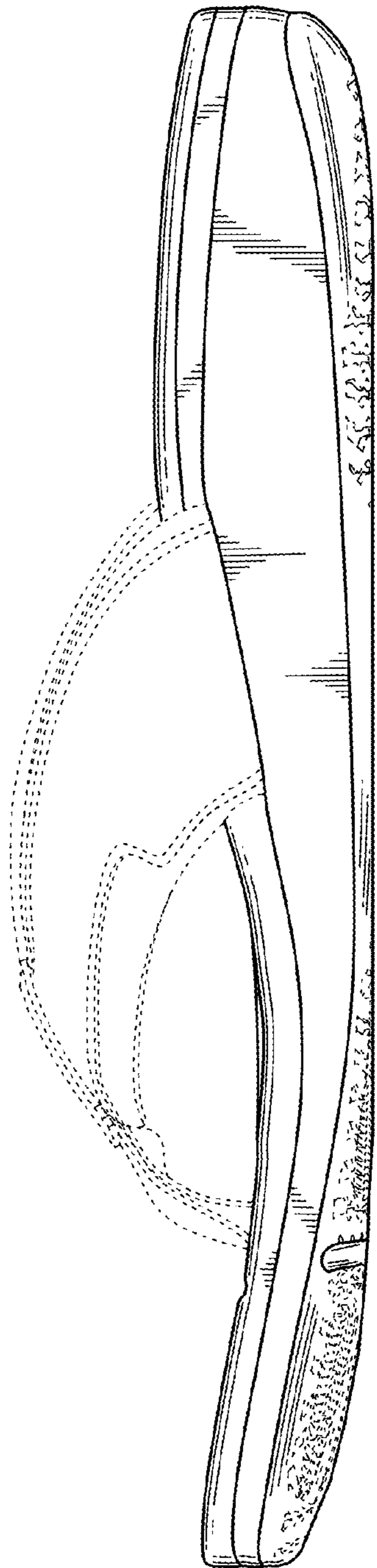

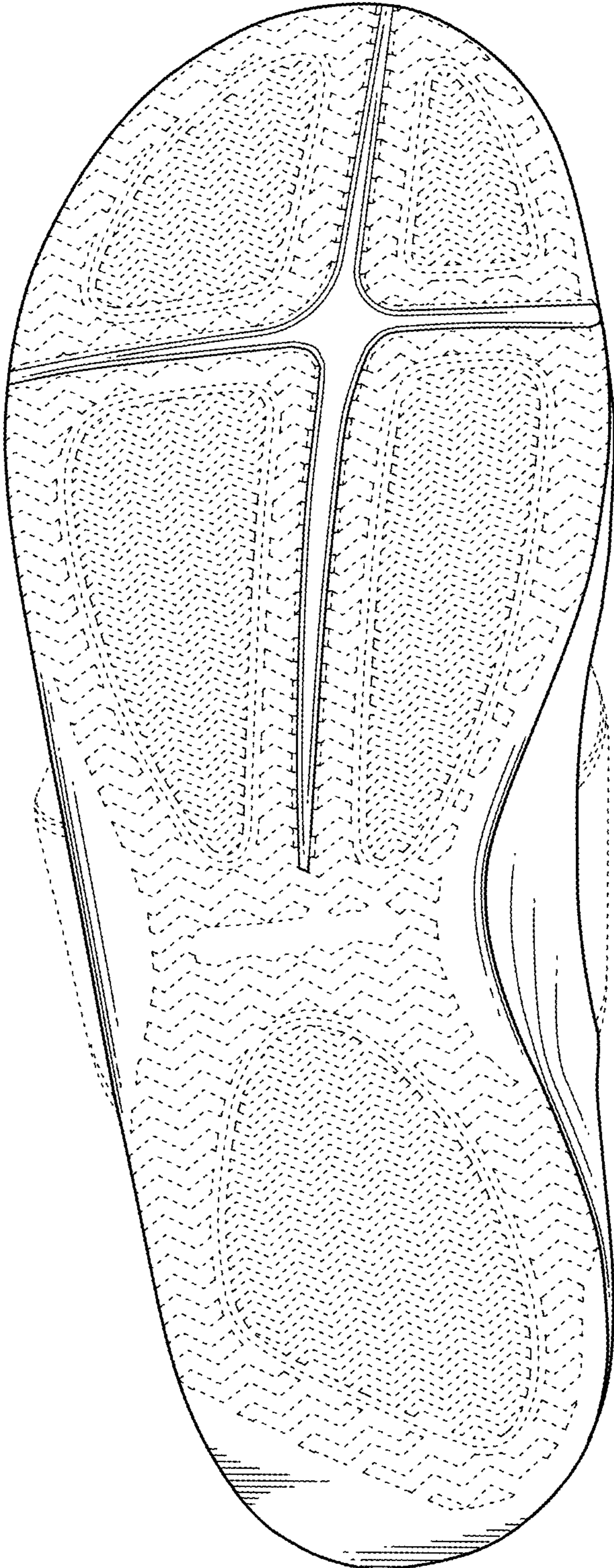

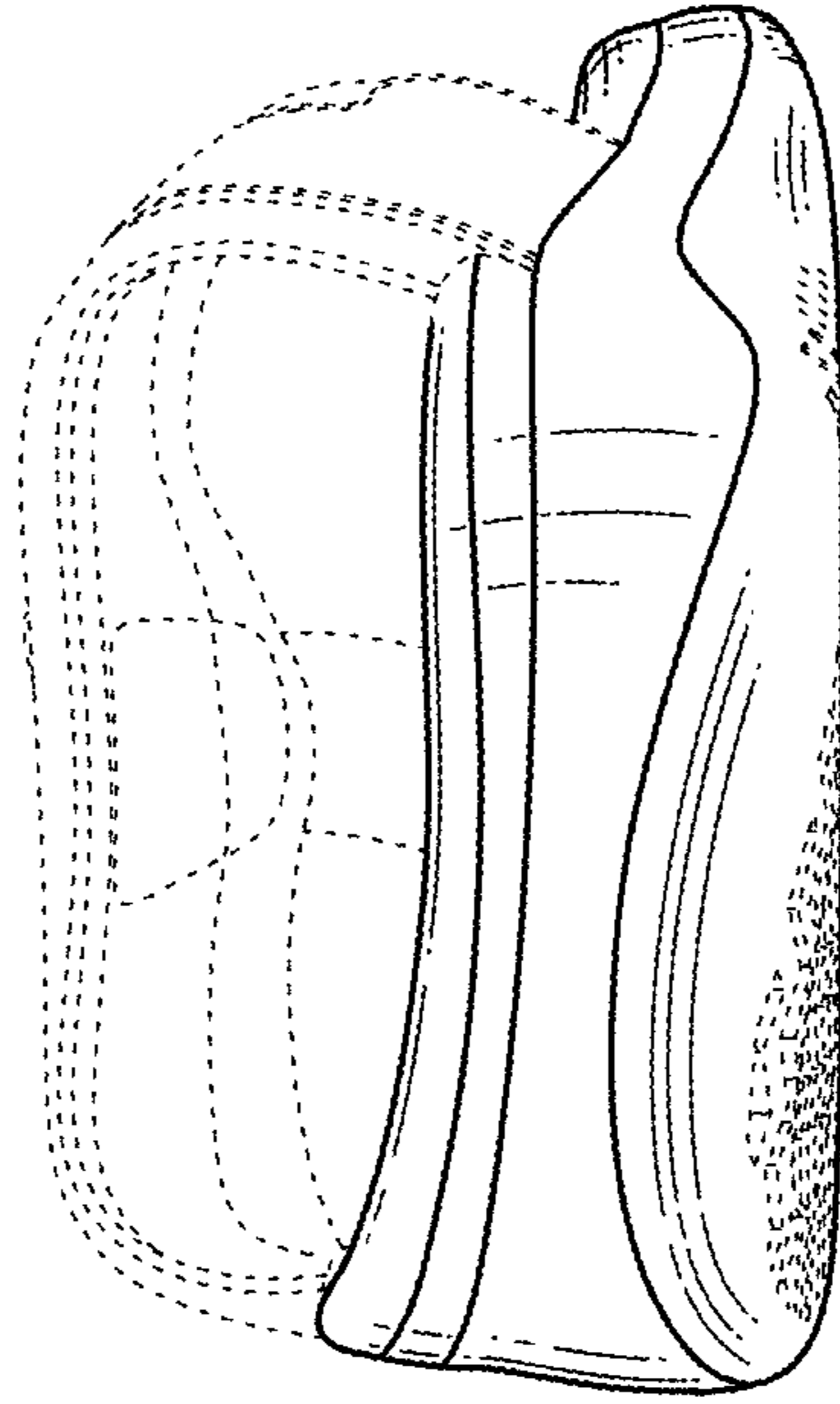

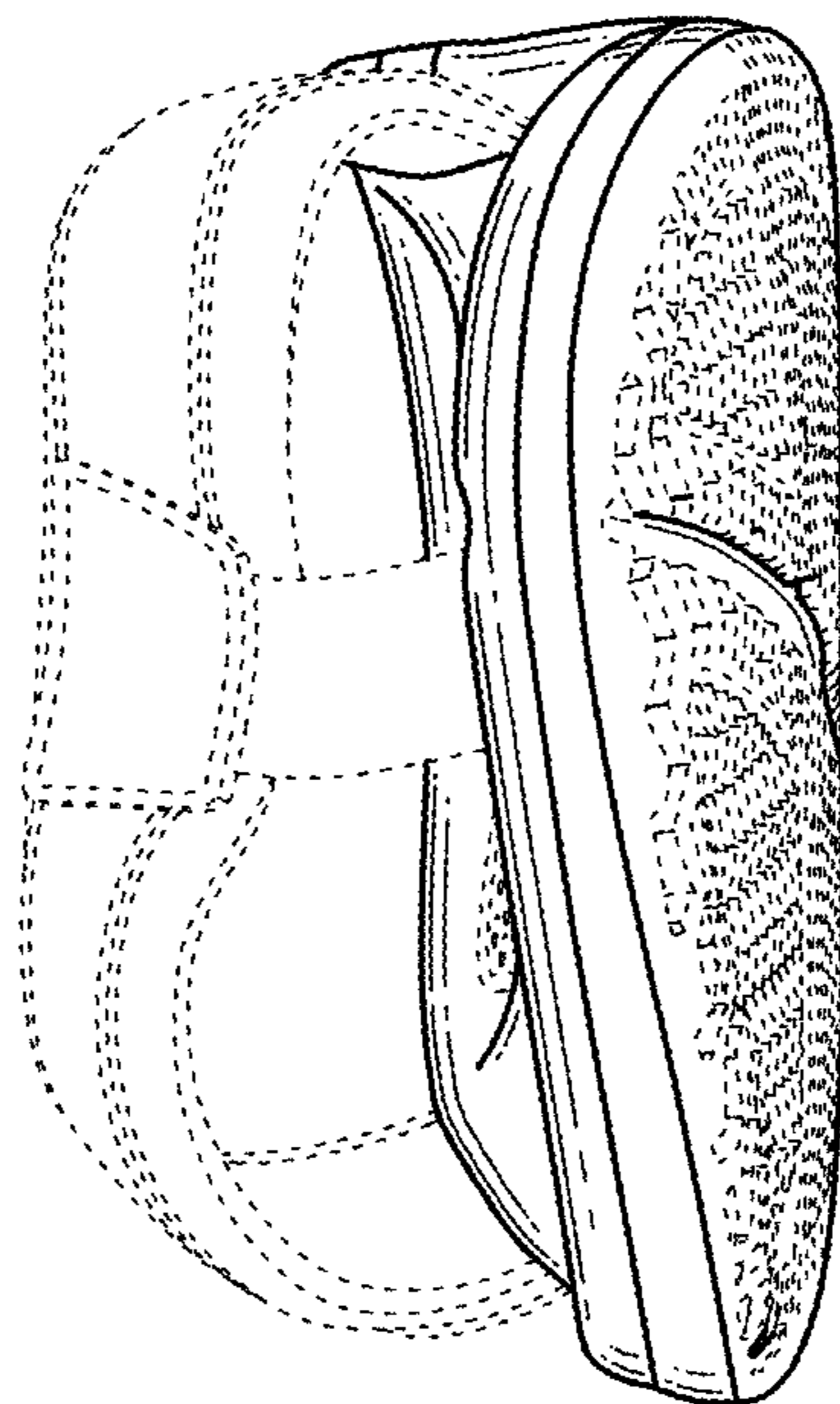
