(57) **CLAIM**

The ornamental design for an umbrella, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an umbrella embodying my new design; the rear view being identical to FIG. 1;
 FIG. 2 is a left side view of the umbrella of FIG. 1; the right side view being identical to FIG. 2;
 FIG. 3 is a top view of the umbrella of FIG. 1;
 FIG. 4 is a bottom view of the umbrella of FIG. 1;
 FIG. 5 is an upper left perspective view of the umbrella of FIG. 1; an upper right perspective view being a mirror image of FIG. 5;
 FIG. 6 is an enlarged view of portions of the upper left perspective view of the umbrella shown in FIG. 5; and,
 FIG. 7 is refracted front view of the umbrella of FIG. 1.

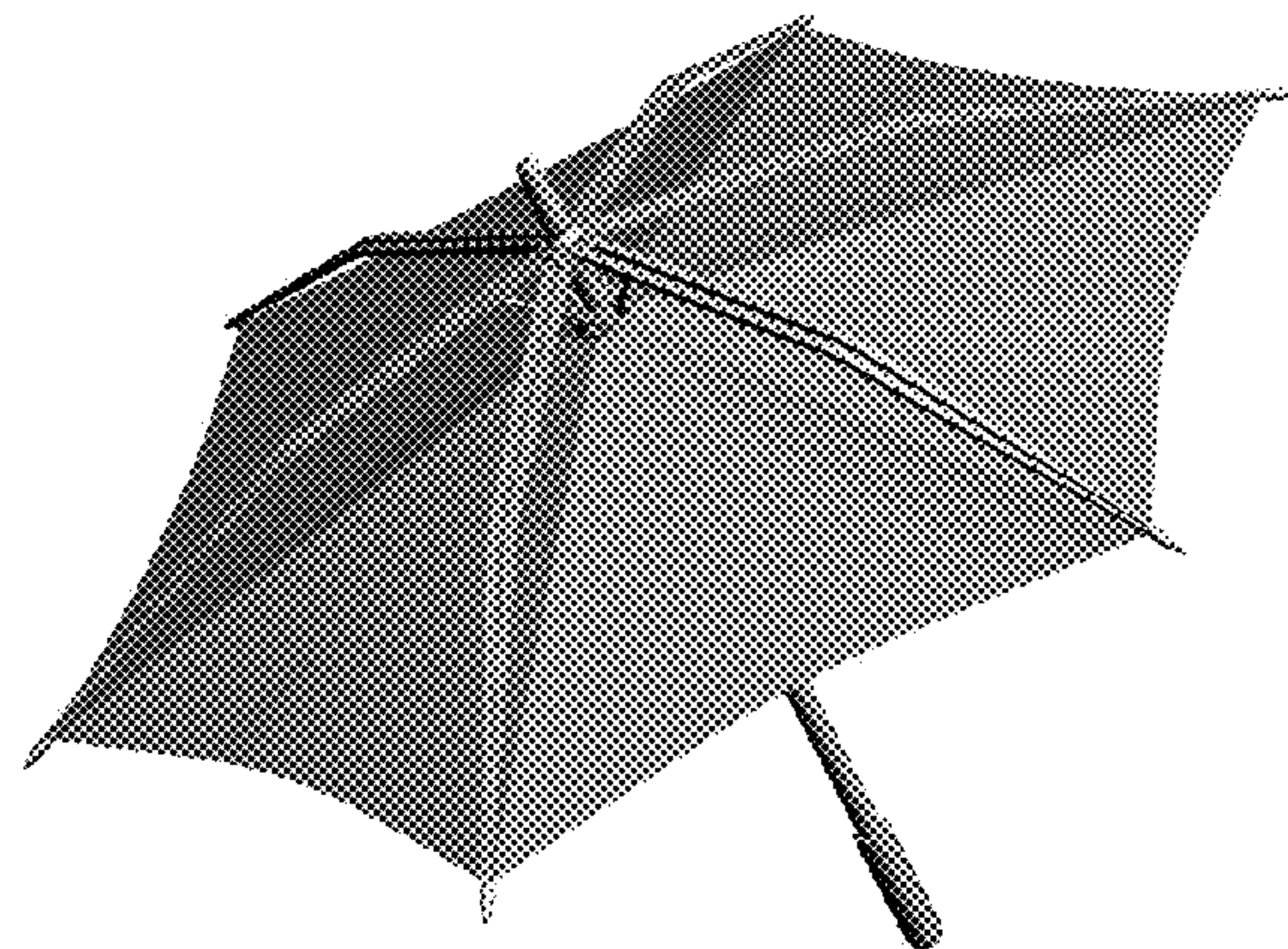
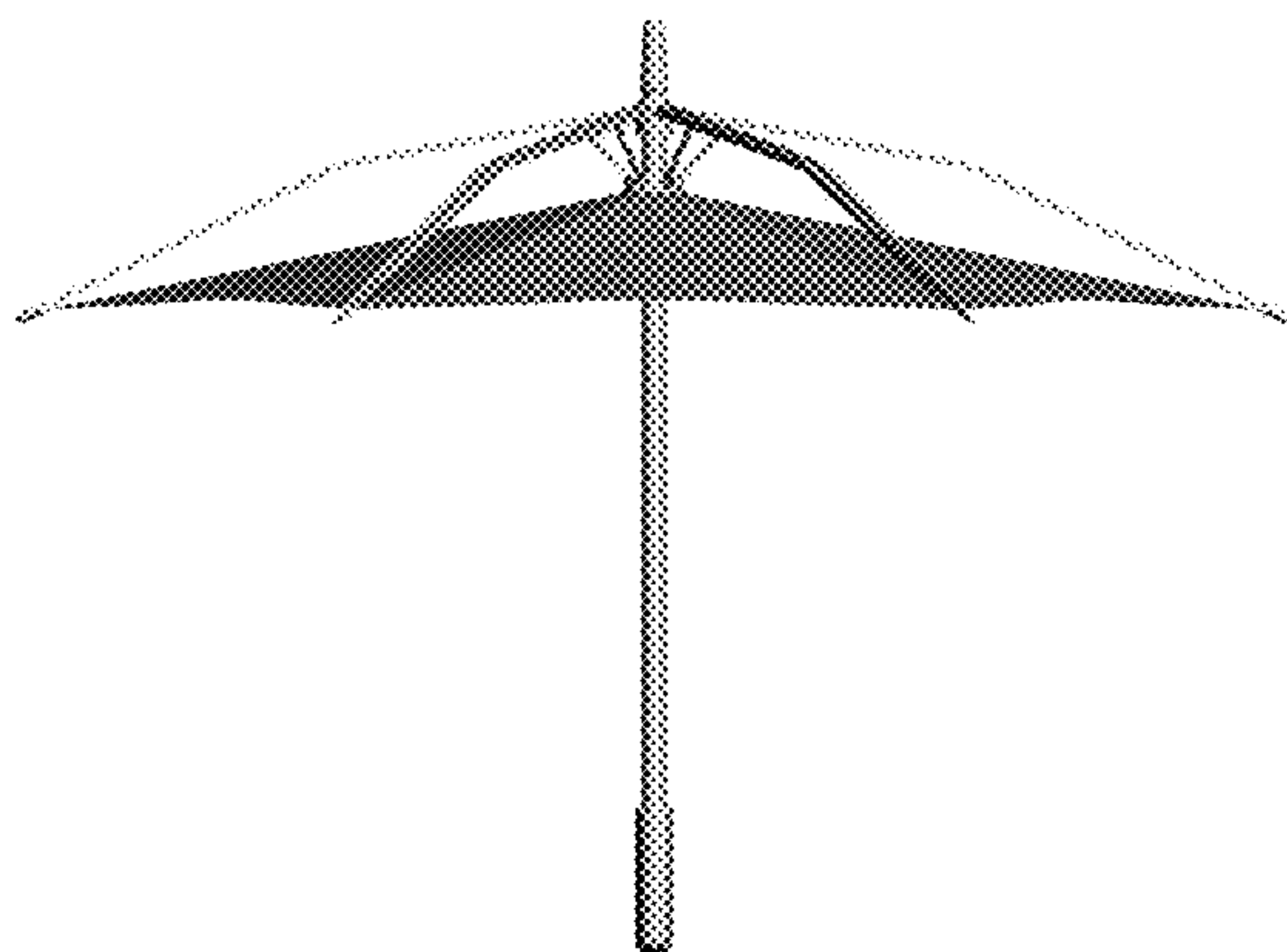

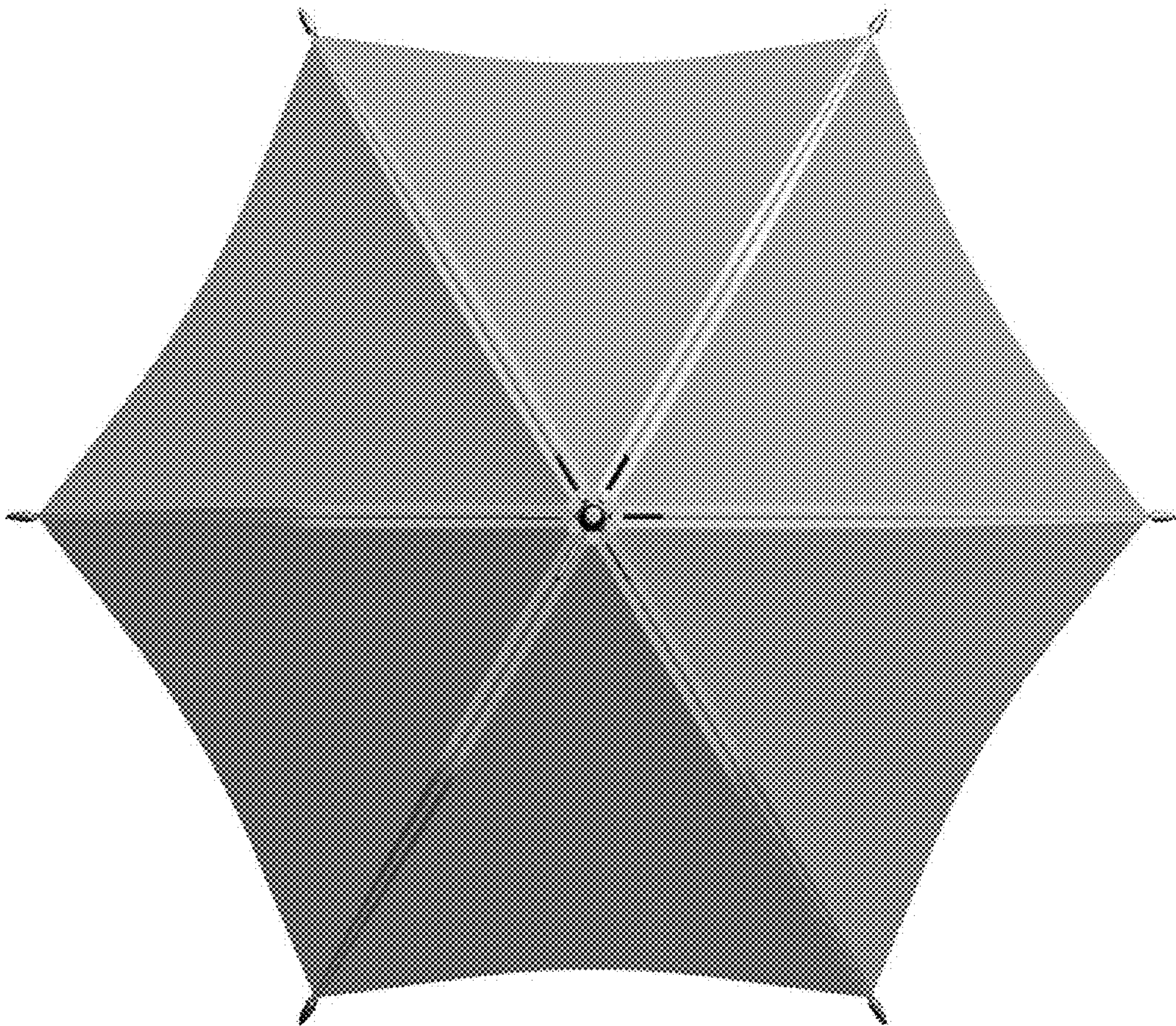

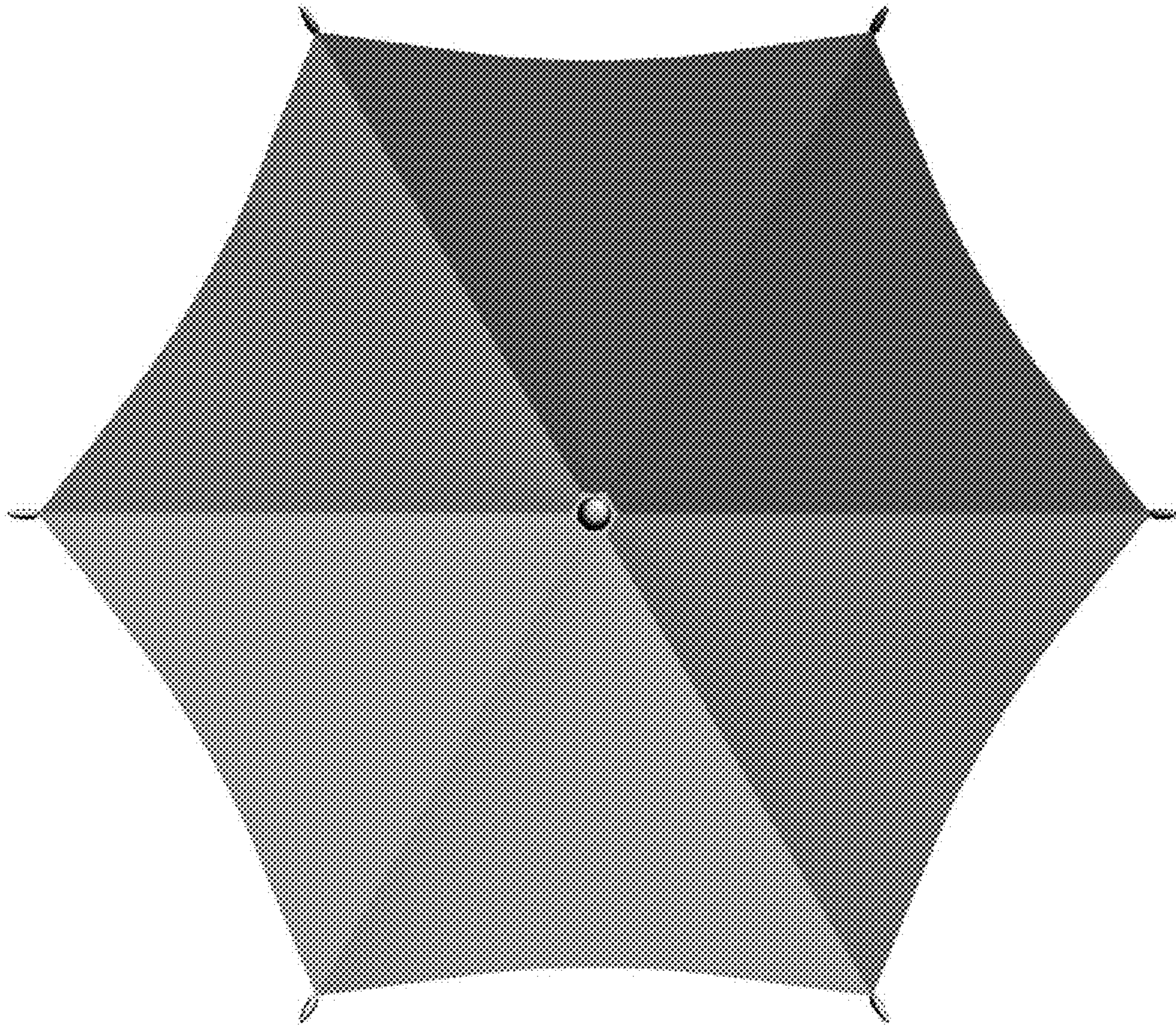
