(57) **CLAIM**

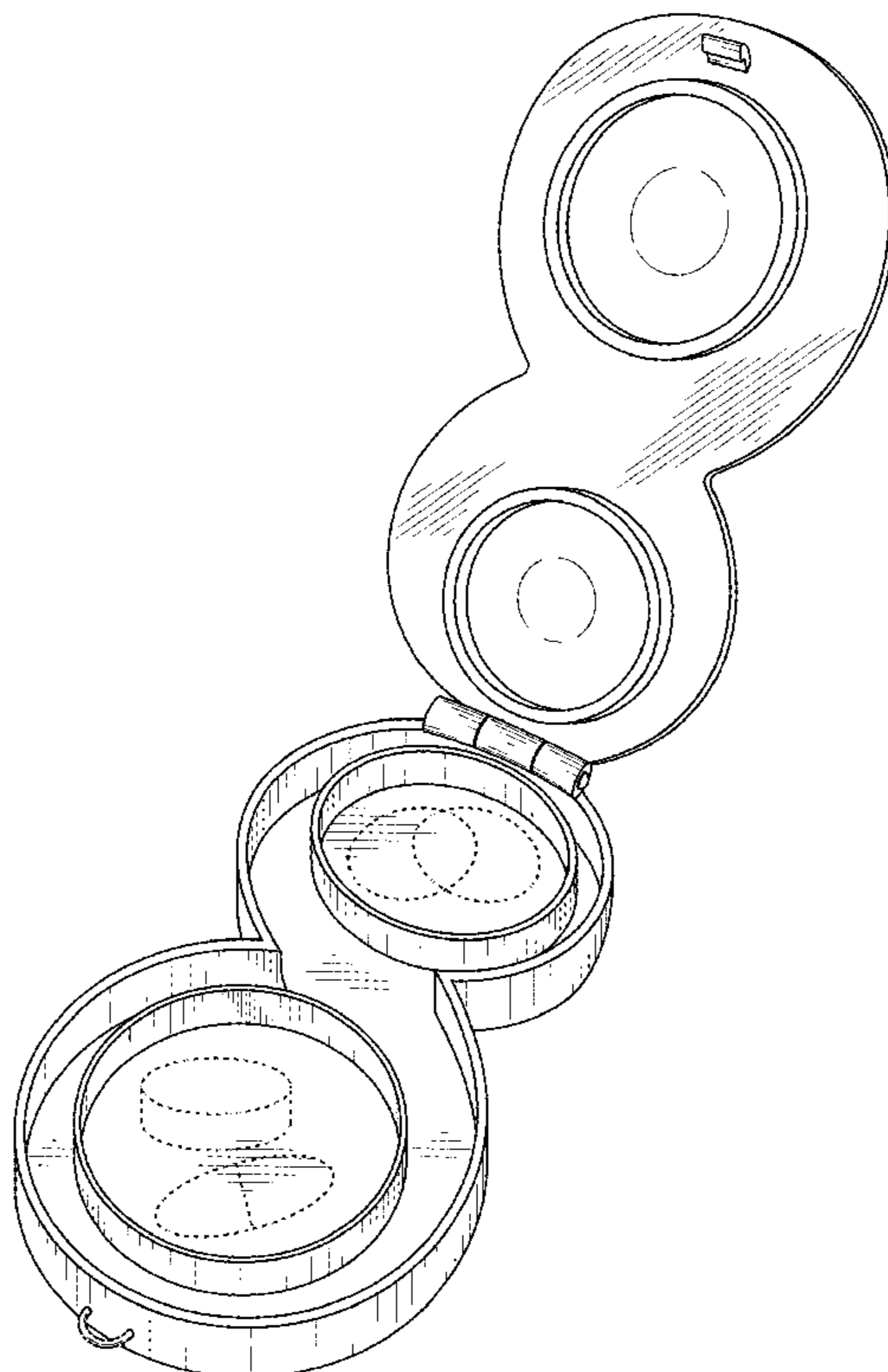
We claim the ornamental design for a pill holder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pill holder, showing our new design in an open configuration;
FIG. 2 is a perspective view thereof, illustrated in a closed configuration;
FIG. 3 is a left-side elevational view of FIG. 2;
FIG. 4 is a right-side elevational view of FIG. 2;
FIG. 5 is a front elevational view of FIG. 2;
FIG. 6 is a rear elevational view of FIG. 2;
FIG. 7 is a top plan view of FIG. 2; and,
FIG. 8 is a bottom plan view thereof.

The broken lines showing pills in FIG. 1 and an attachment pin in FIGS. 2-6 depict environmental matter and form no part of the claimed design.

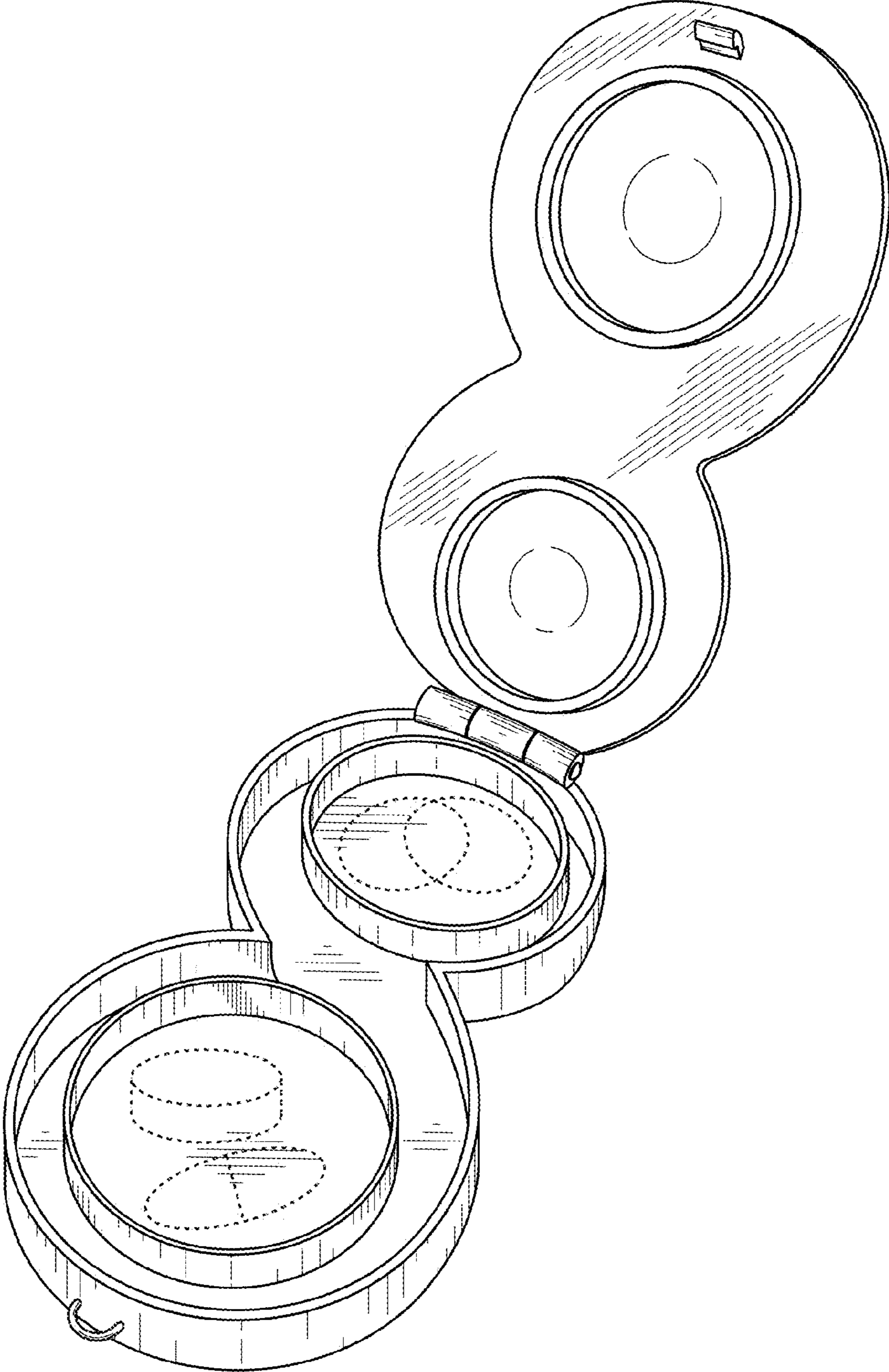

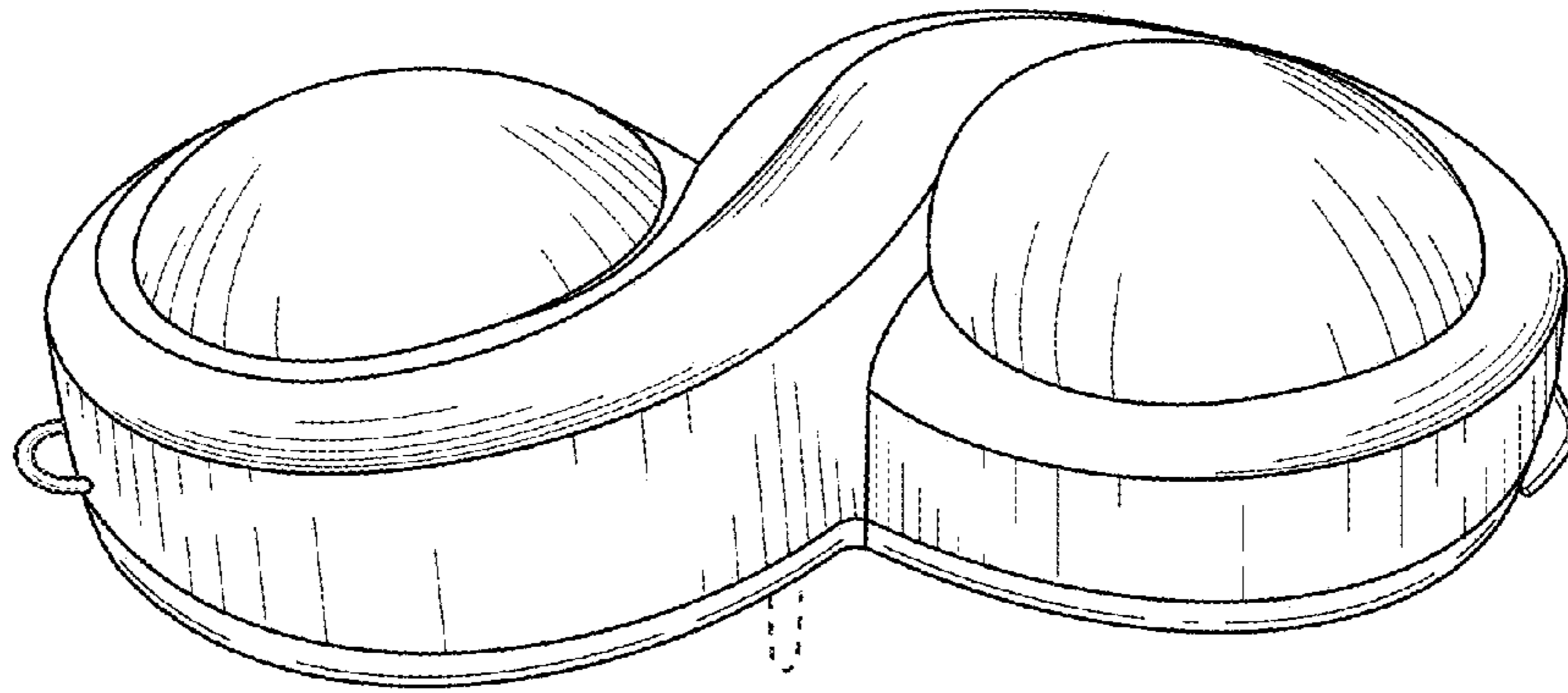

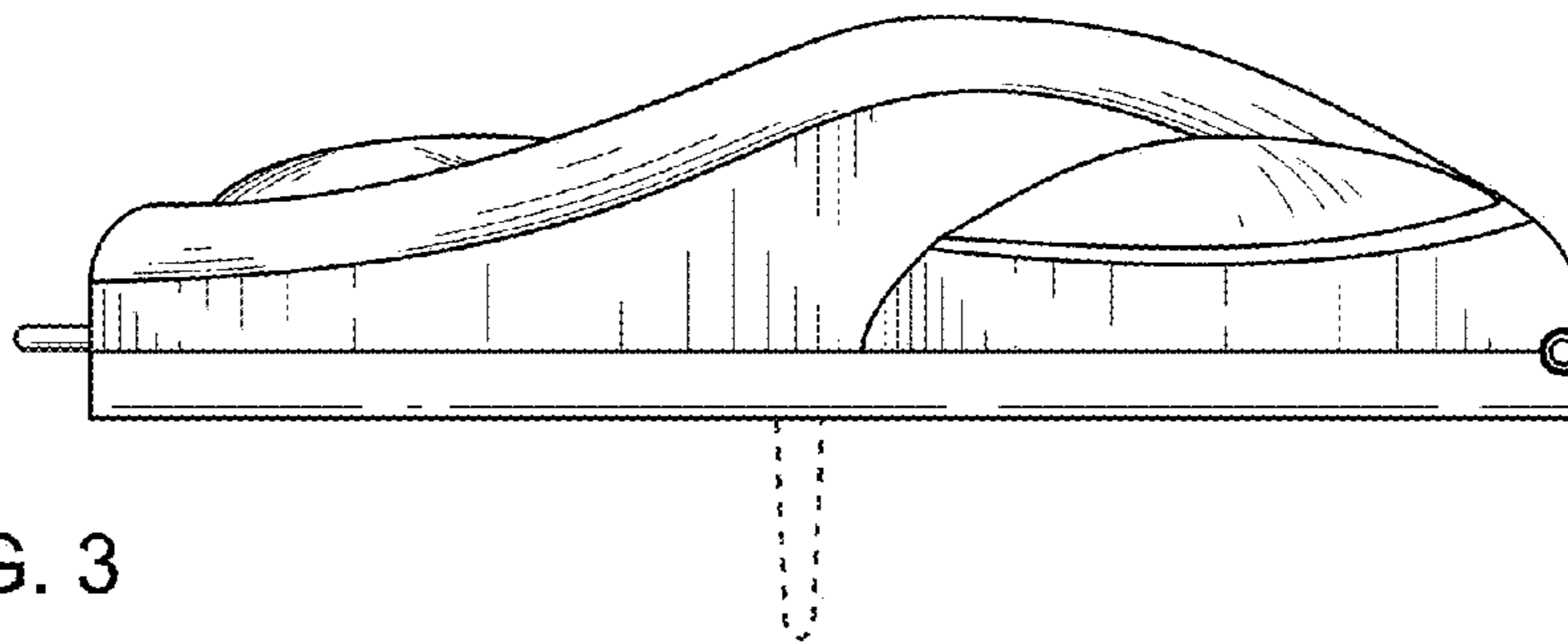

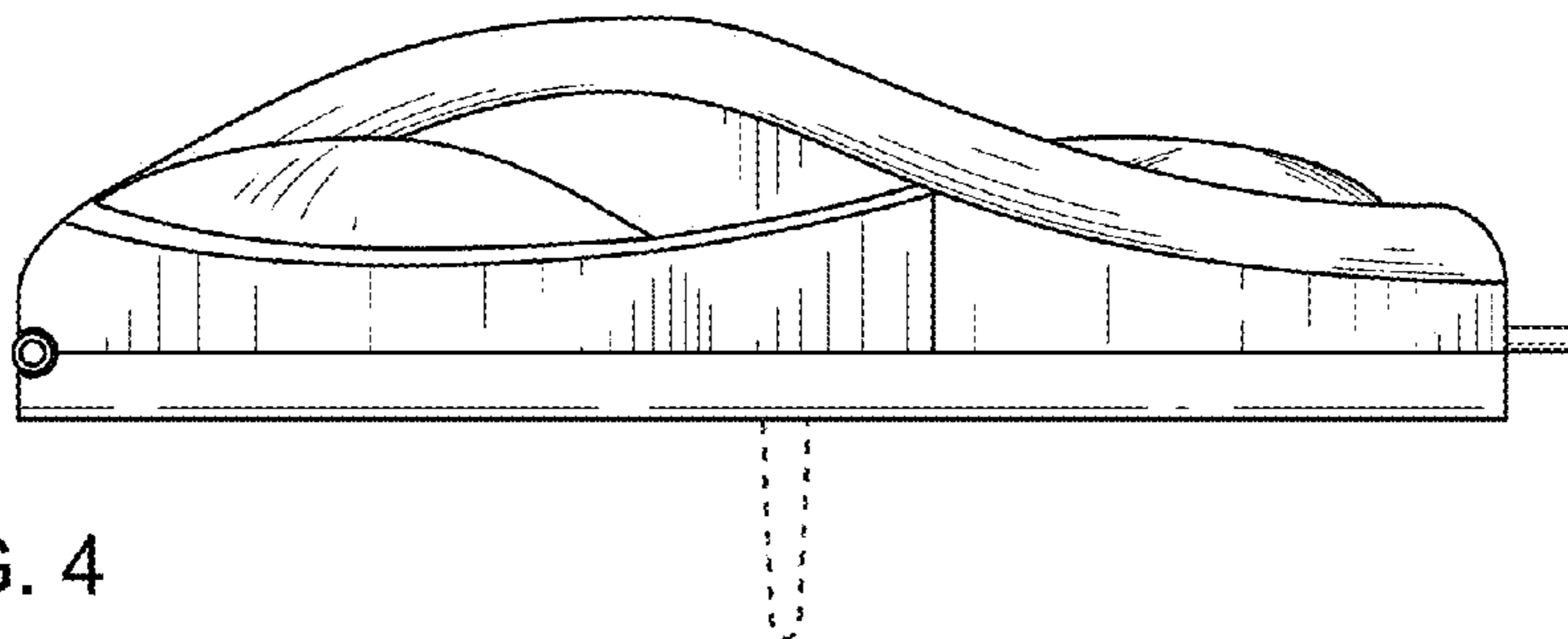

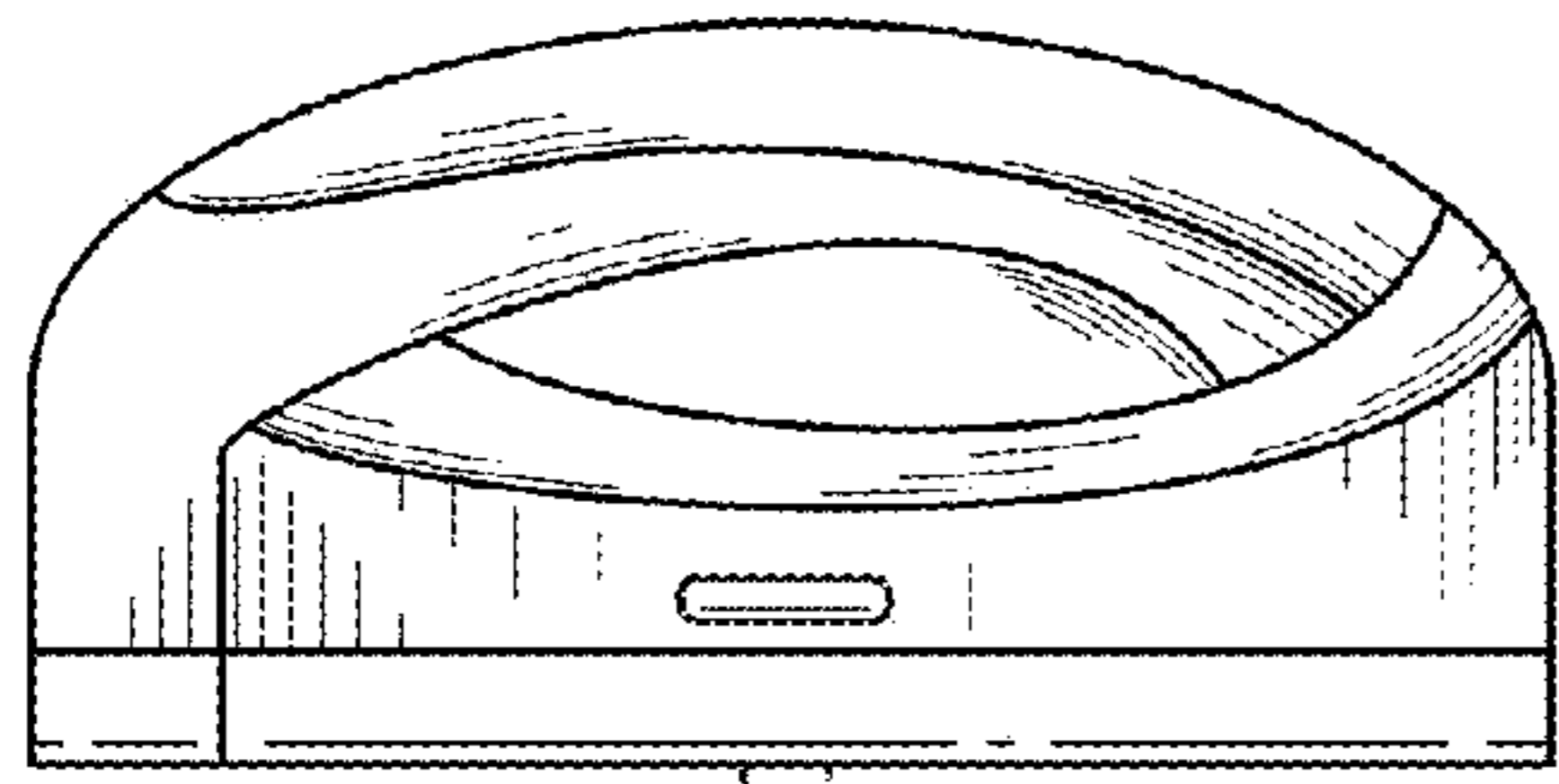

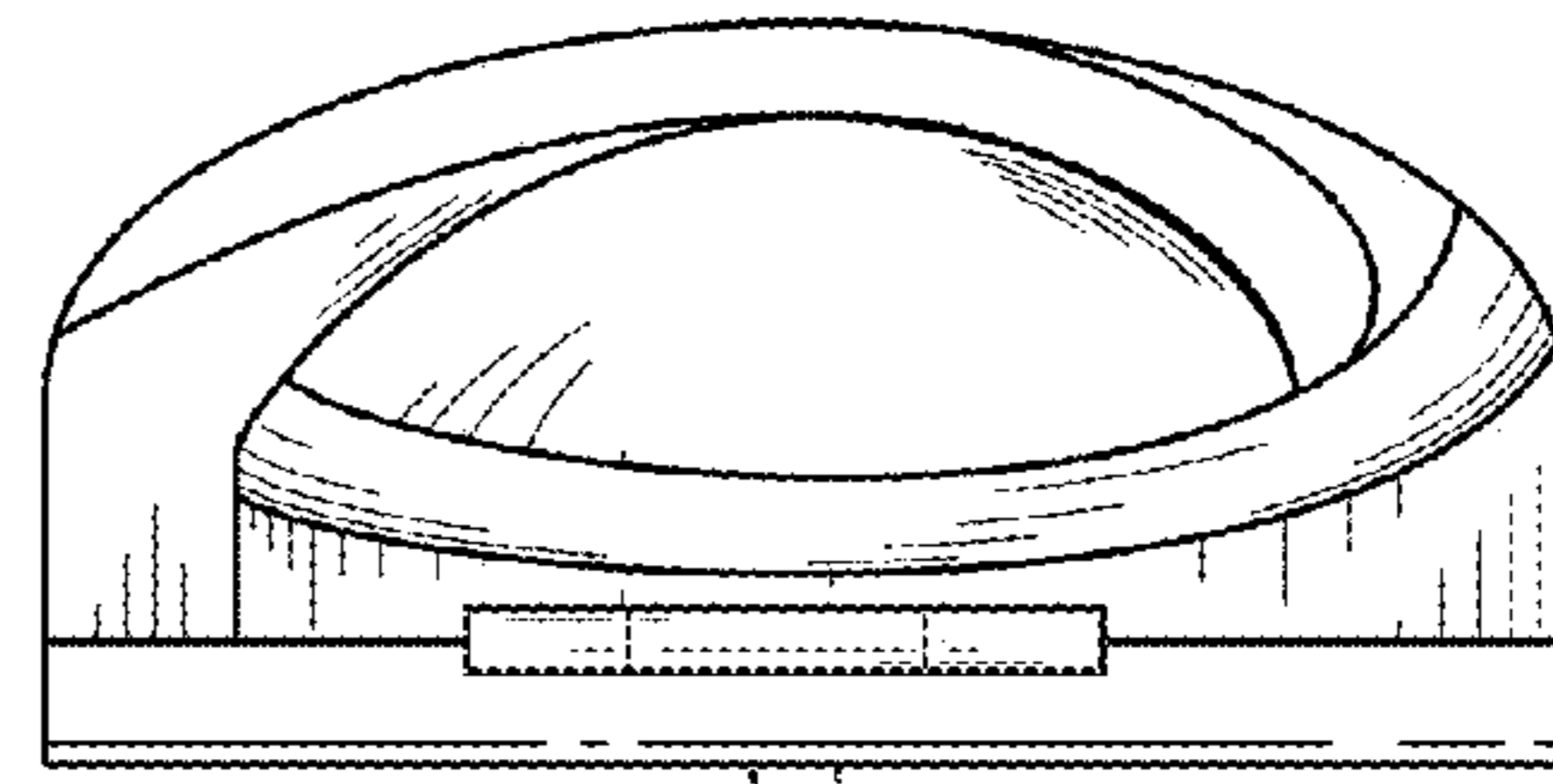

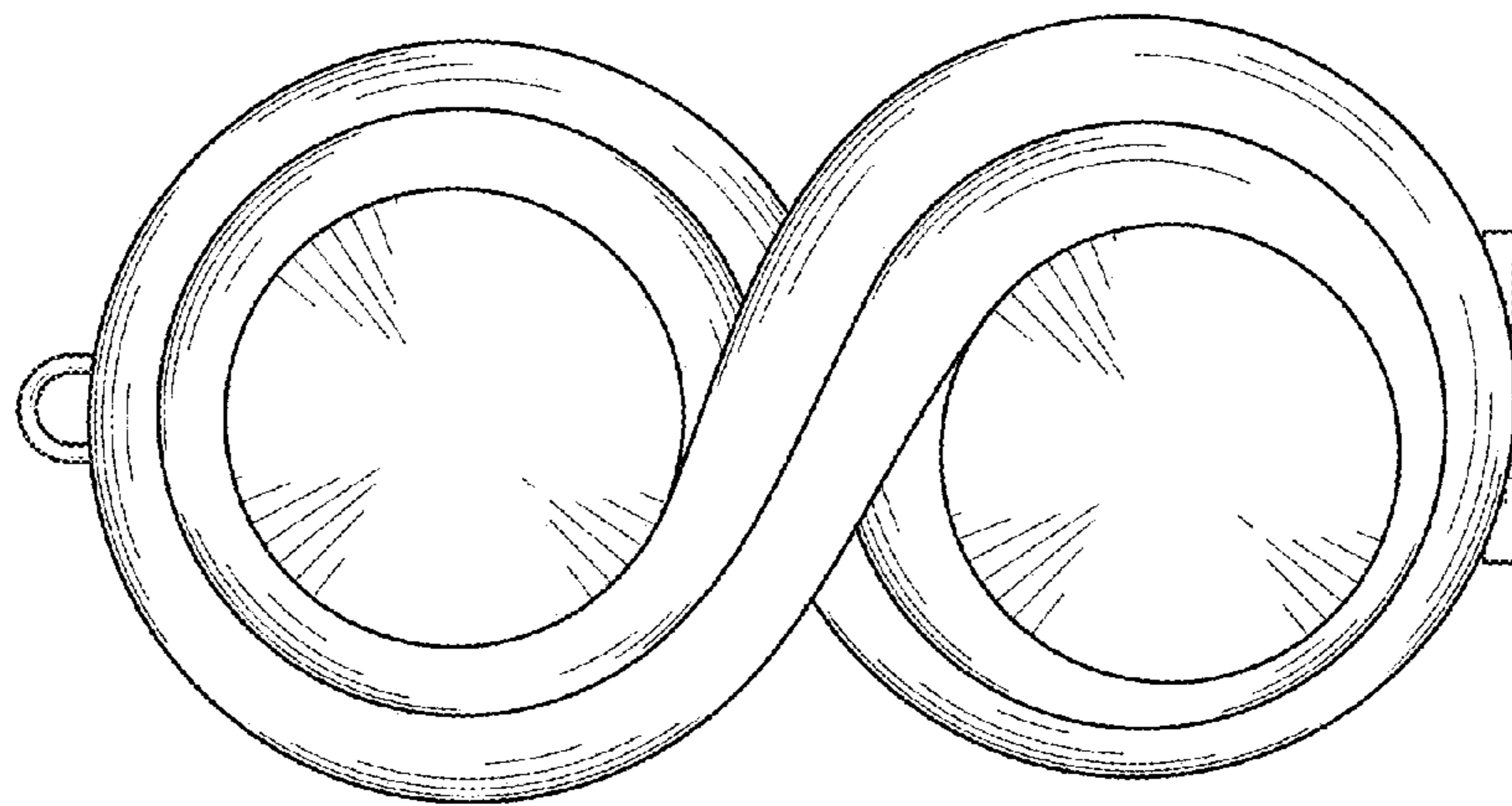

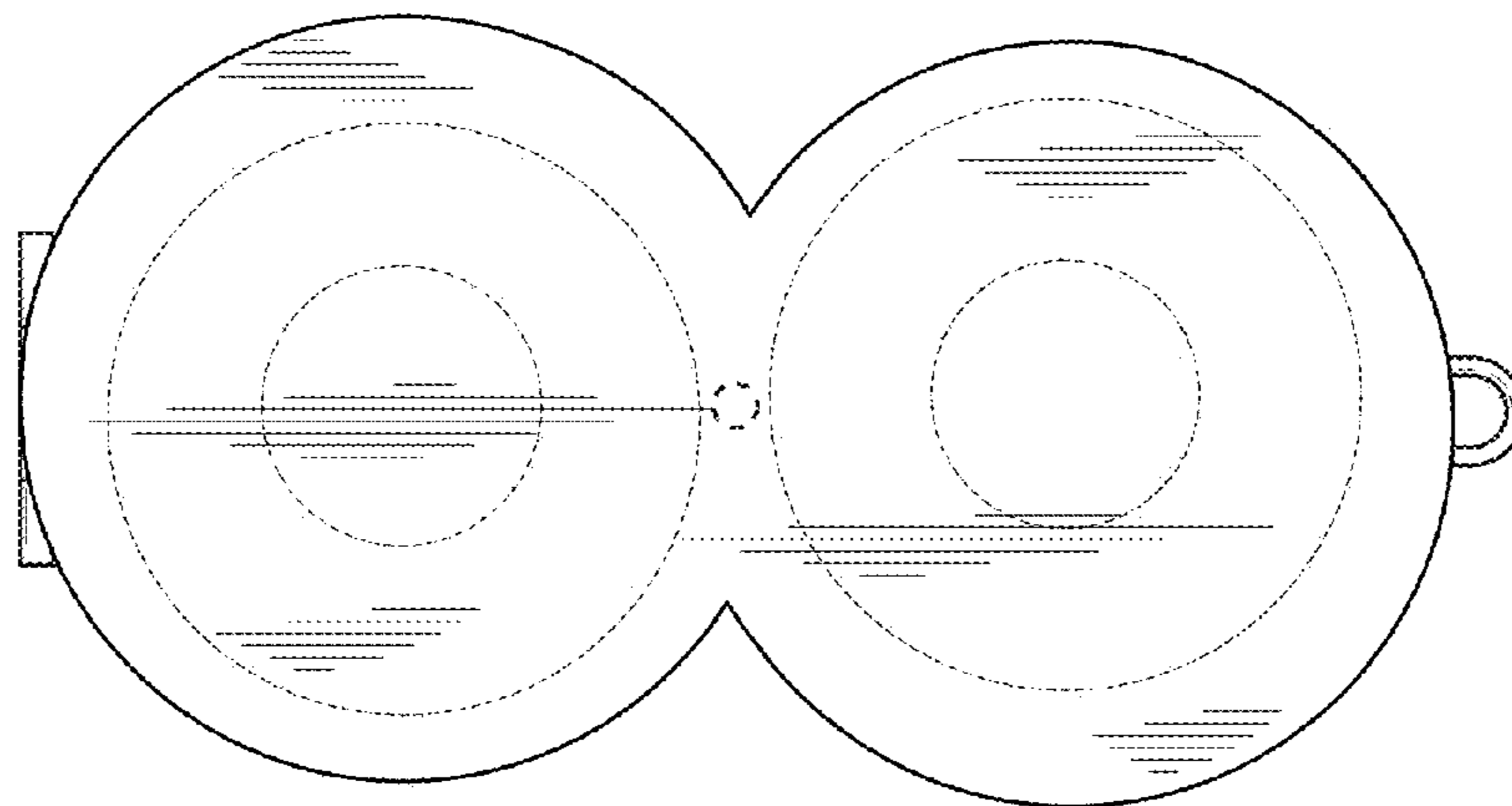
