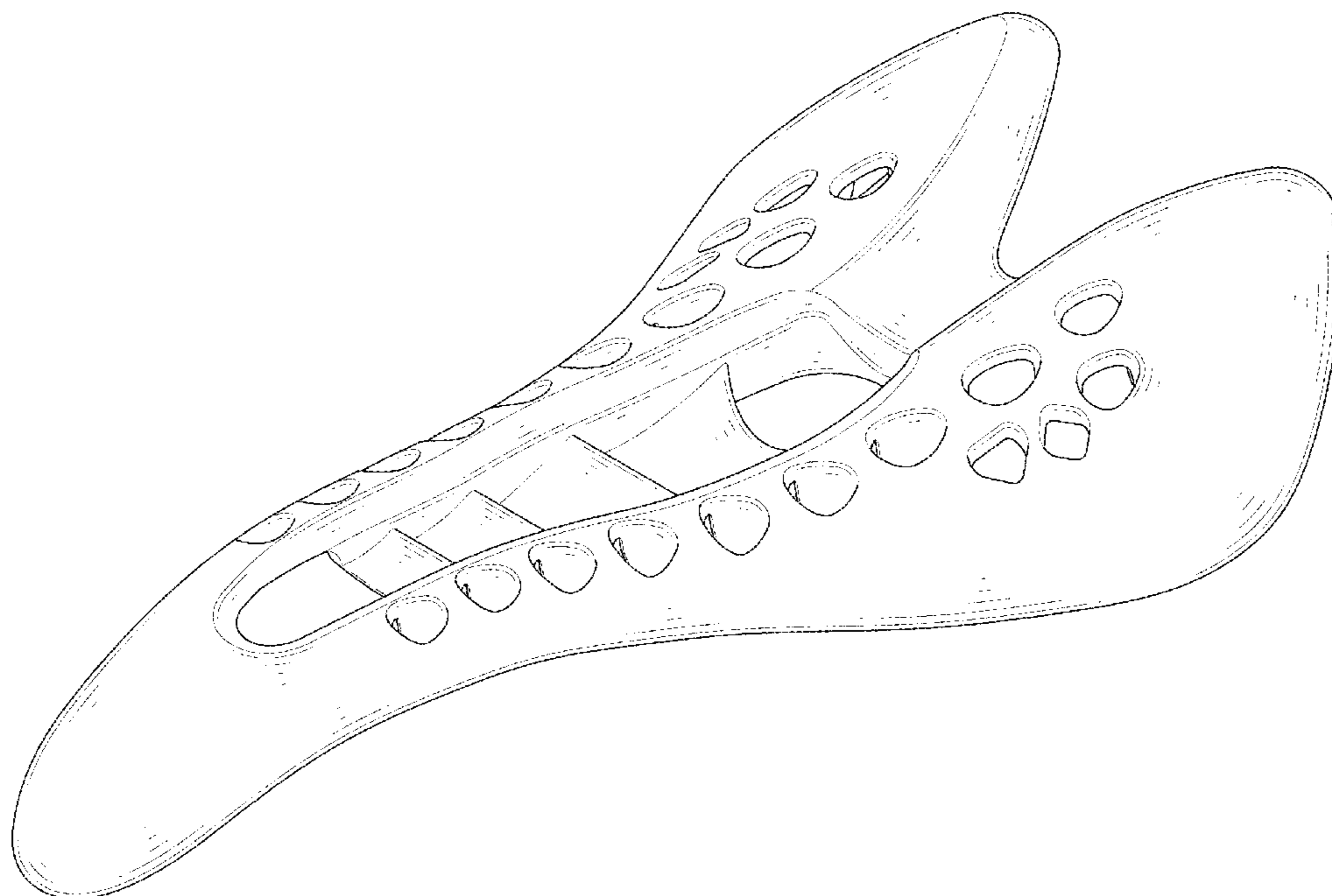
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of saddle for a bike, showing my new design;

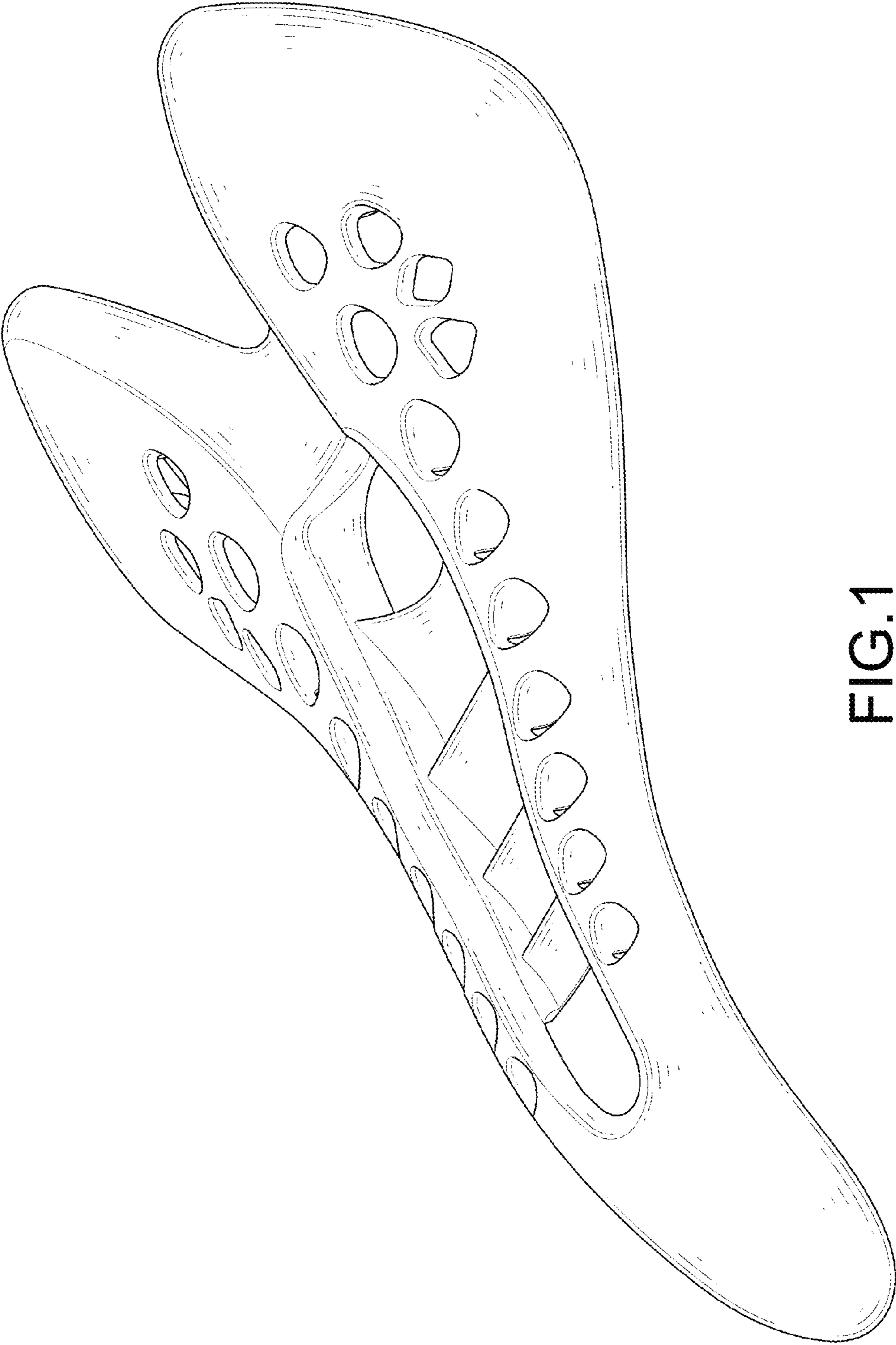

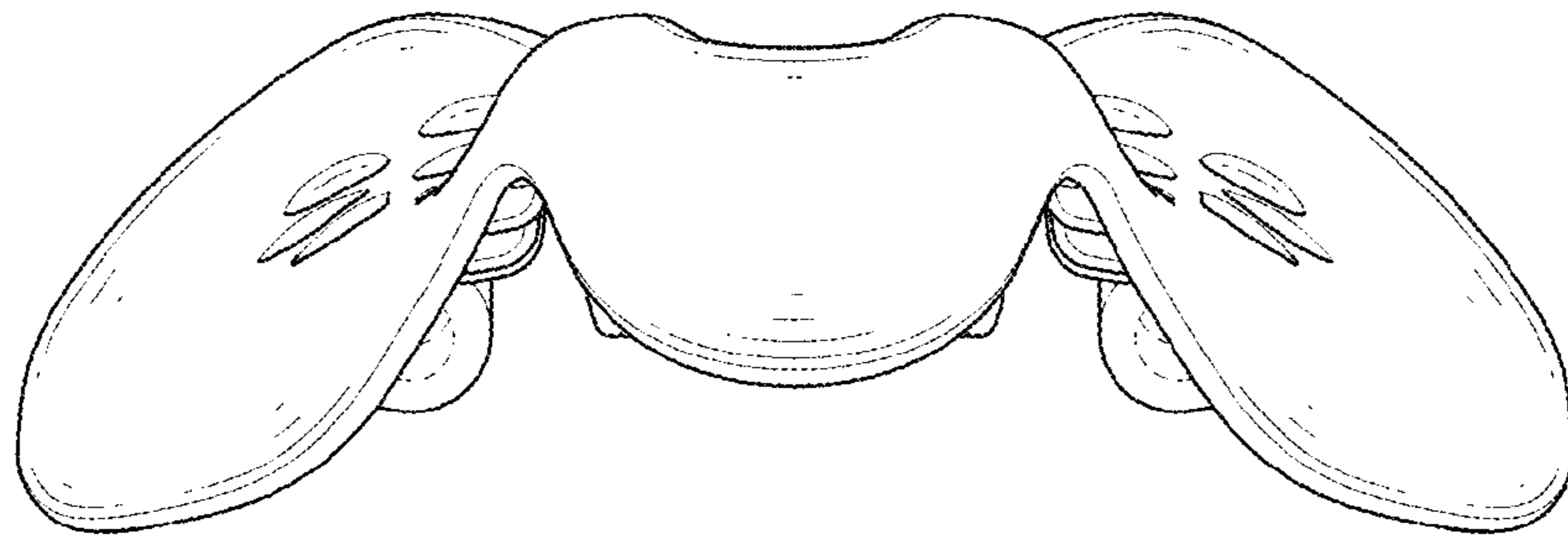

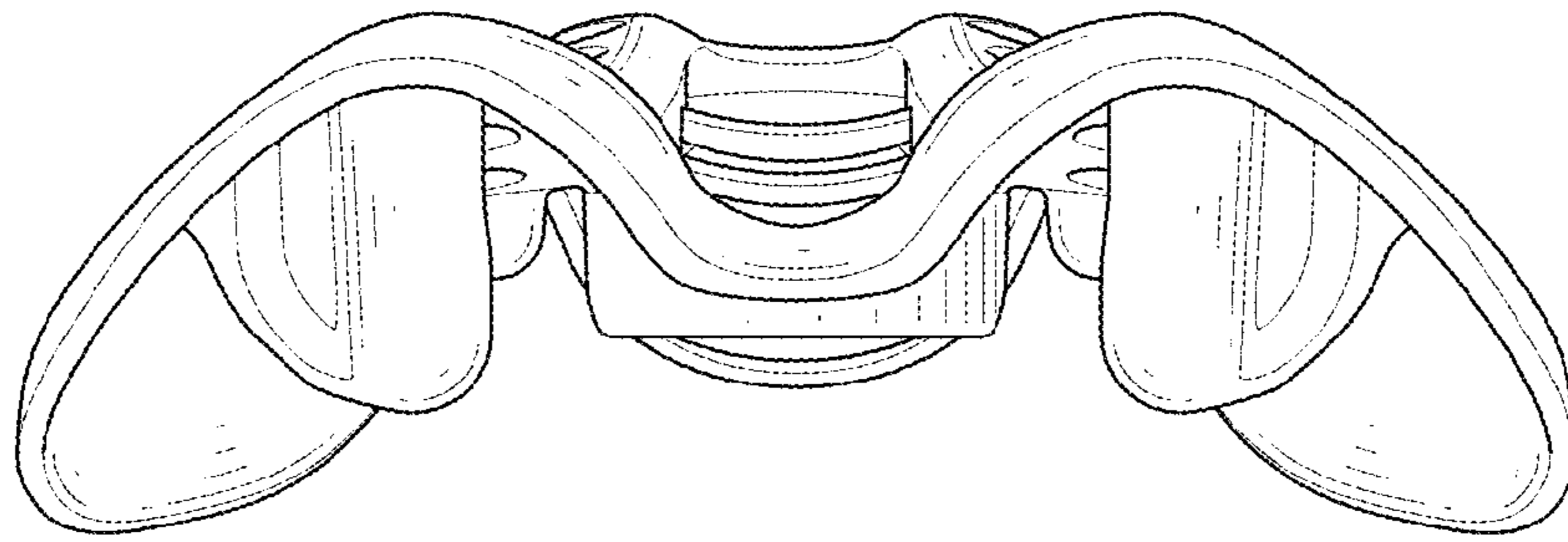

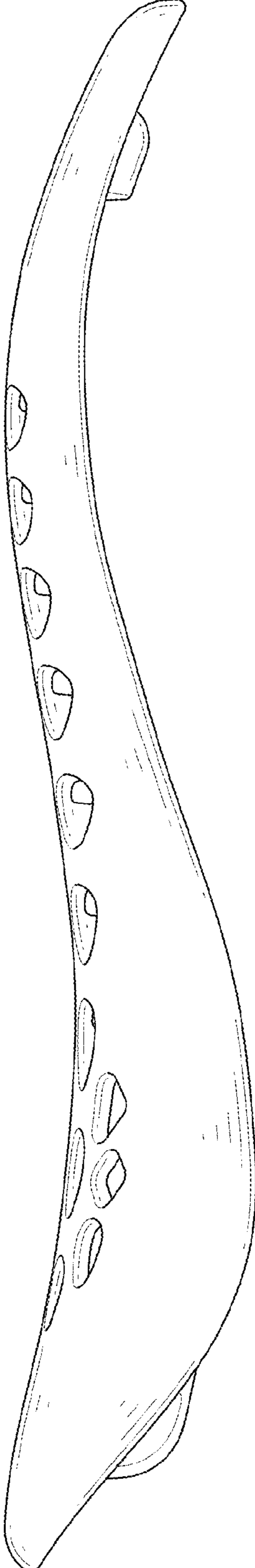

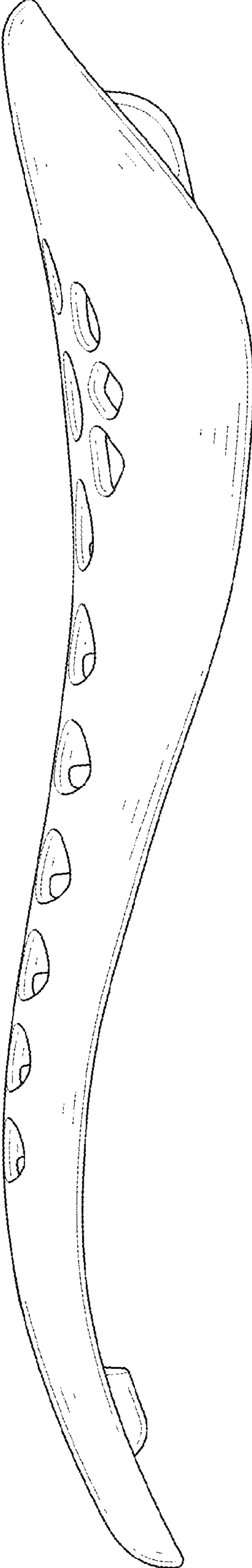

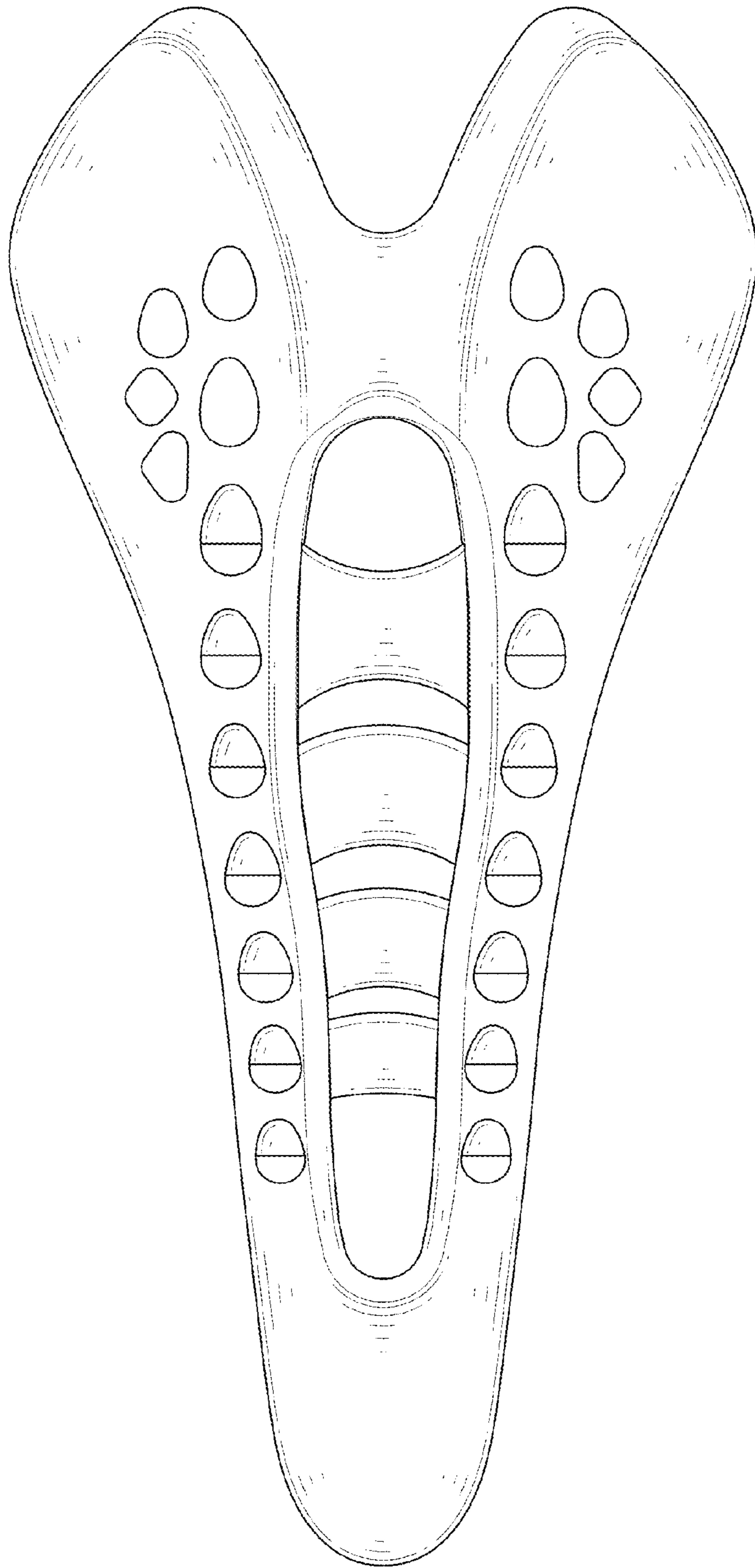

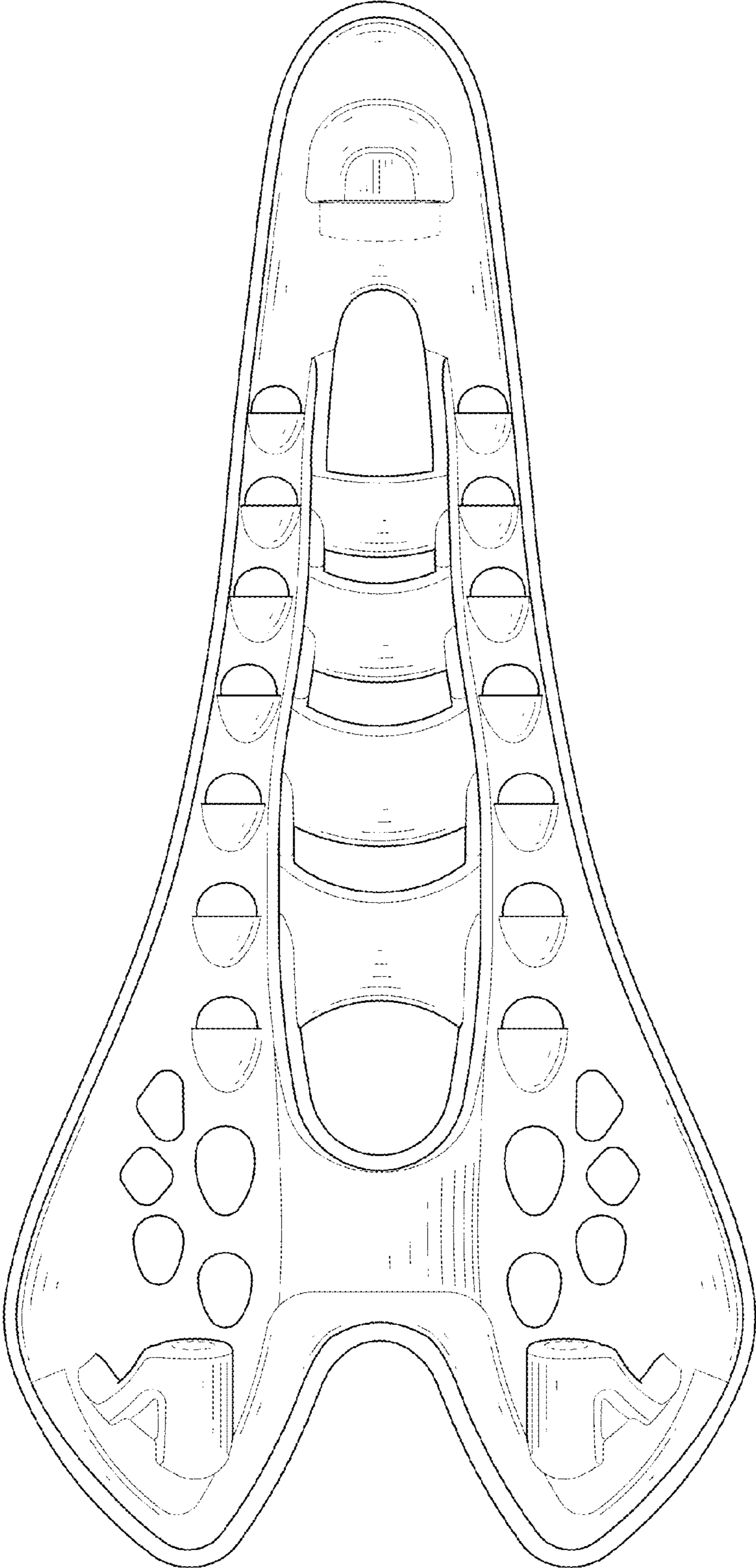

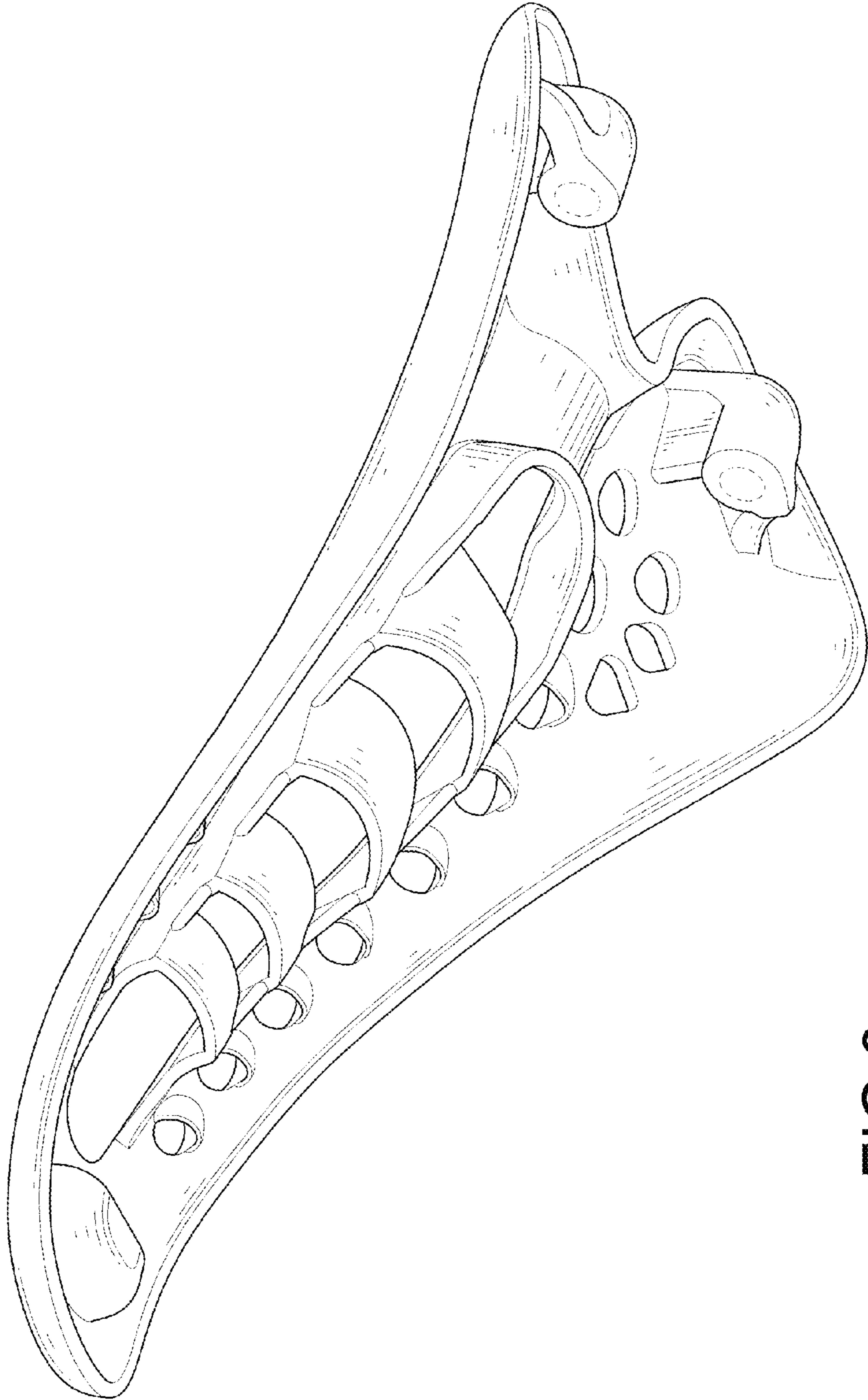
