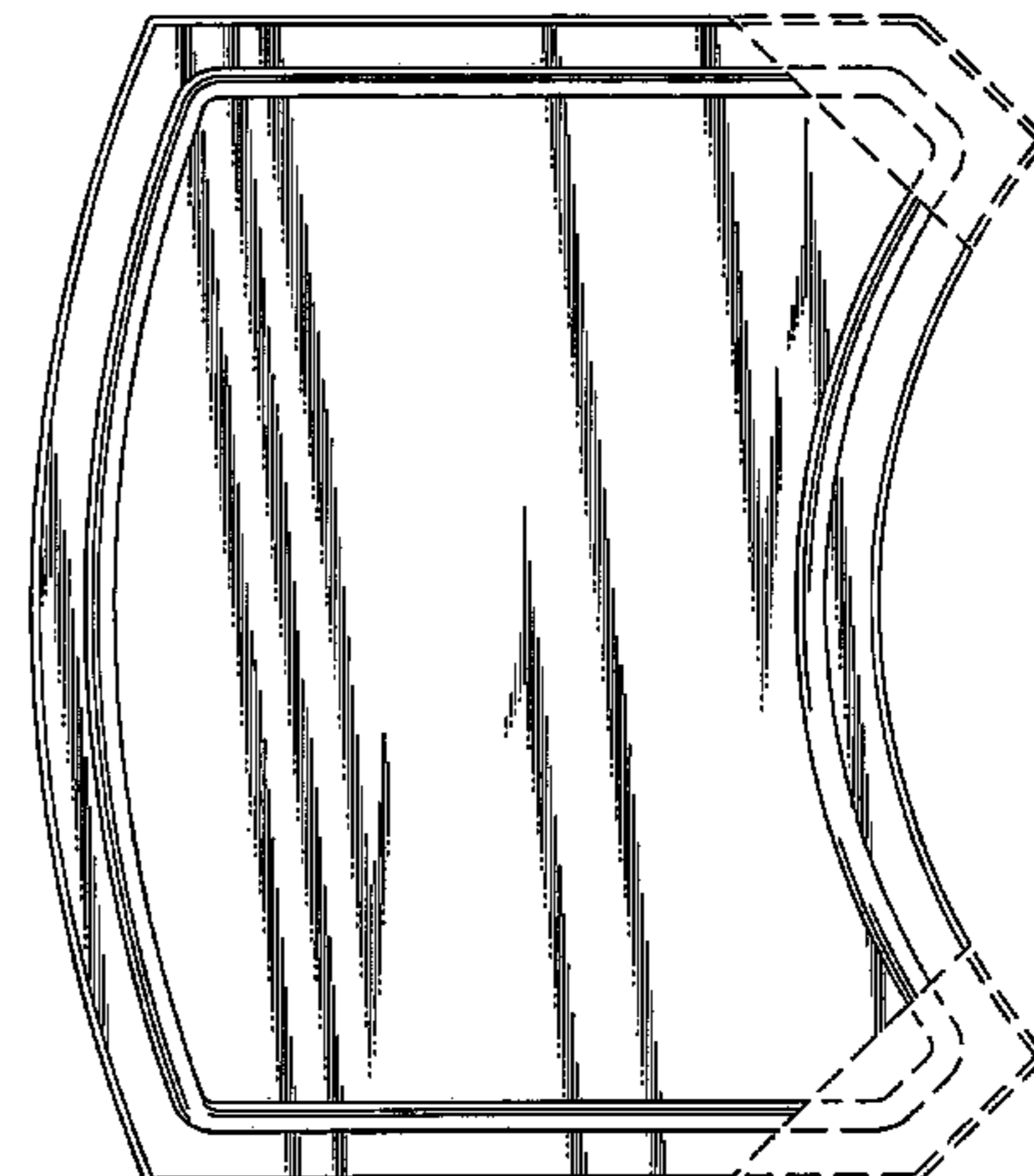
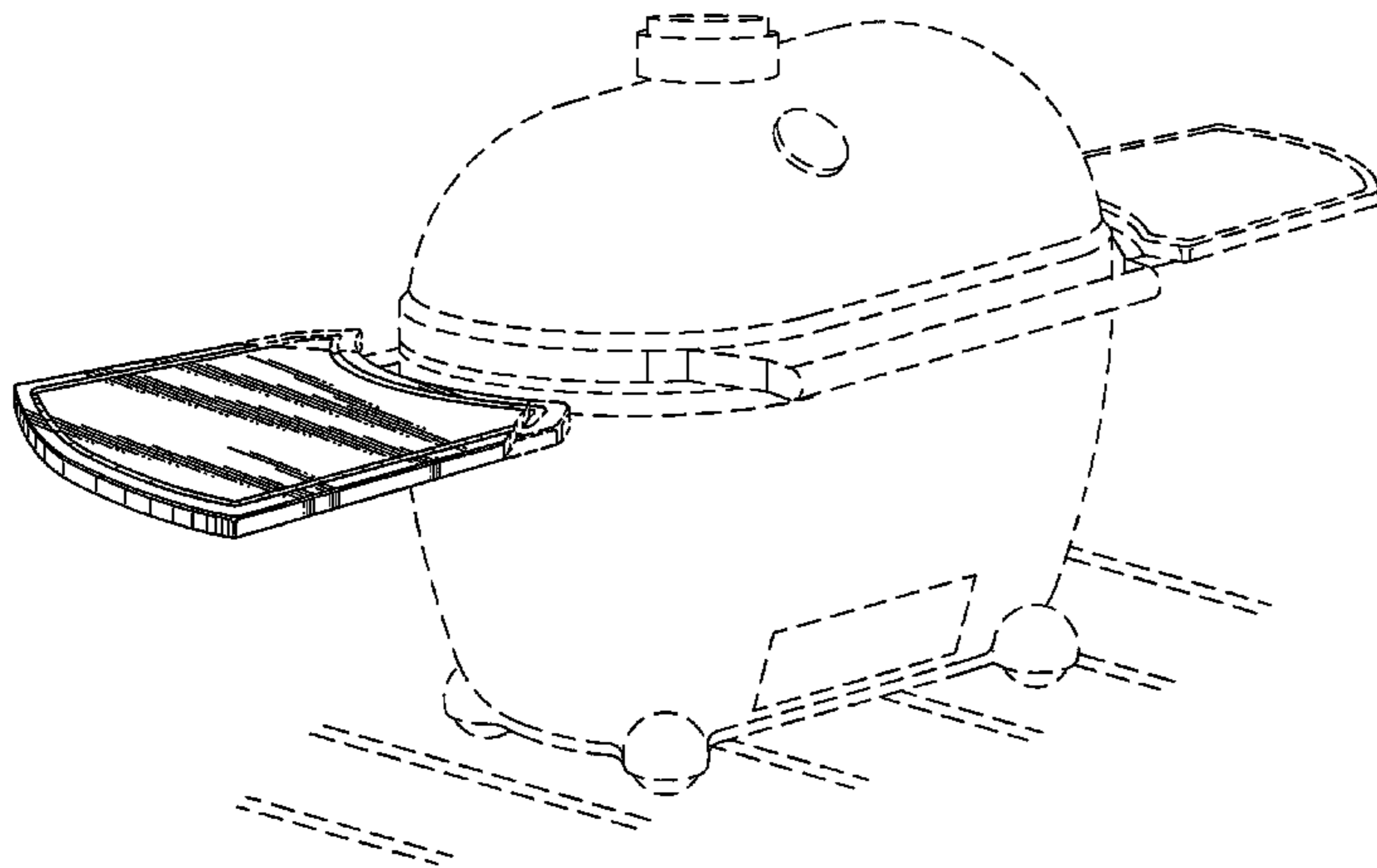
(57) **CLAIM**

The ornamental design for a ceramic cooker side shelf, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a ceramic cooker side shelf showing my new design;  
FIG. 2 is an enlarged top perspective view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a side elevation view thereof; and,  
FIG. 5 is a front elevation view thereof, the rear view being a mirror image.

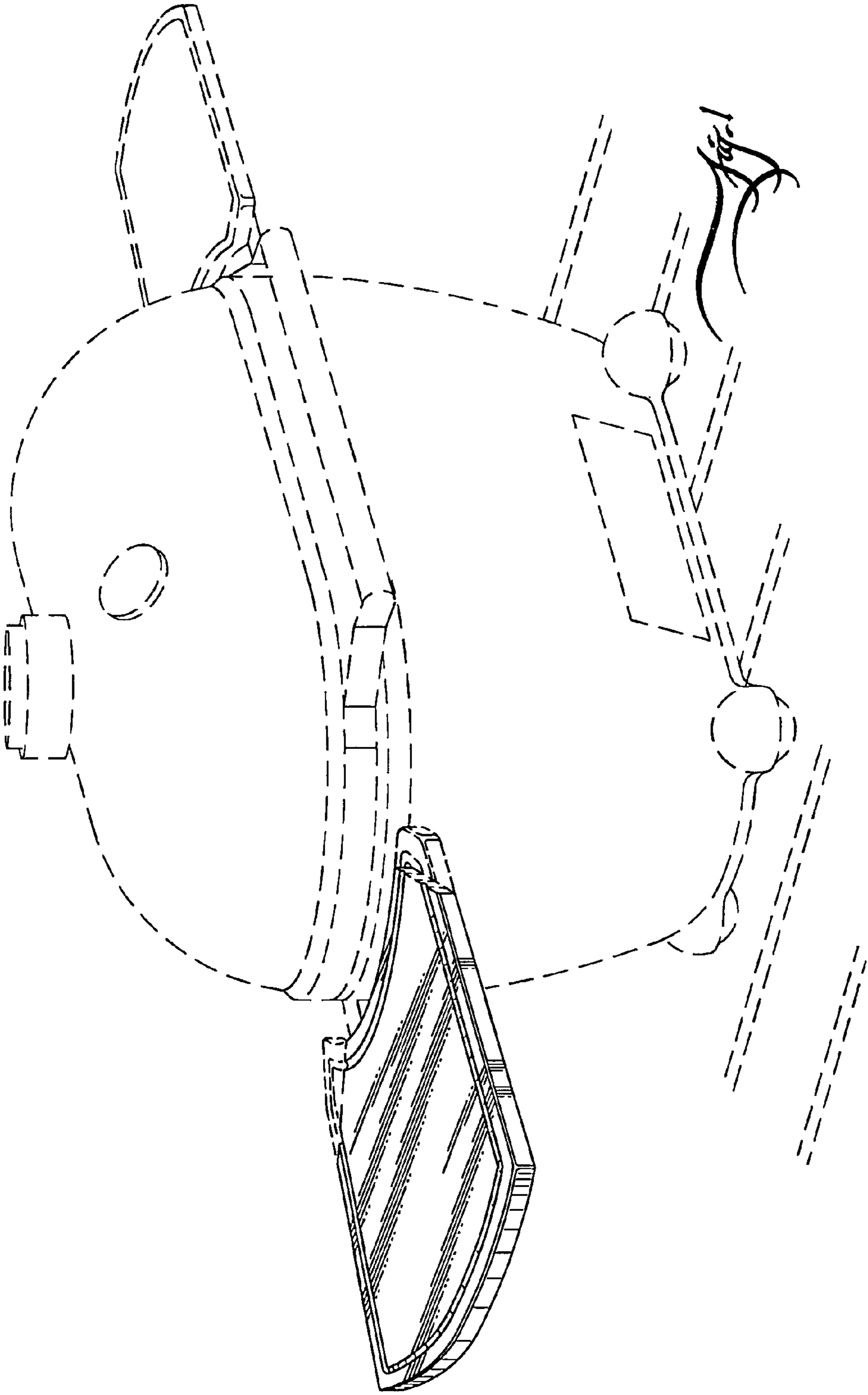

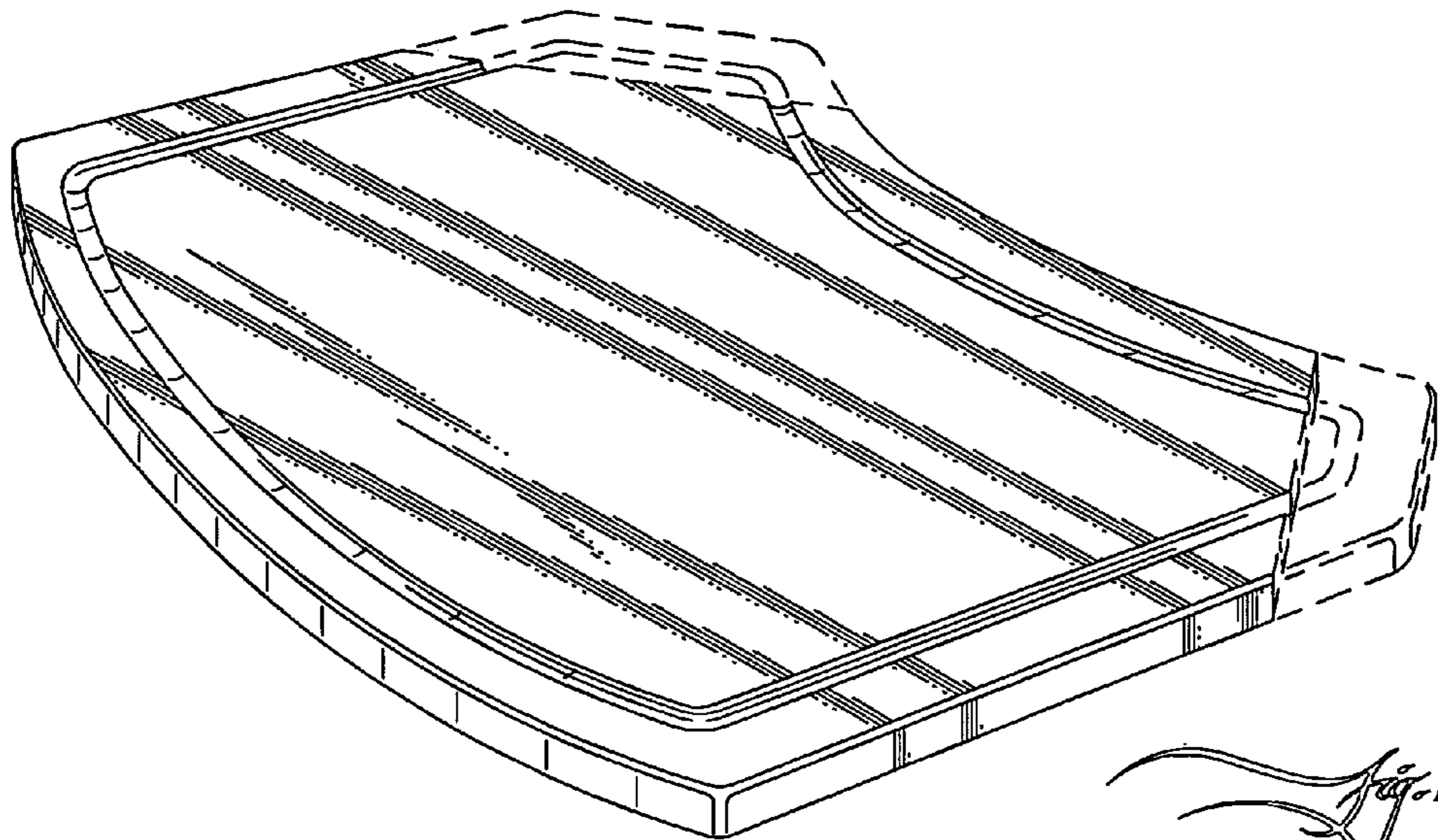

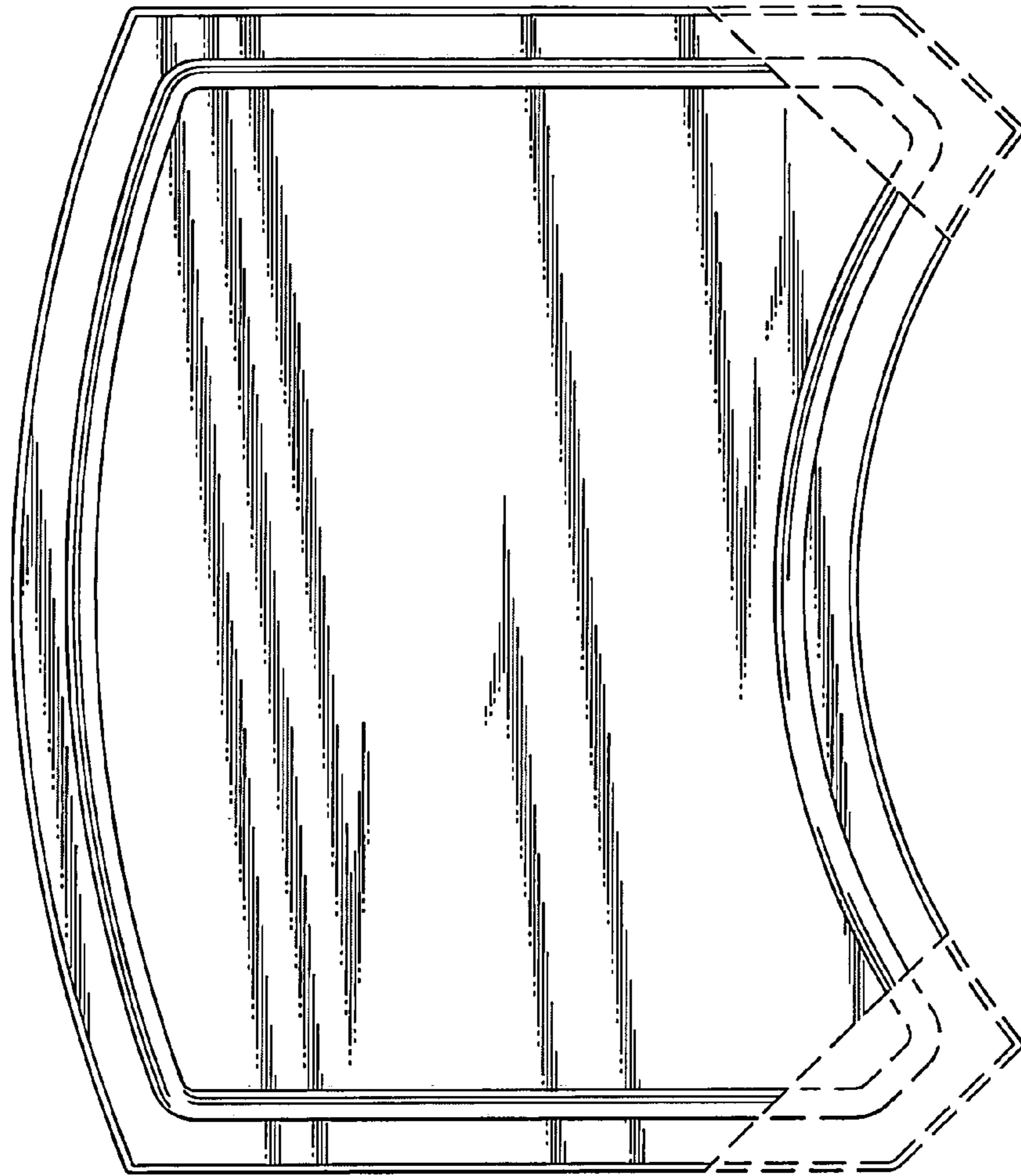

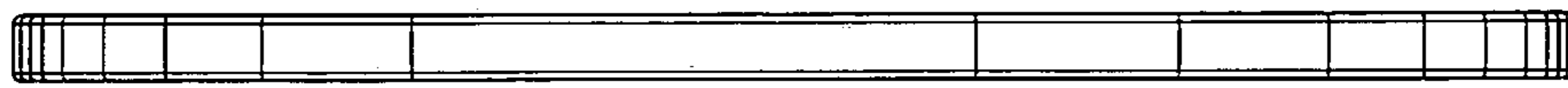




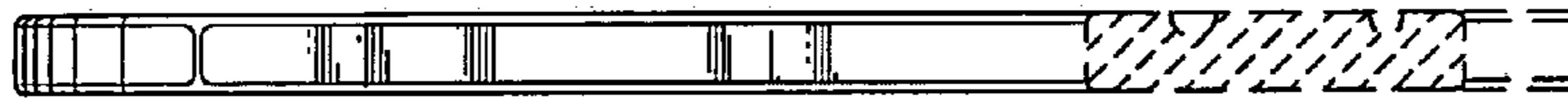
