DESCRIPTION

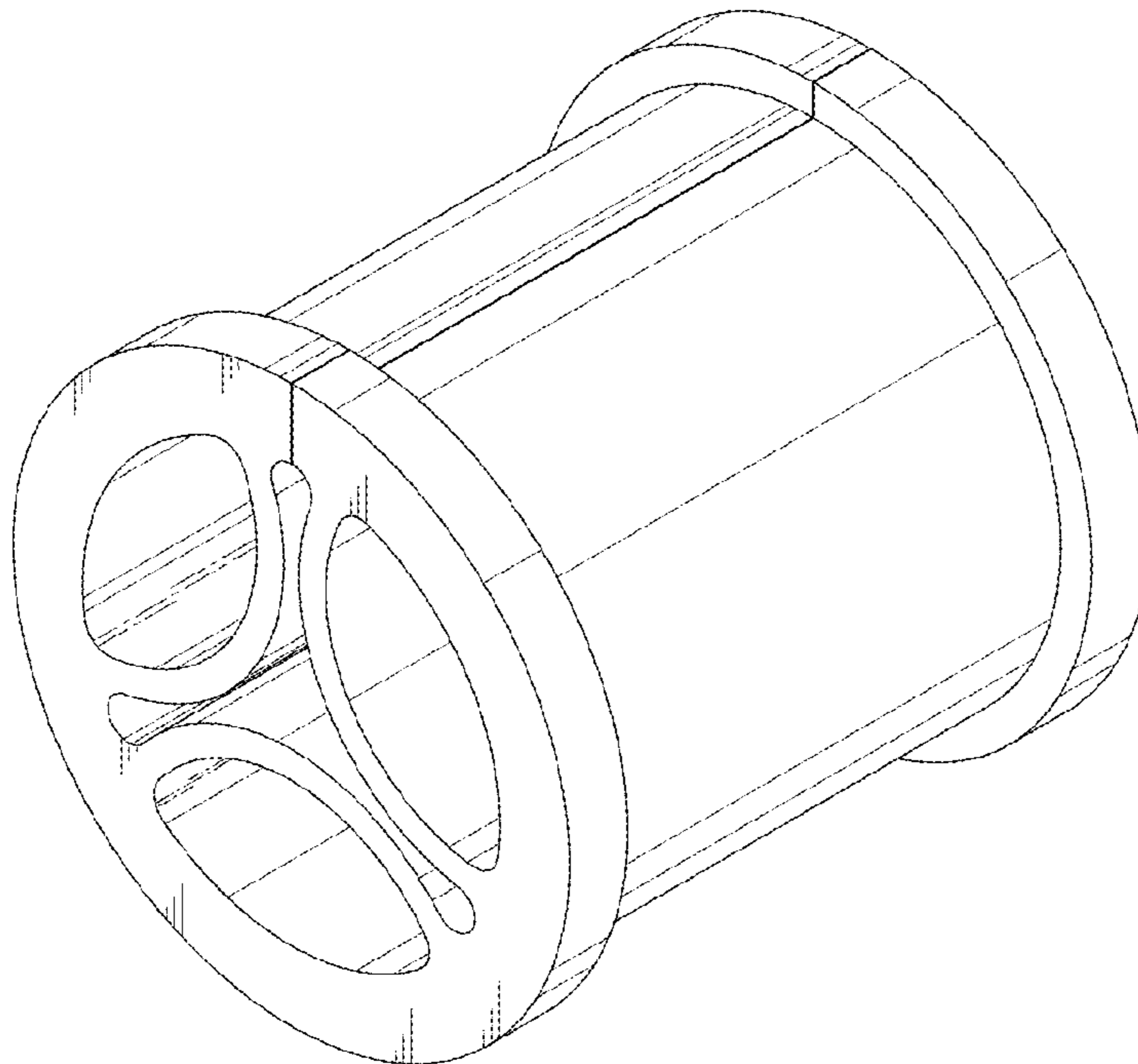
FIG. 1 is a perspective view of a cable organizing device showing my new design;

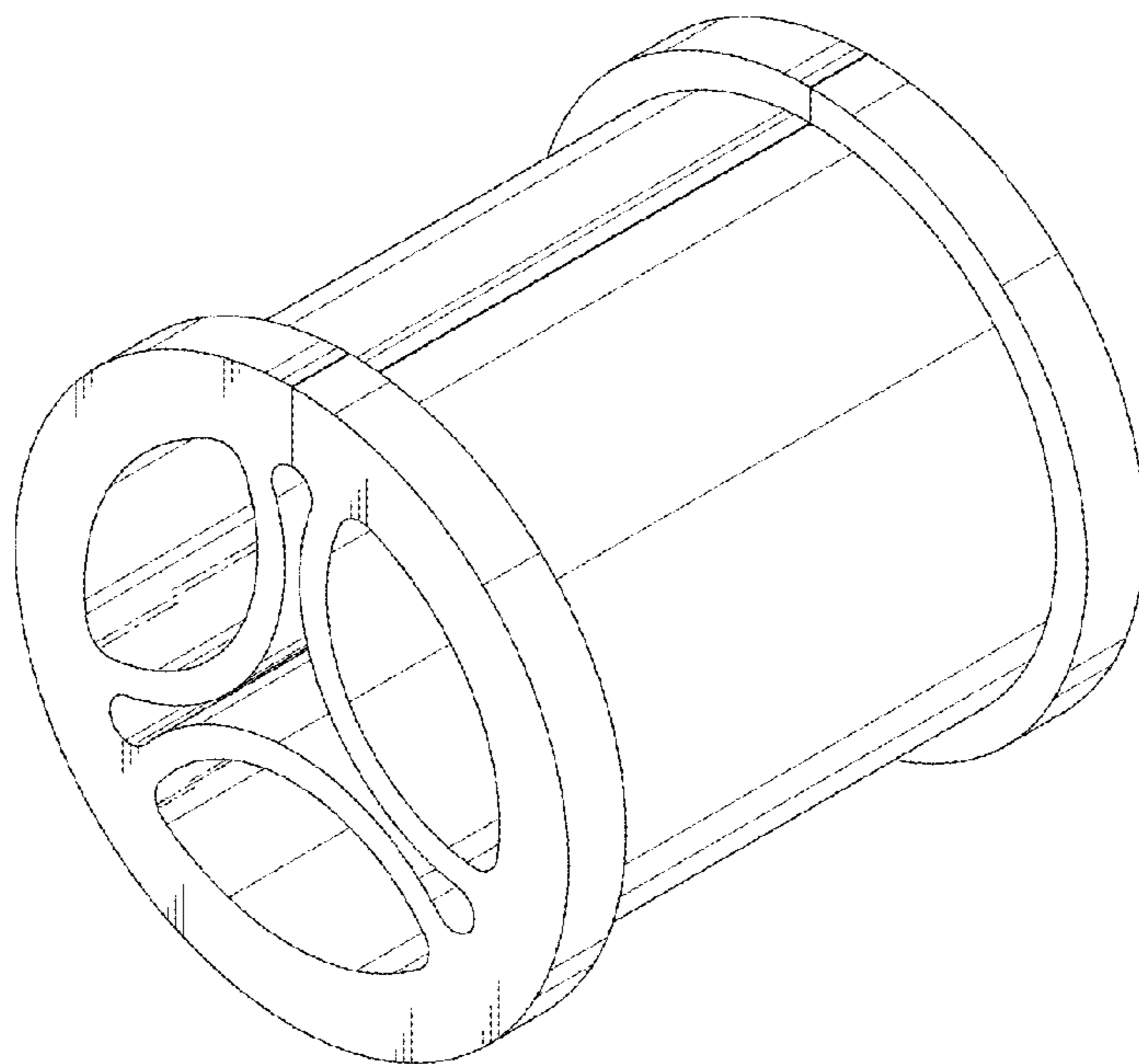

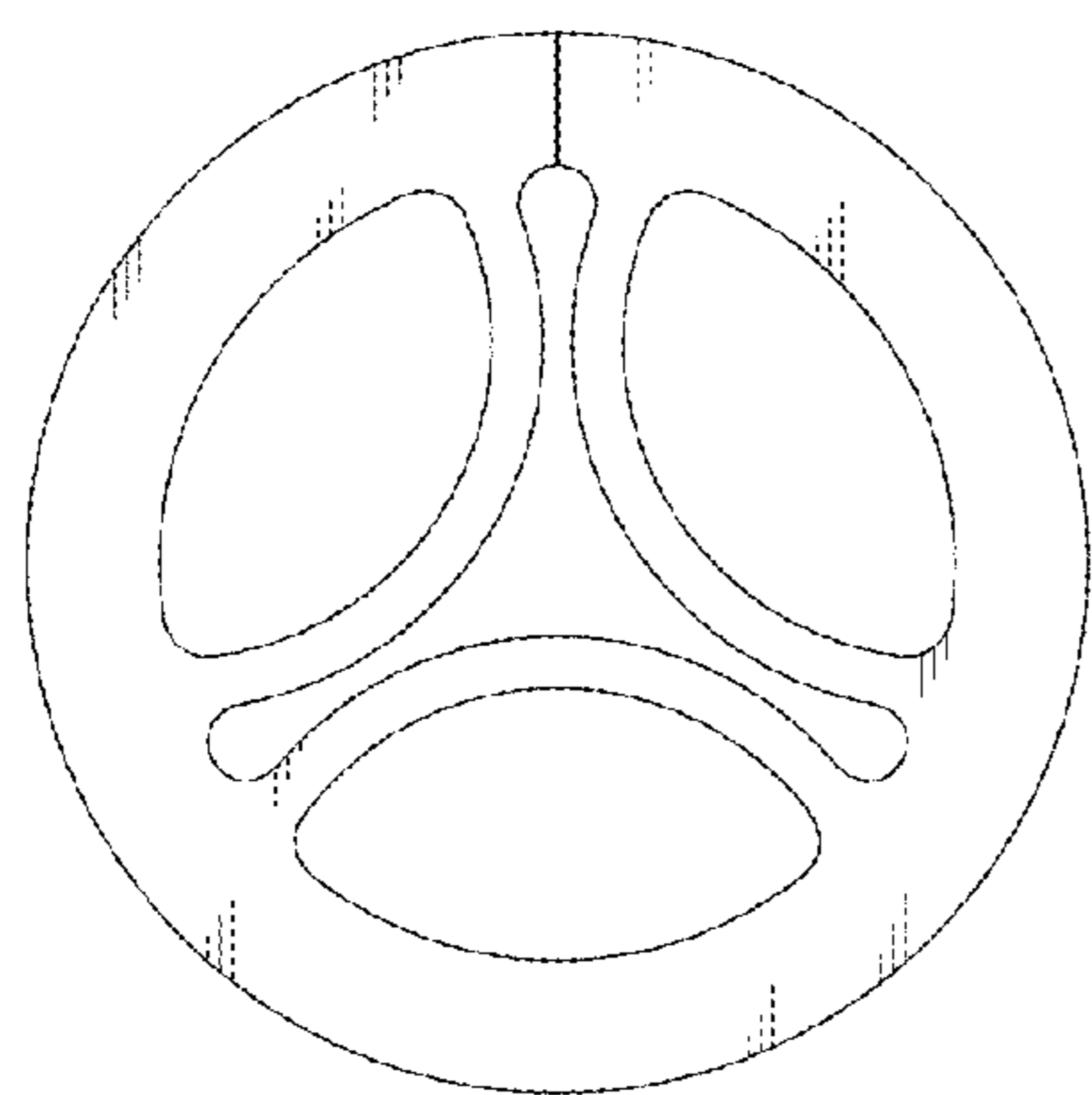

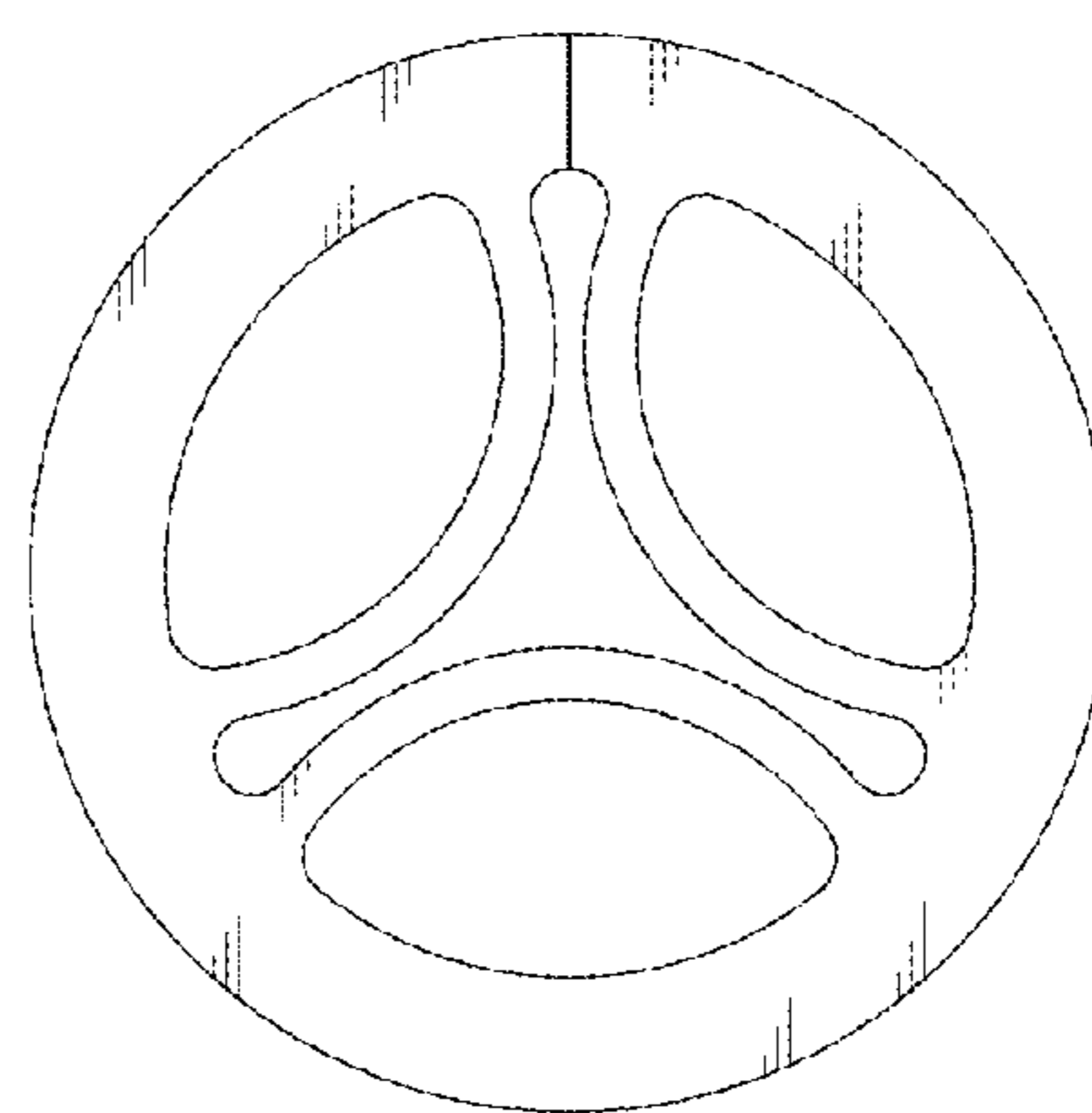

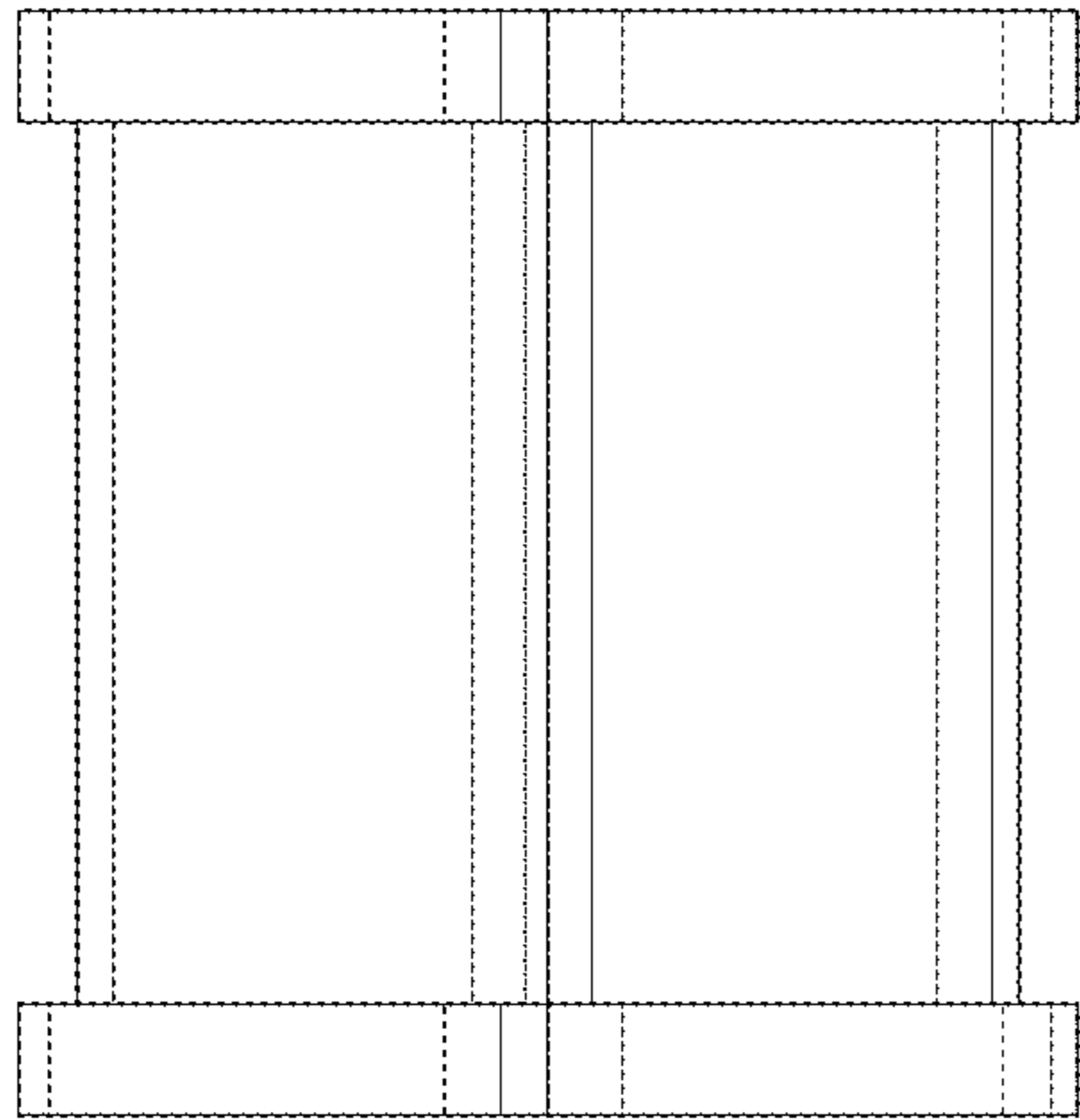

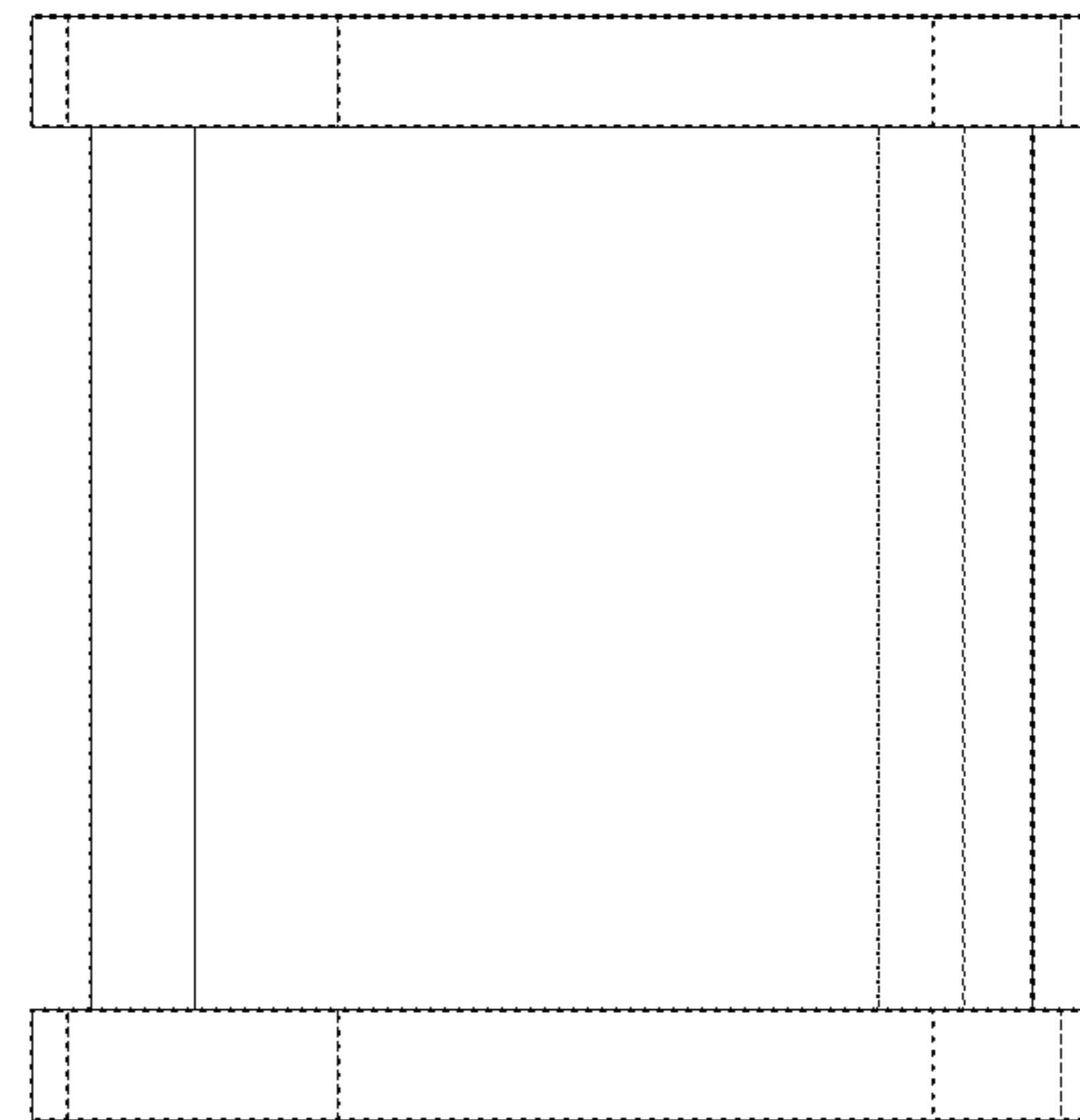

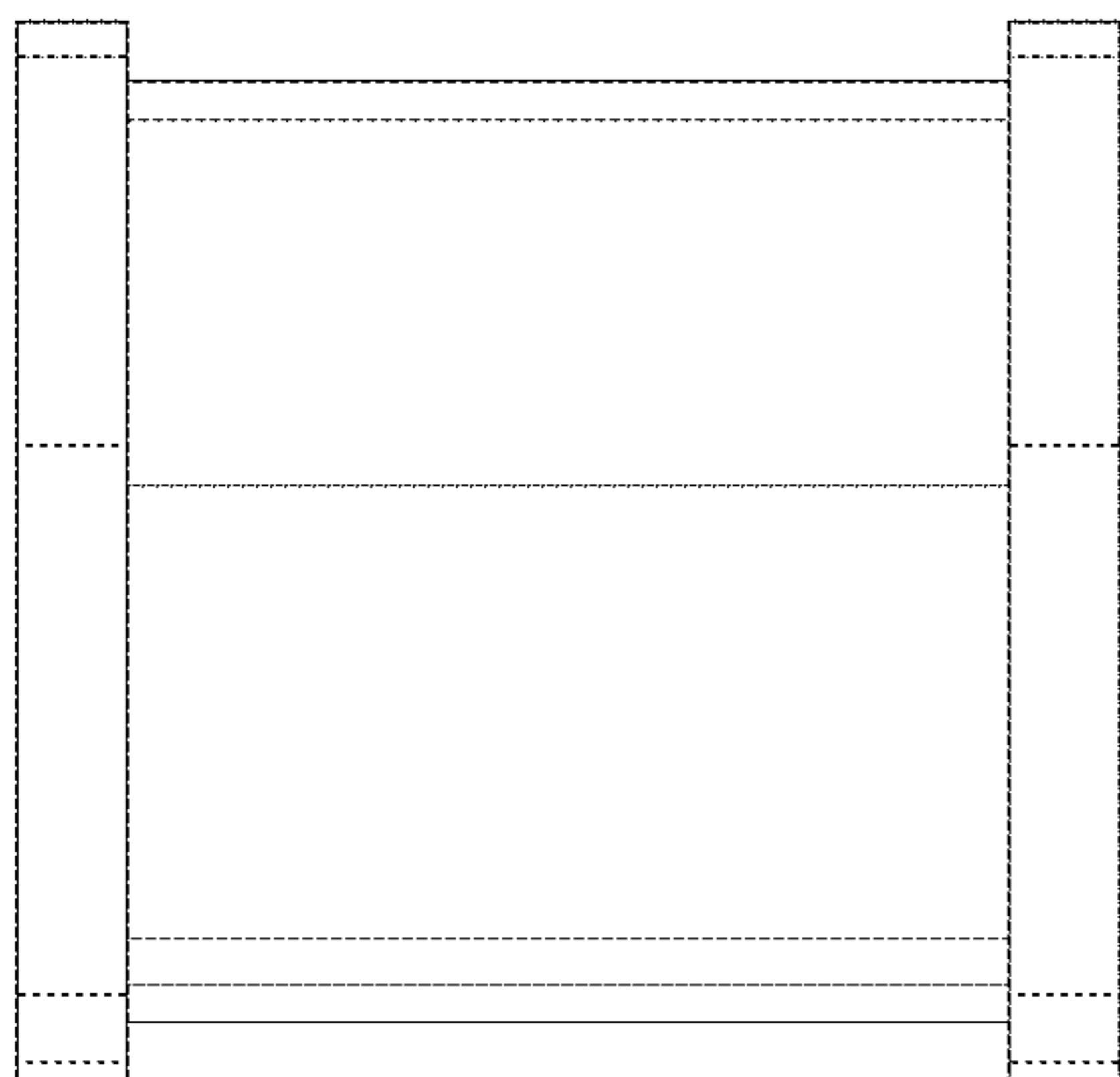

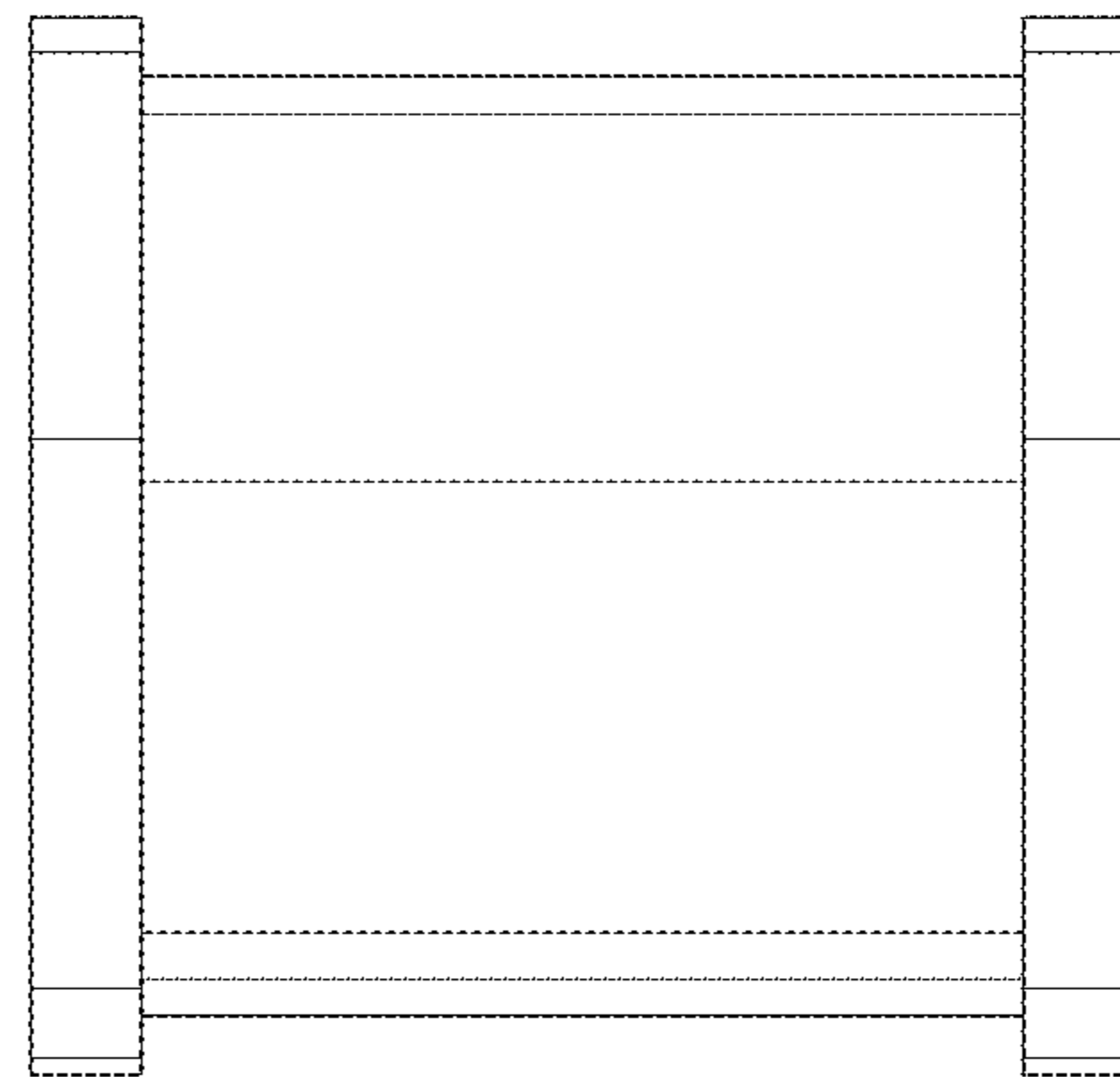
