DESCRIPTION

FIG. 1 is a front perspective view of a packaging box with pattern showing my new design;

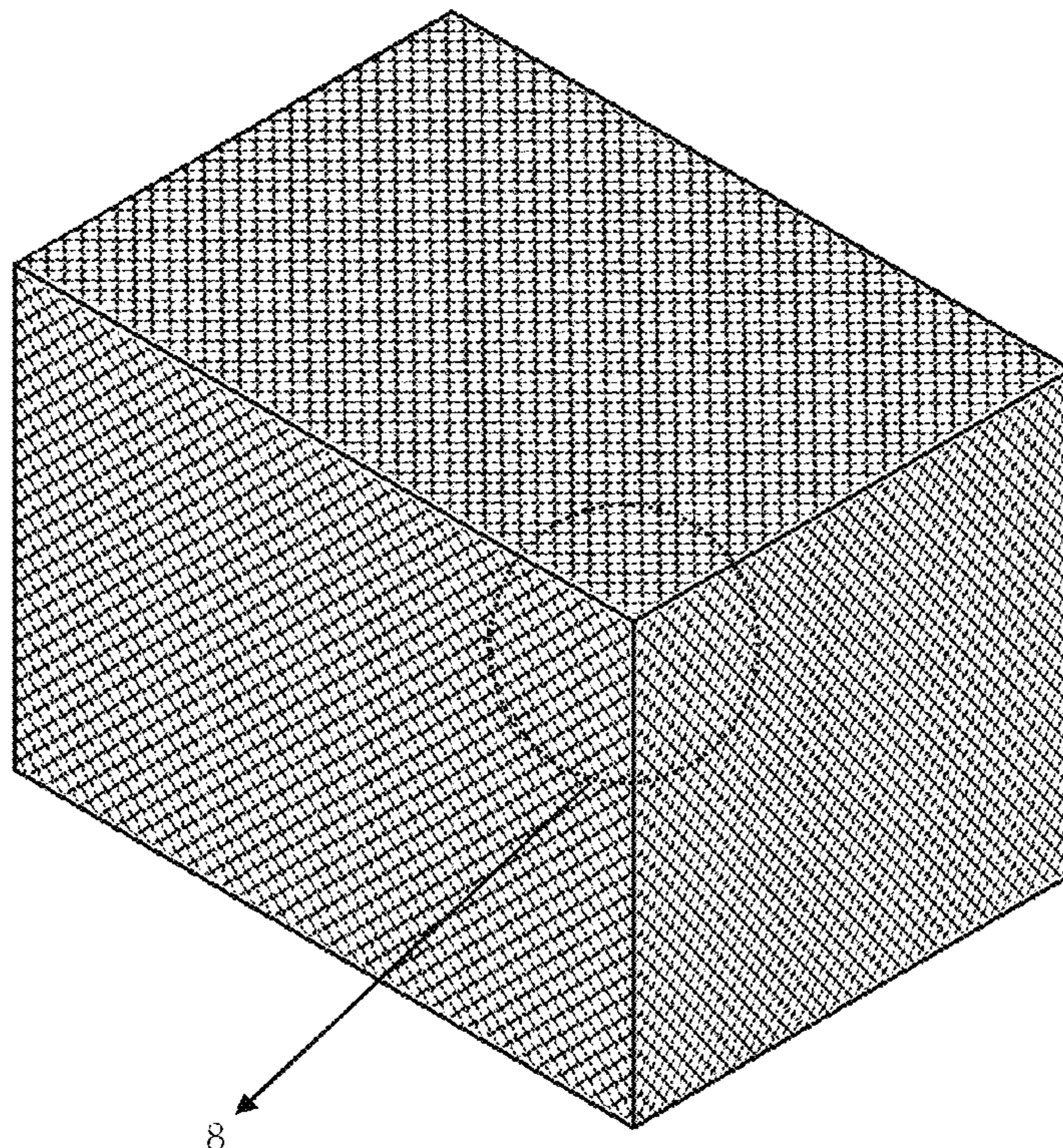

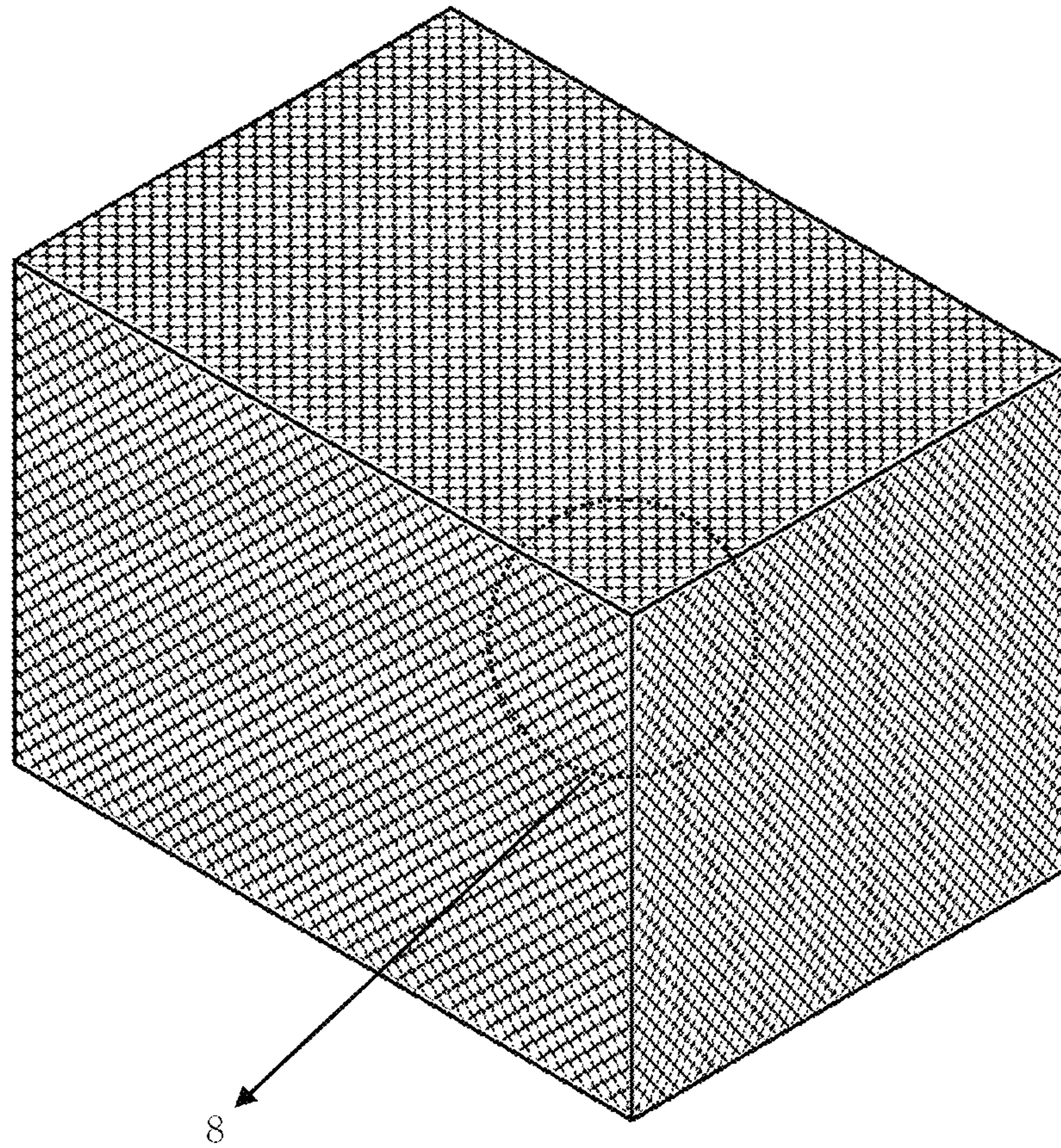

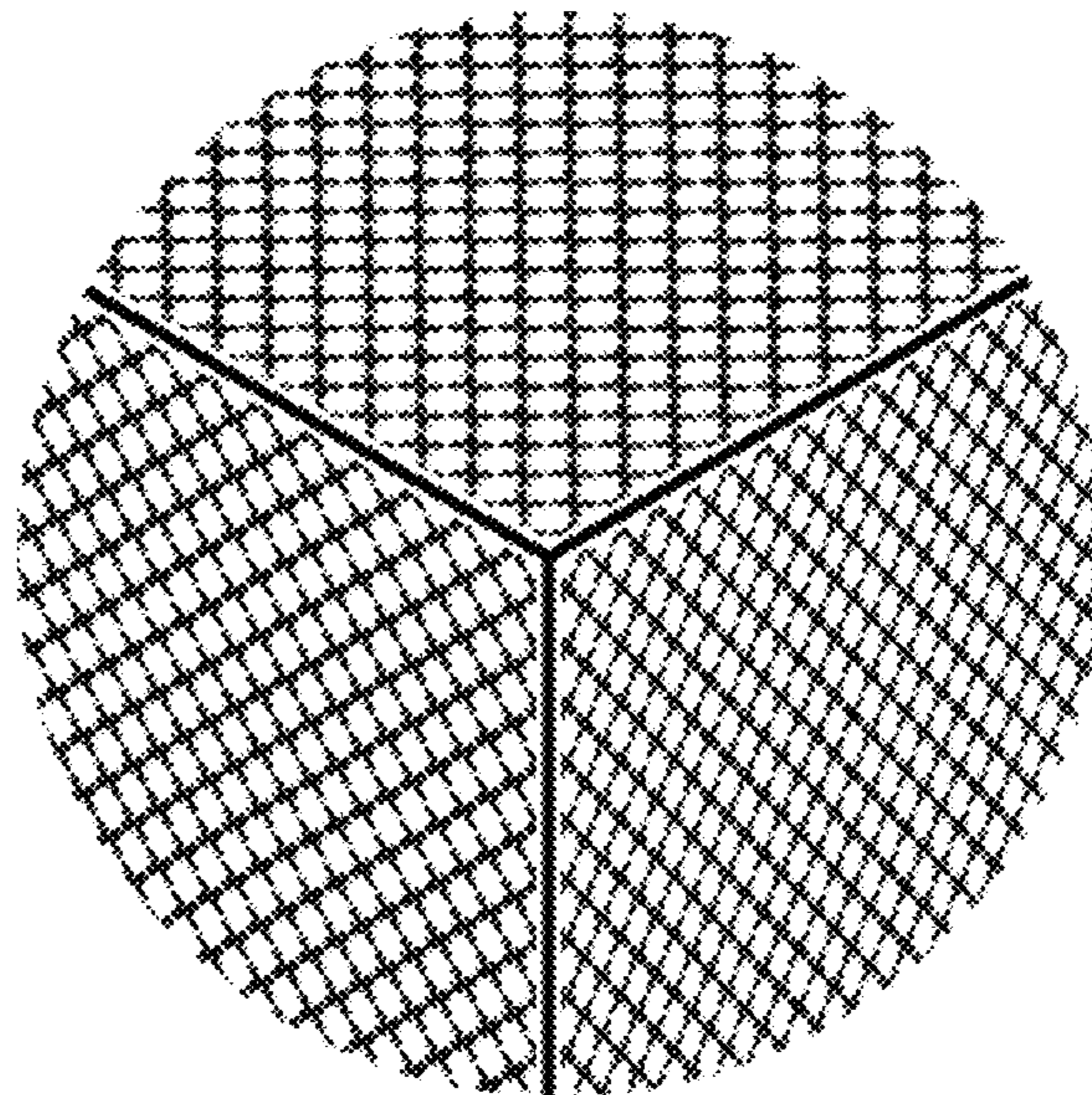

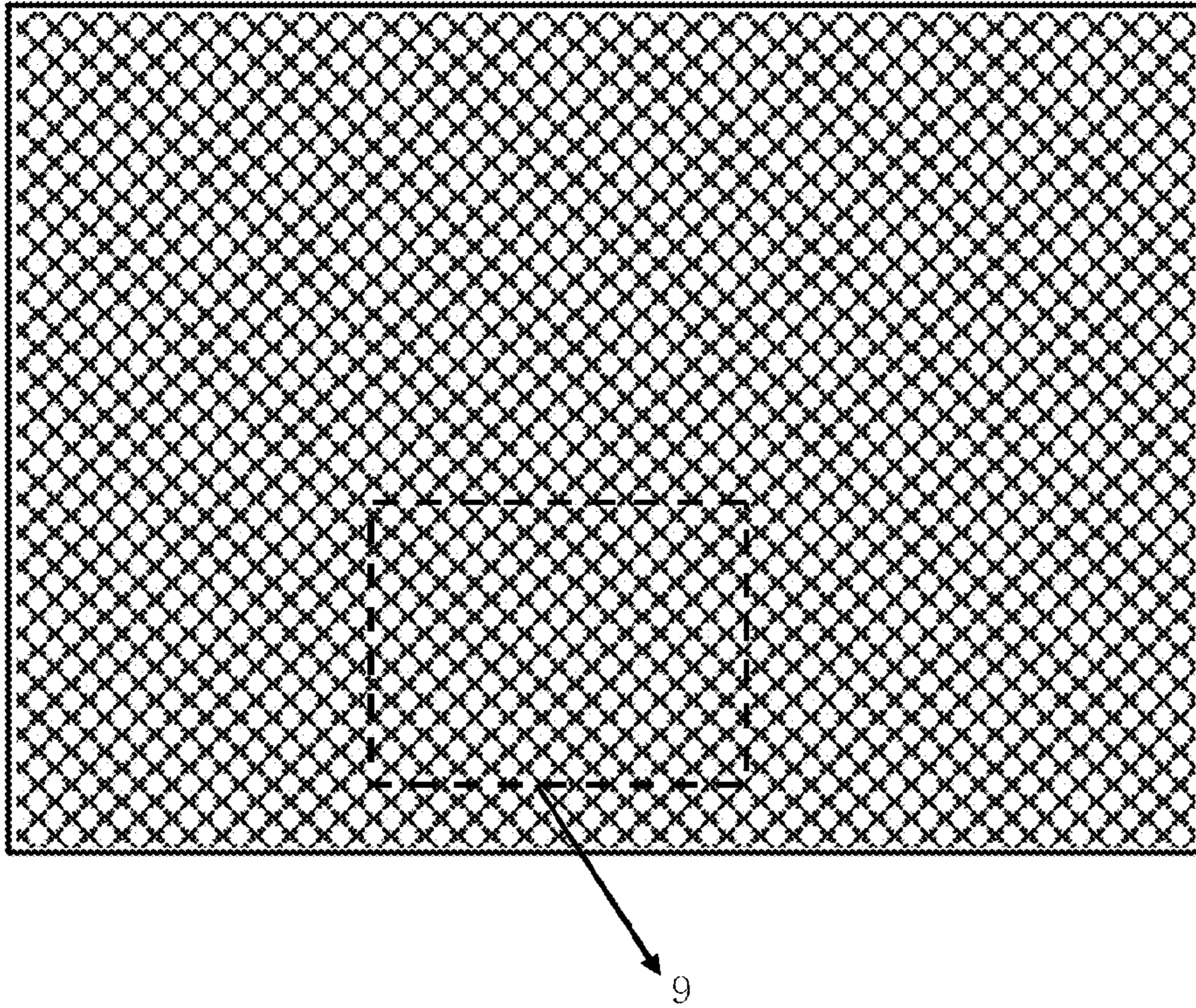

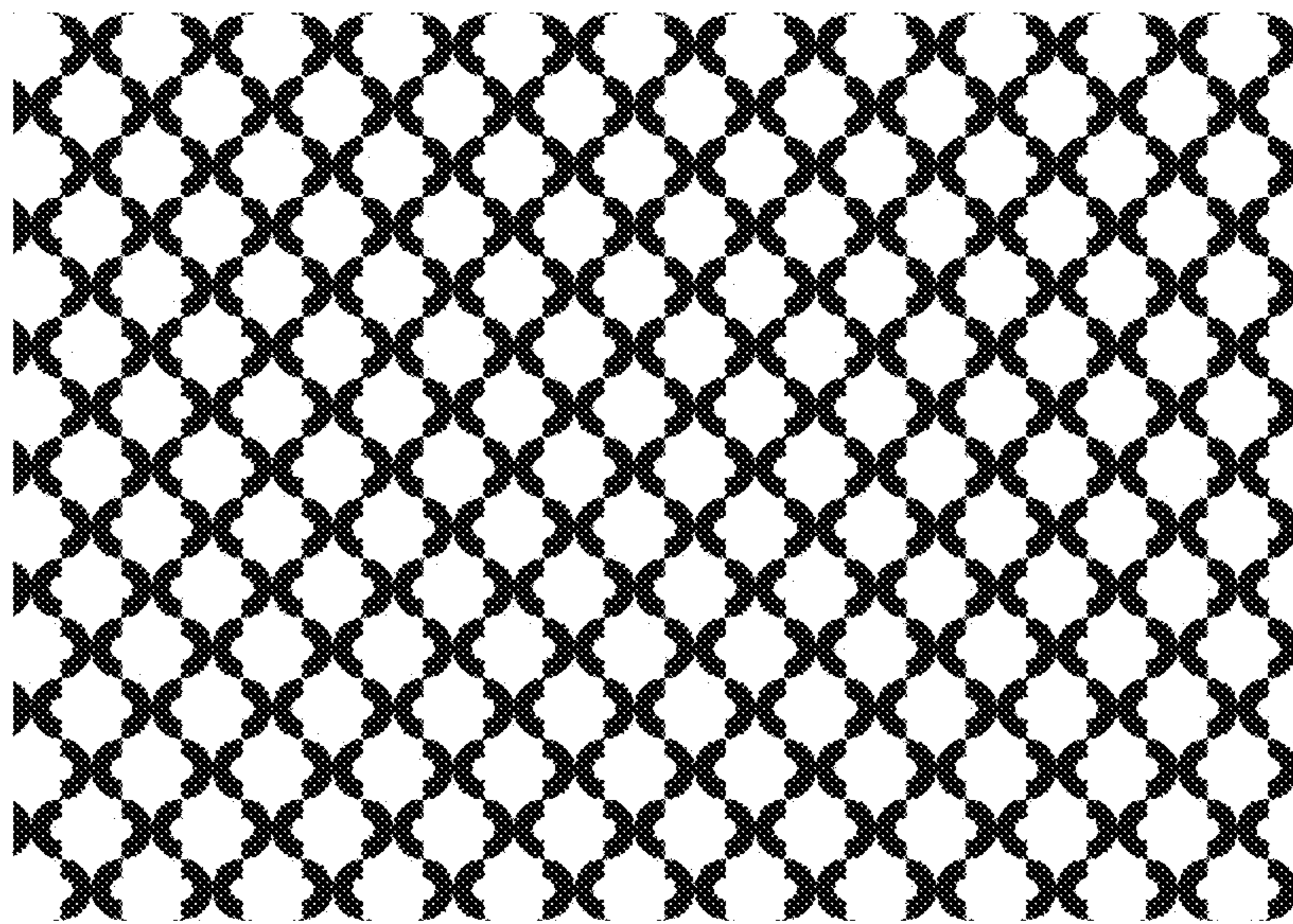
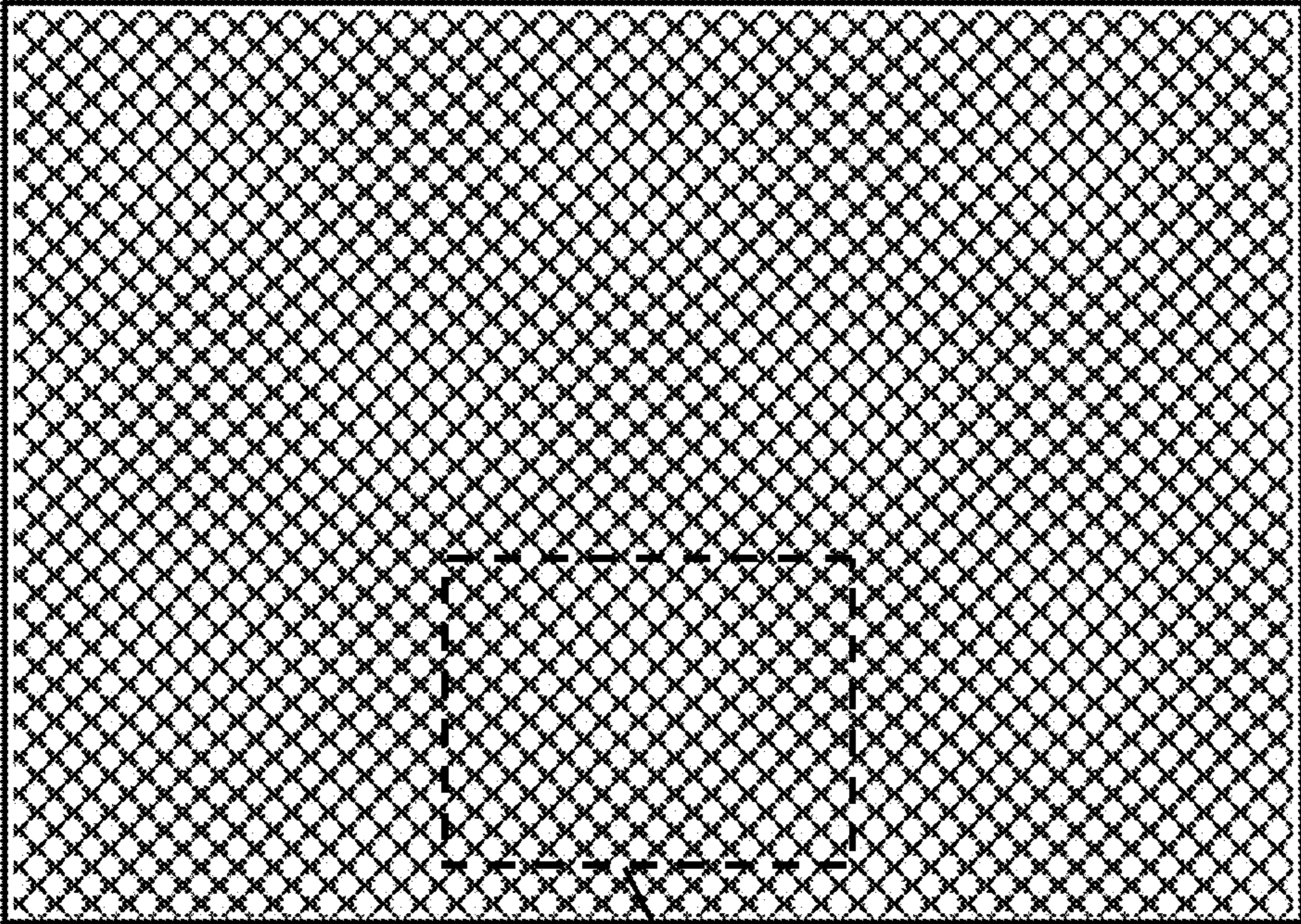

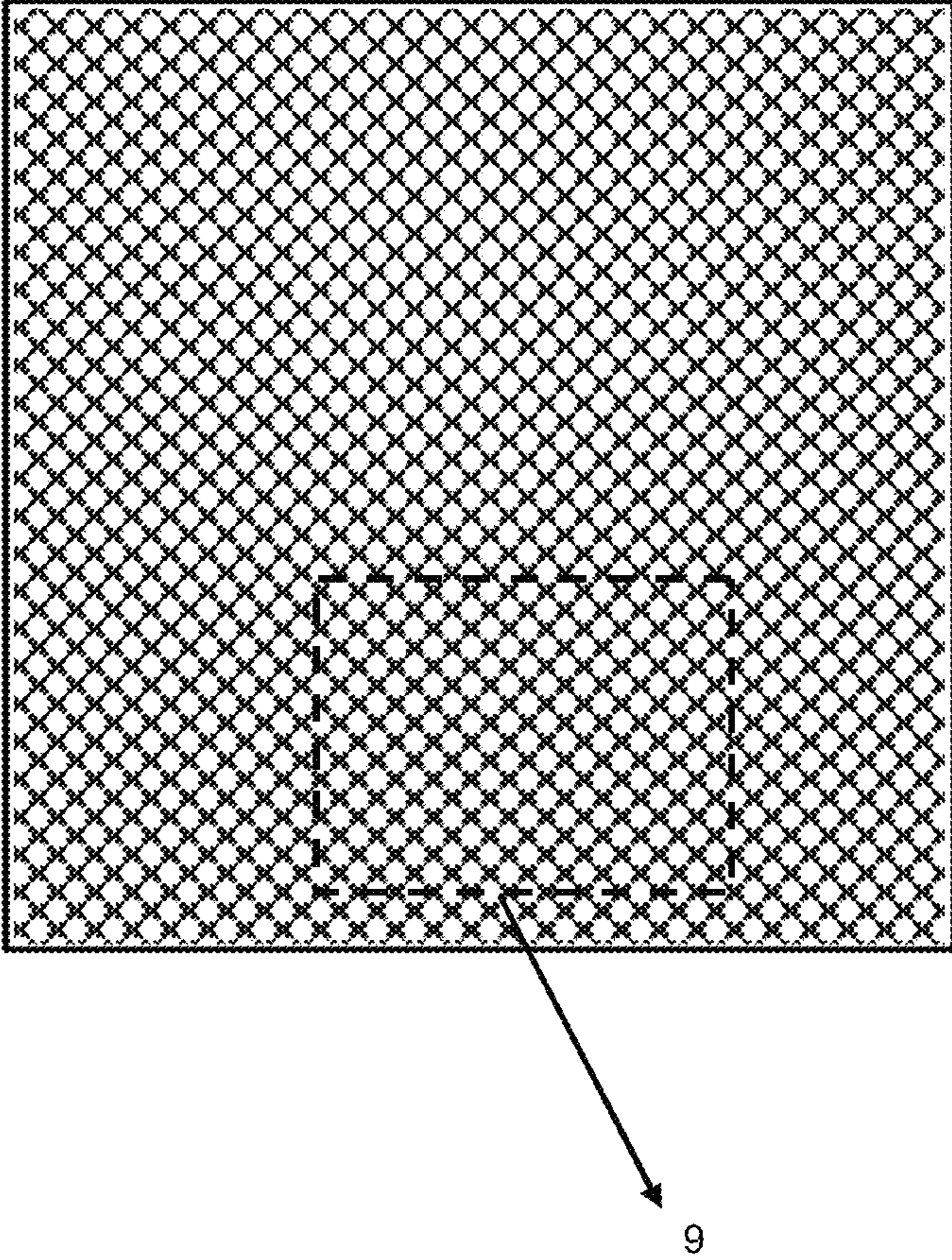
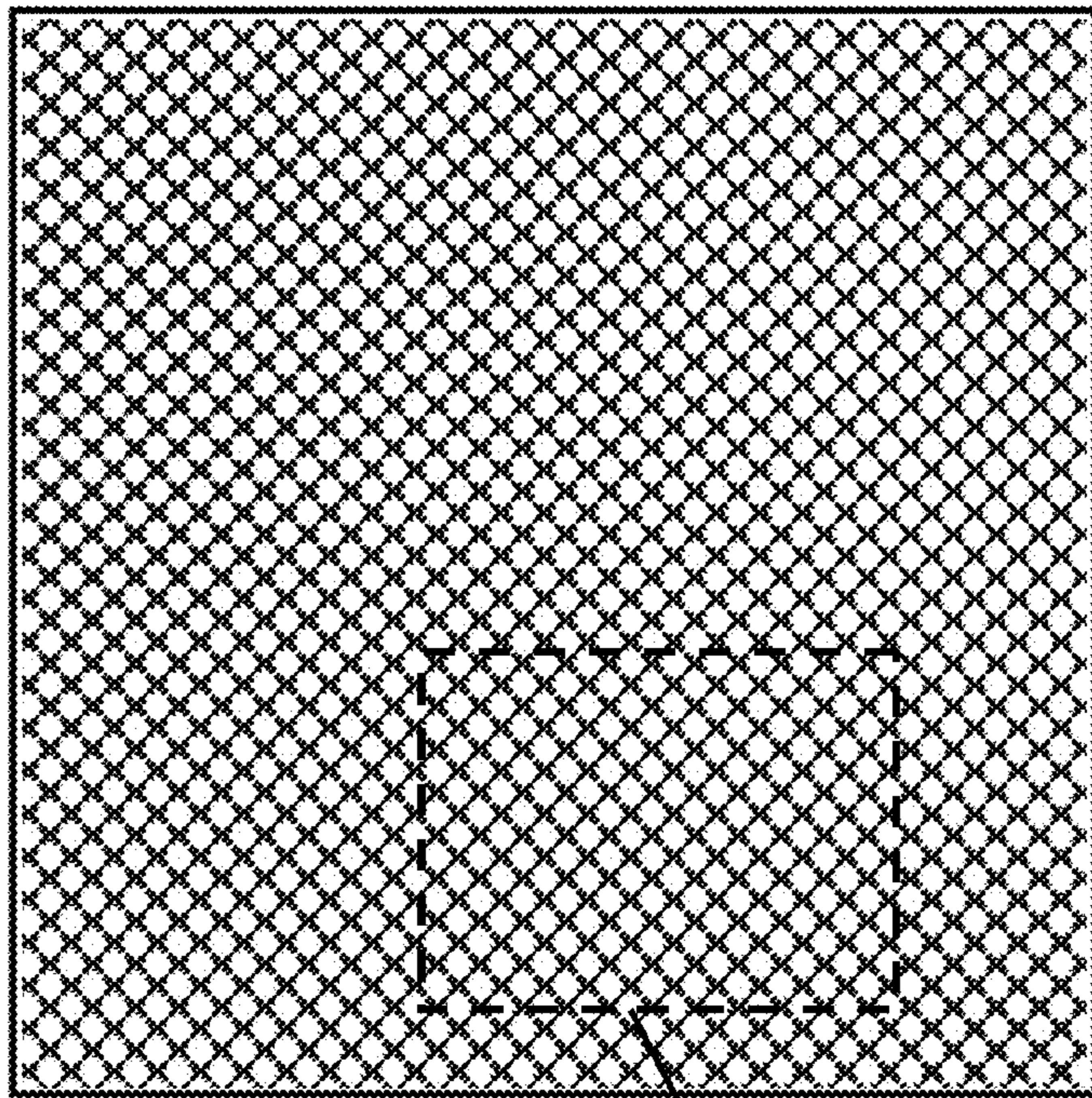

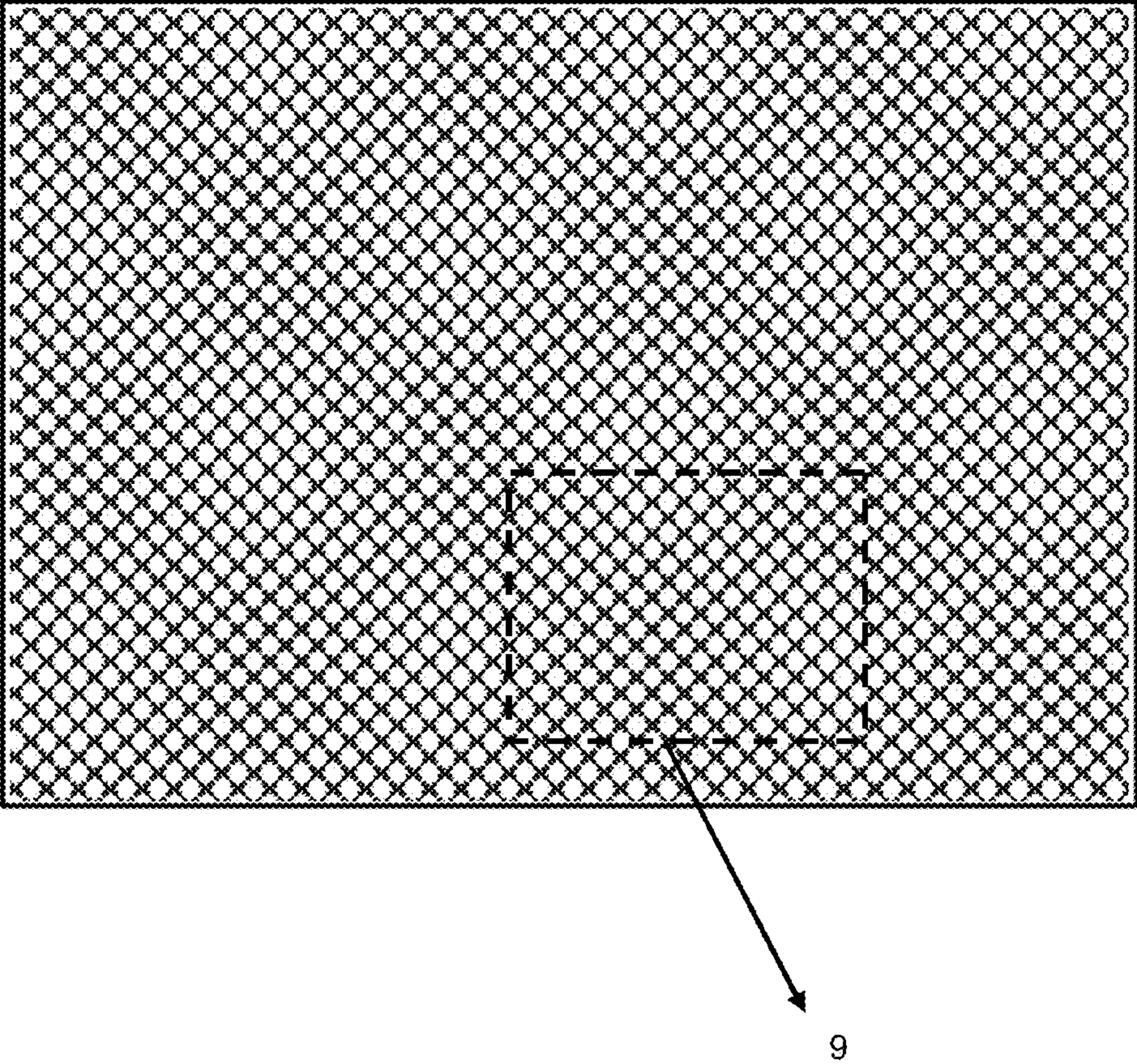
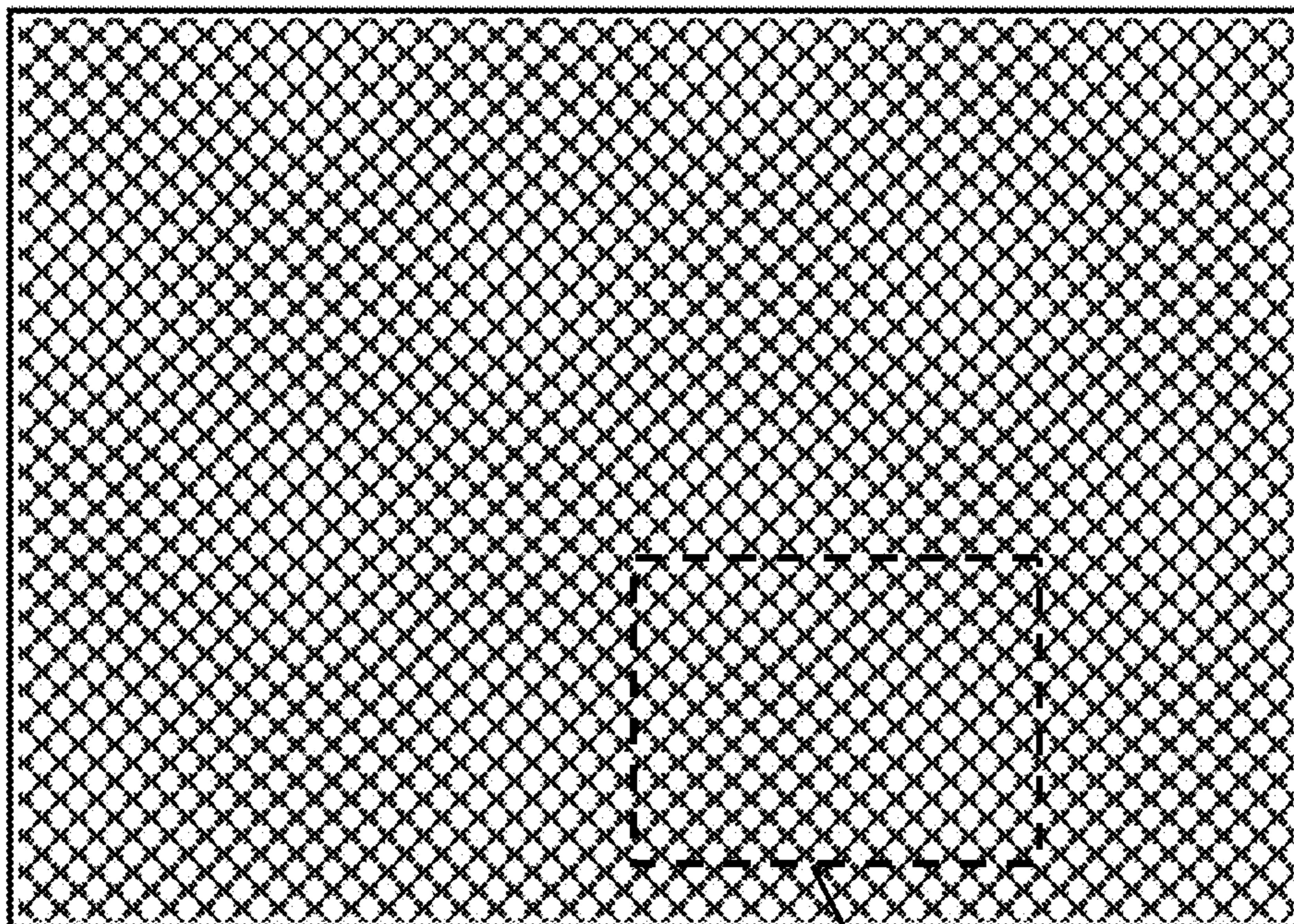
