**DESCRIPTION**

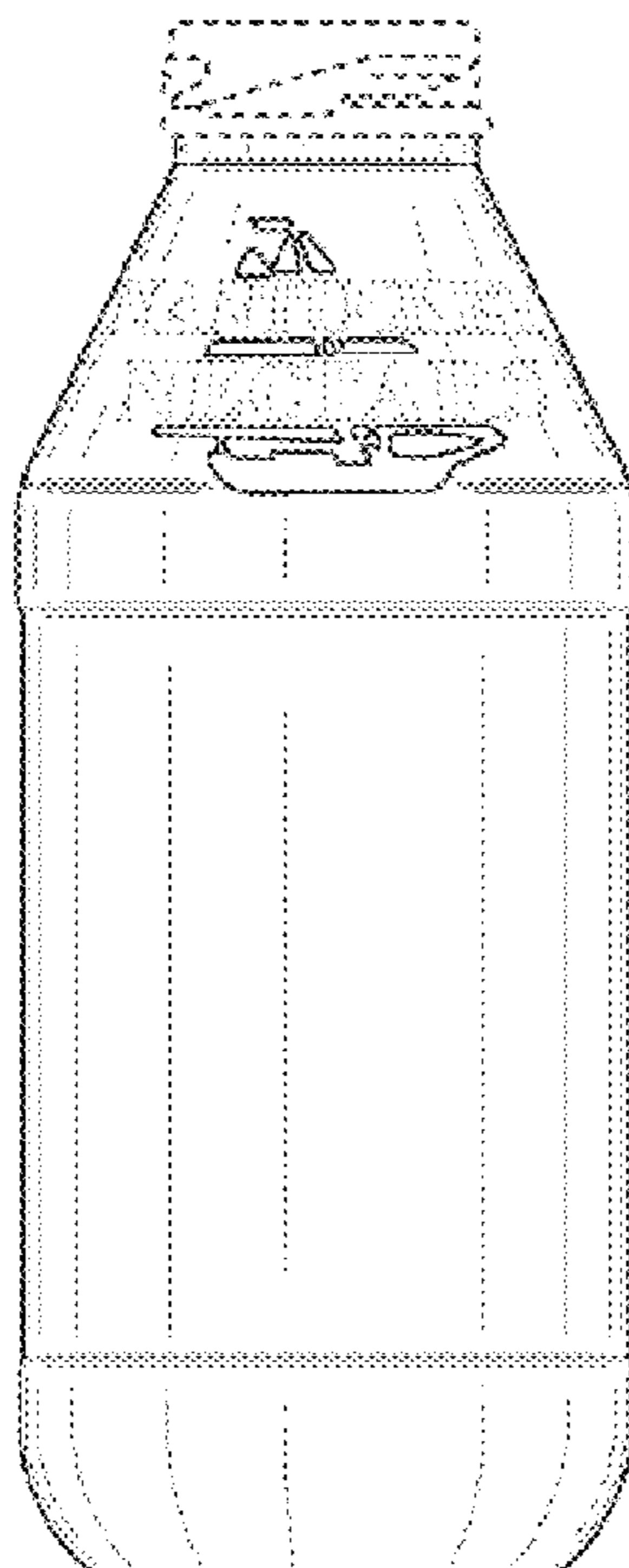
FIG. 1 is top, front, and right-side perspective view of the new design for a bottle;

 The broken lines in the drawings are for illustrative purposes only and form no part of the claimed design.

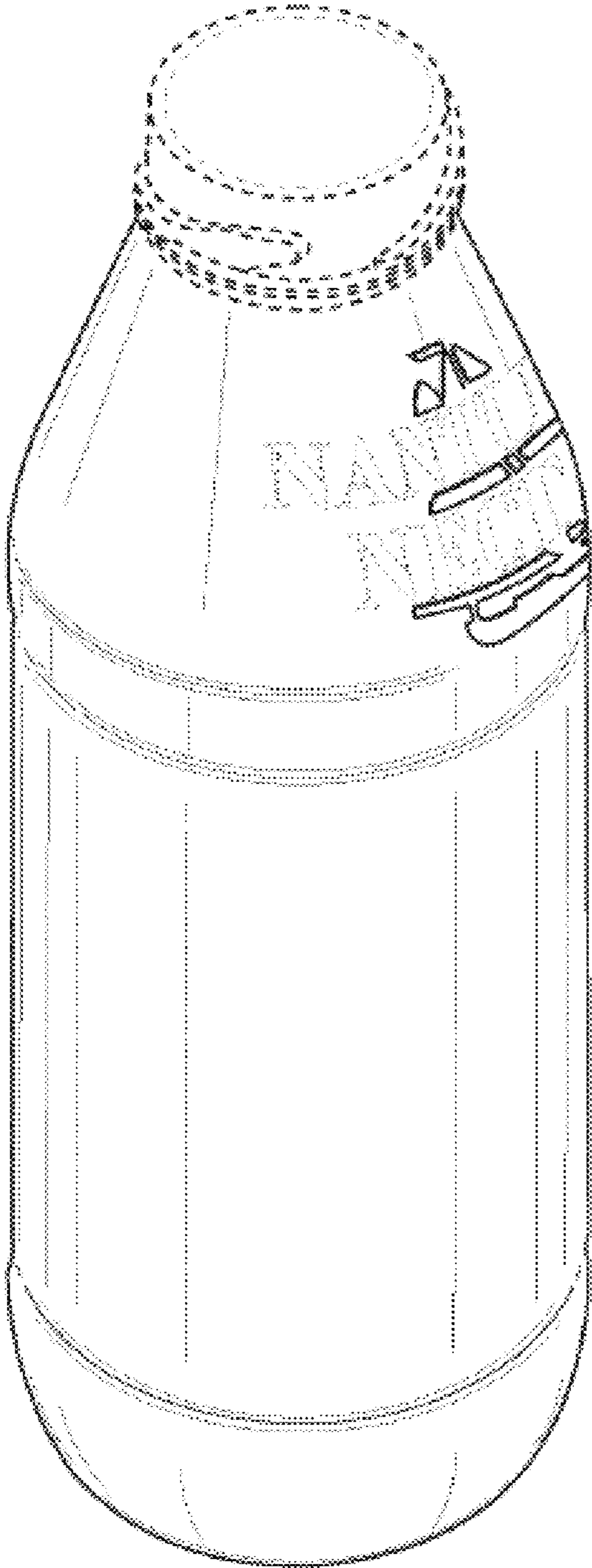

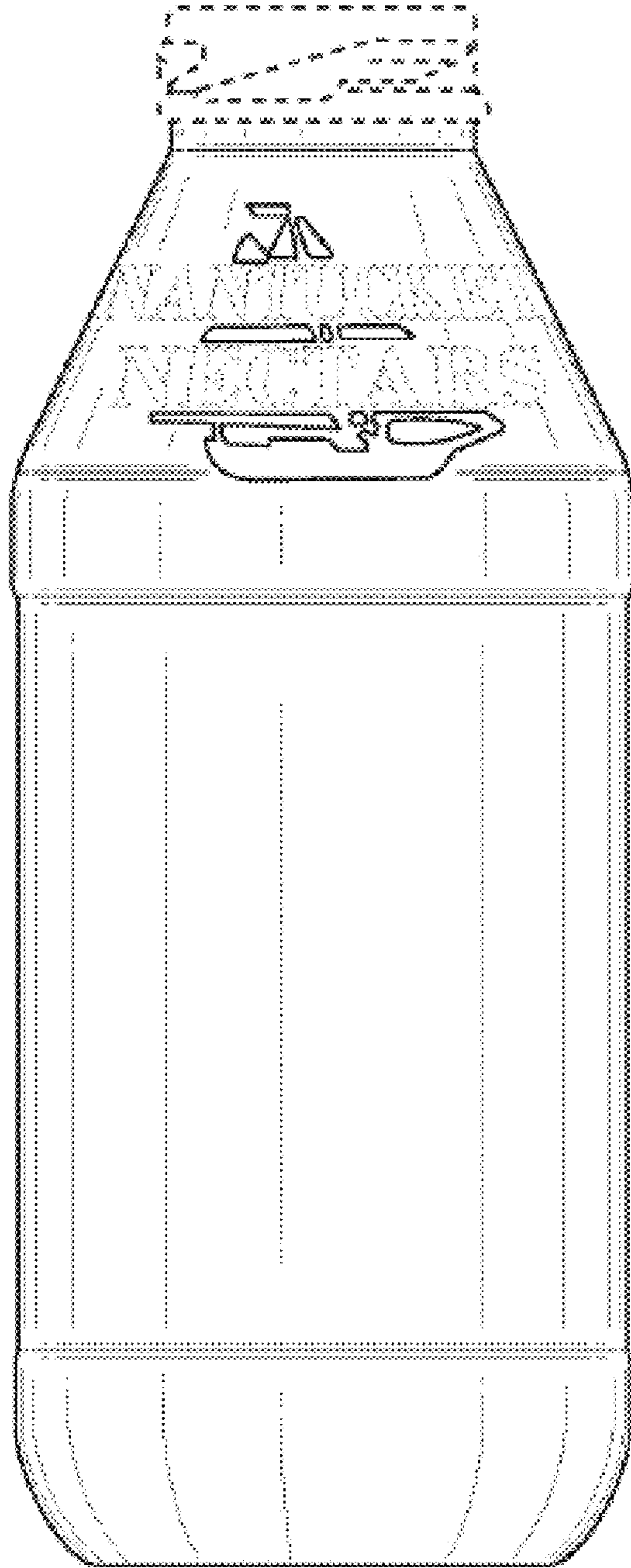

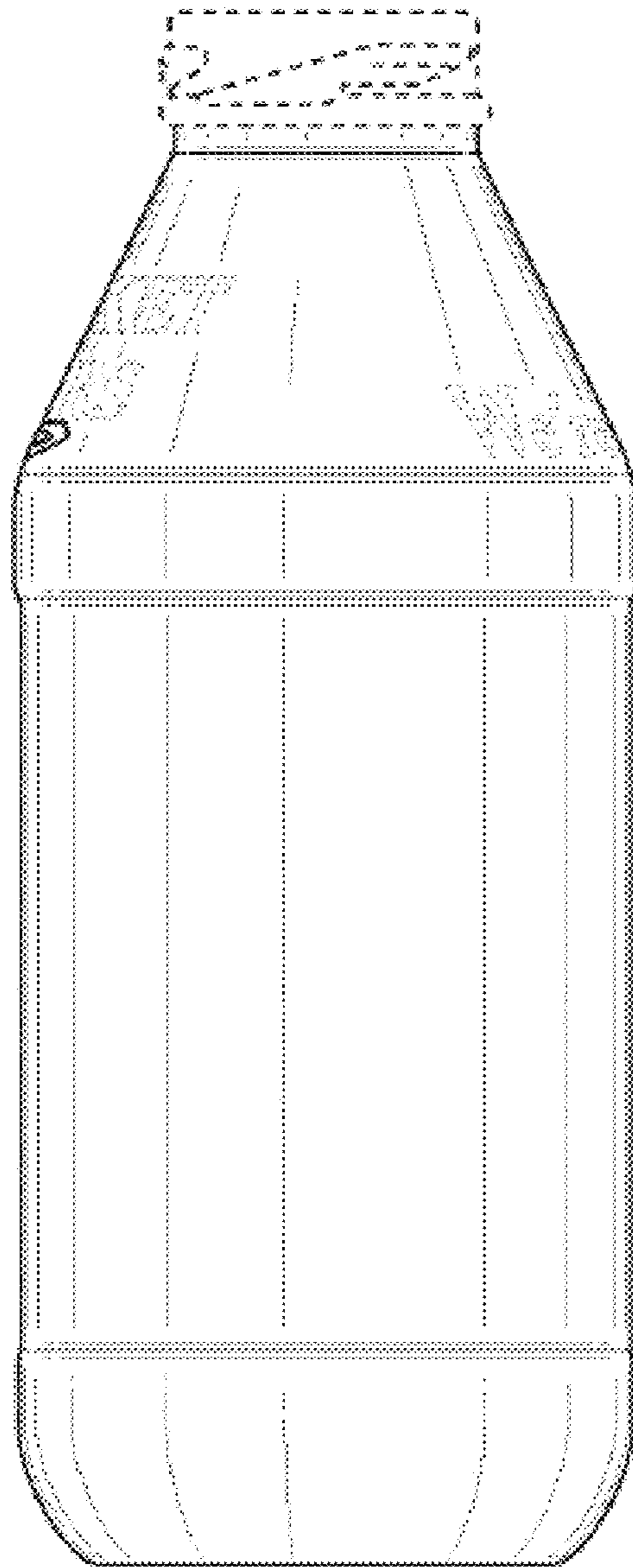




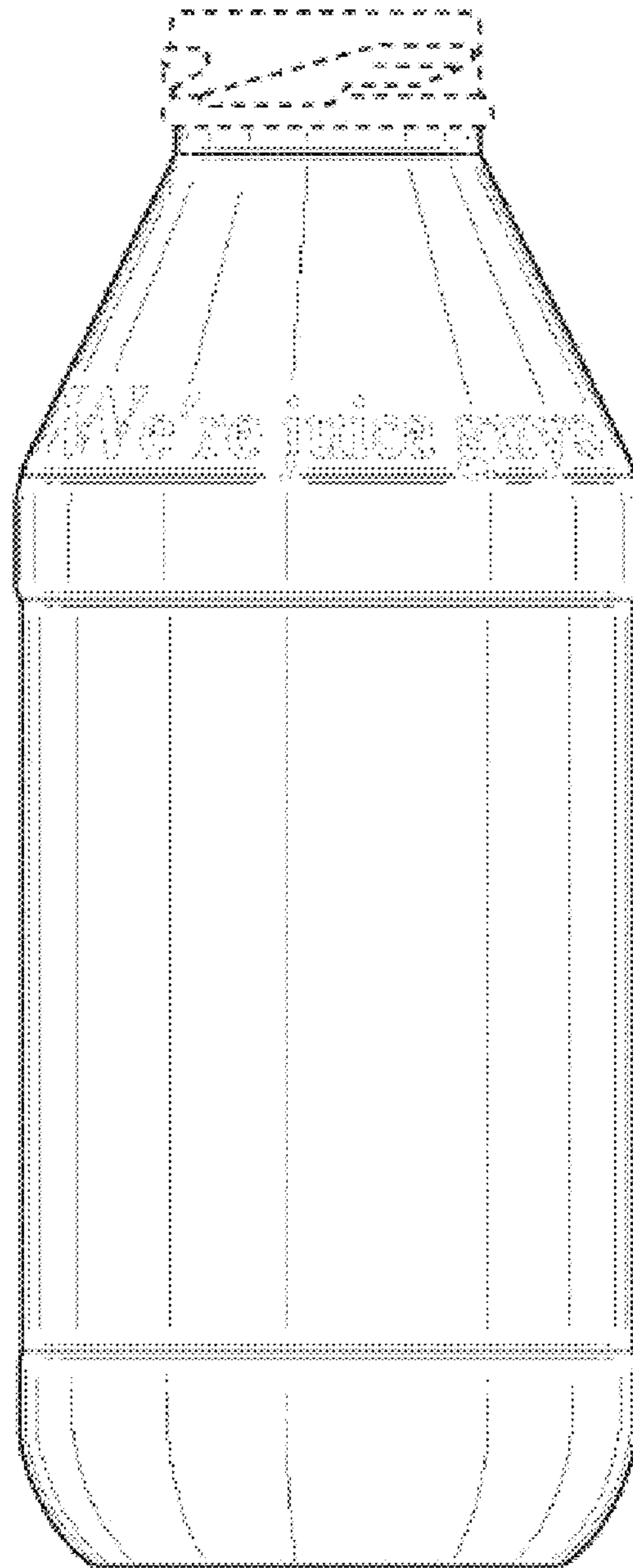

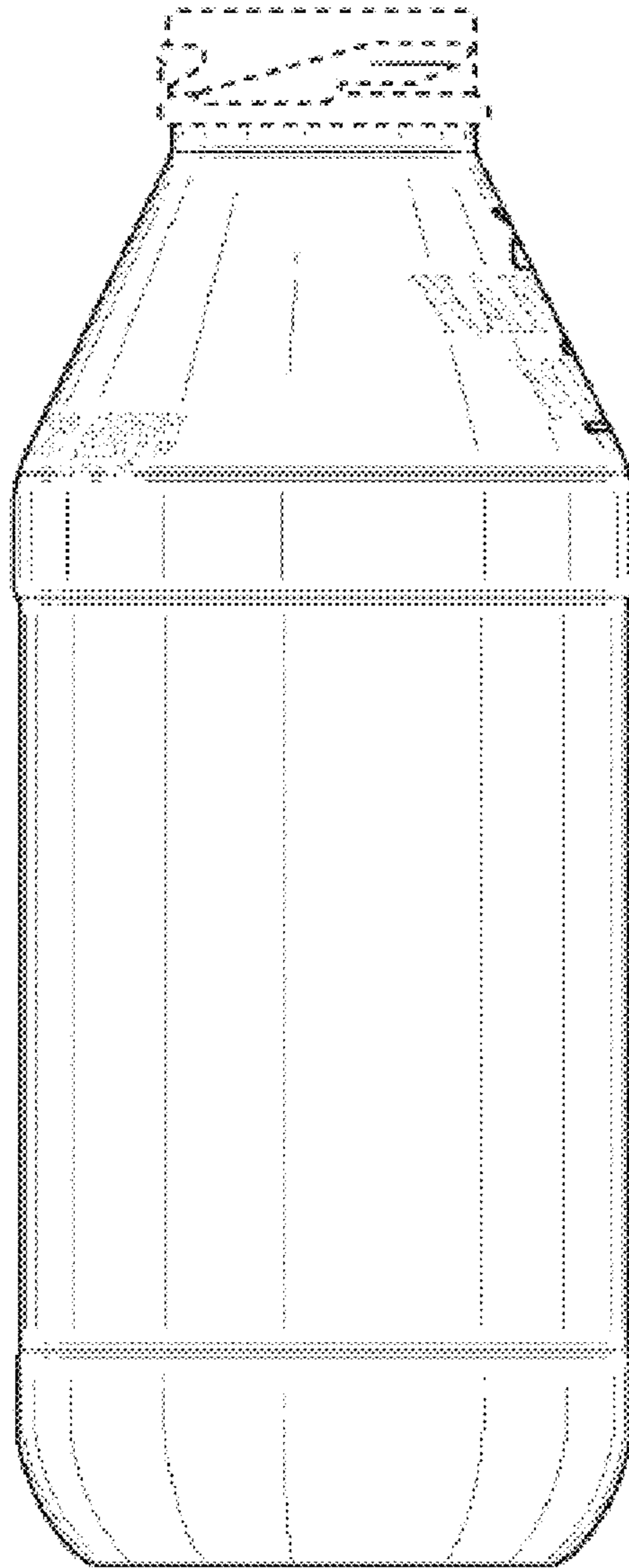

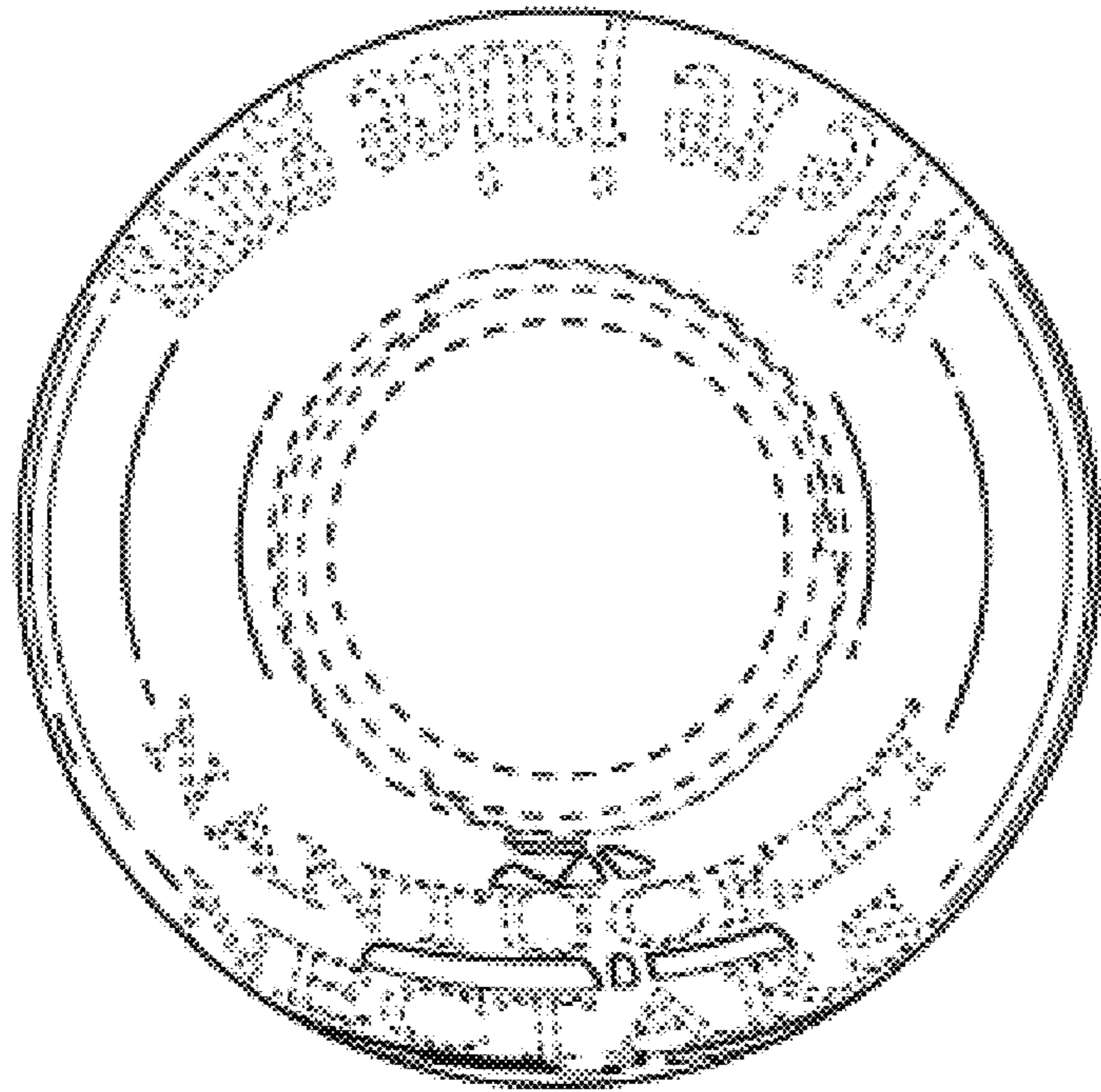

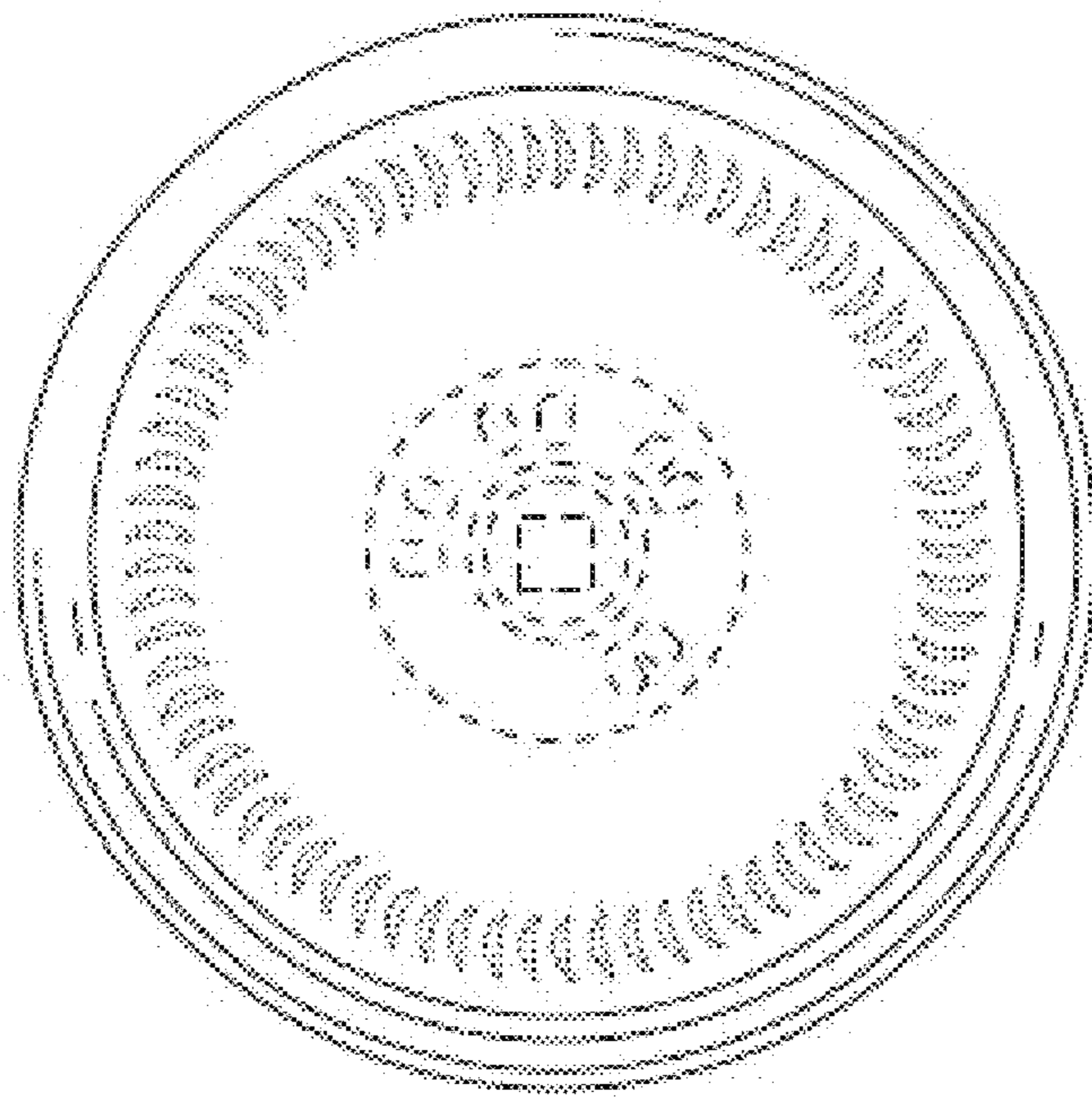
