FIG. 2 is a bottom perspective view thereof.

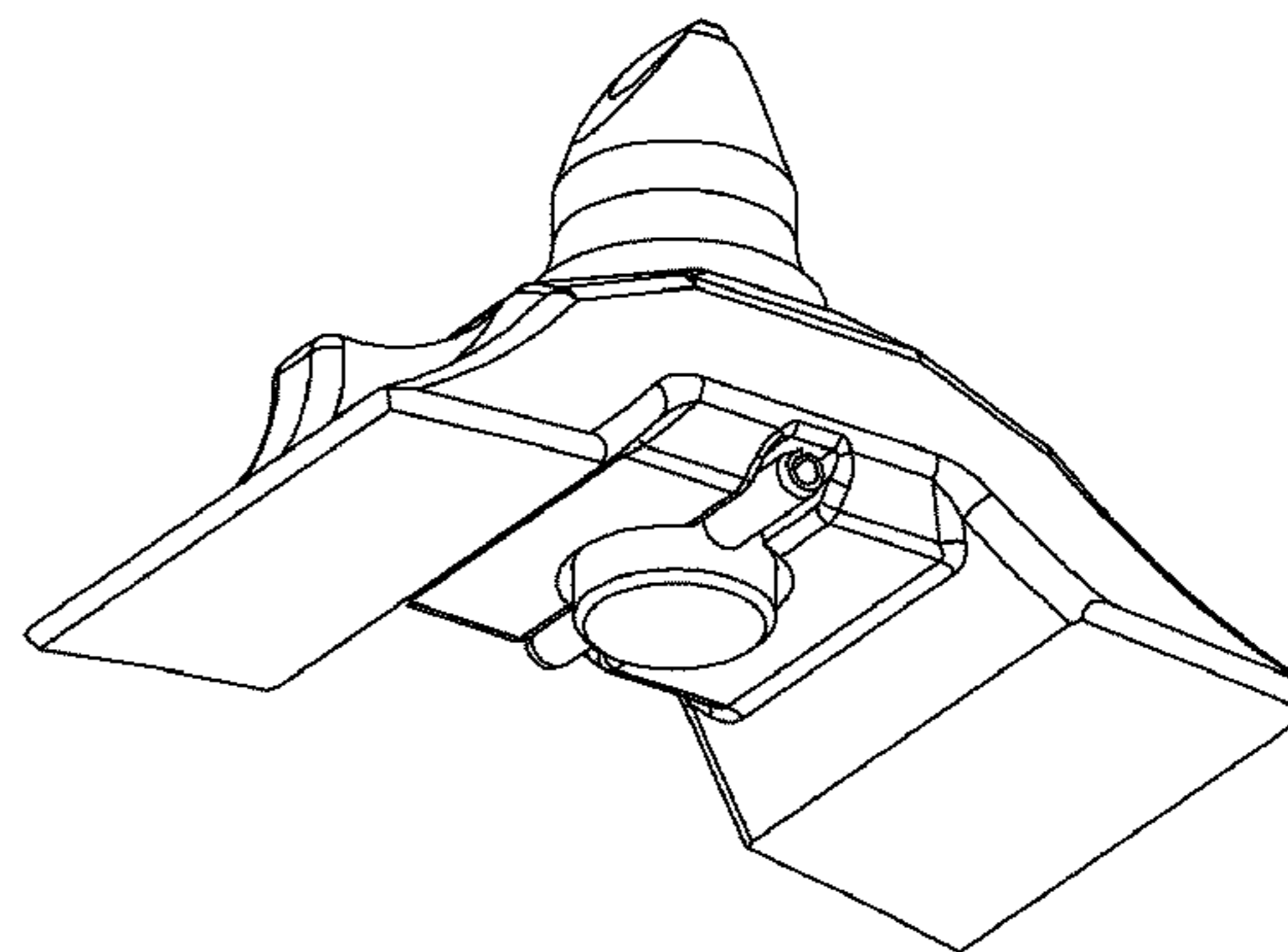
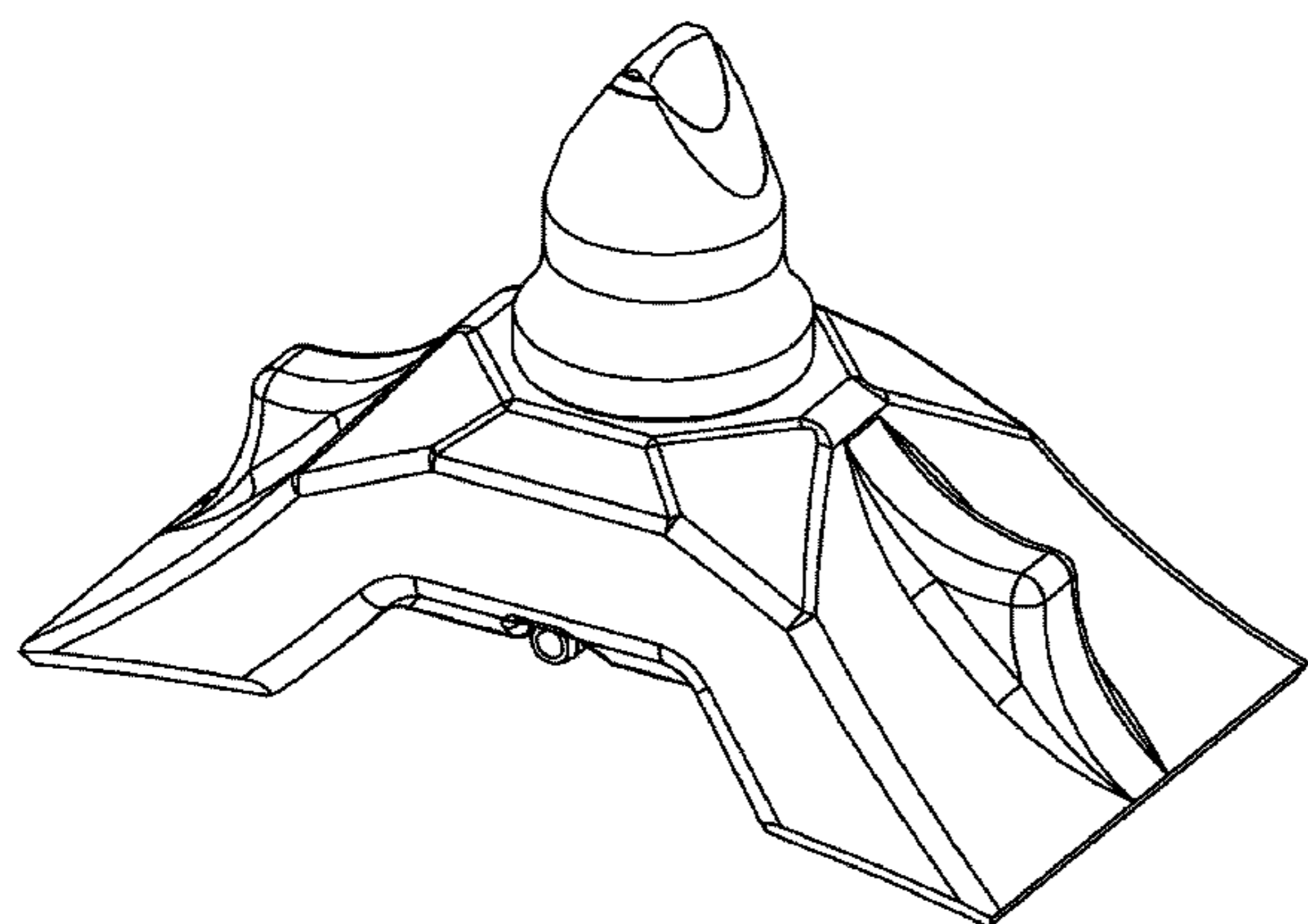
FIG. 3 is a right side view thereof, the left side view being a mirror image of the right side view.

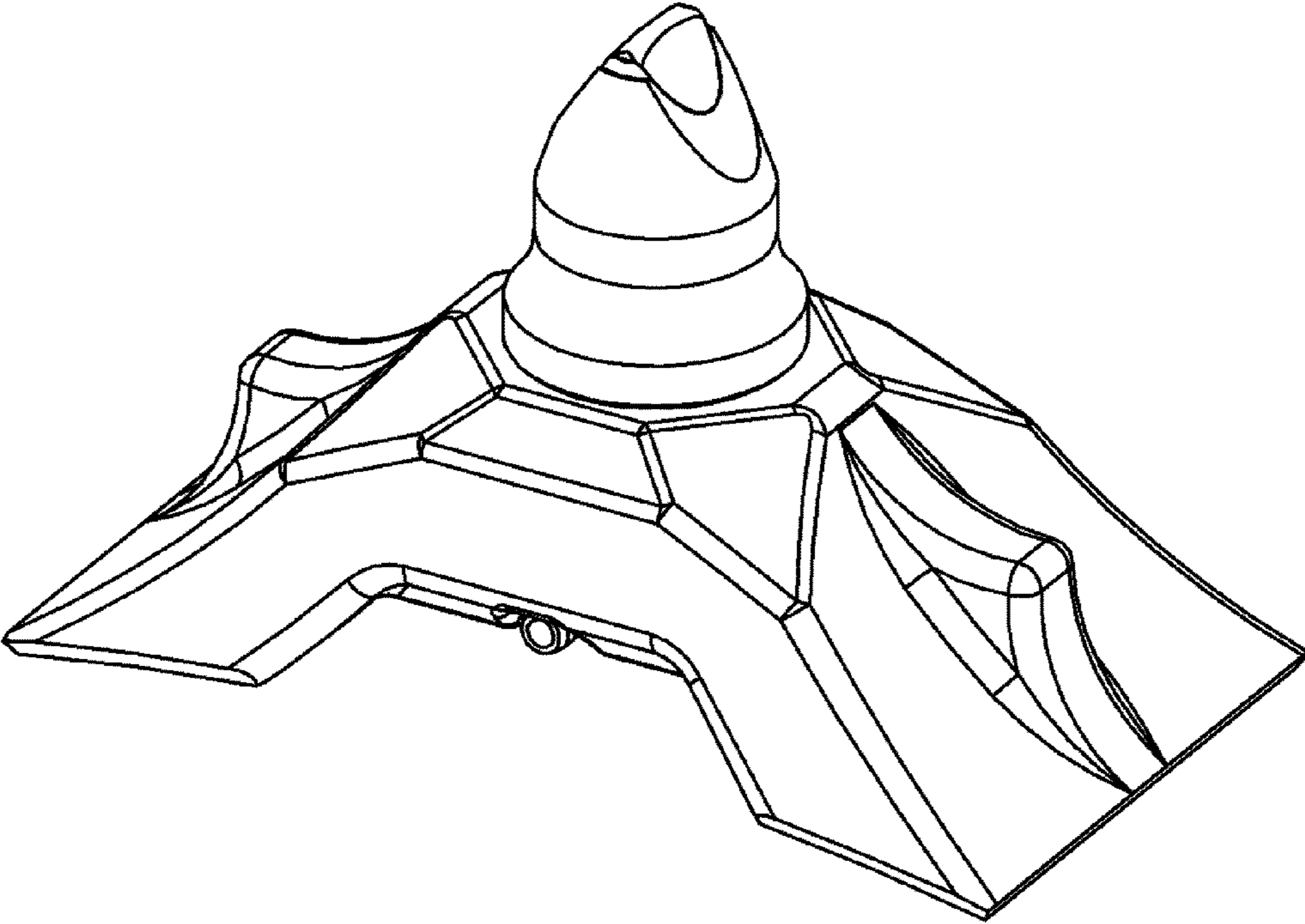

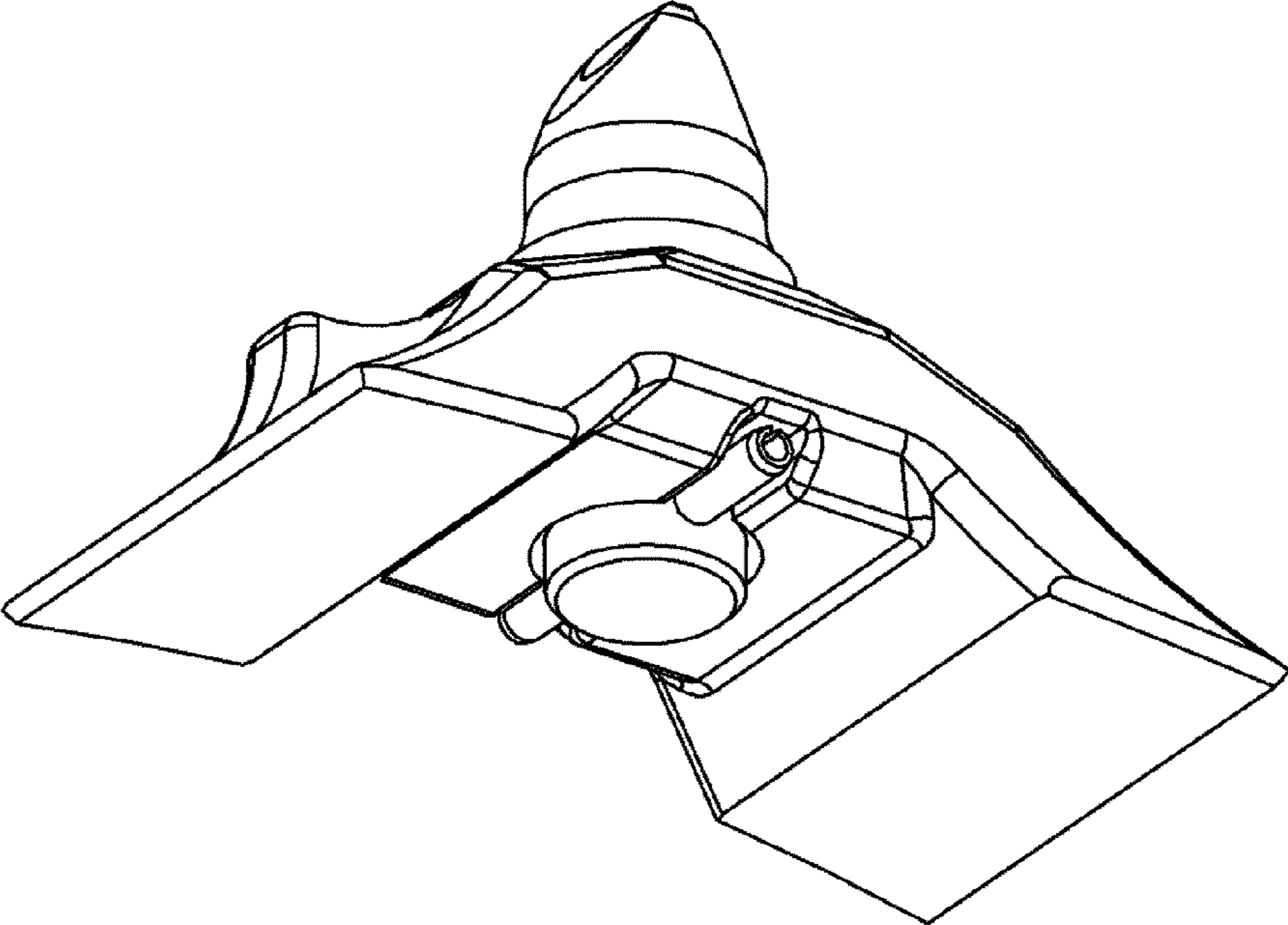

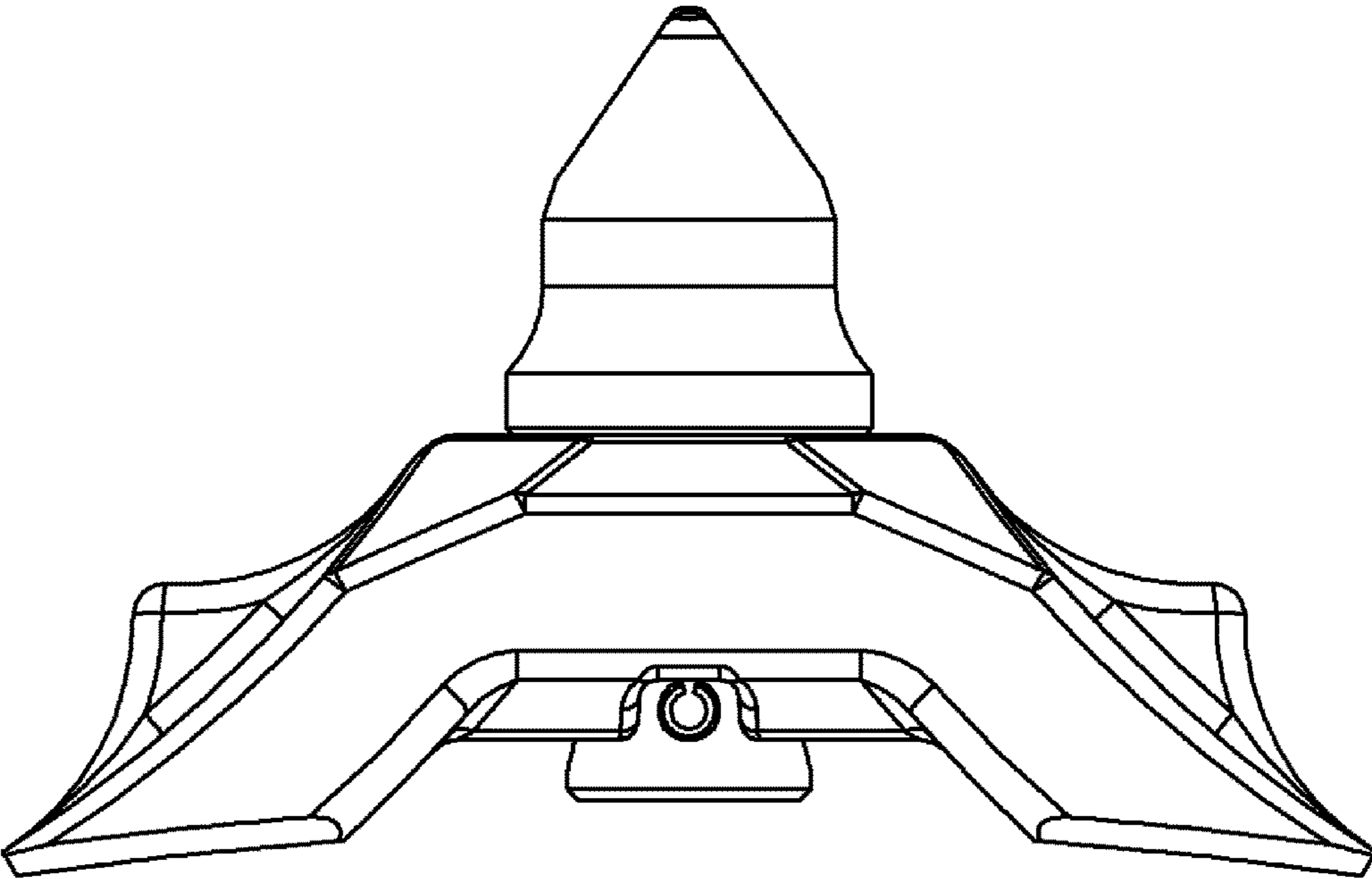

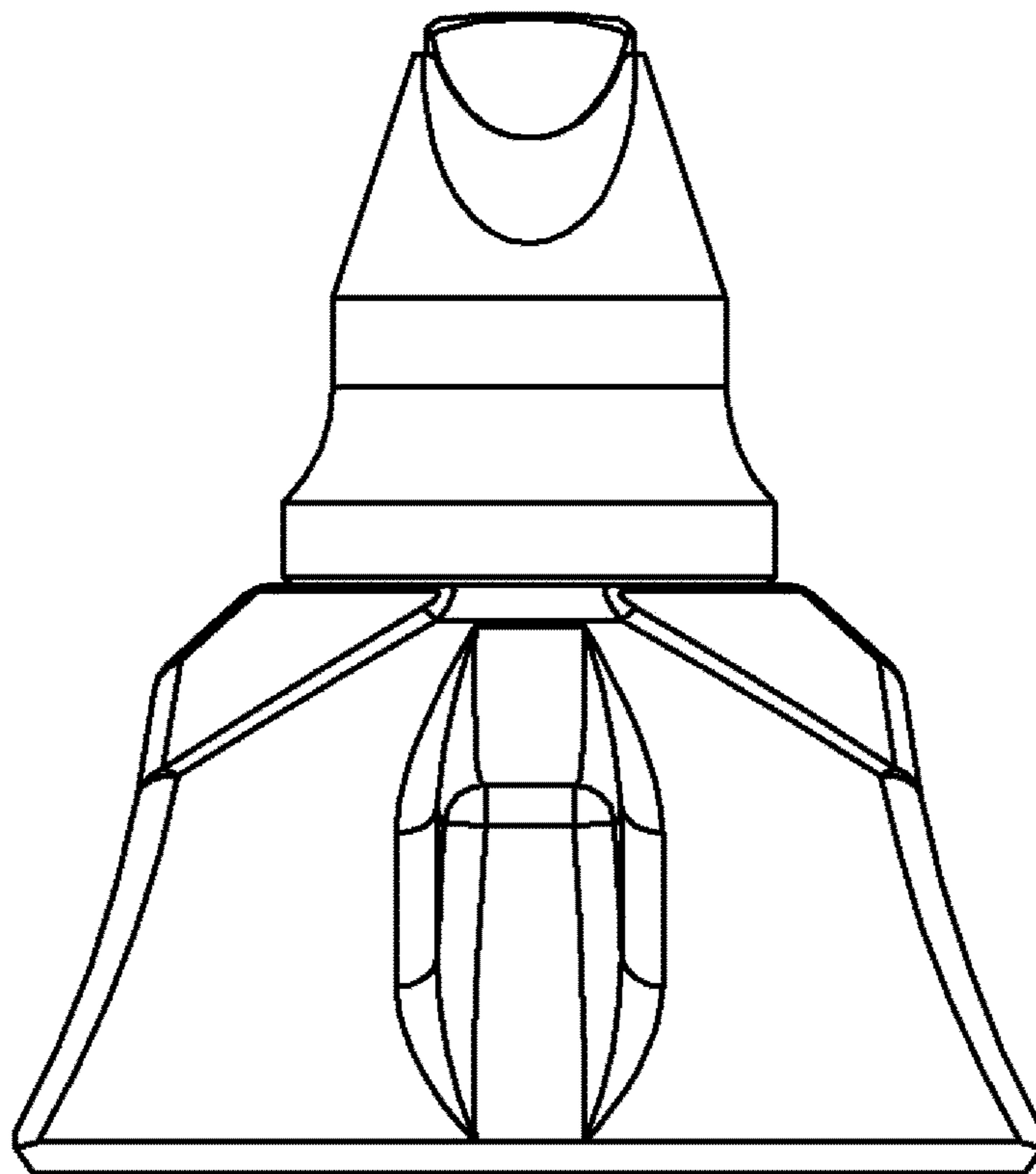

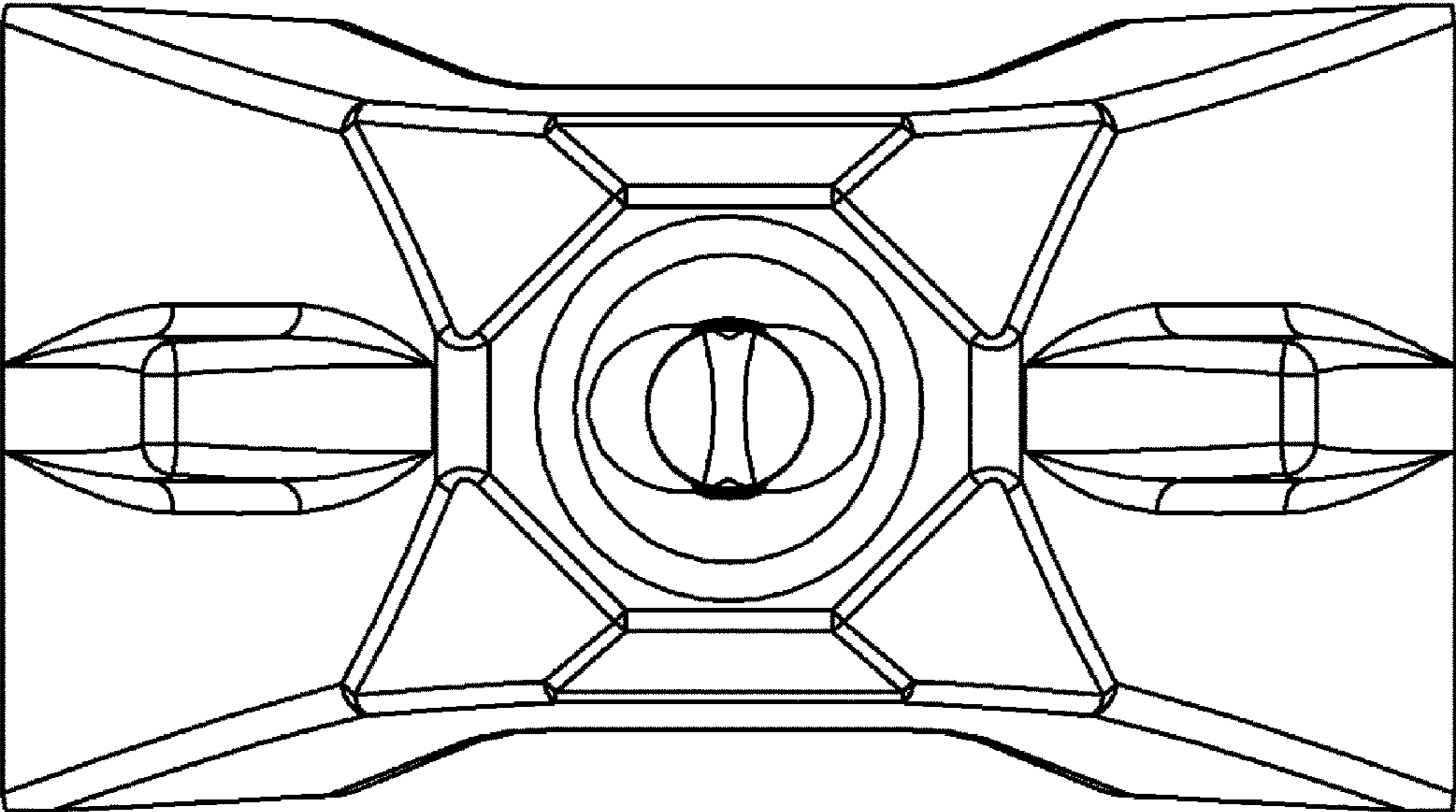

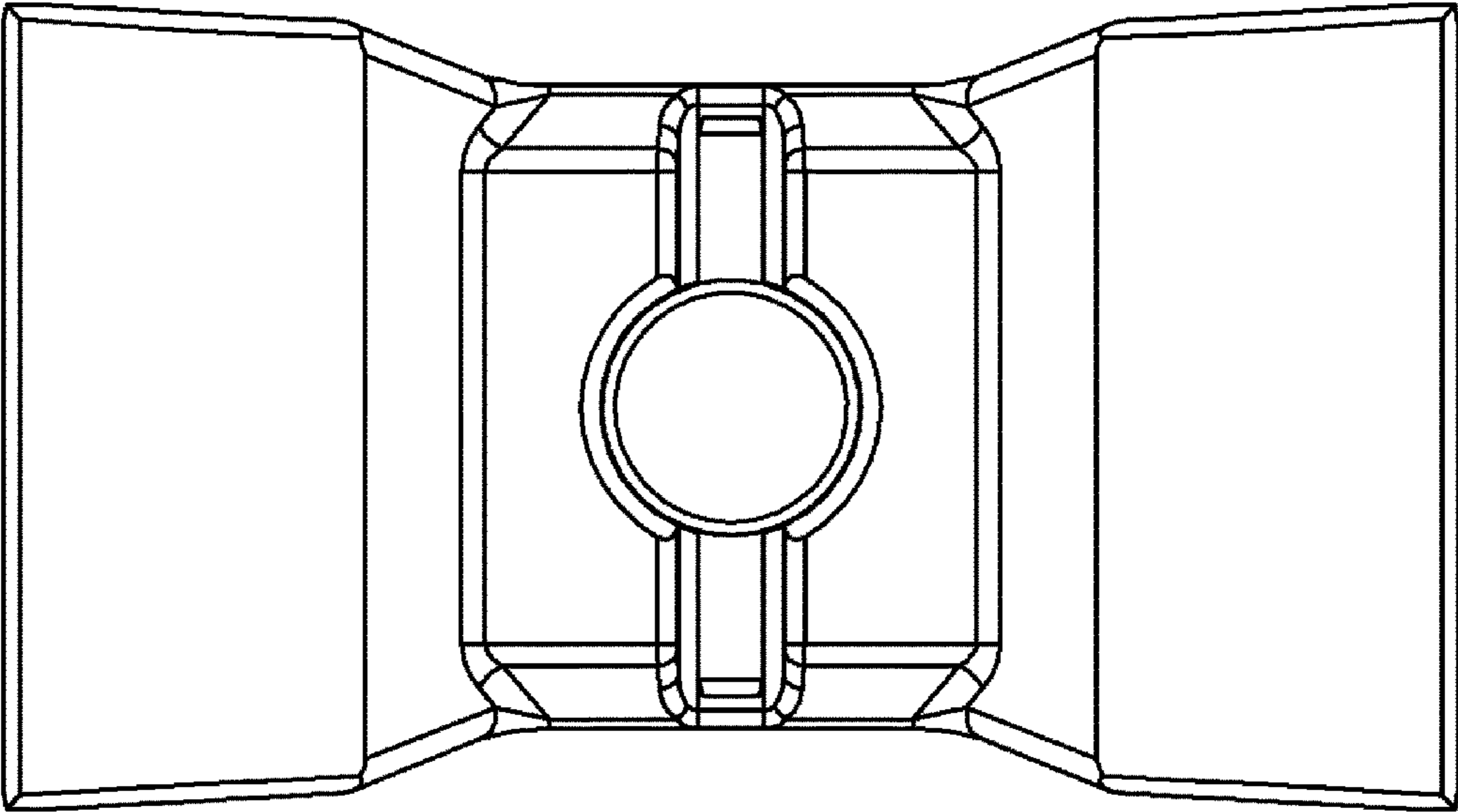
