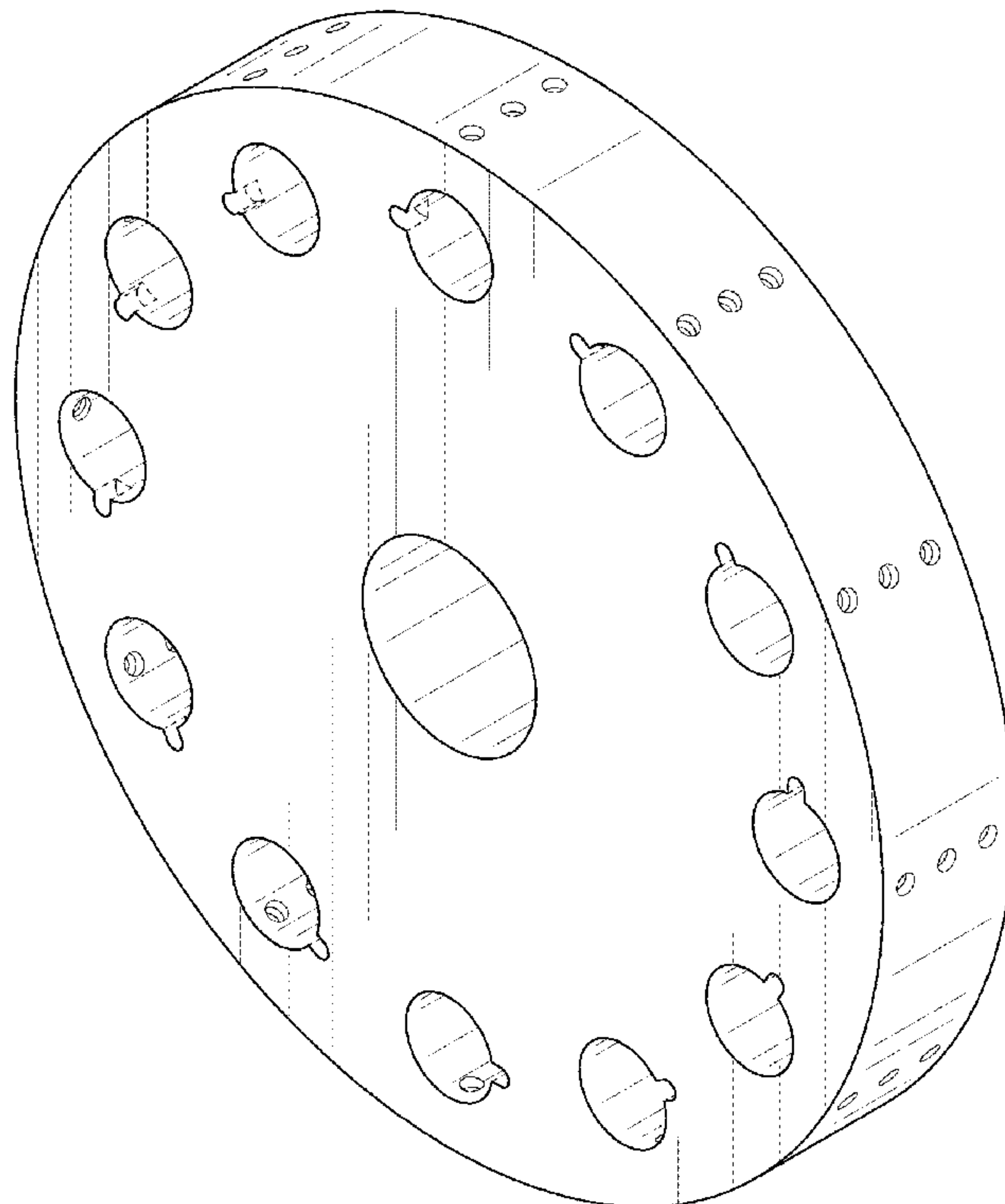
FIG. 1 is a perspective view of one embodiment of a turret showing the new design;

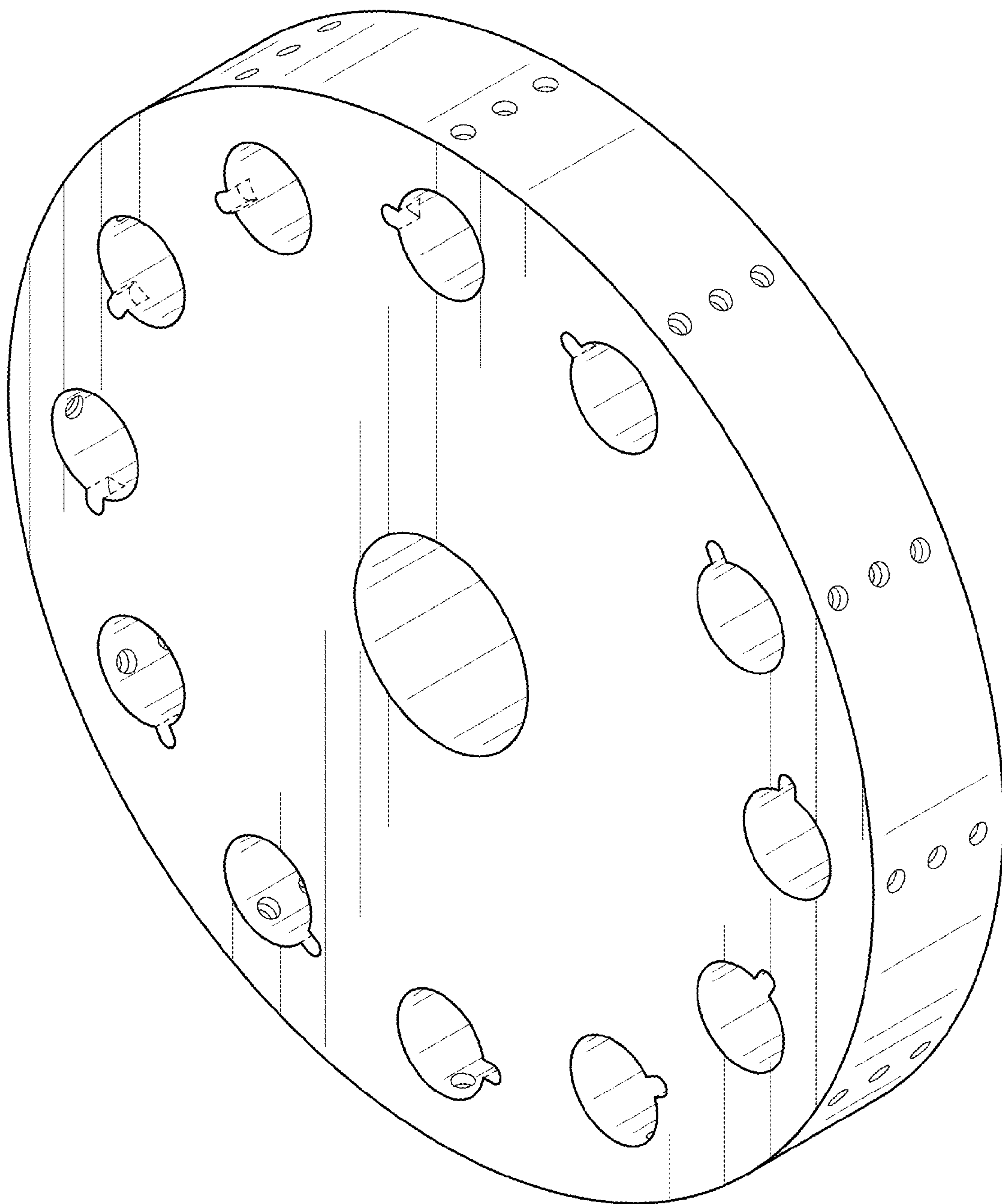

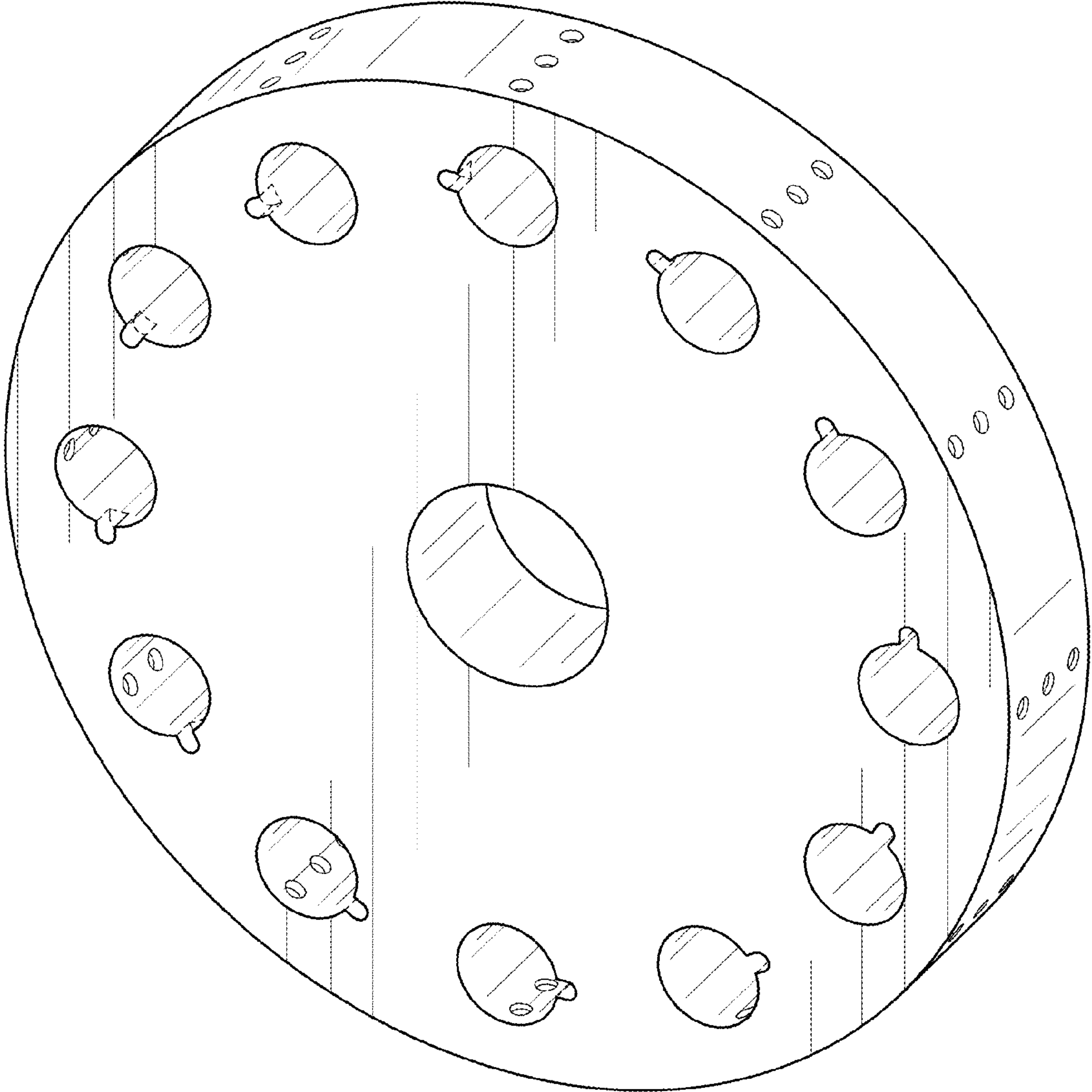

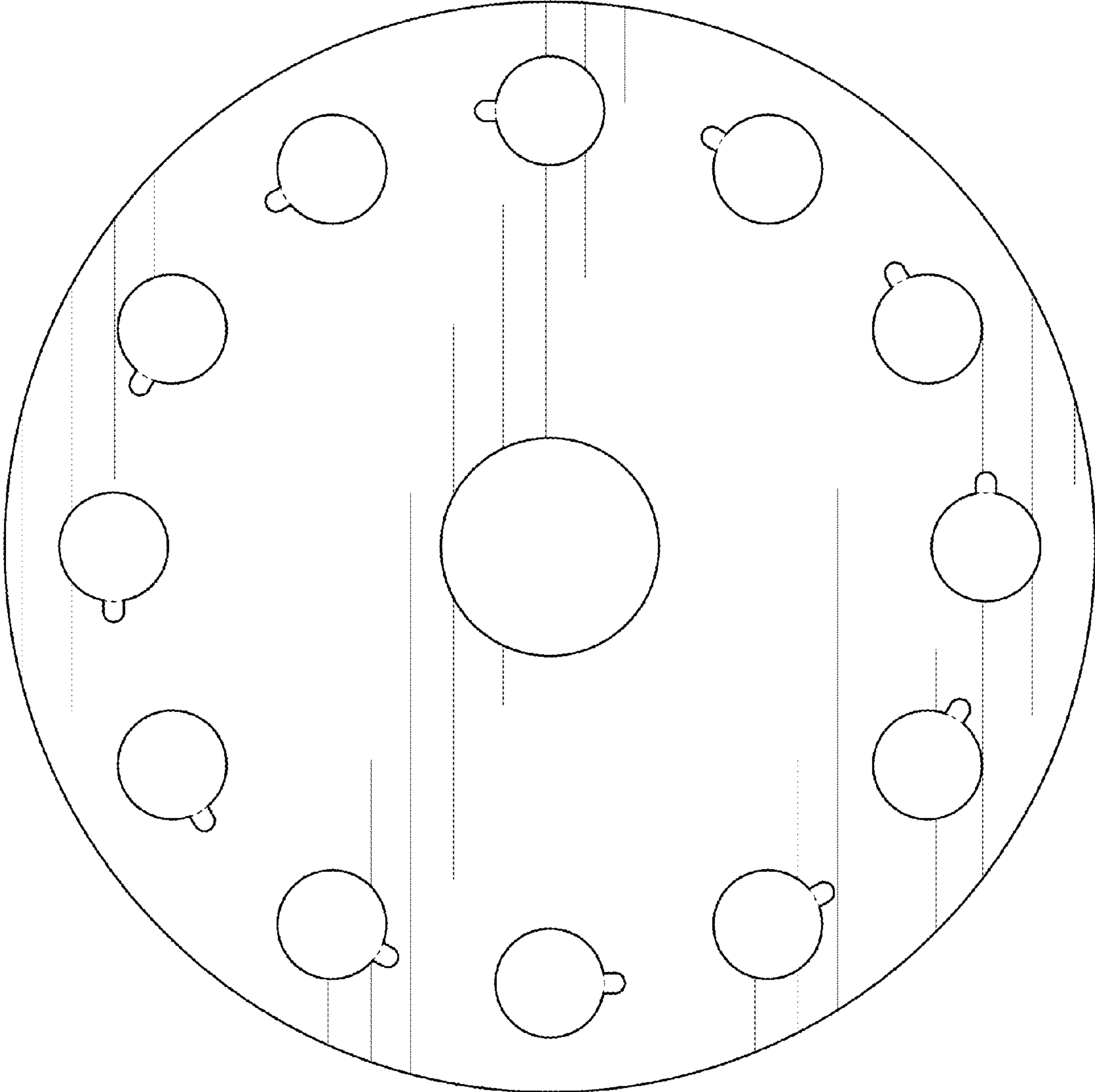
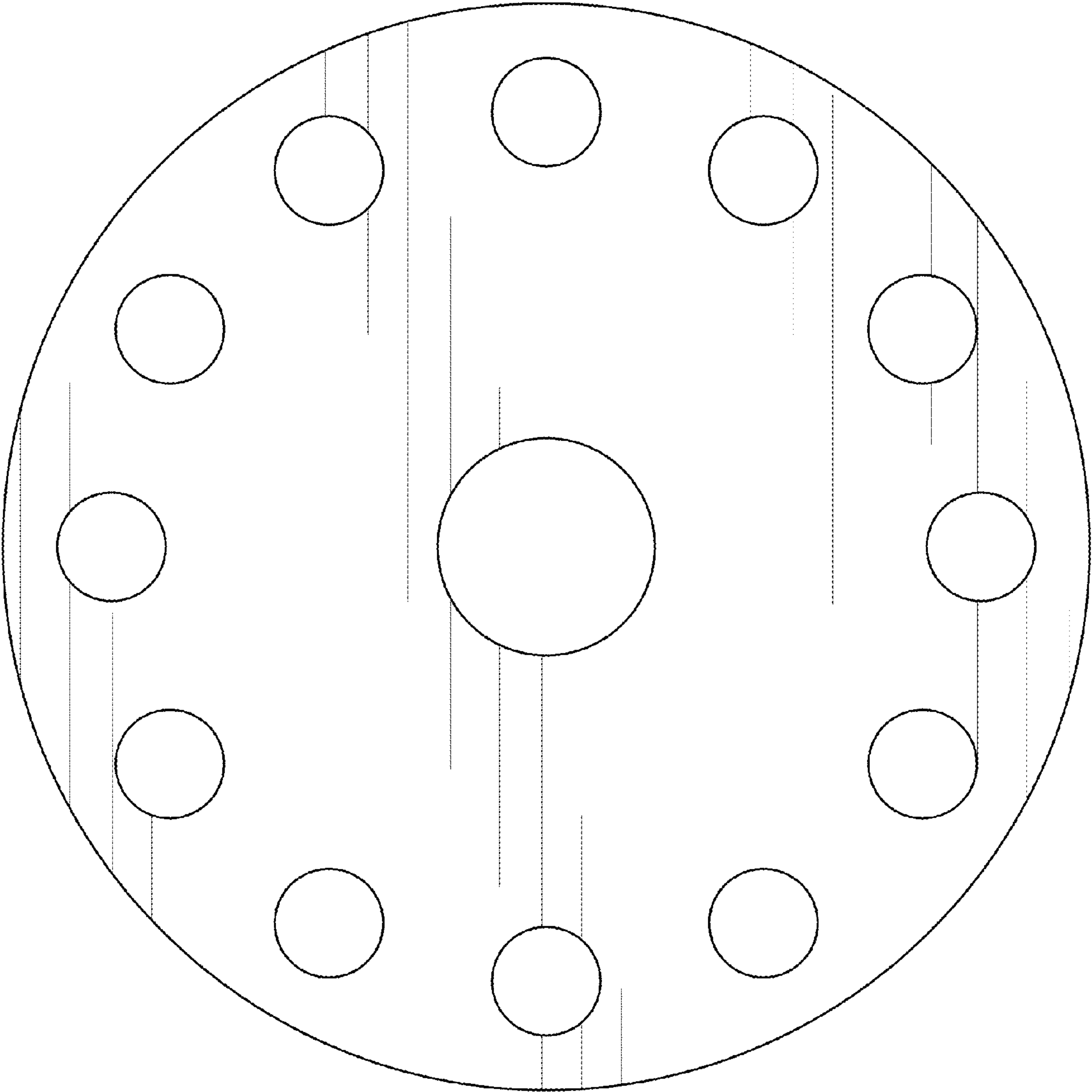
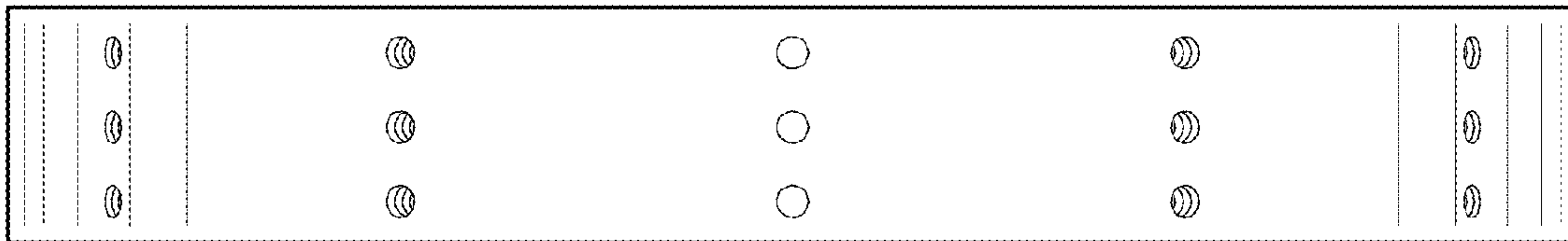

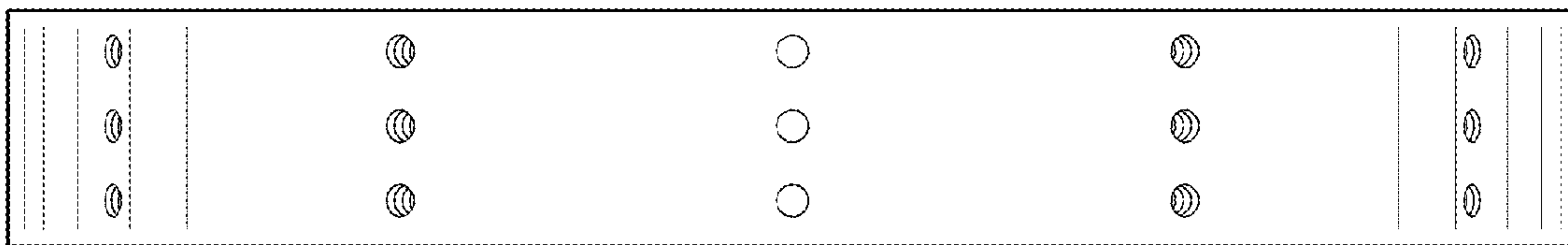

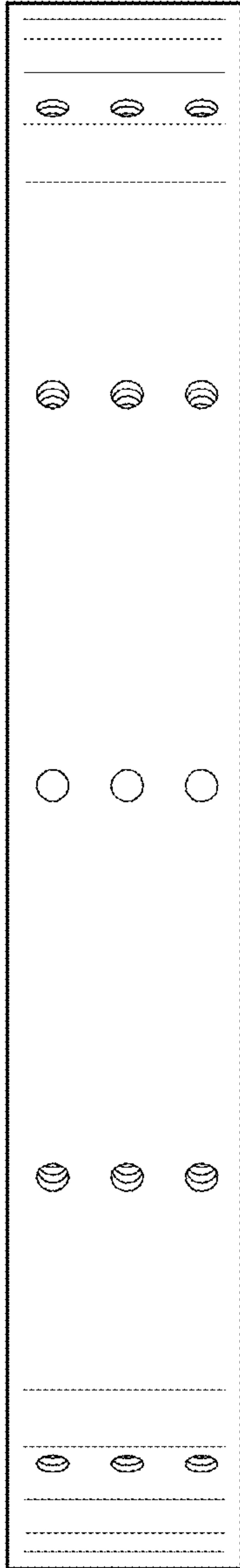




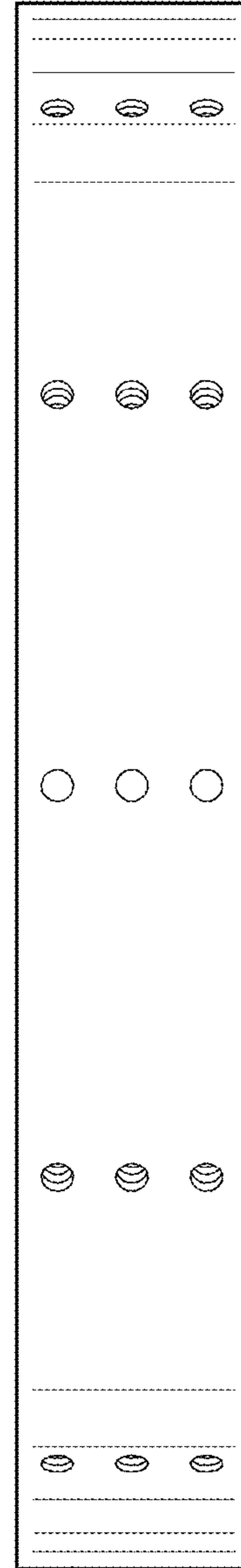

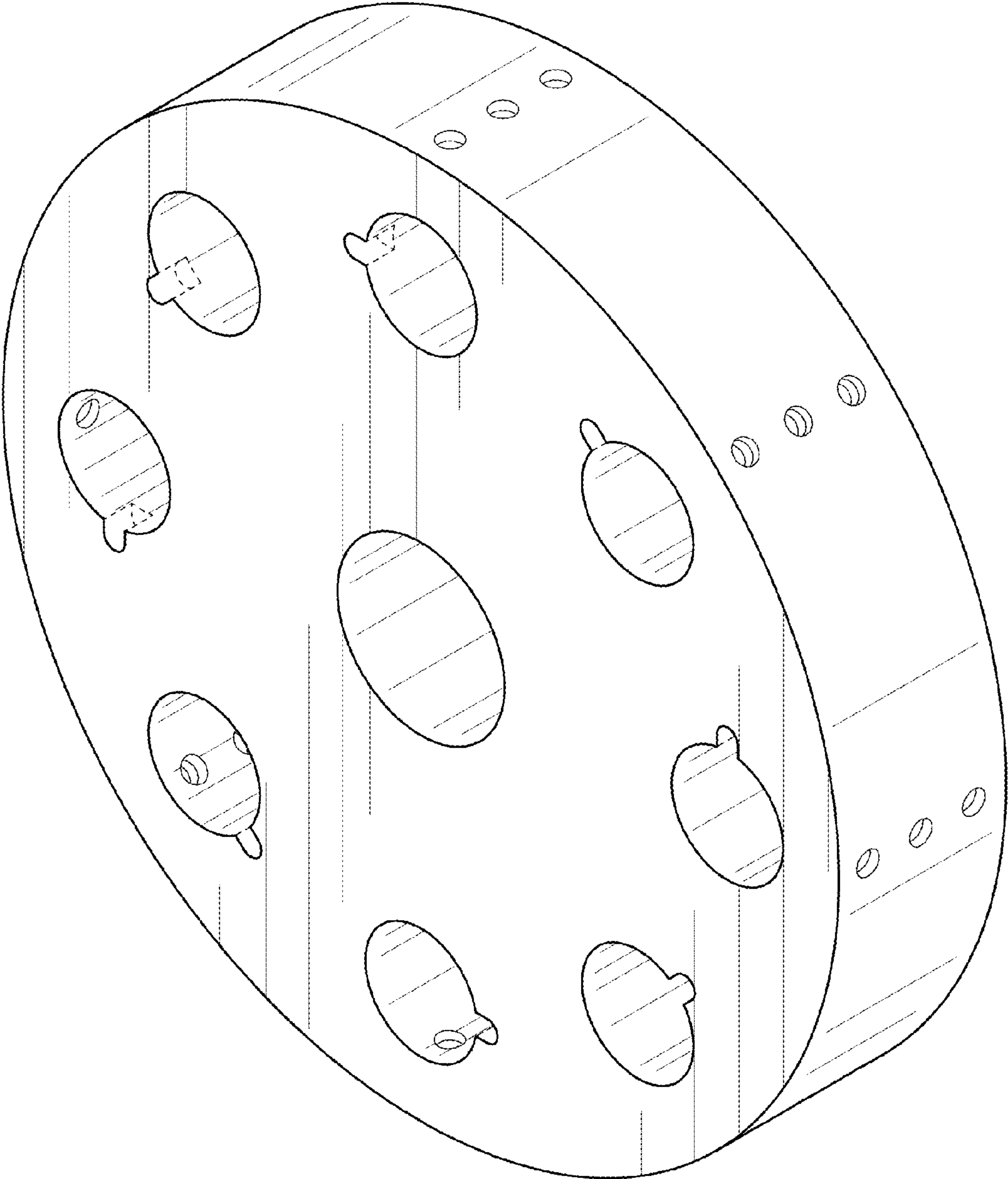
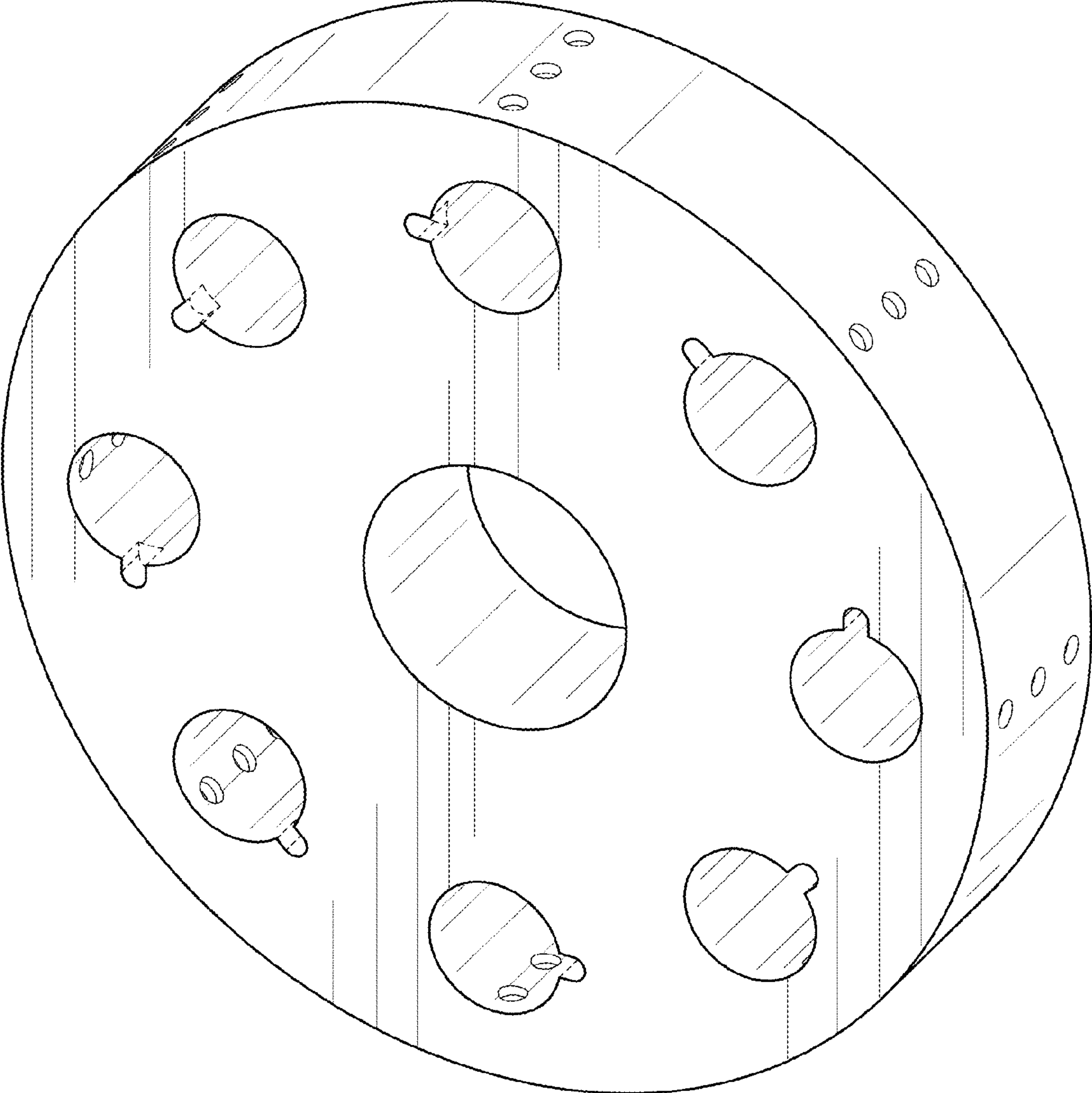
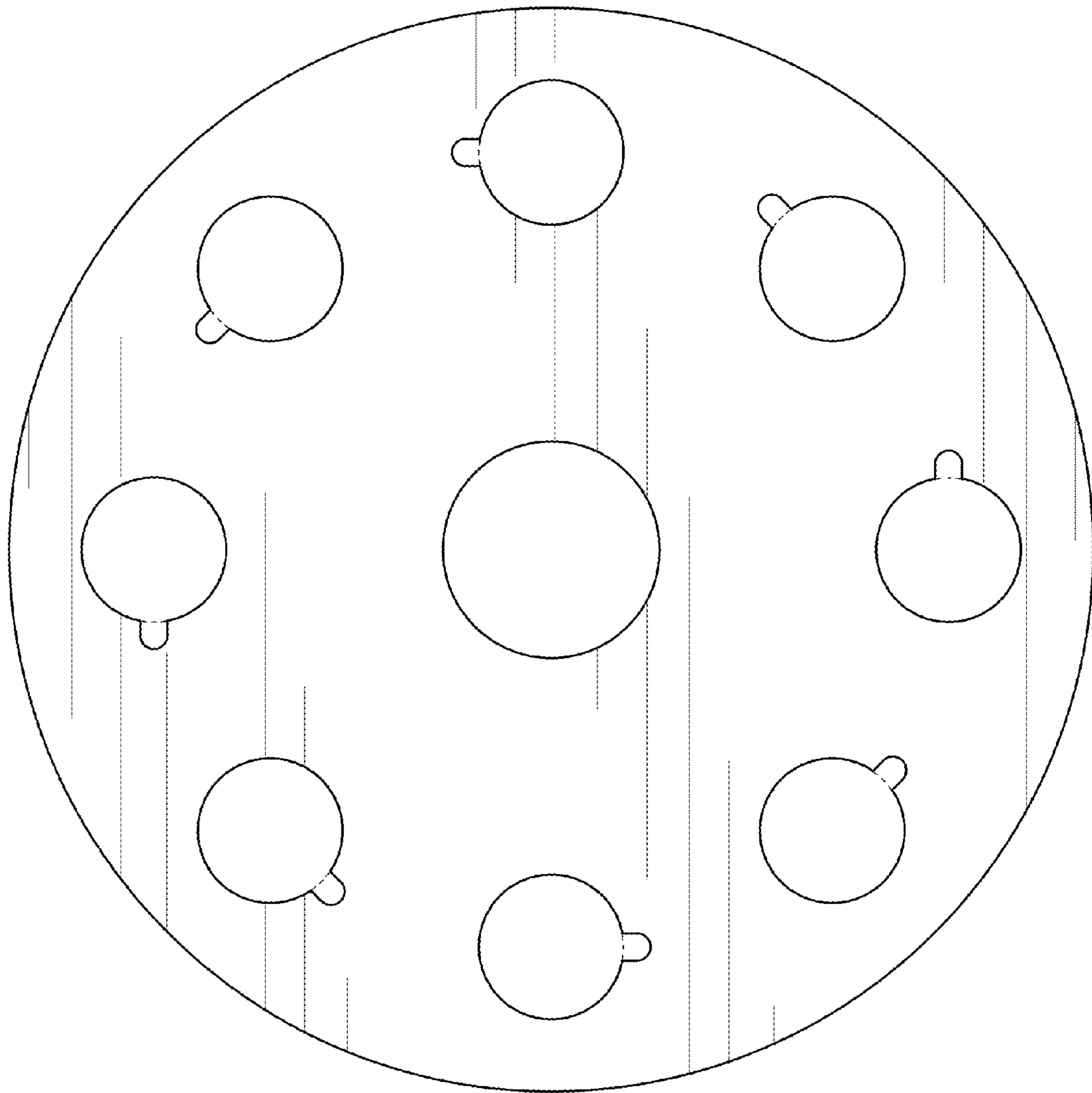

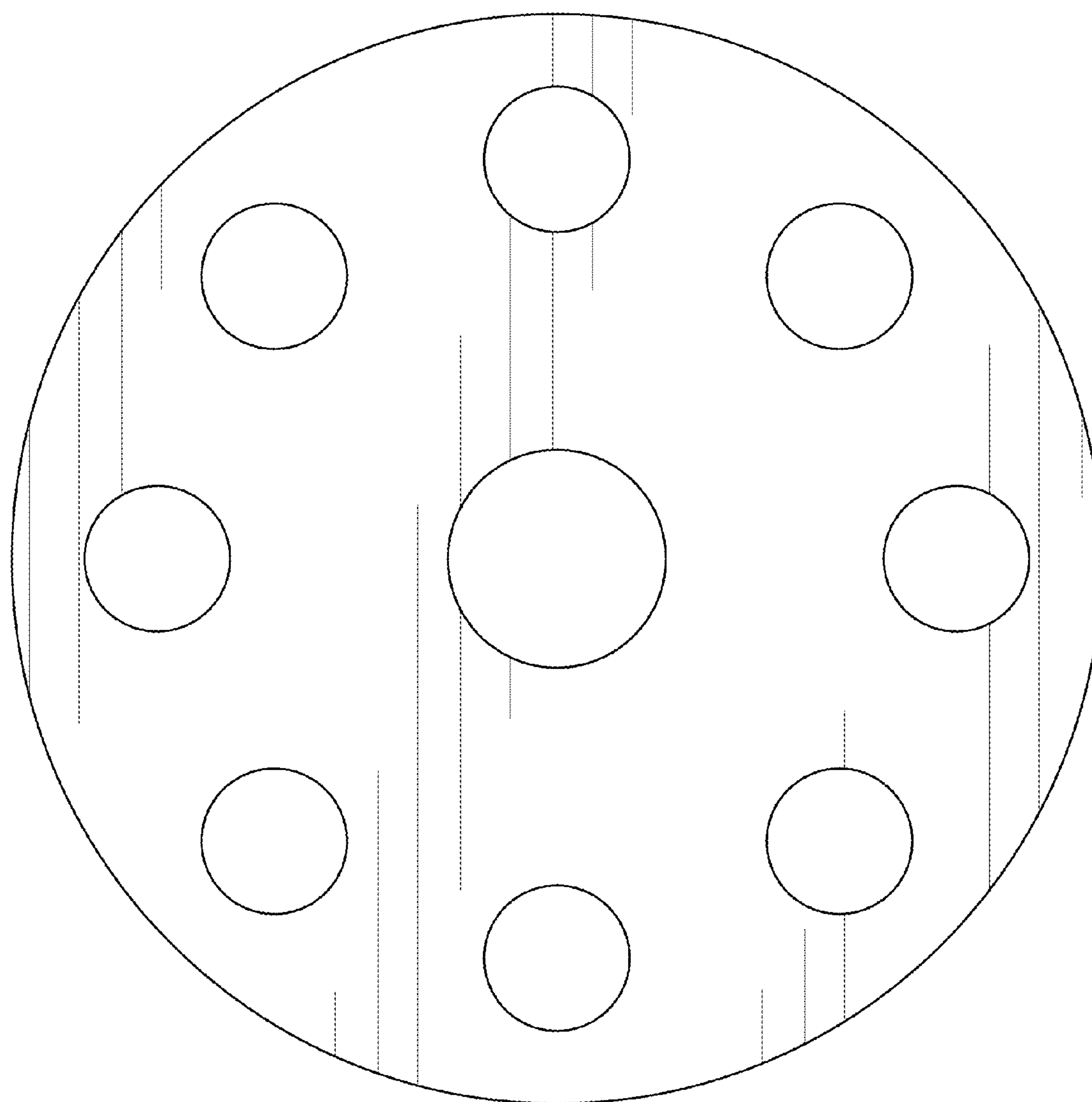




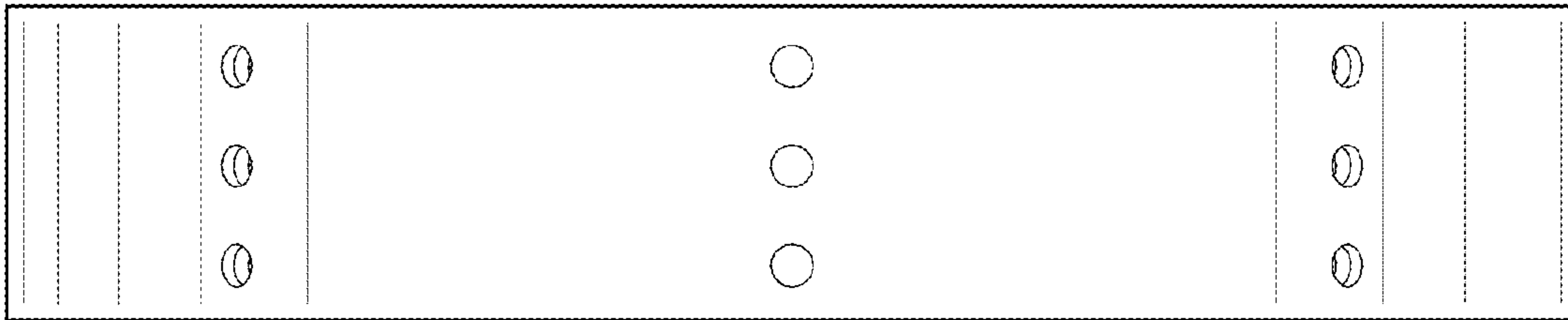

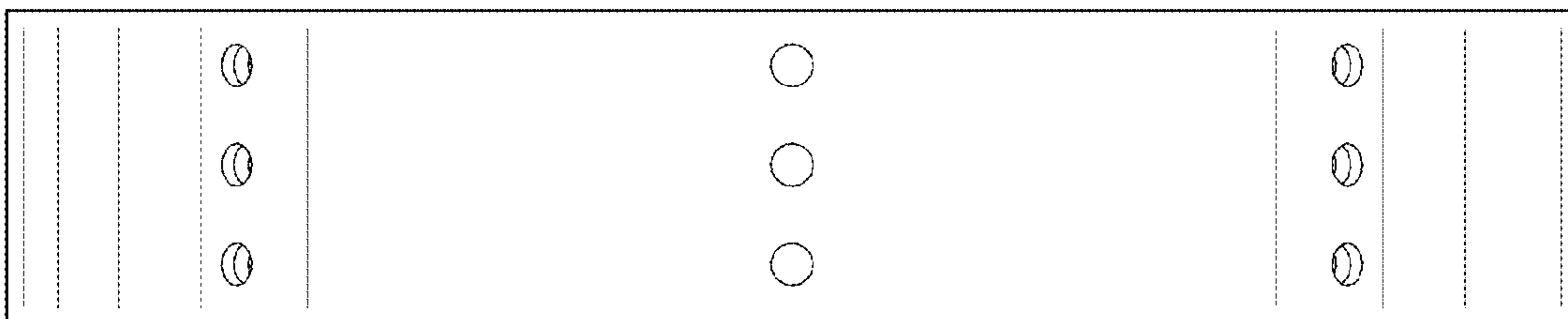

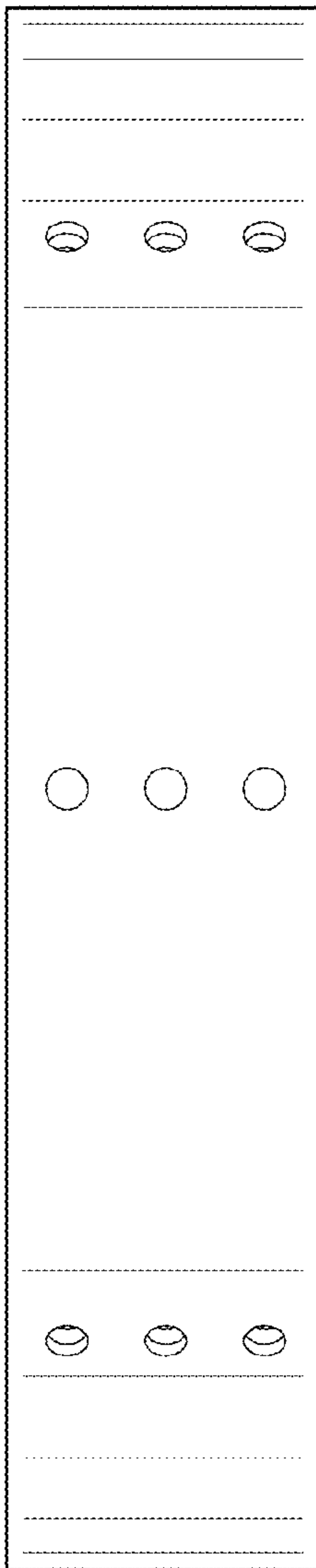

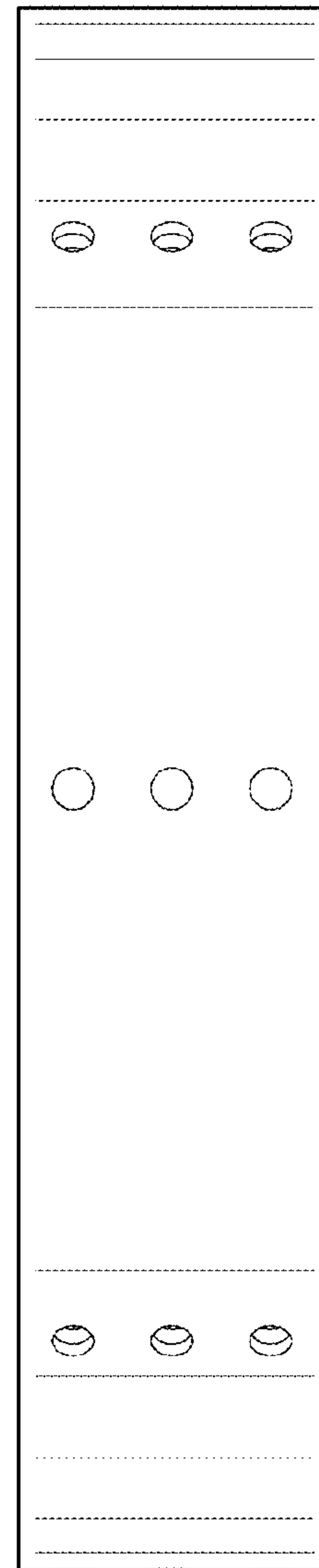
