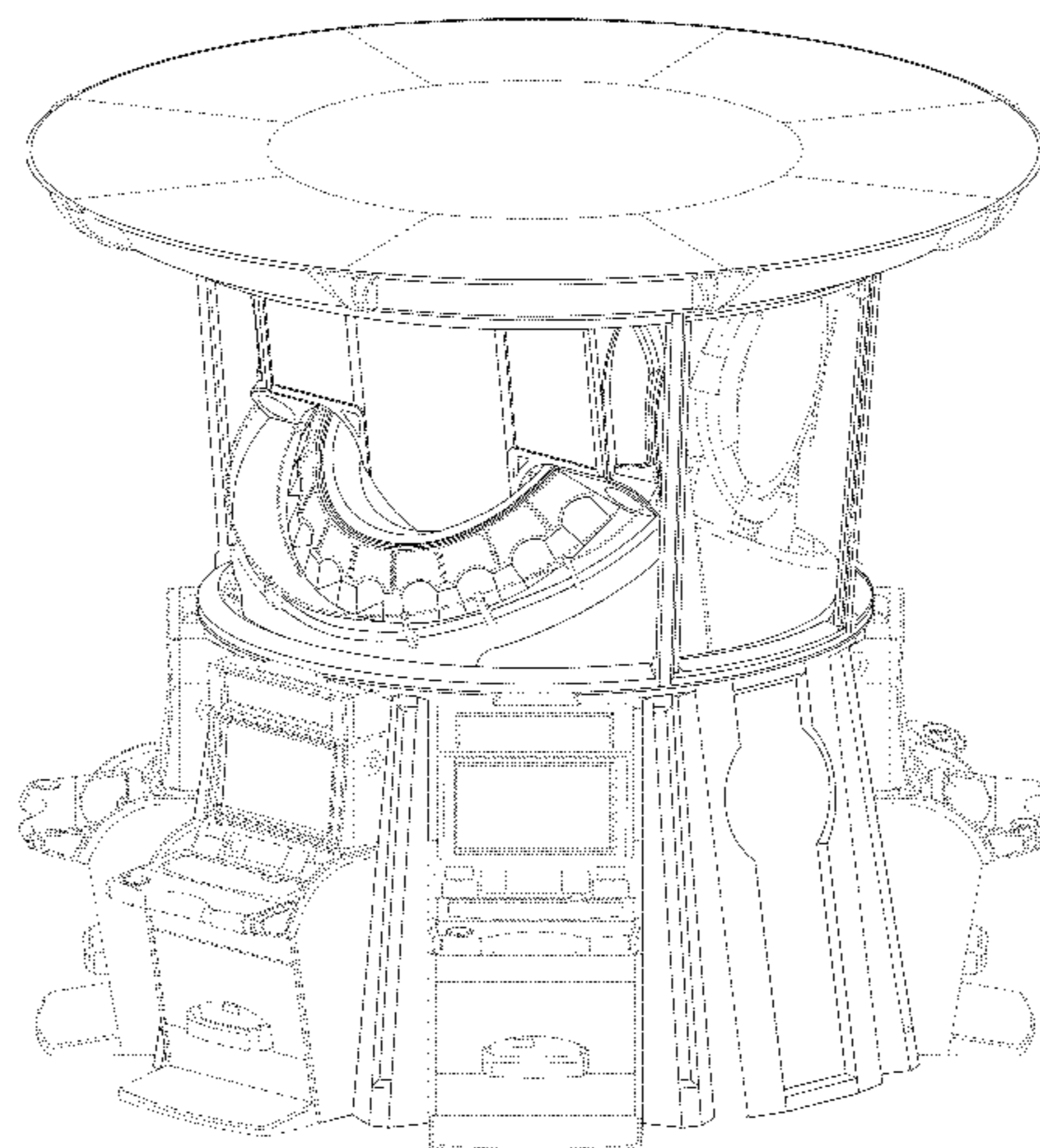
FIG. 1 is a first perspective view of a new design of a game machine;

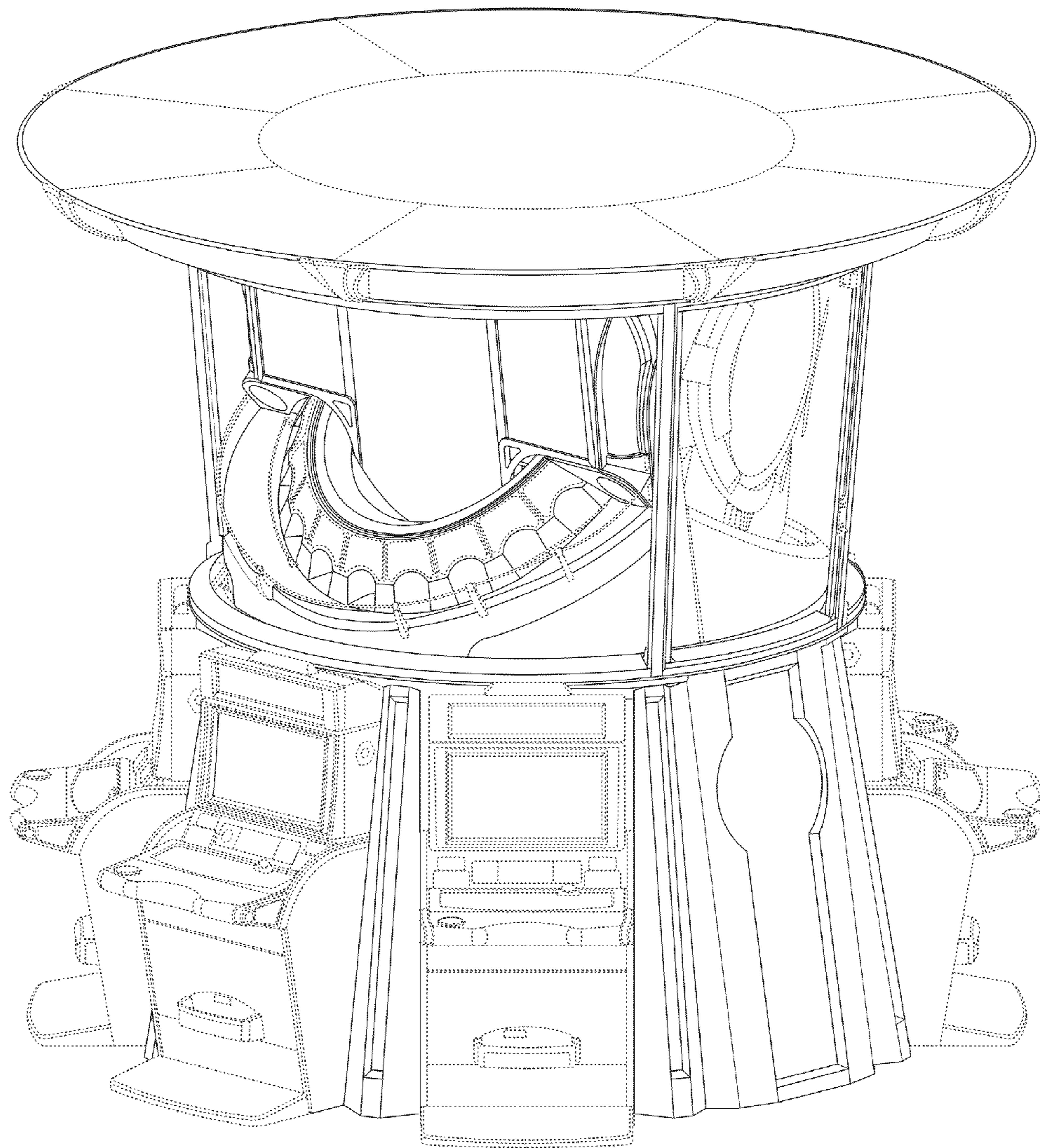

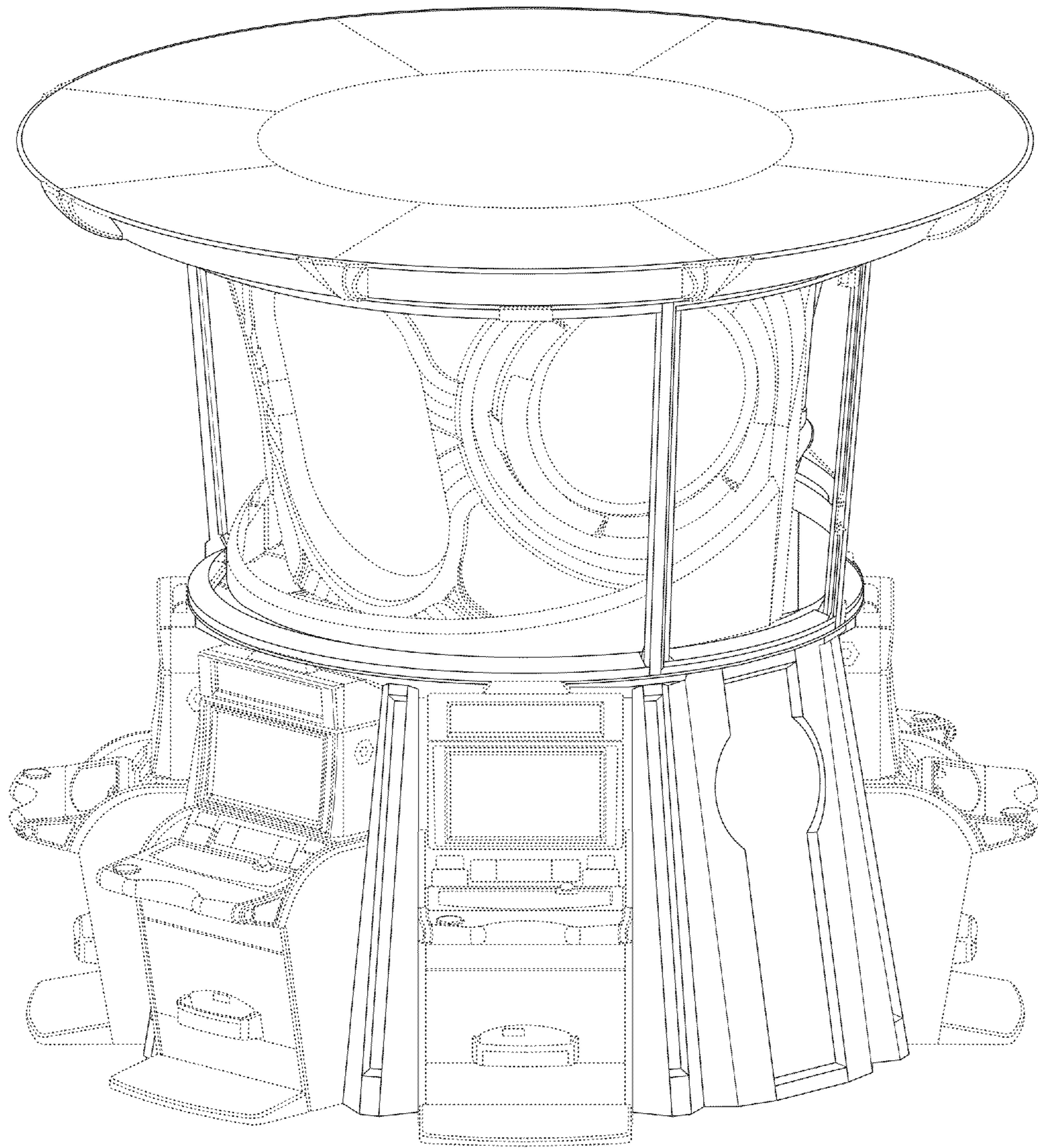

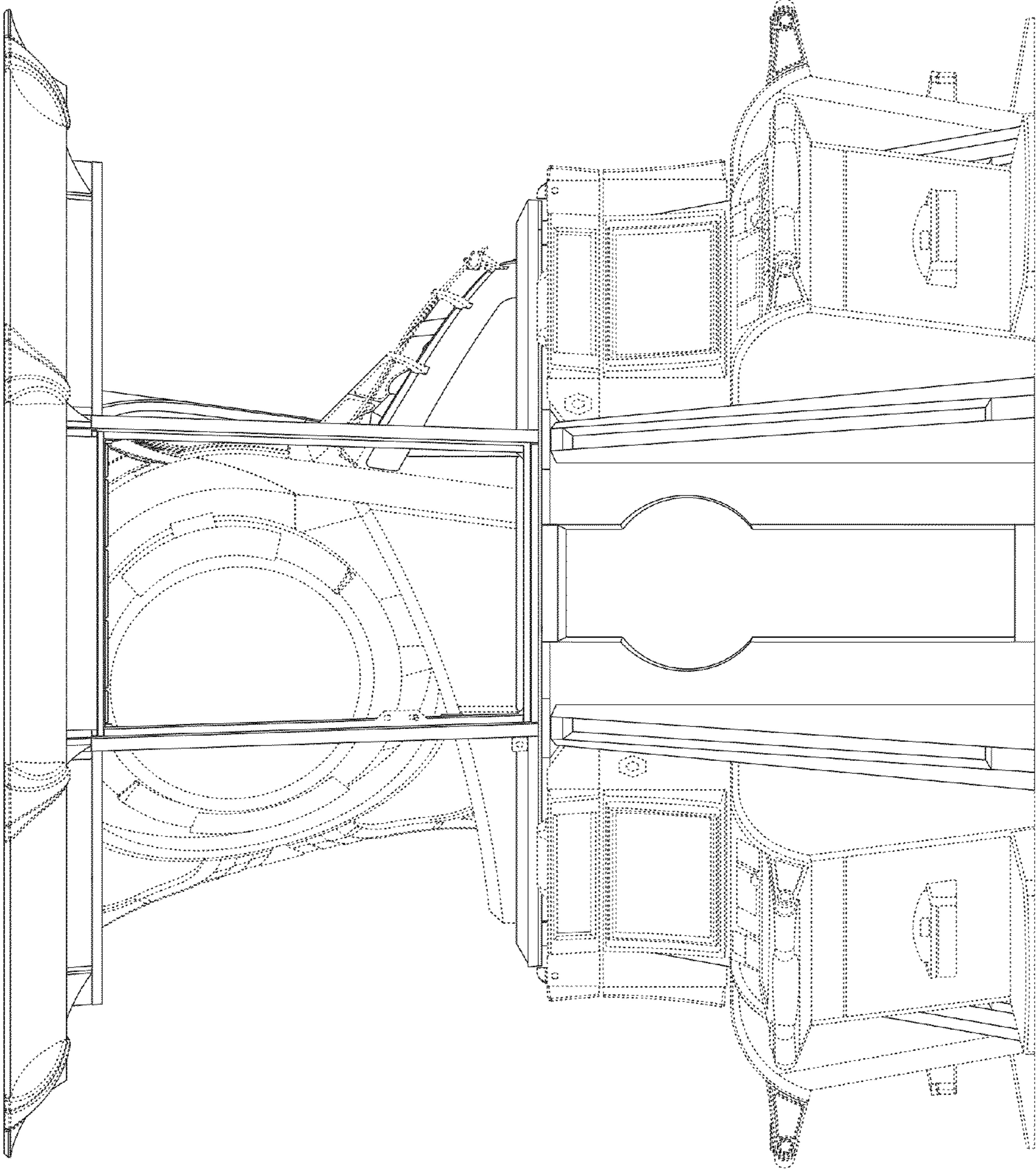

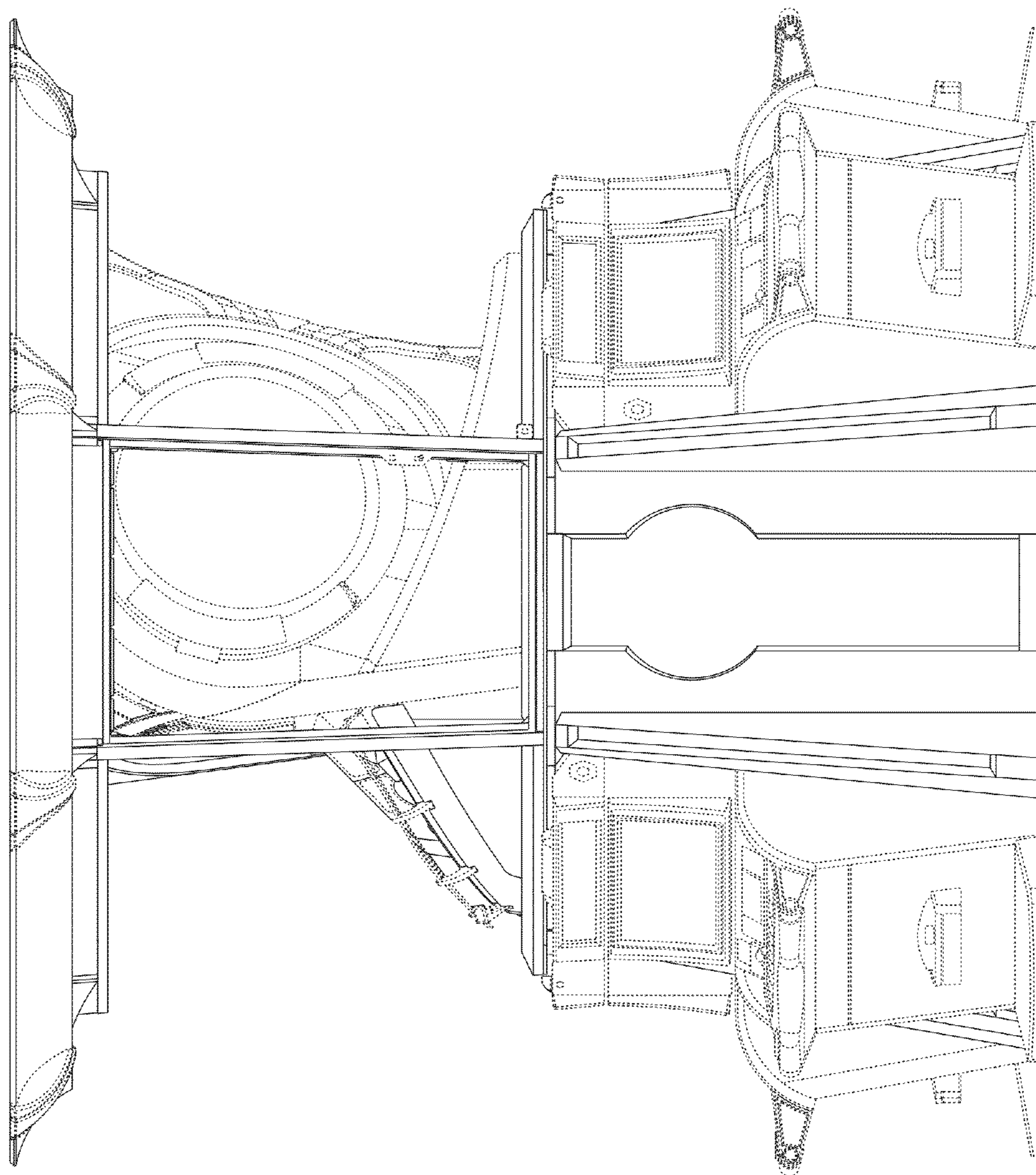

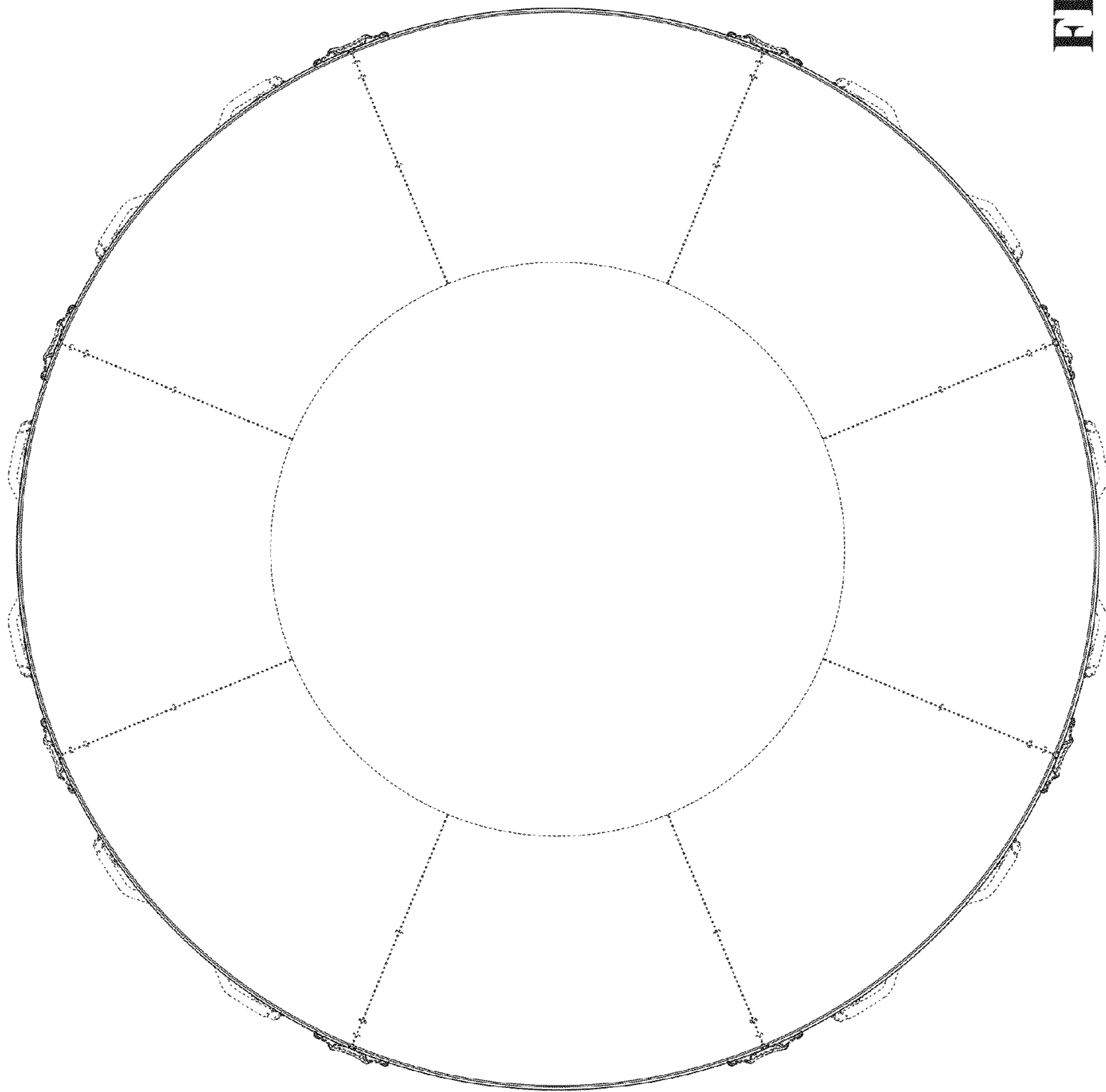

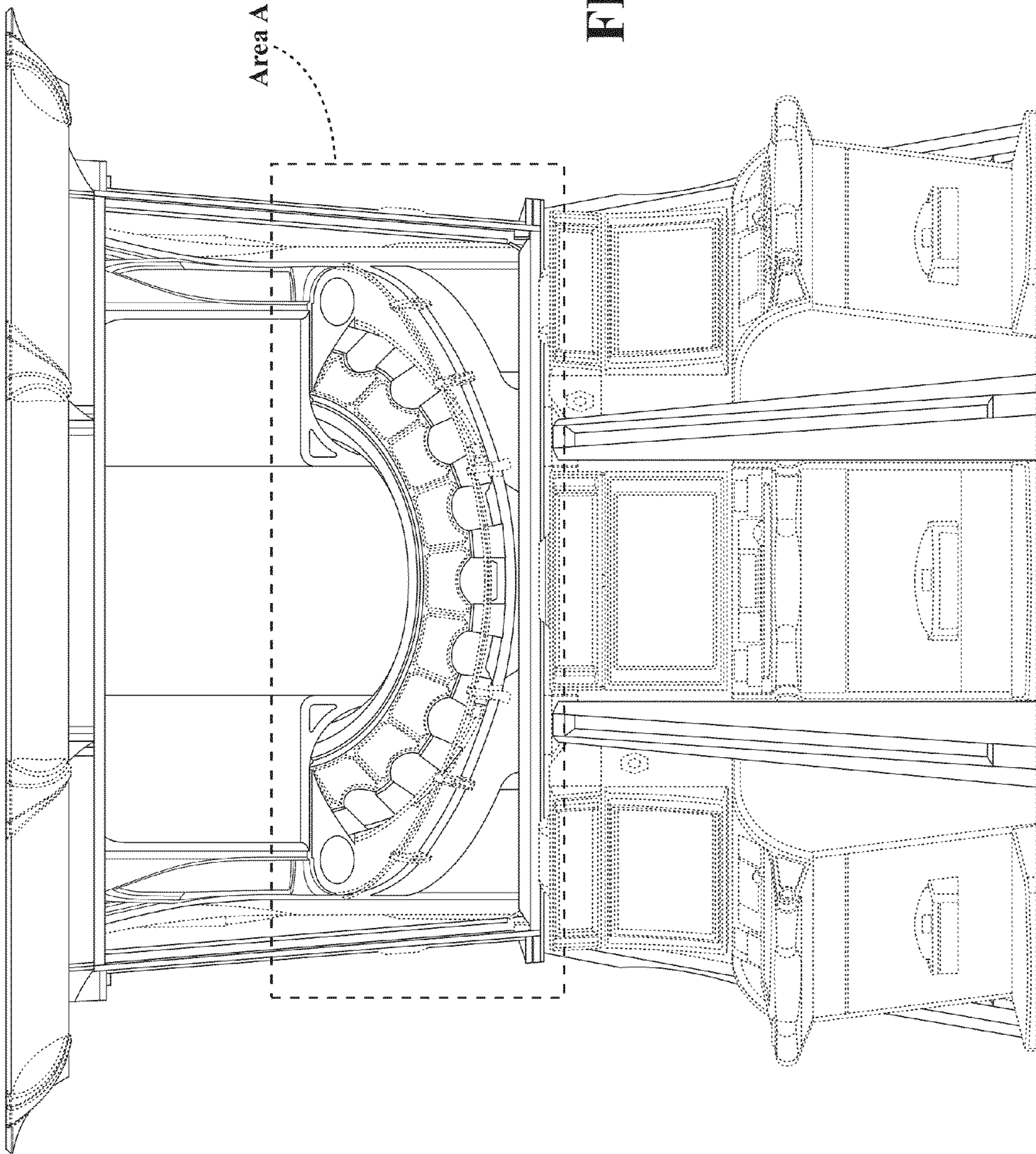

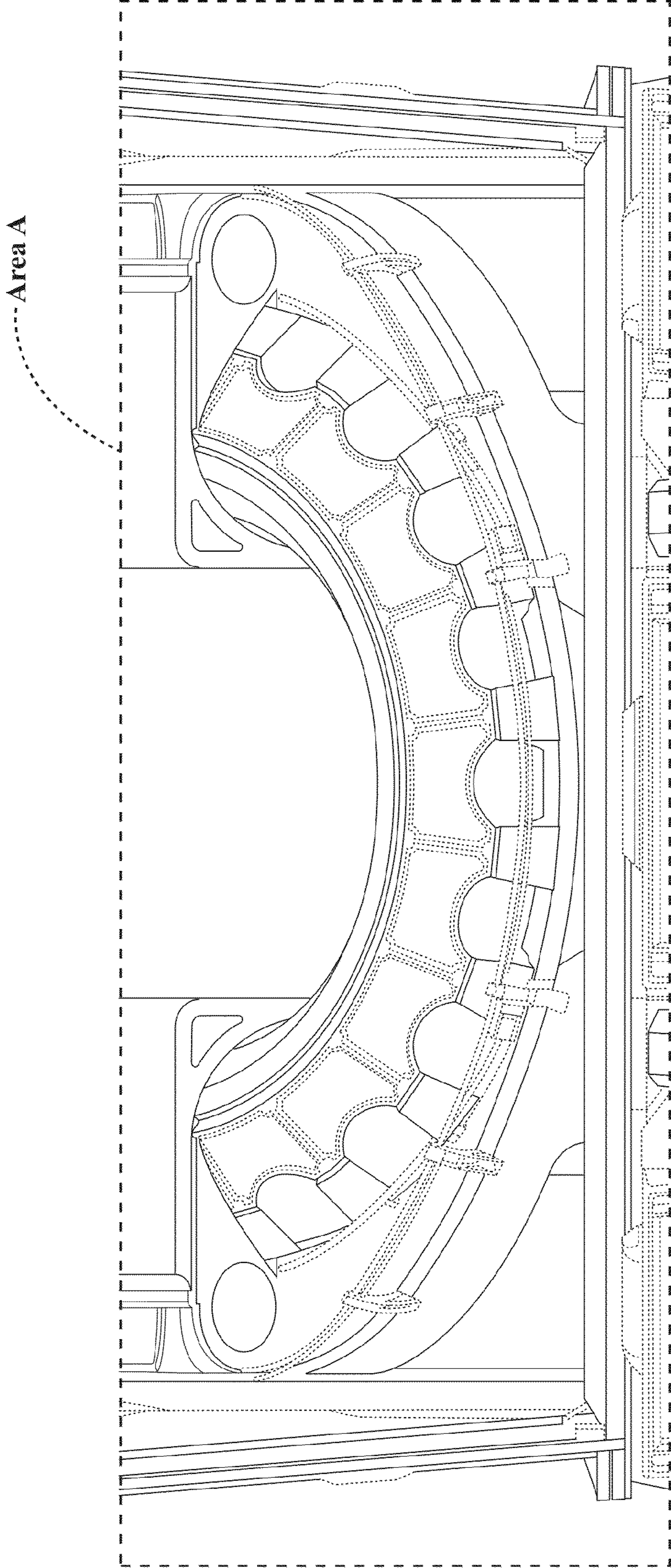
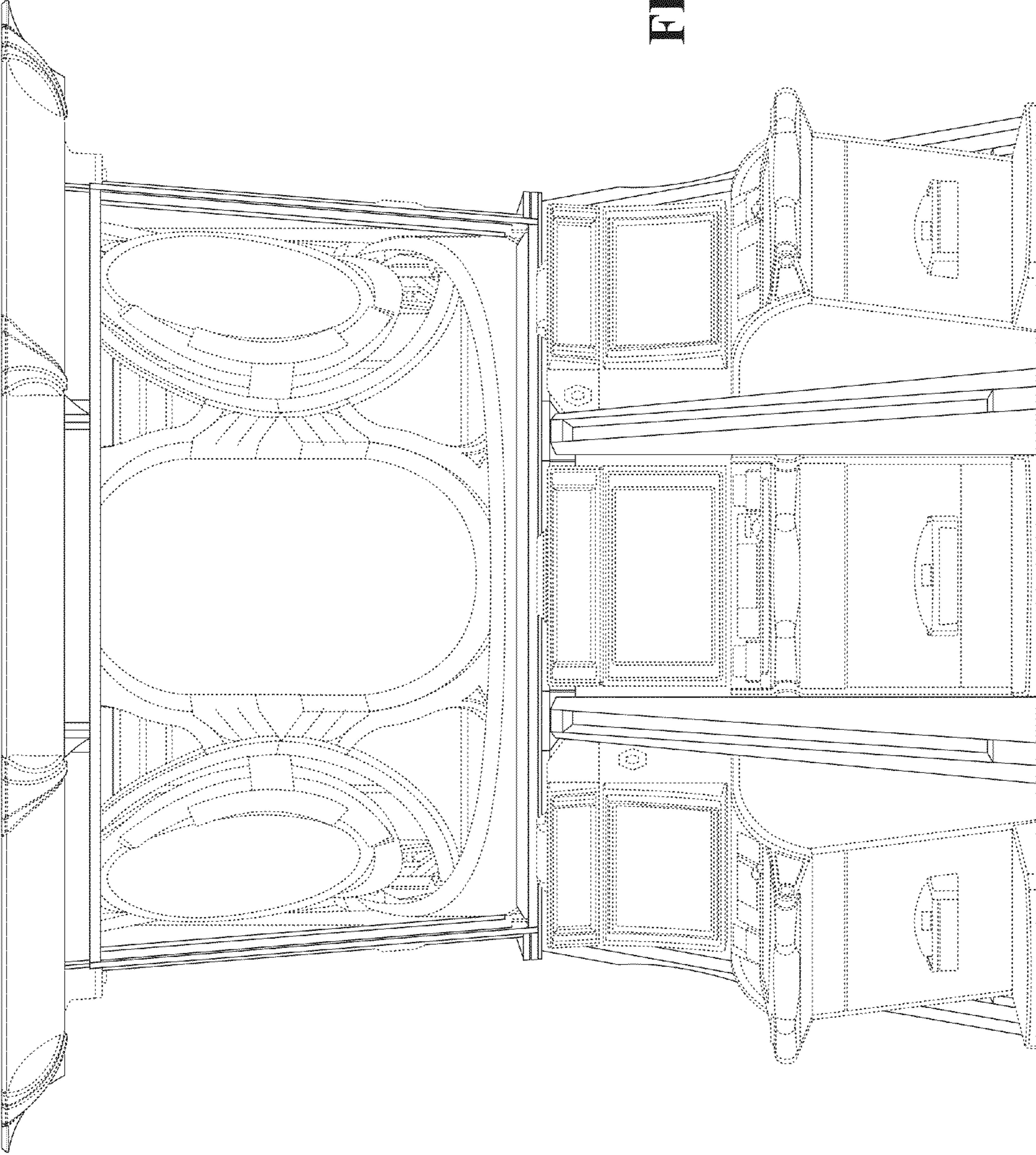

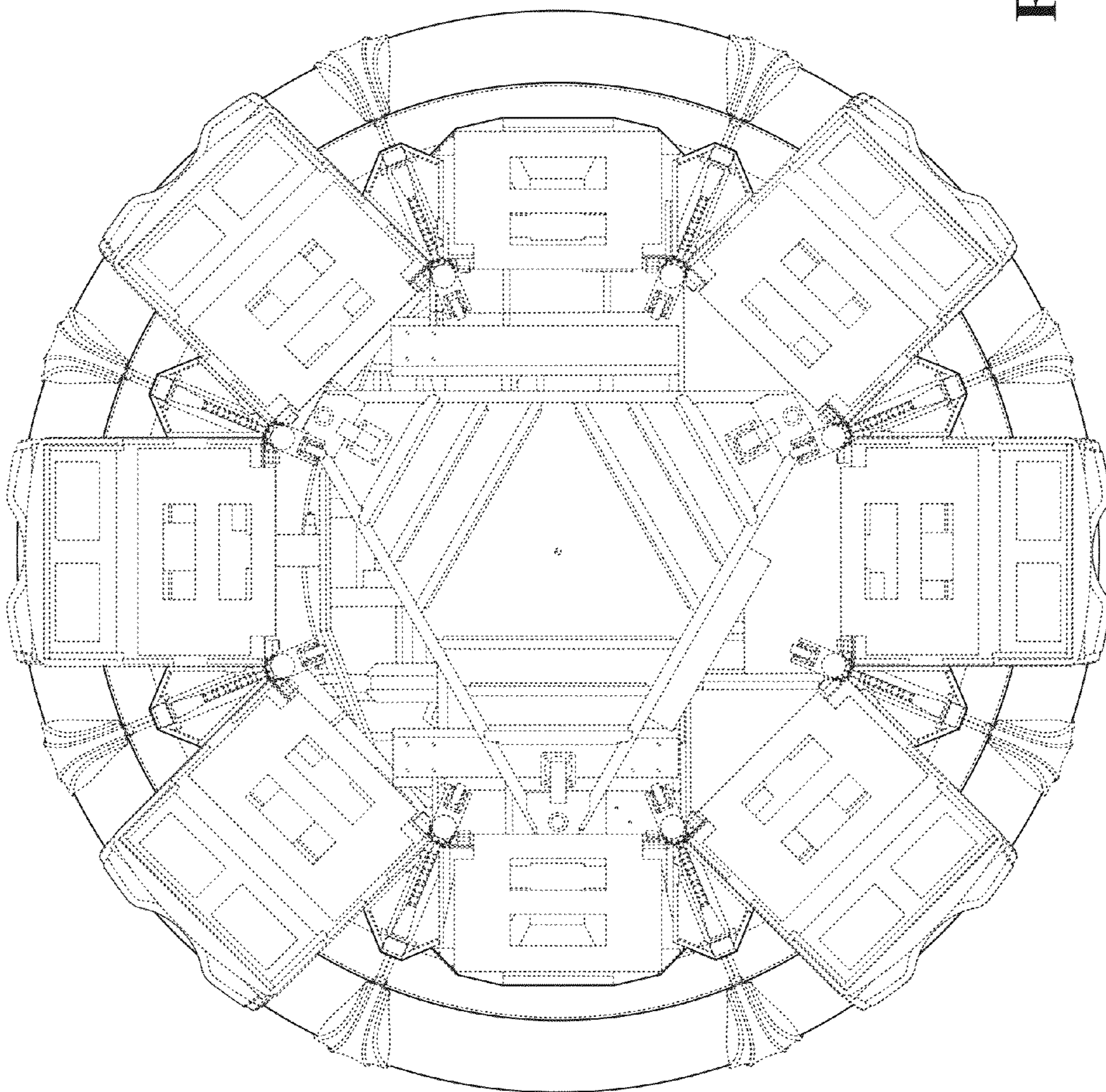
