DESCRIPTION

FIG. 1 is a perspective view of a multi-contoured yoga support;
FIG. 2 is a front side view of the multi-contoured yoga support of FIG. 1;
FIG. 3 is a back side view of the multi-contoured yoga support of FIG. 1;
FIG. 4 is a left side view of the multi-contoured yoga support taken from FIG. 1;
FIG. 5 is a right side view of the multi-contoured yoga support taken from FIG. 1;
FIG. 6 is a bottom view of the multi-contoured yoga support of FIG. 1; and,

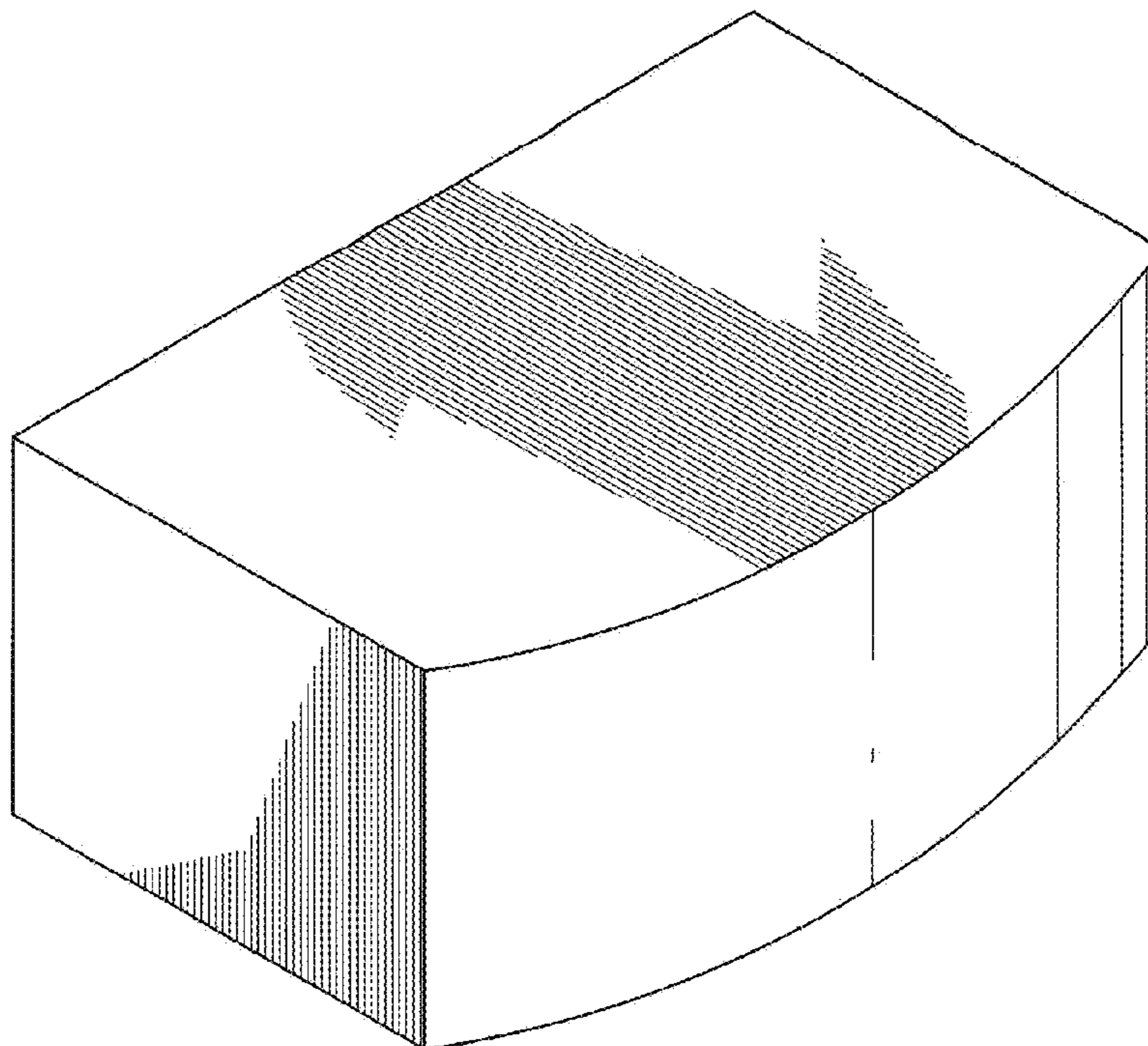

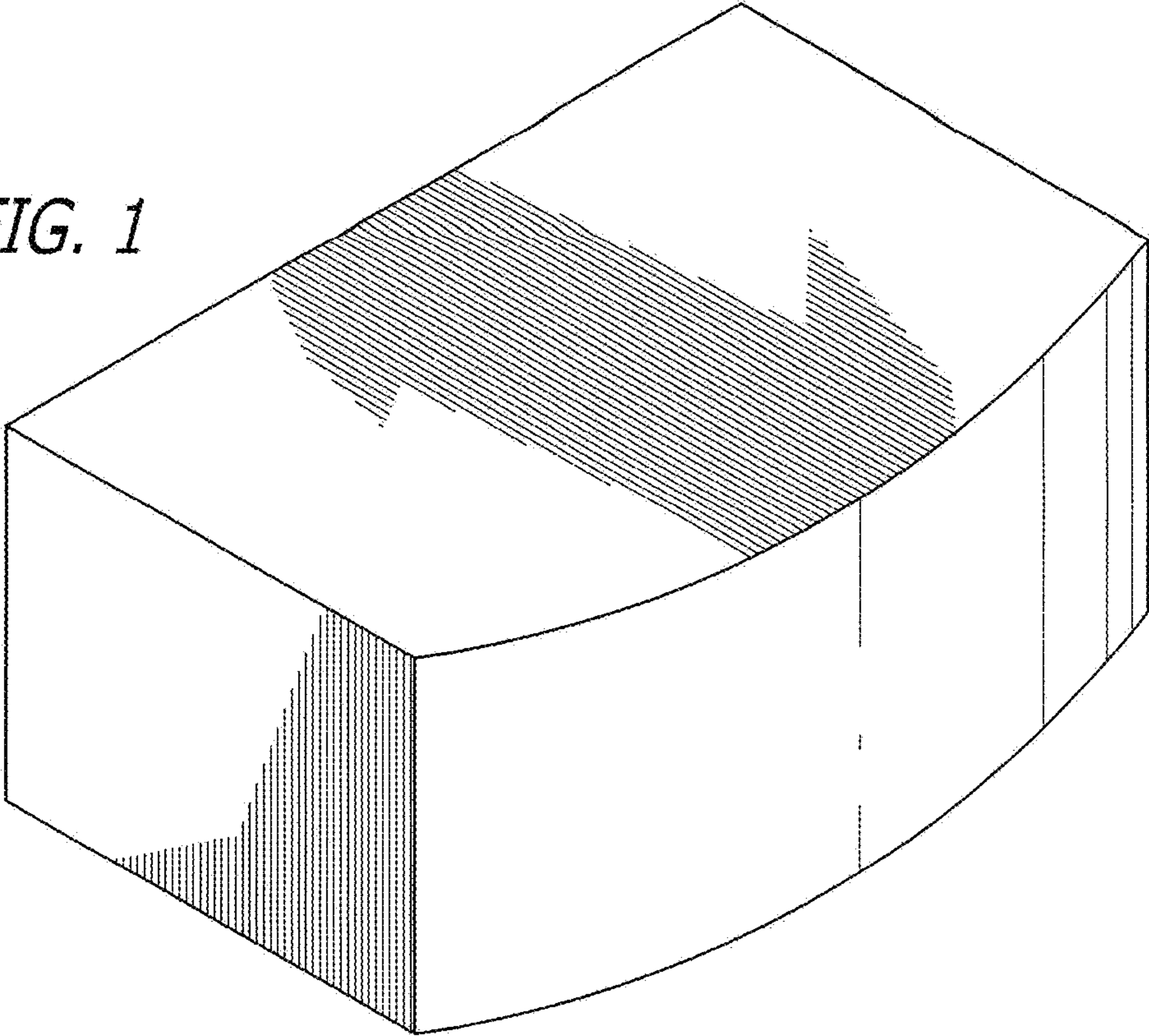

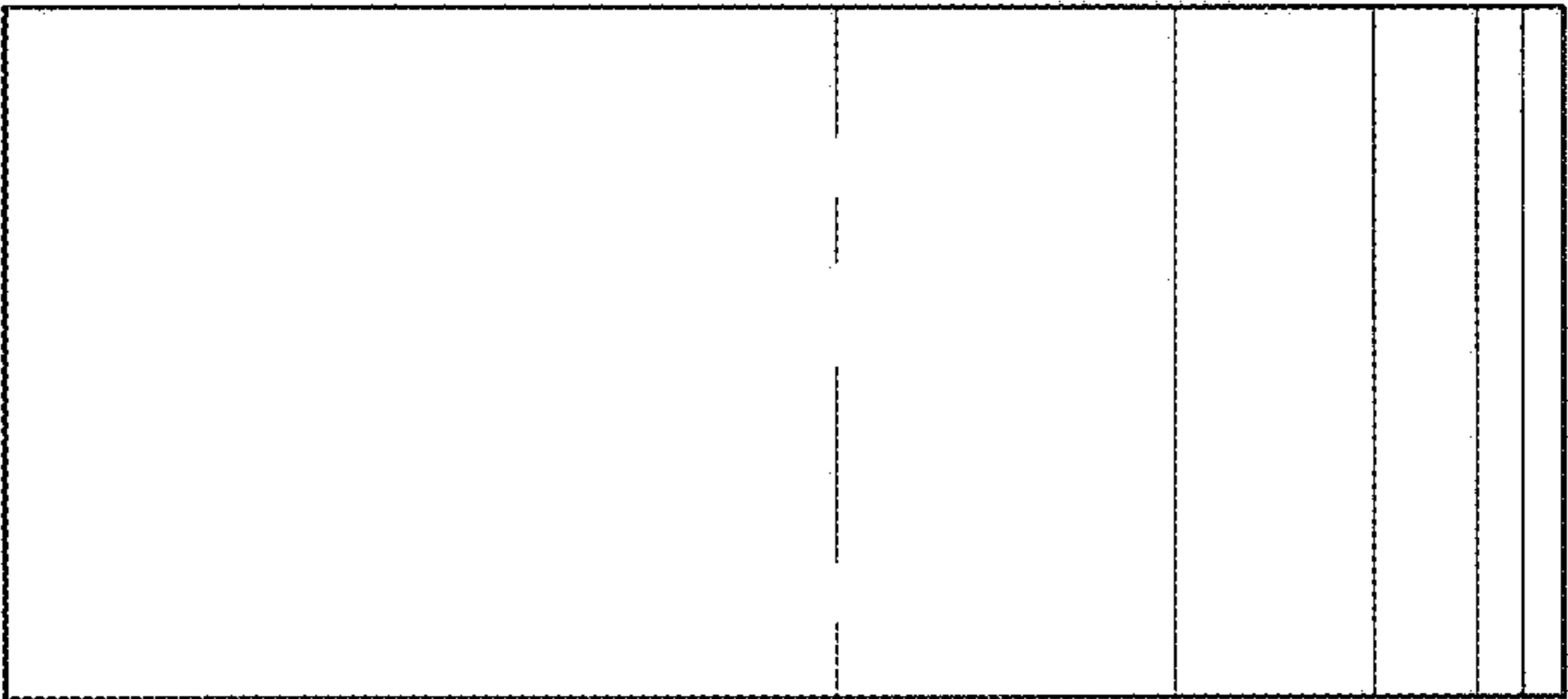
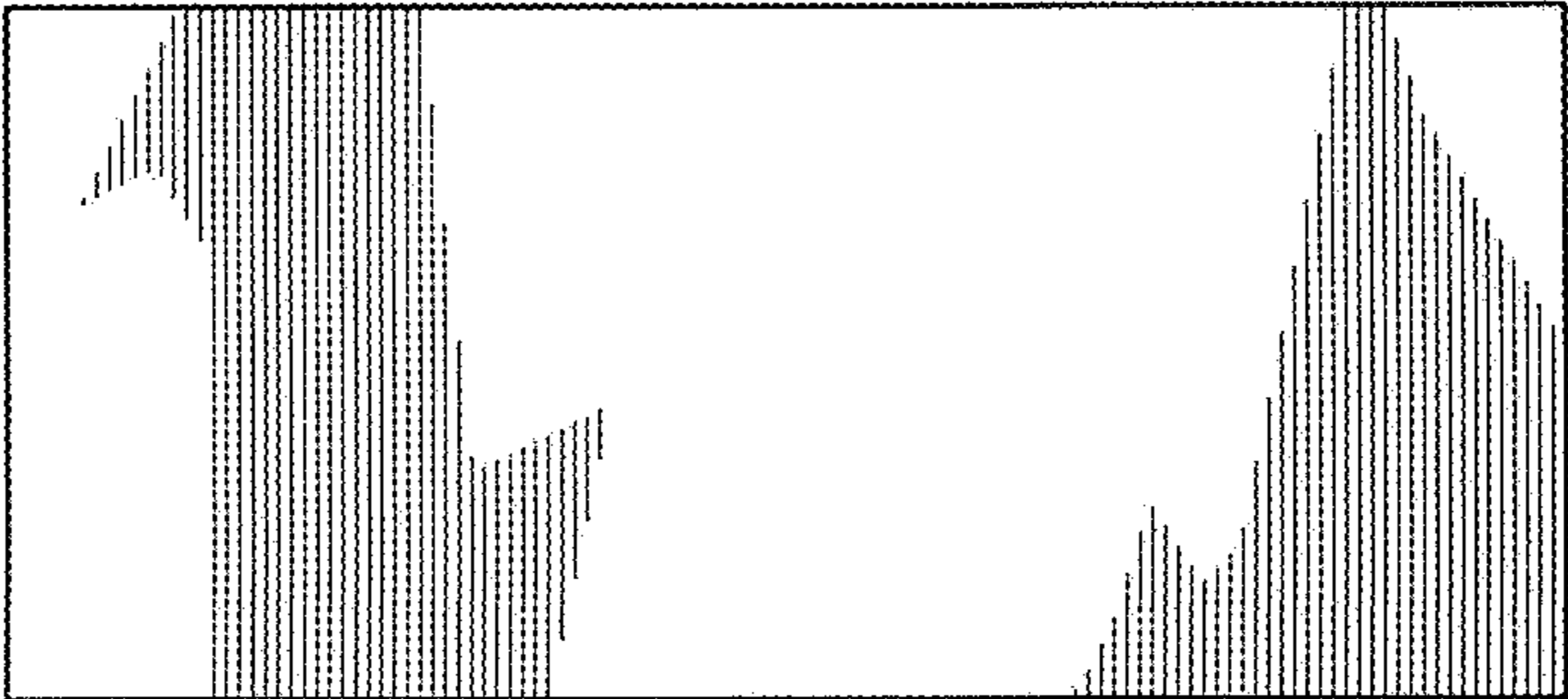

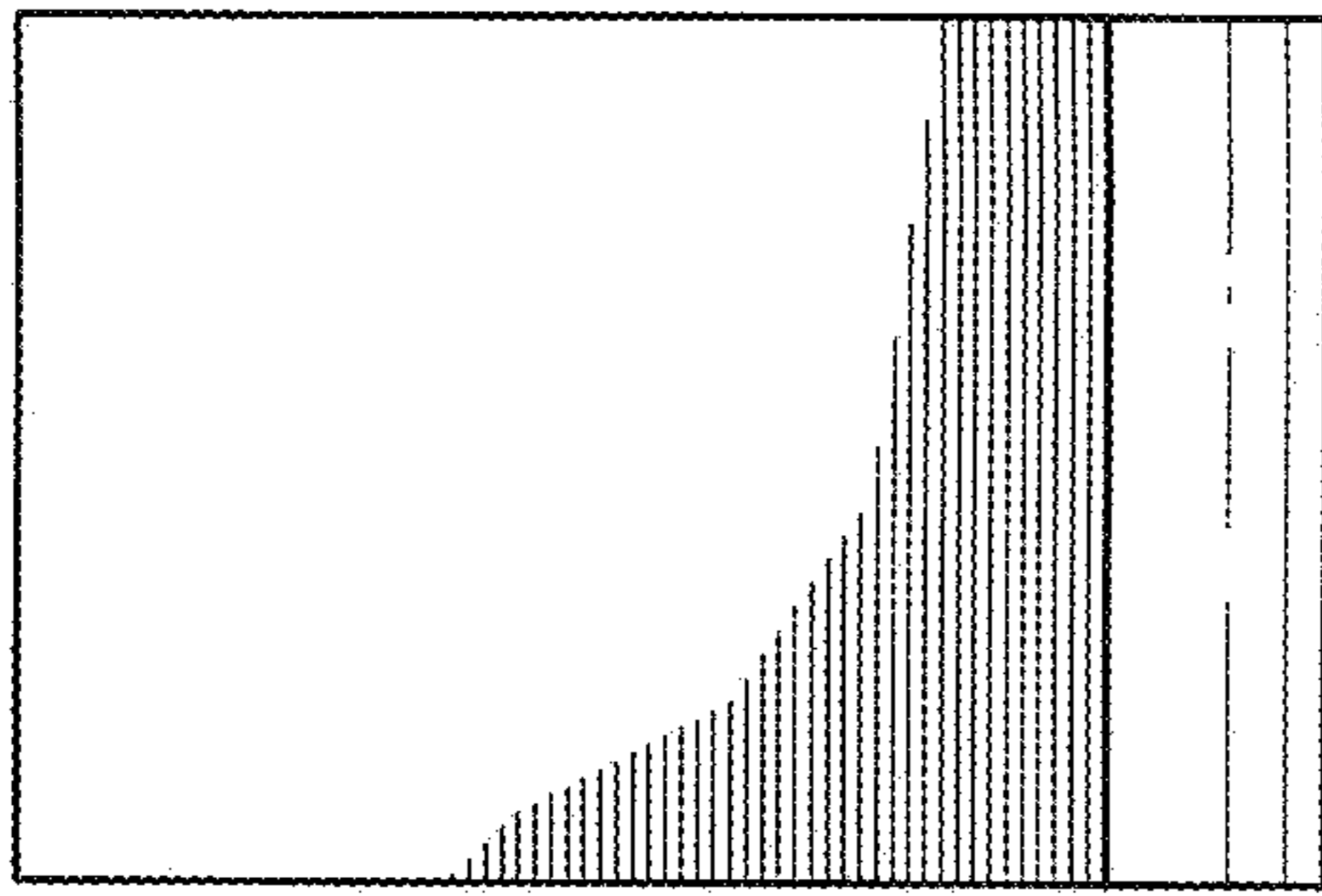

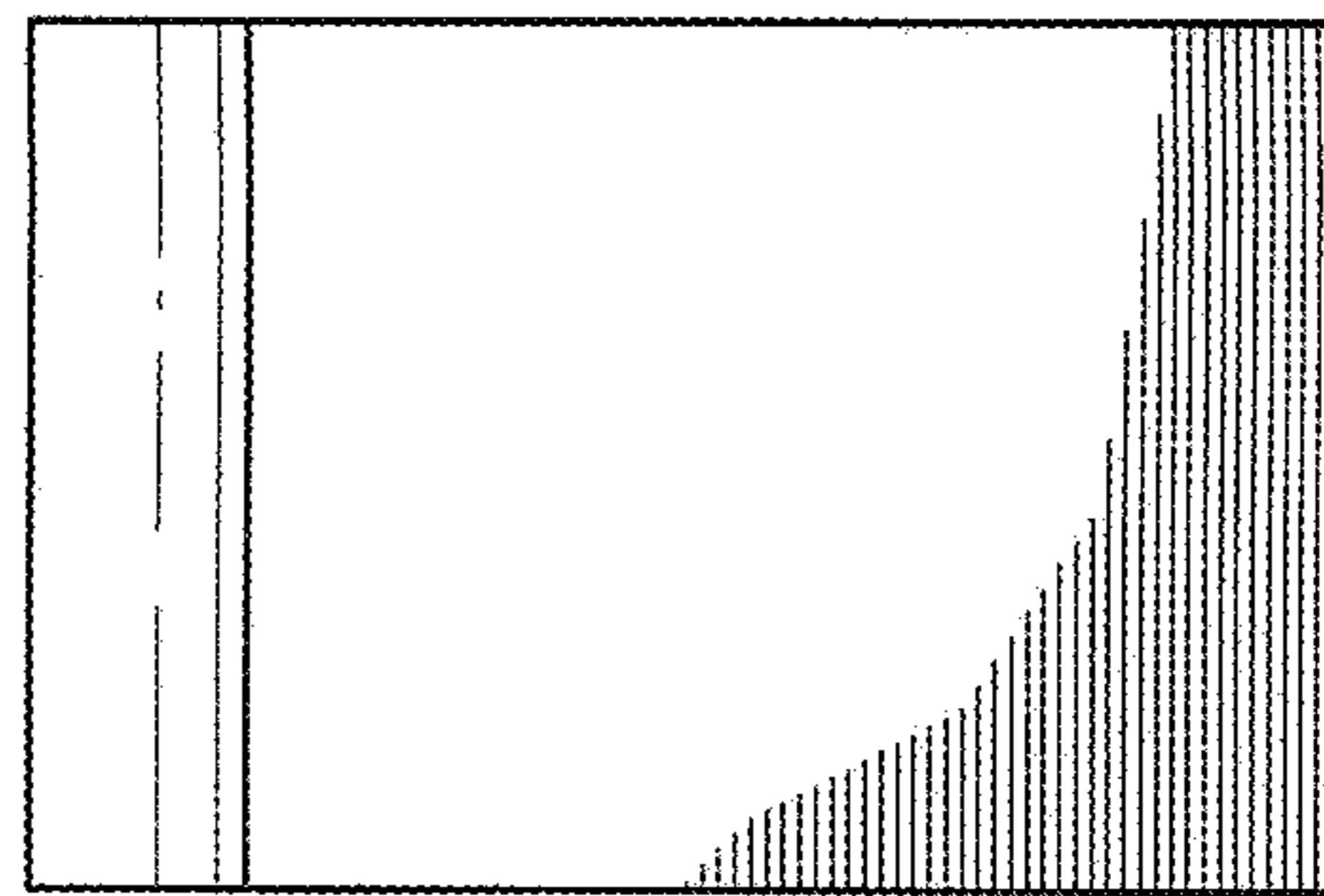

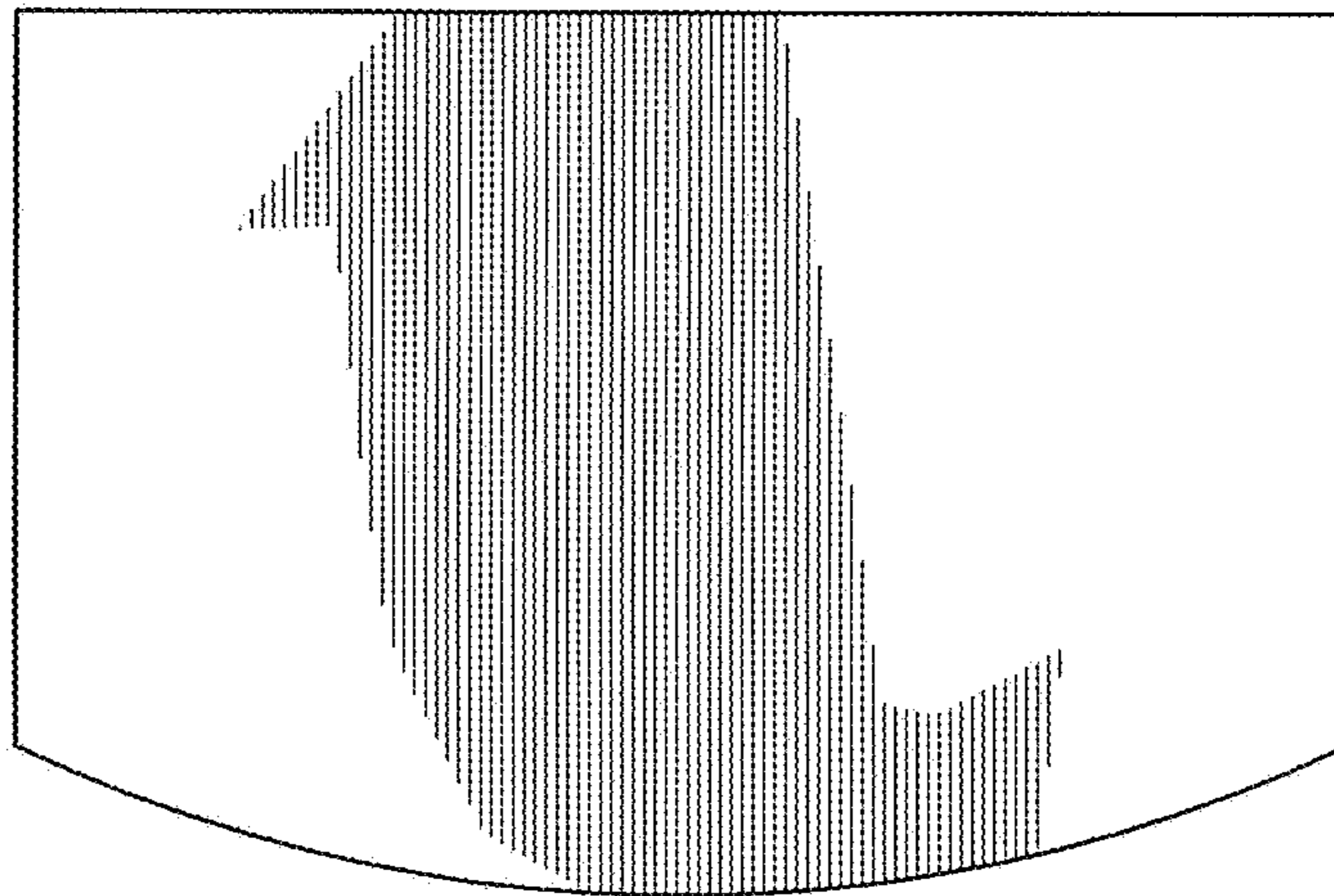
