The ornamental design for a striking face for a golf club head, as shown and described.

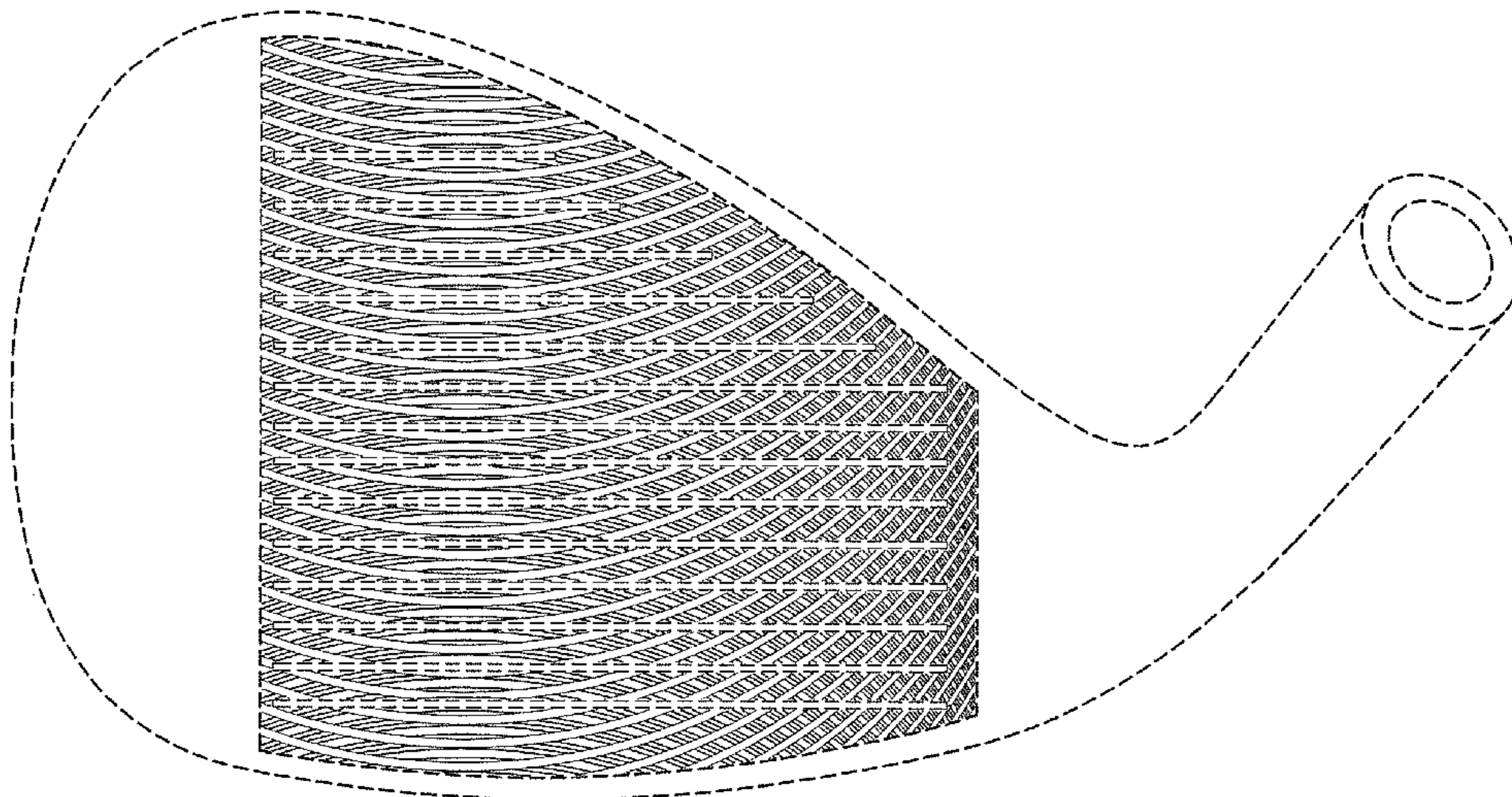
**DESCRIPTION**

FIG. 1 is a front elevational view of the striking face of golf club head according to the present design; FIG. 2 is an enlarge front elevational view thereof; FIG. 3 is a detailed elevational view of a portion of the striking face indicated by the dashed circle 3 of FIG. 2; FIG. 4 is a cross sectional view taken on line 4-4 of FIG. 3; FIG. 5 is a top plan view of FIG. 1; FIG. 6 is a bottom plan view of FIG. 1; FIG. 7 is a left side elevational view of FIG. 1; FIG. 8 is a right side elevational view of FIG. 1; and, FIG. 9 is a rear elevational view of FIG. 1. The phantom lining illustrates environmental structure that forms no part of the claimed design.

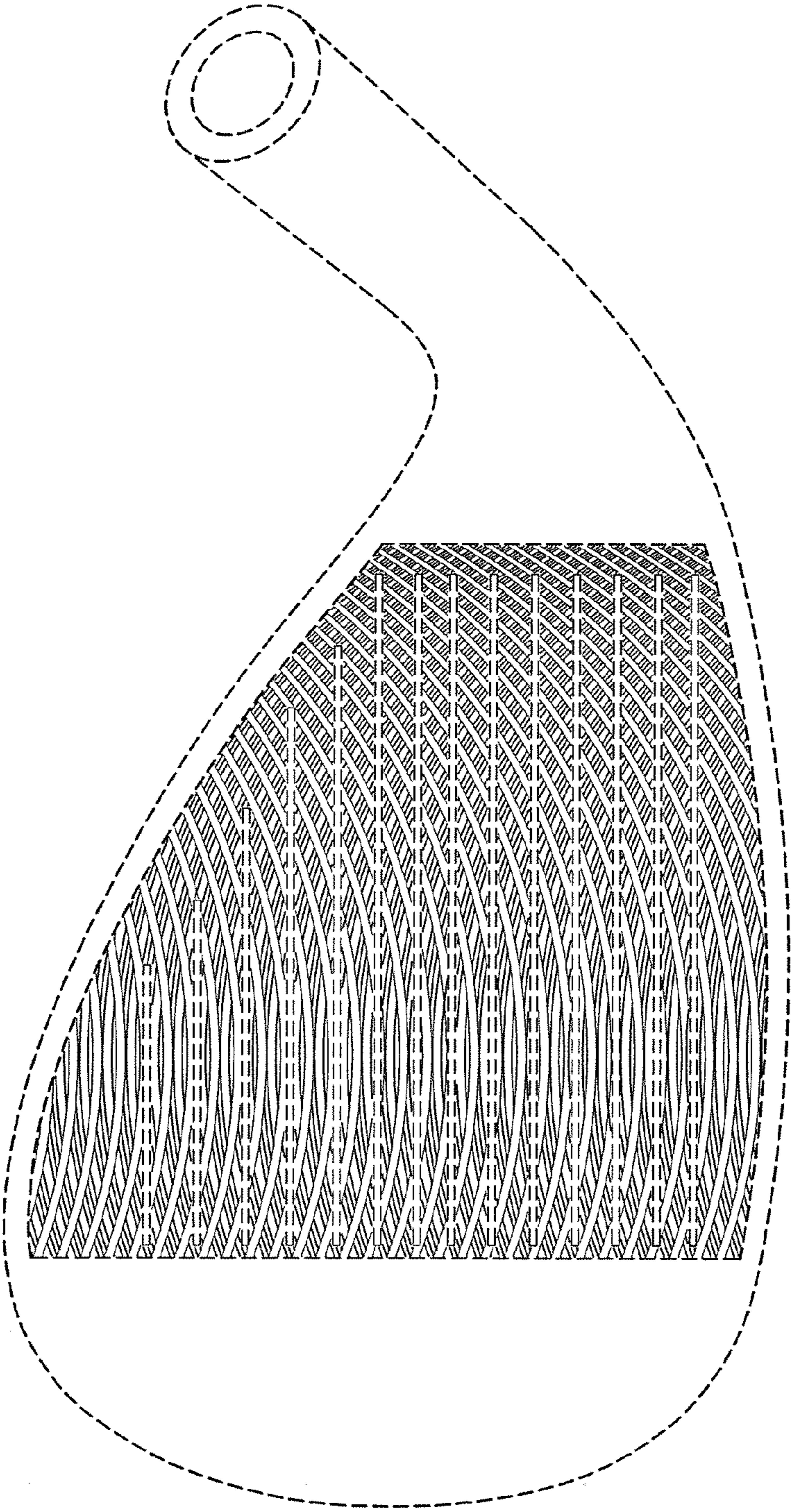

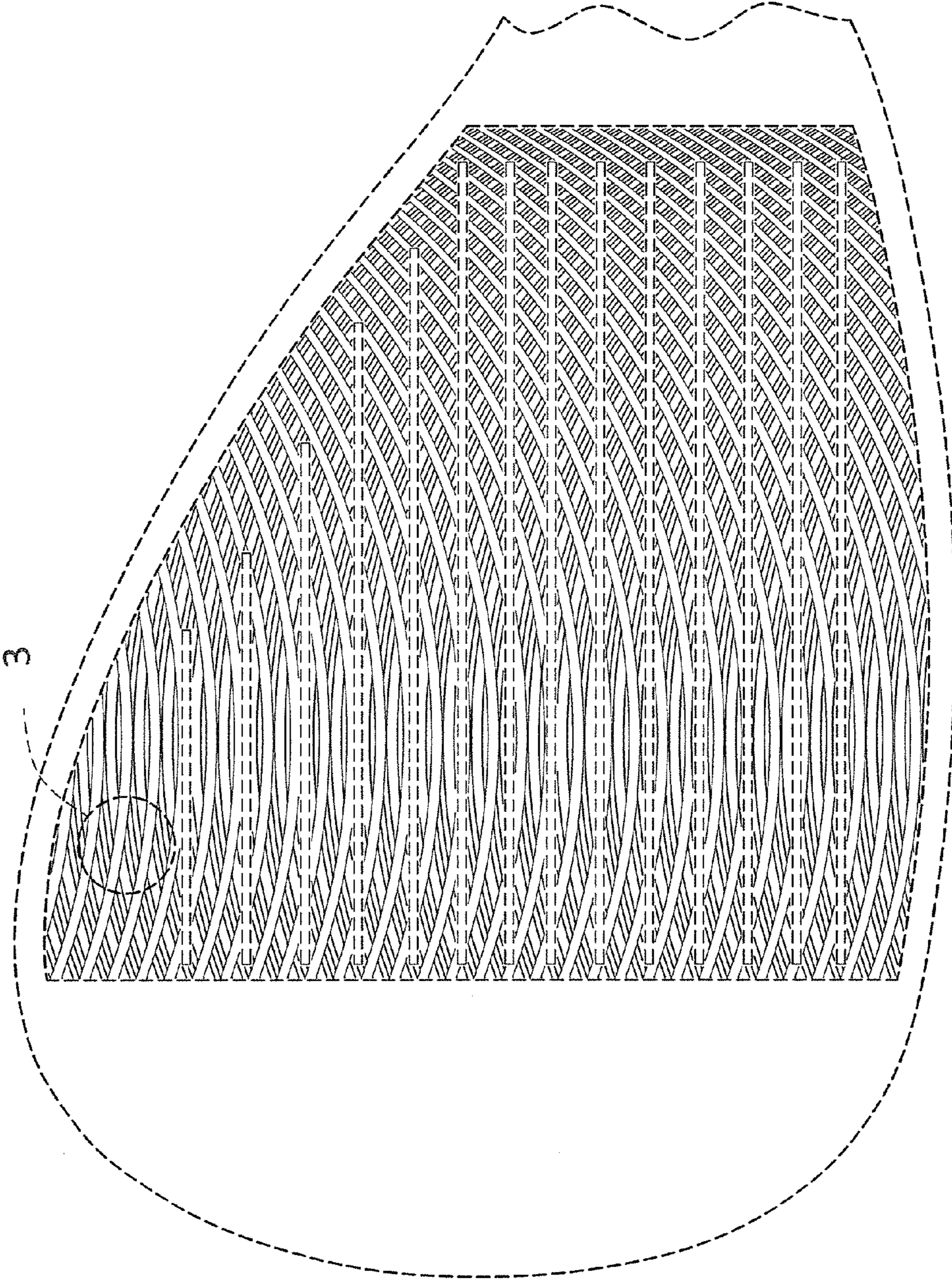

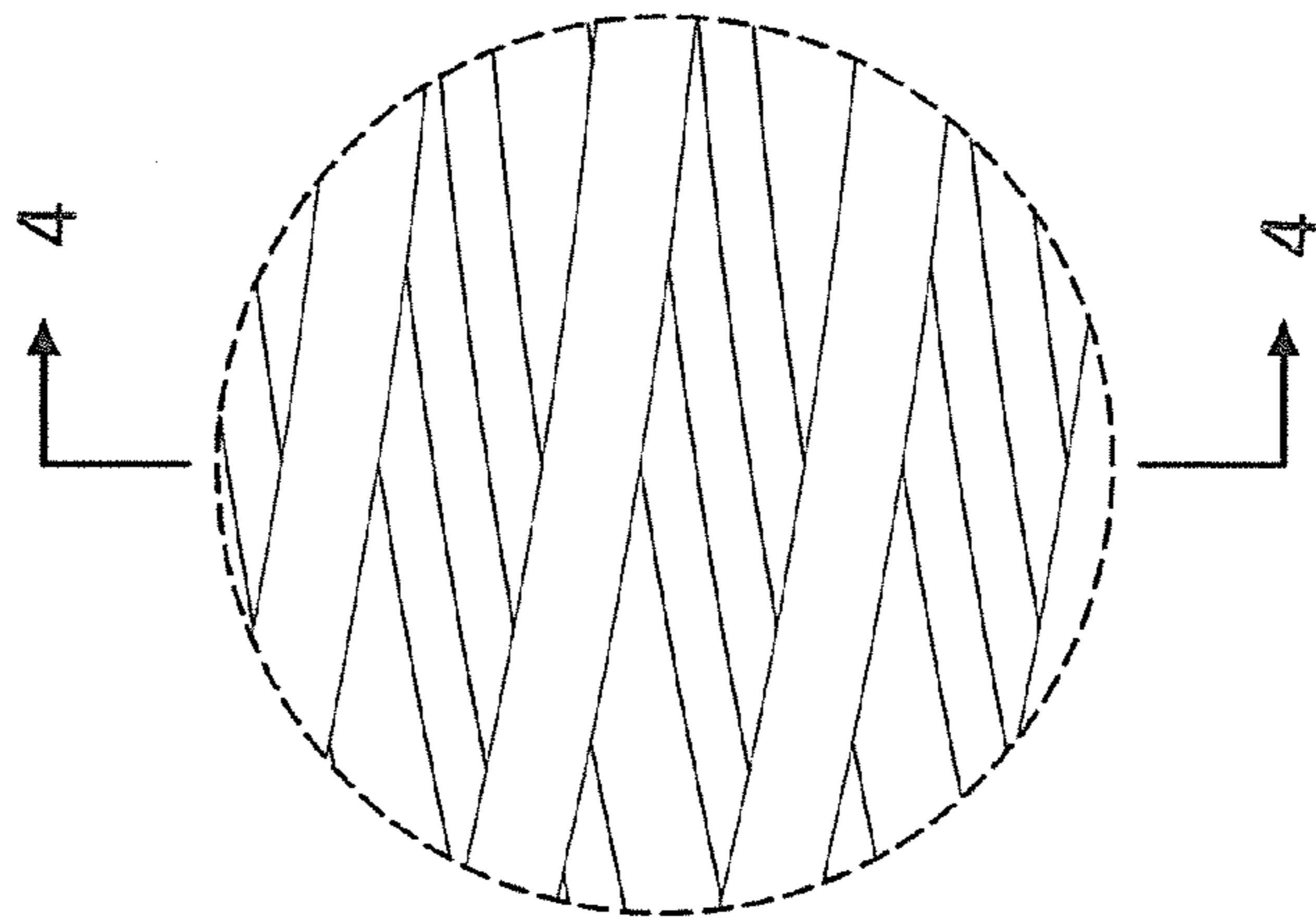

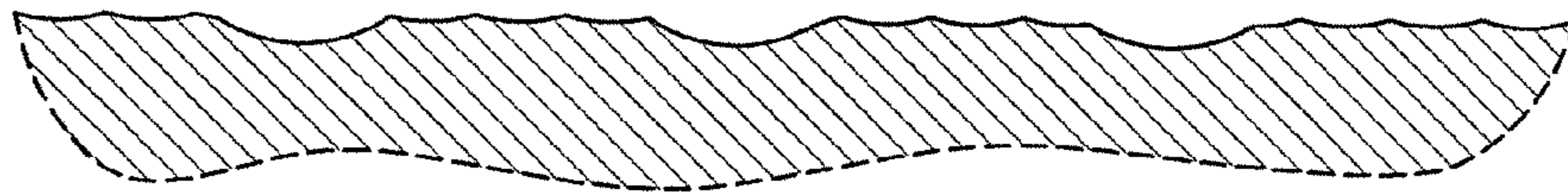

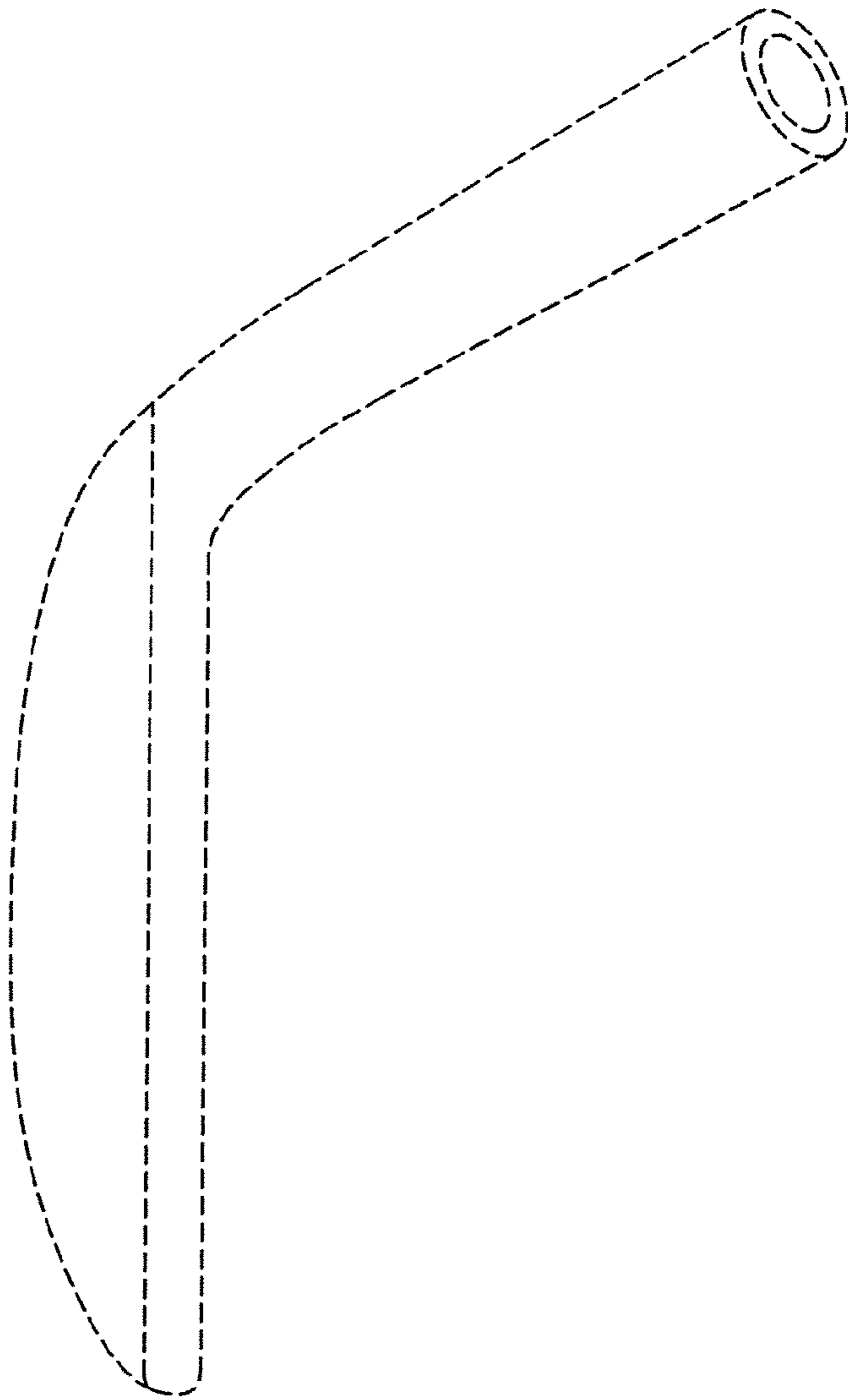

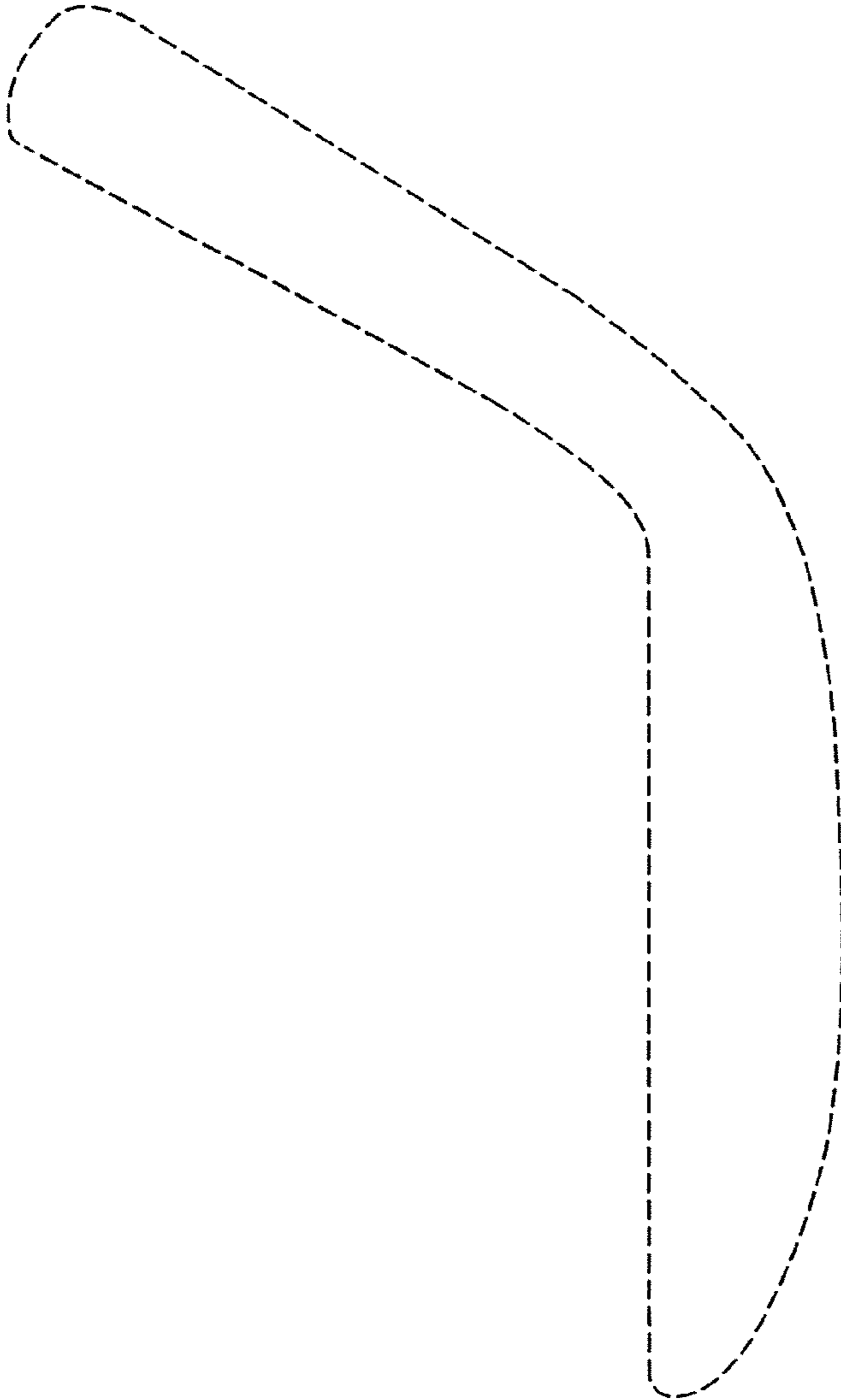

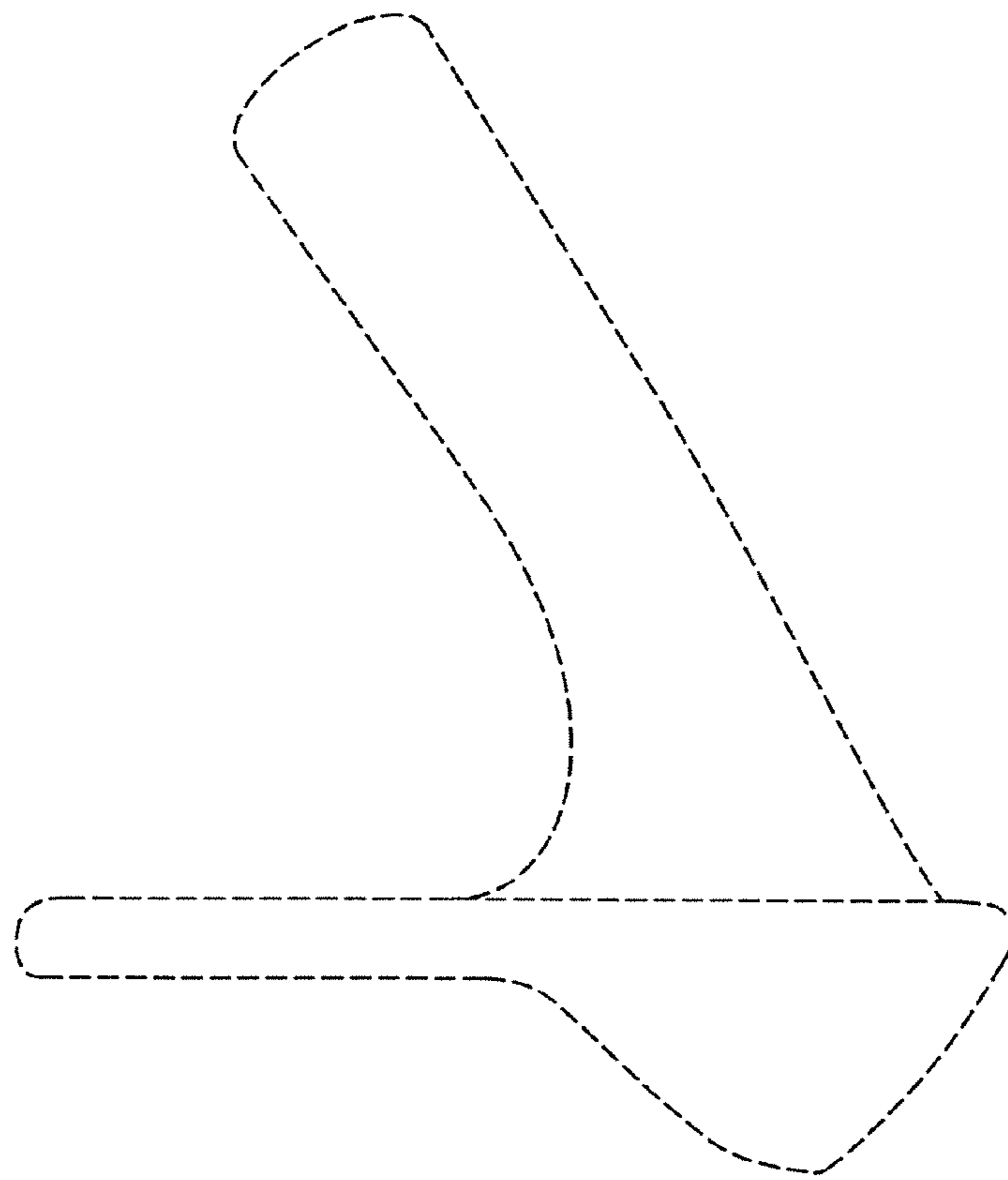

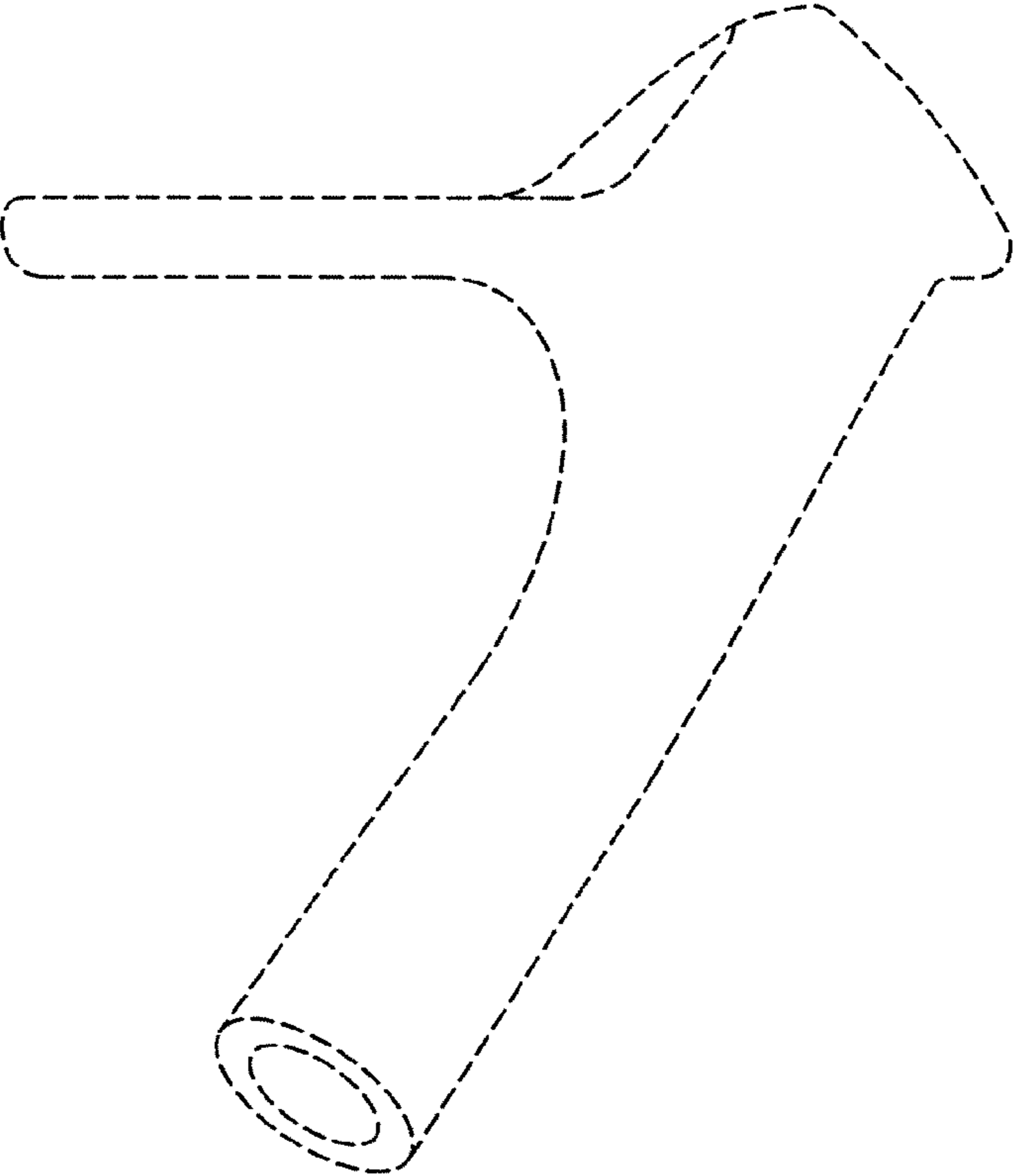

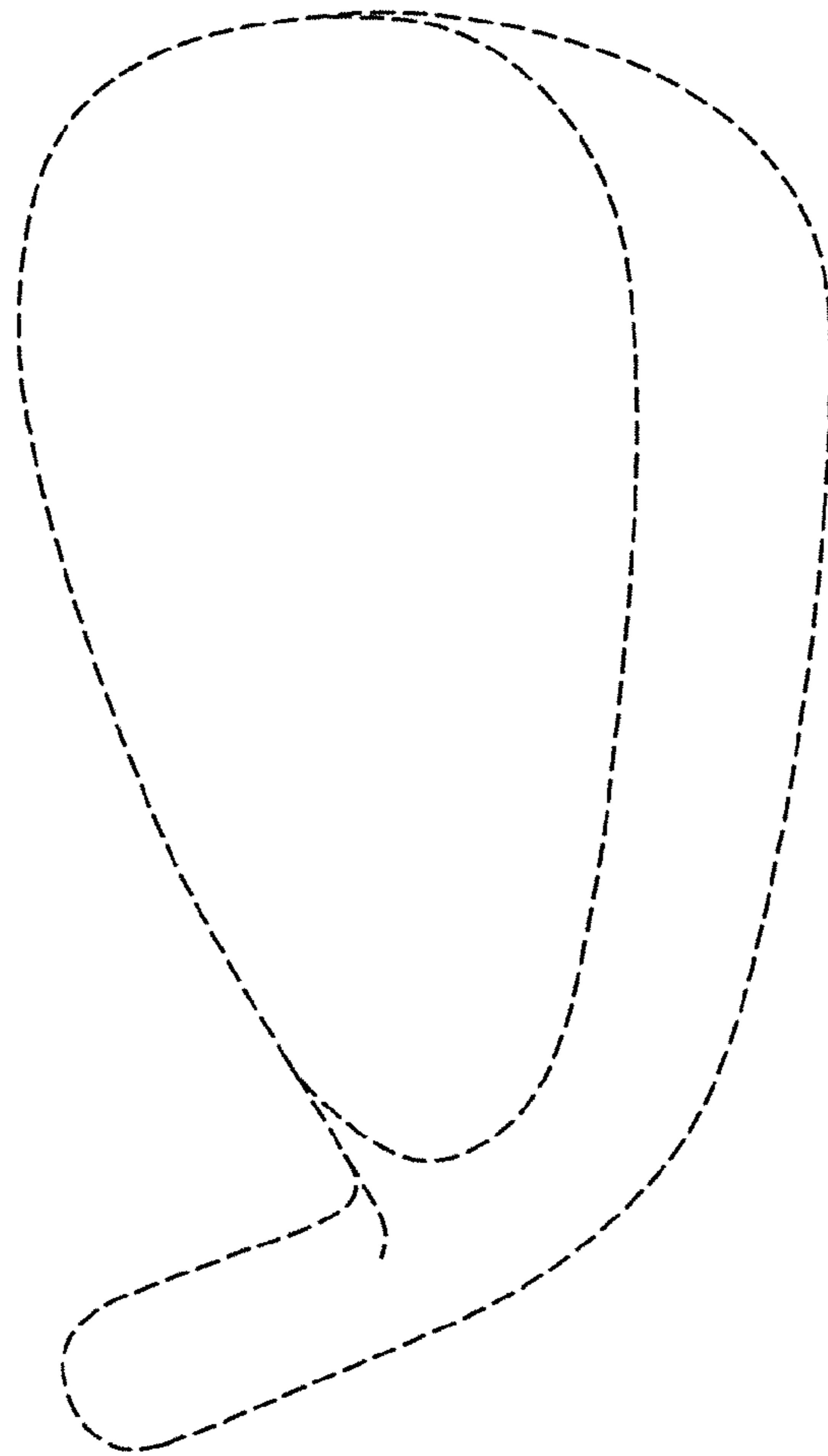
