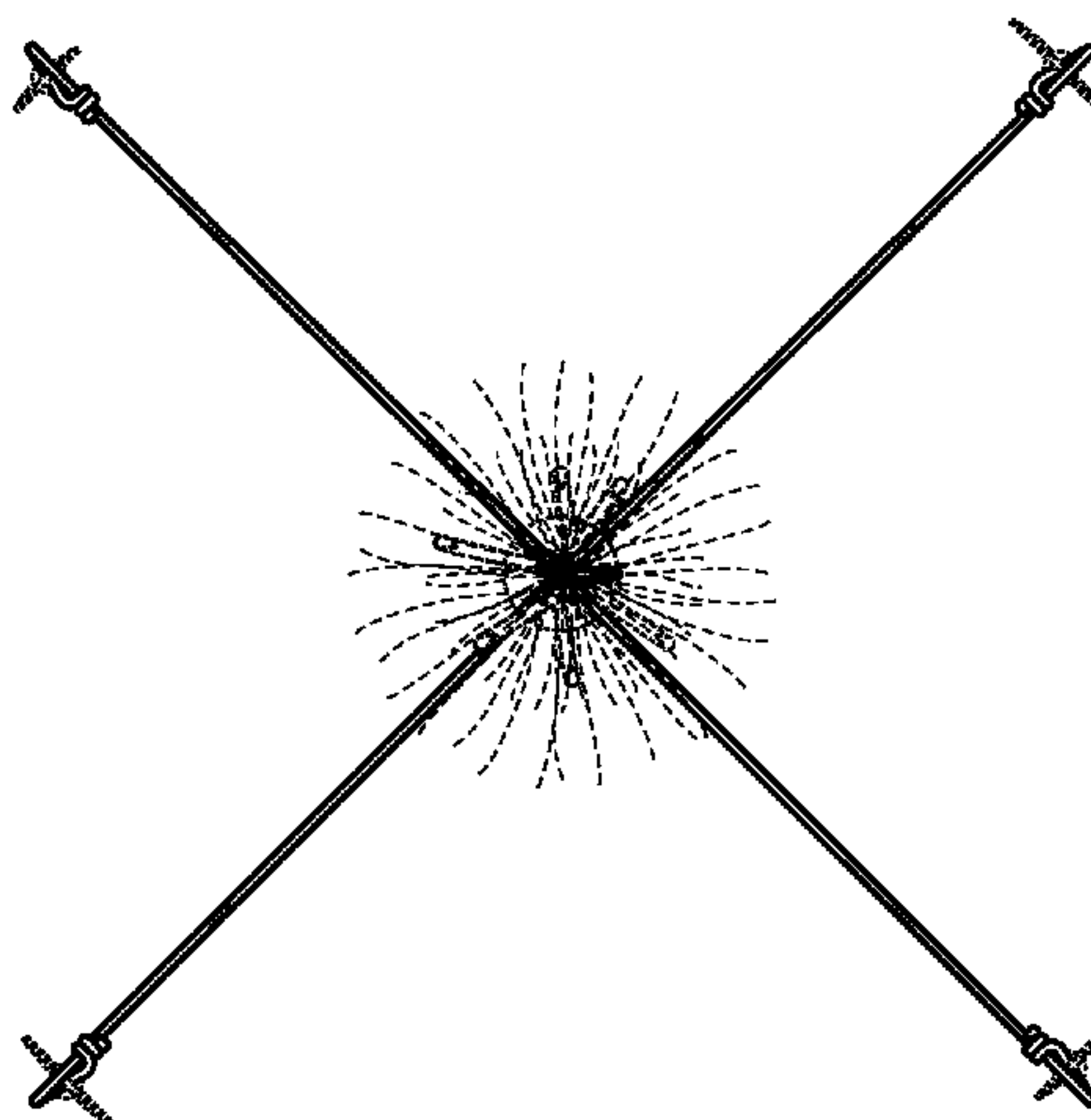
(57) **CLAIM**

The ornamental design for a fishing lure, as shown and described.

DESCRIPTION

FIG. 1 is a top view of the fishing lure.
 FIG. 2 is a bottom view thereof.

 FIG. 5 is a left side view (as seen from the front) thereof.
 FIG. 6 is a right side view (as seen from the front) thereof.

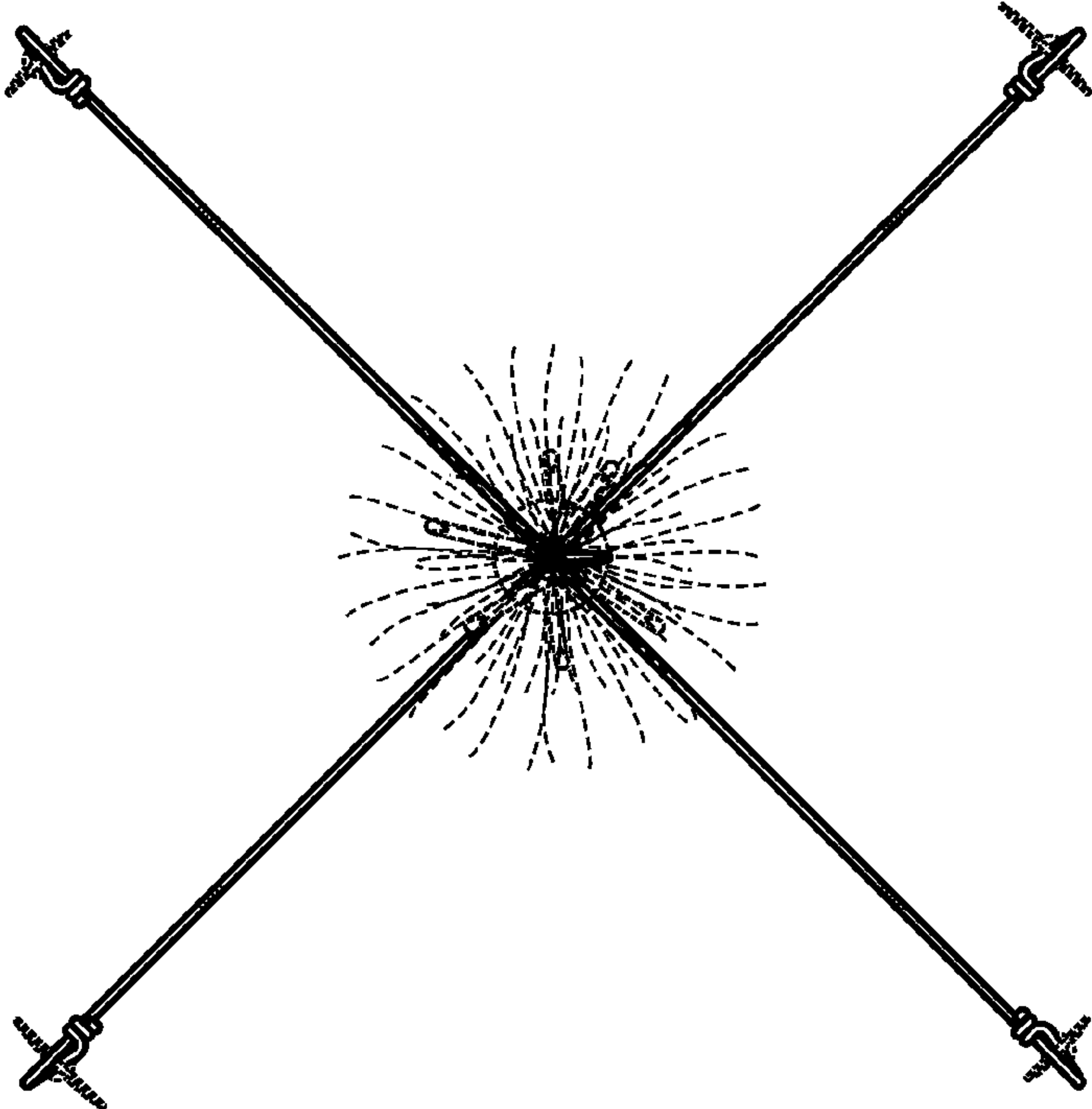

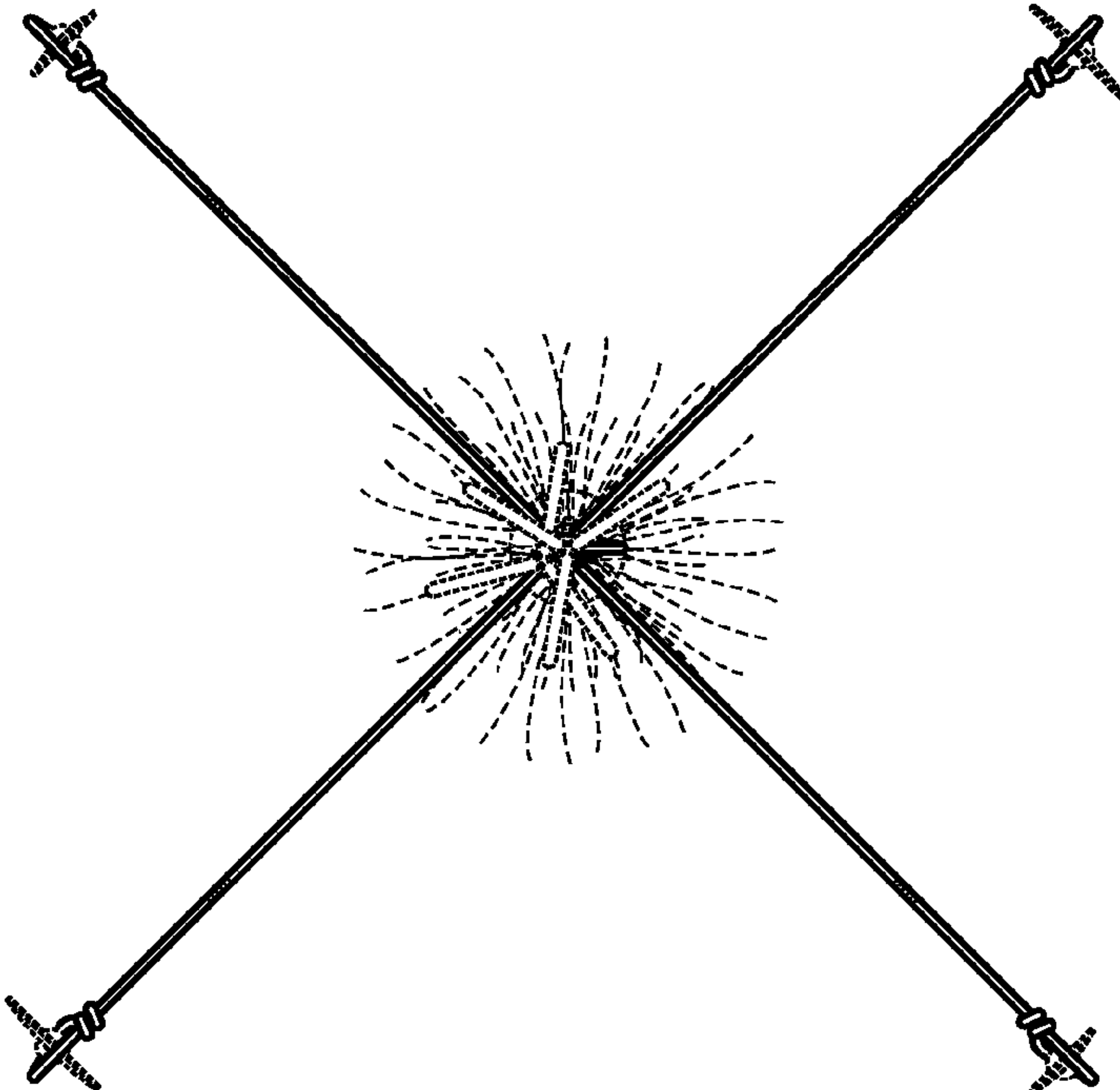

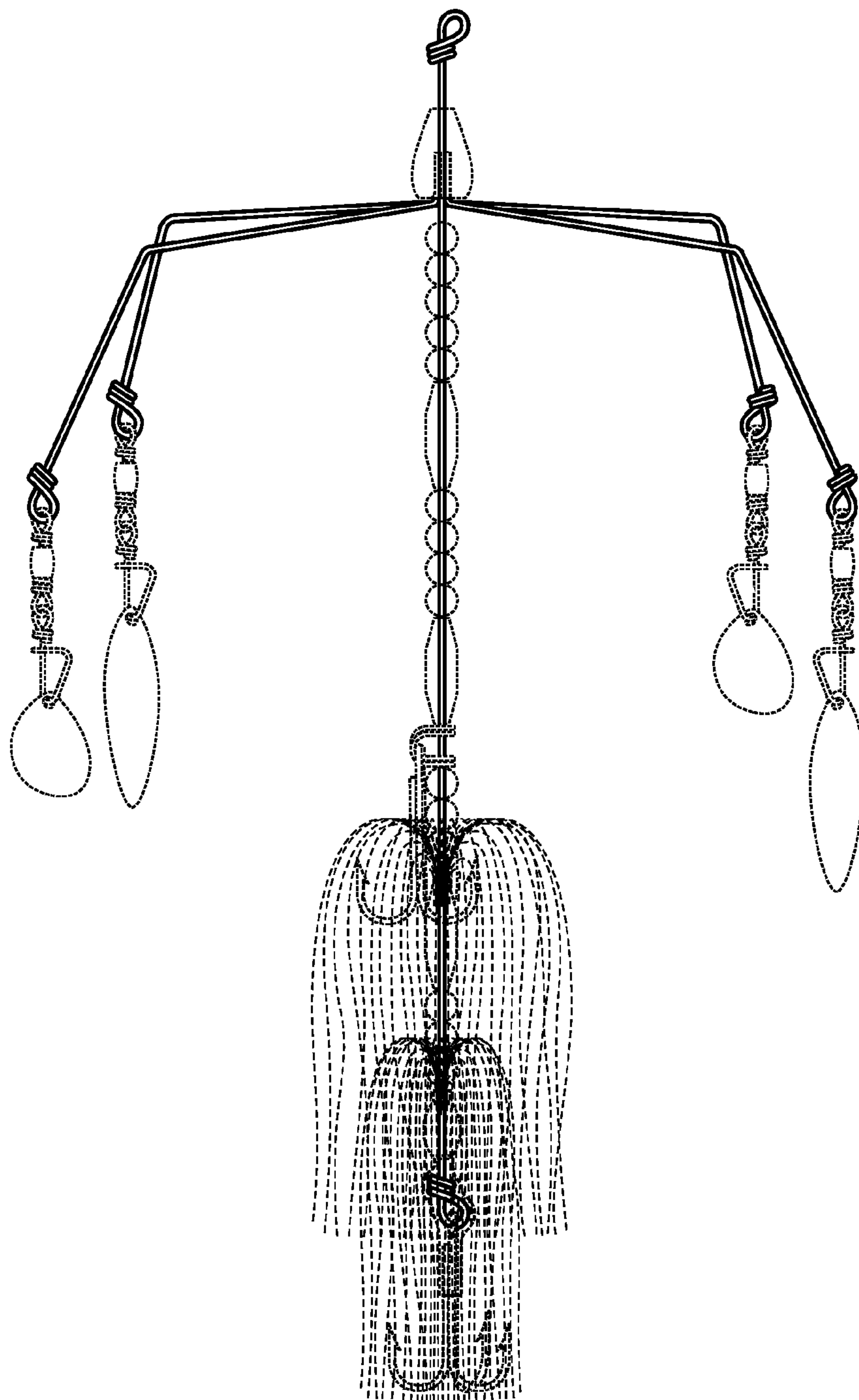

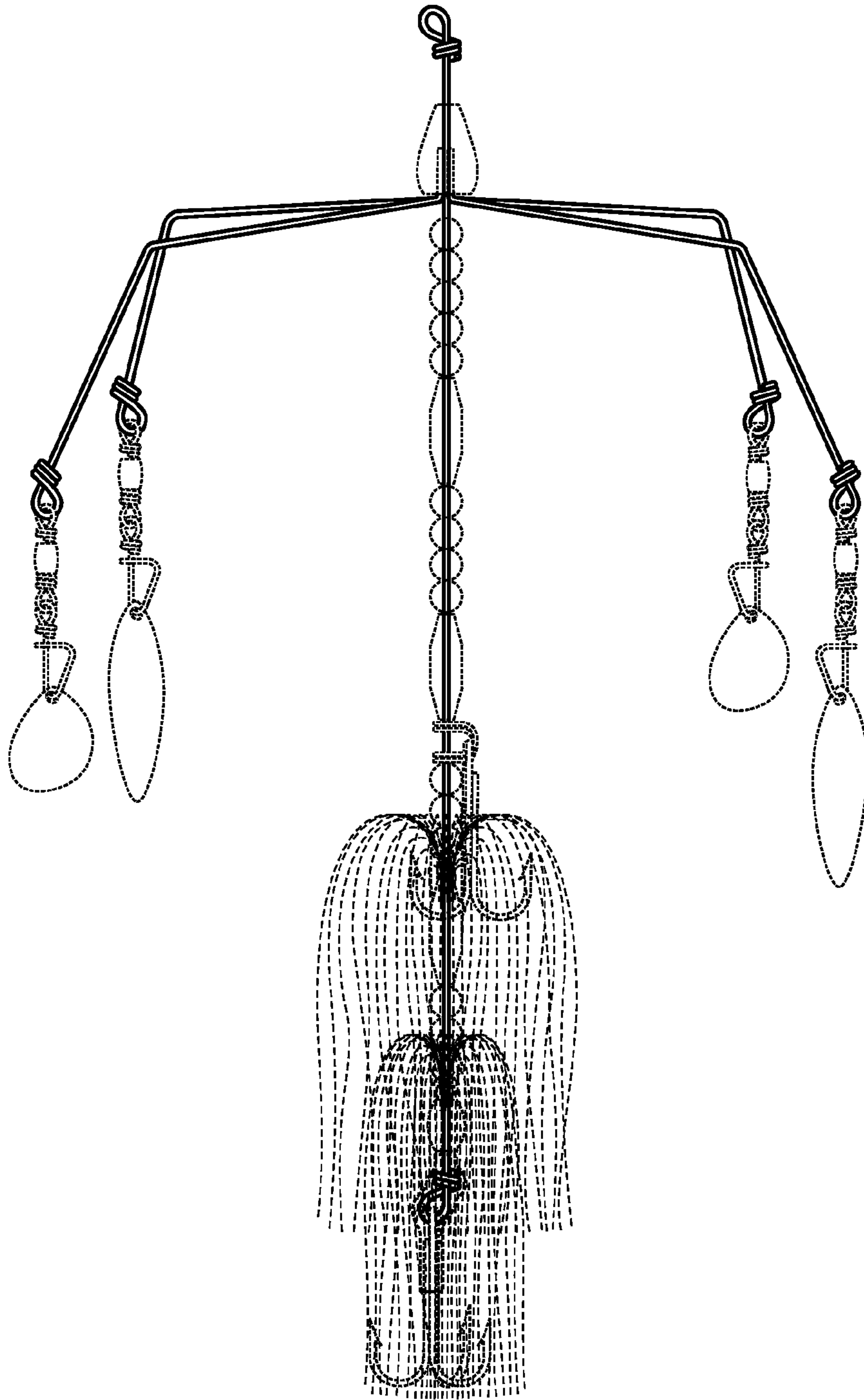

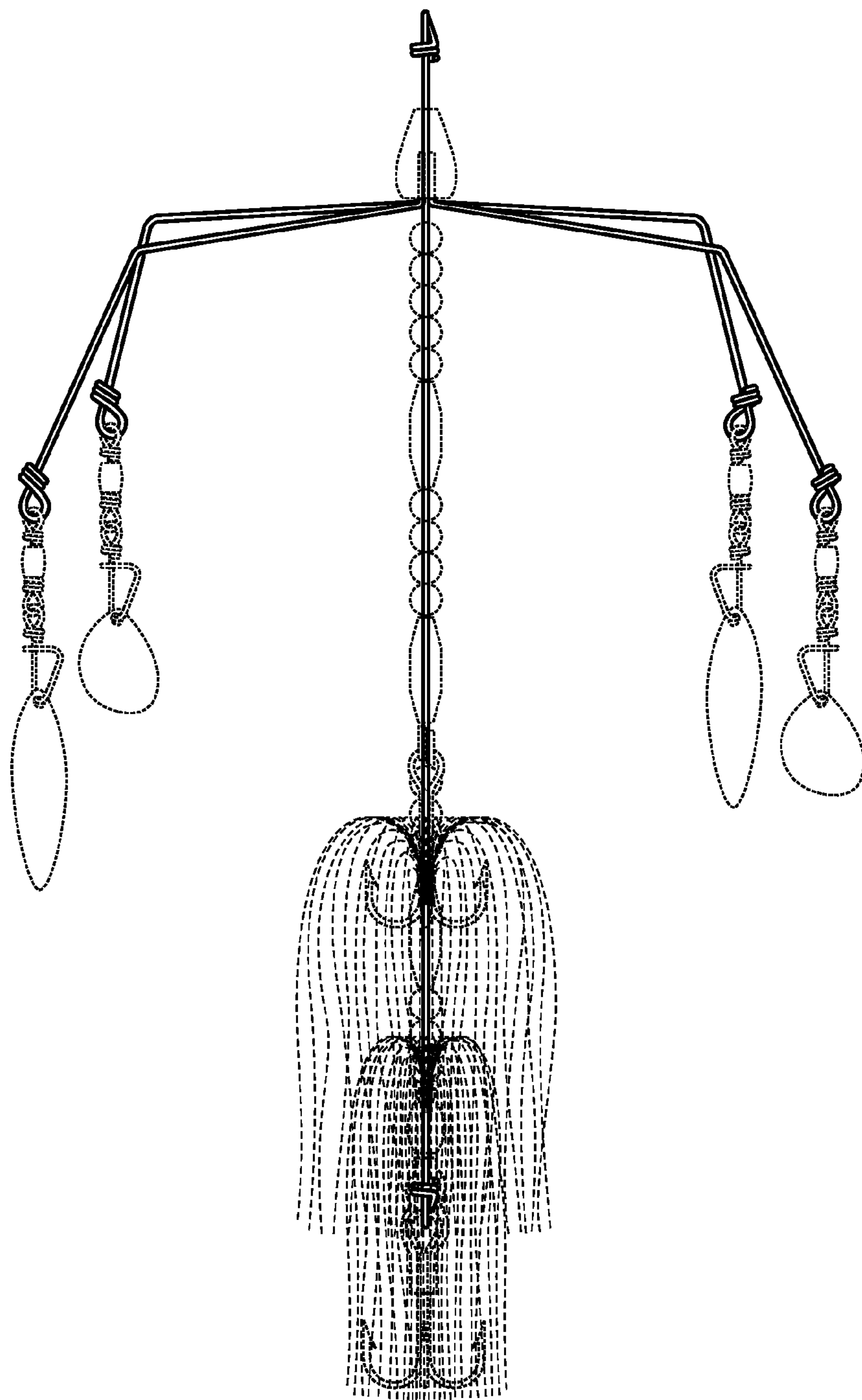

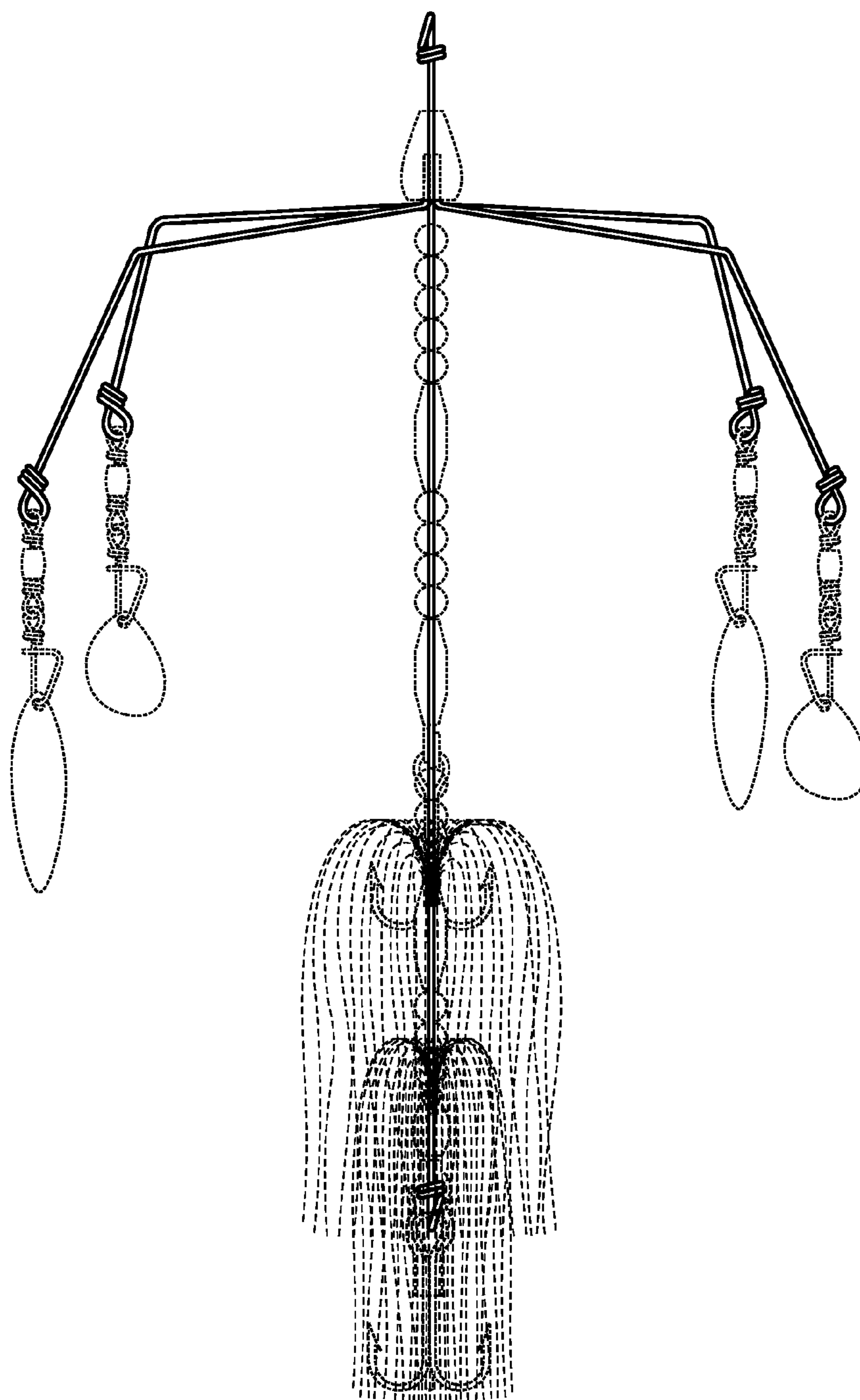

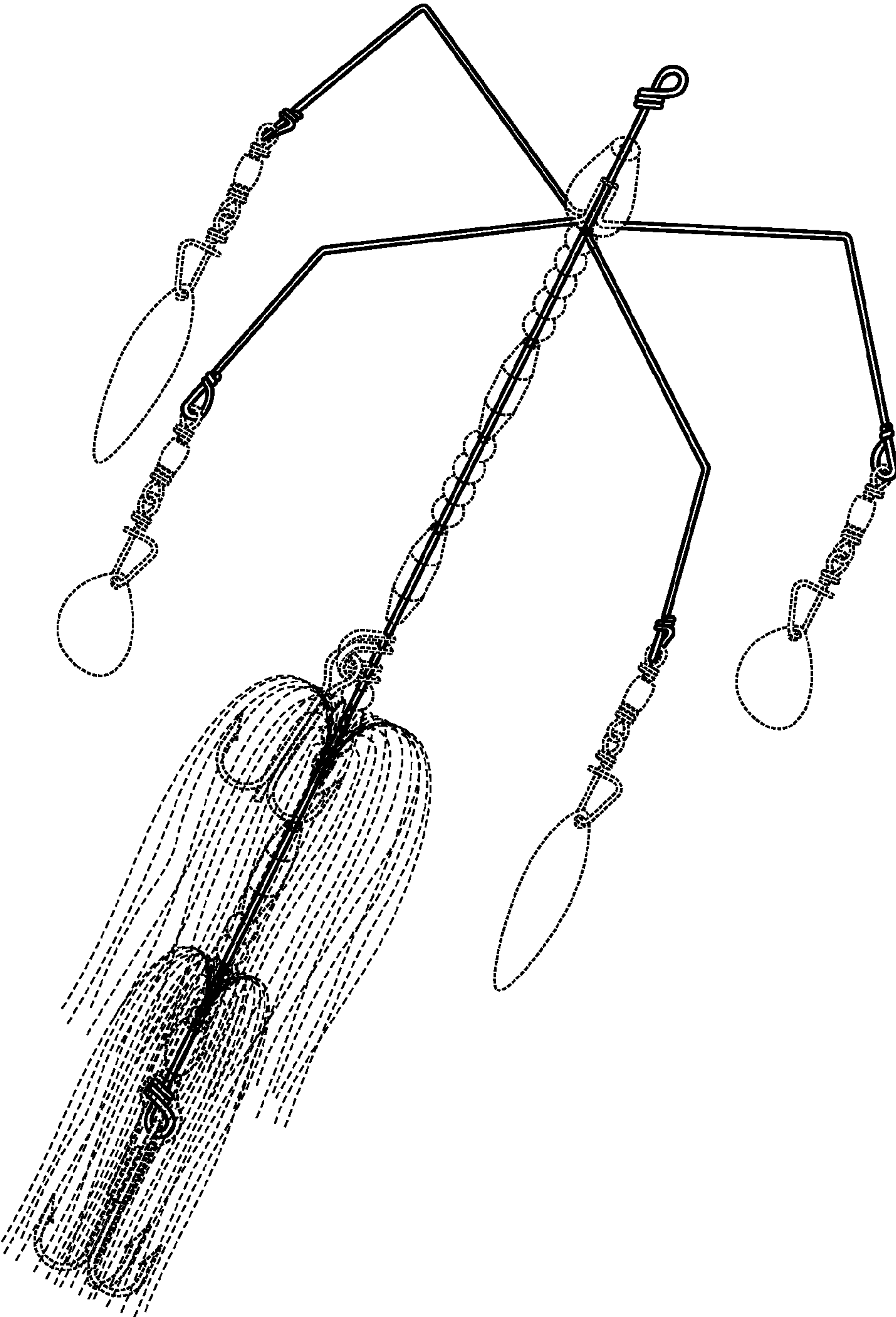

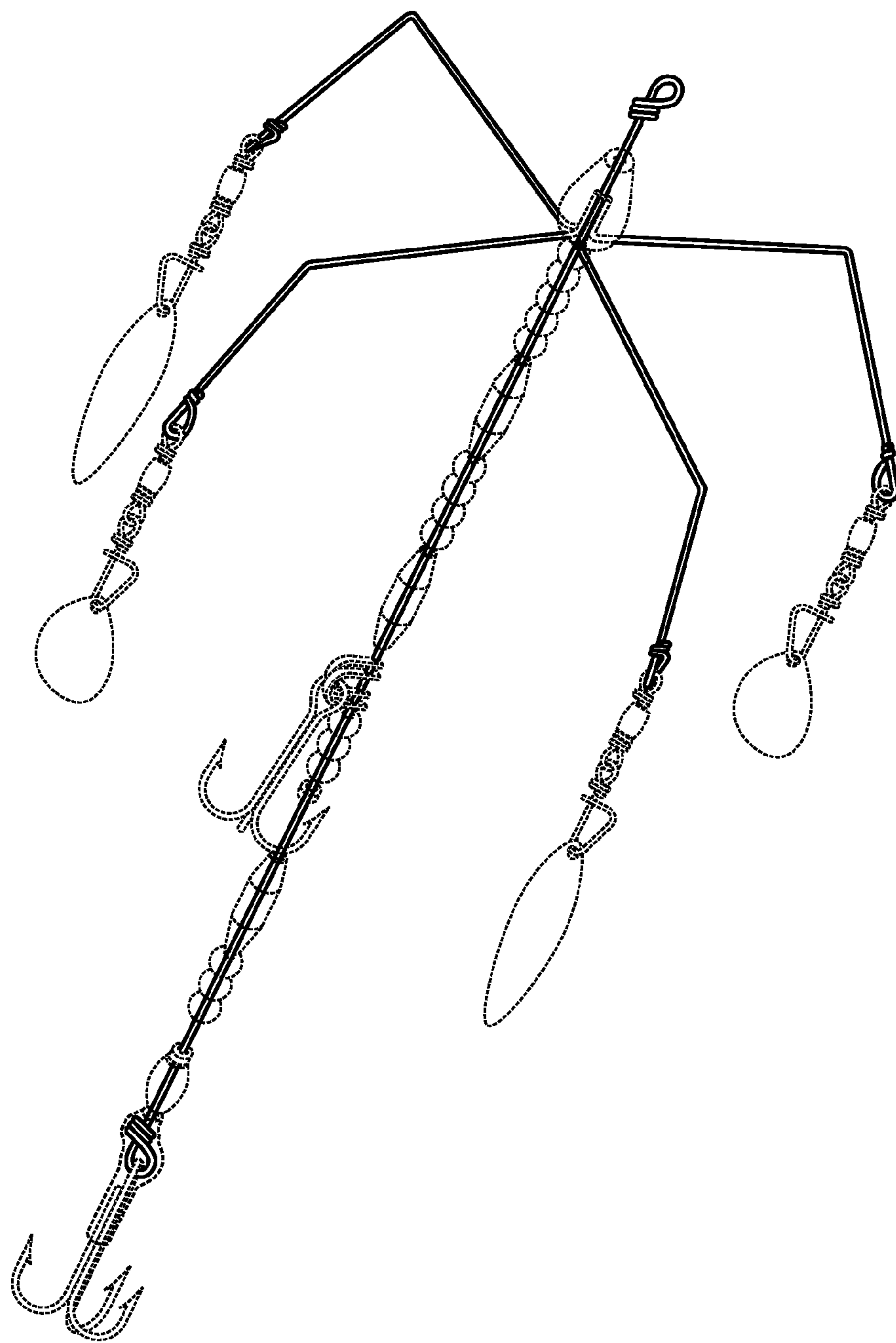
