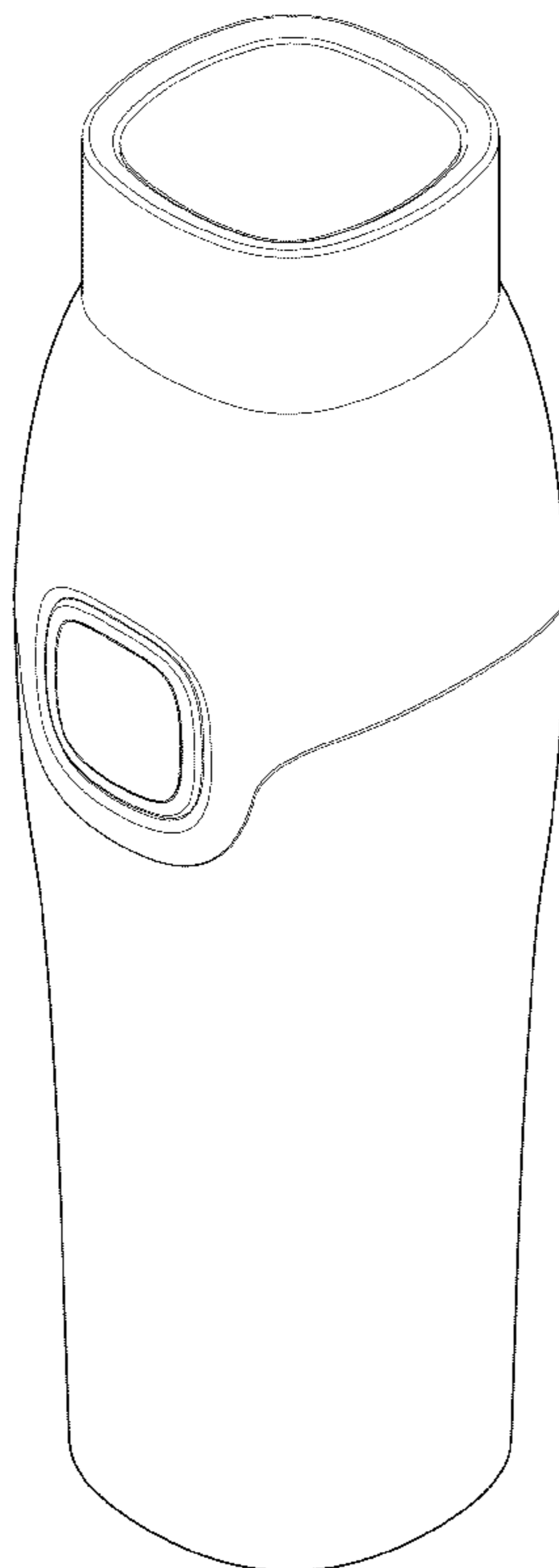
(57) **CLAIM**

I claim the ornamental design for a portable UV sterilizer for baby bottle and nipple, as shown and described.

**DESCRIPTION**

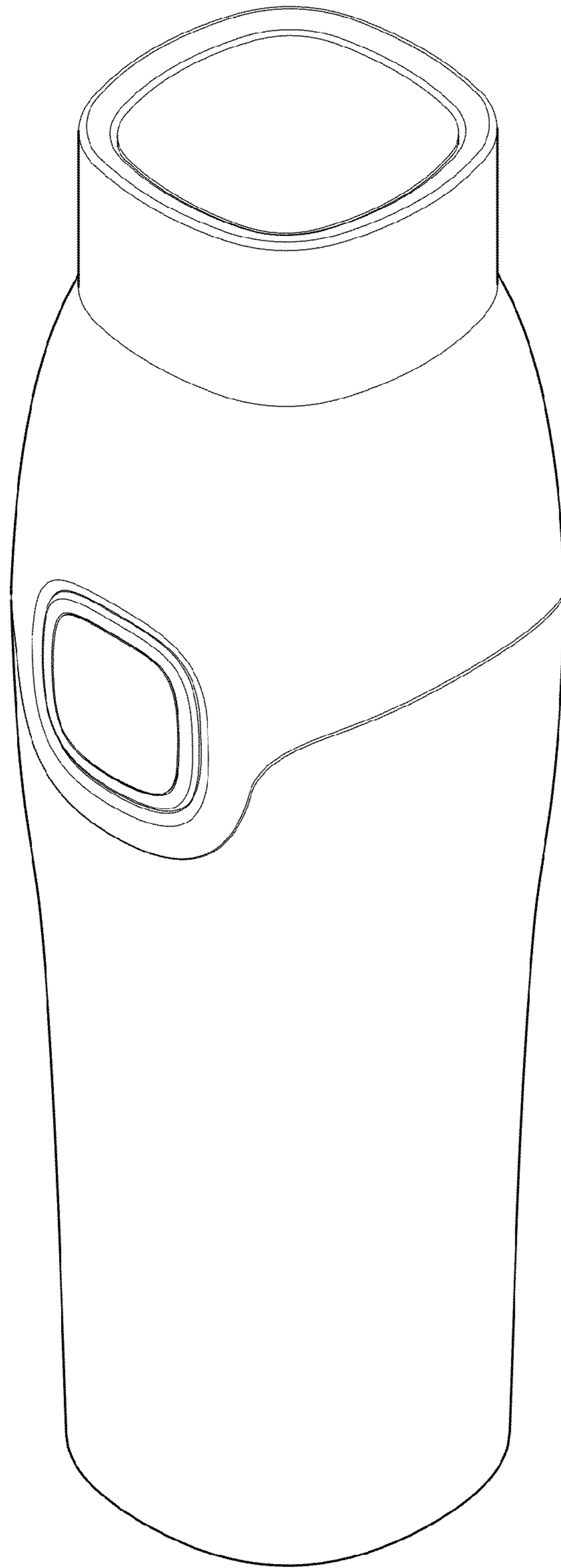

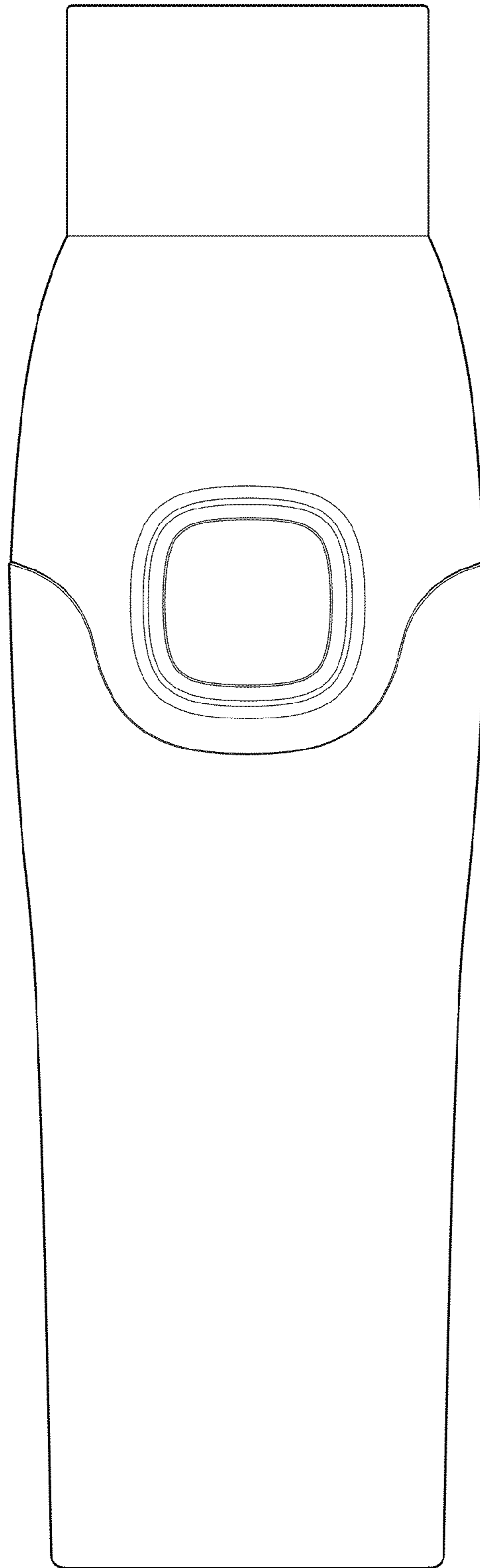
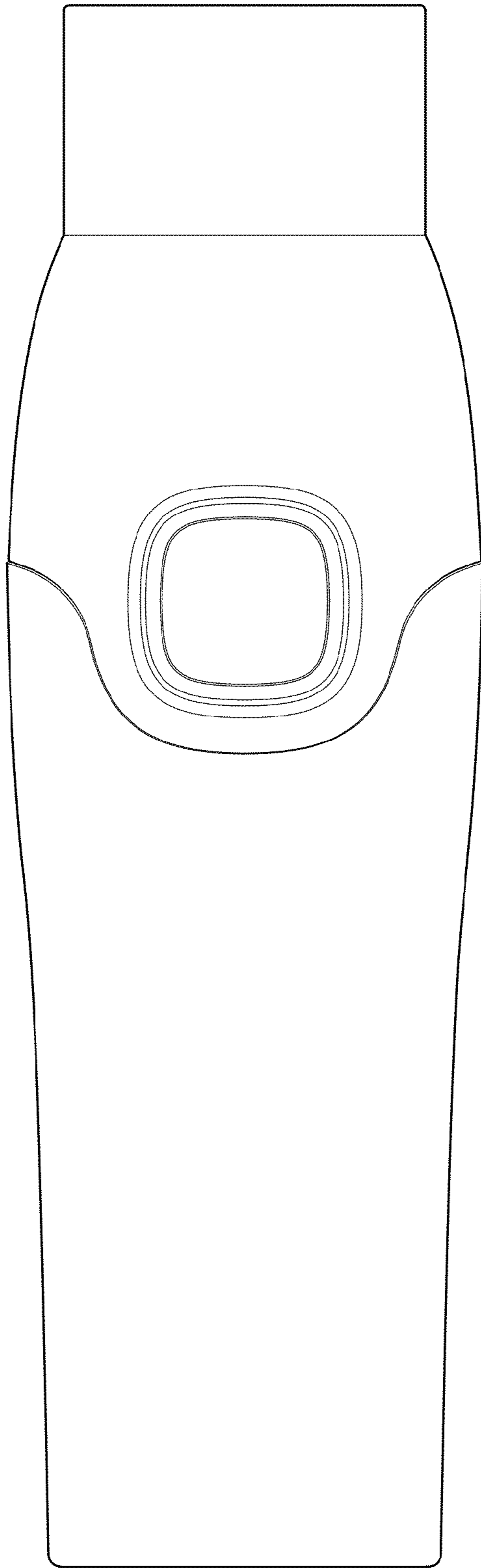

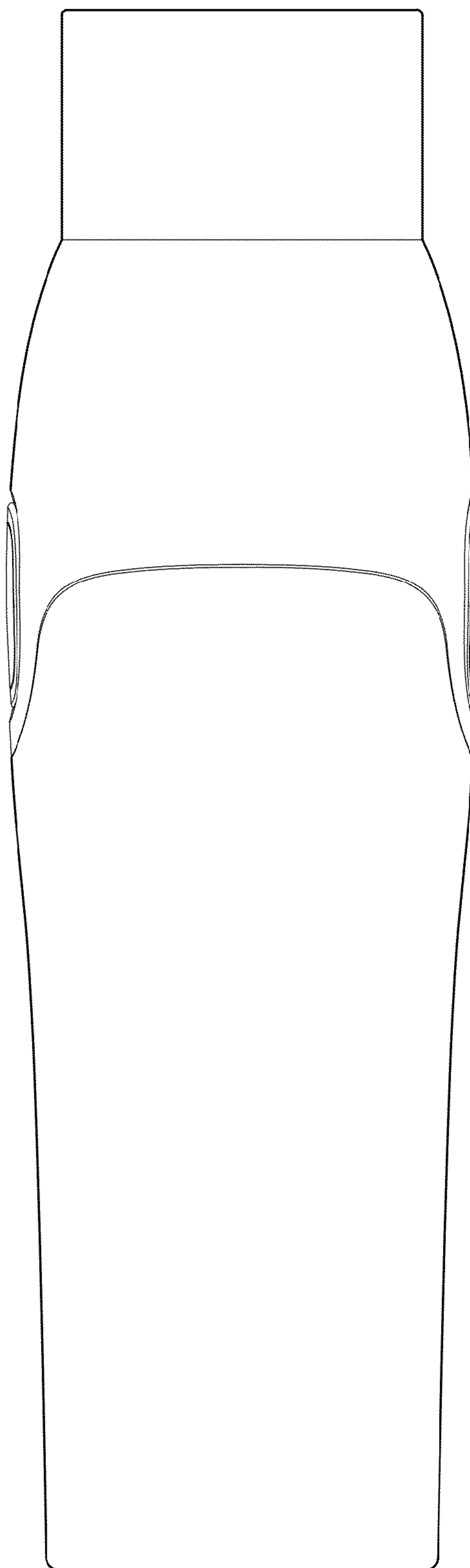
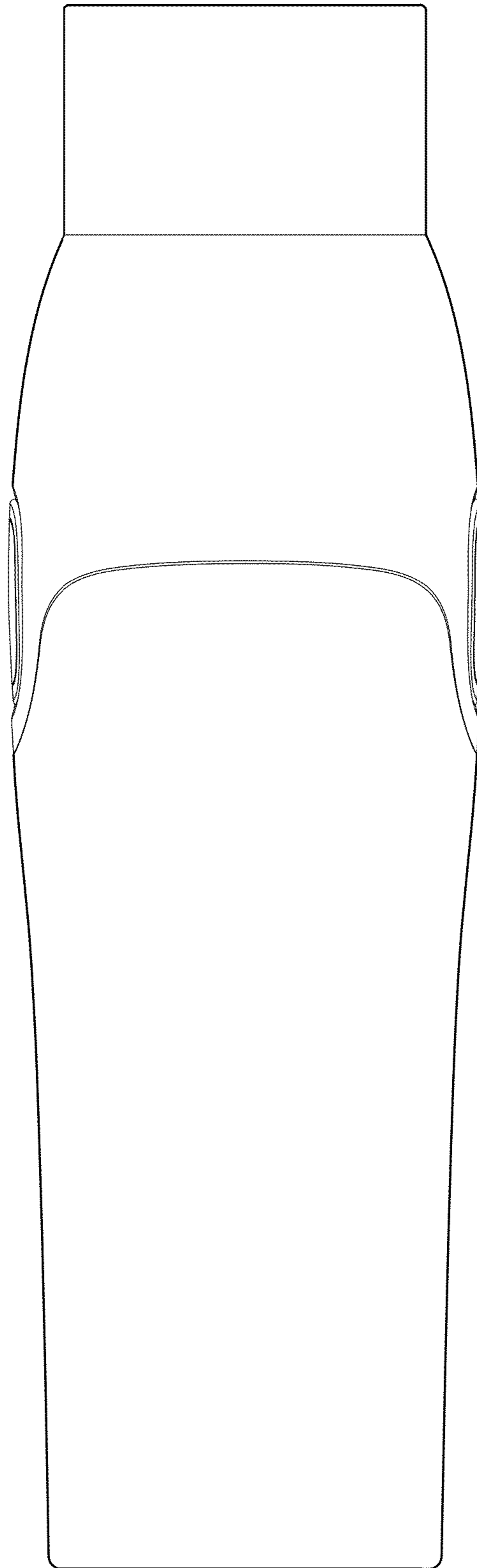
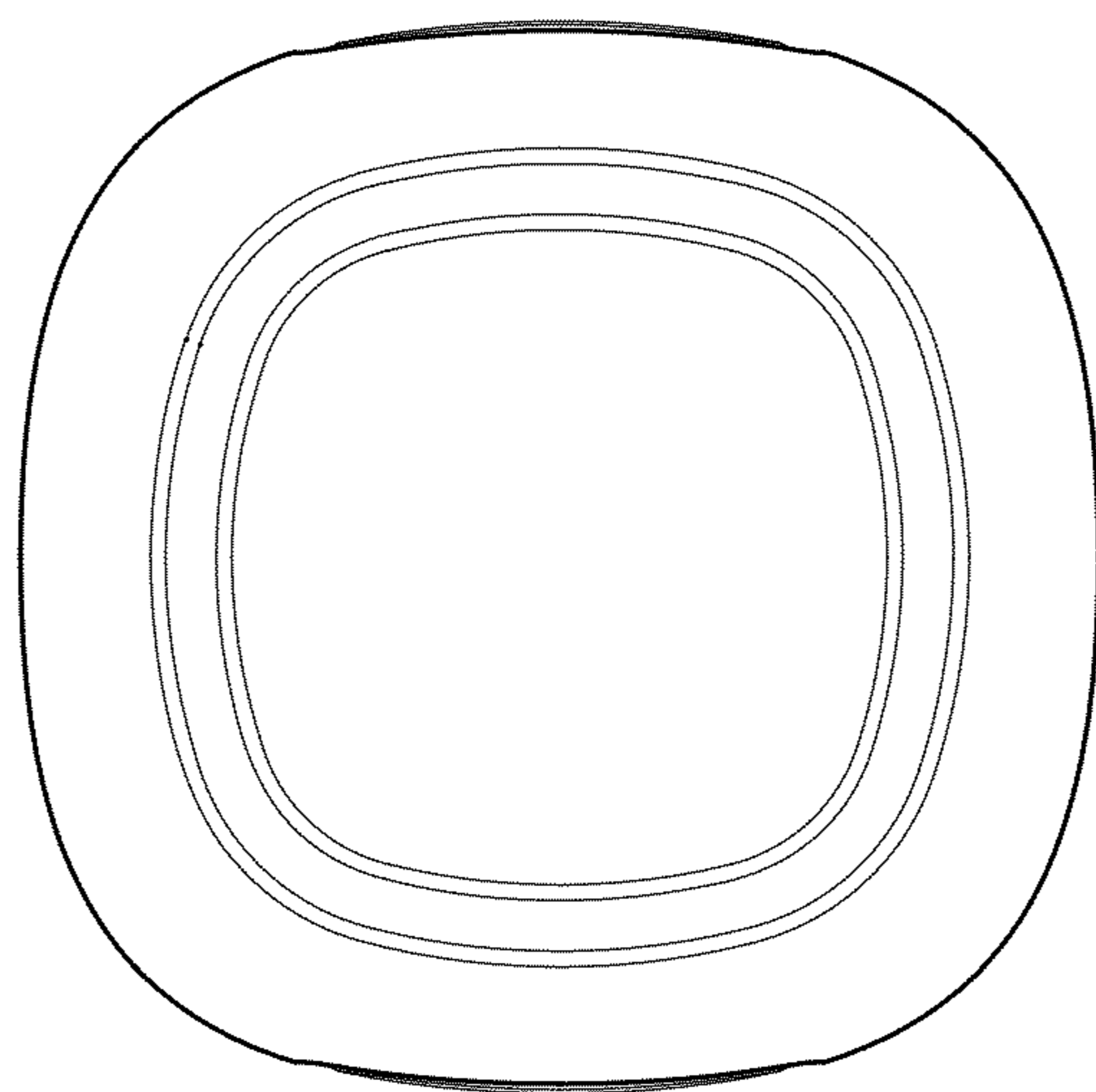


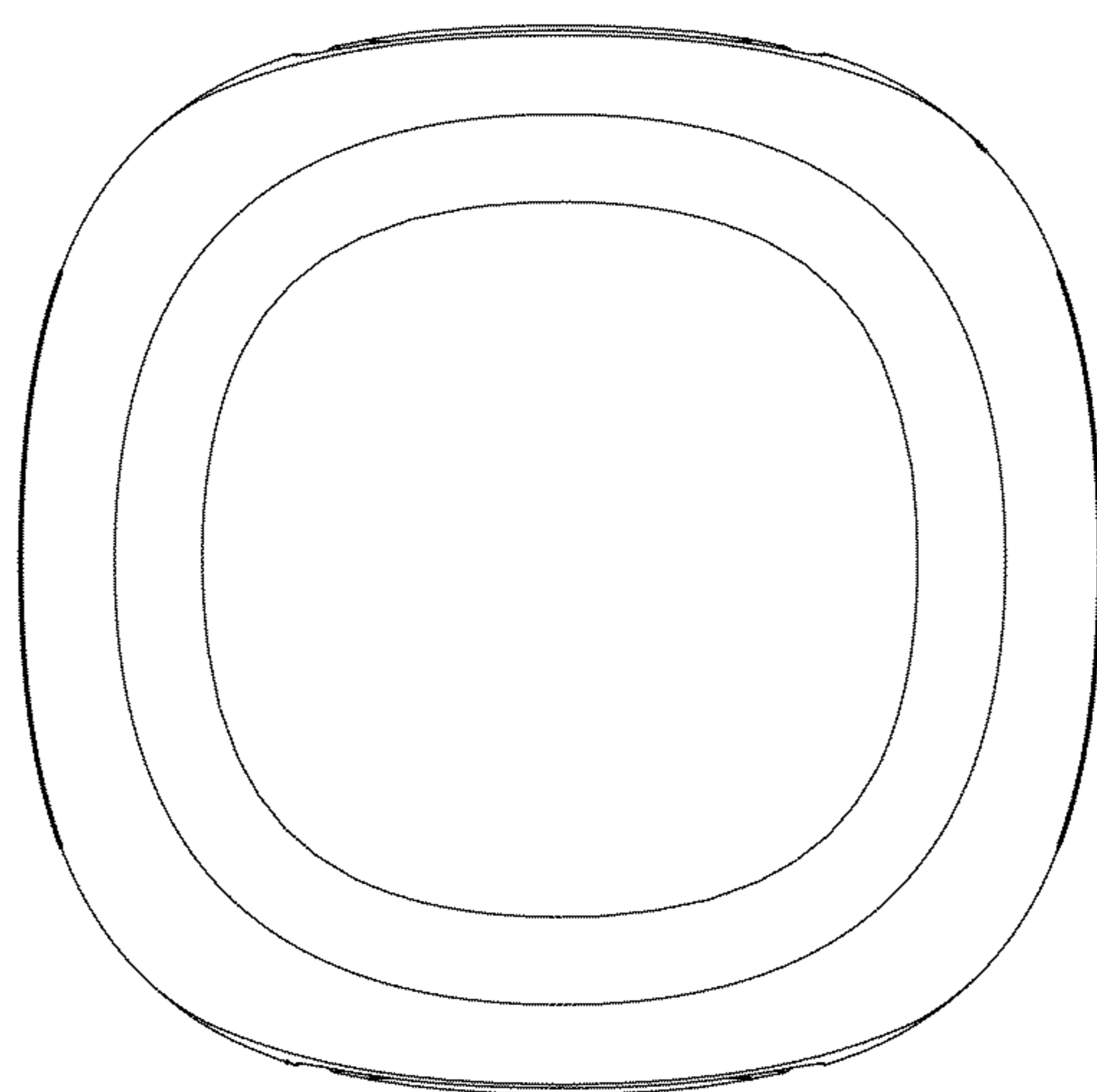
