FIG. 4 is a left side view of the architectural panel with scatter embossed surface.

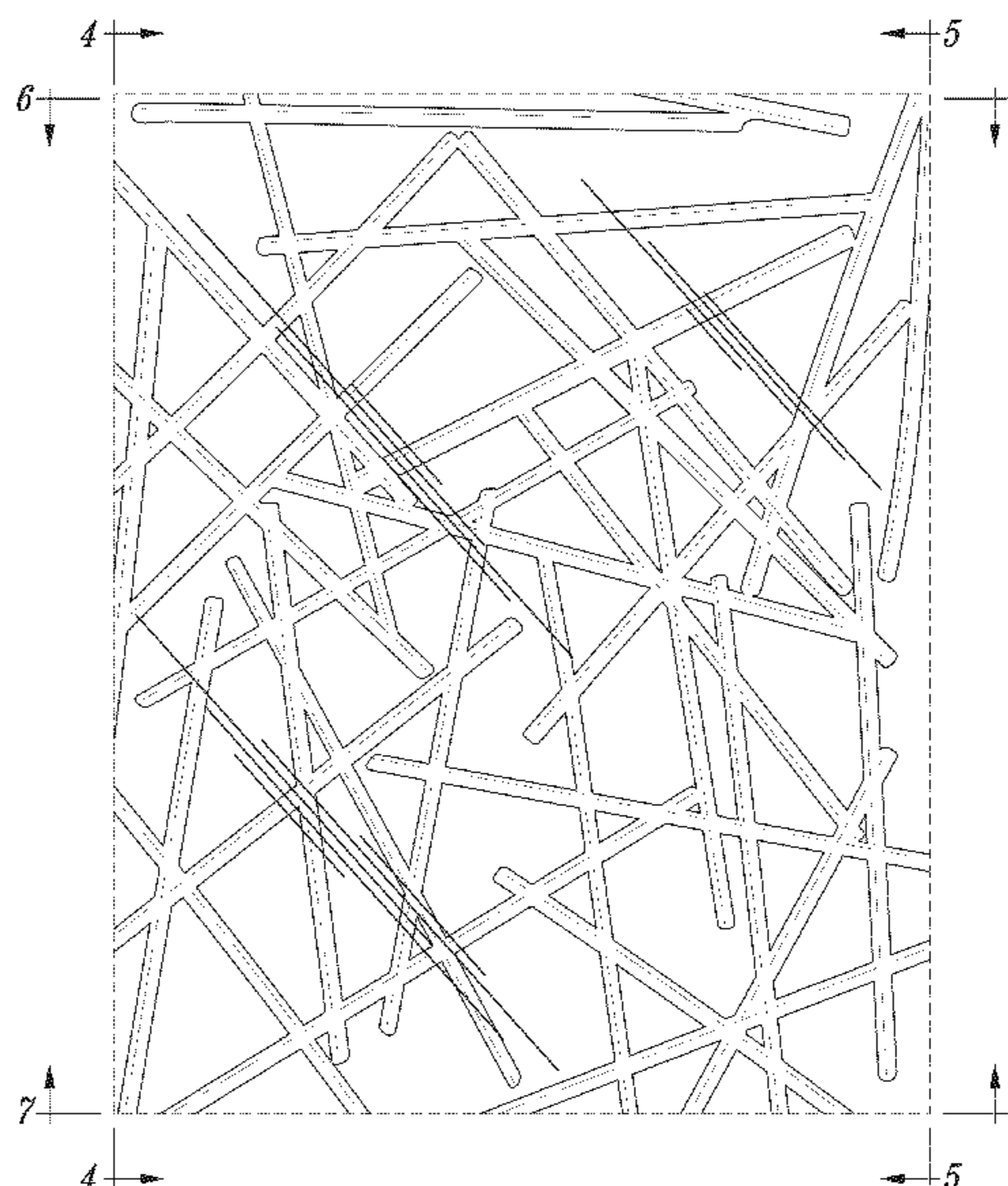
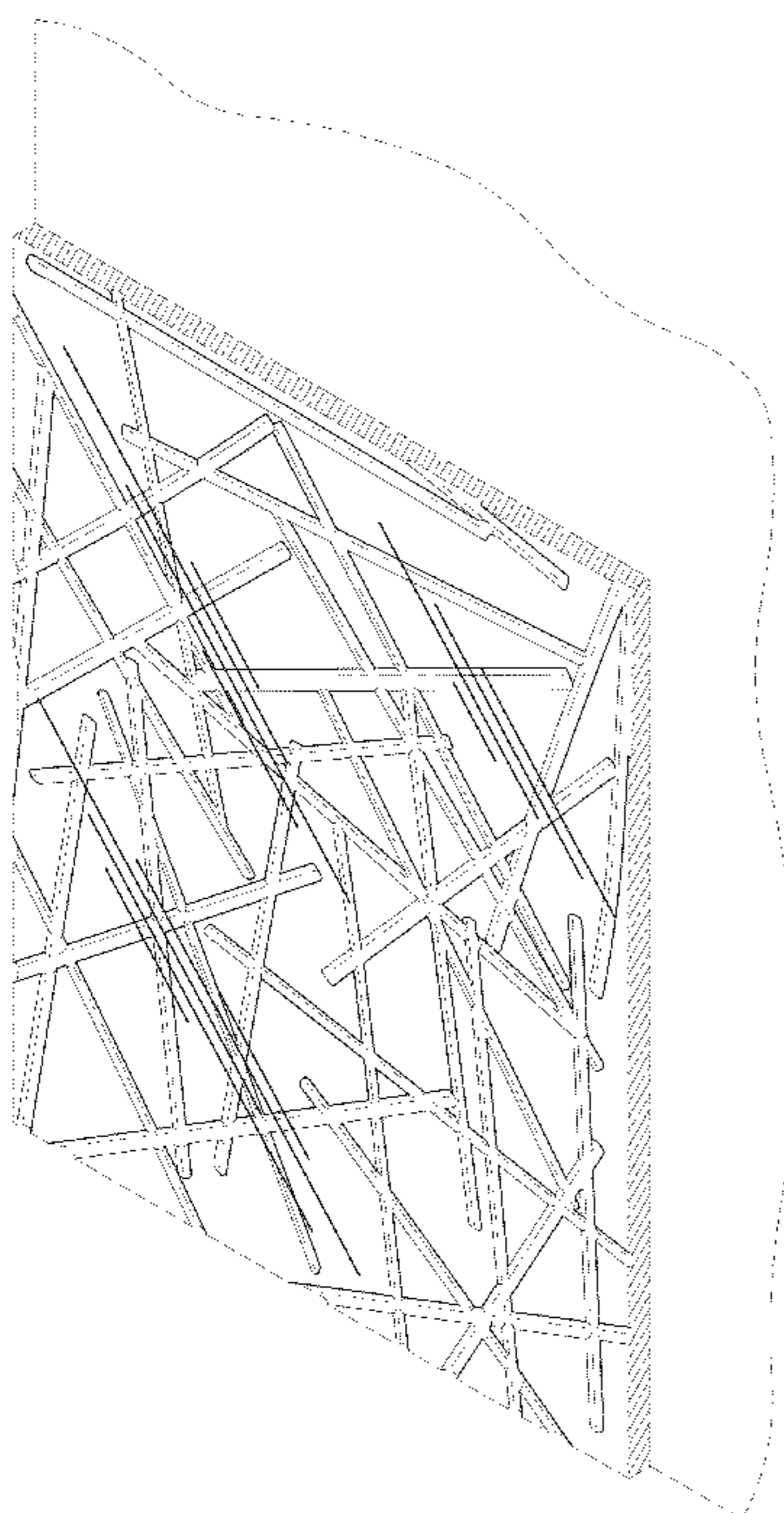
FIG. 5 is a right side view of the architectural panel with scatter embossed surface.

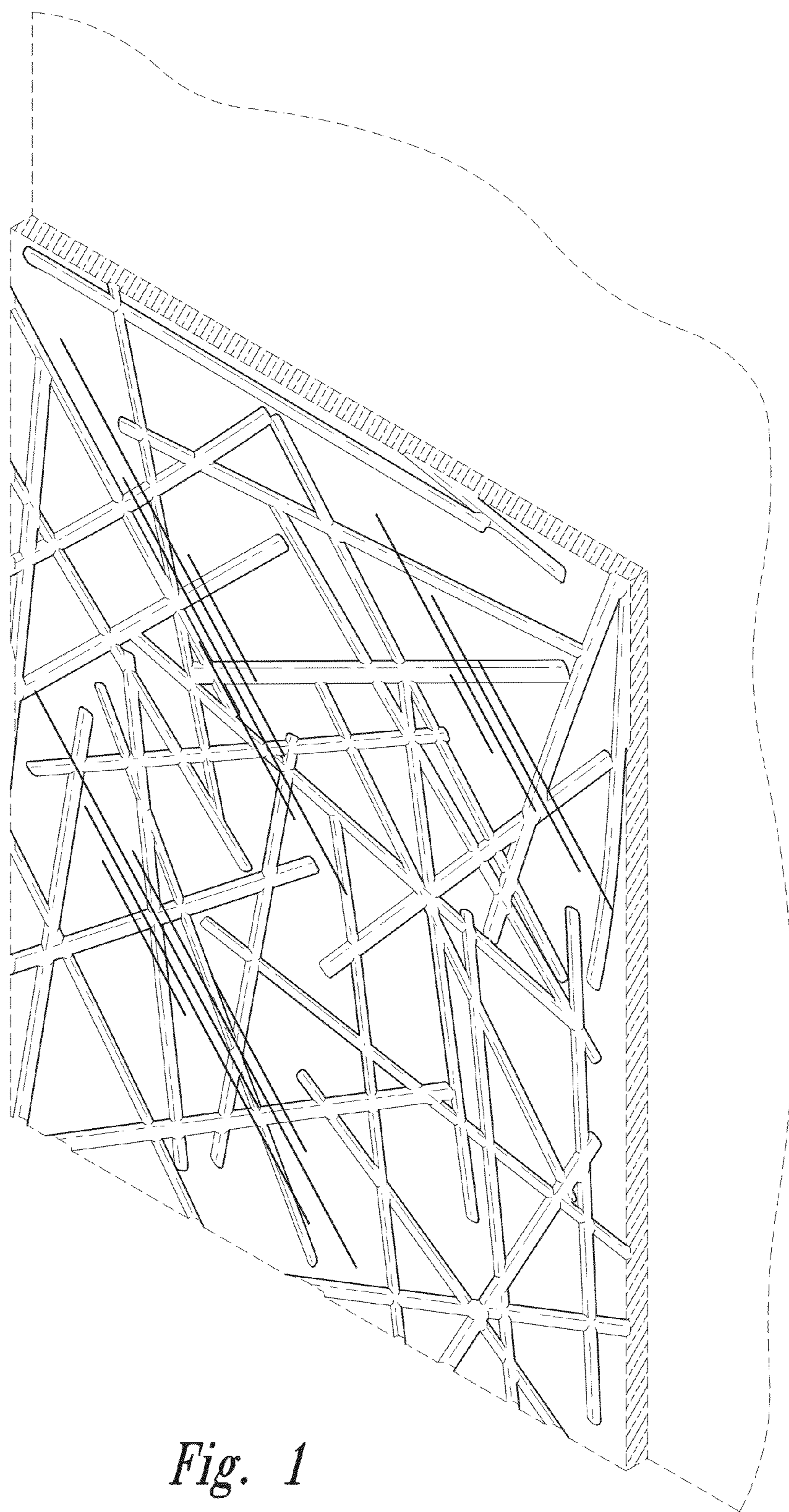
FIG. 6 is a top view of the architectural panel with scatter embossed surface; and,

FIG. 7 is a bottom view of the architectural panel with scatter embossed surface.

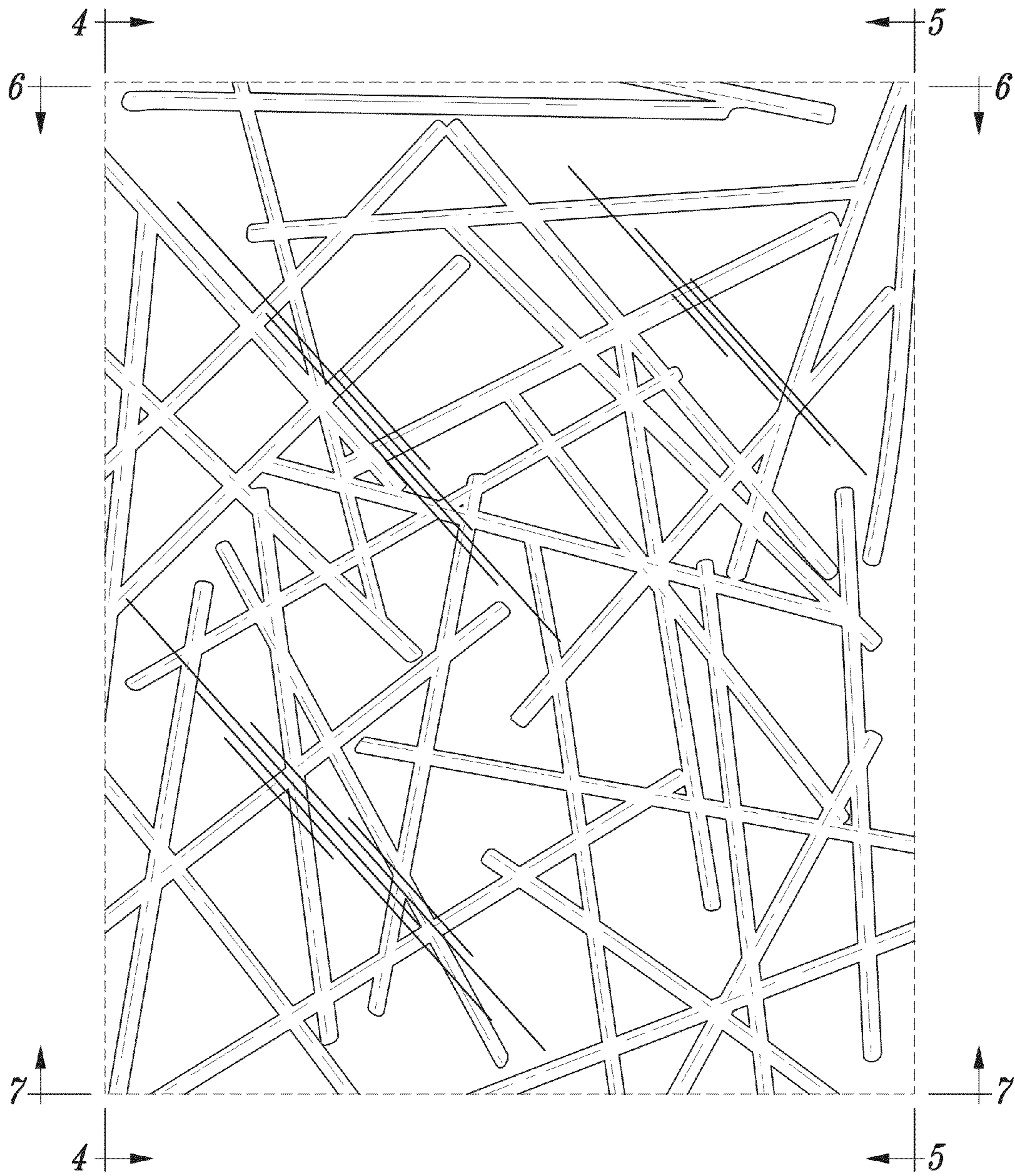
The broken lines adjacent to the shaded portions of the design depict the bounds of the claim and all other broken lines depict environmental subject matter. All broken lines form no part of the claim.

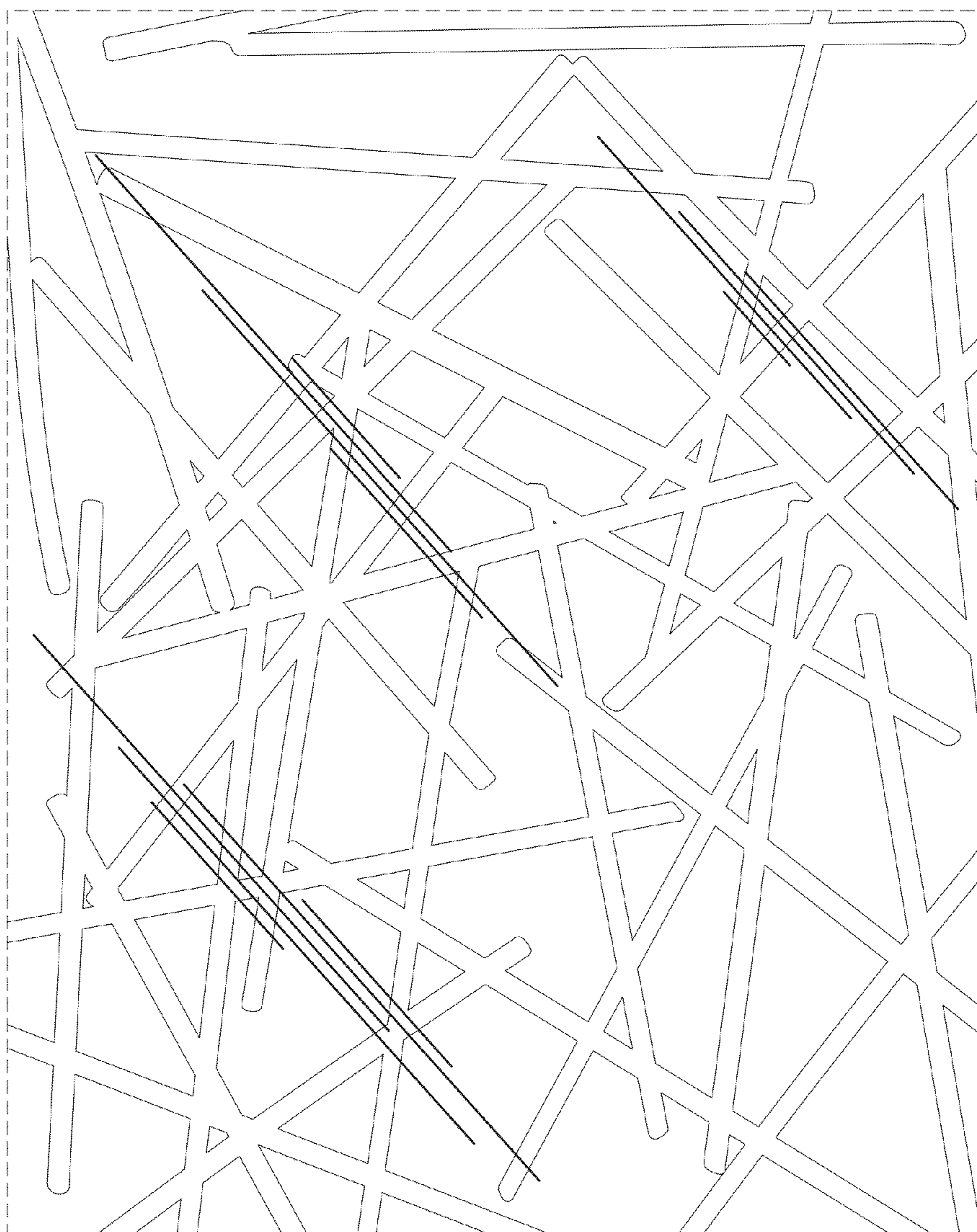




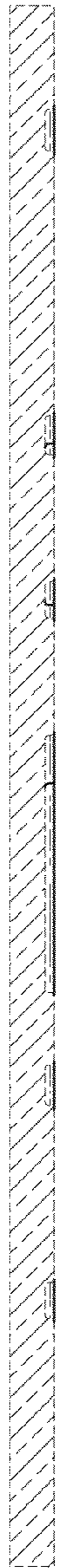

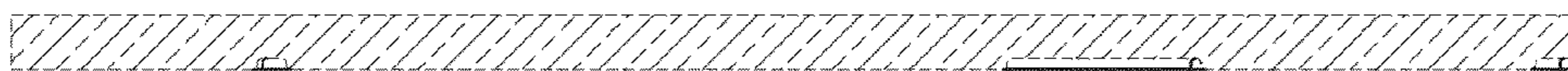

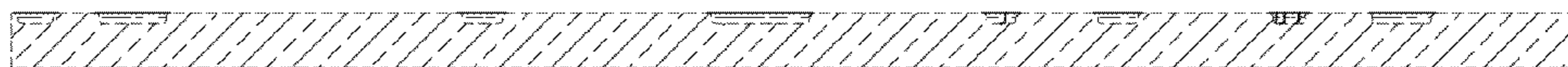
