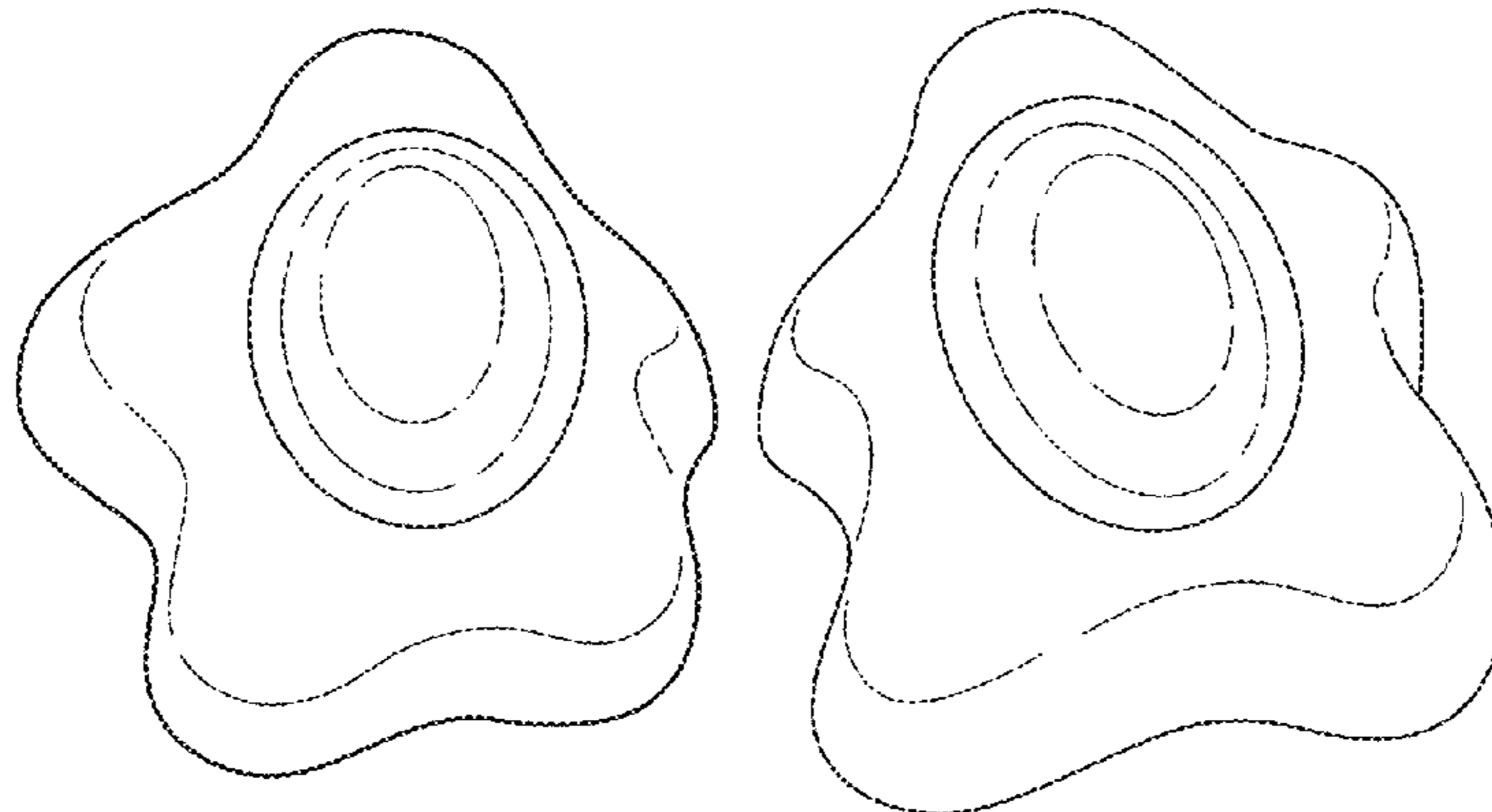

I claim, the ornamental design for a chocolate confectionery, as shown and described.

DESCRIPTION

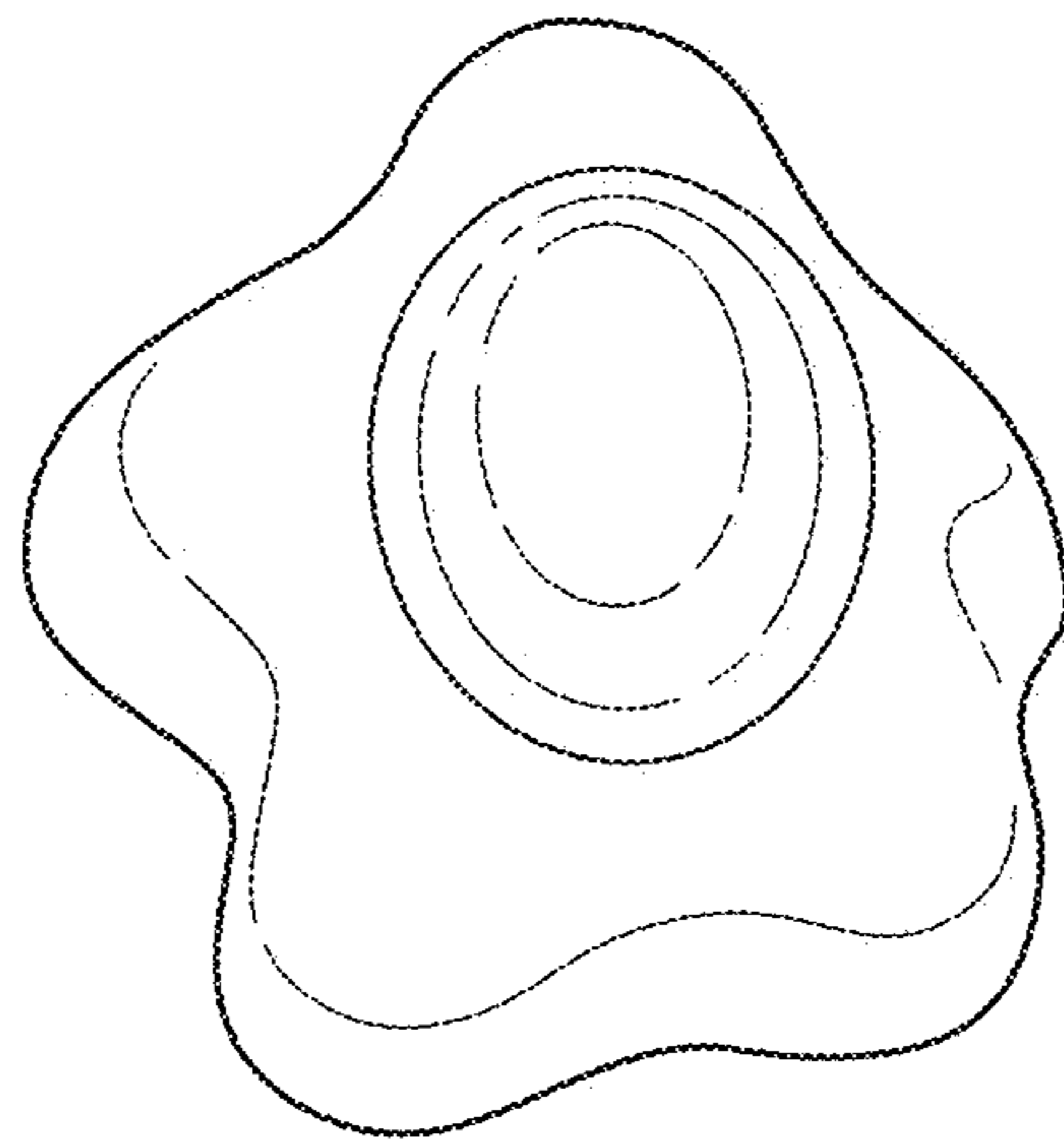

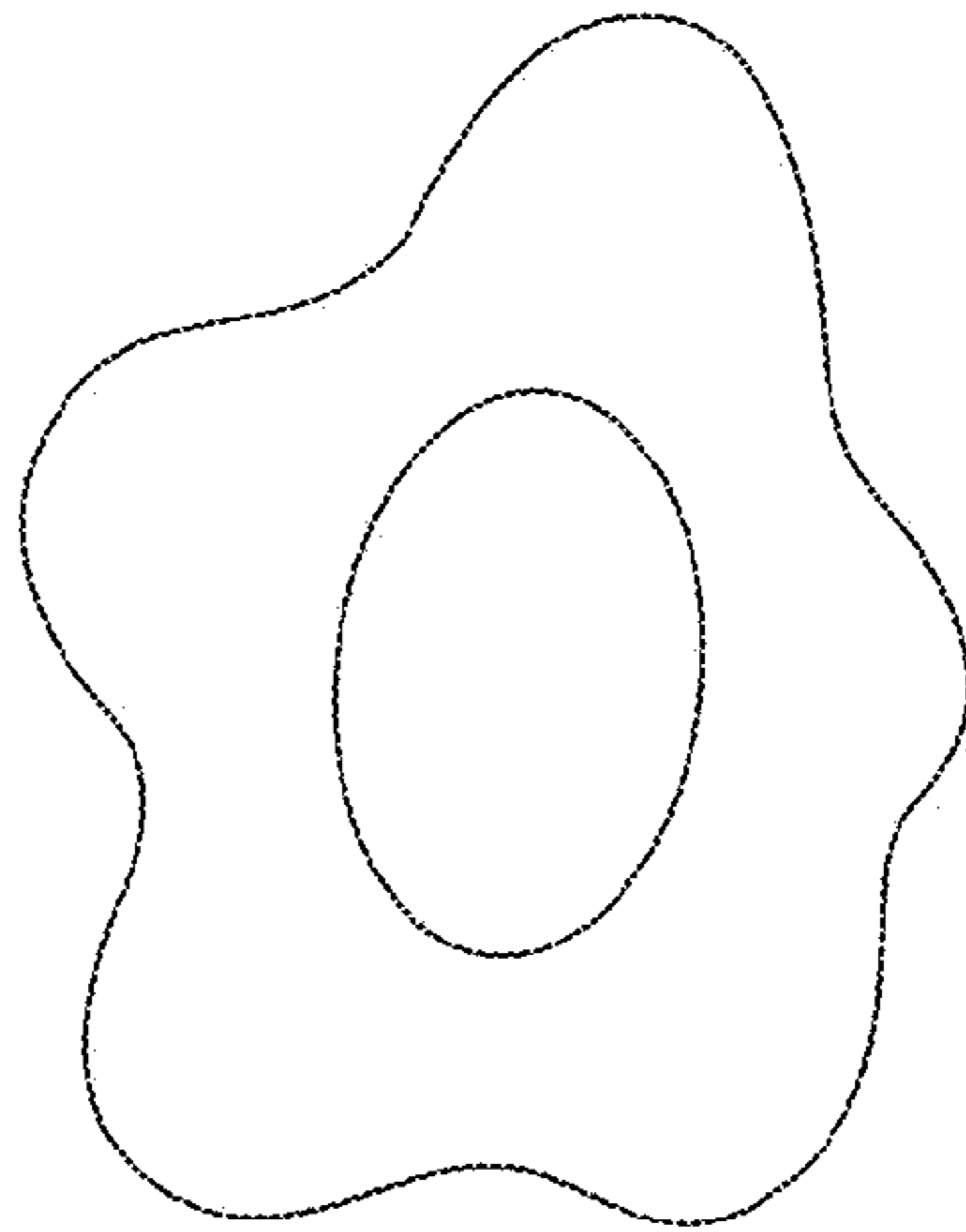

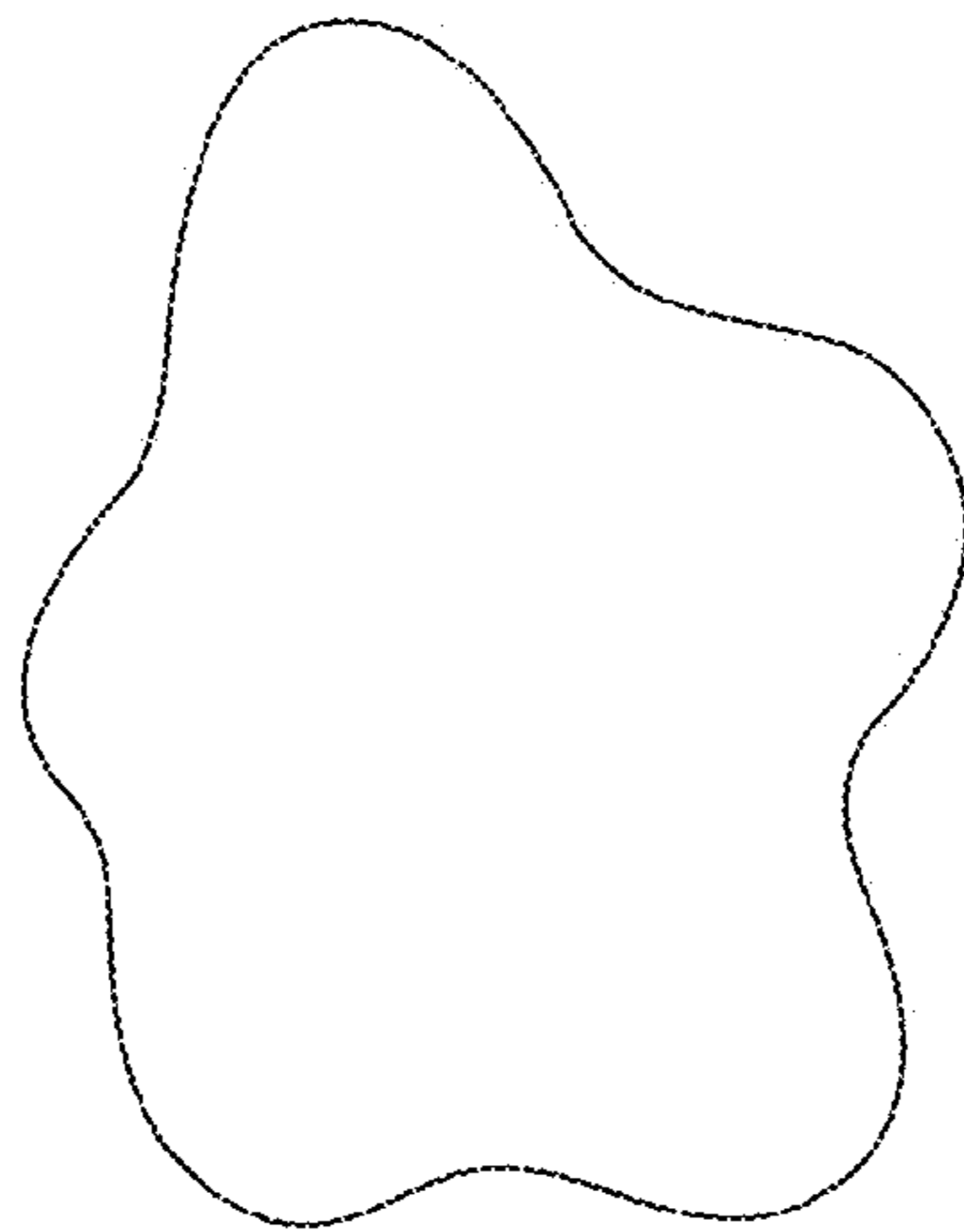

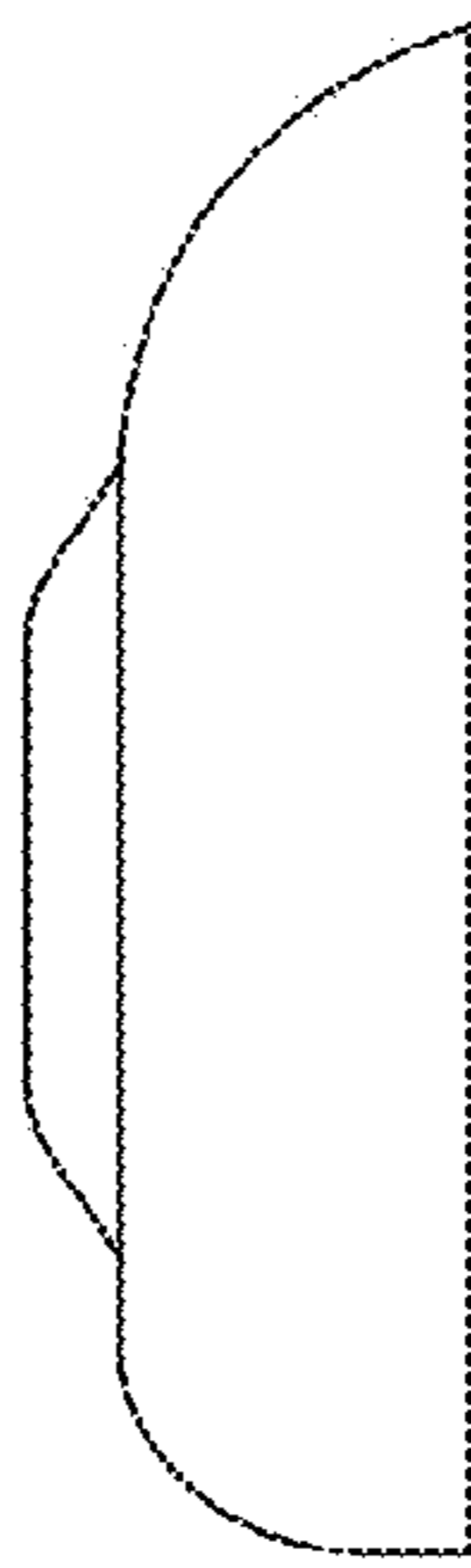

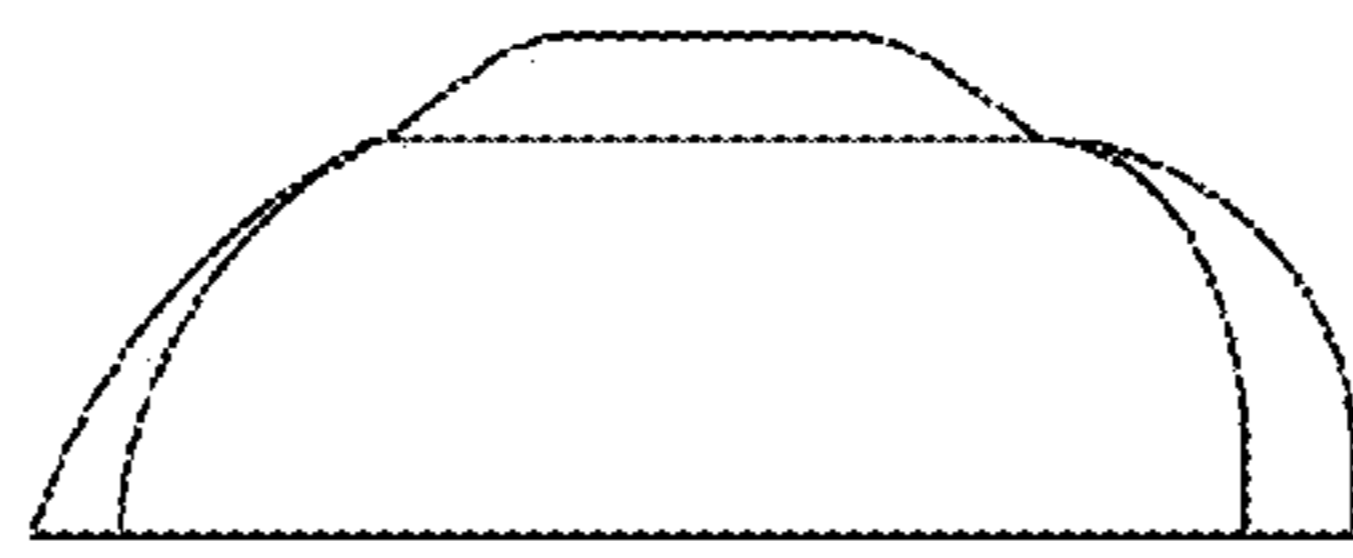

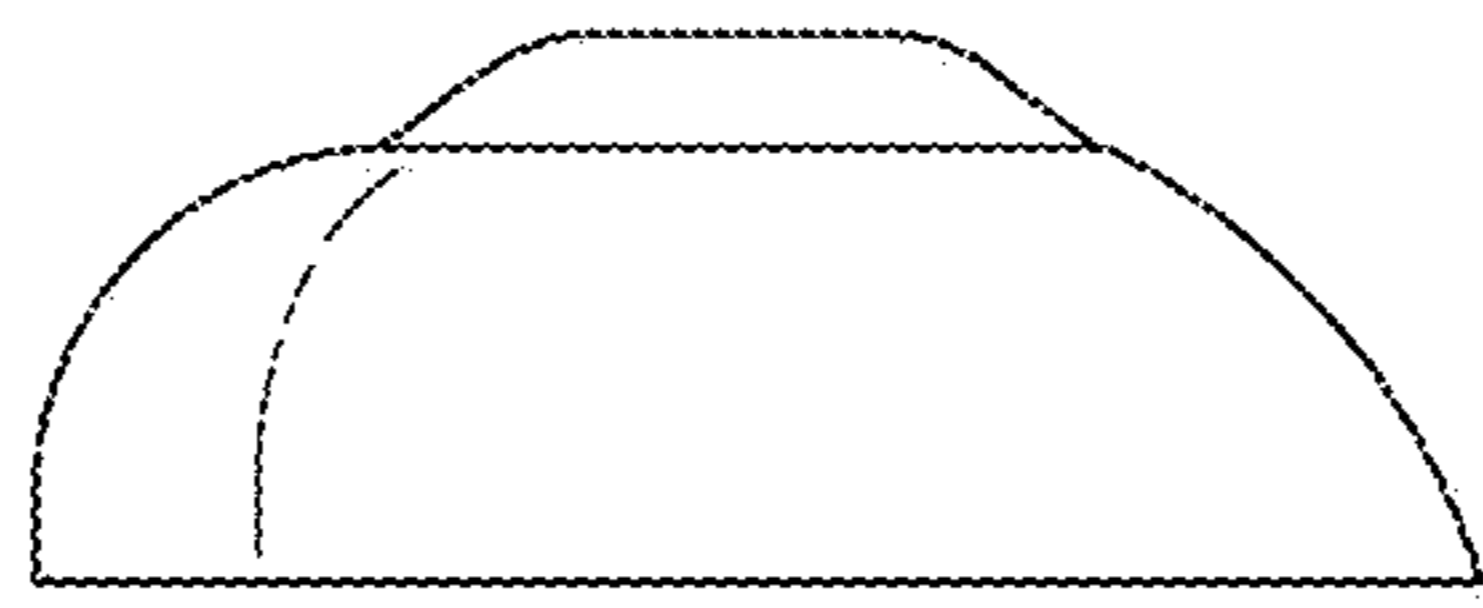

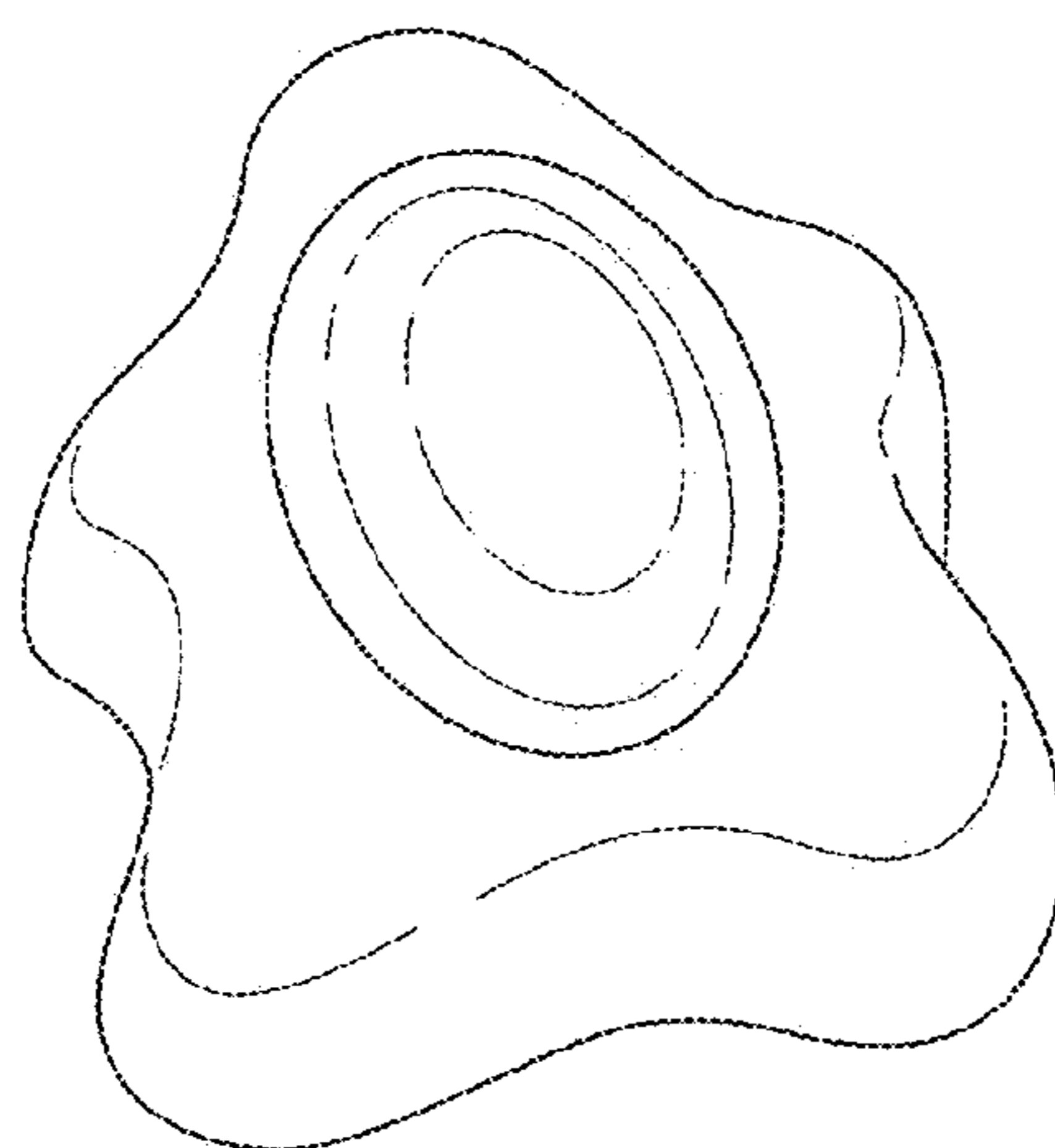

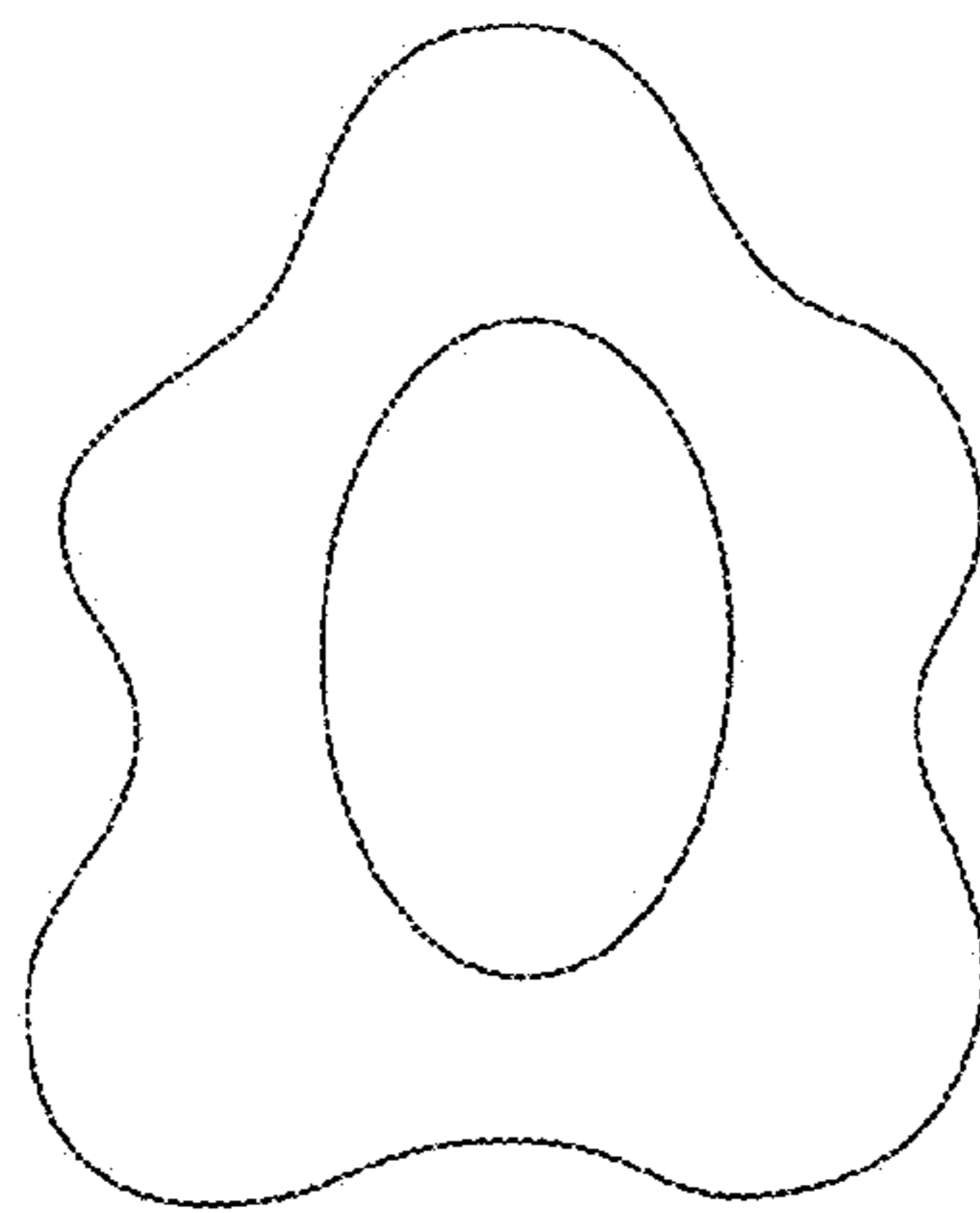

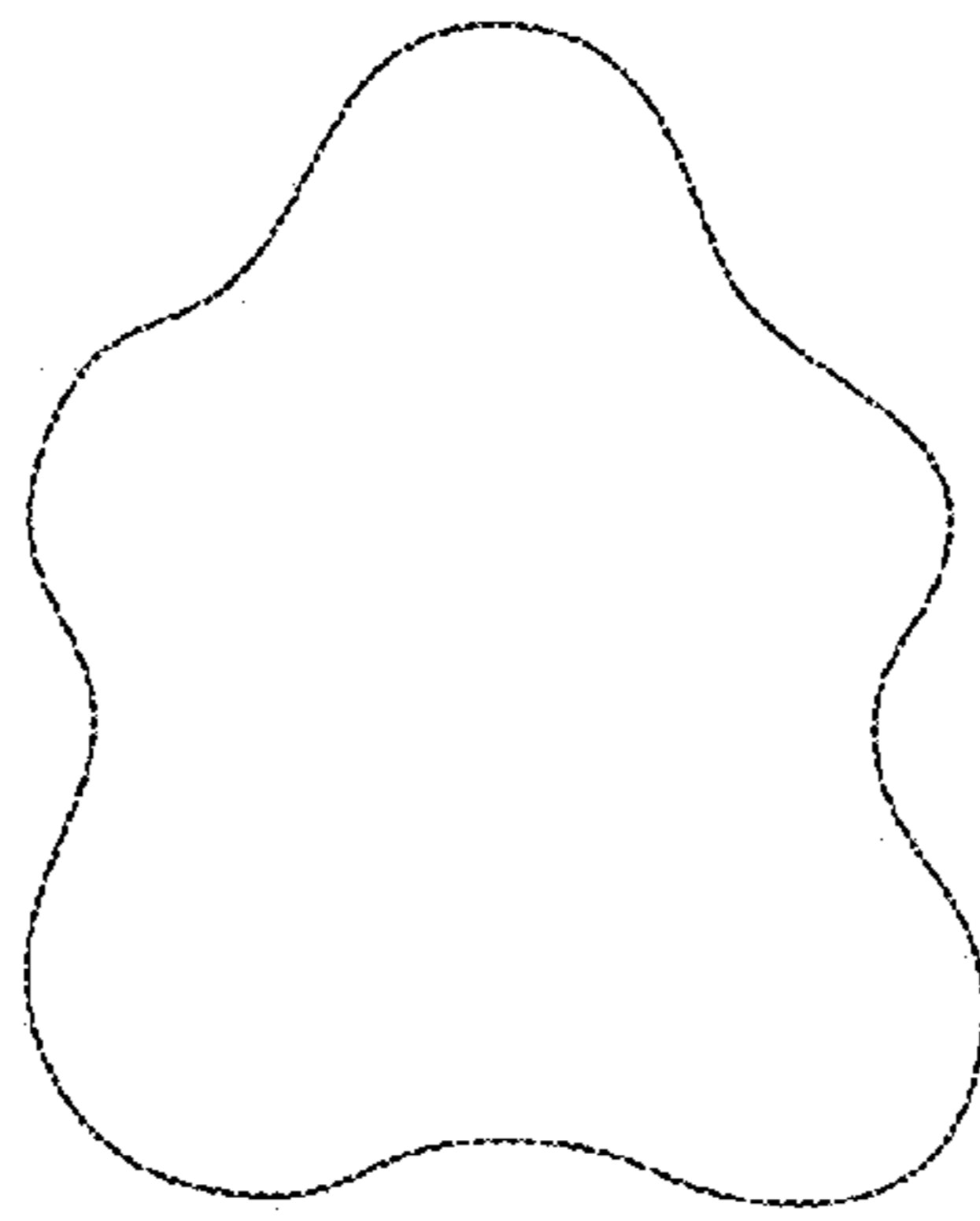

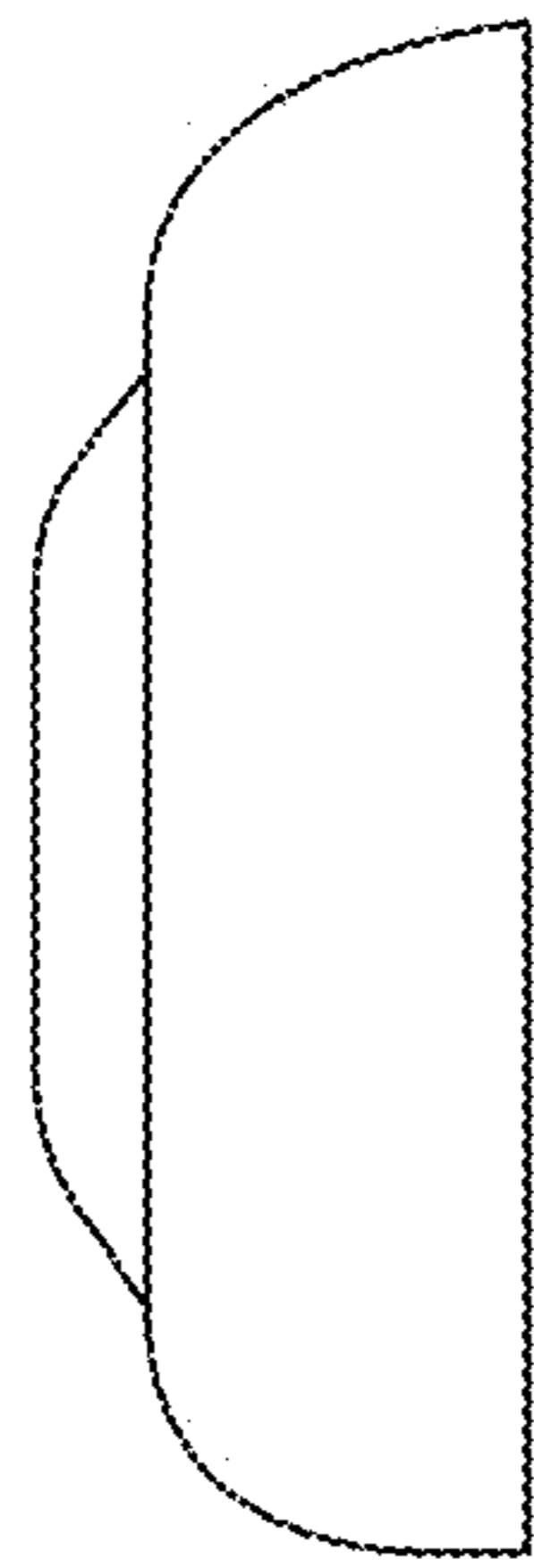

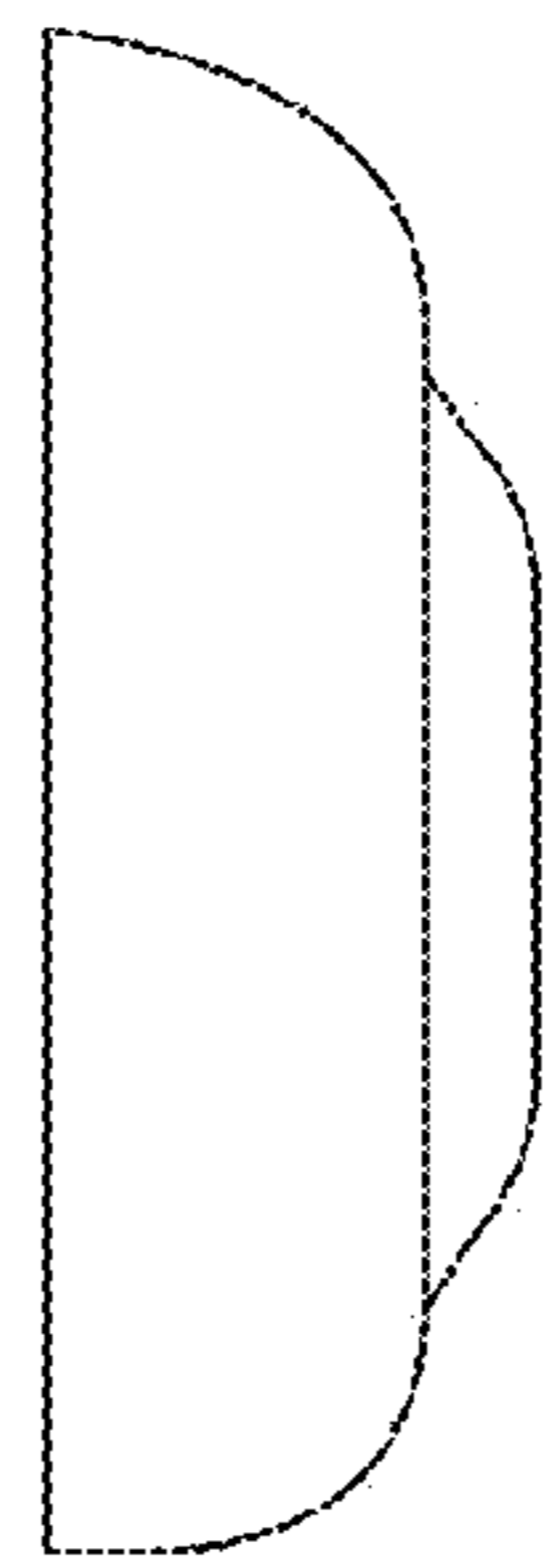

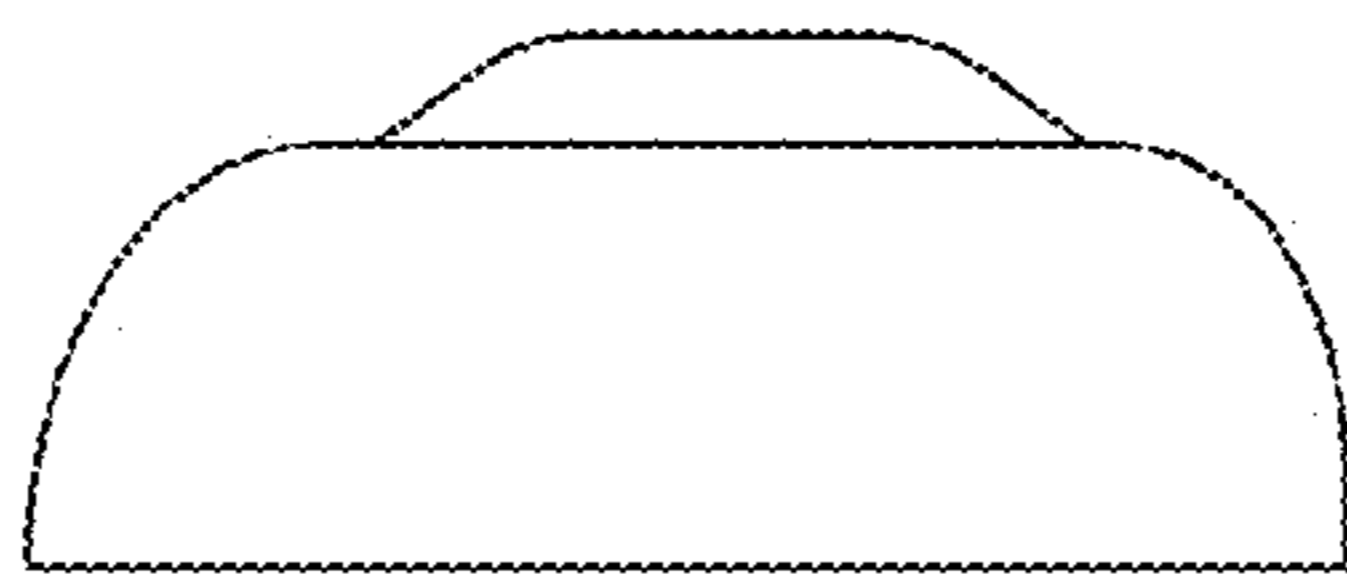

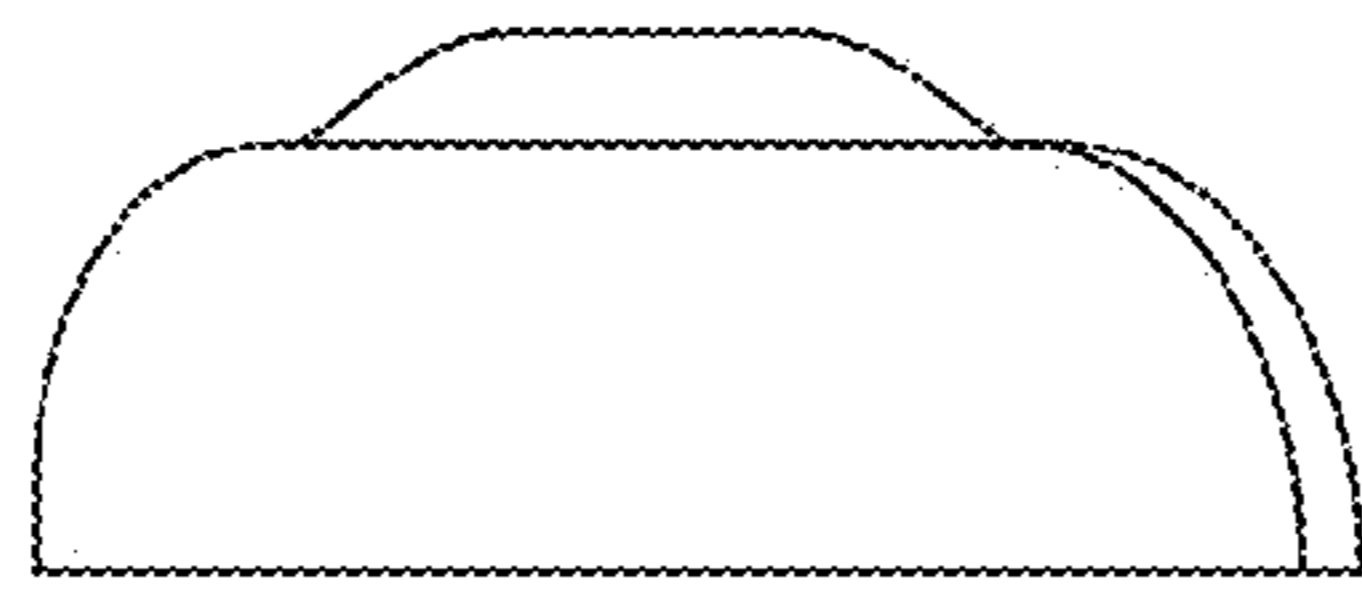

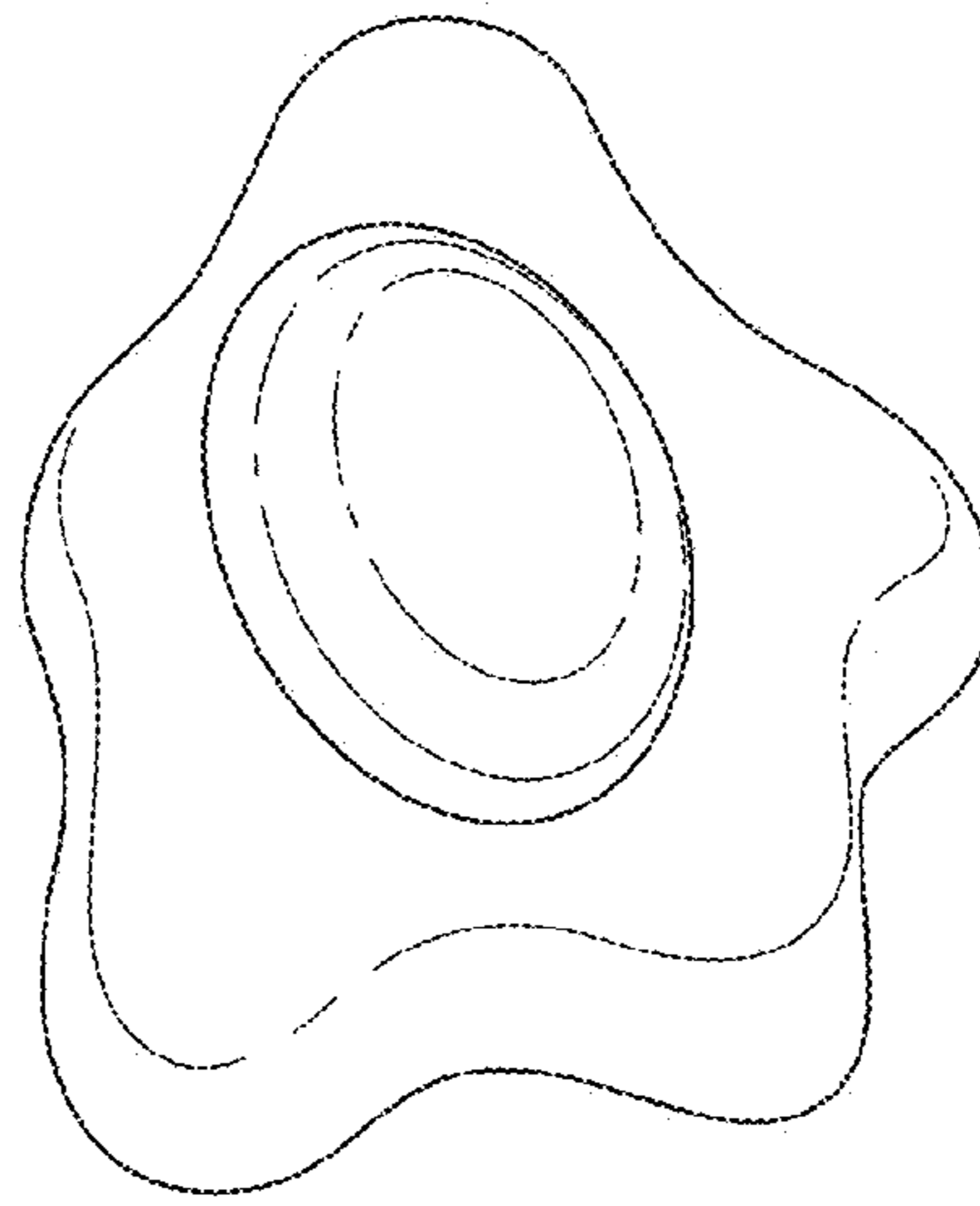

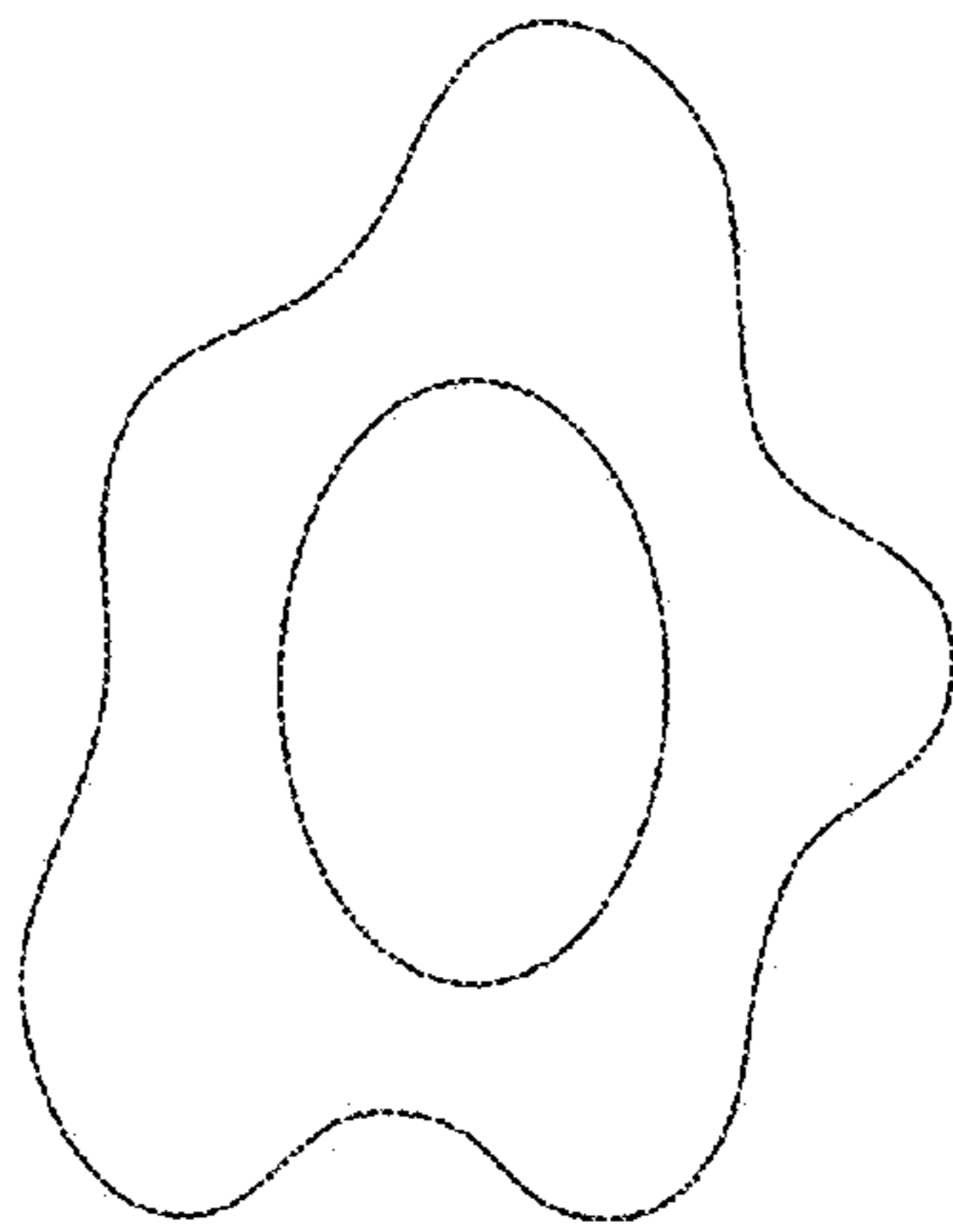

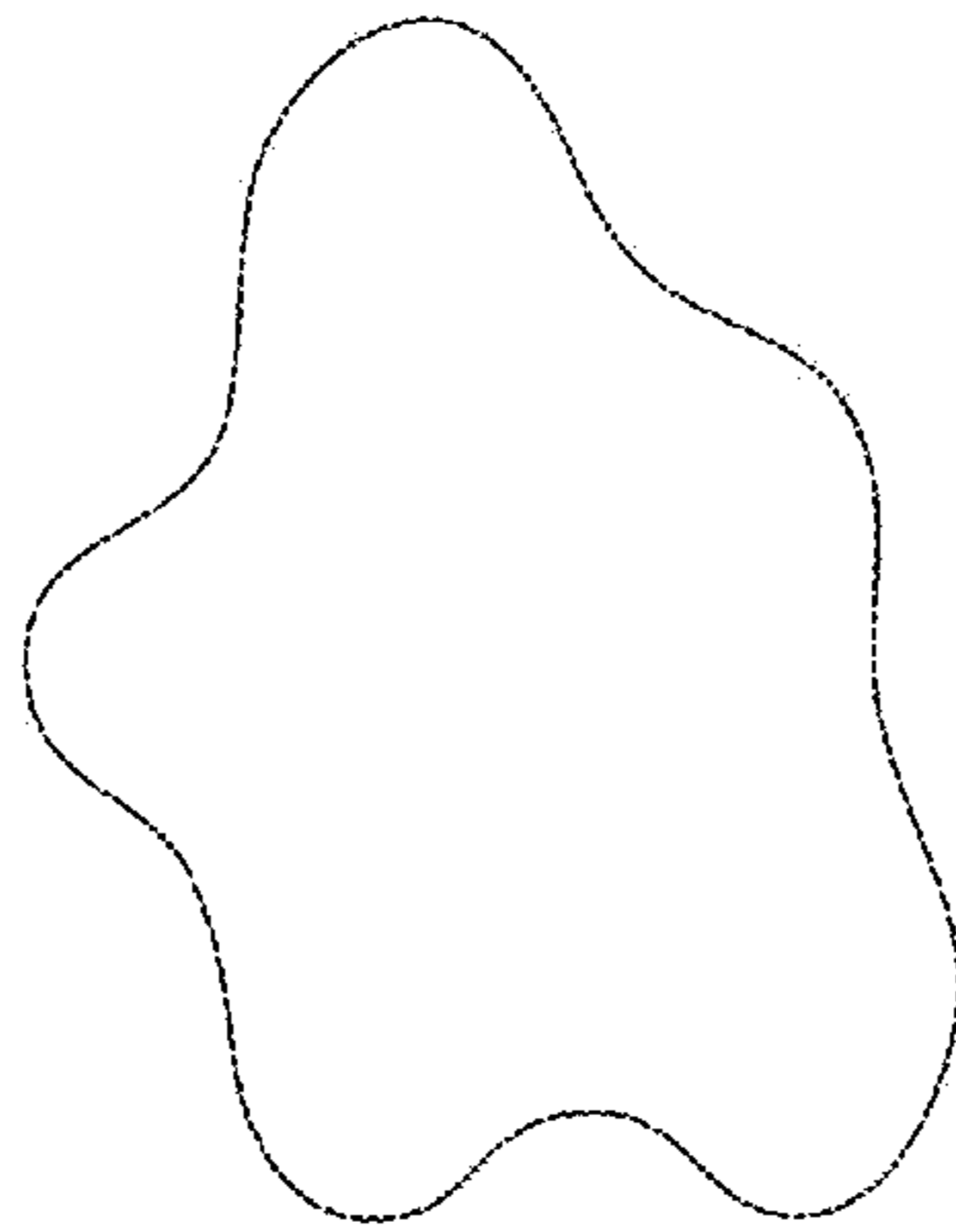

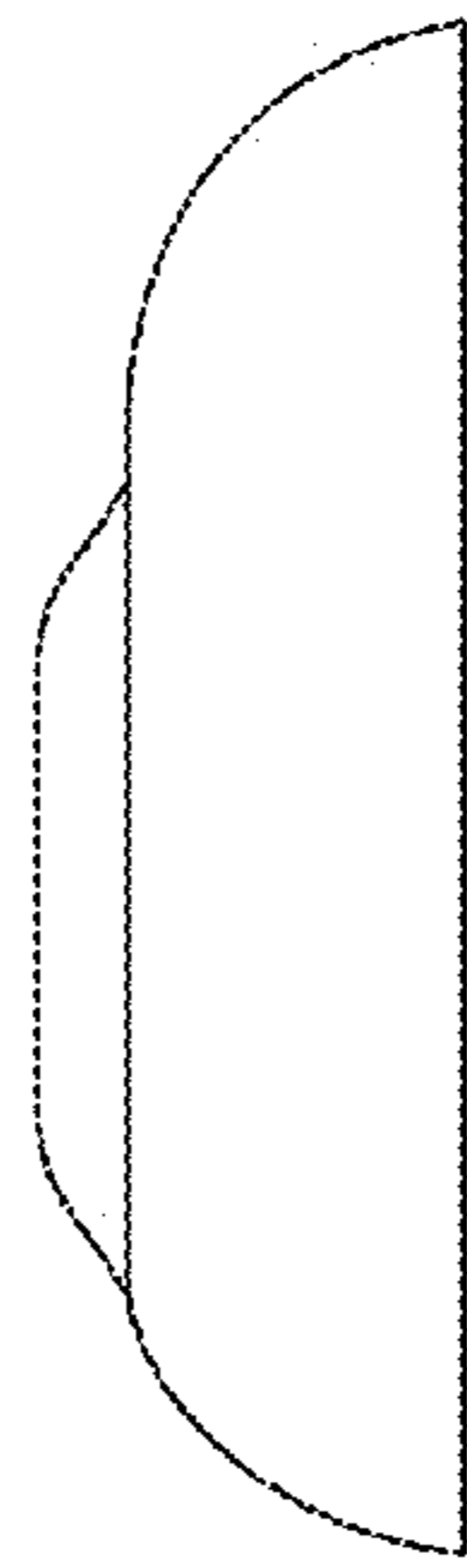

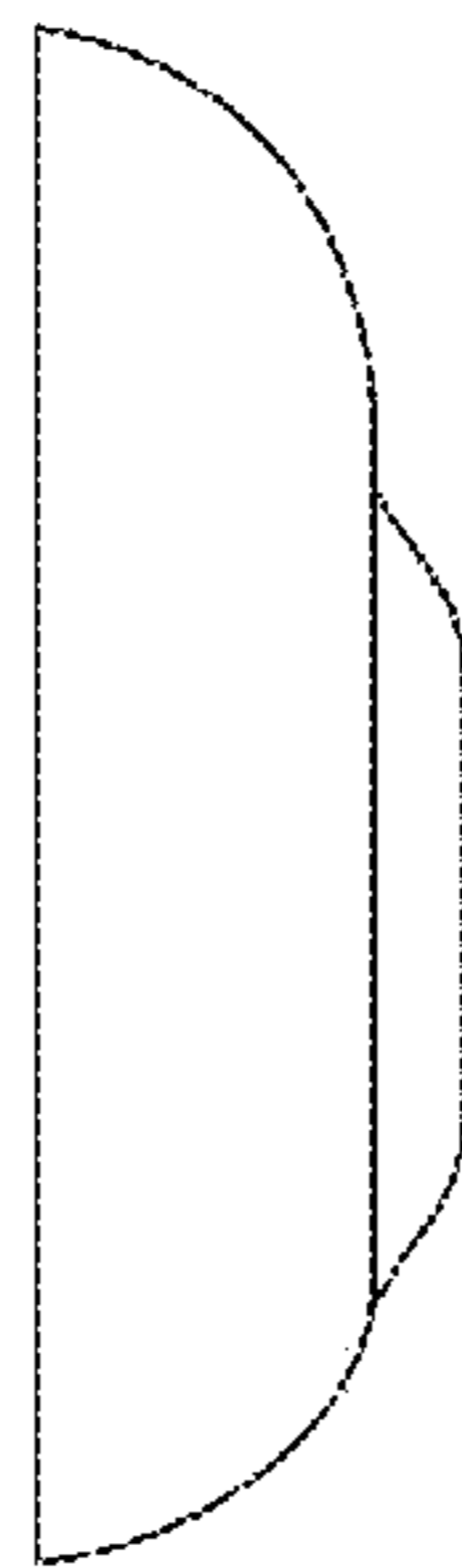

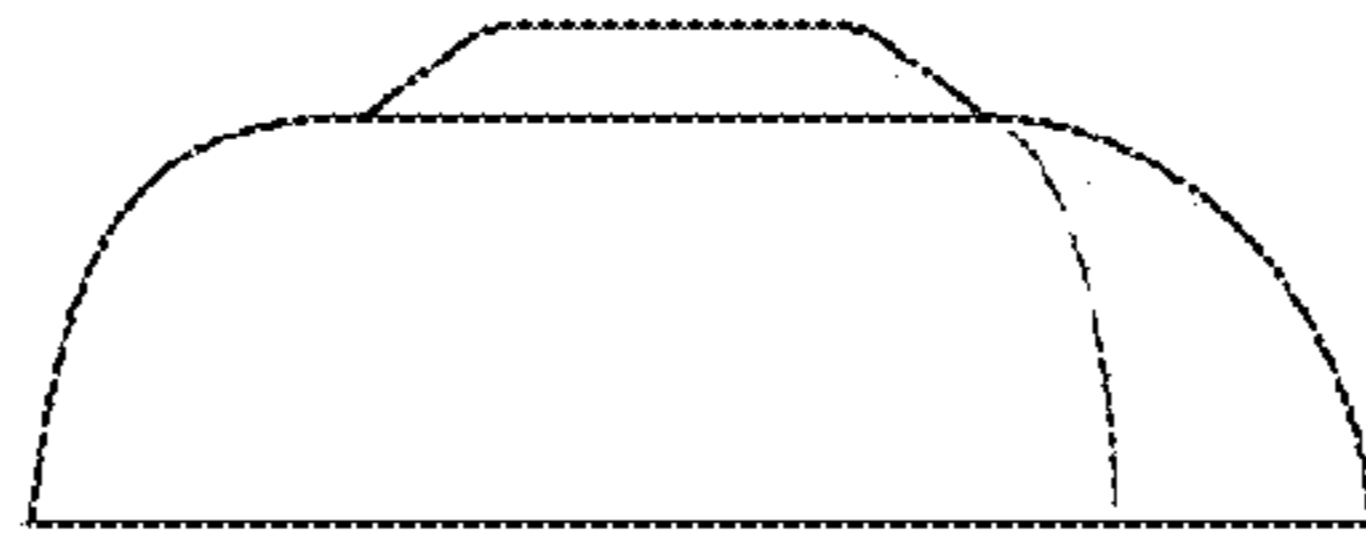

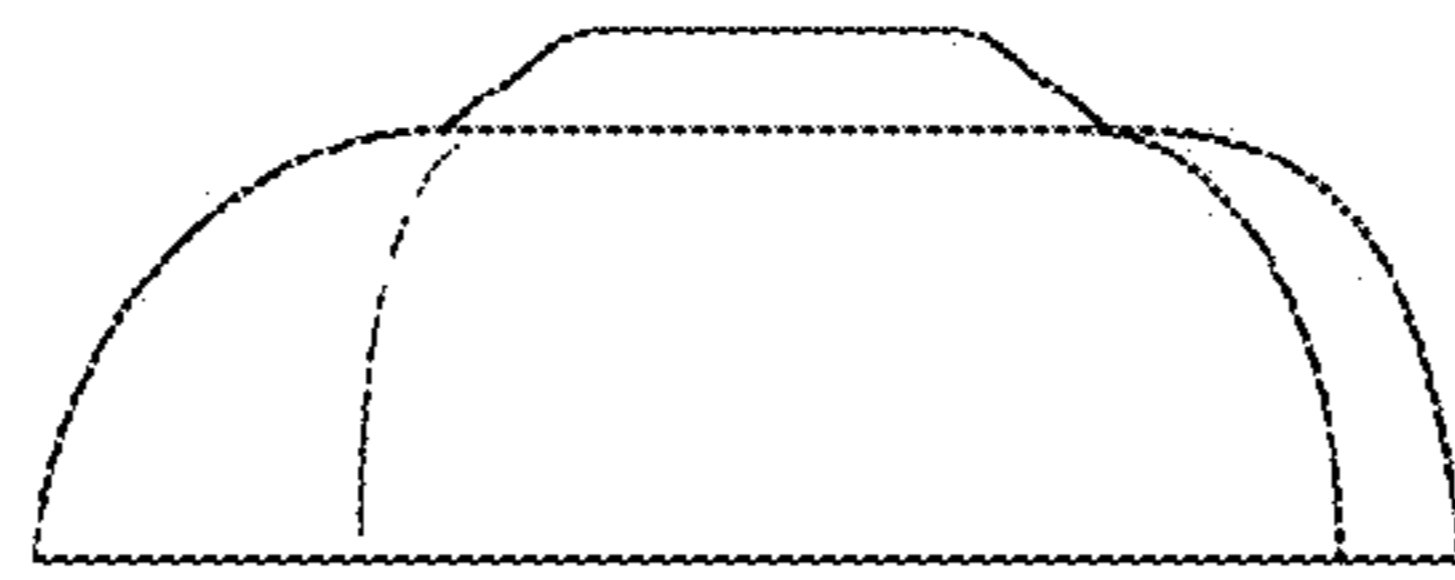
