(57) **CLAIM**

We claim the ornamental design for a garment with gastric tube access, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a garment with gastric tube access, showing our new design; the gastric tube flap shown in a lowered position;

FIG. 2 is a front elevational view of FIG. 1;

FIG. 3 is a rear elevational view of FIG. 1;

FIG. 4 is a right-side elevational view of FIG. 1;

FIG. 5 is a left-side elevational view of FIG. 1;

FIG. 6 is a top plan view of FIG. 1;

FIG. 7 is a bottom plan view of FIG. 1;

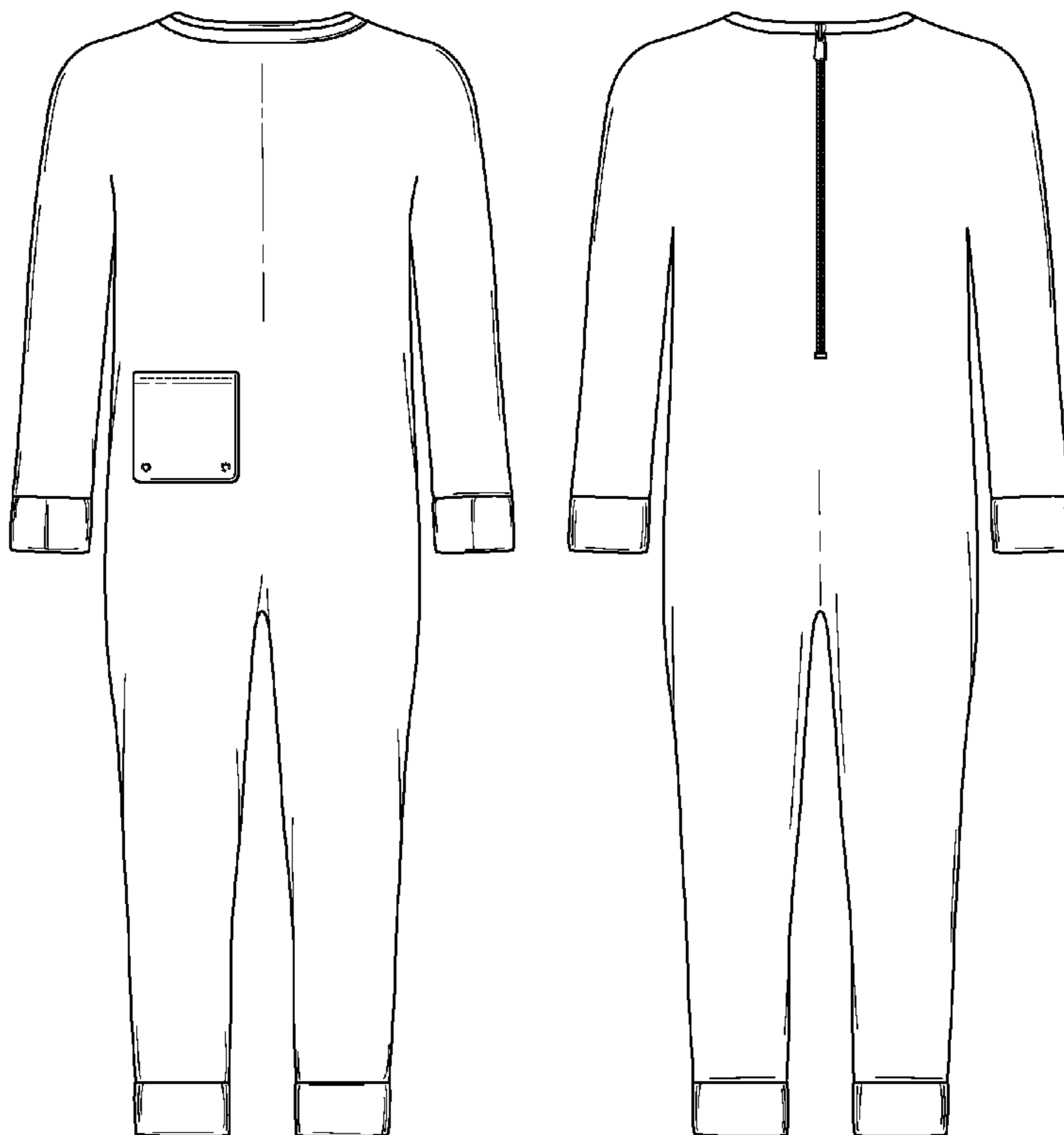
FIG. 8 is a front perspective view of FIG. 1, illustrated with the gastric tube flap in a raised position;

FIG. 9 is a front elevational view of FIG. 8; and,

FIG. 10 is a left-side elevational view of FIG. 8.

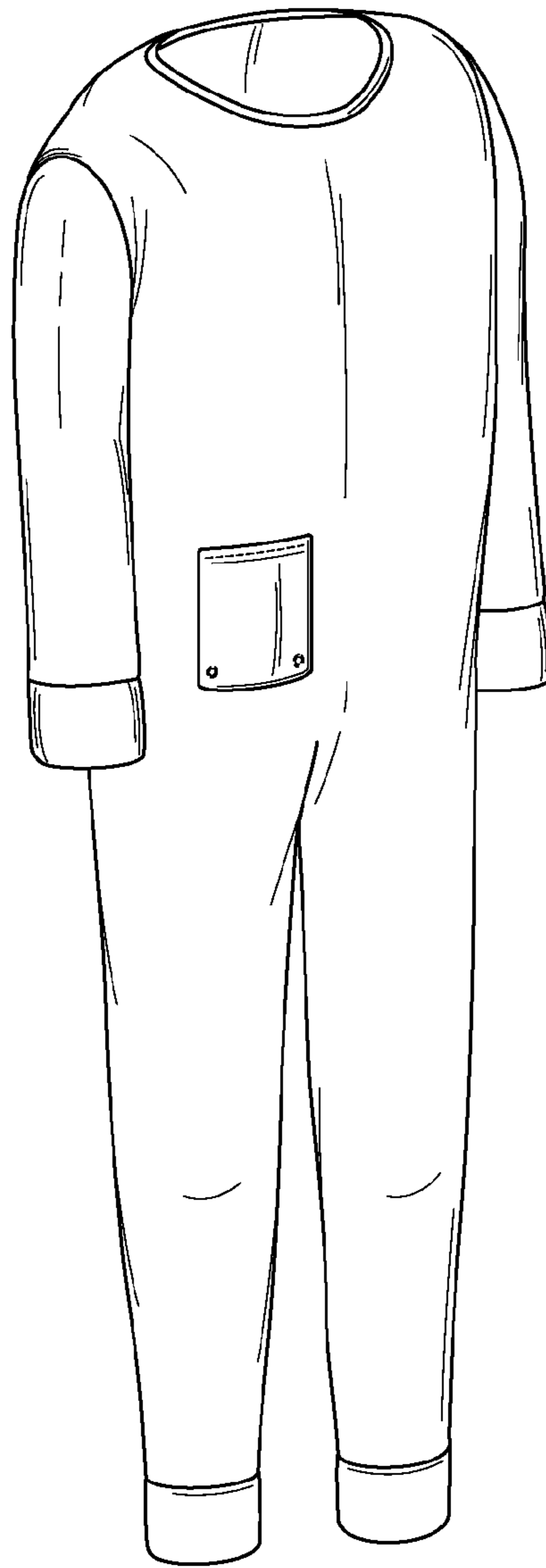

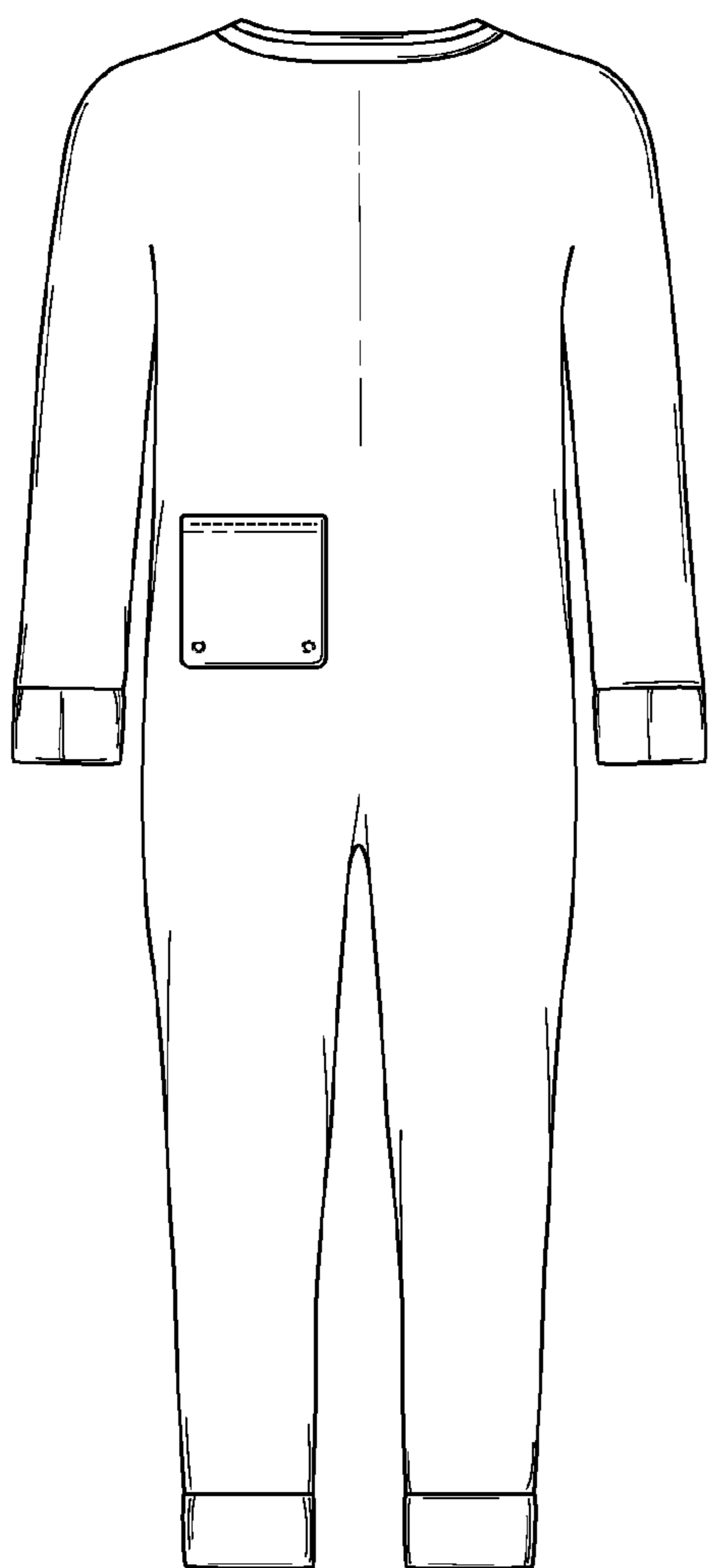

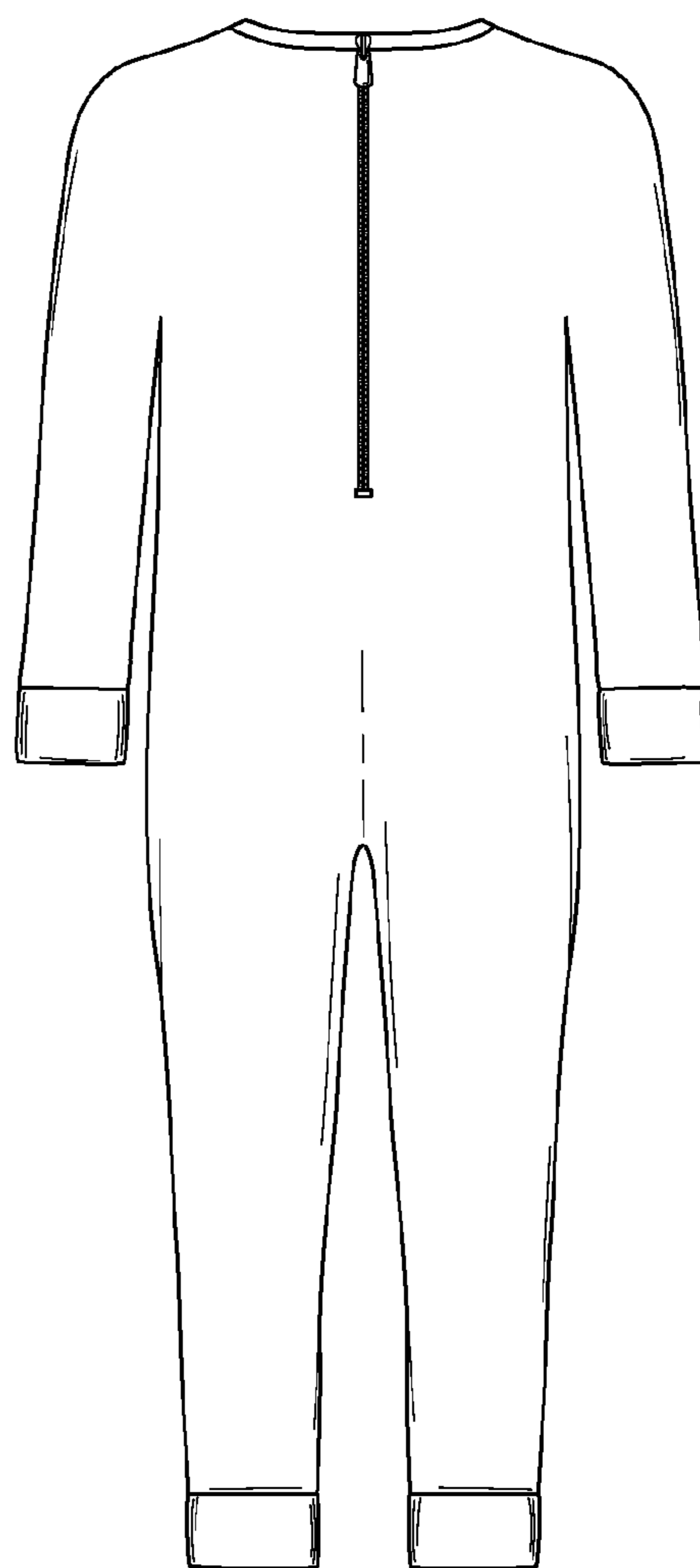

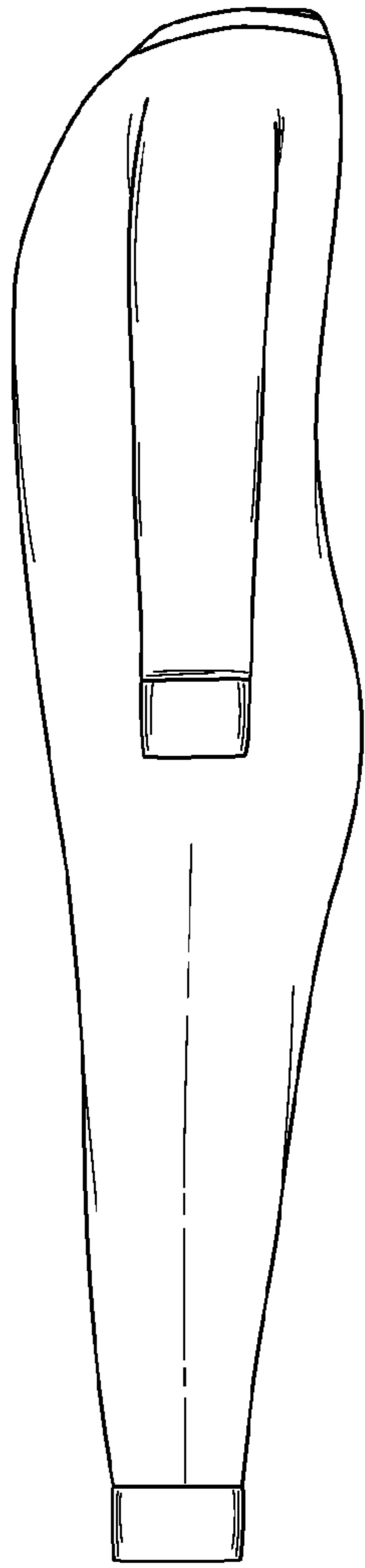

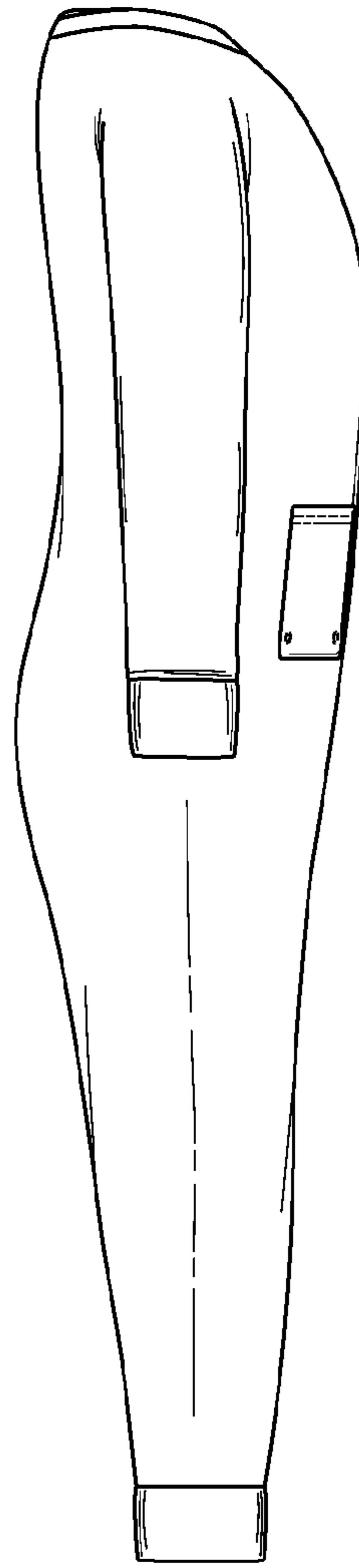

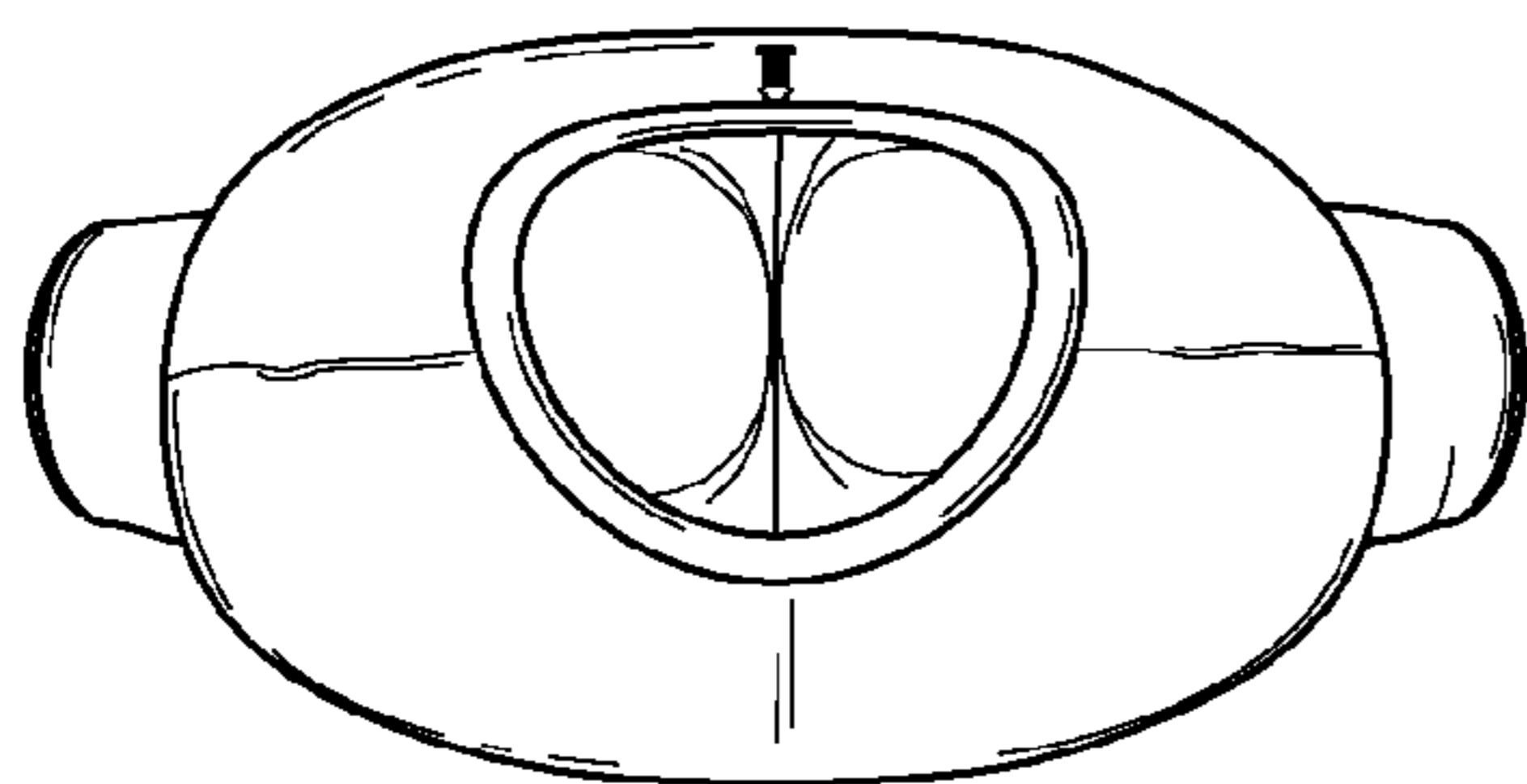

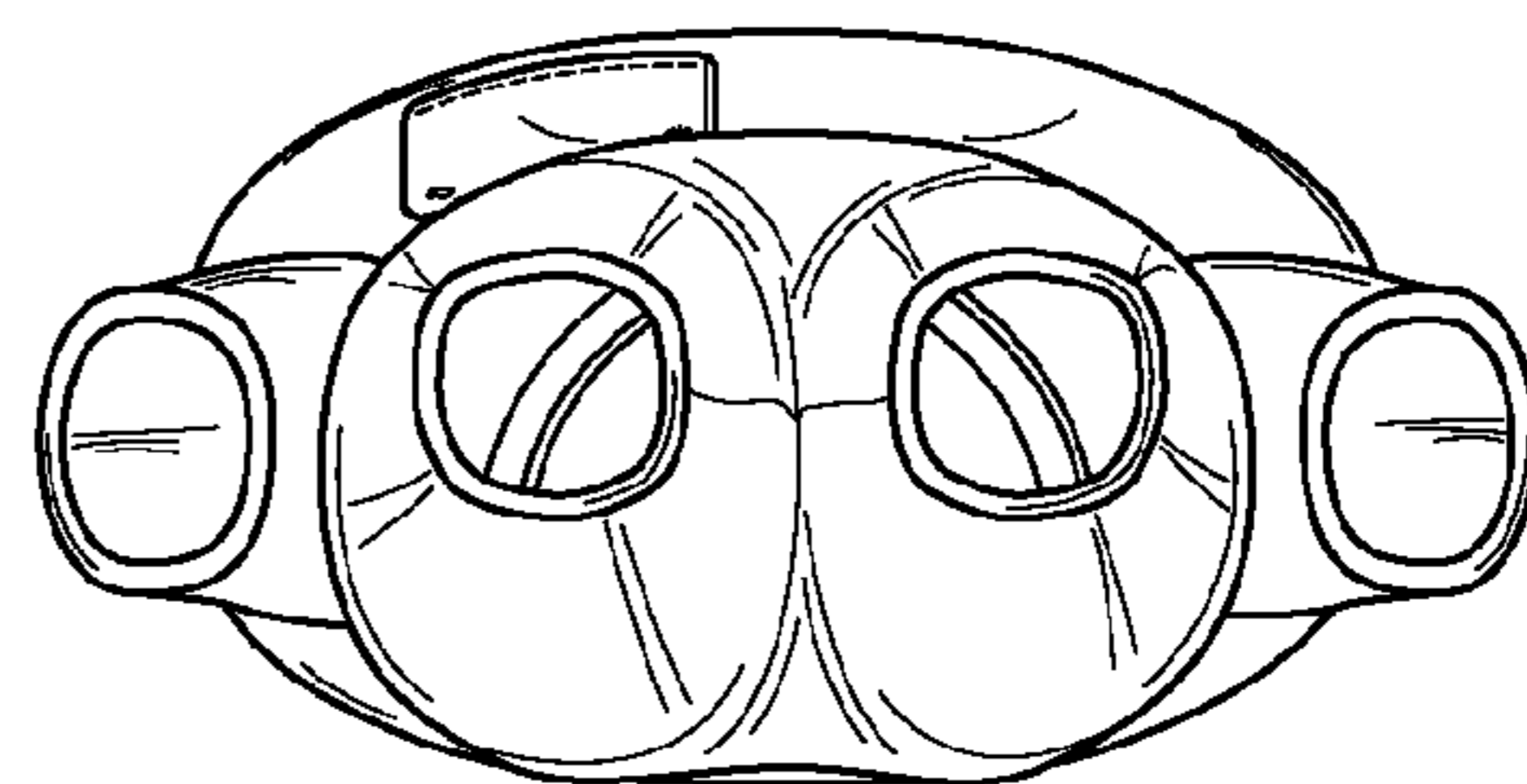

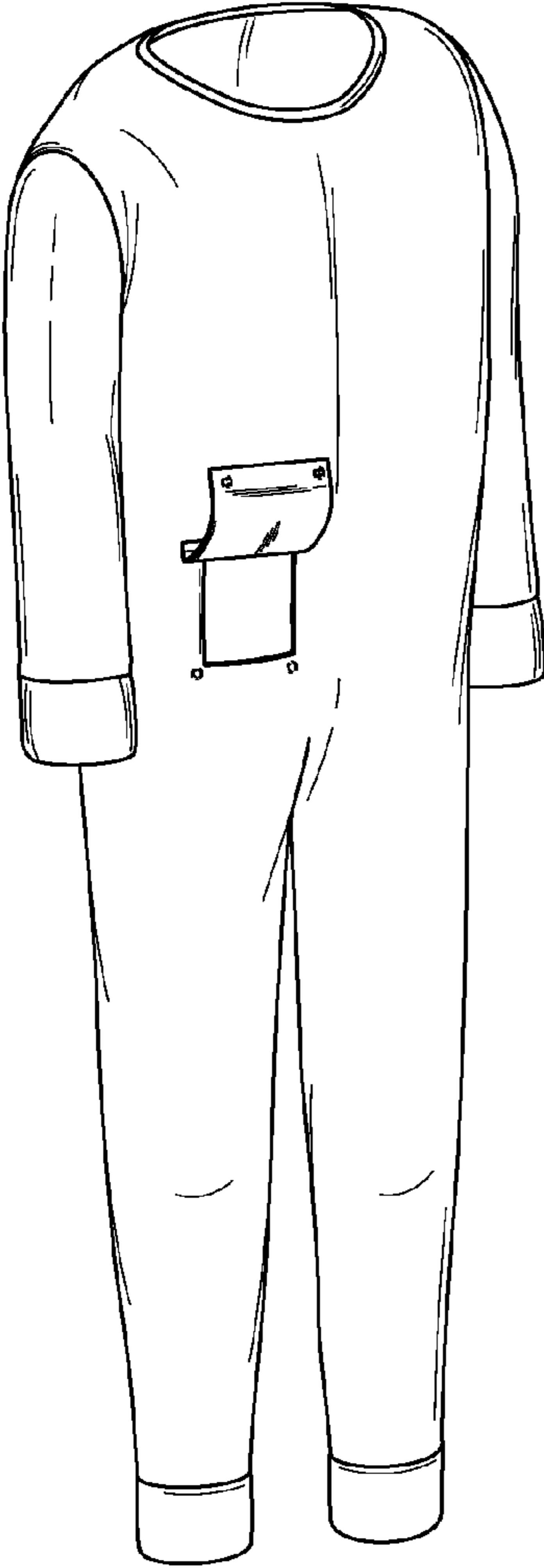

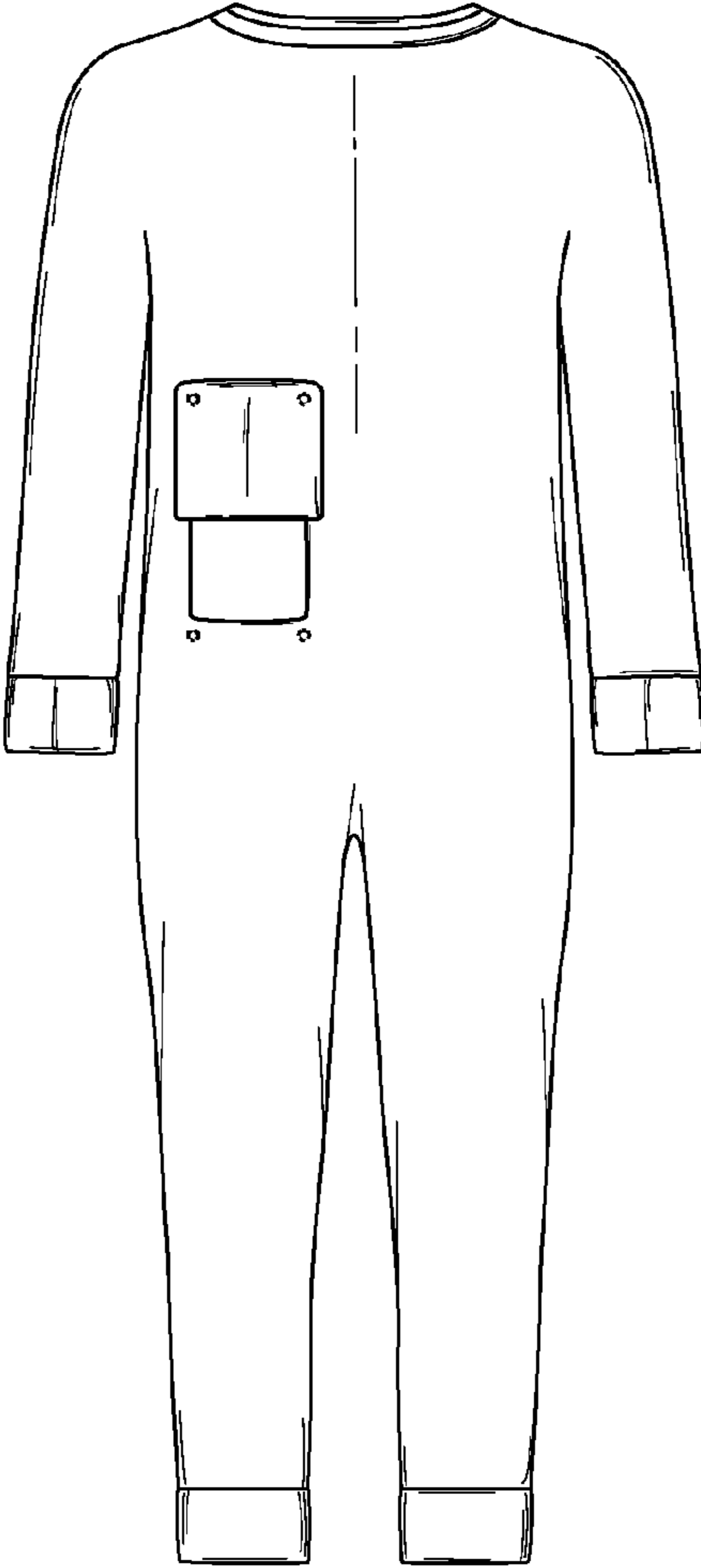

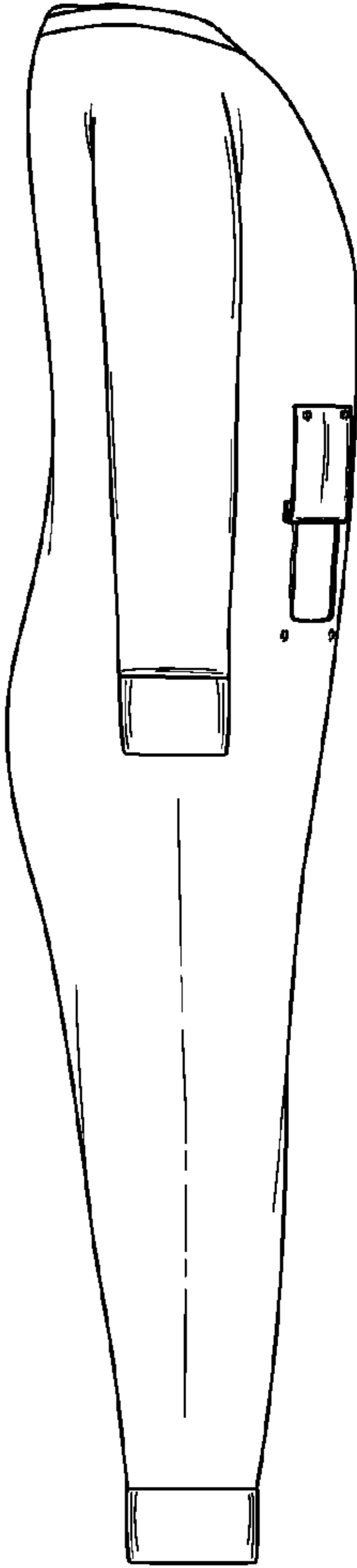
