**DESCRIPTION**

FIG. 1 is a left perspective front view of a garment showing my new design in an in-use configuration;

FIG. 3 is a front view thereof;

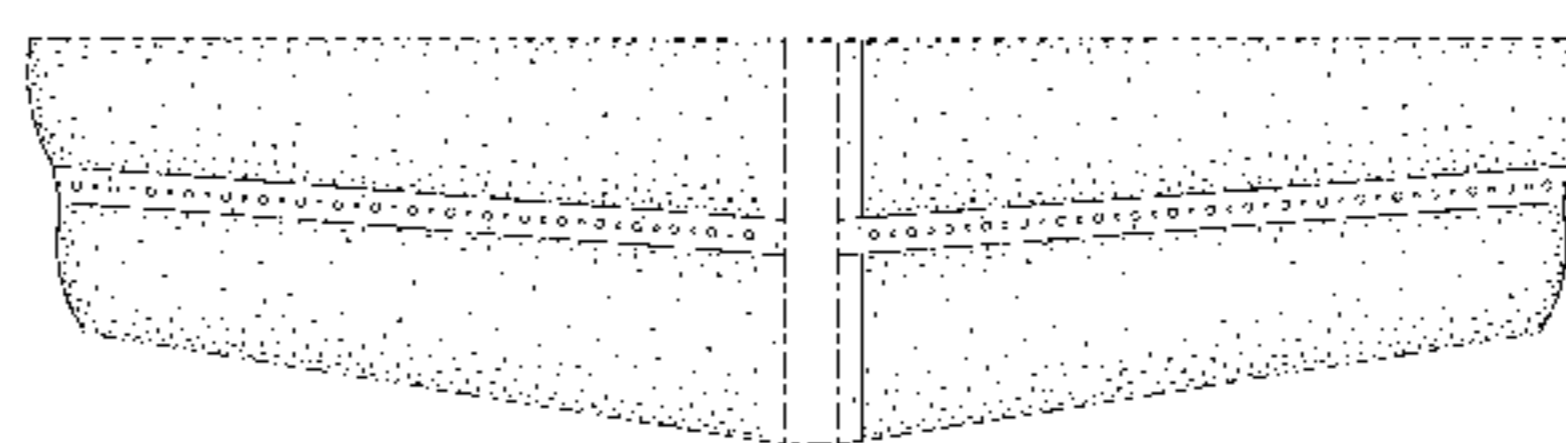
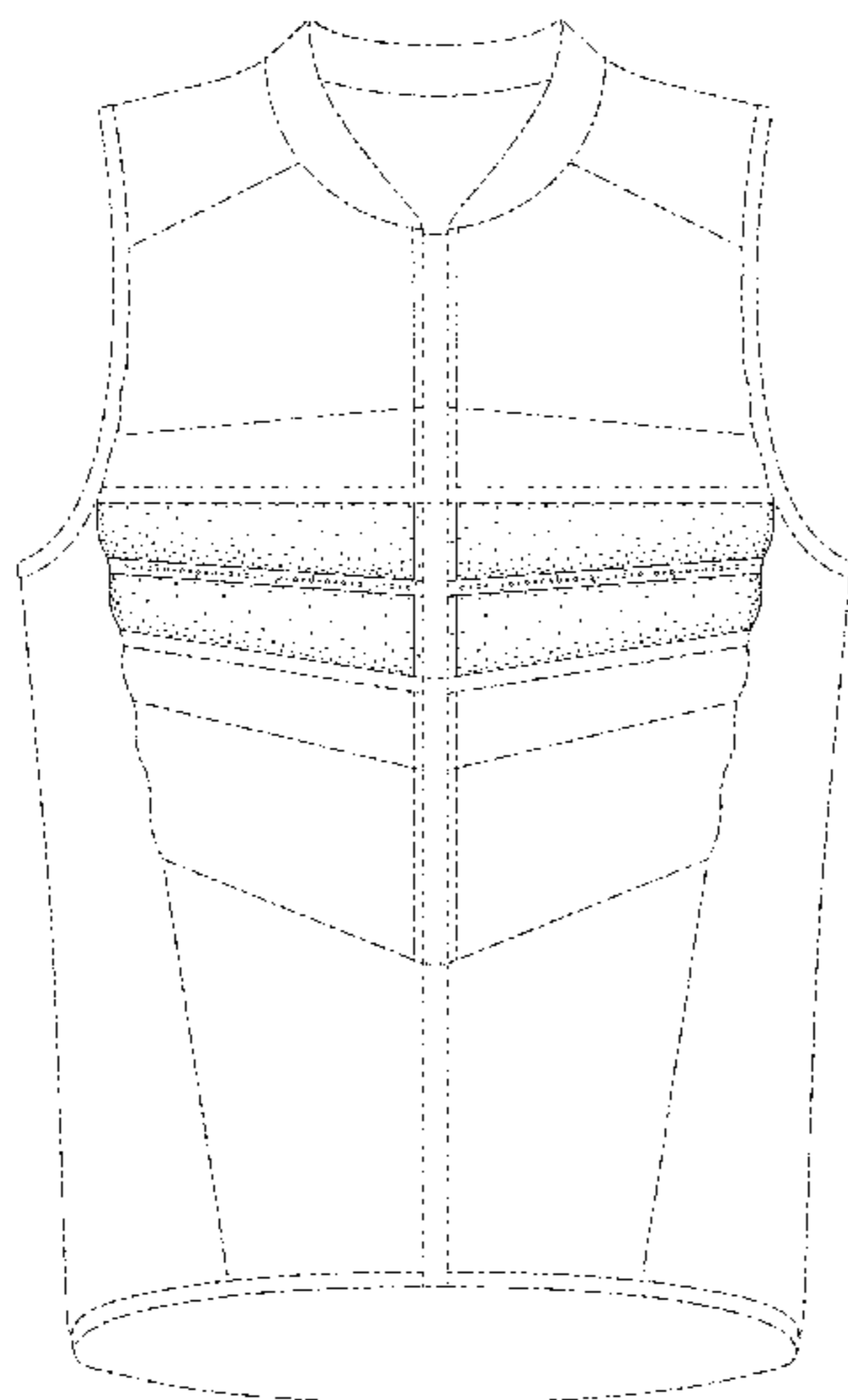
FIG. 4 is a left side view thereof;

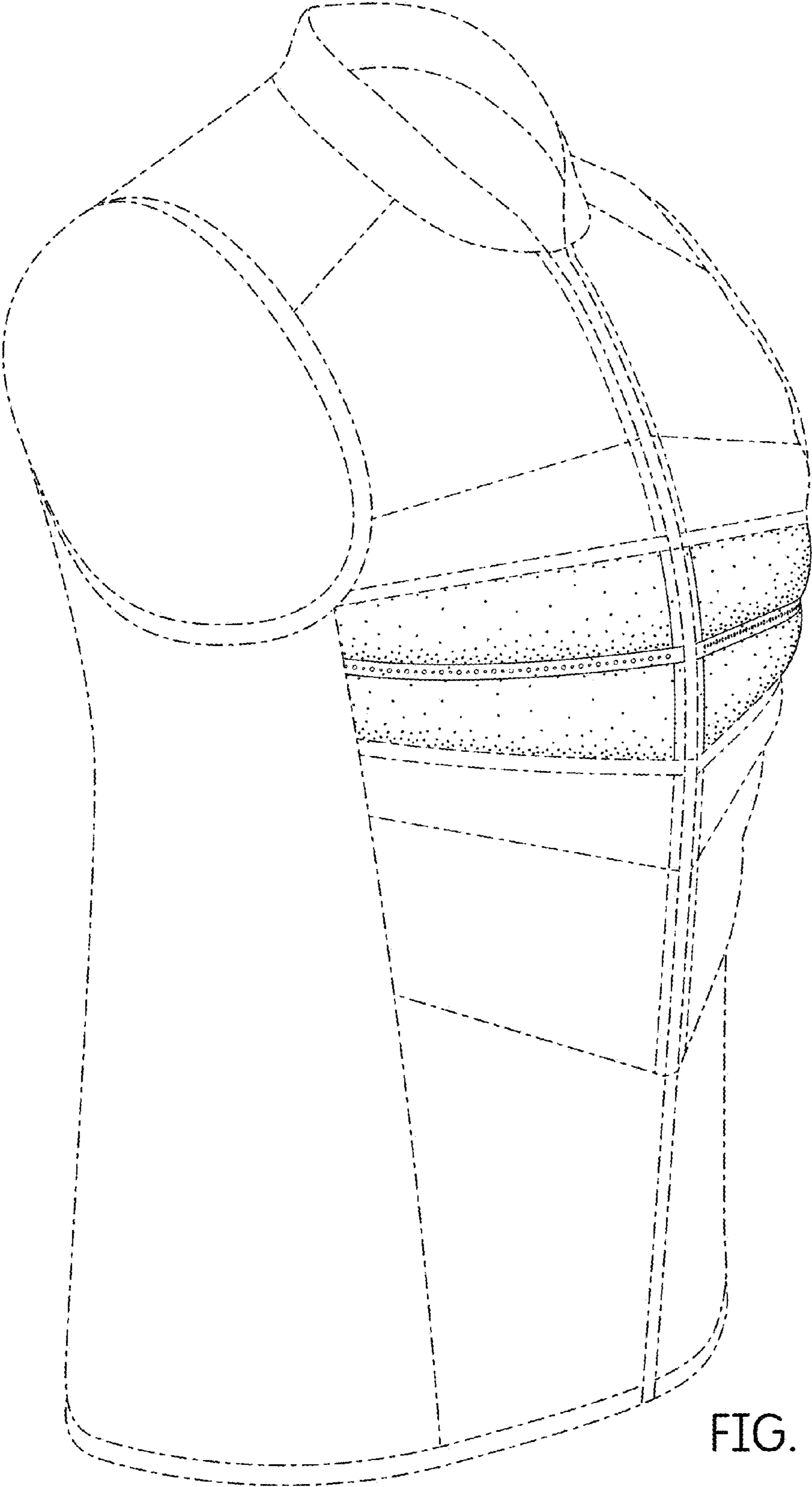

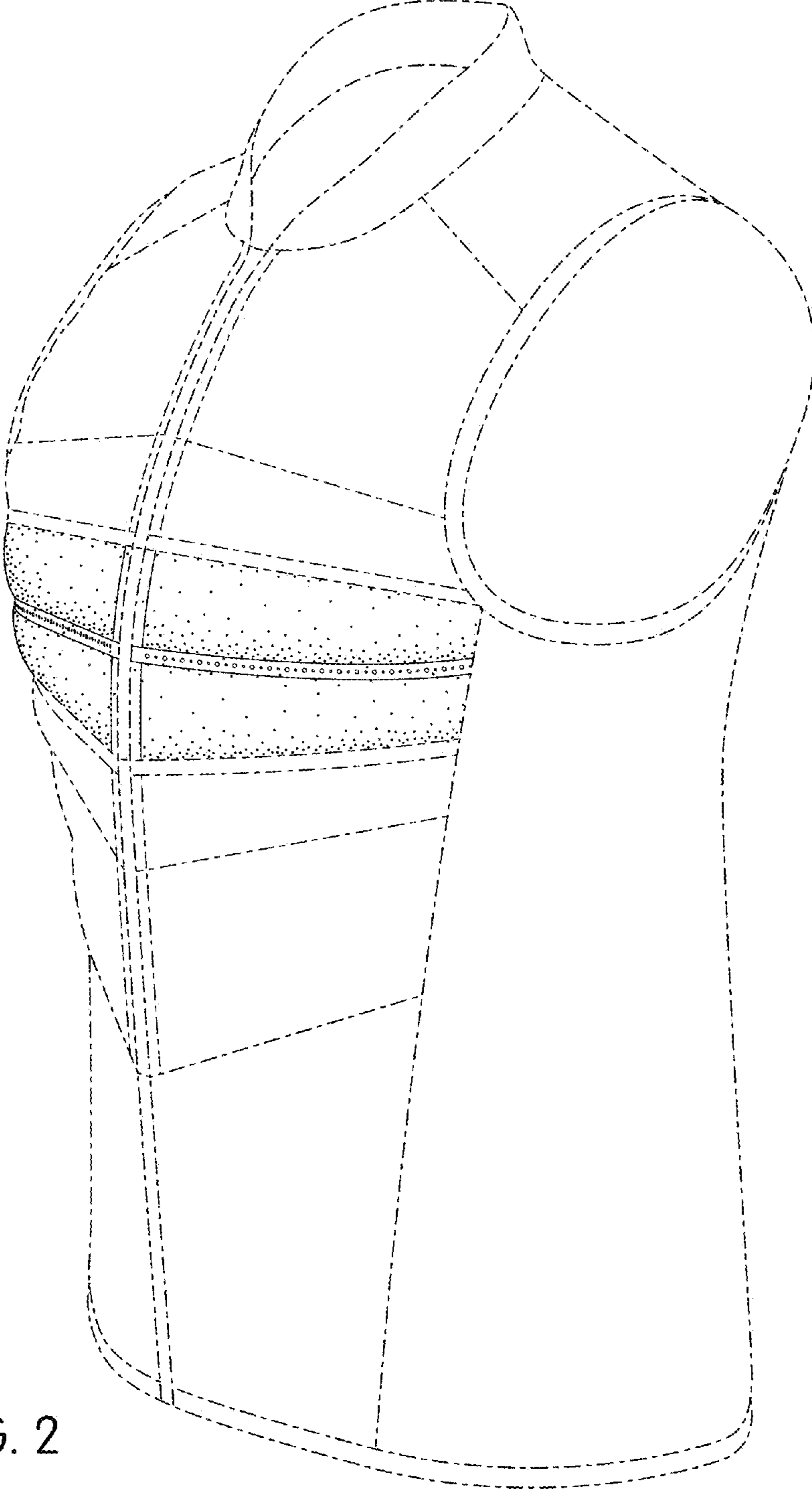

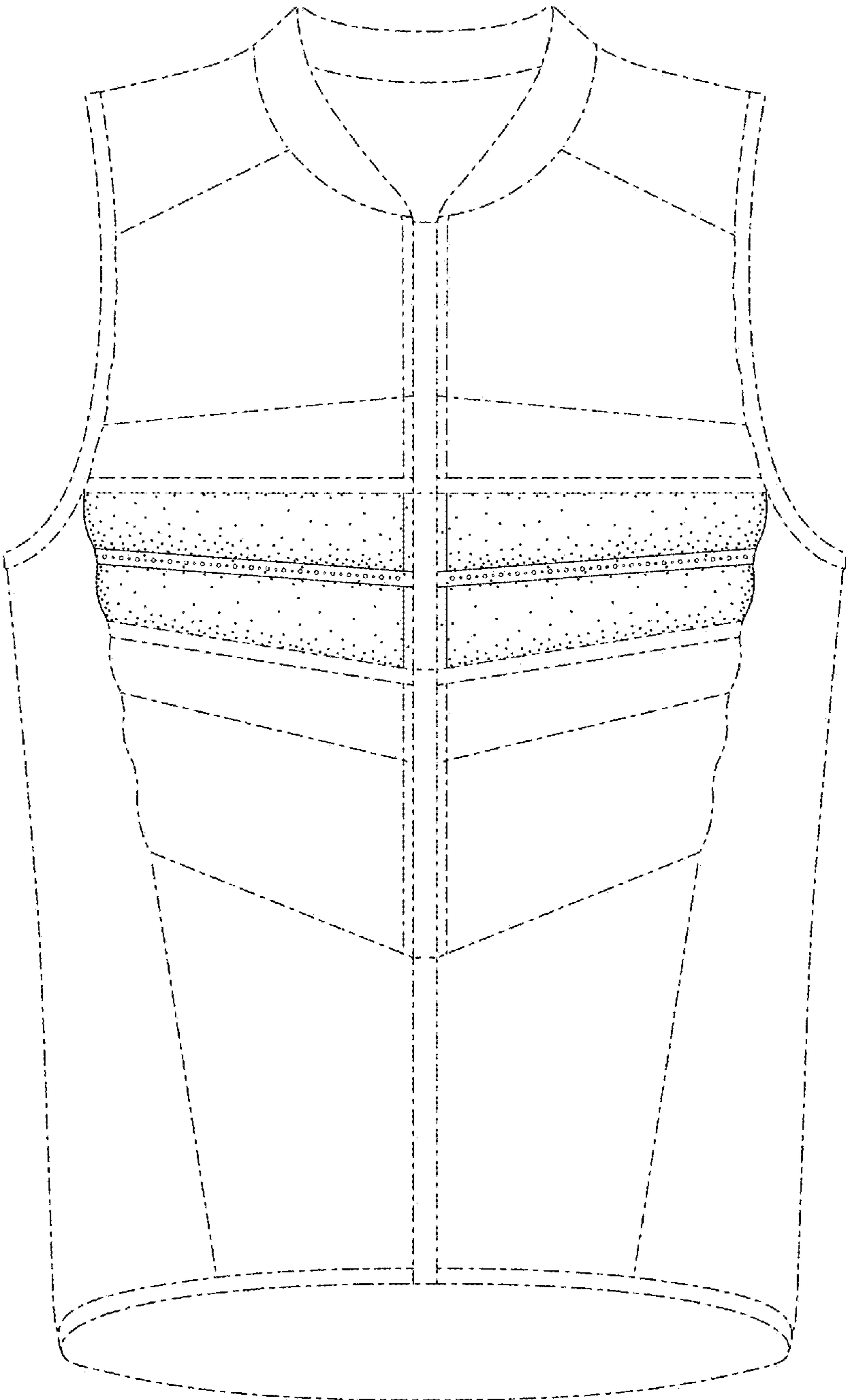

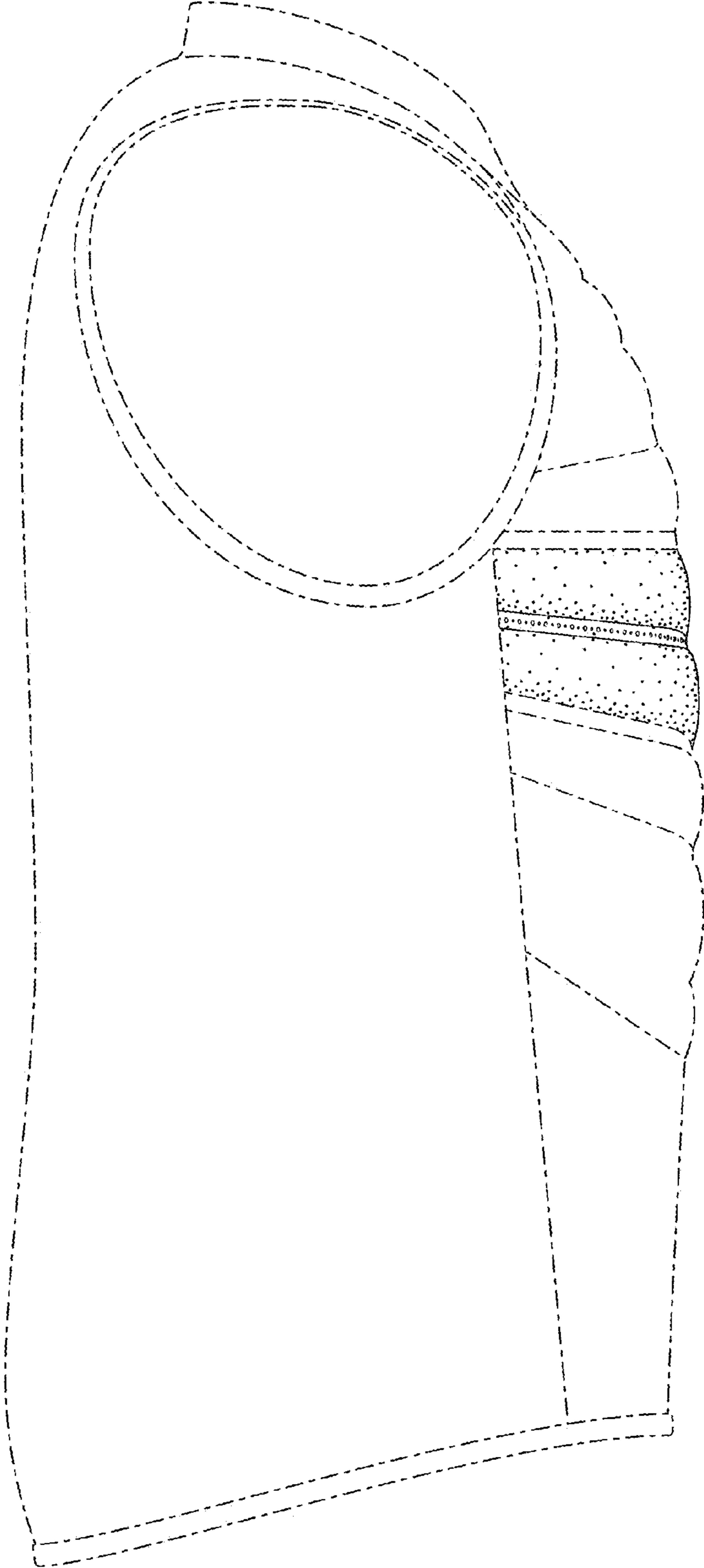

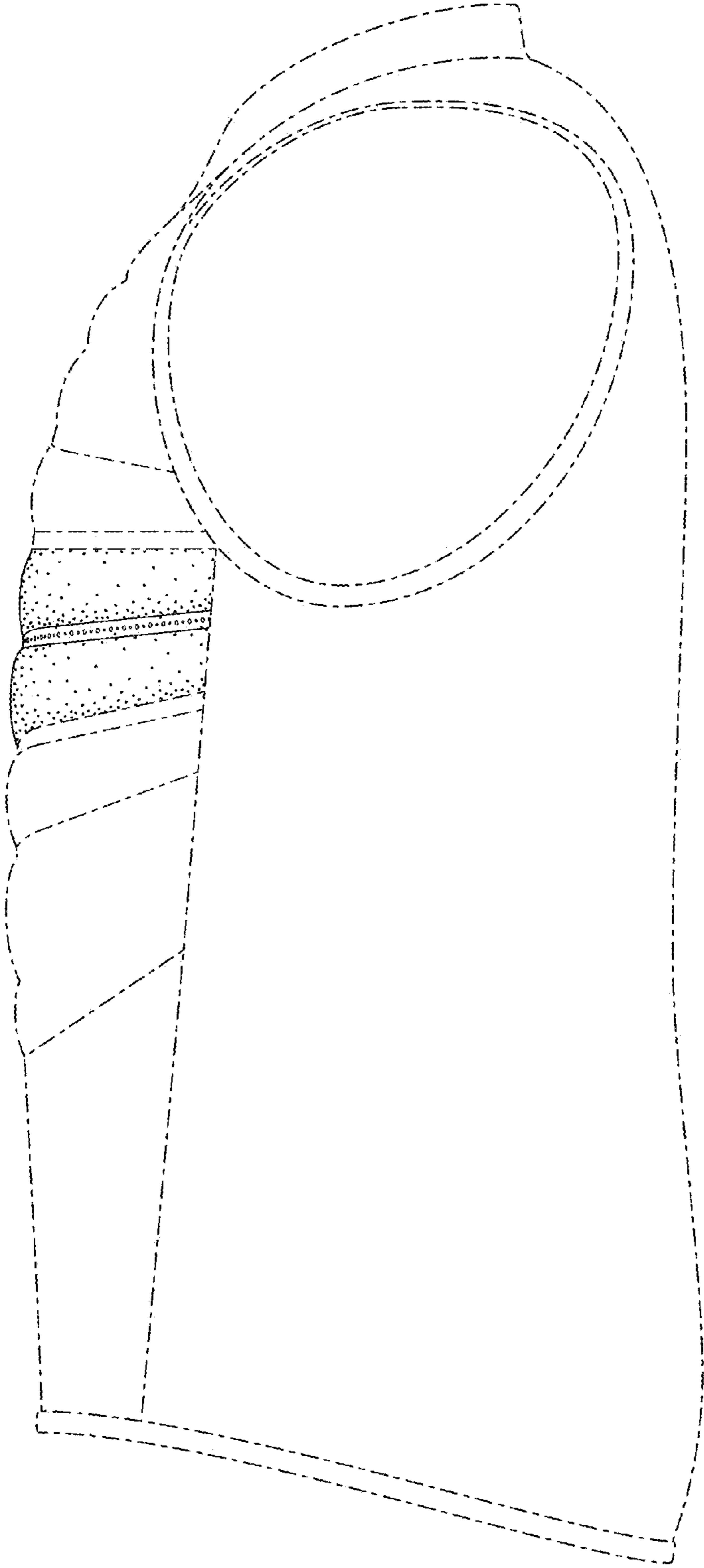

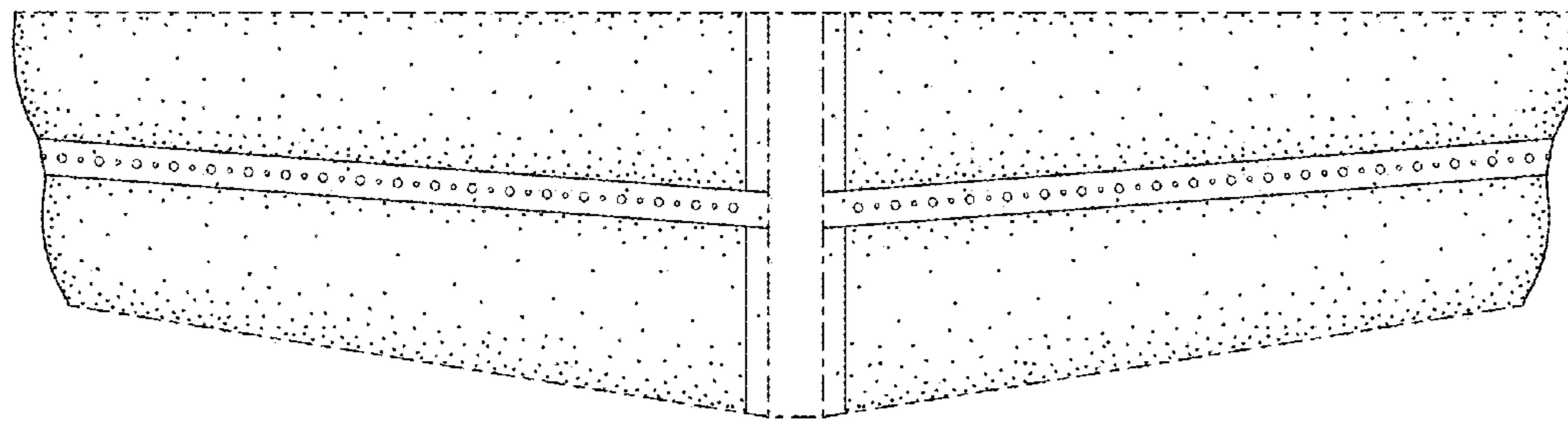
