DESCRIPTION

FIG. 1 is a front perspective view of a shoe upper showing my new design;

FIG. 7 is a top view thereof;

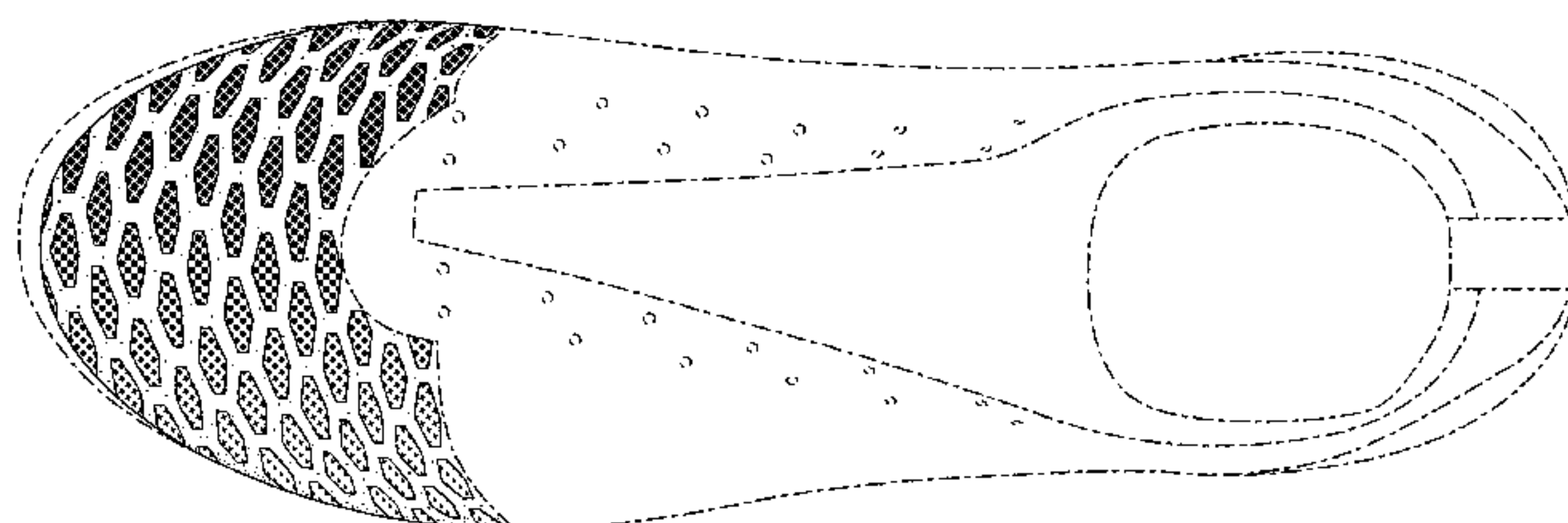
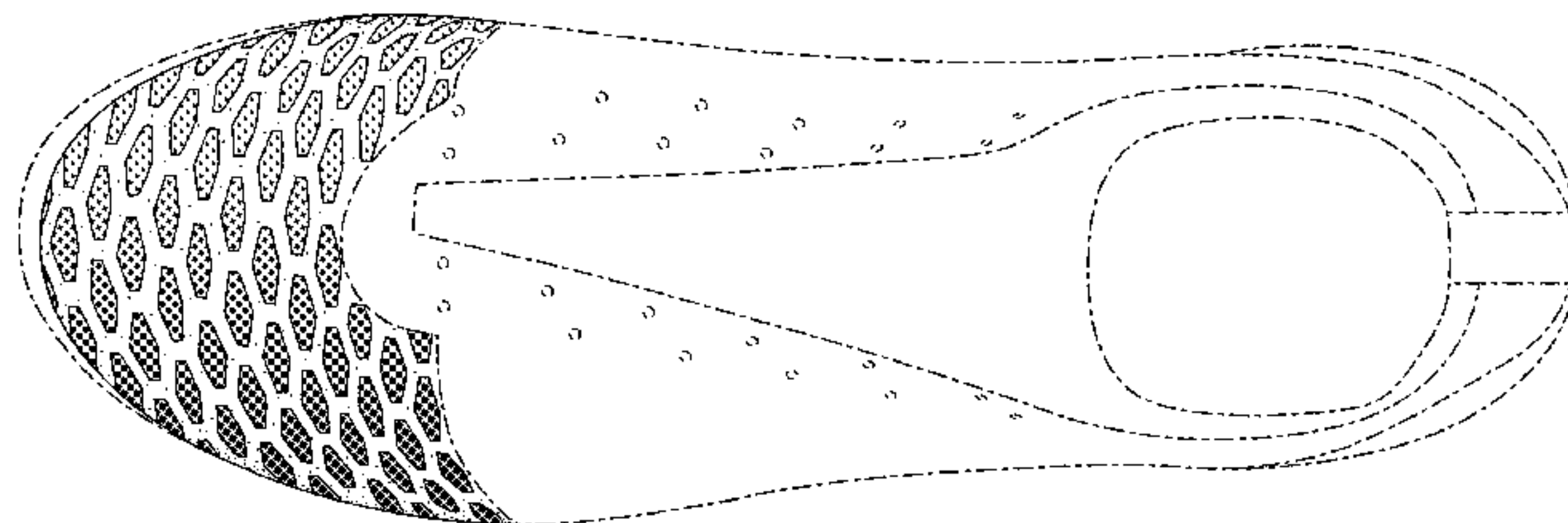
FIG. 8 is a first side view thereof;

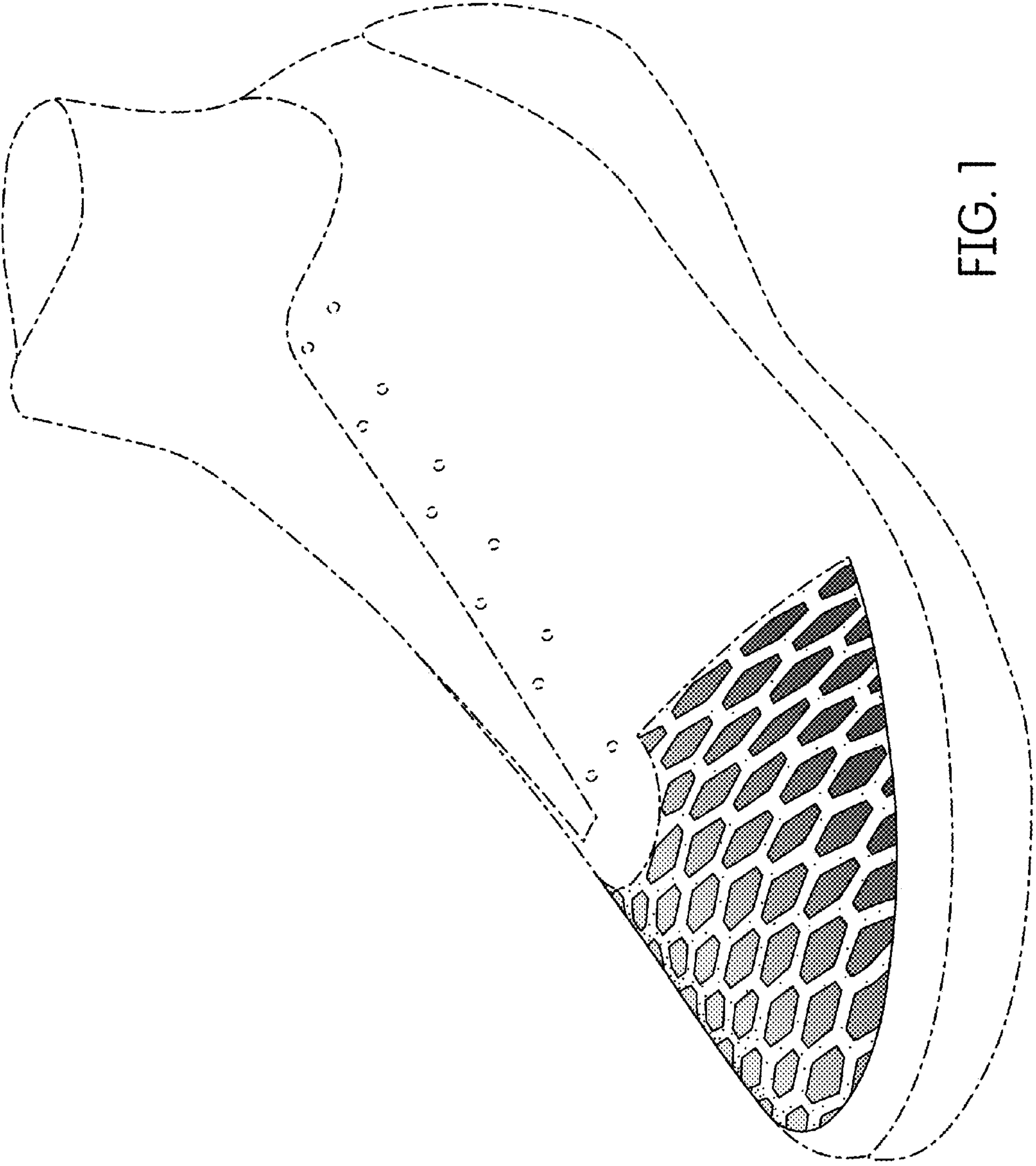

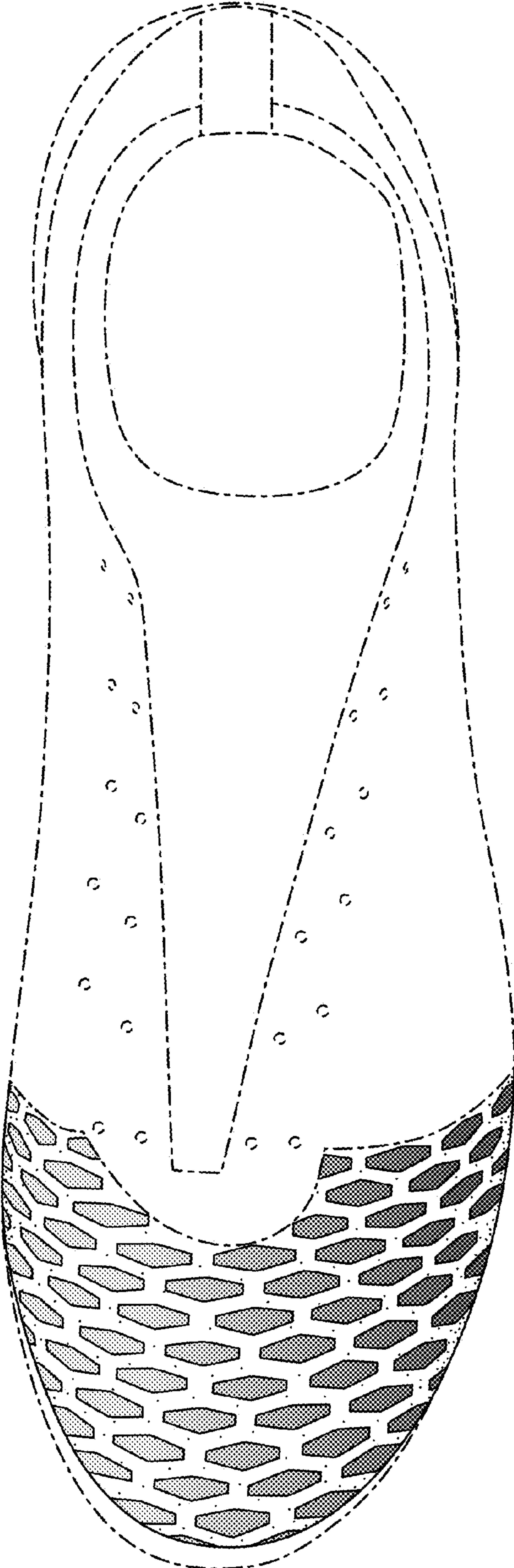

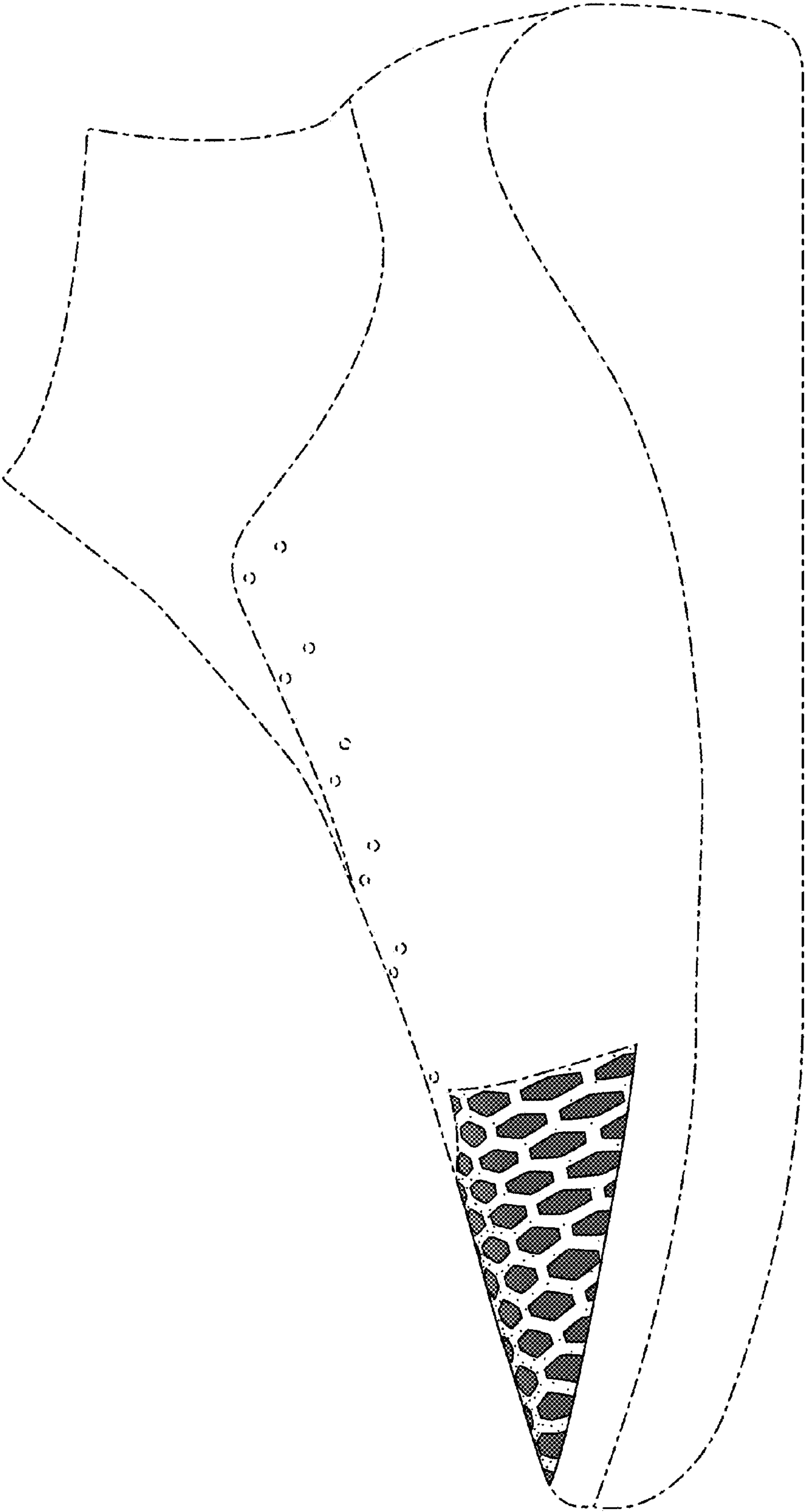

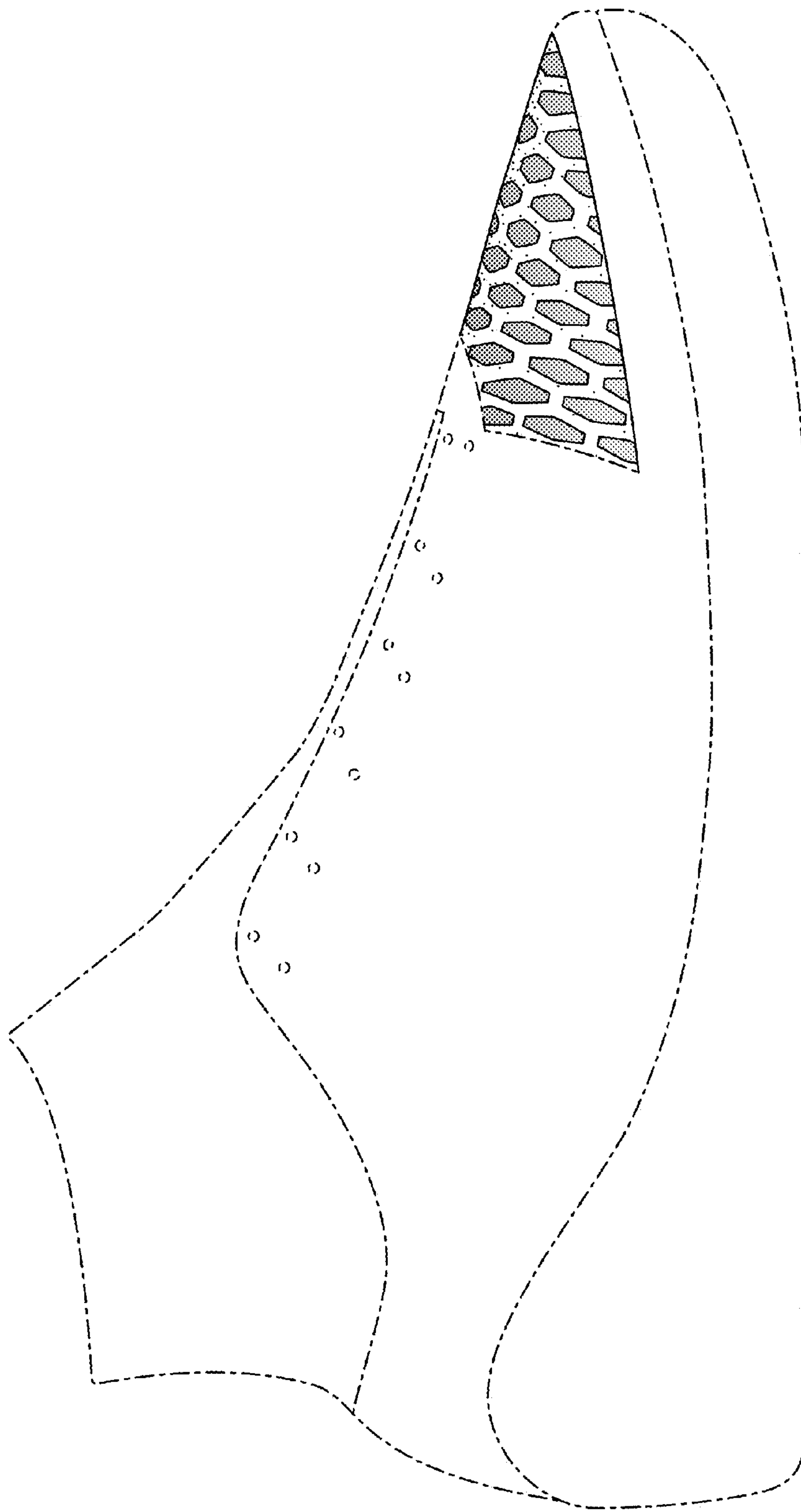

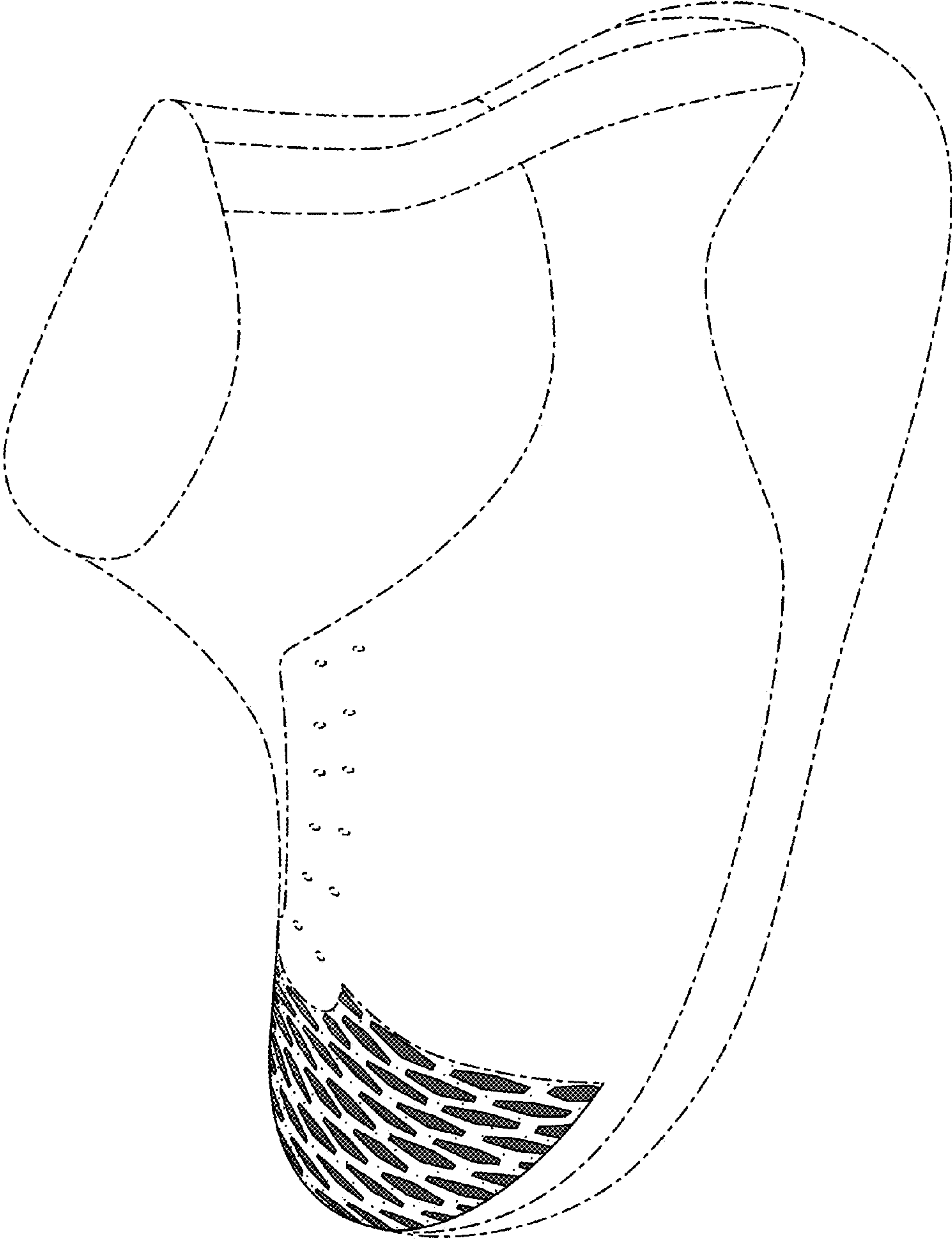

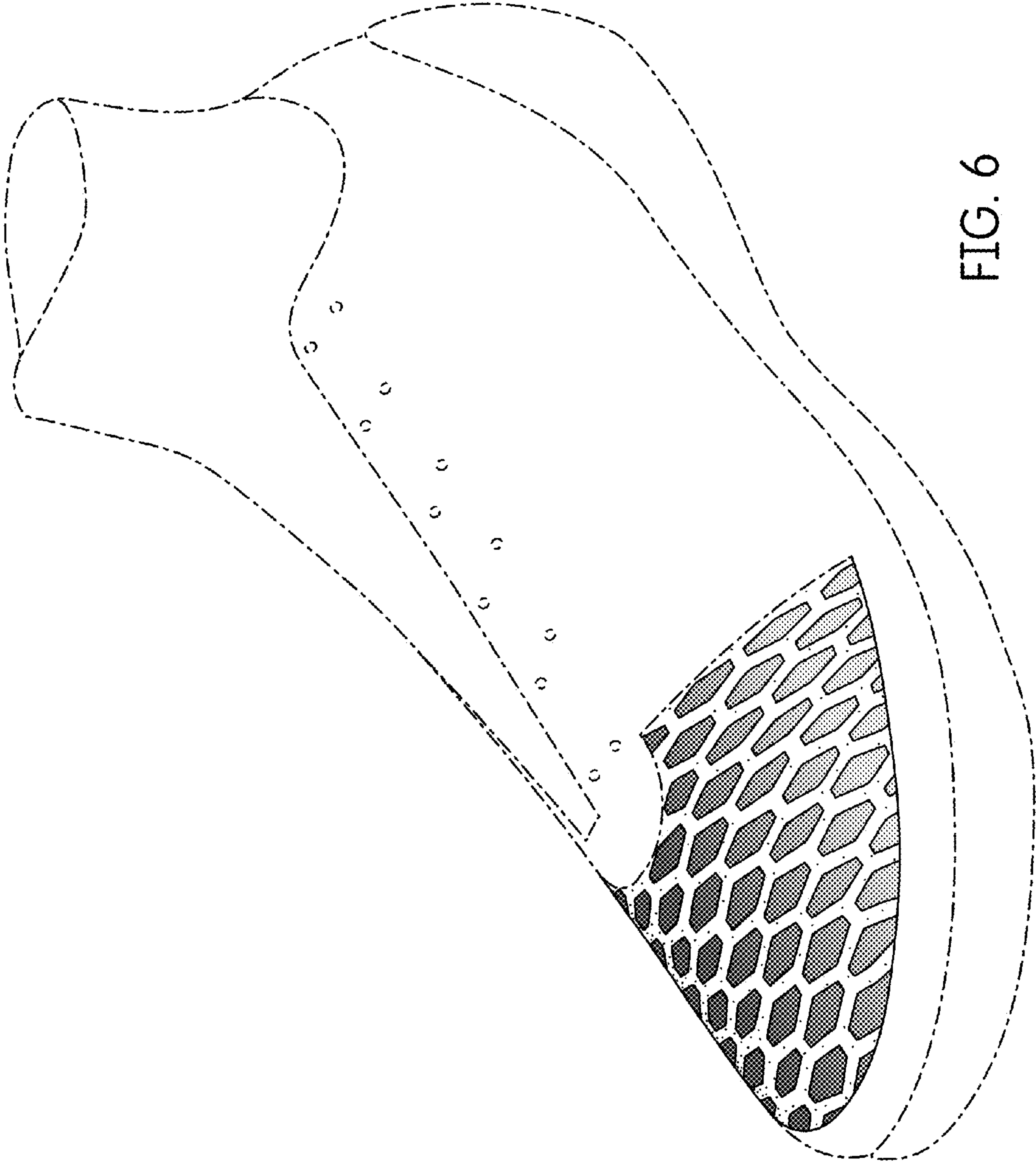

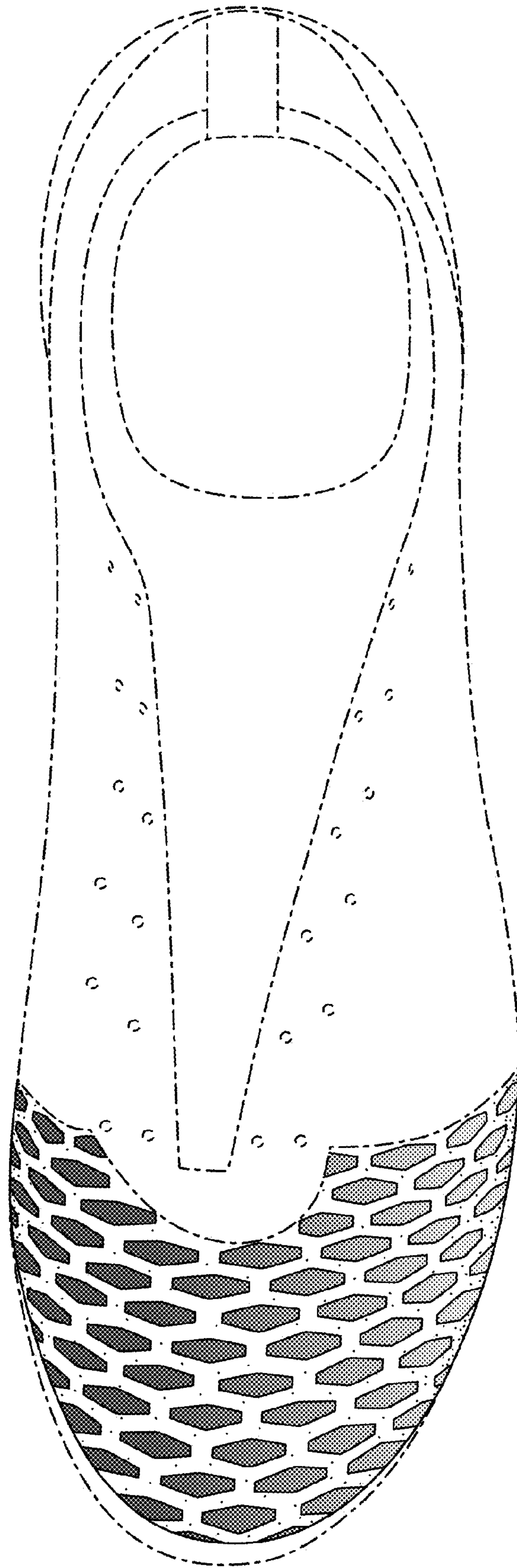

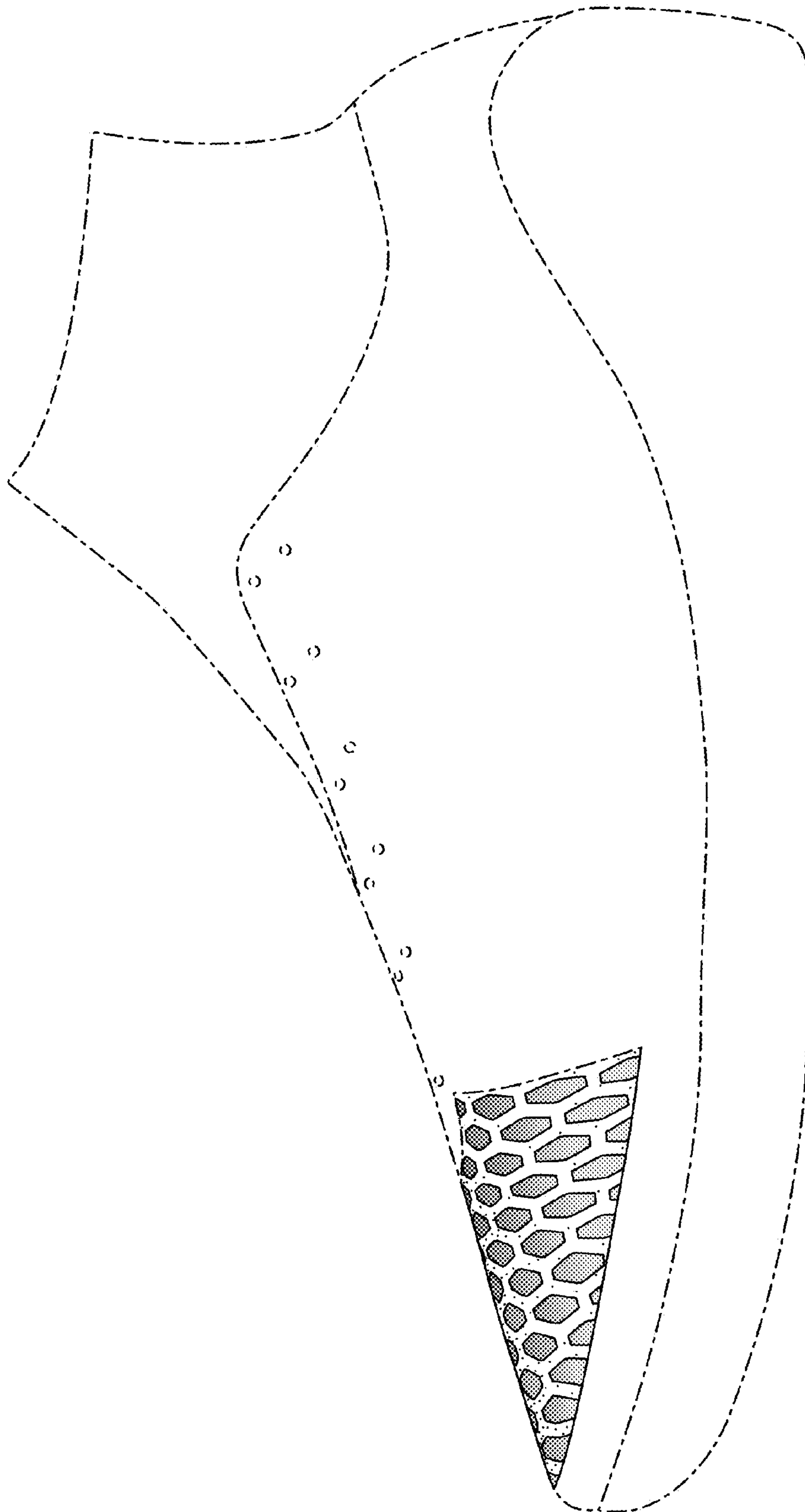

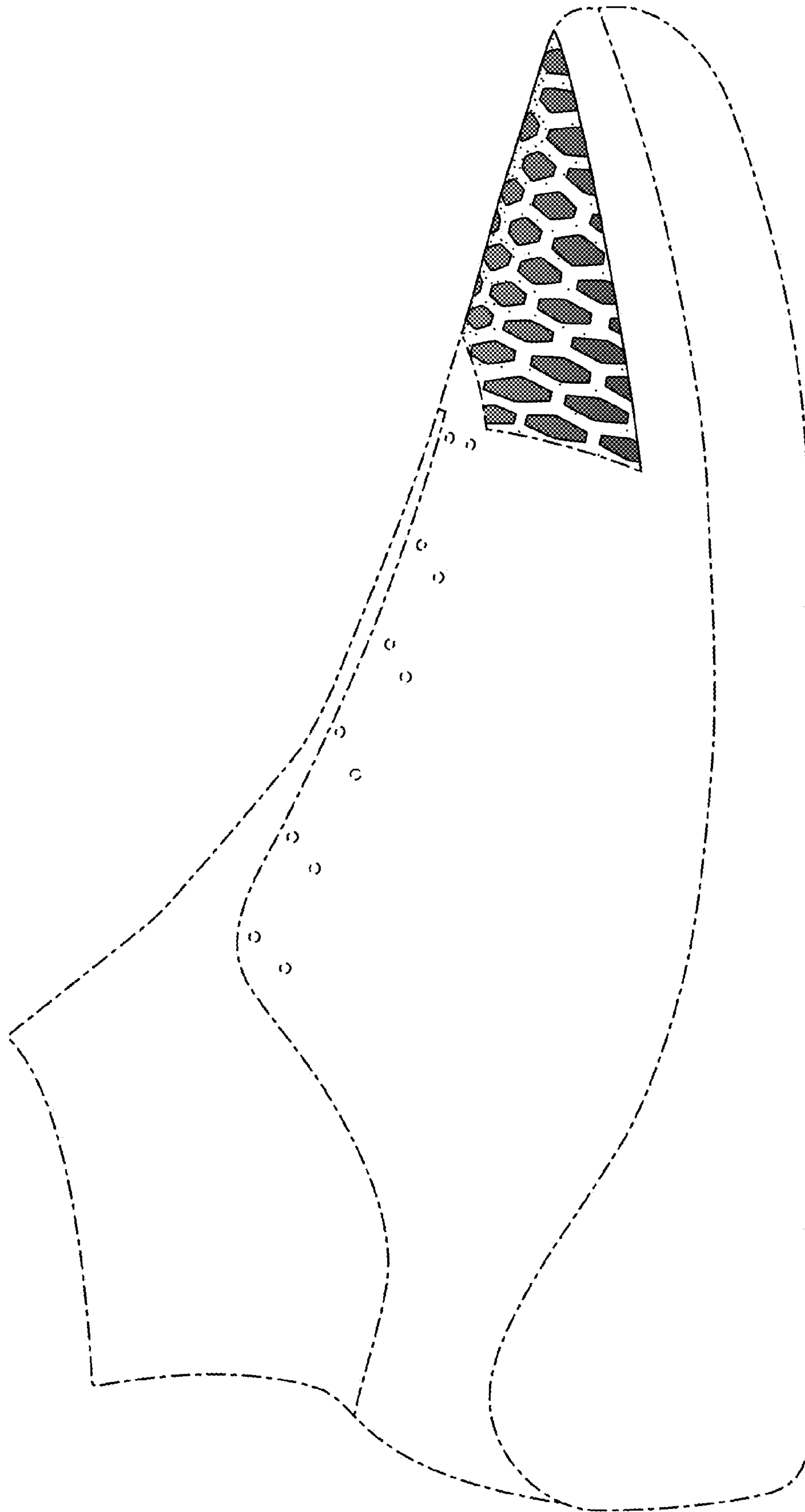

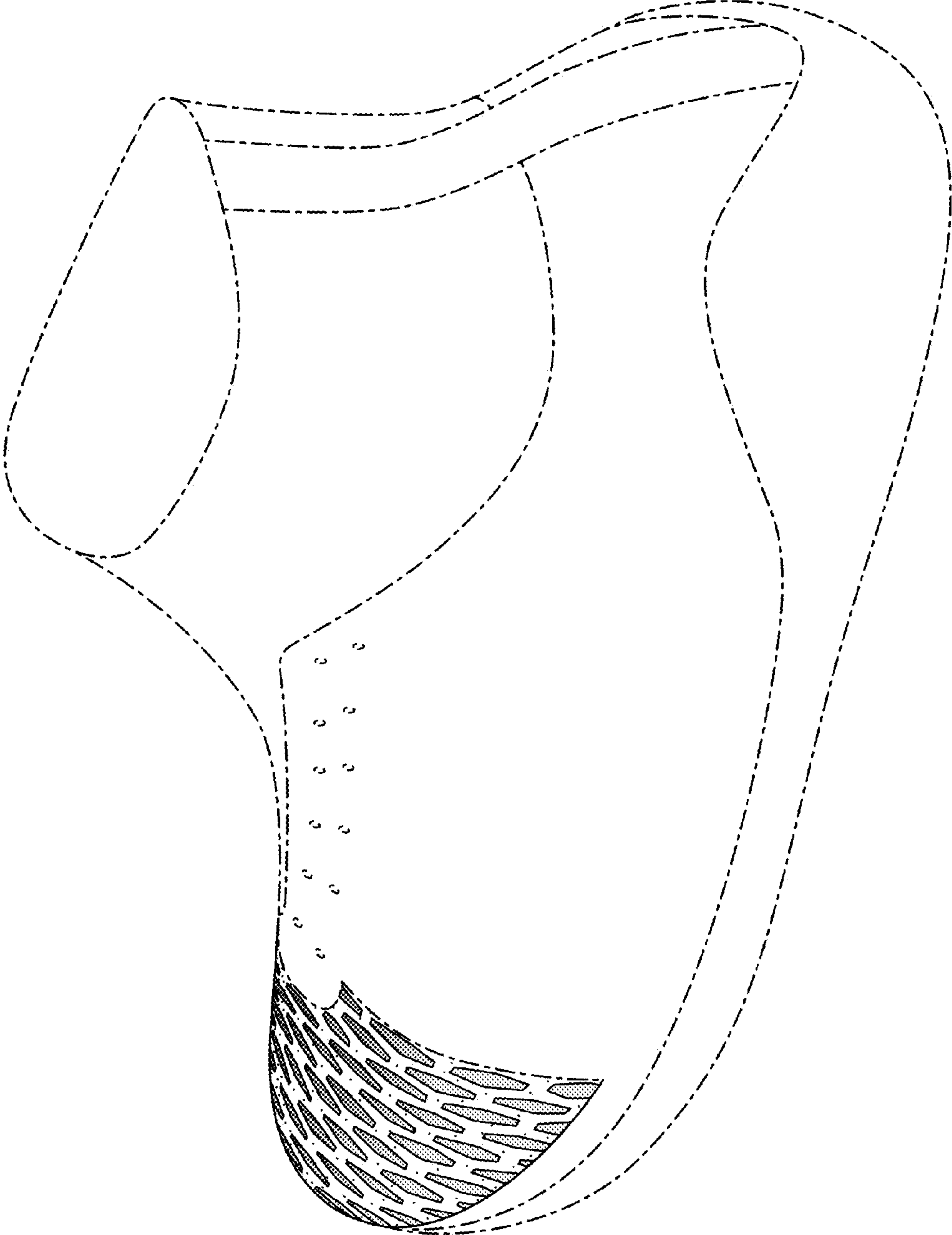
