(57) **CLAIM**

The ornamental design for a personal security keychain, as shown and described.

FIG. 1 is a perspective view of a personal security keychain showing my new design;

 FIG. 12 is a top view of a personal security keychain showing a fifth embodiment of my new design.

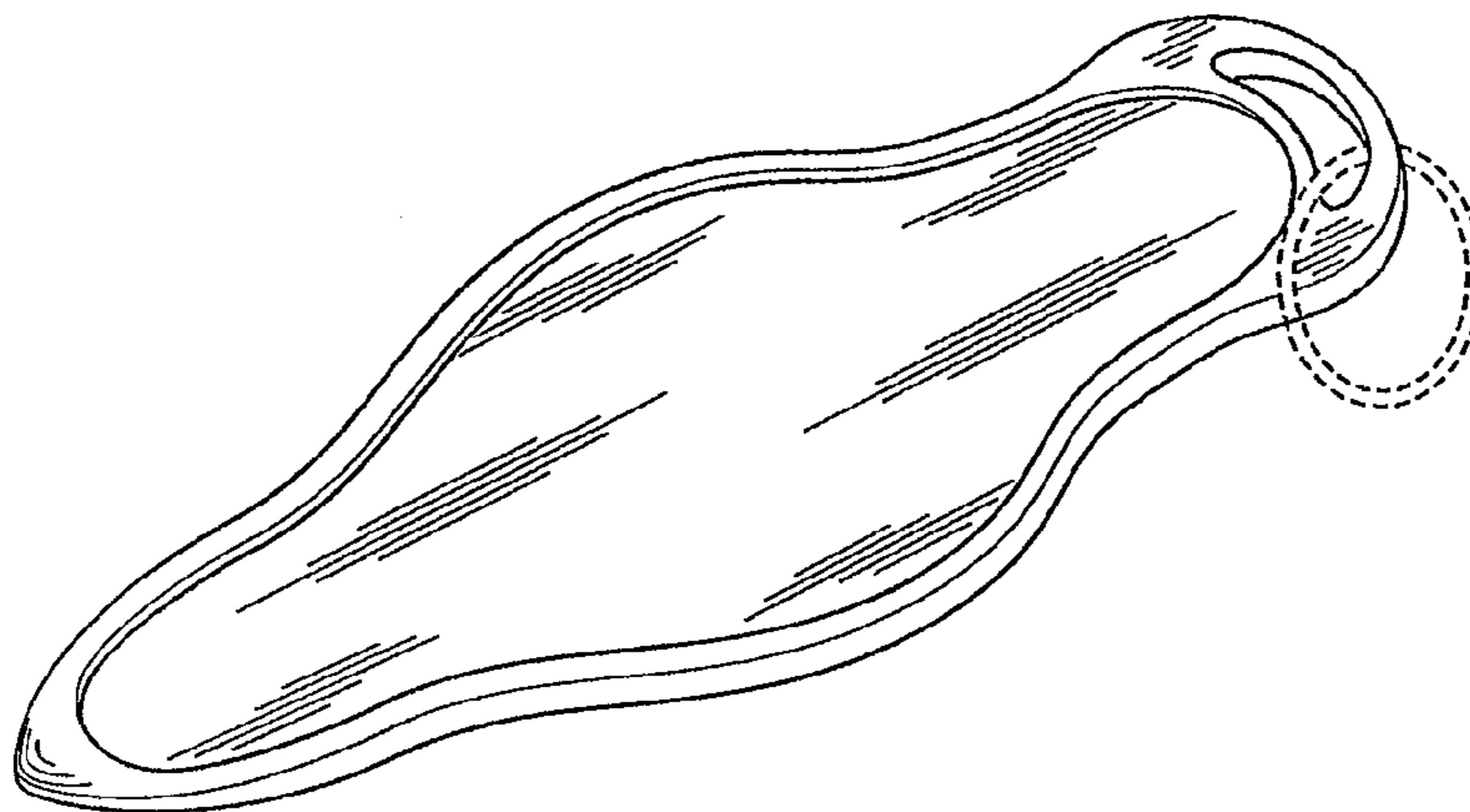
The broken line showing of a key ring, blade, thumb button and a series of remote control buttons is included for the purpose of illustrating environmental matter and forms no part of the claimed design.

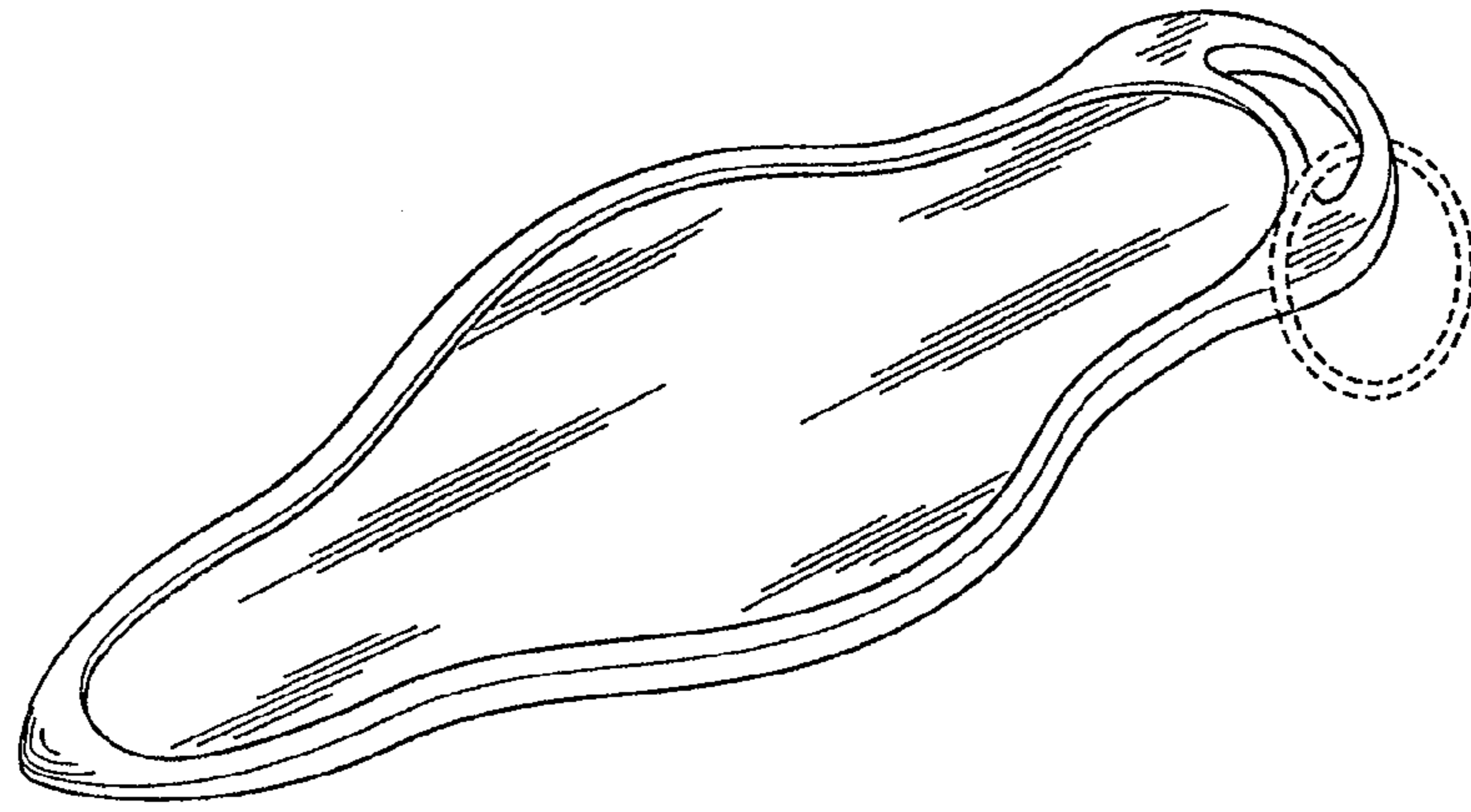

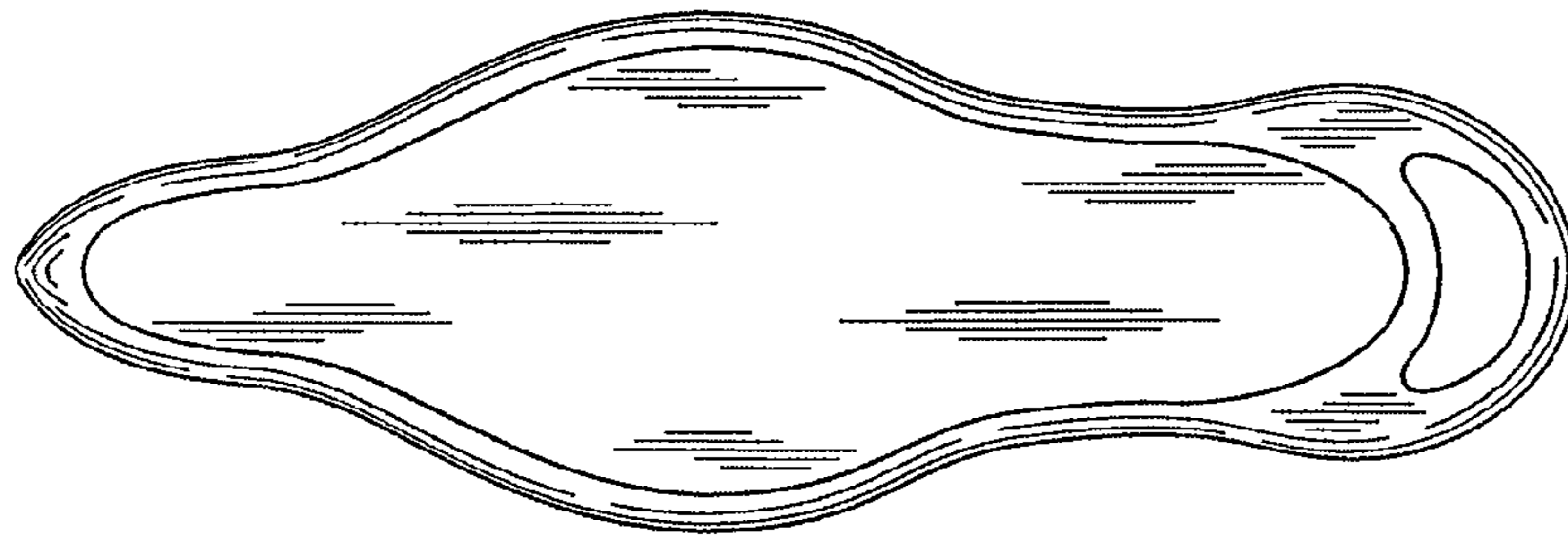

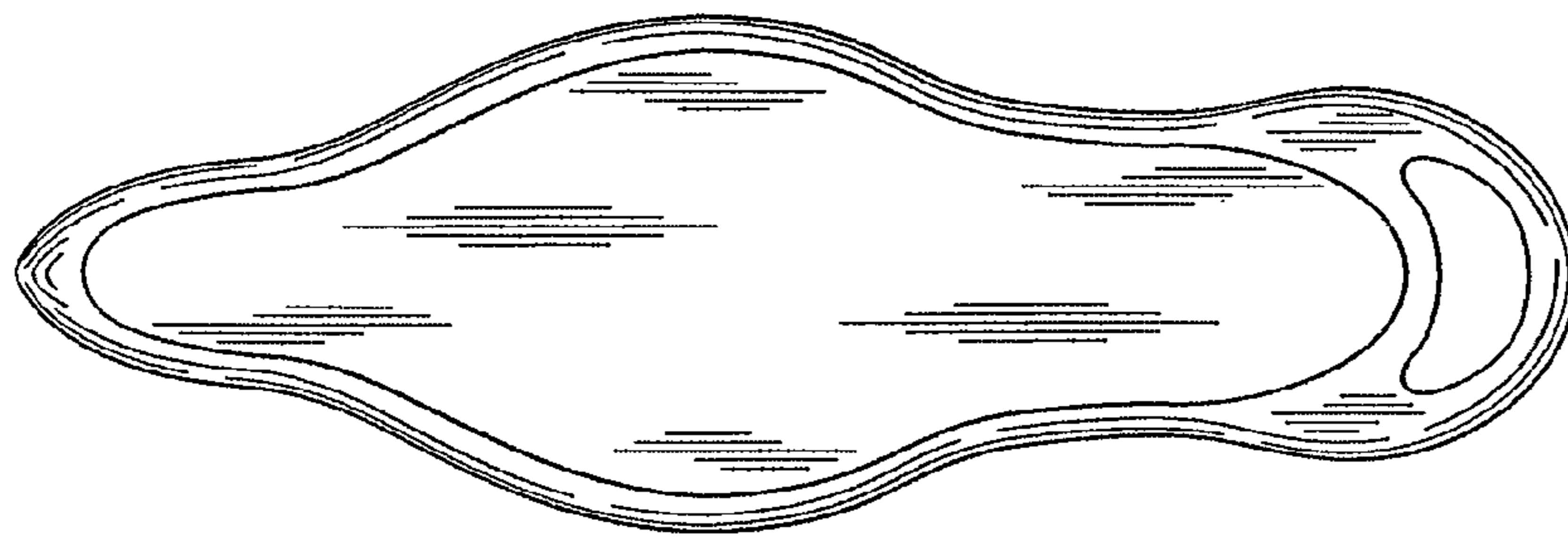

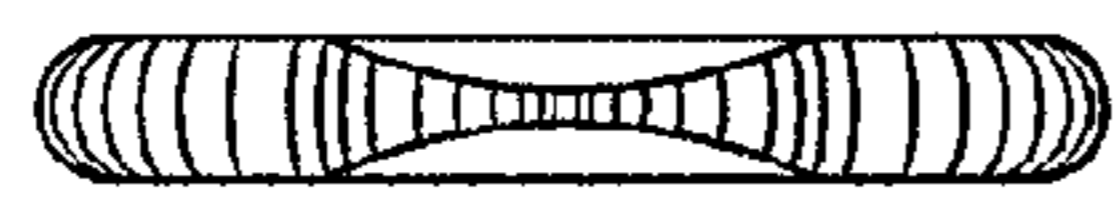

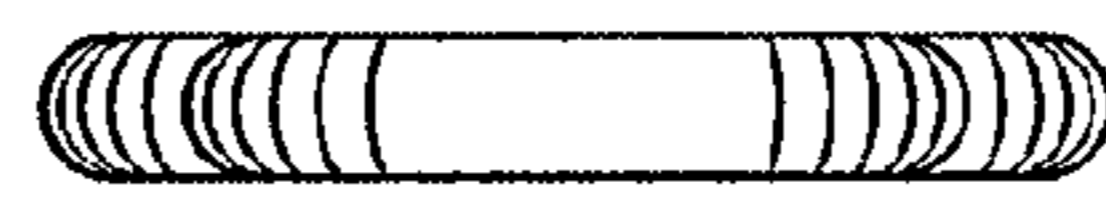

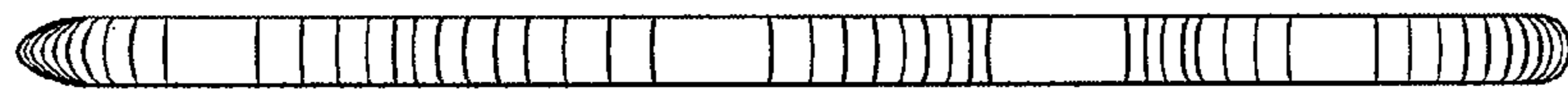

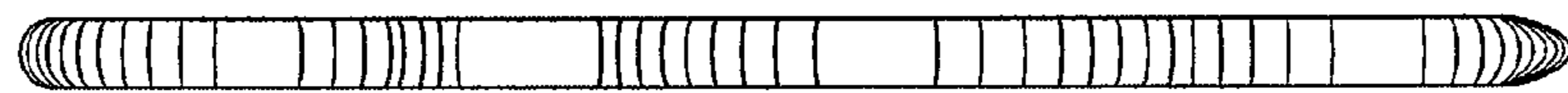

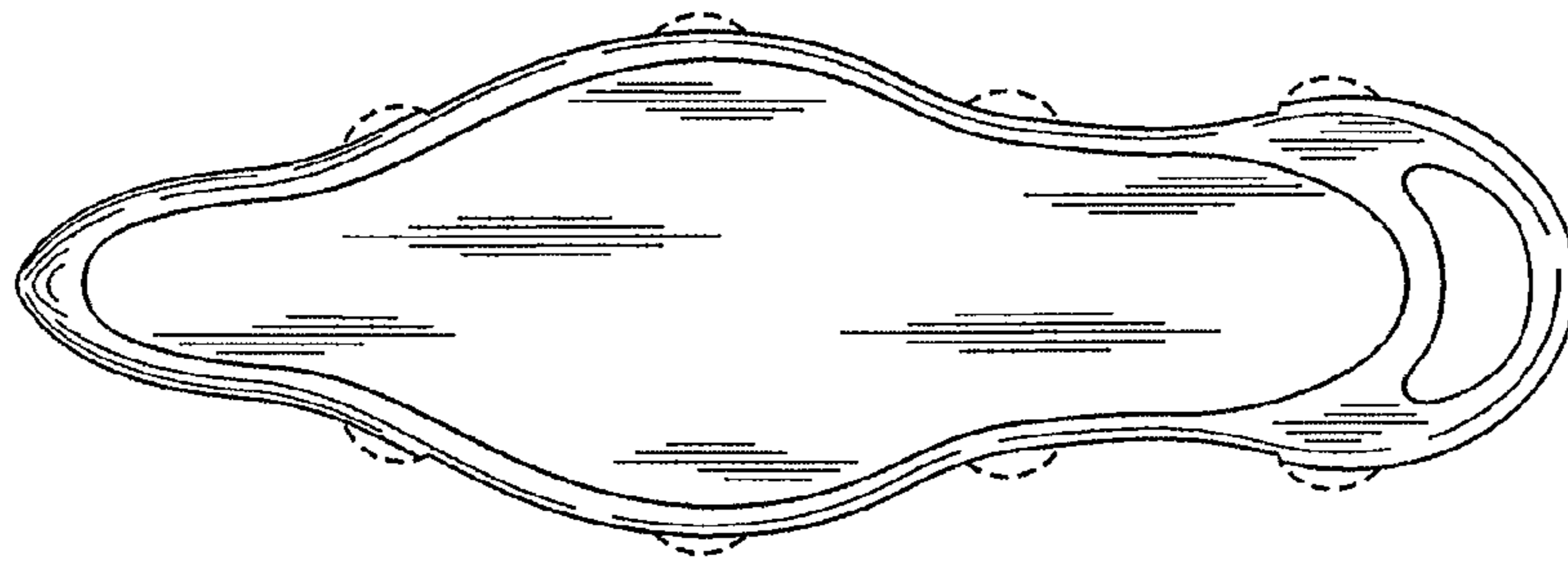

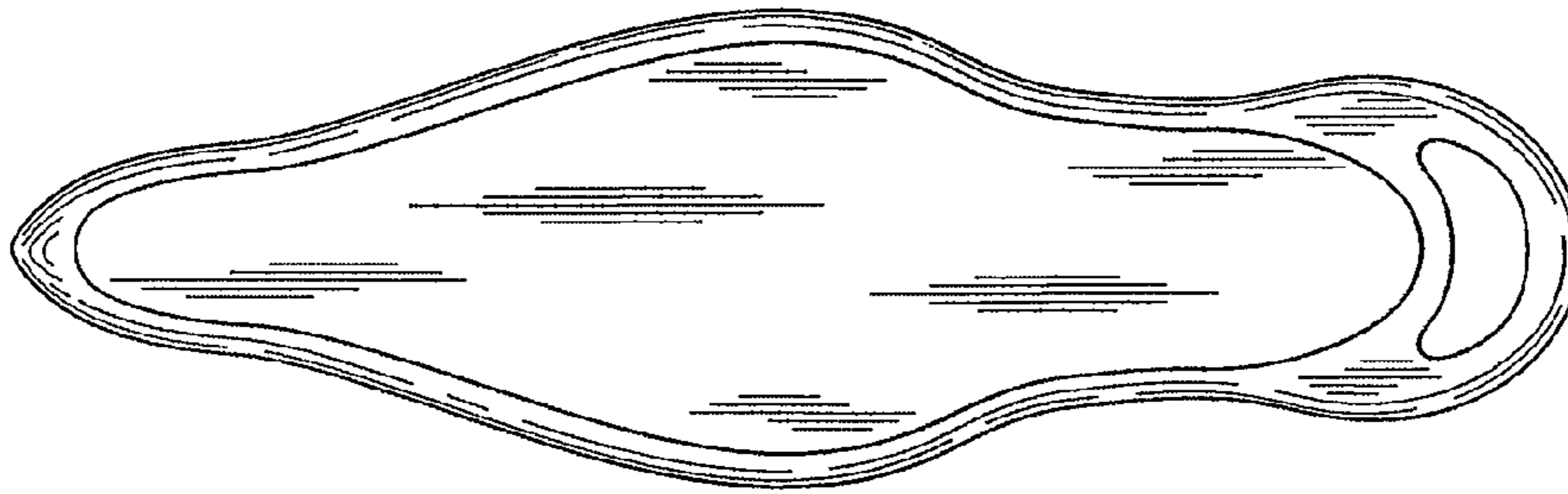

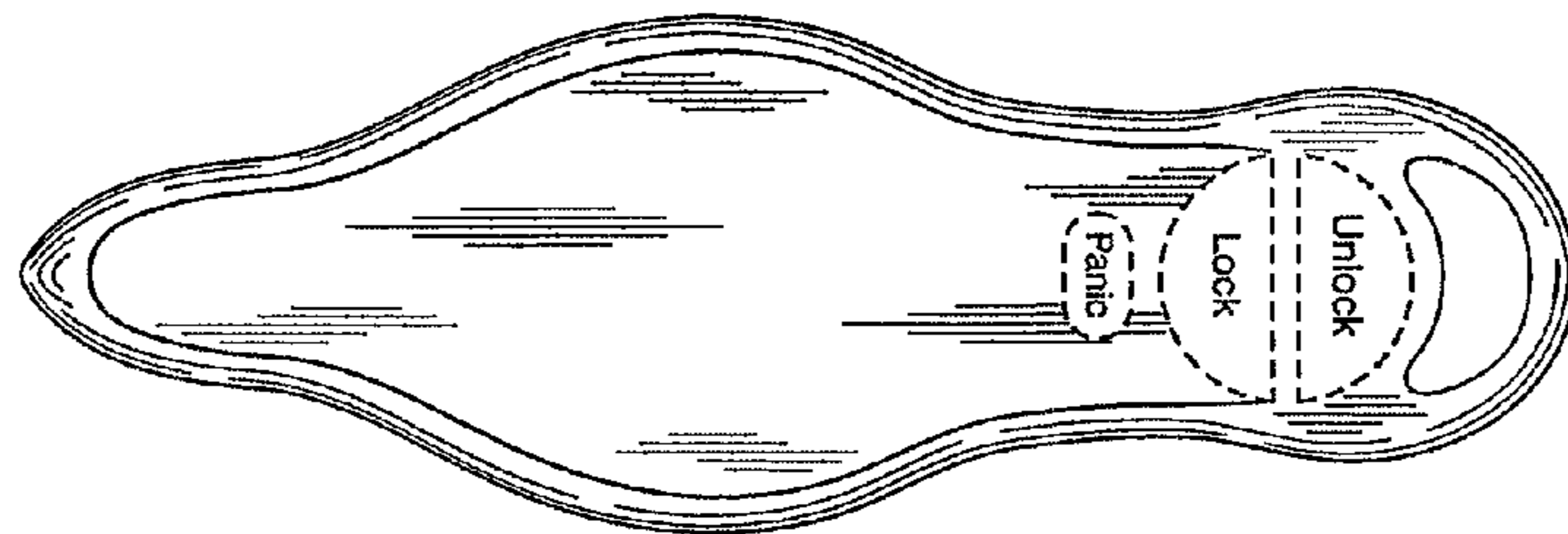

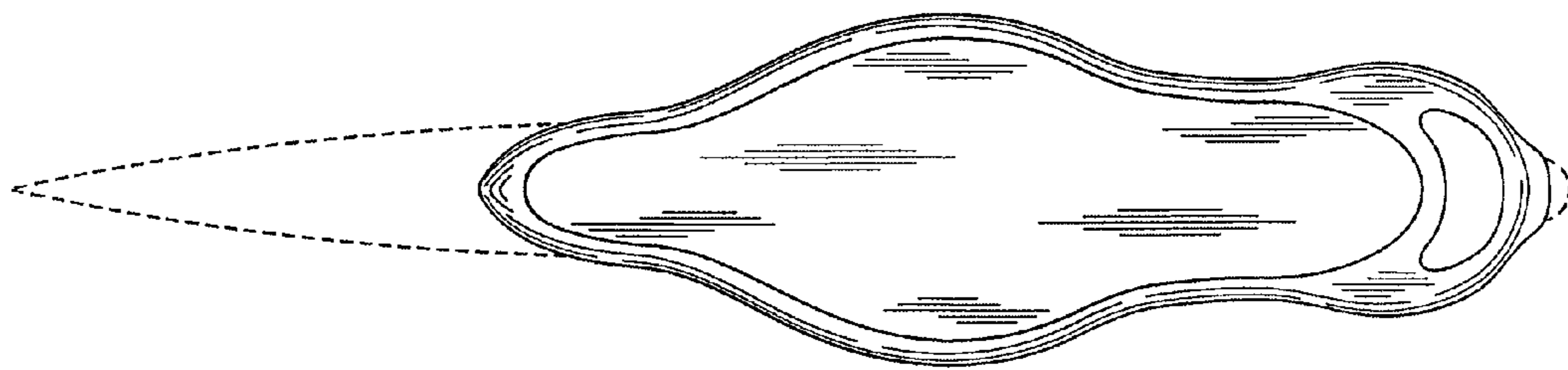

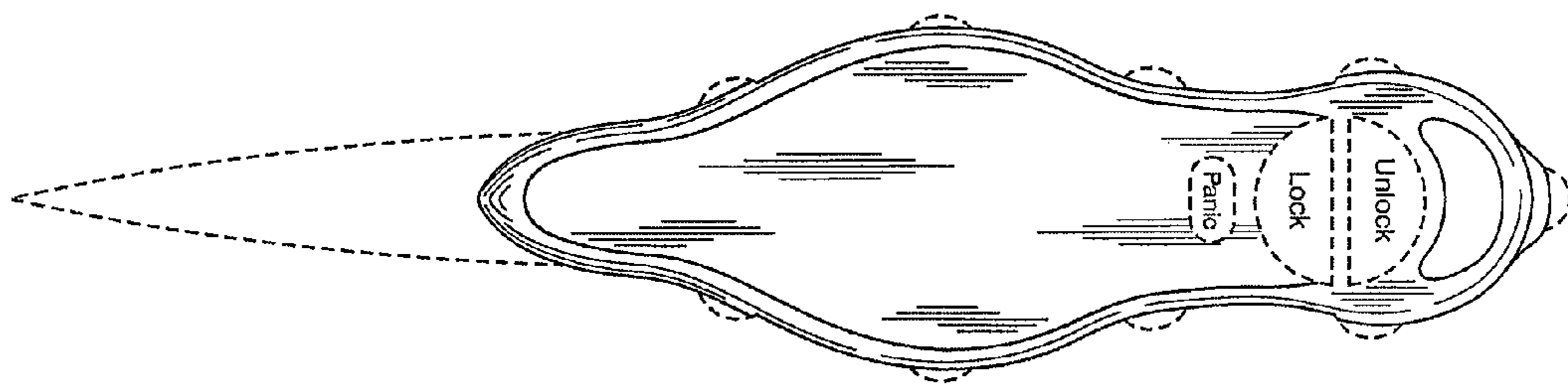
