(57) **CLAIM**

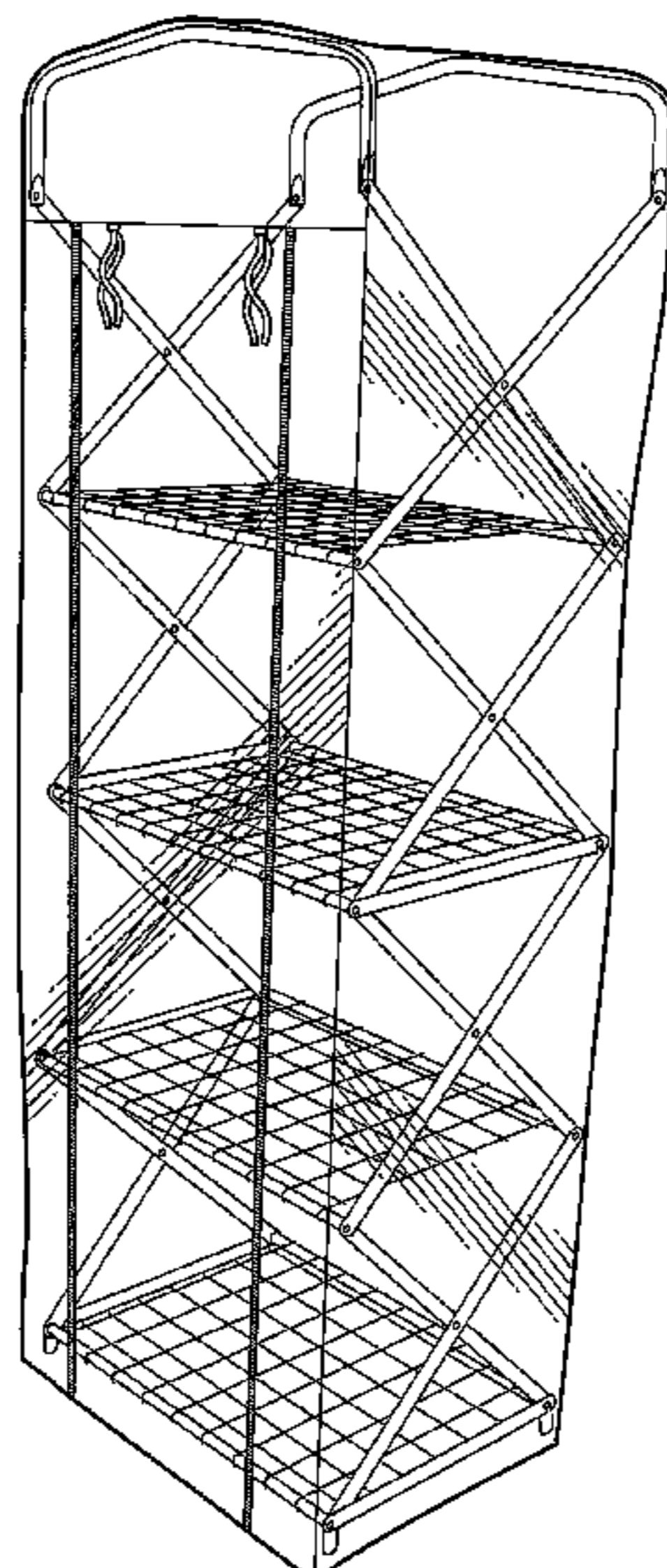
The ornamental design for a collapsible enclosure, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a collapsible enclosure showing my new design with a door flap in a closed position; FIG. 2 is a front perspective view thereof with the door flap in an open position; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left side side elevational view thereof; and, FIG. 6 is a top view thereof.

The broken lines showing additional detail are for illustrative purposes only and form no part of the claimed design.

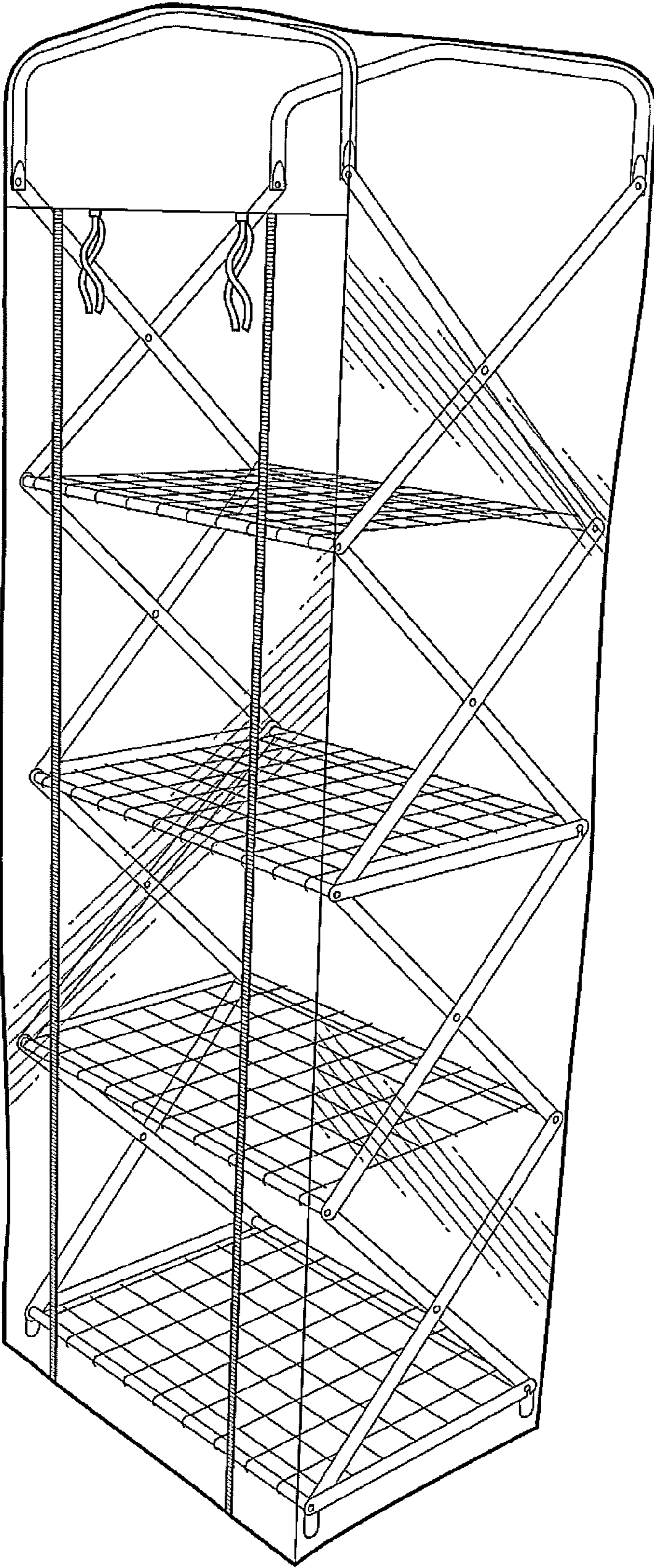

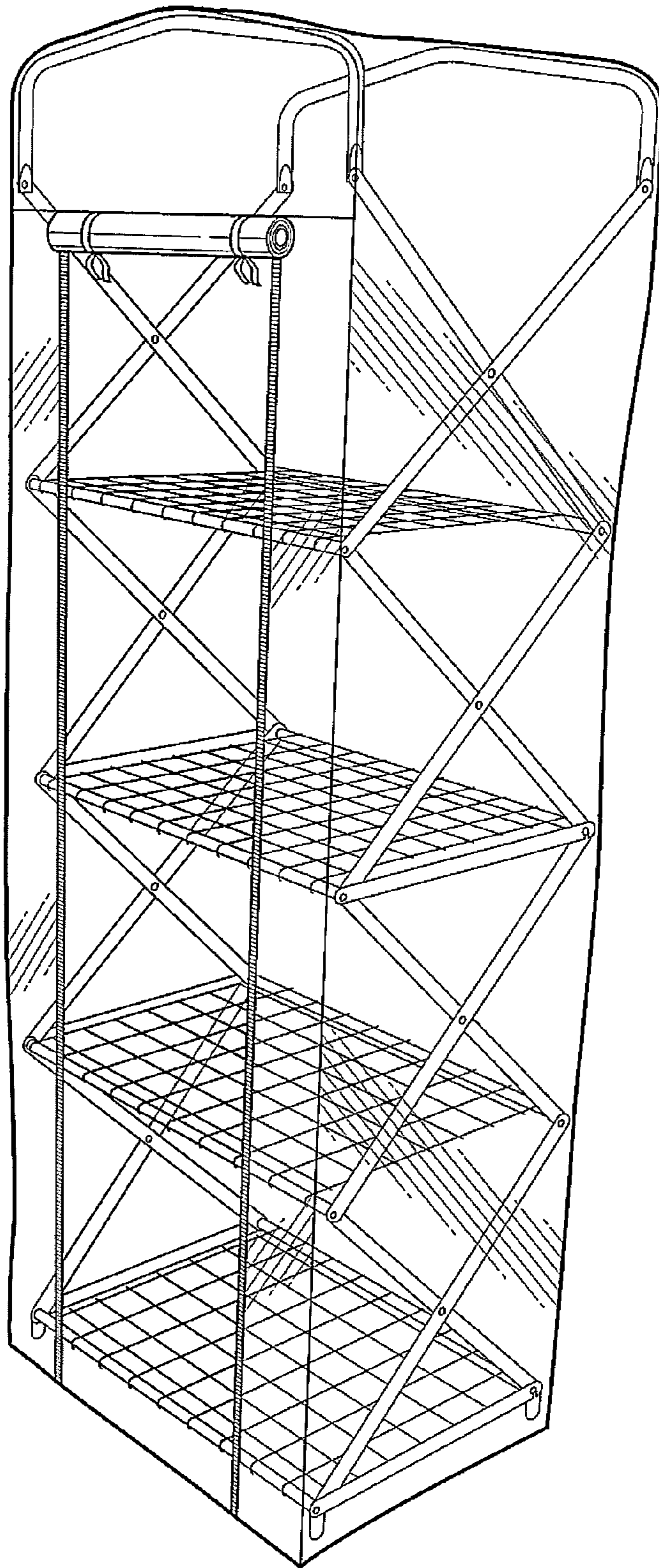

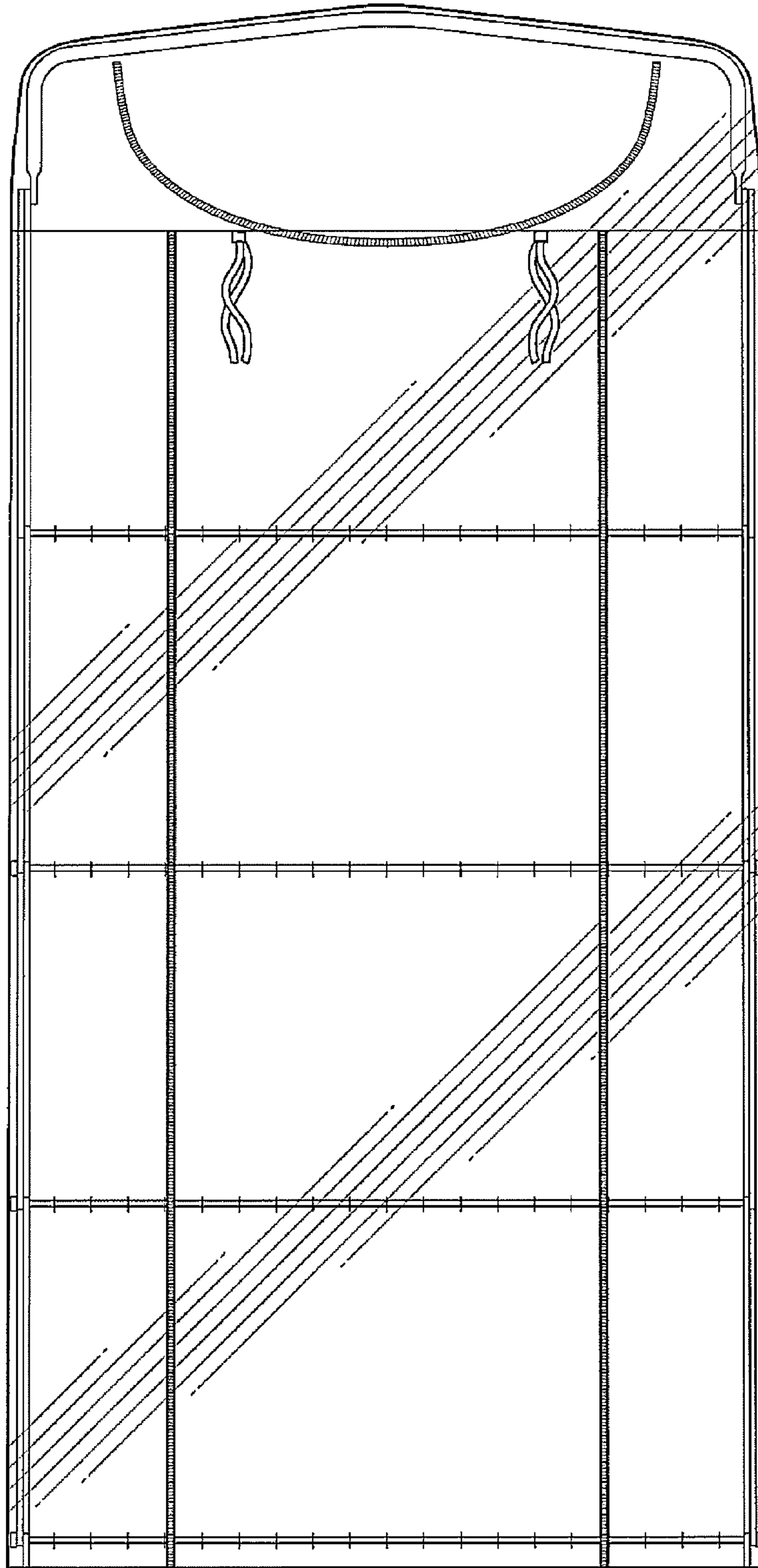

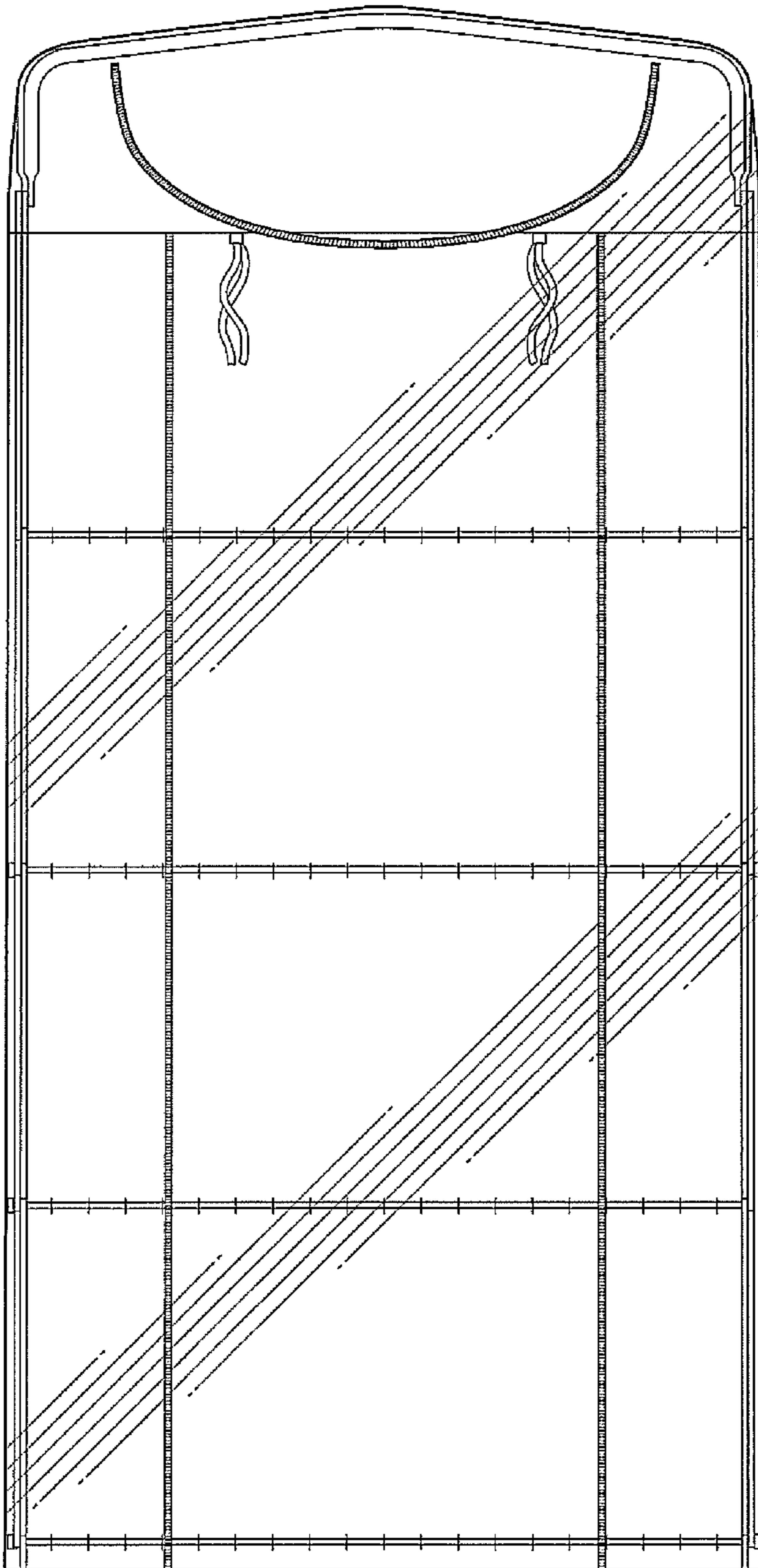

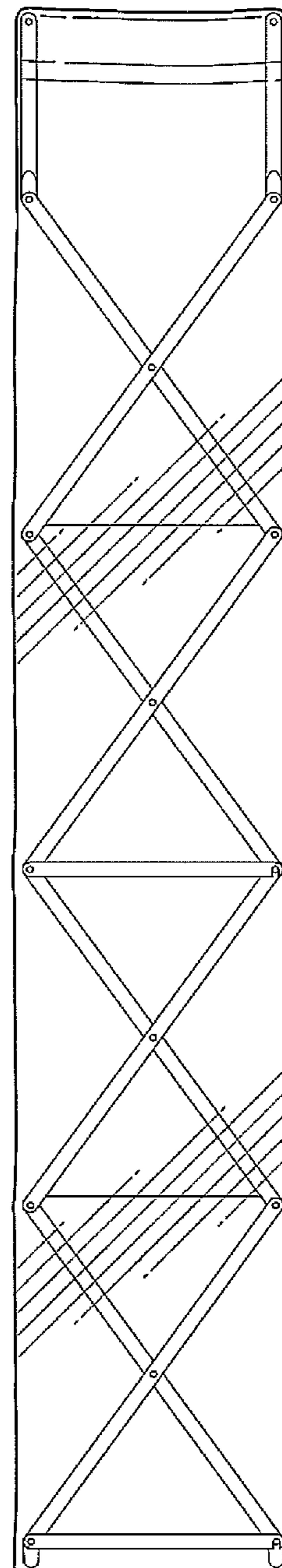

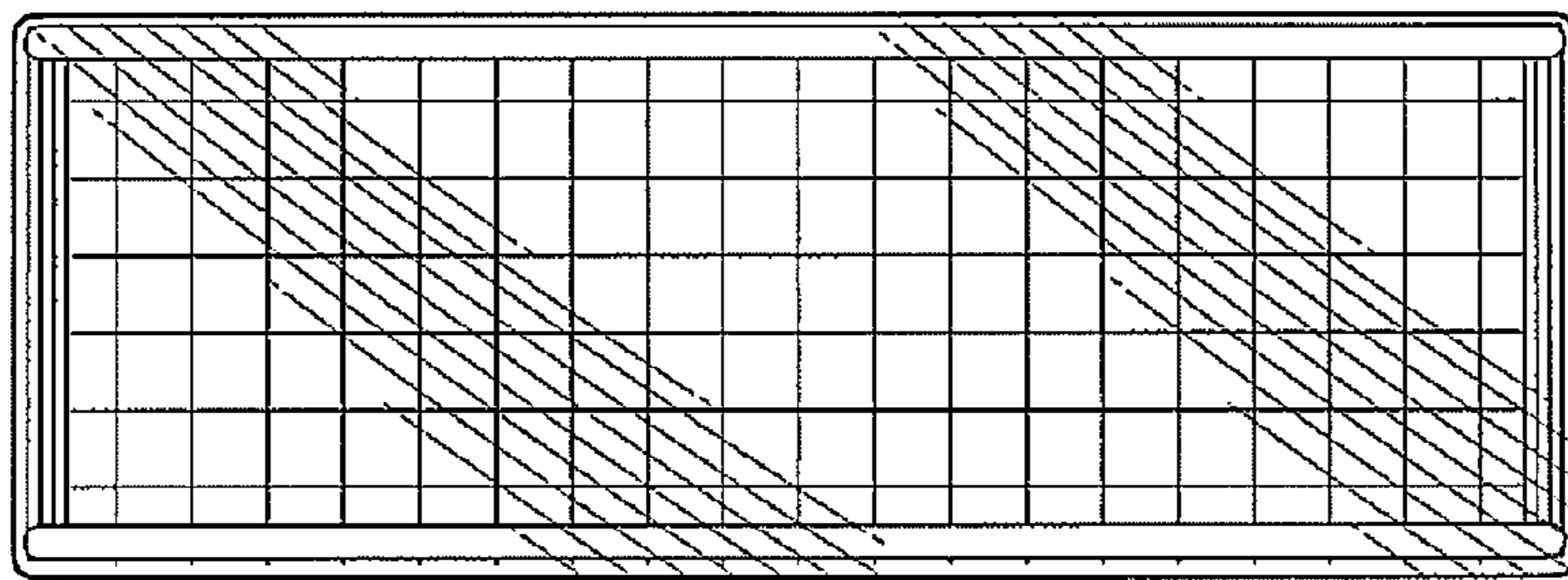
