DESCRIPTION

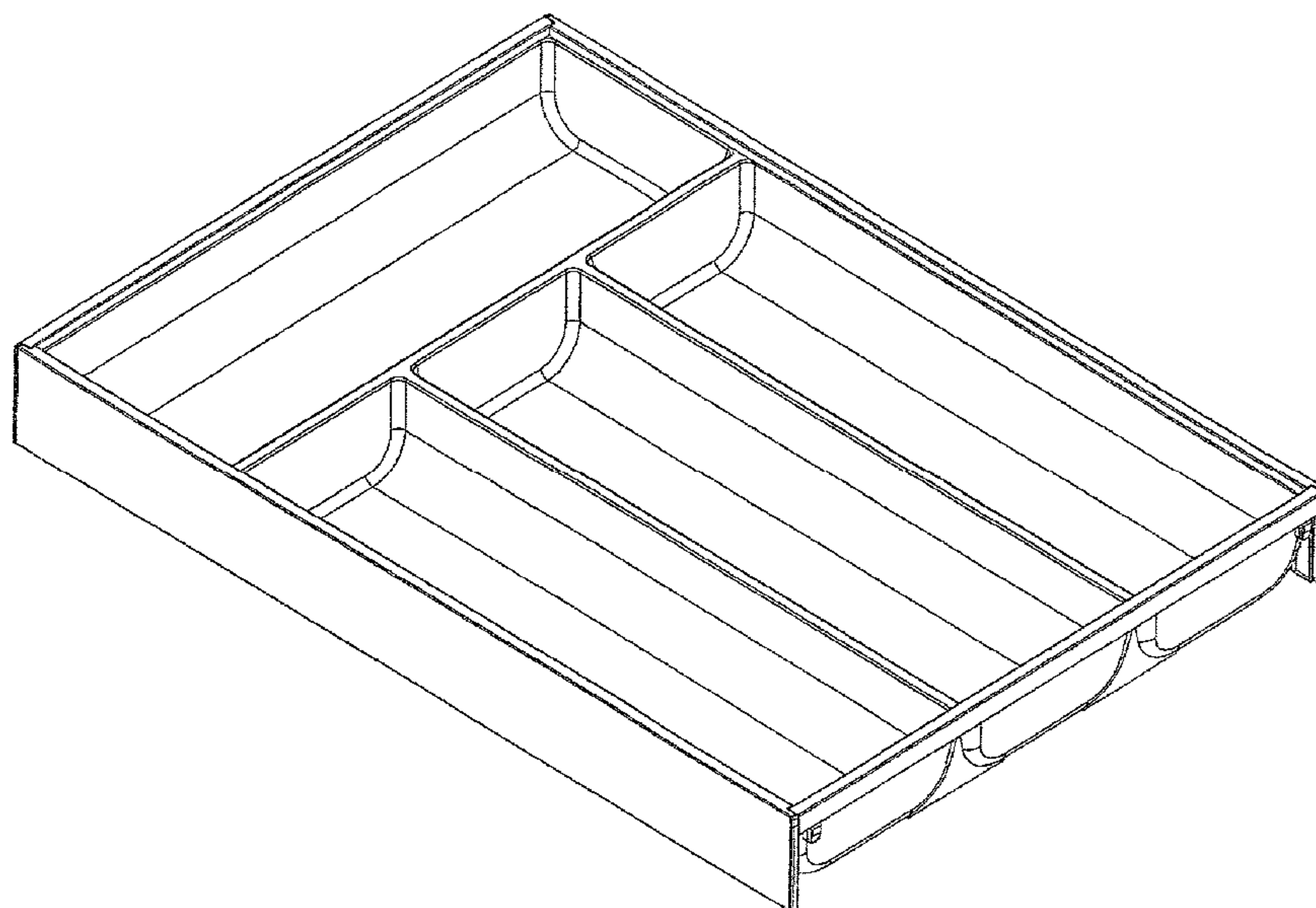

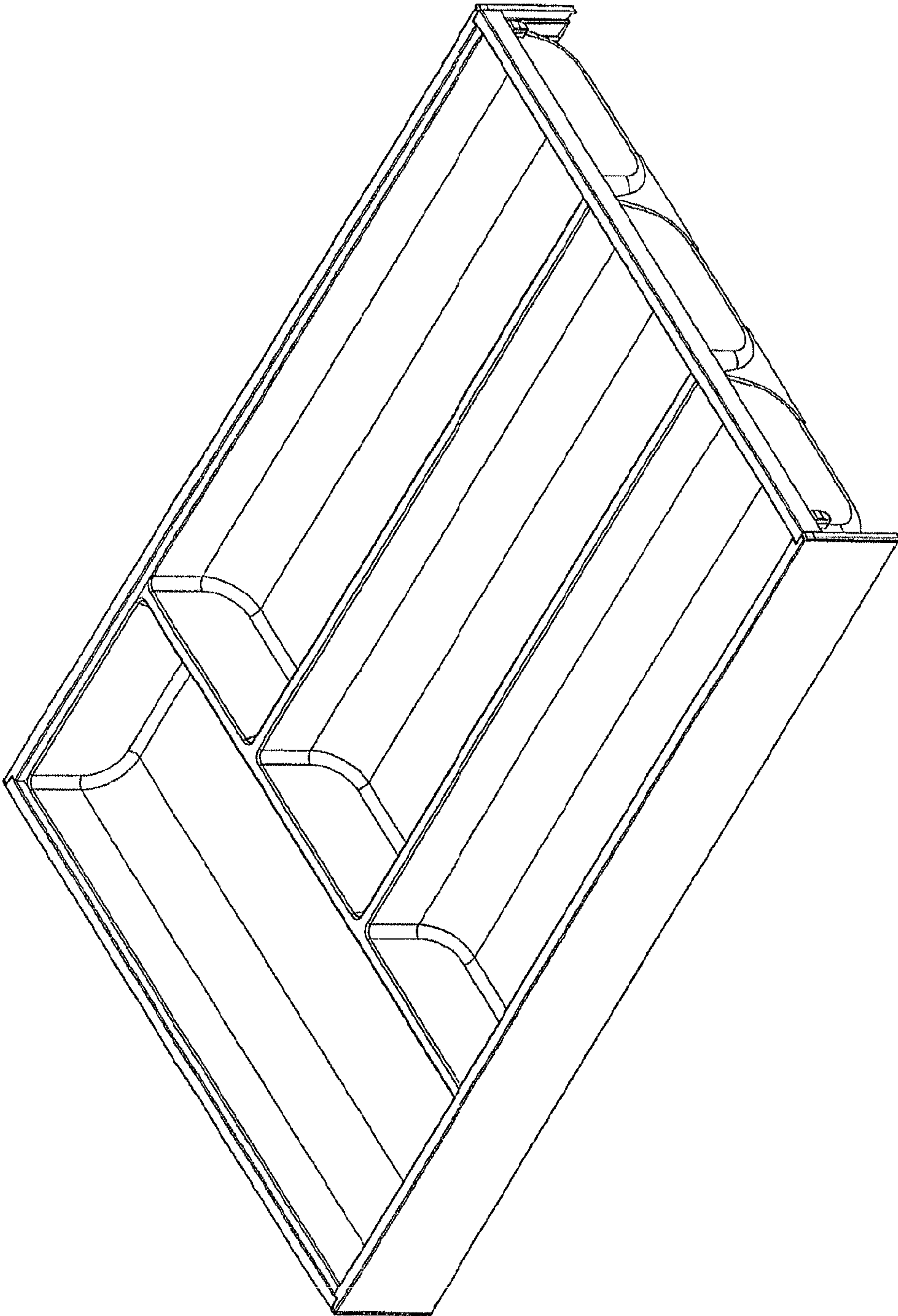

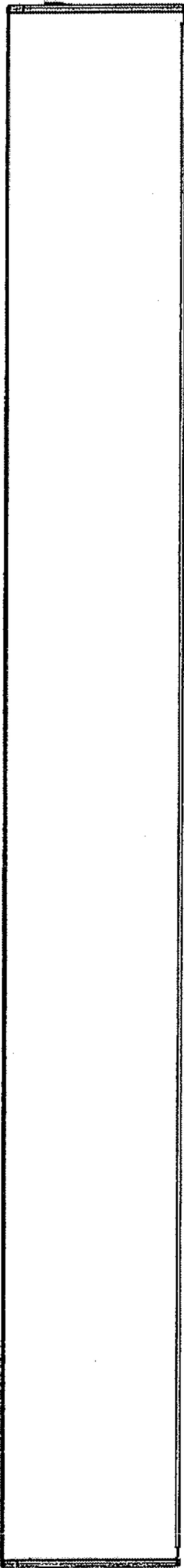

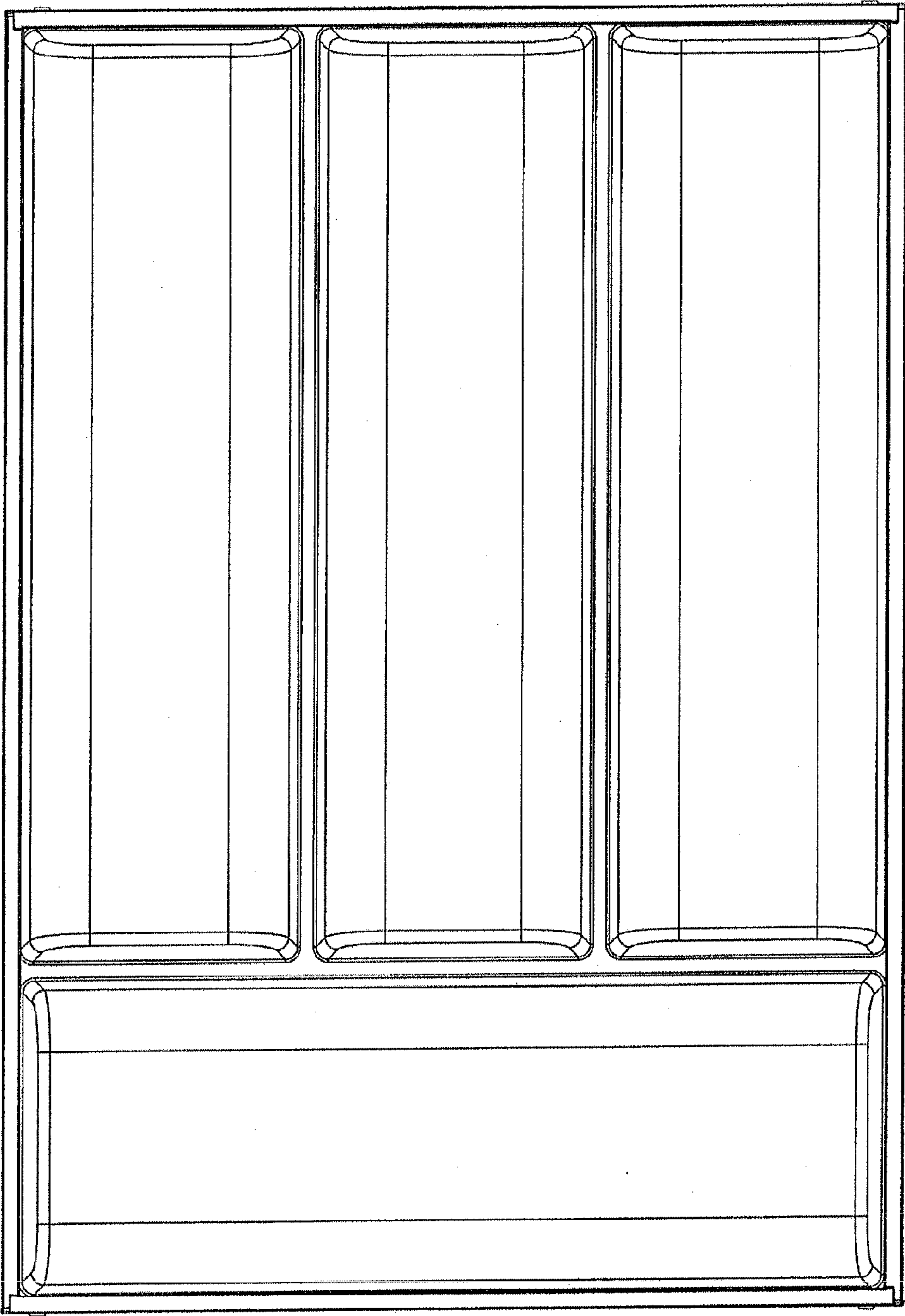

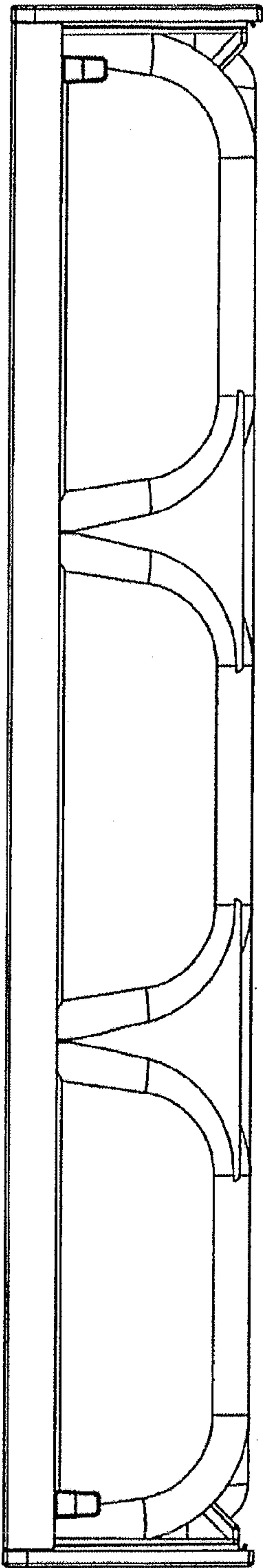

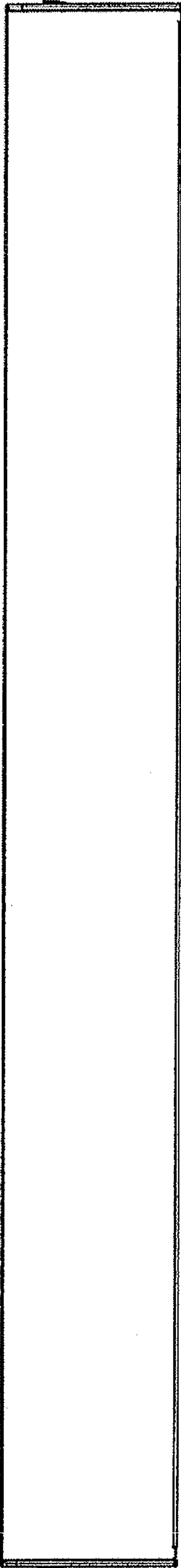

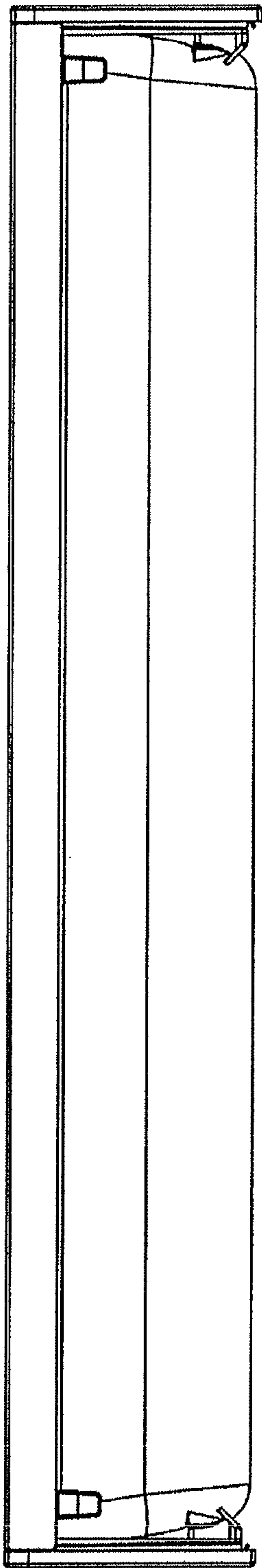

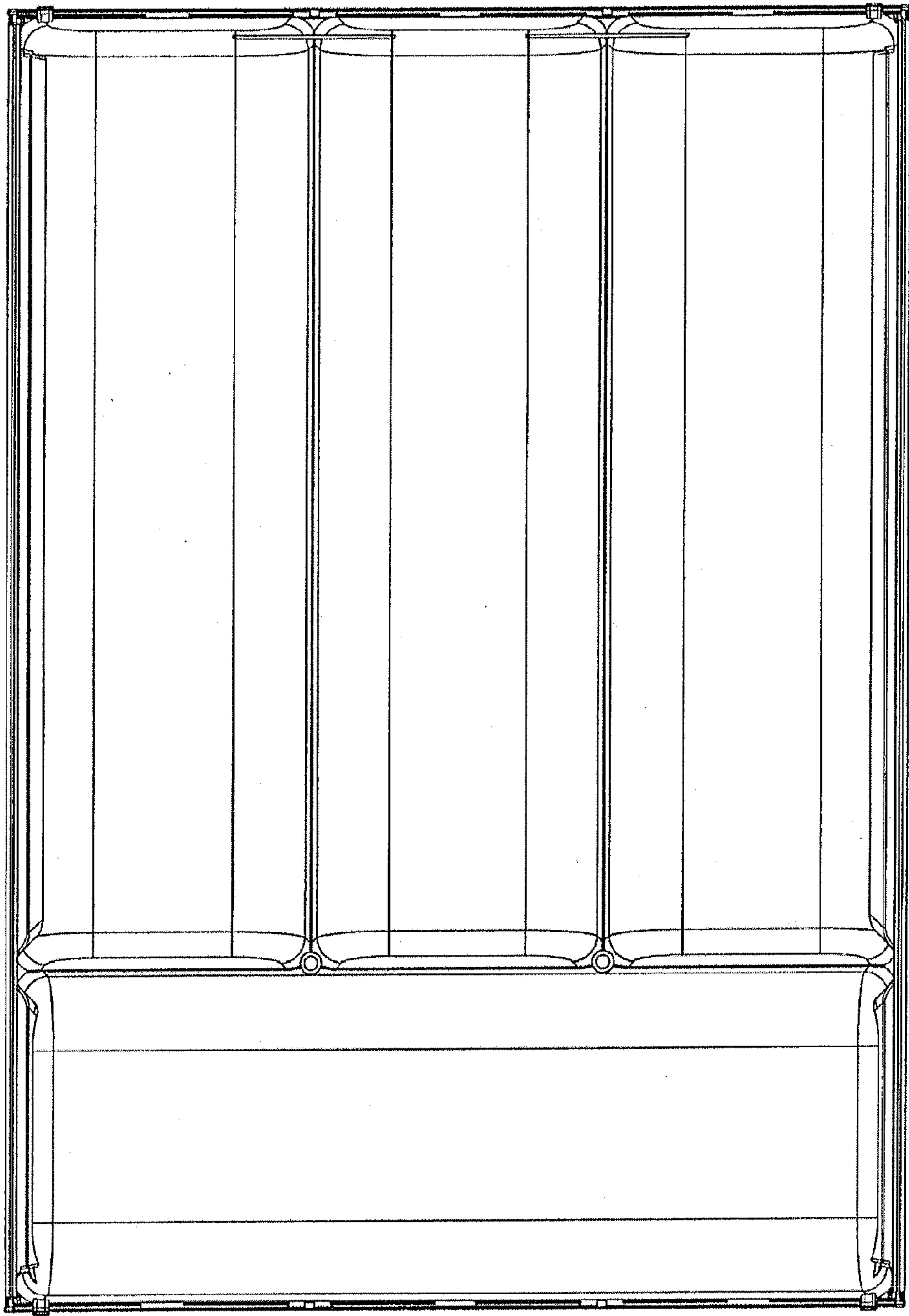

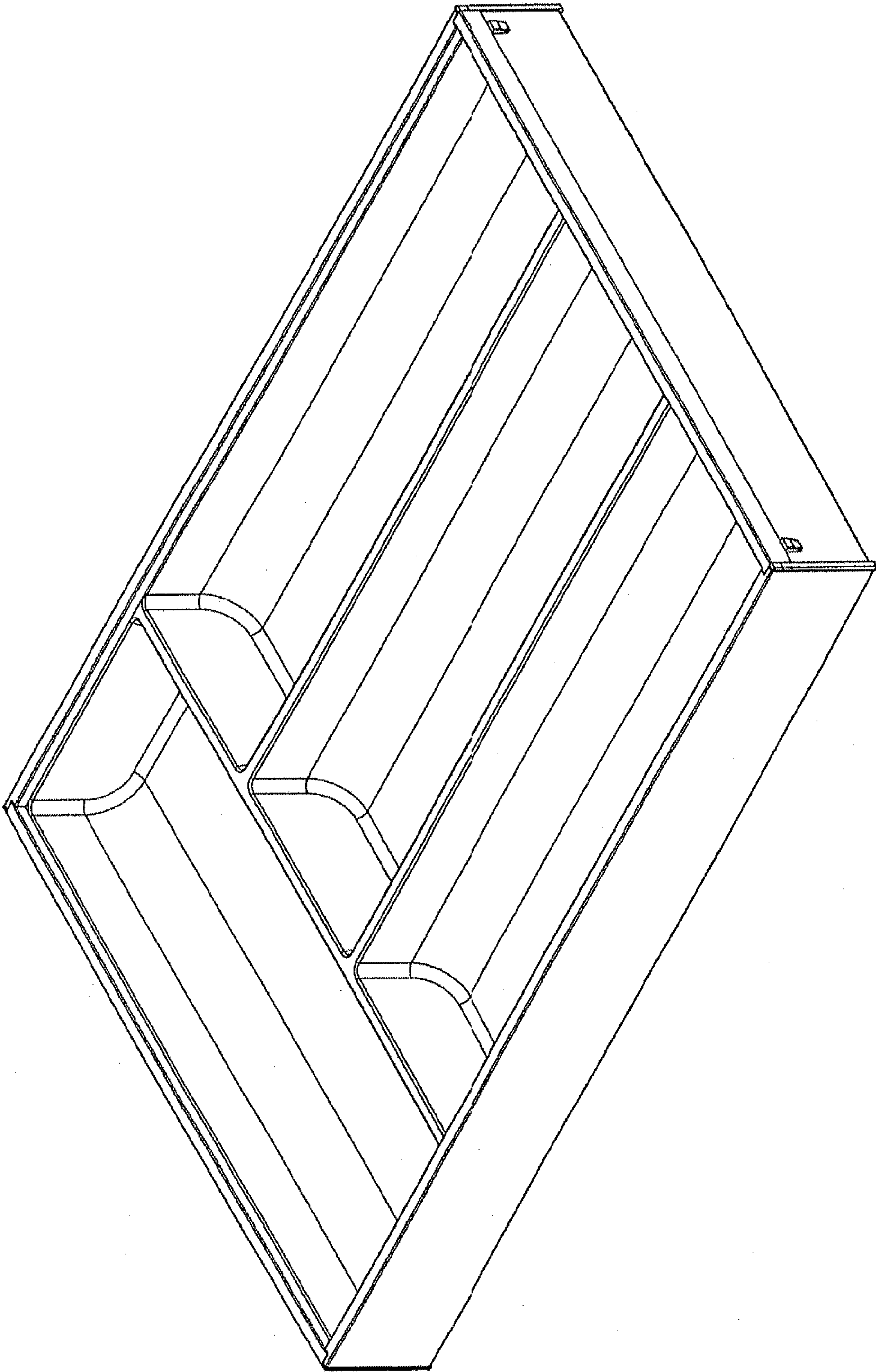

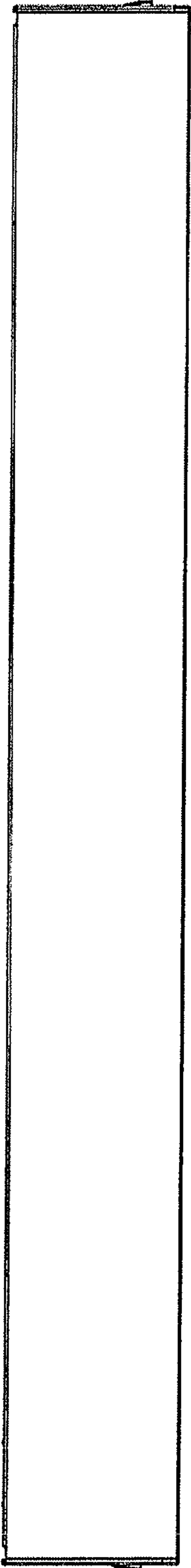

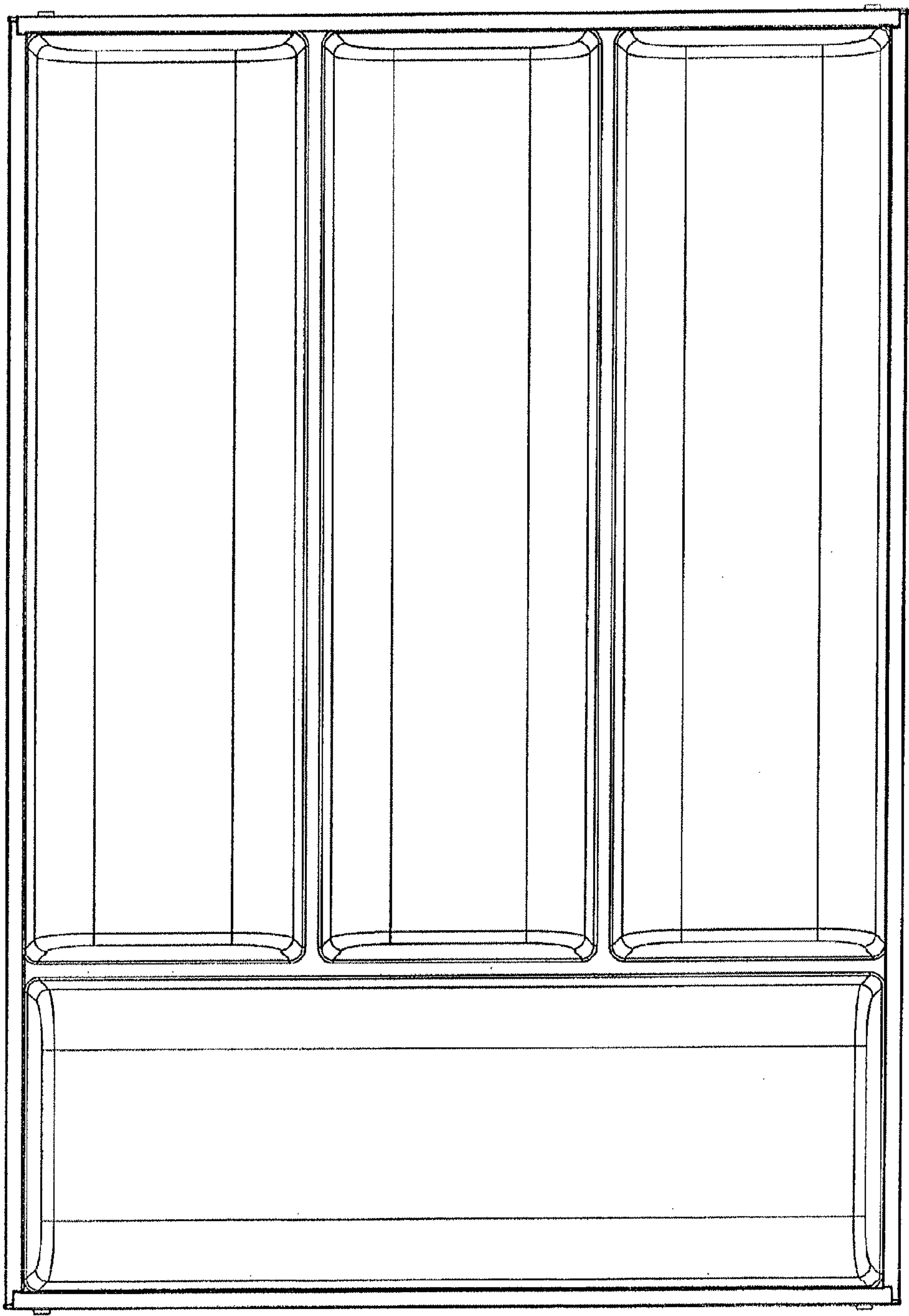

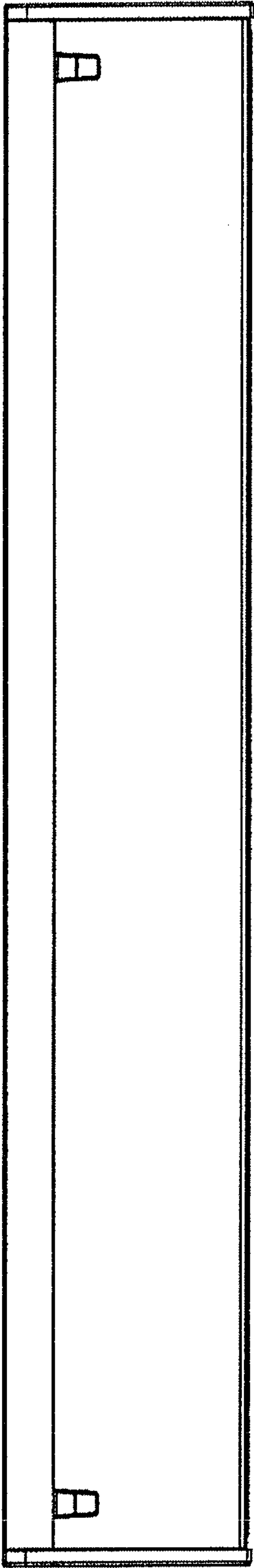

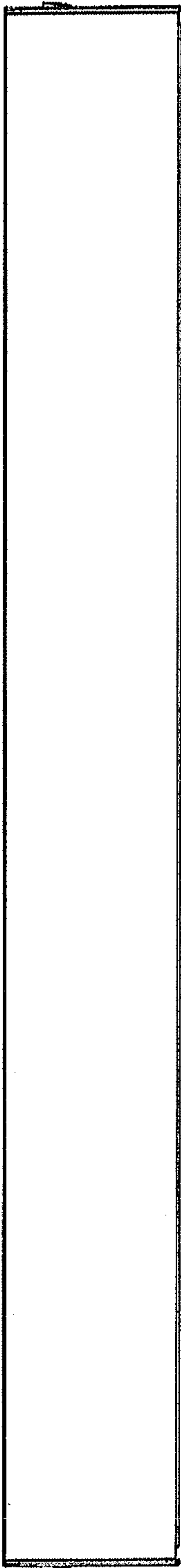

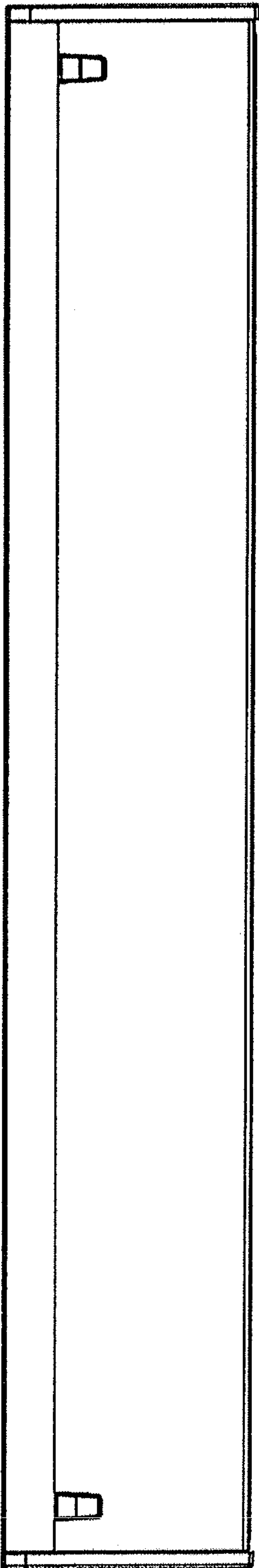
