**DESCRIPTION**

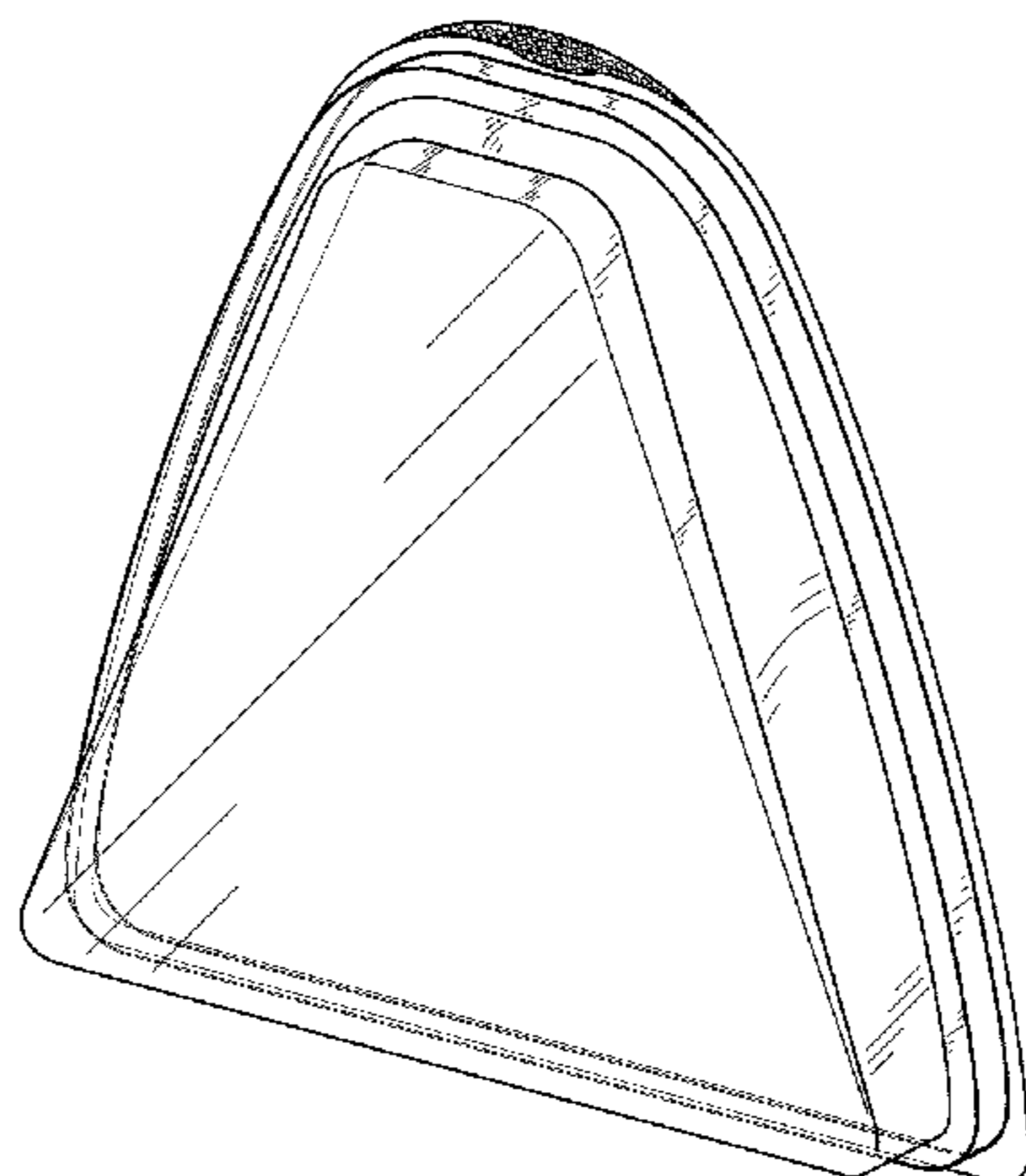
FIG. 1 is a perspective view of a clamshell package showing my new design;

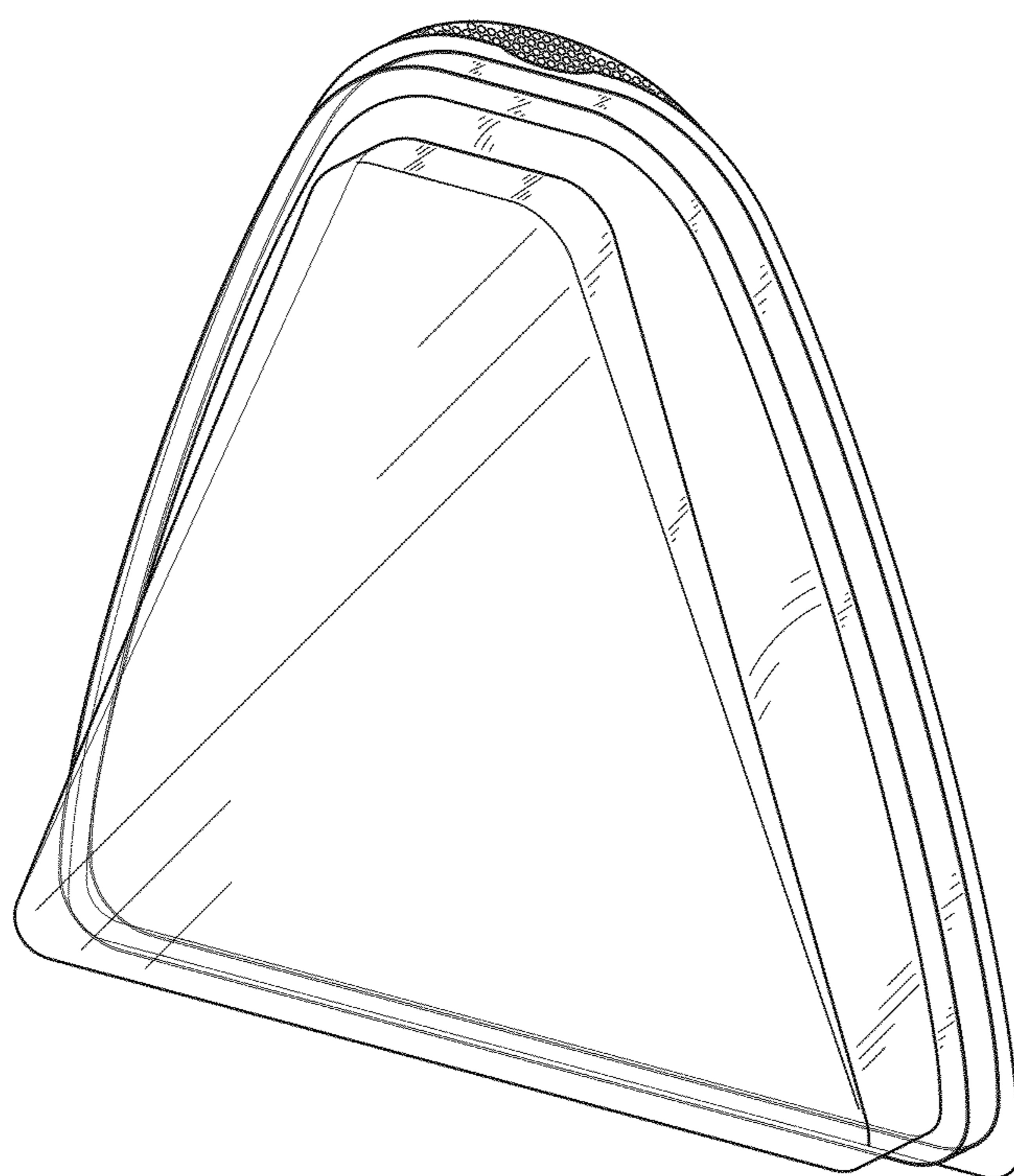

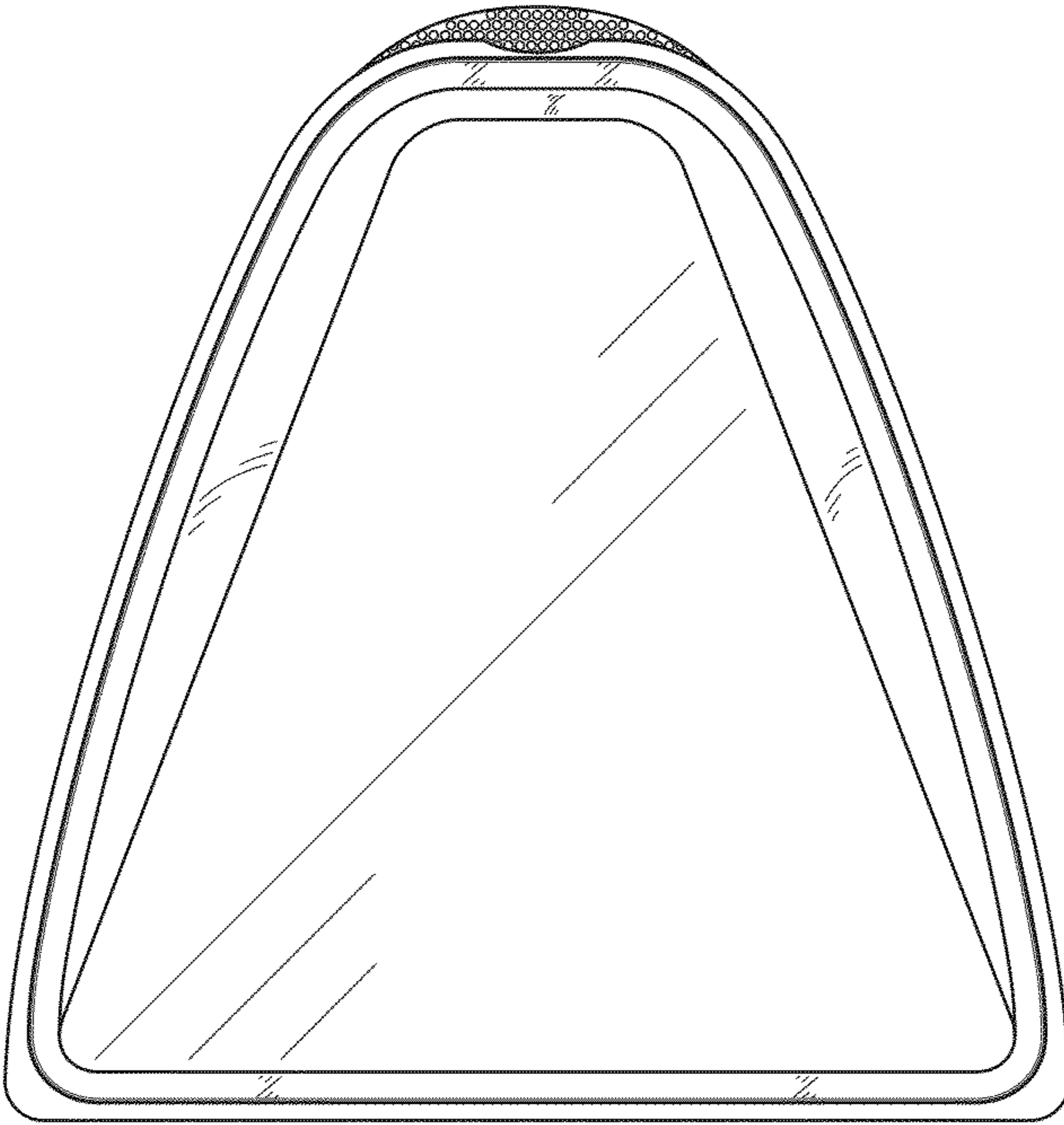

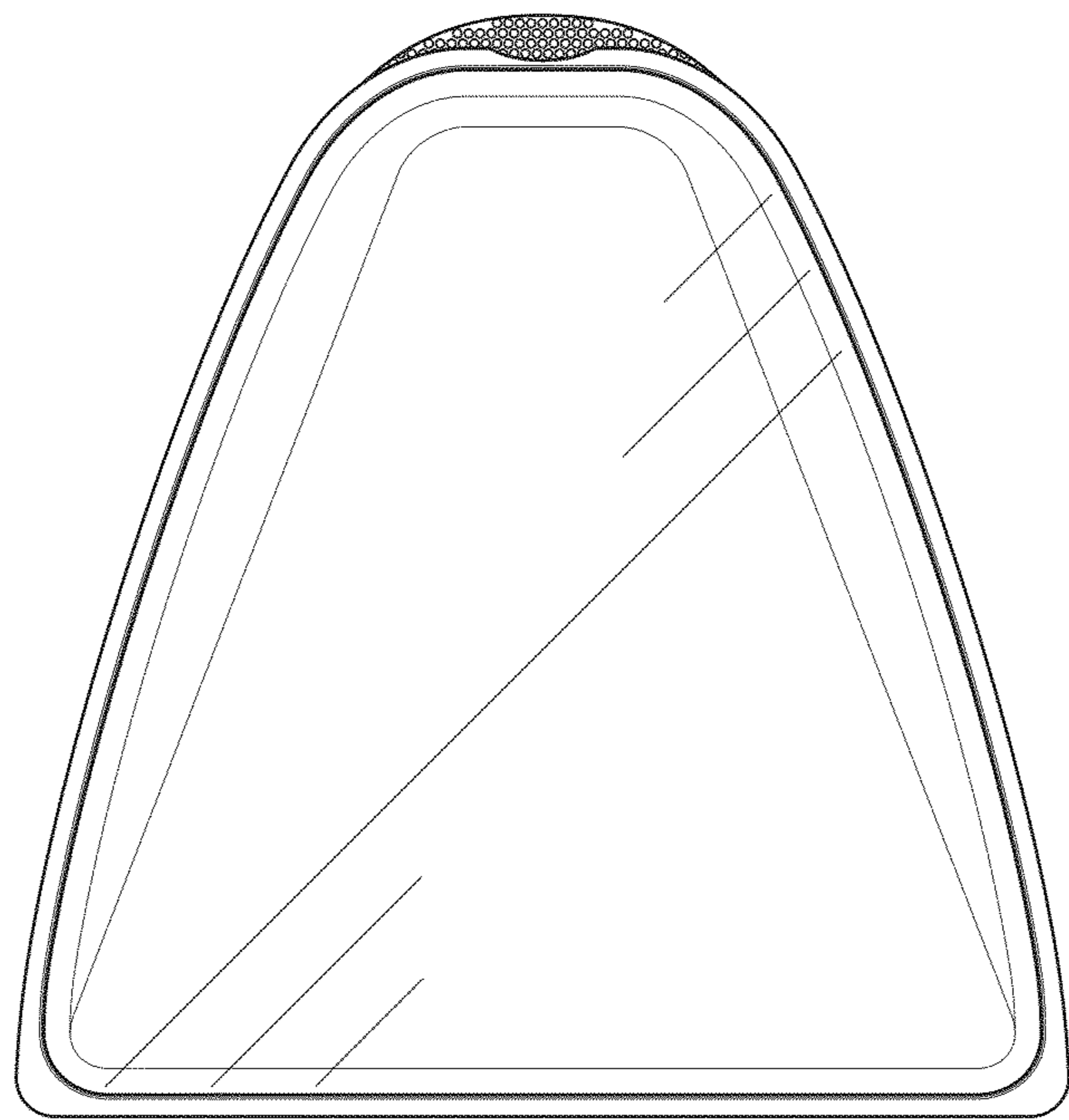

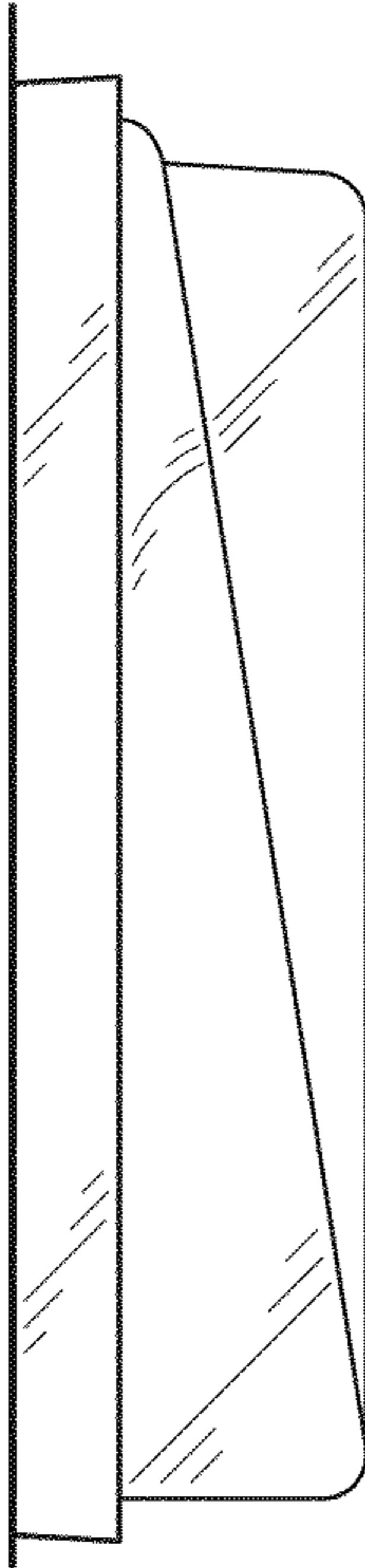

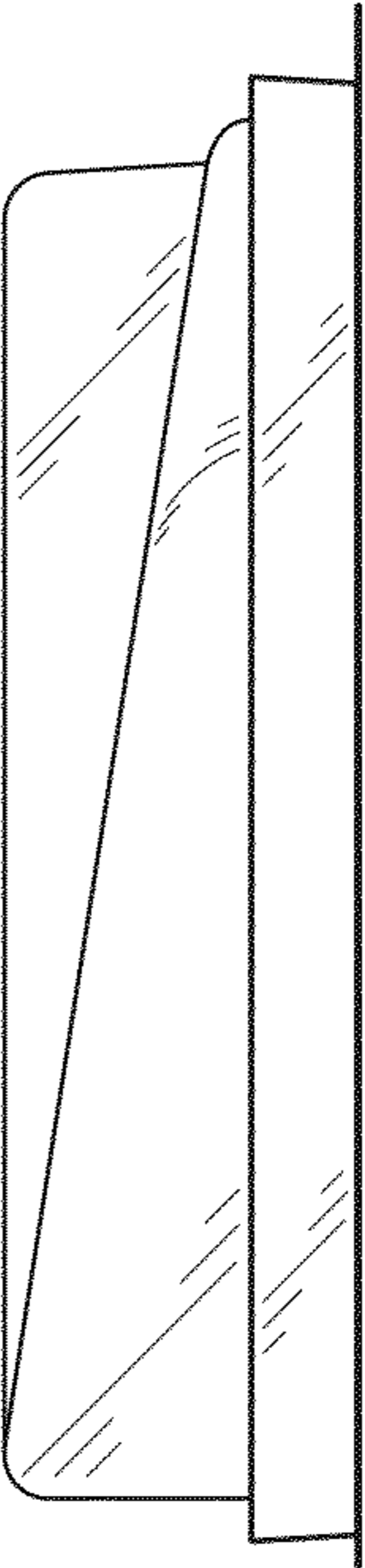

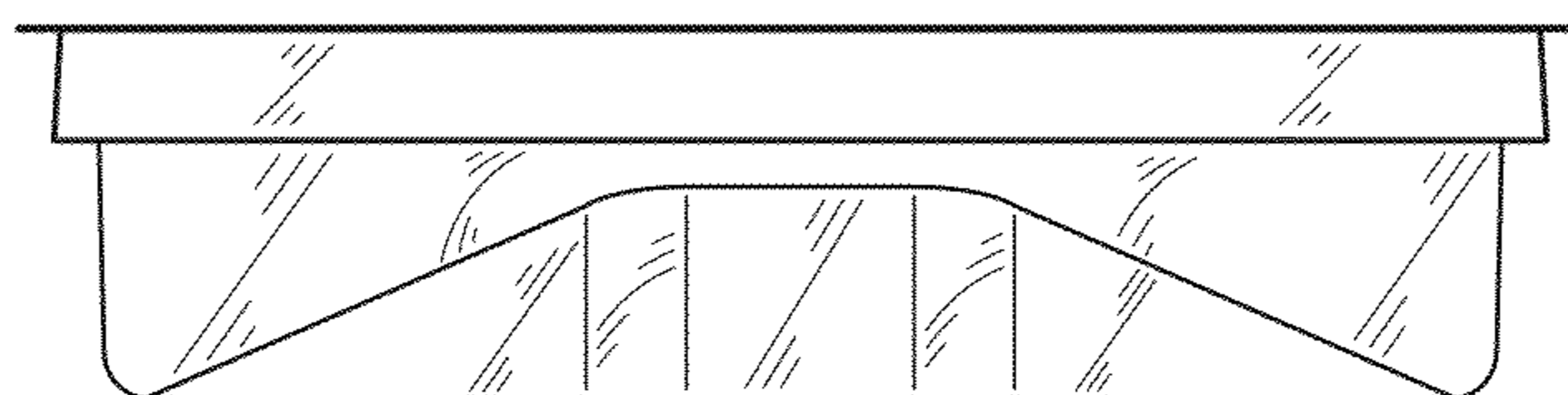

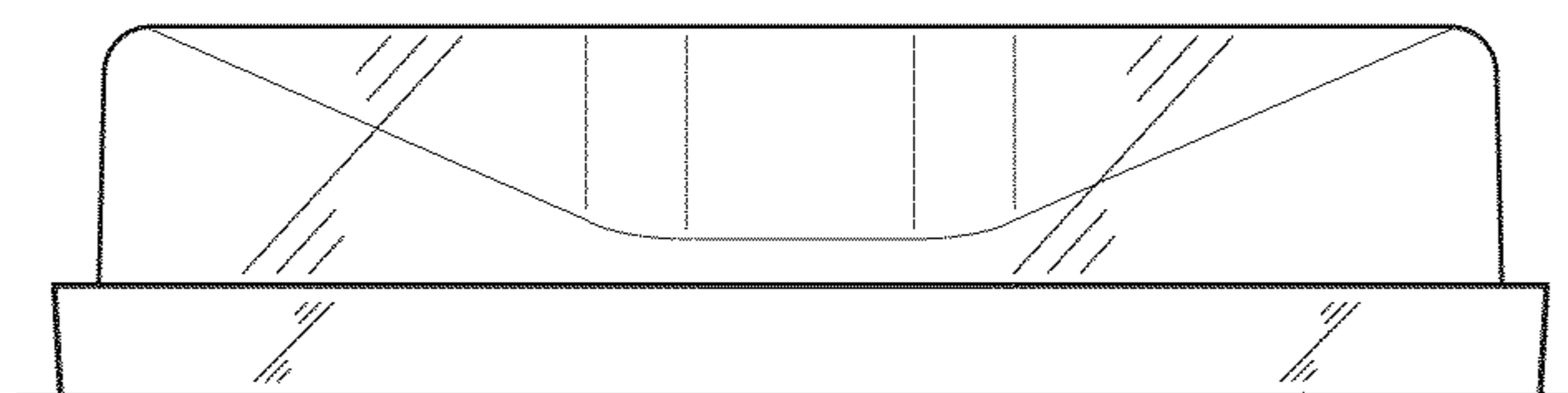
