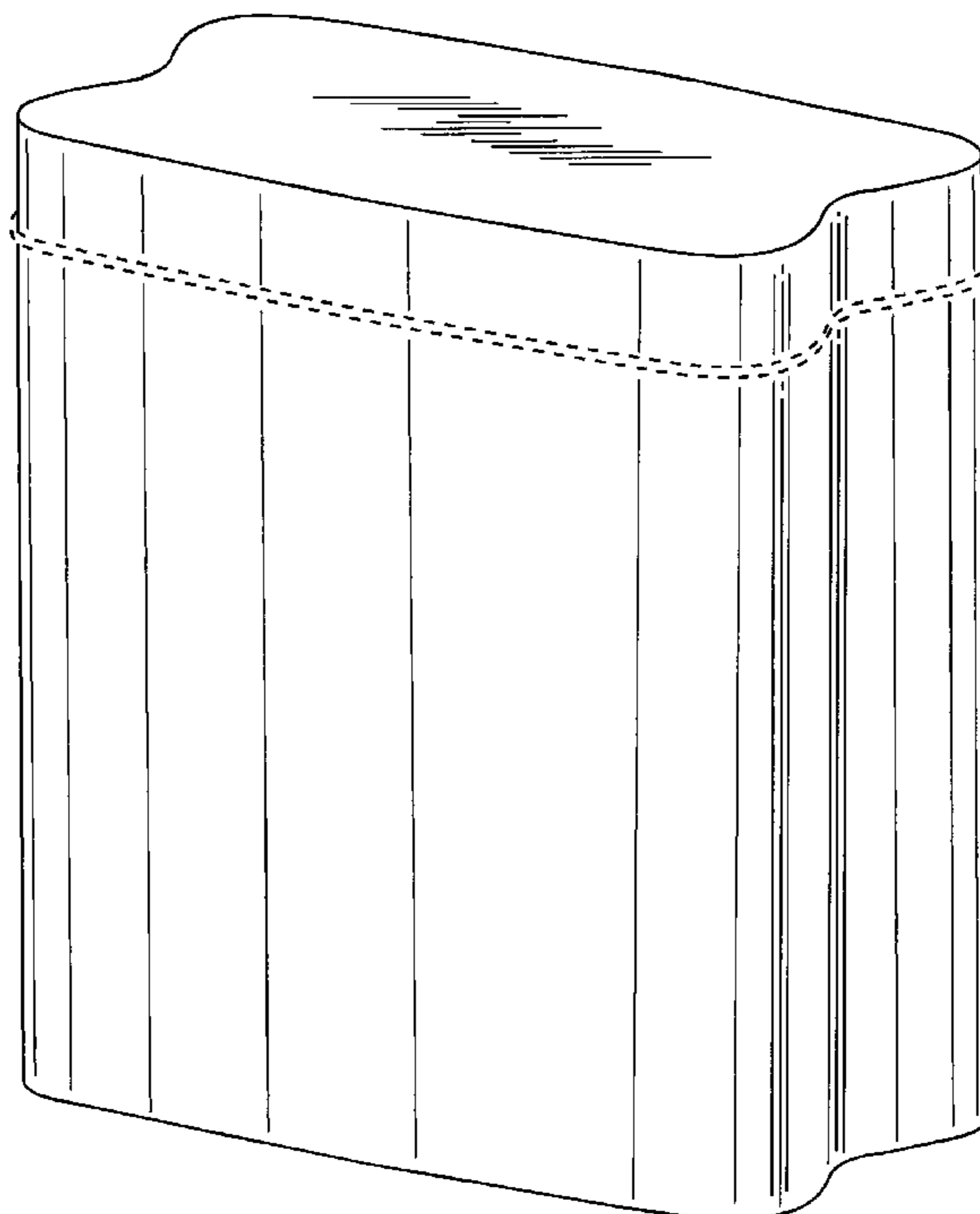

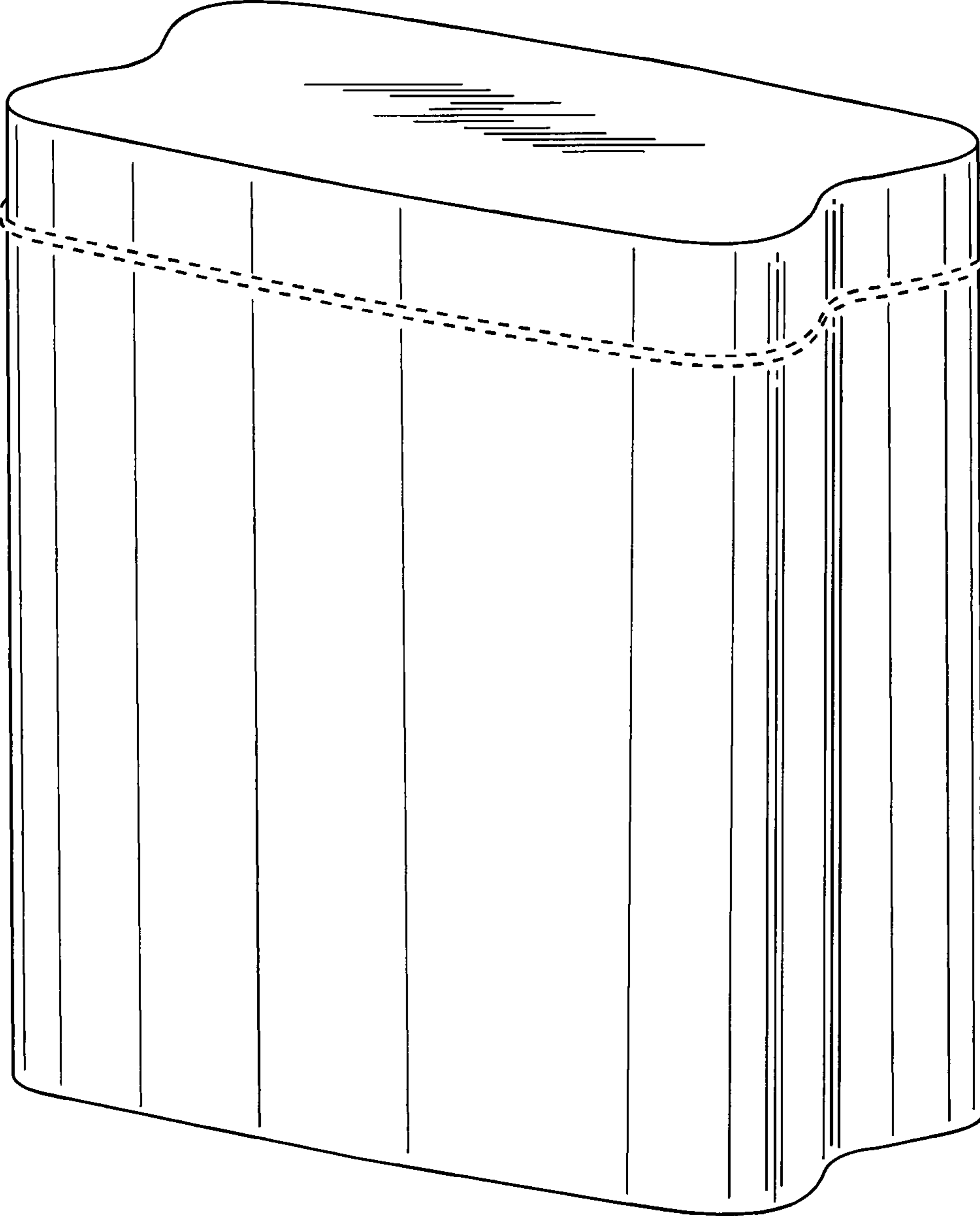
The ornamental design for a concave hexagonal rigid container, as shown and described.

**DESCRIPTION**

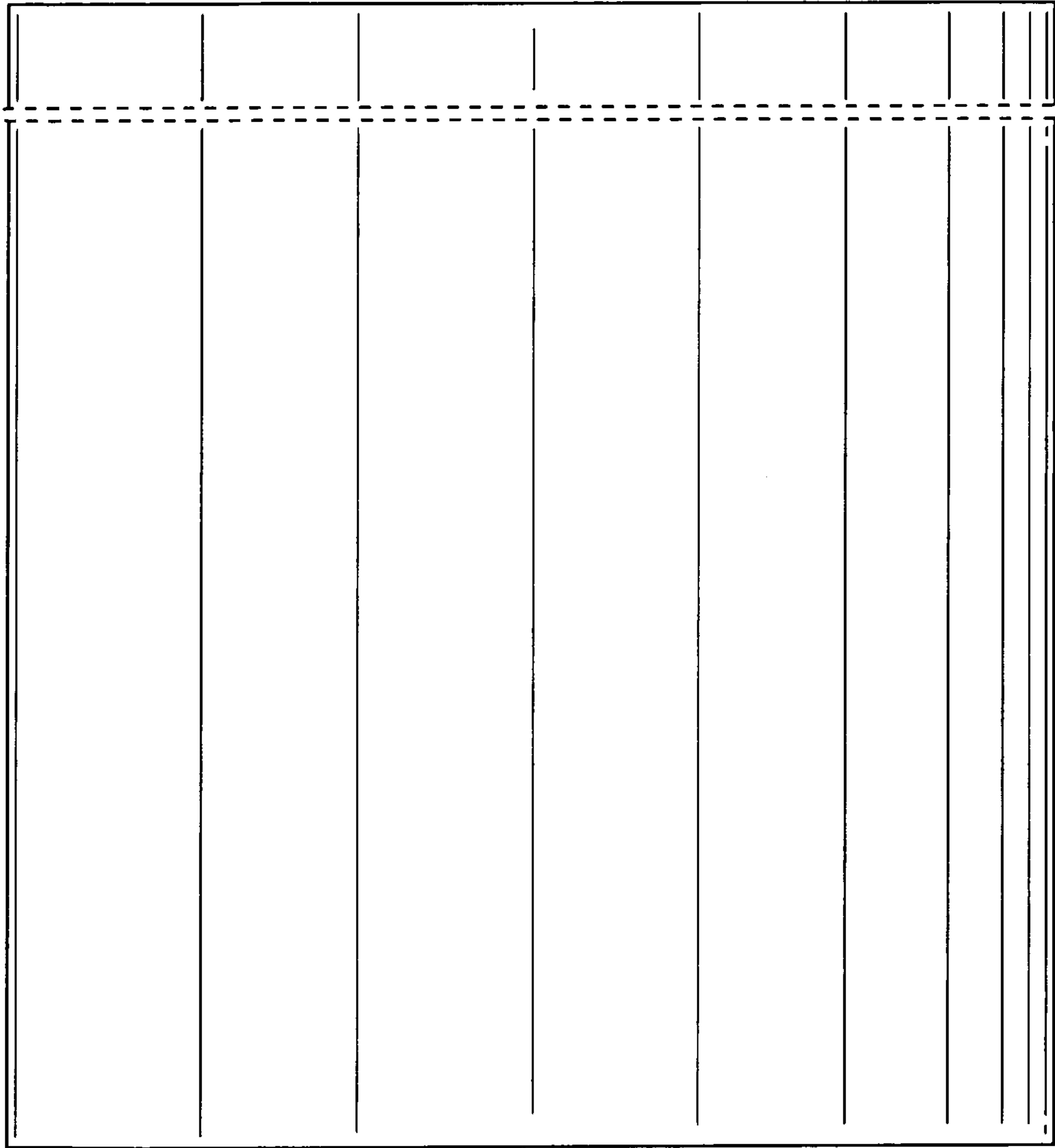
FIG. 1 is a front perspective view of a concave hexagonal rigid container, showing my new design;

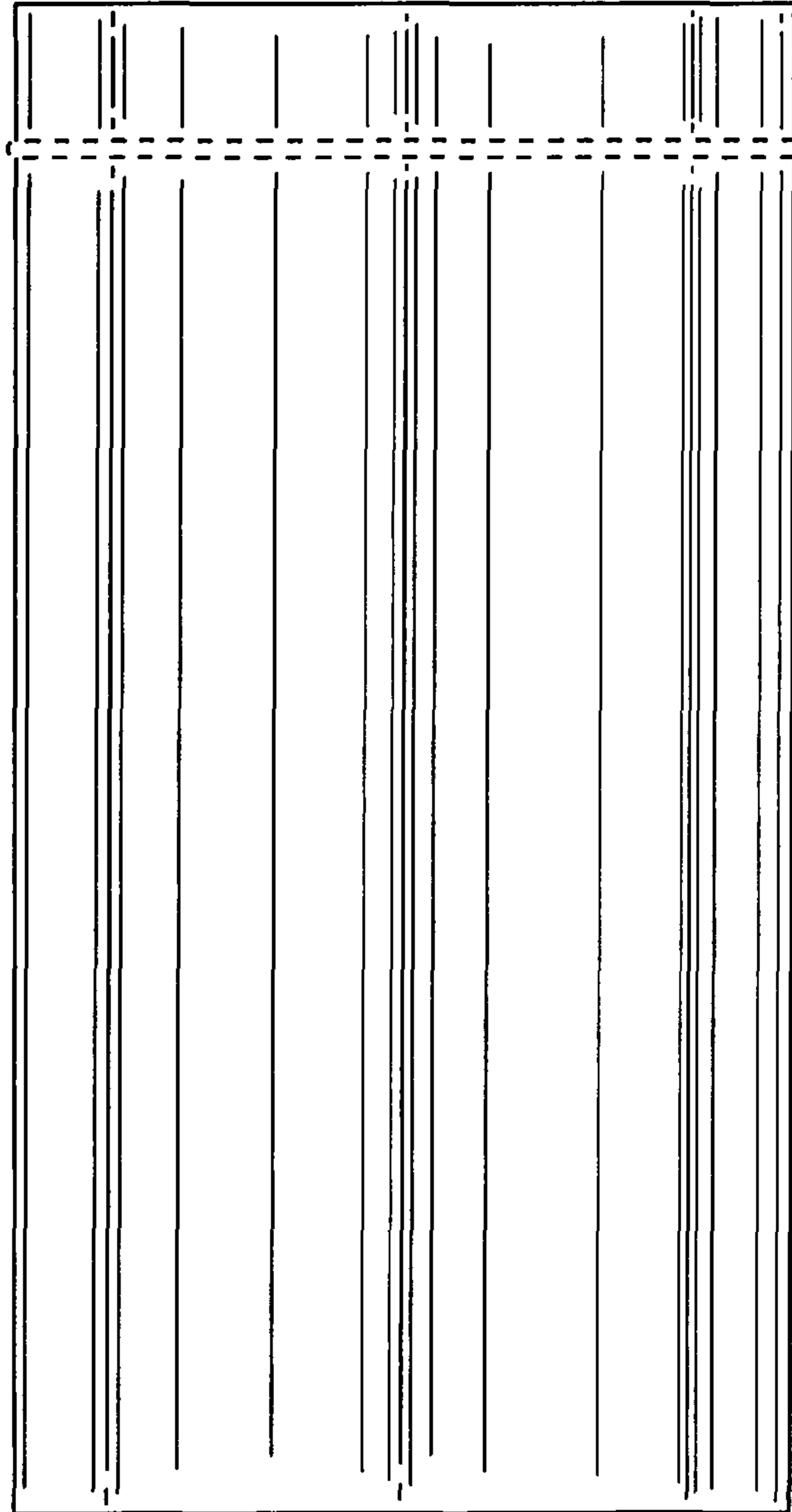




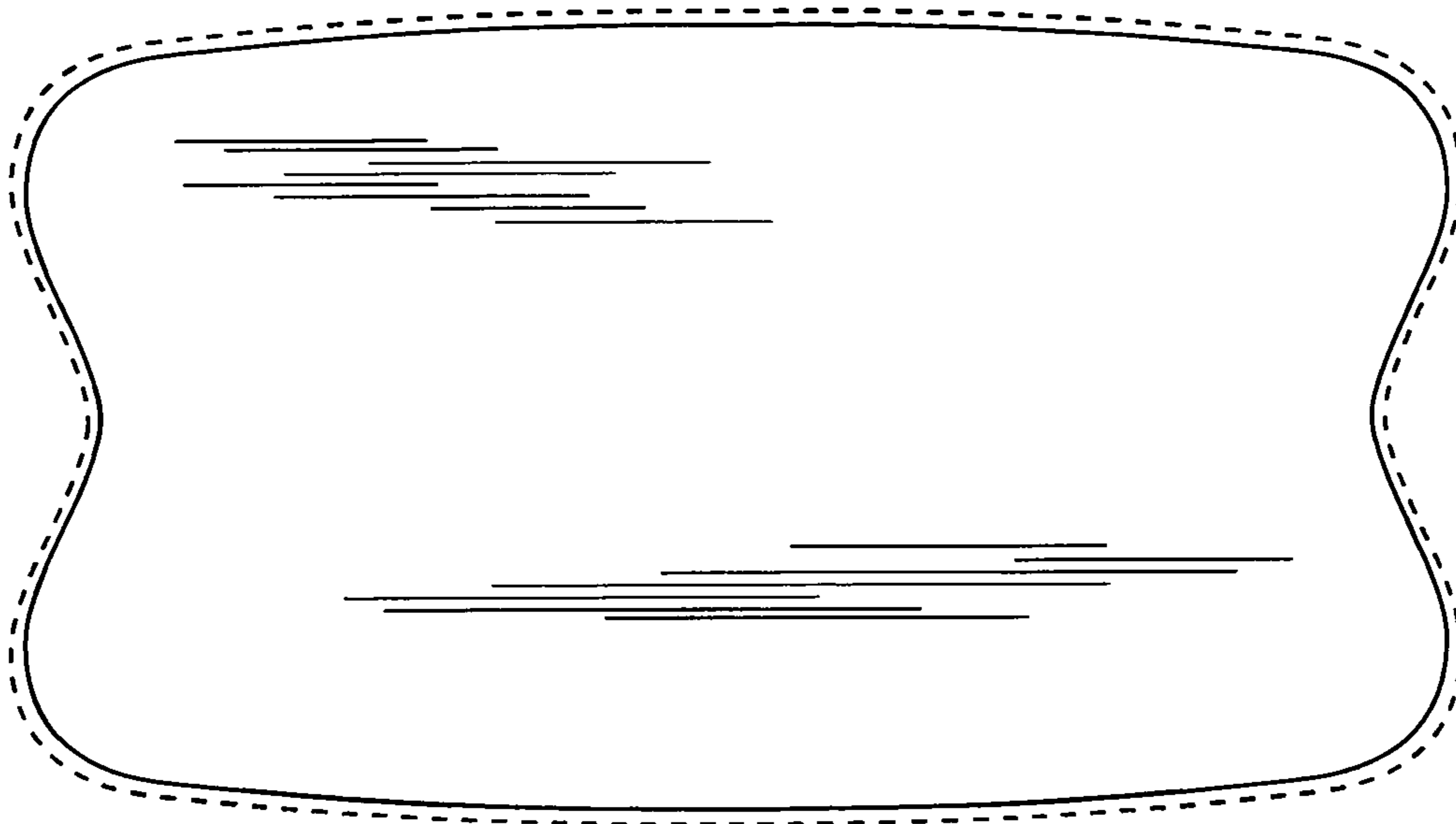
