DESCRIPTION

FIG. 1 is a front elevational view of automobile adornment showing our new design;
 FIG. 2 is a rear elevational view thereof;
 FIG. 3 is a right side view thereof;
 FIG. 4 is a left side view thereof;
 FIG. 5 is a top view thereof;
 FIG. 6 is a bottom view thereof; and,
 FIG. 7 is a front elevational view of our new automobile adornment design applied to an automobile.

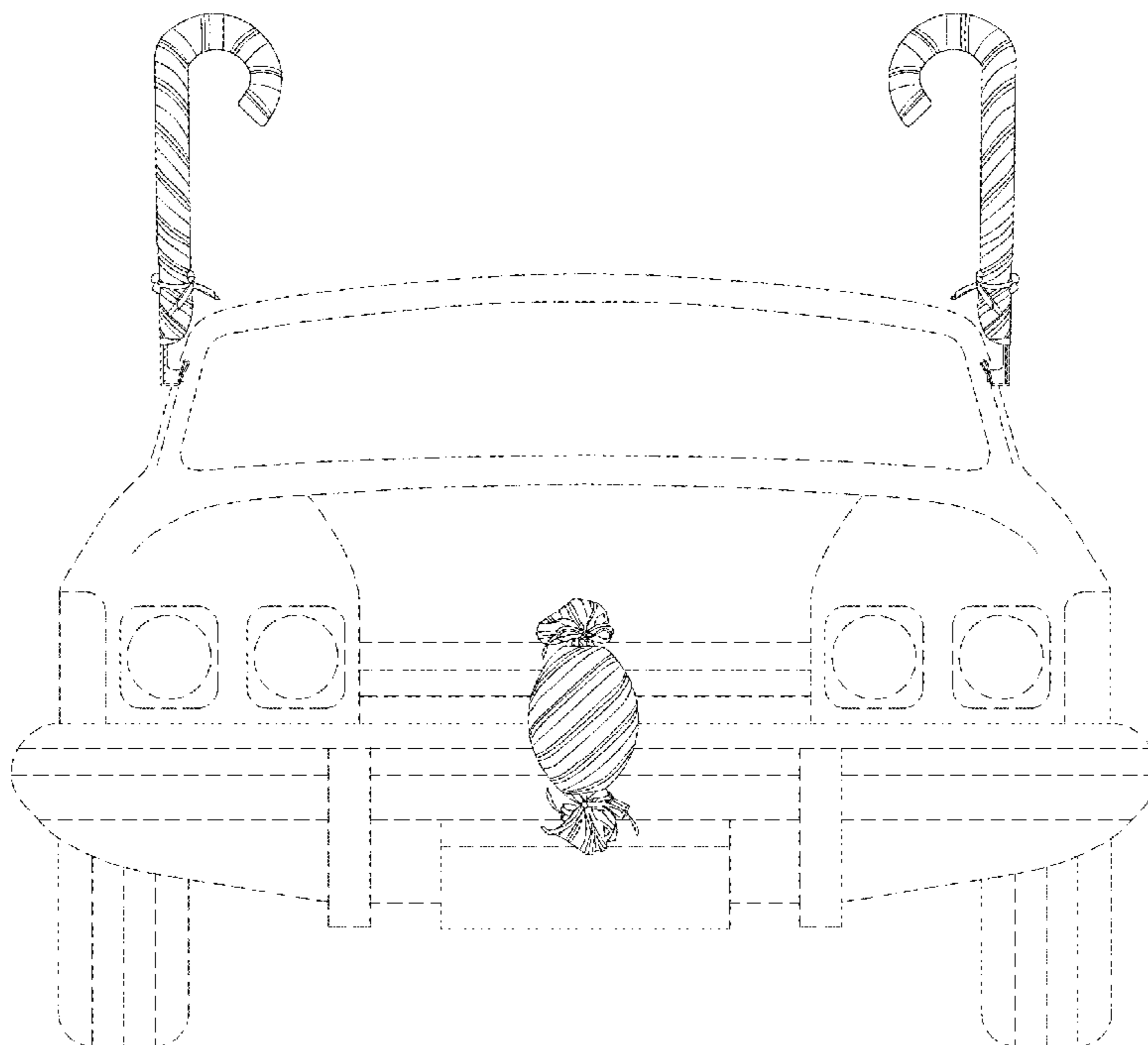

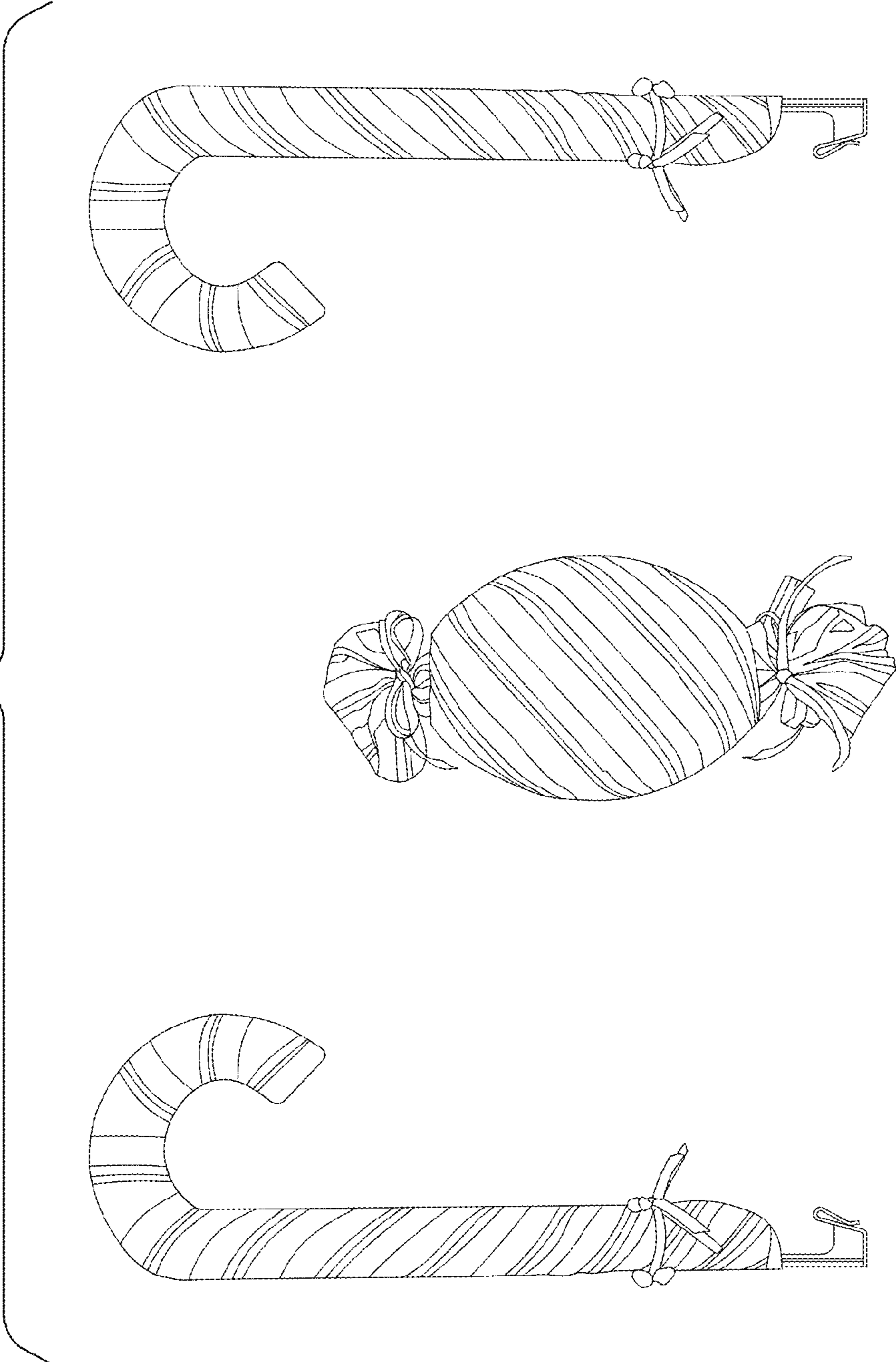

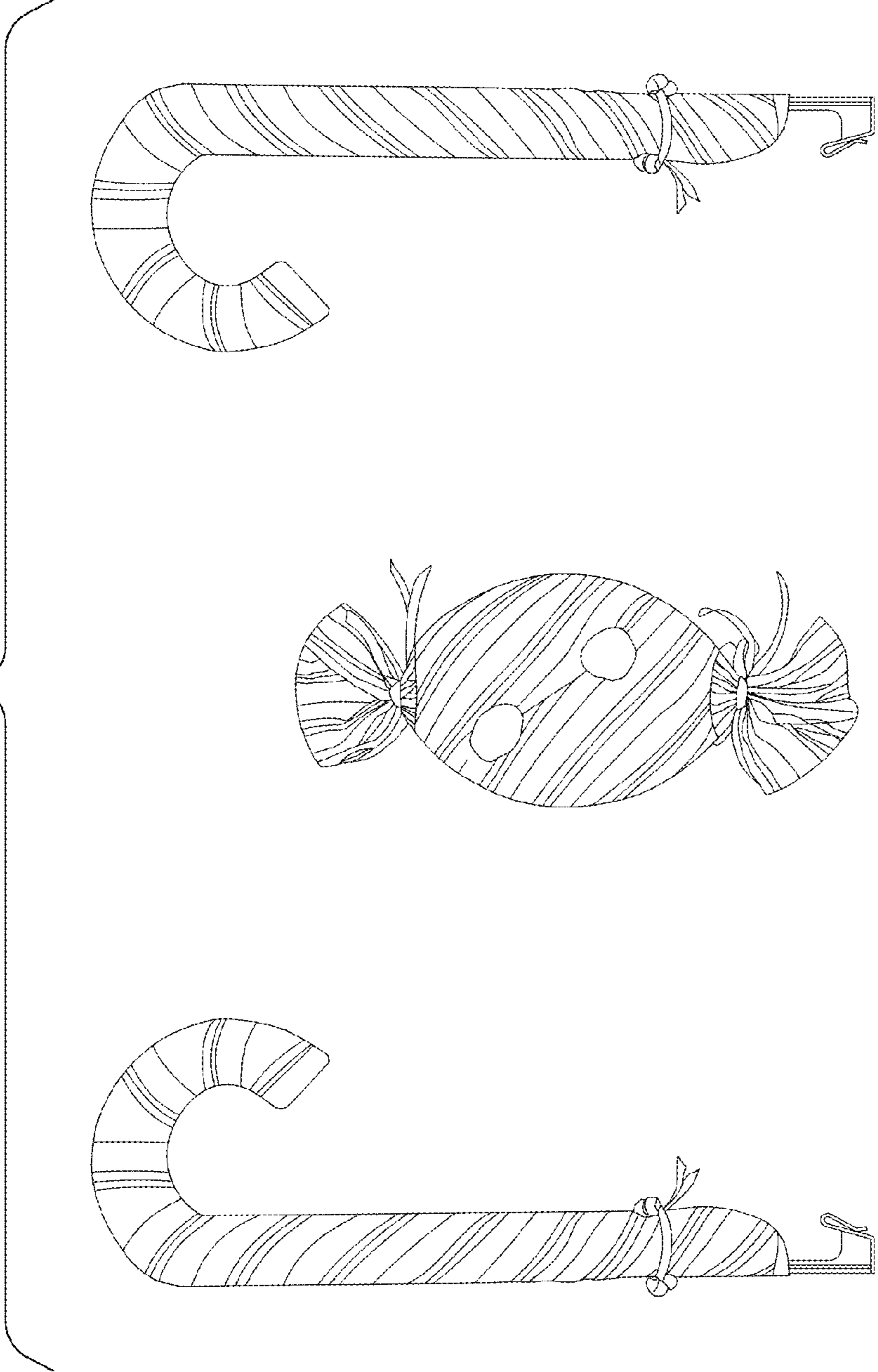

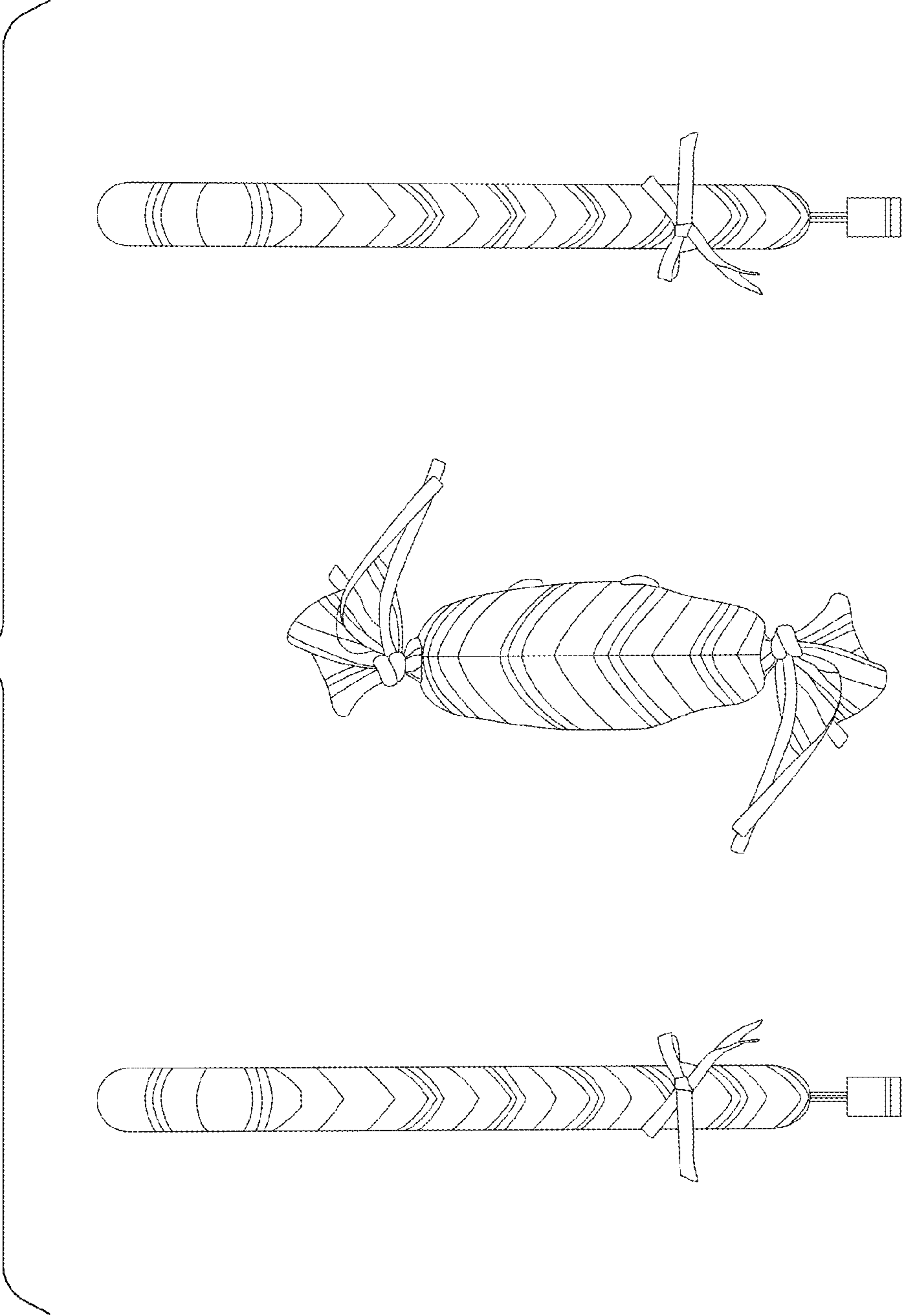

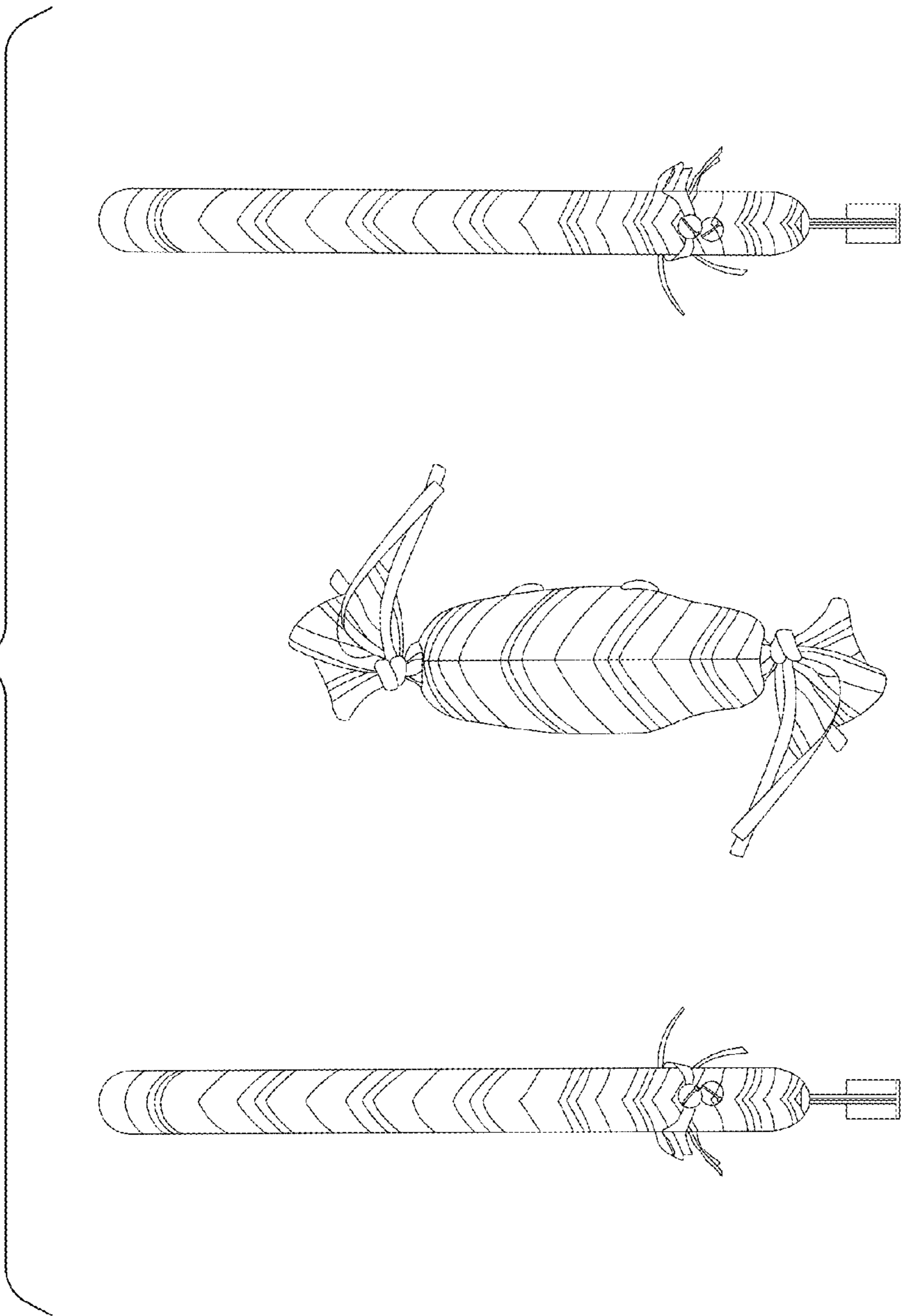

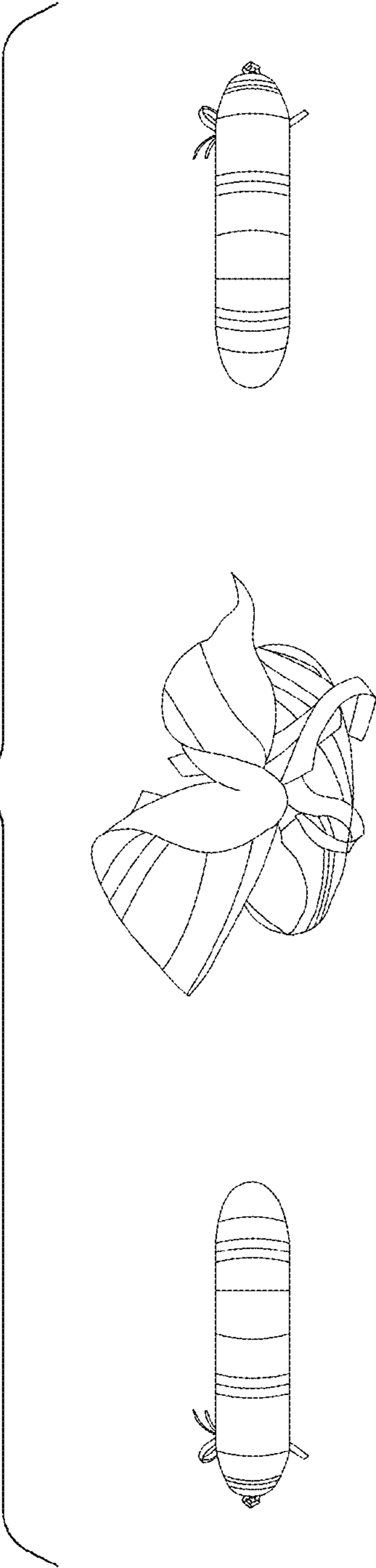

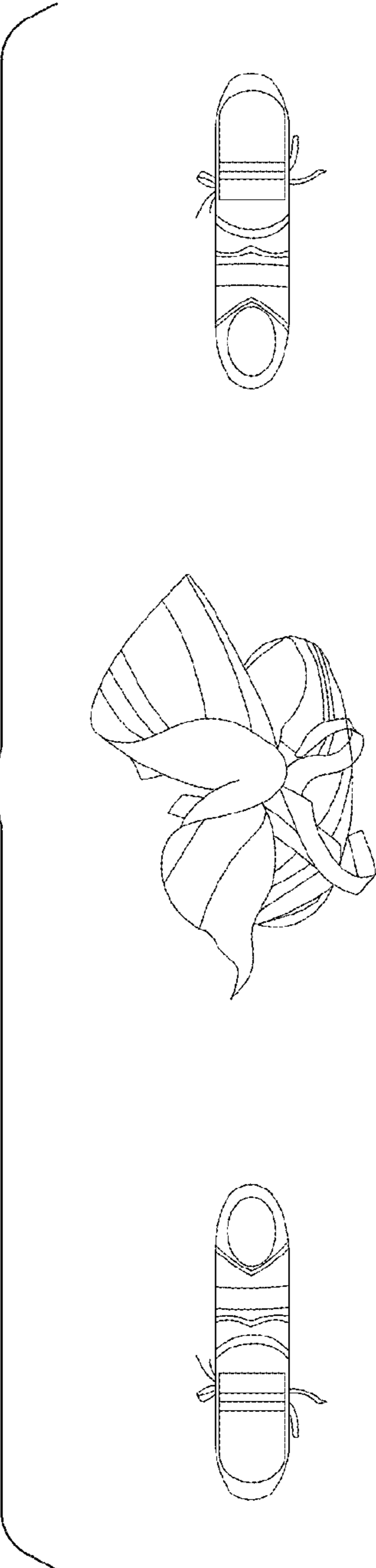
