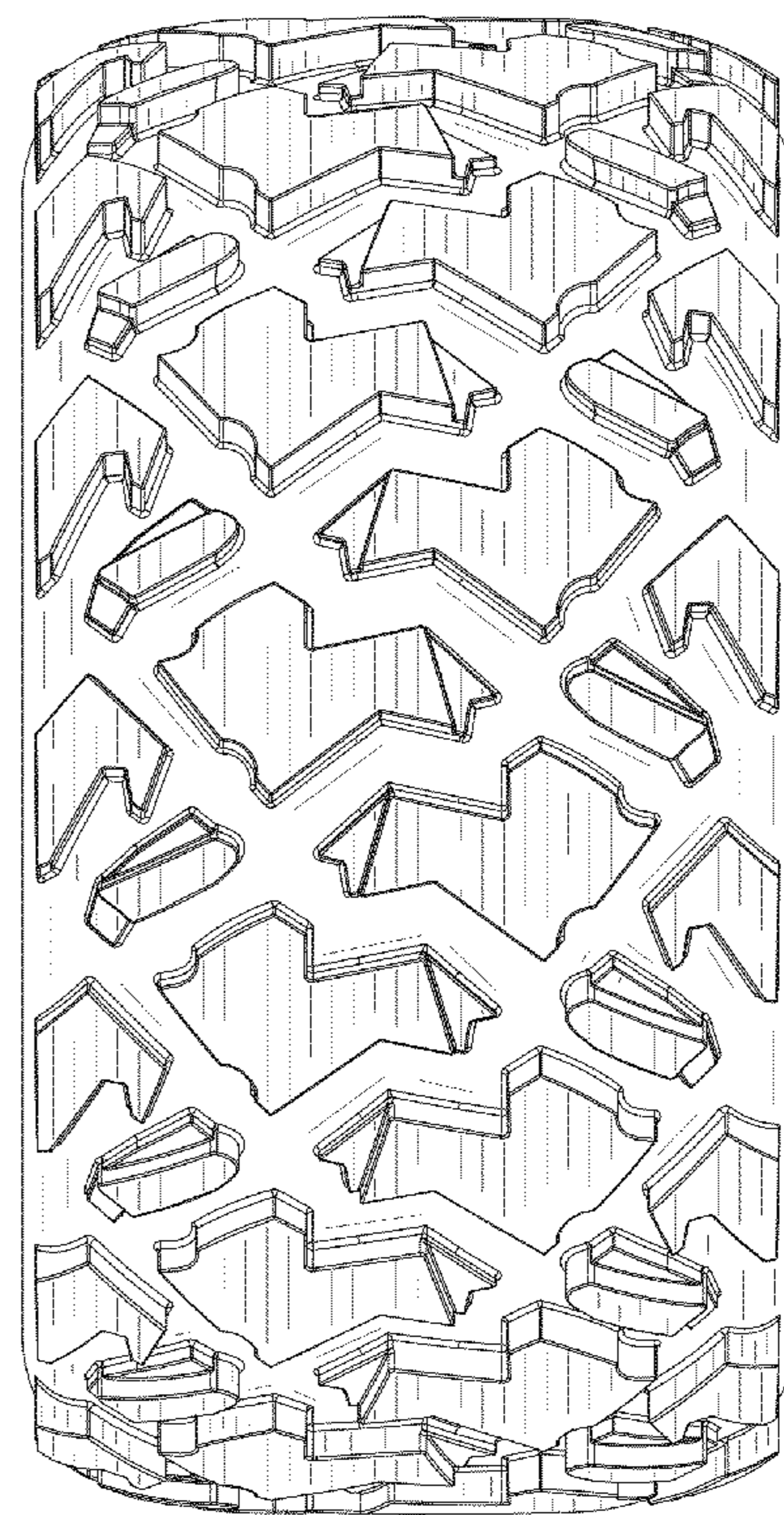
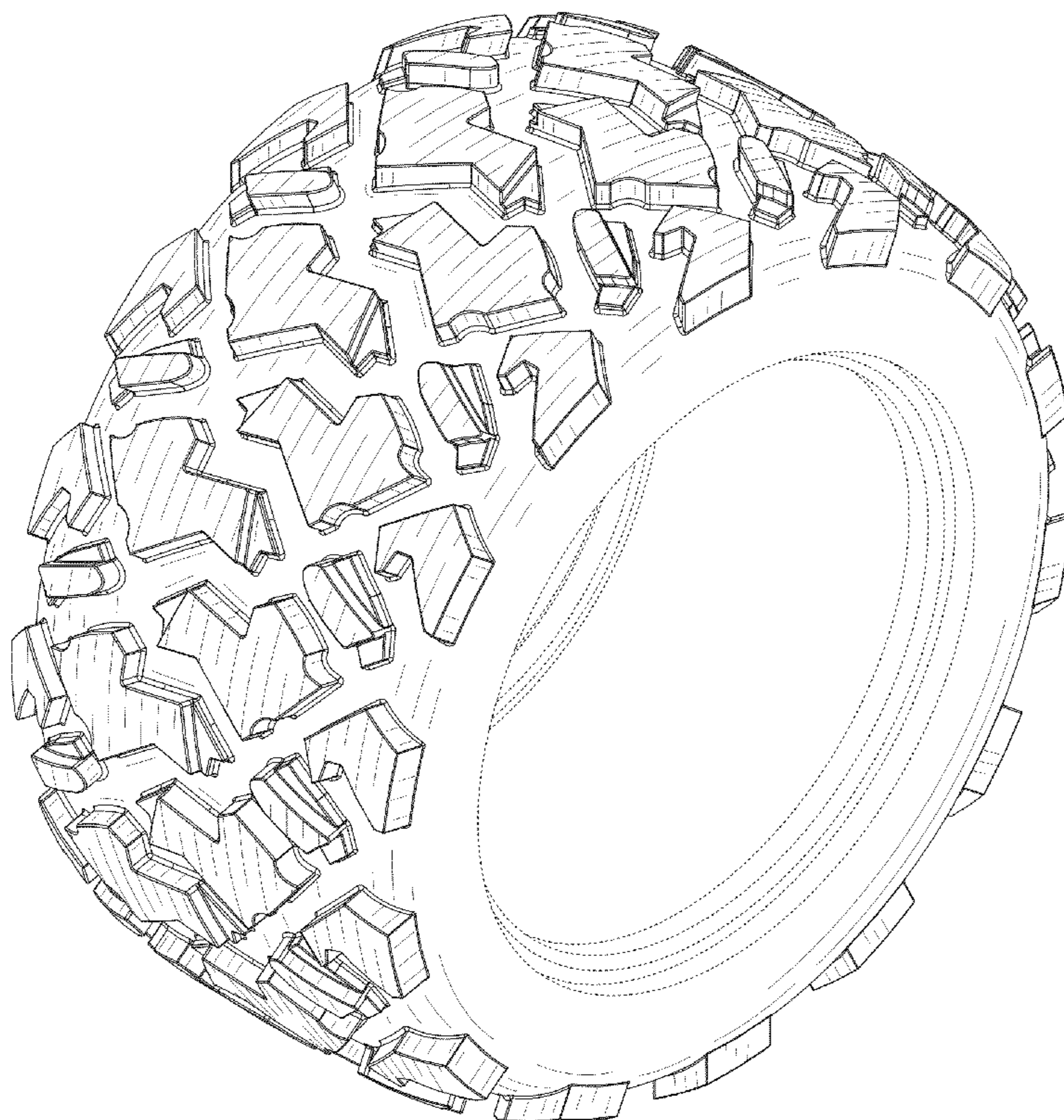
(57) **CLAIM**

We claim the ornamental design for a tire tread, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tire tread taken from the front, top and right side, it being understood that the pattern repeats uniformly throughout the circumference of the tread; FIG. 2 is a side elevation view thereof; and, FIG. 3 is a front elevation view thereof. The portions of the figures presented in dotted lines show environmental structure that forms no part of the claimed design.

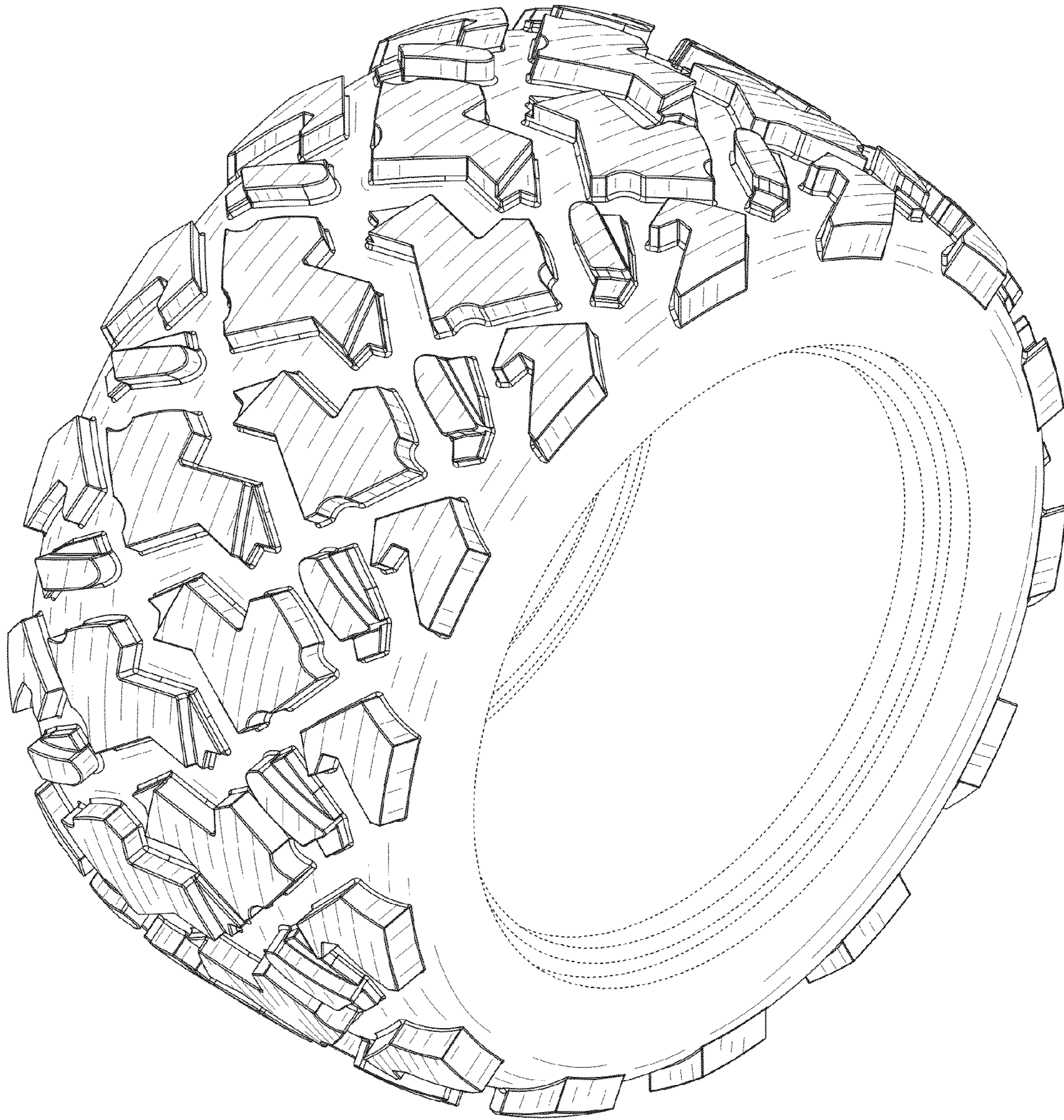

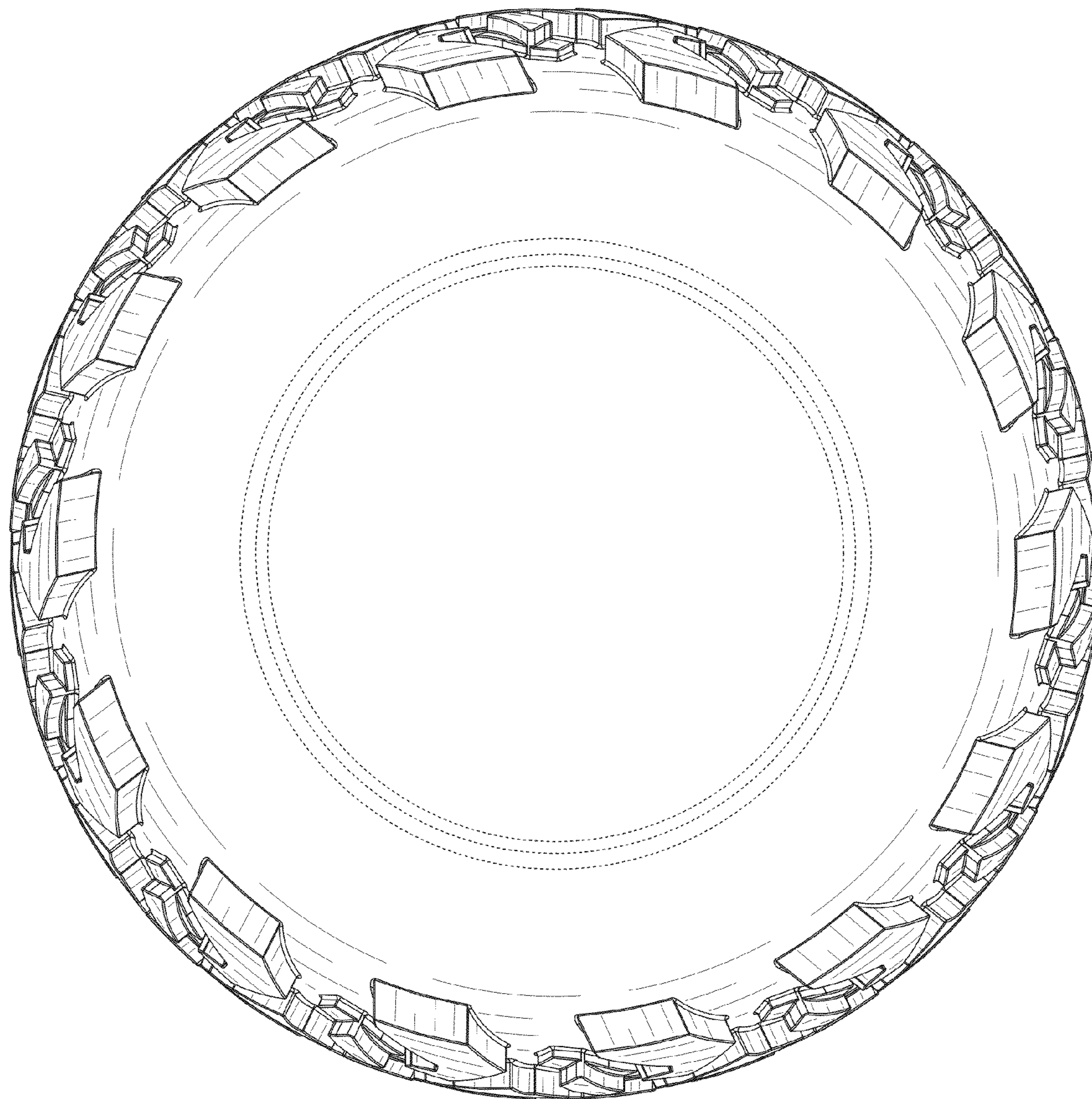

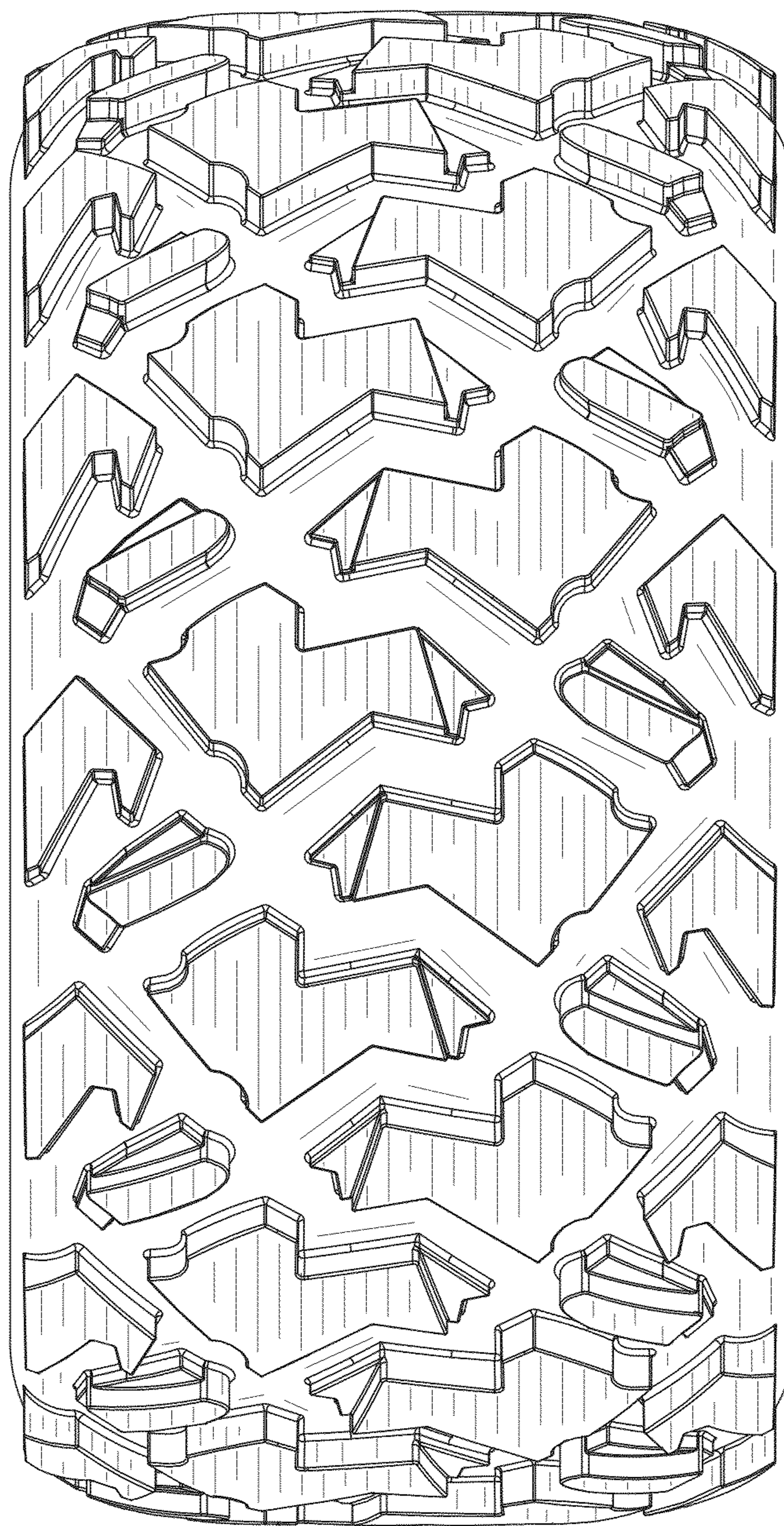
