DESCRIPTION

FIG. 1 is a top, front and left side perspective view of an instant camera showing my new design; FIG. 2 is a top, rear and right side perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a left side elevational view thereof; FIG. 8 is a right side elevational view thereof; FIG. 9 is a top, front and left side perspective view thereof in a manner of non-use; and, FIG. 10 is a top, front and left side perspective view thereof with a lens barrel protruded.

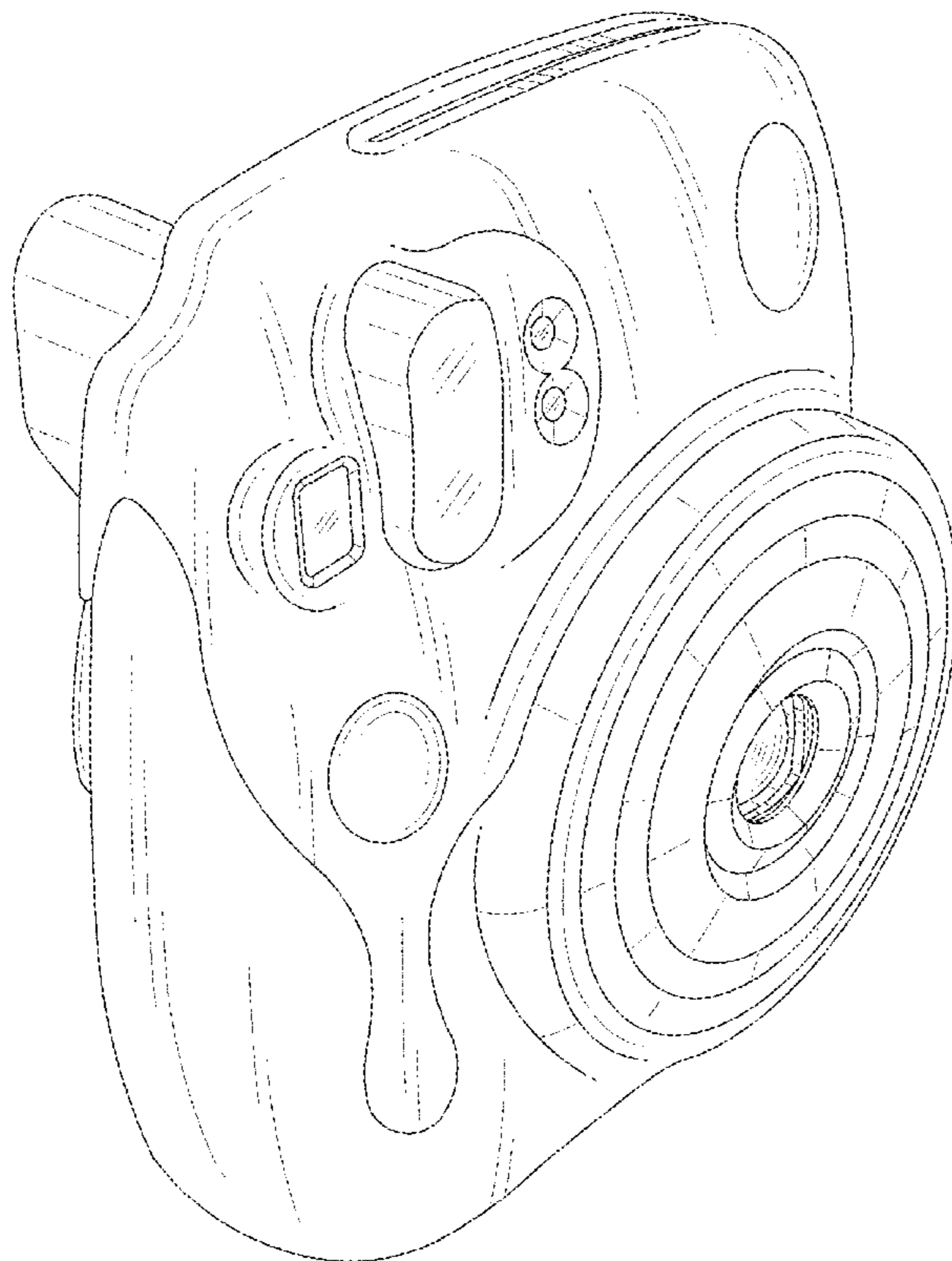

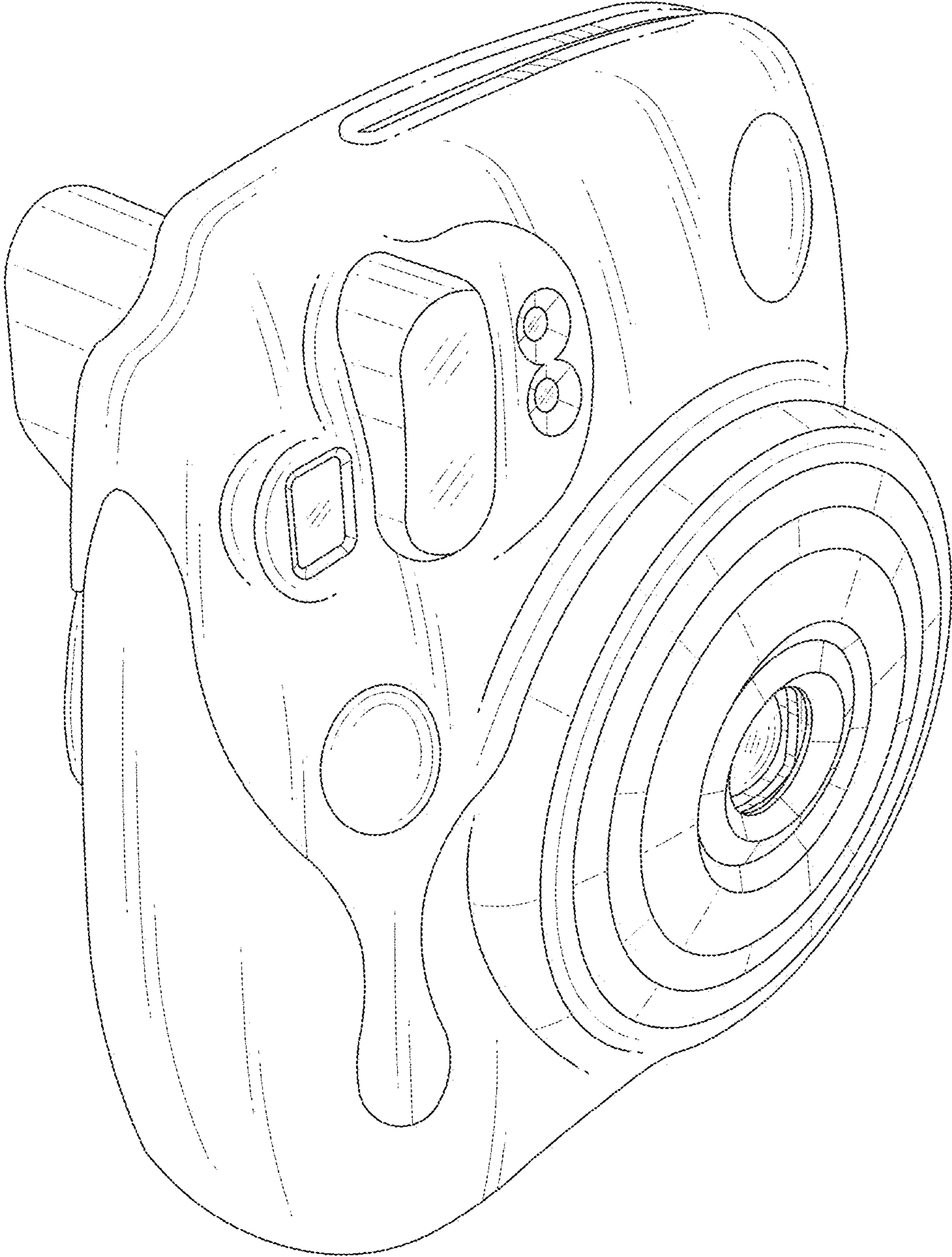

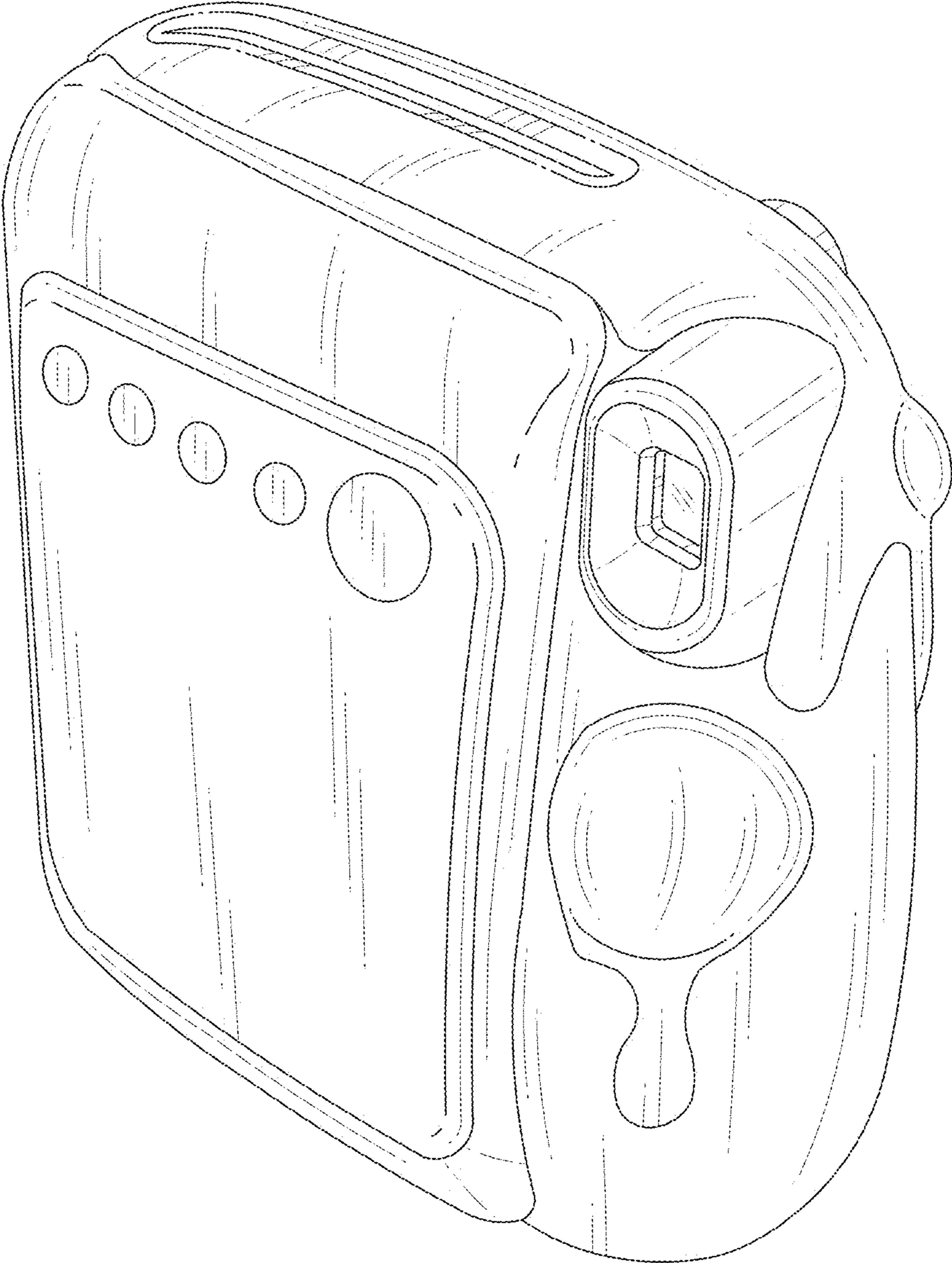

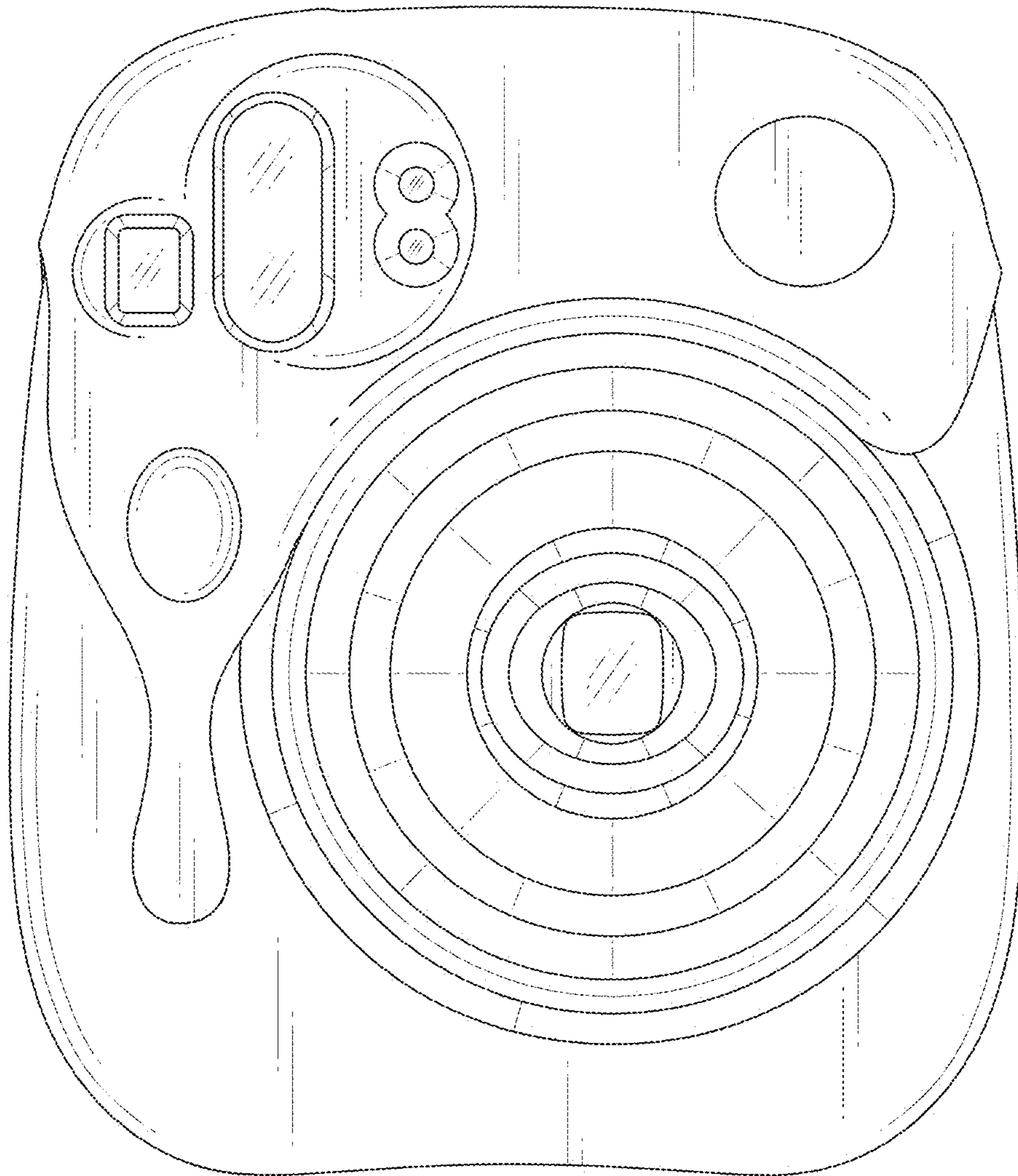

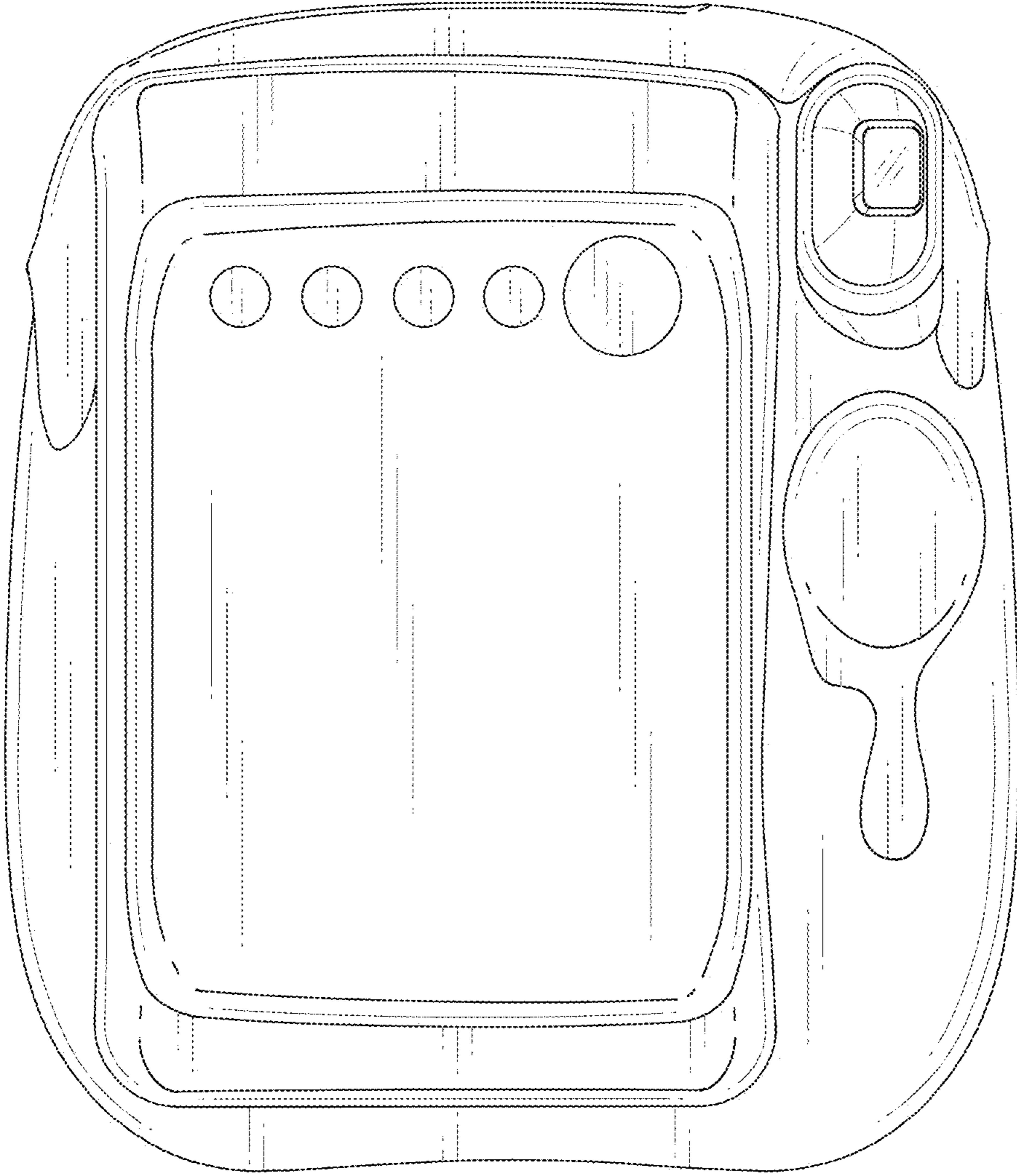

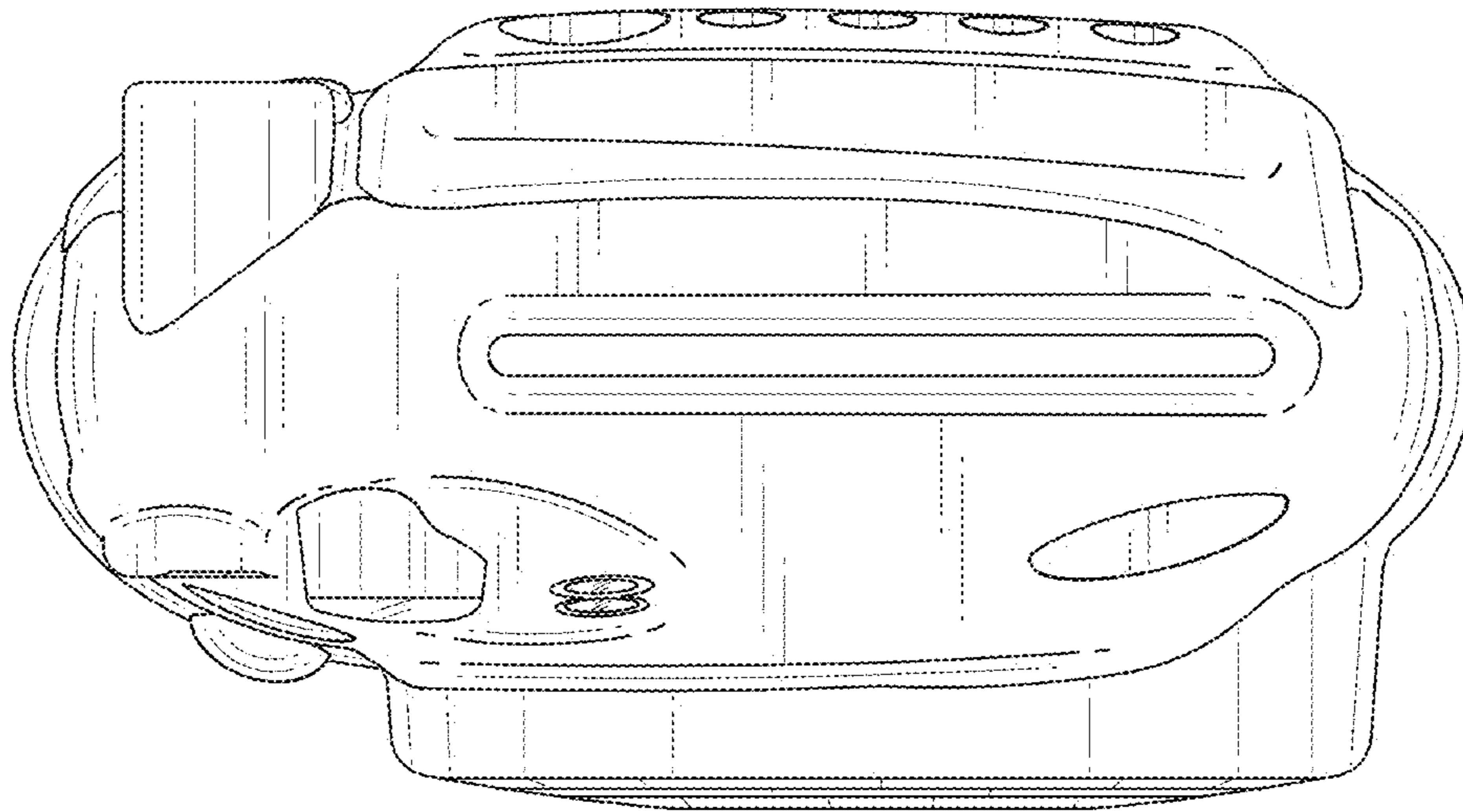

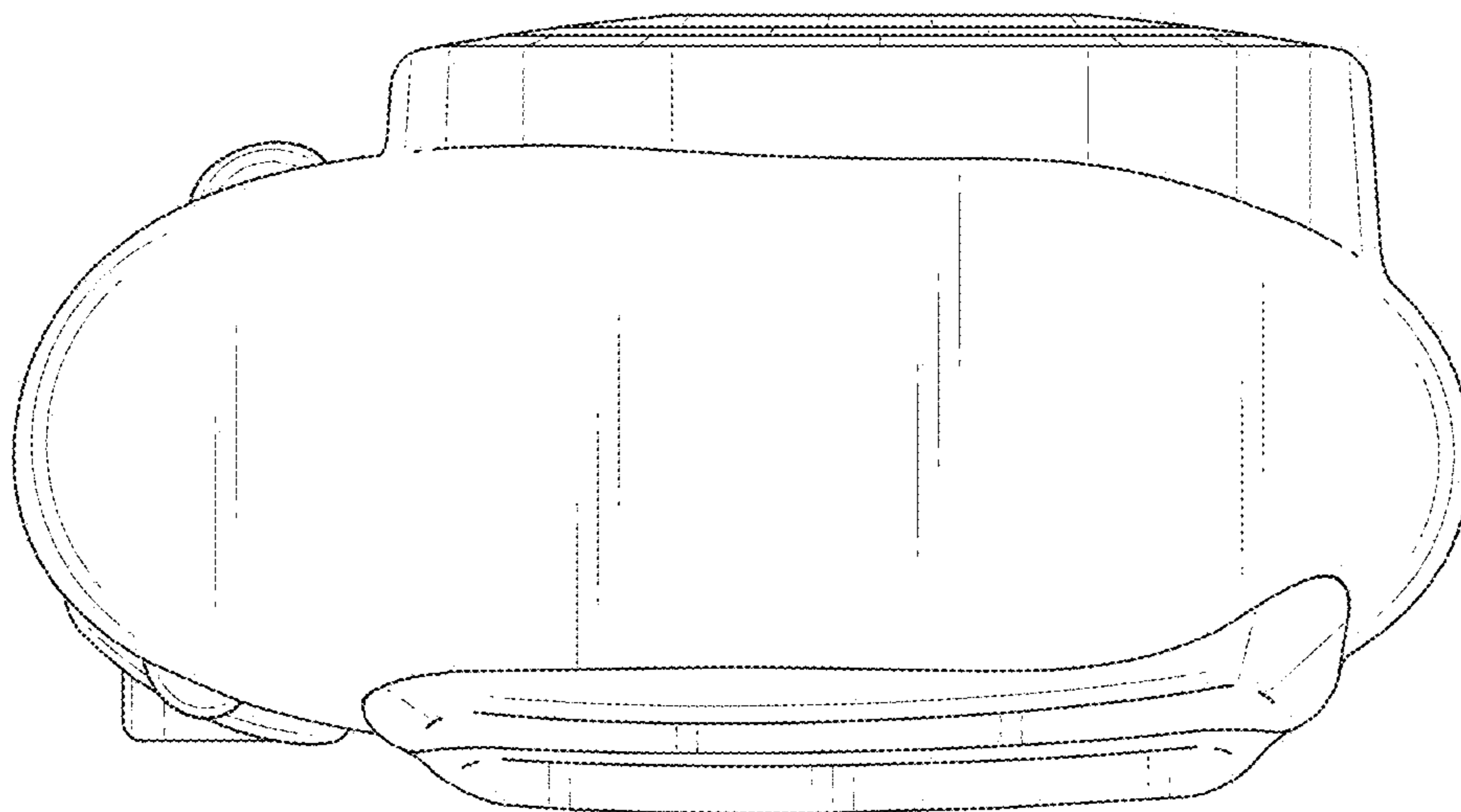

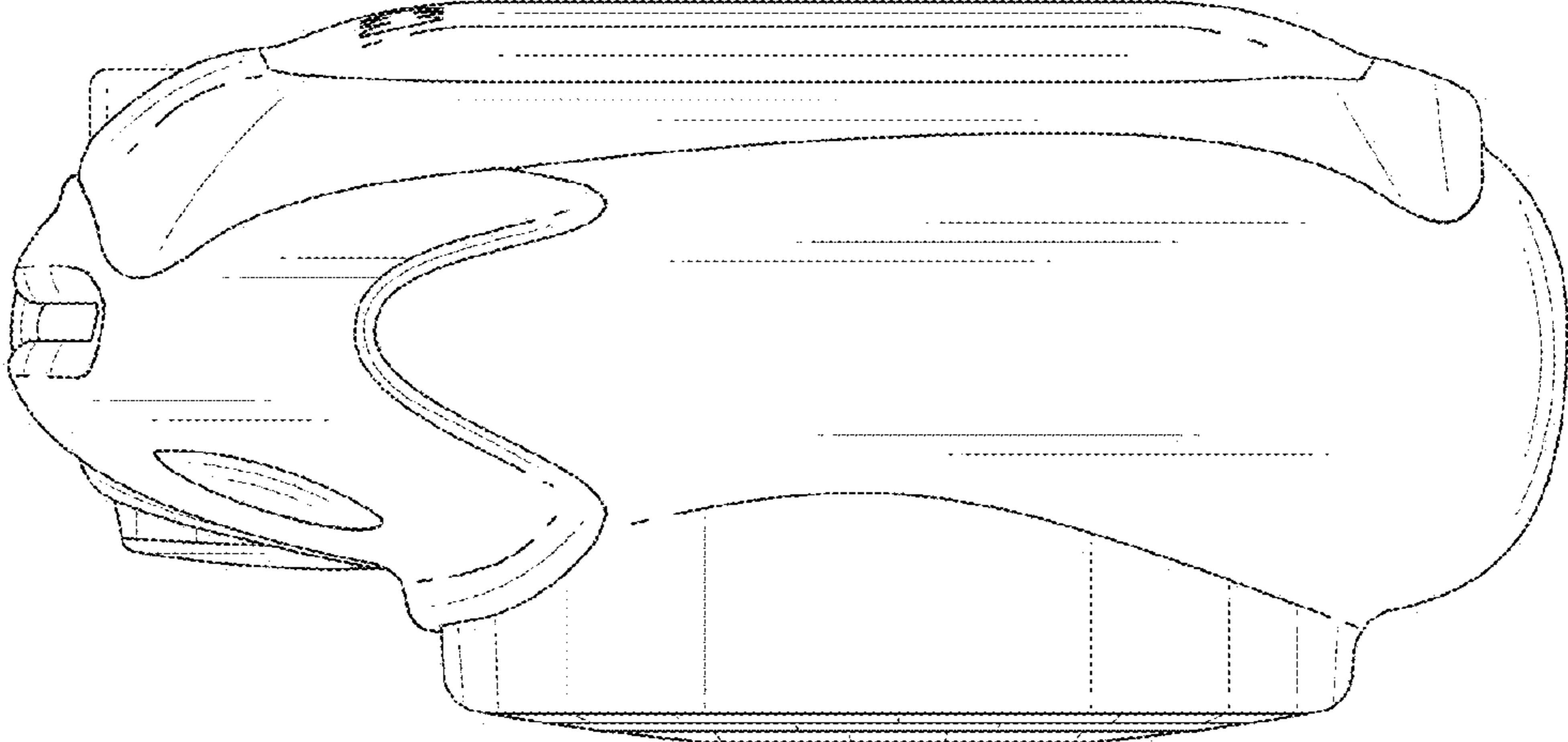

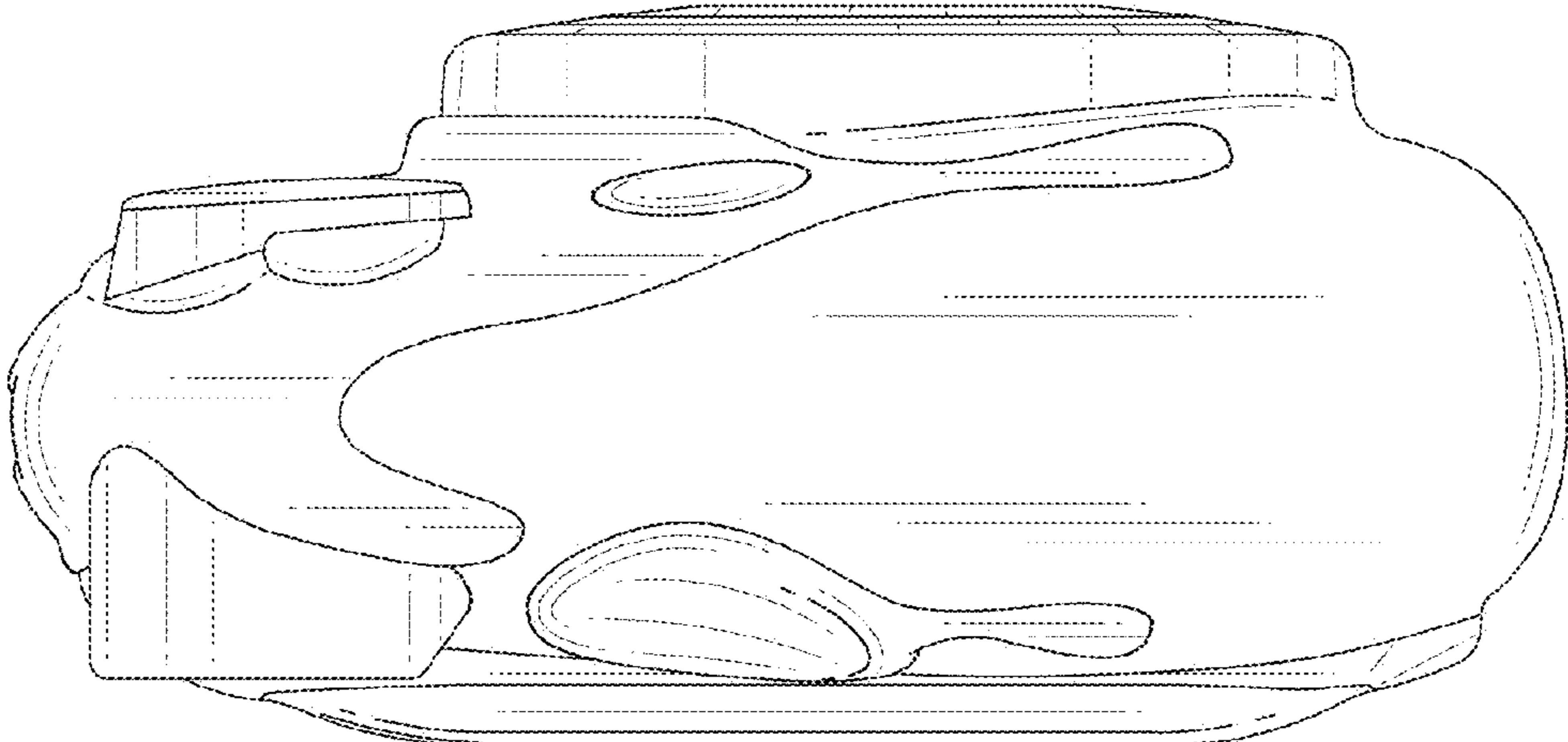

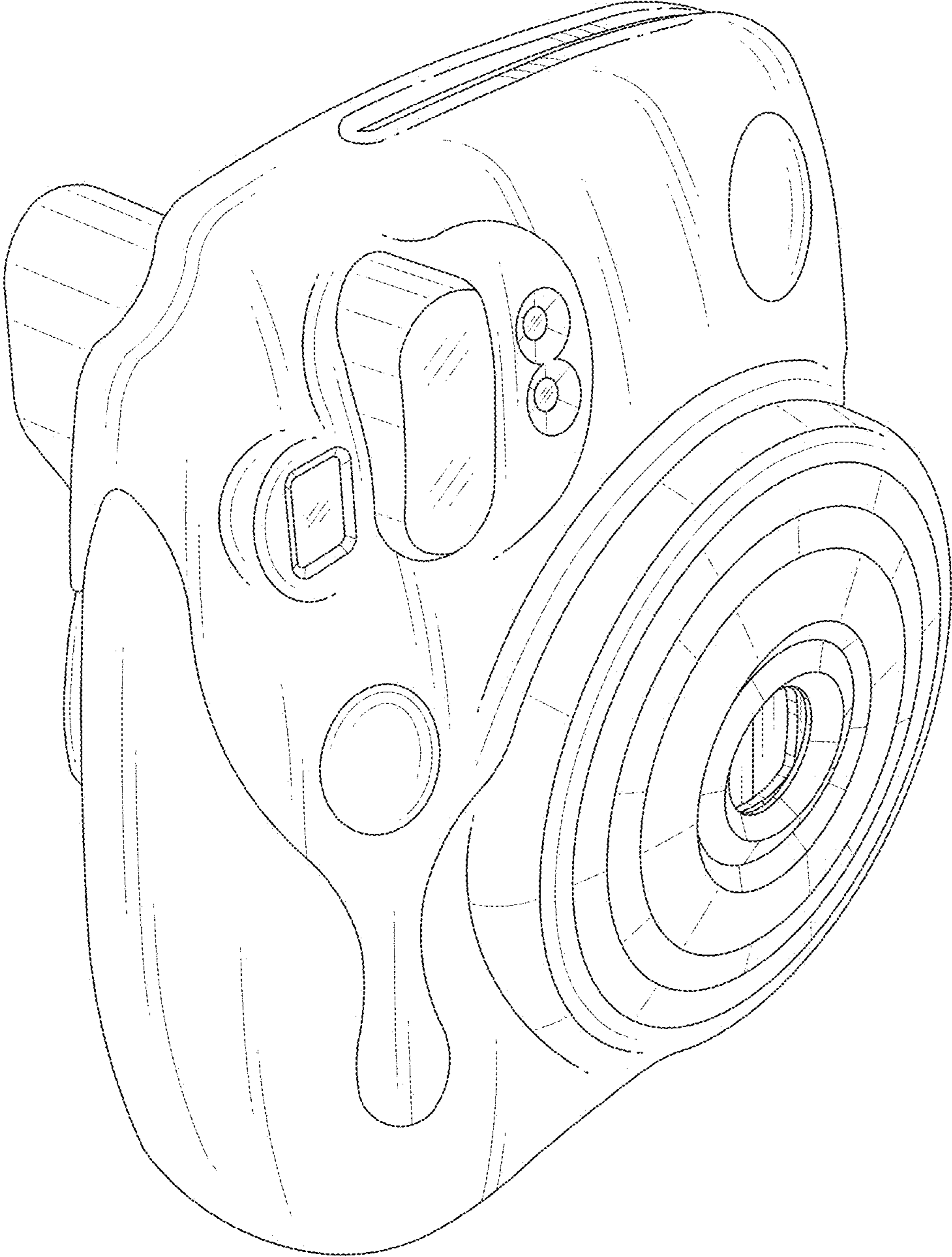
