(57) **CLAIM**

We claim the ornamental design for a shredder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a shredder according to our new design;

FIG. 2 is a top plan view of the shredder of FIG. 1;

FIG. 3 is a bottom plan view of the shredder of FIG. 1;

FIG. 4 is a front elevational view of the shredder of FIG. 1;

FIG. 5 is a rear elevational view of the shredder of FIG. 1;

FIG. 6 is a left side elevational view of the shredder of FIG. 1;

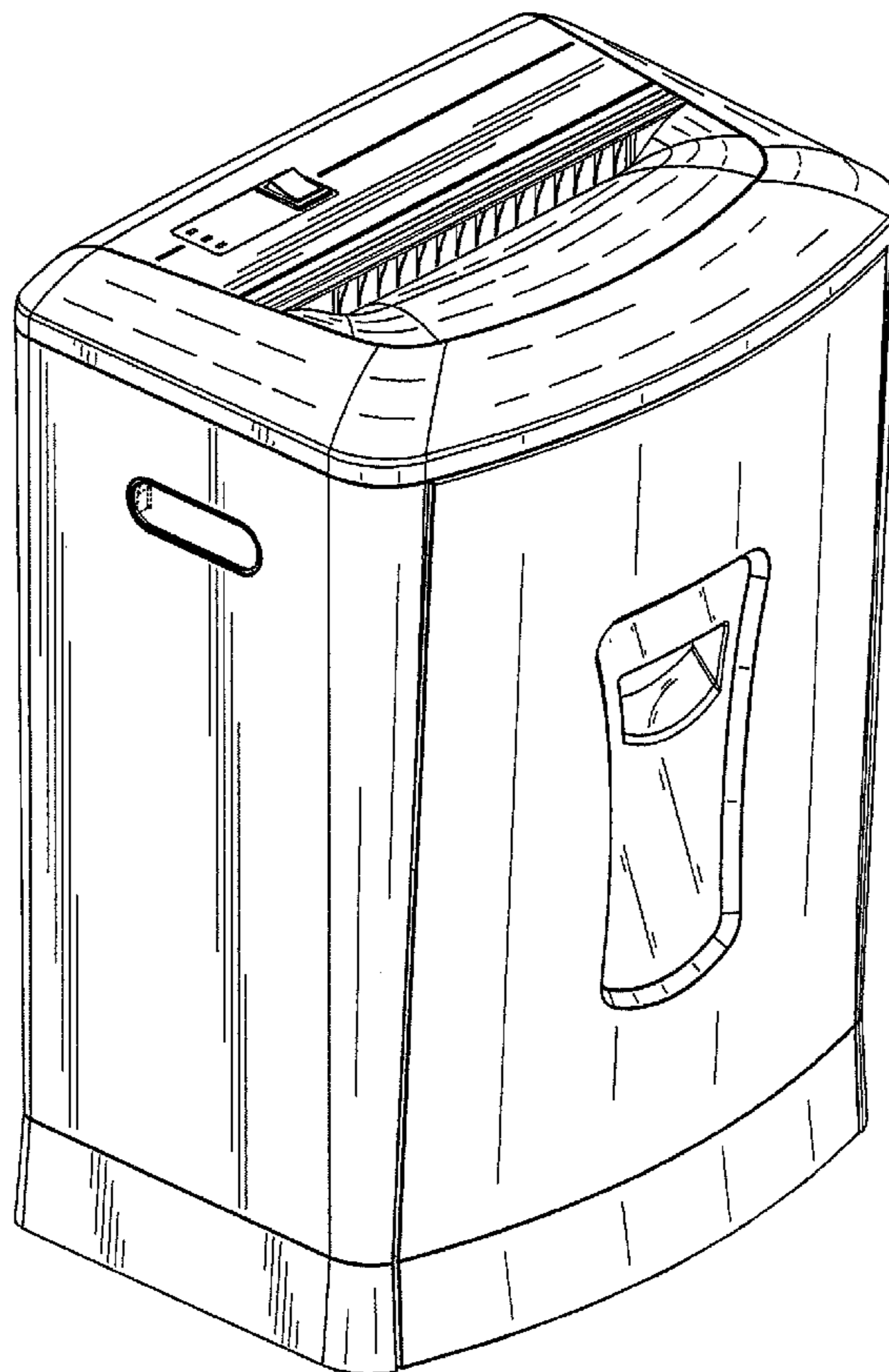

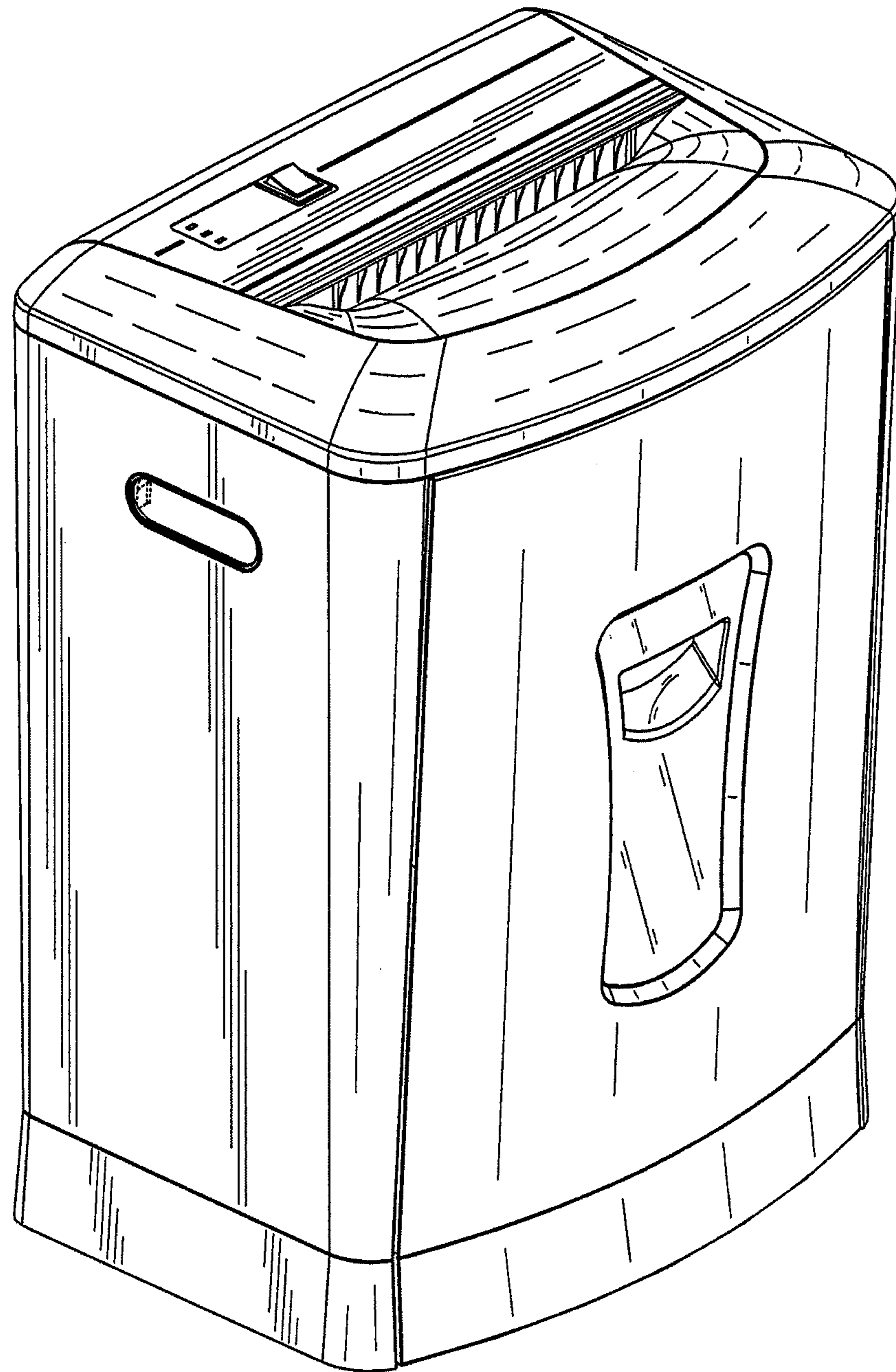

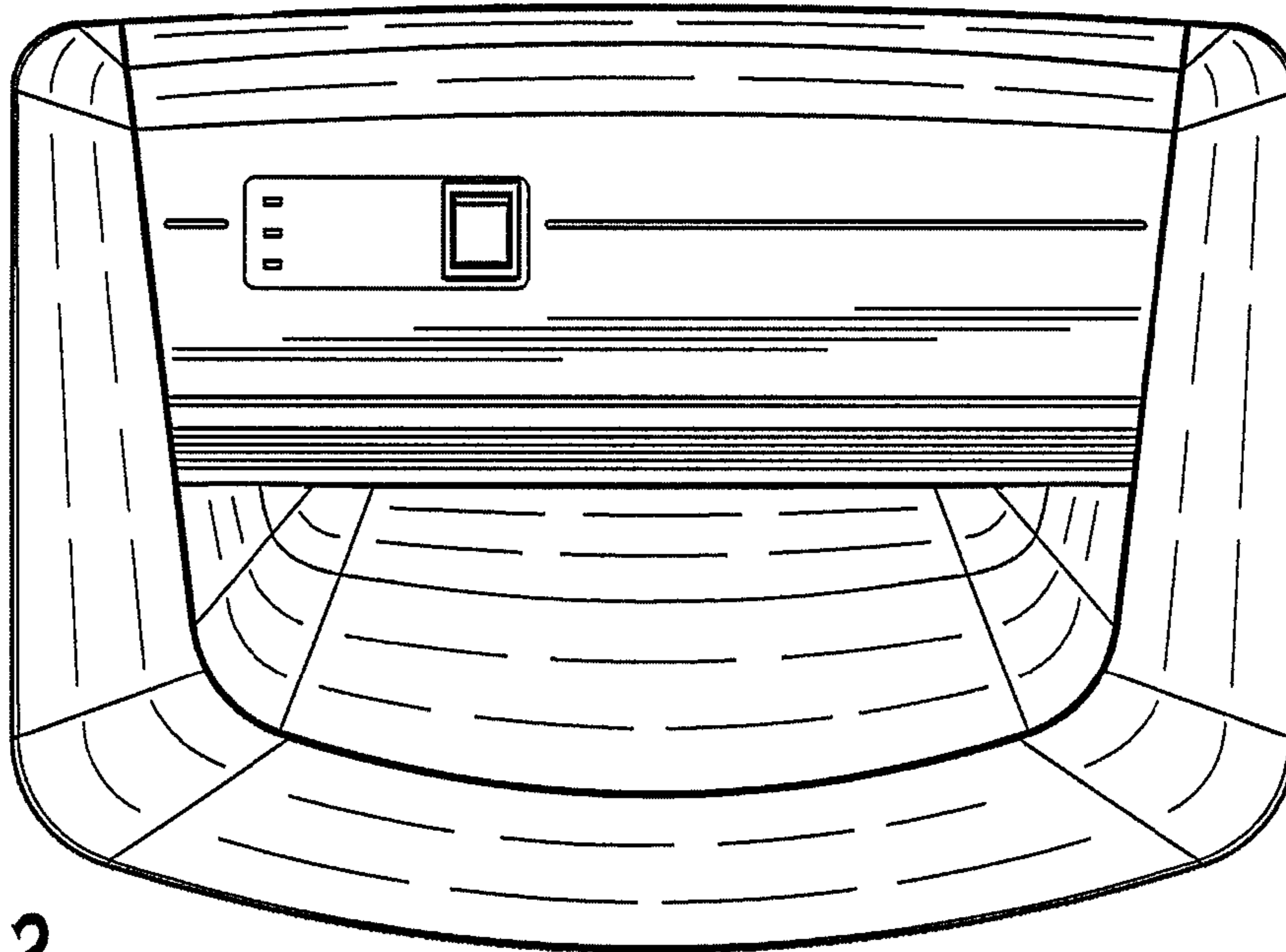

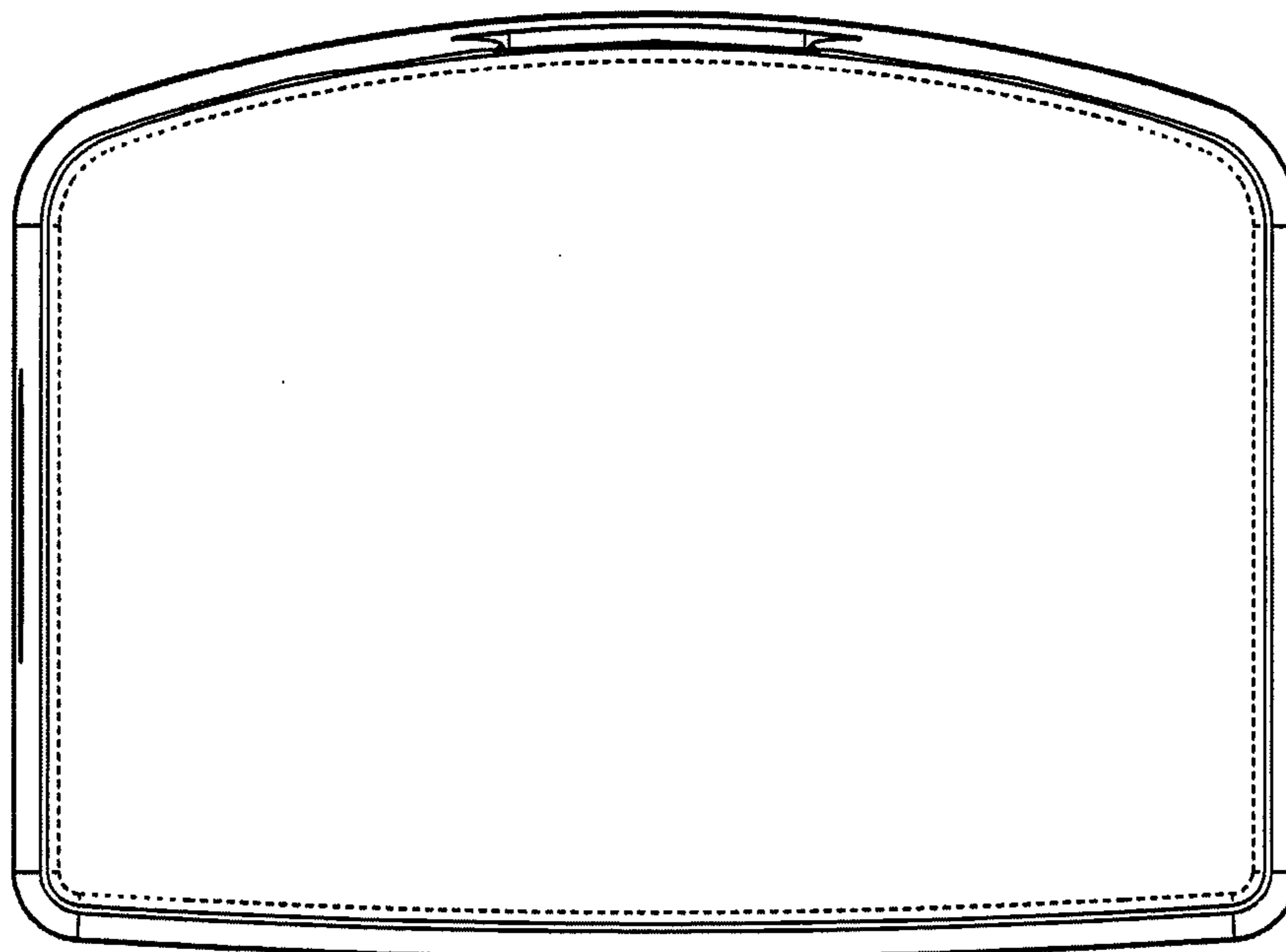

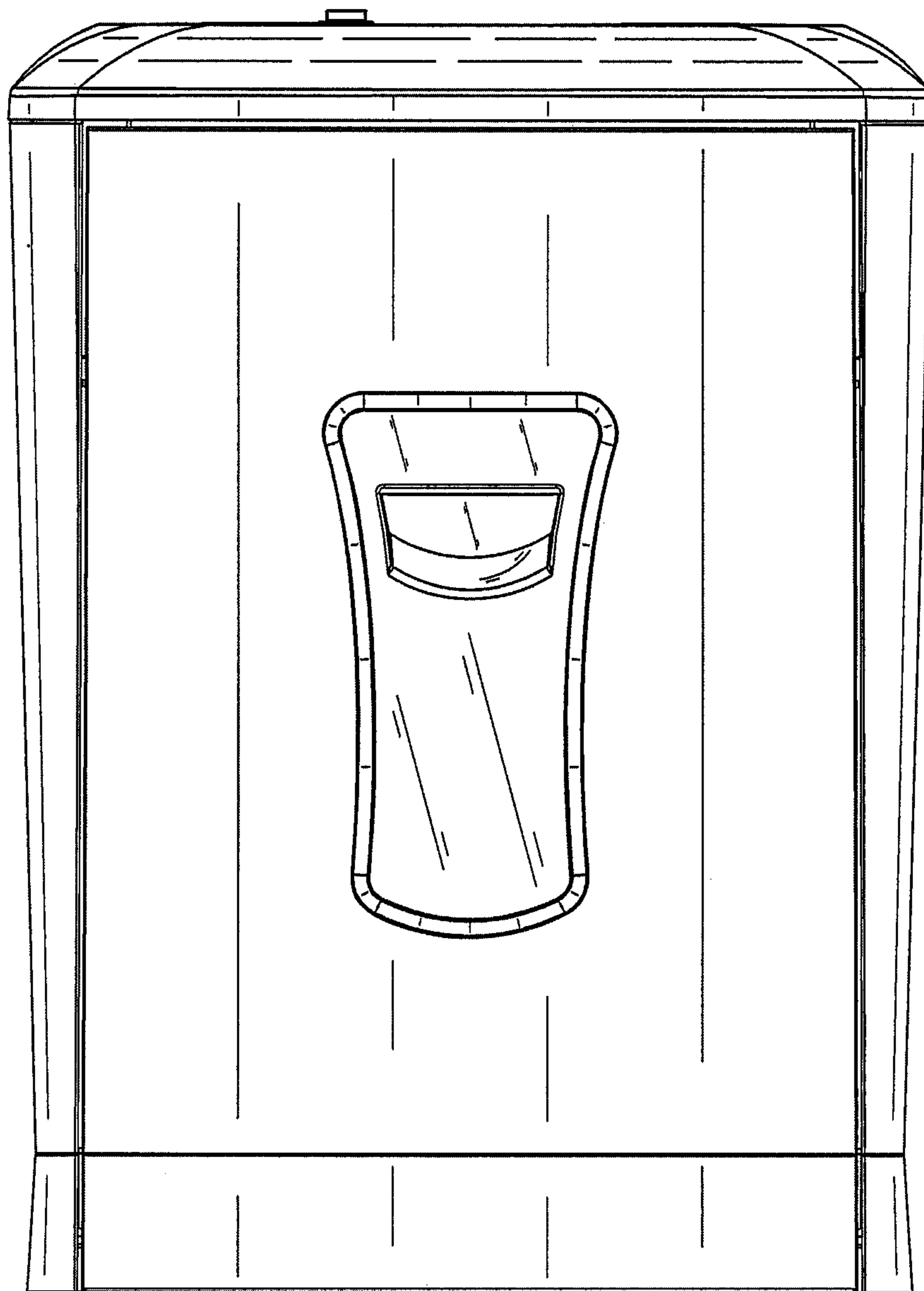

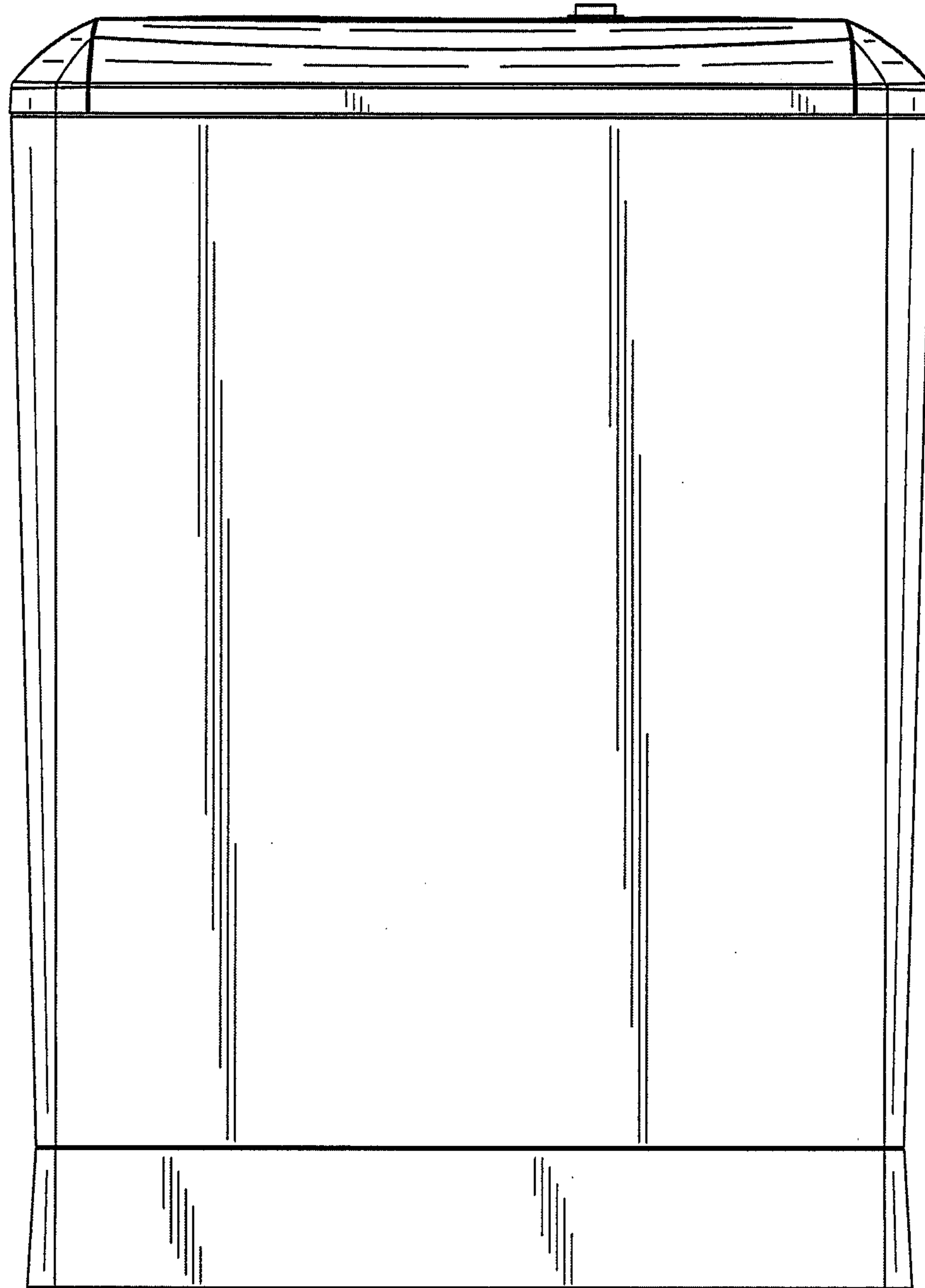

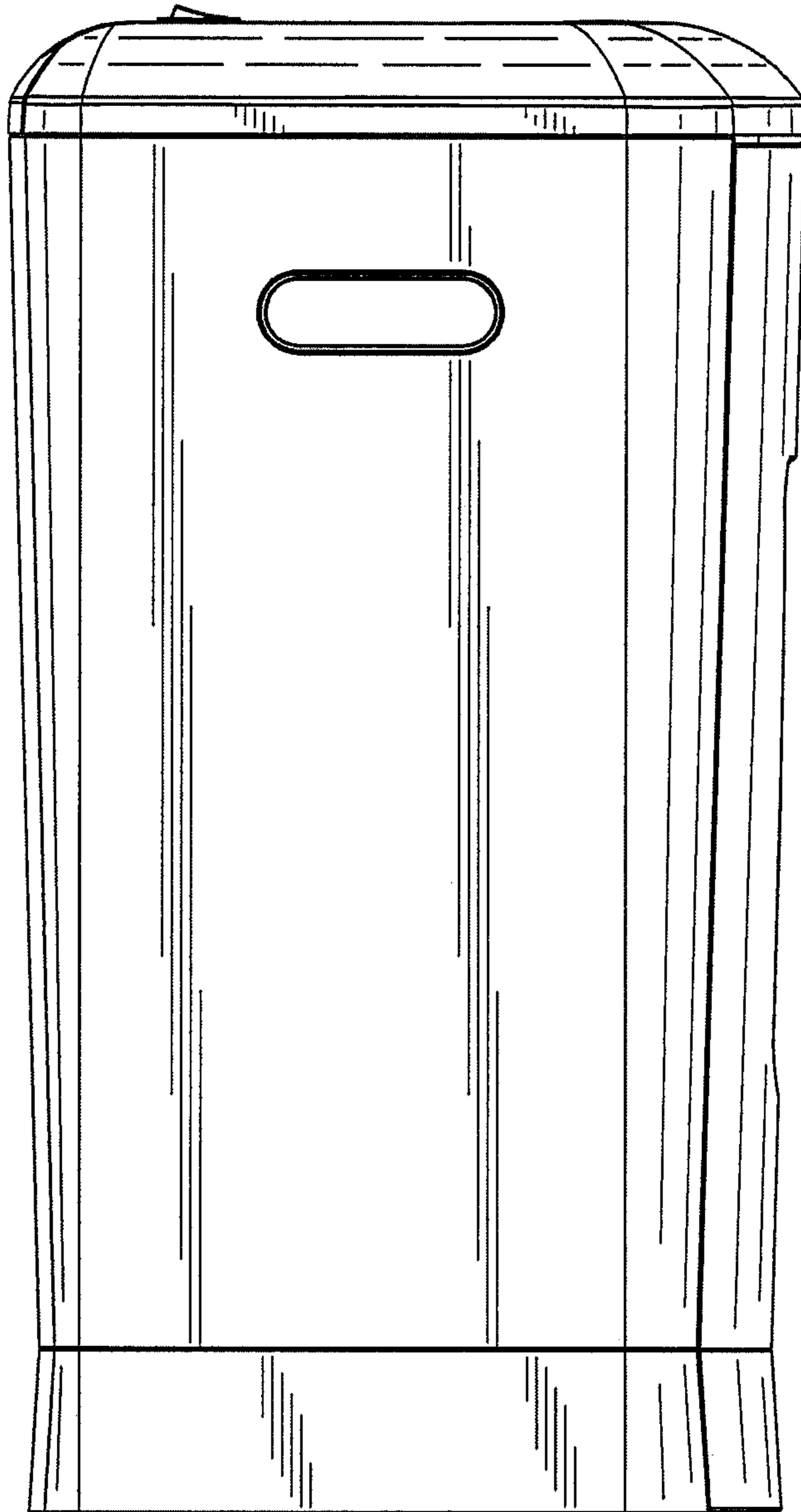

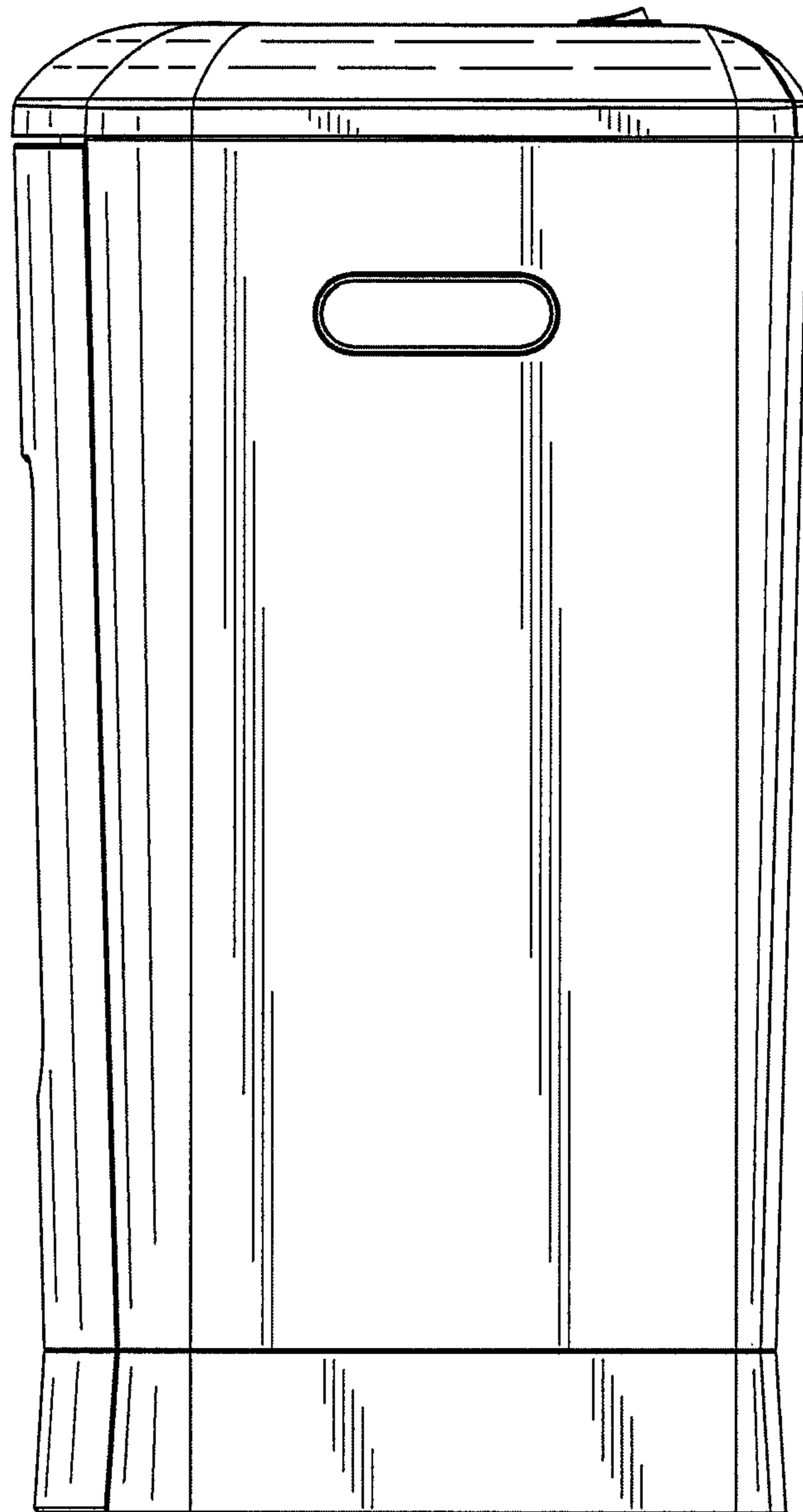
