**DESCRIPTION**

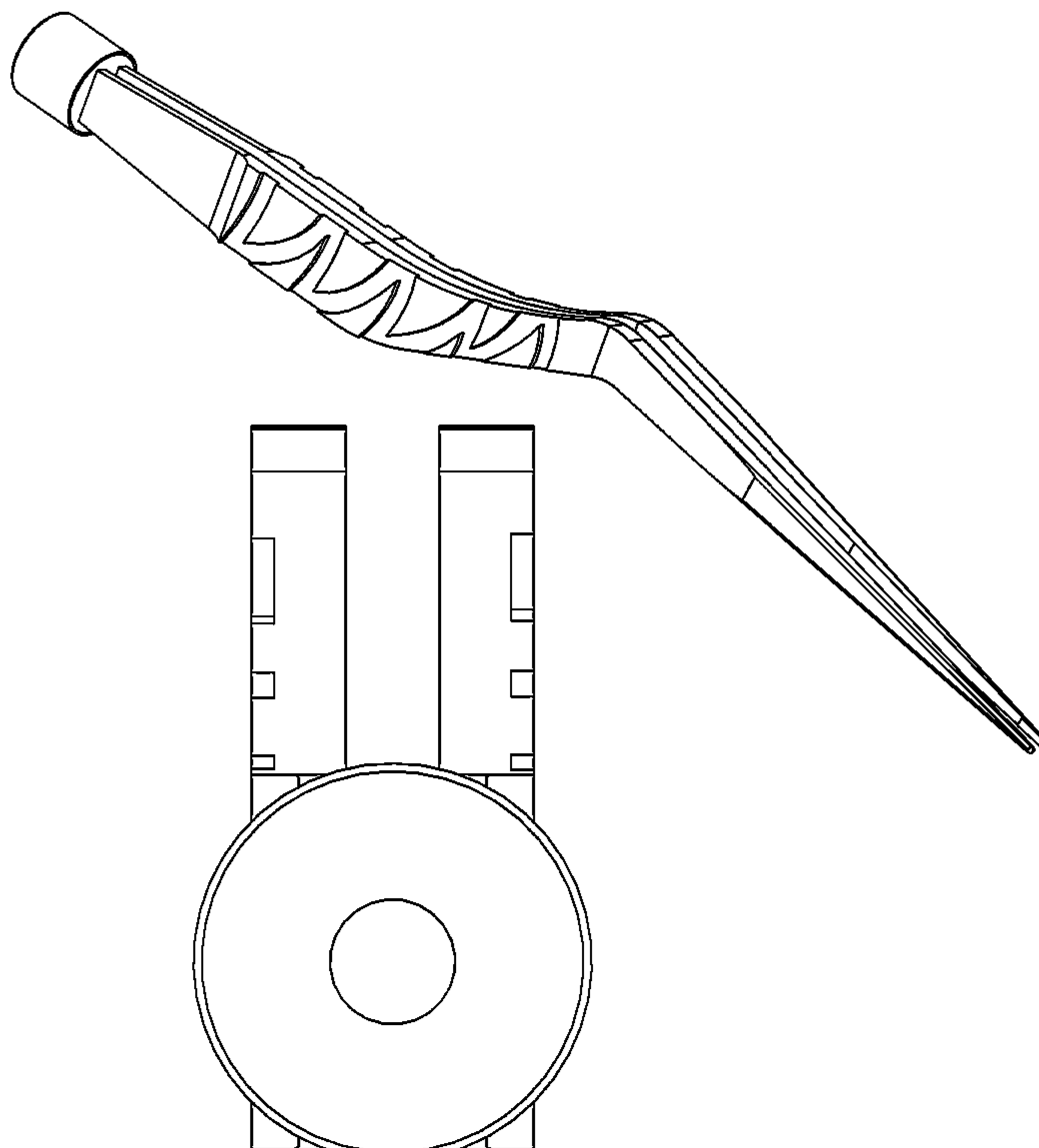
FIG. 1 is a perspective view of a surgical forceps showing our new design;

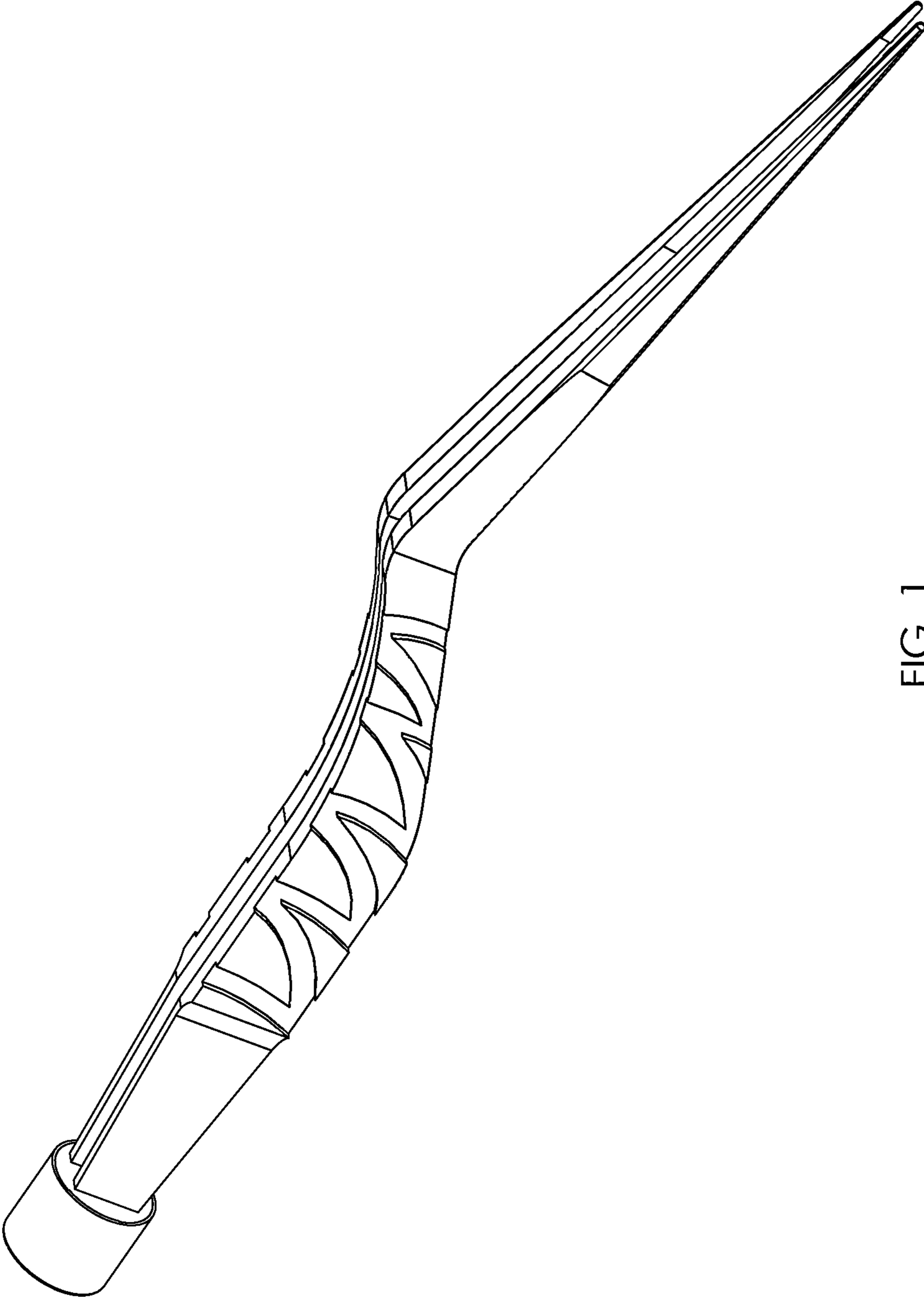

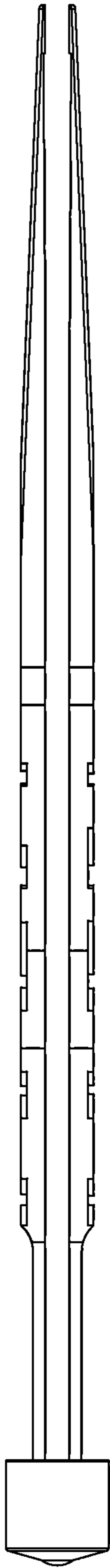

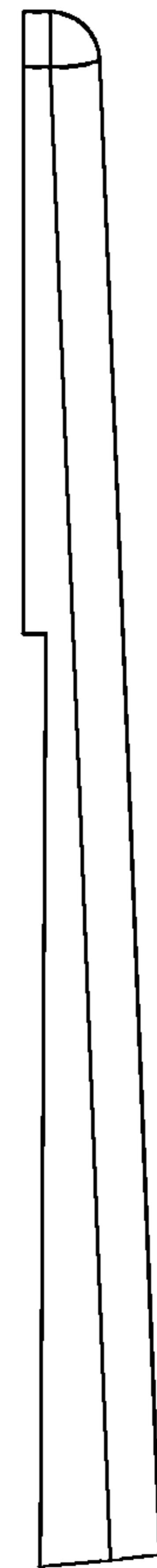
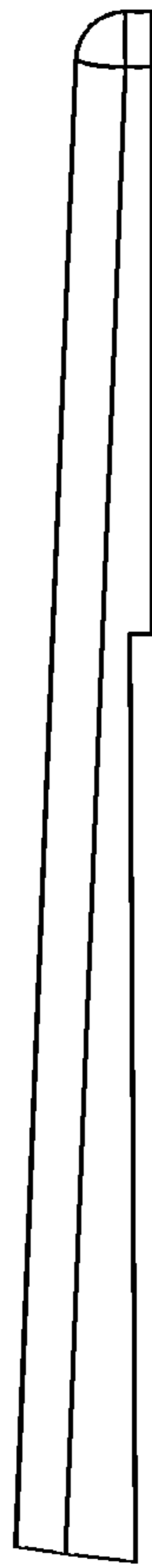

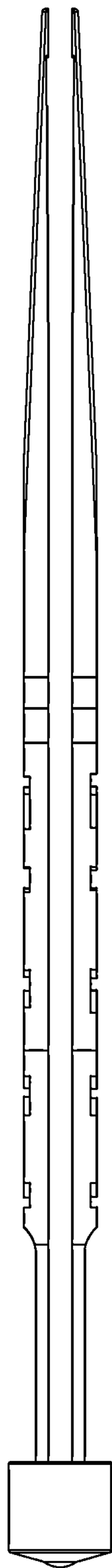

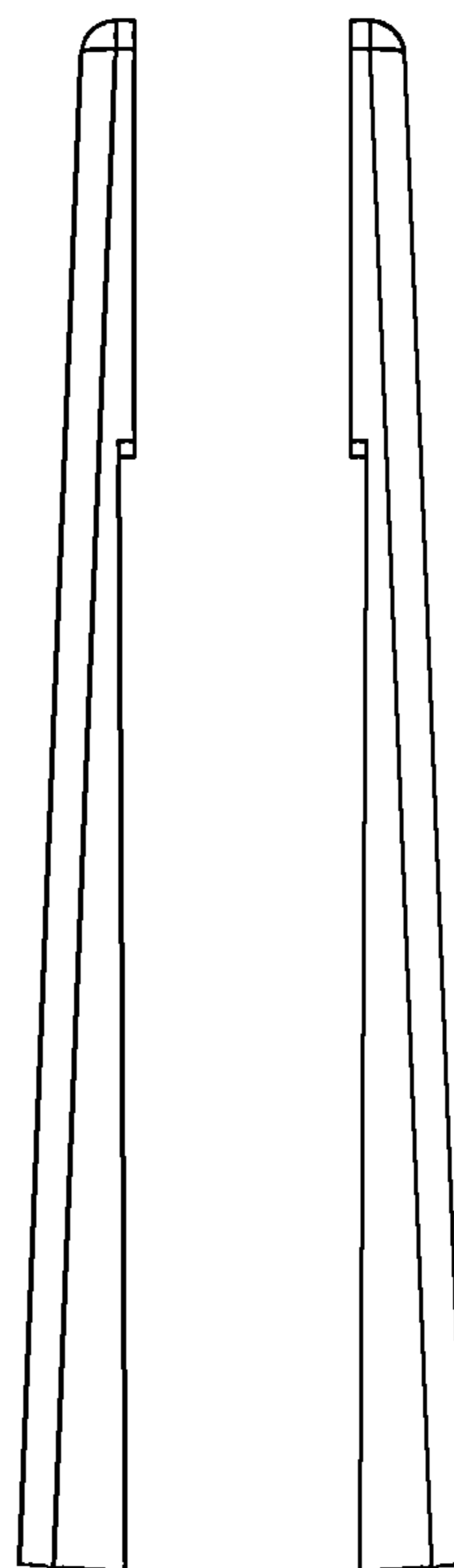

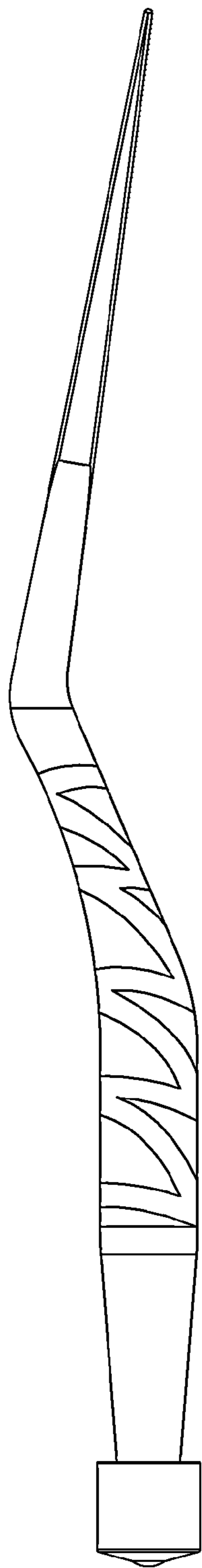

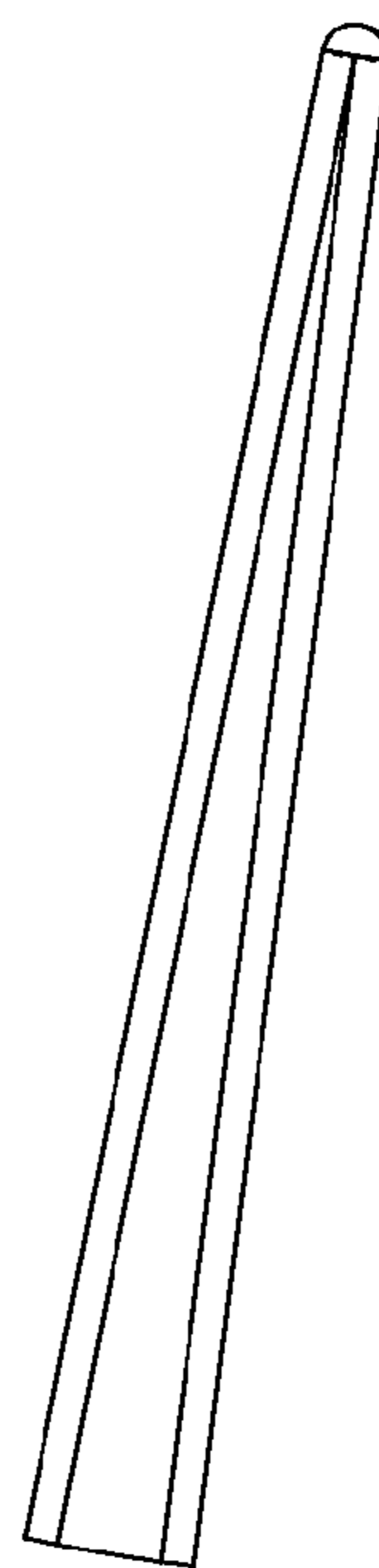

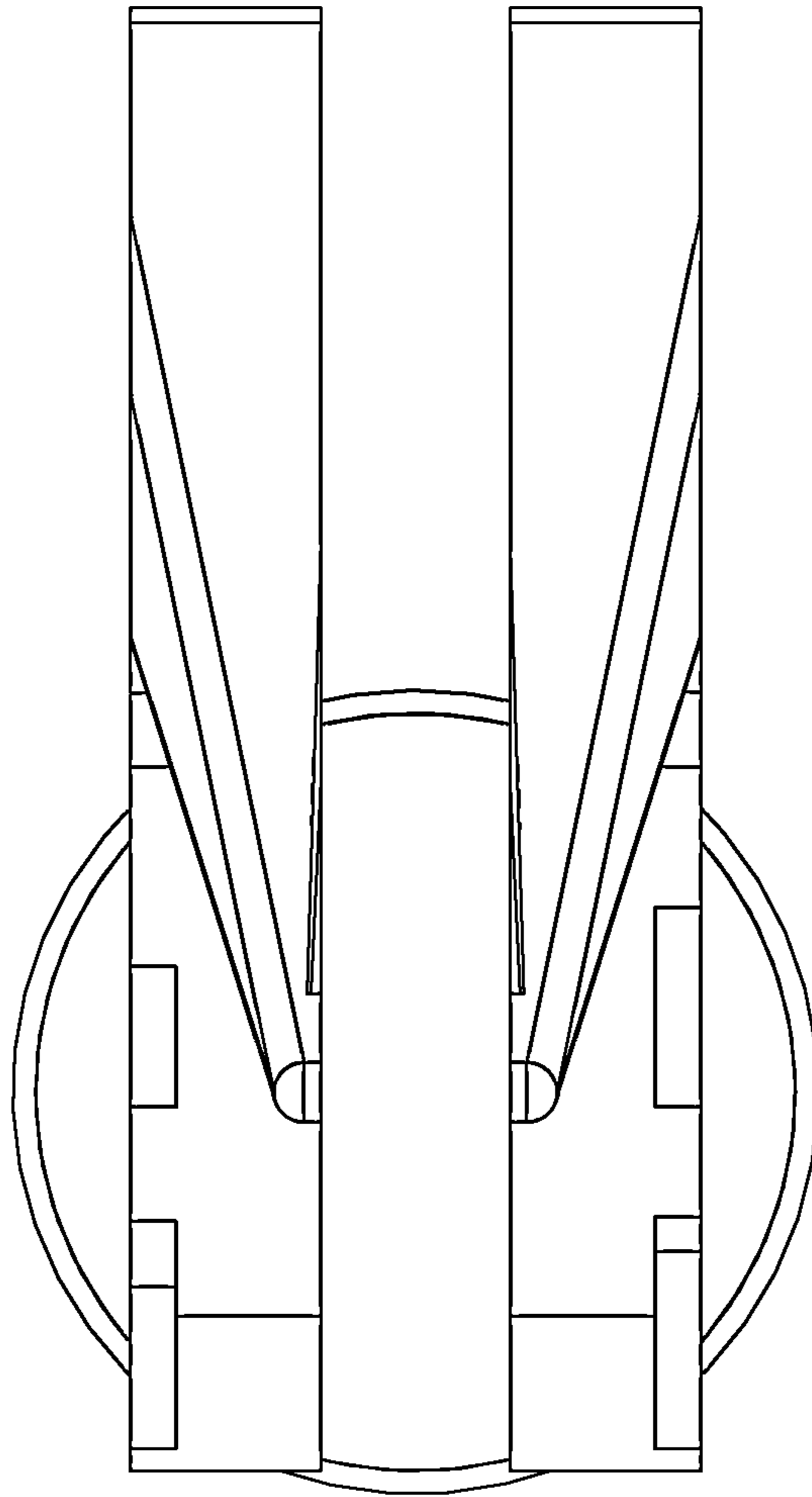

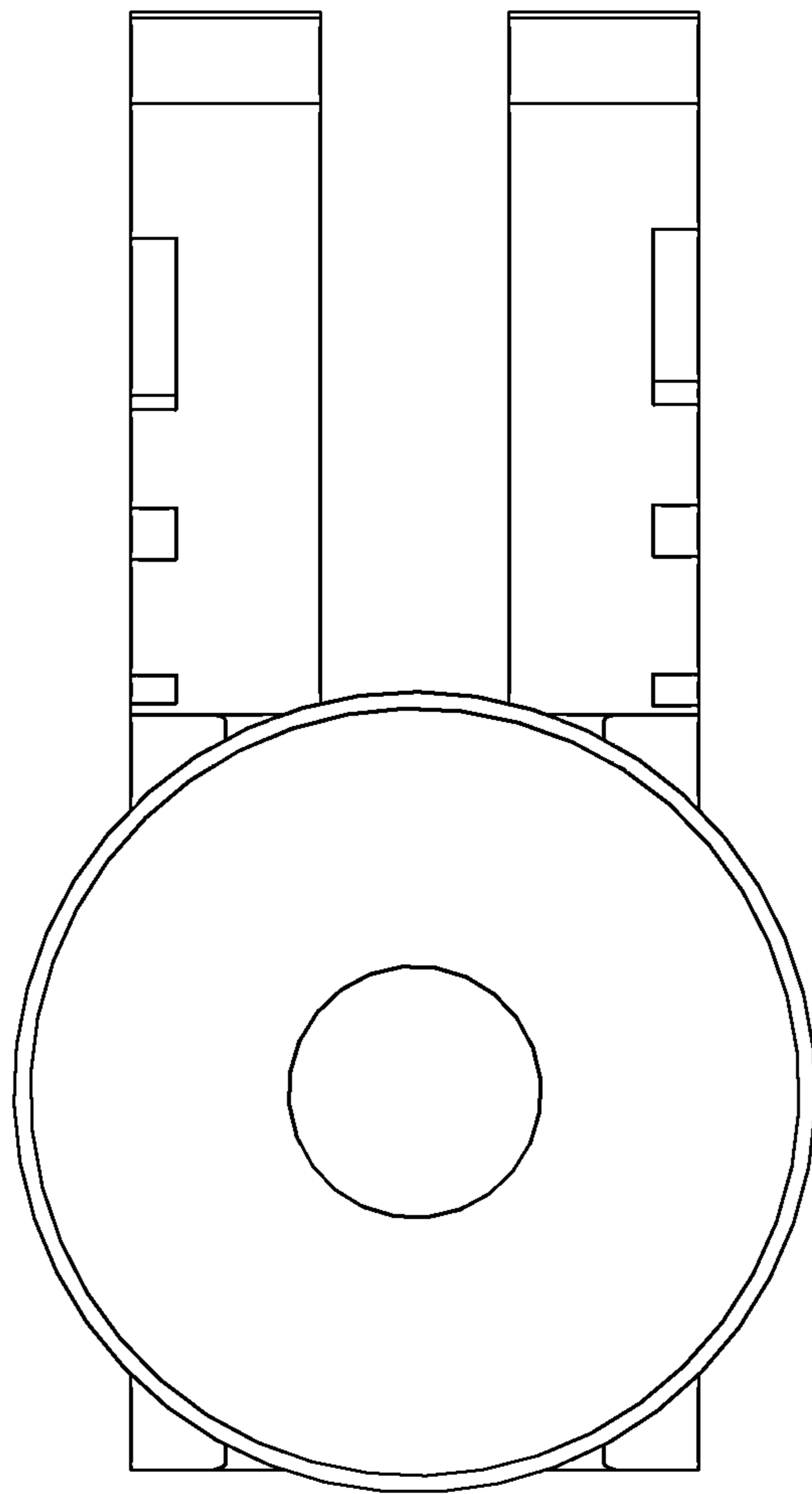
