The ornamental design for a “baby bottle holder,” as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a baby bottle holder showing my new design;

FIG. 8 is a cross-sectional view taken along line 8-8 of FIG. 6;

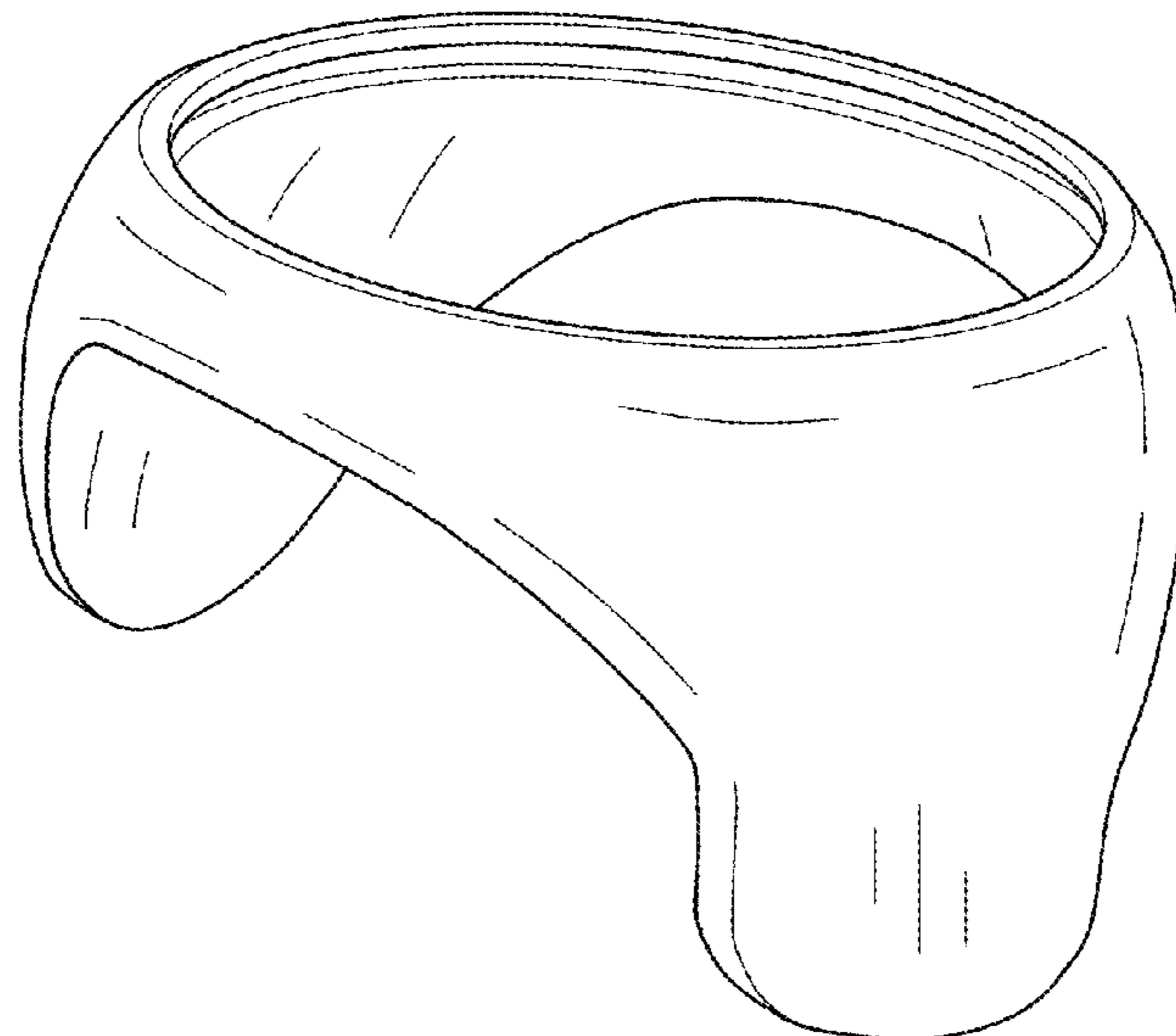
FIG. 9 is a cross-sectional view taken along line 9-9 of FIG. 6;

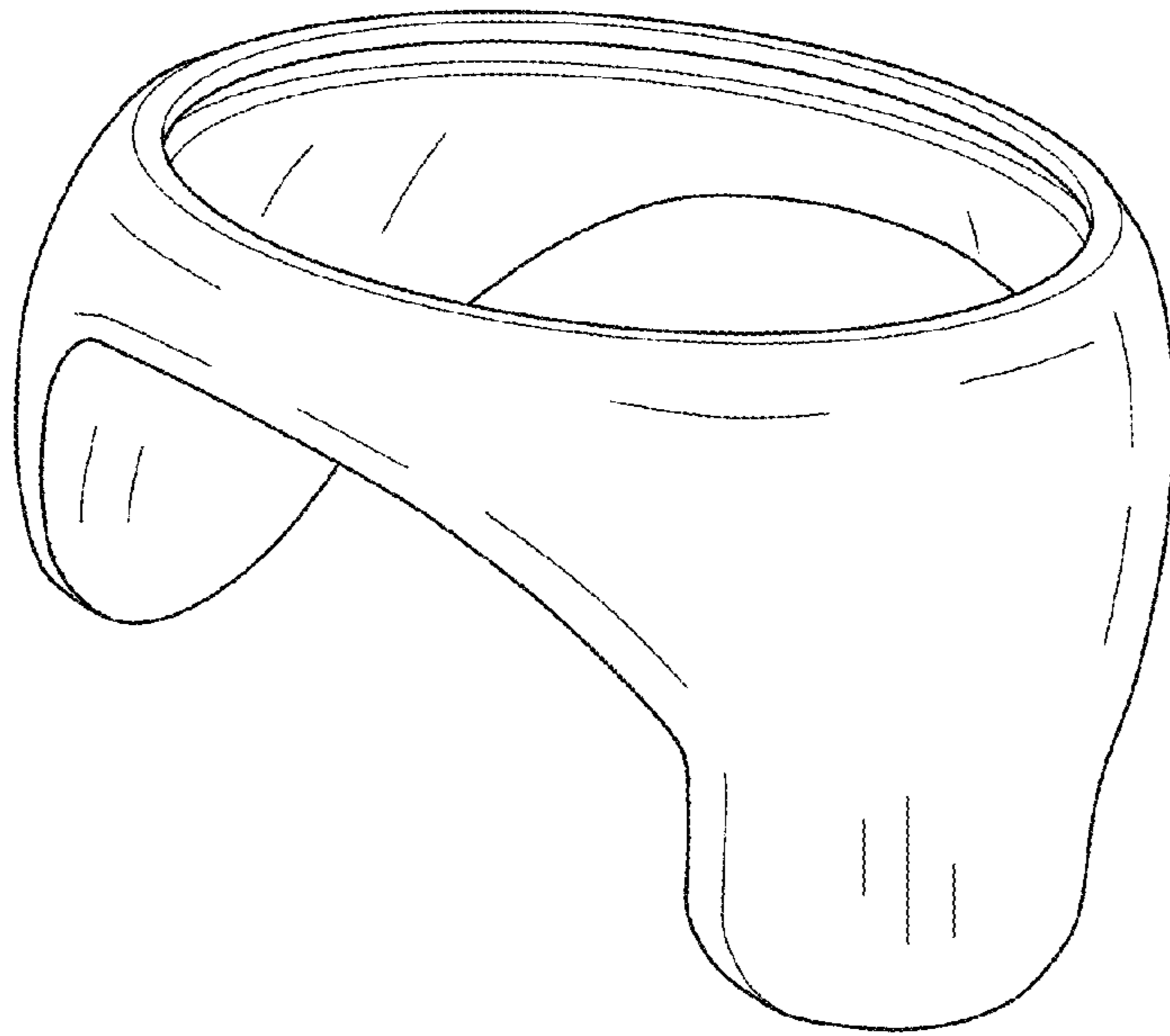

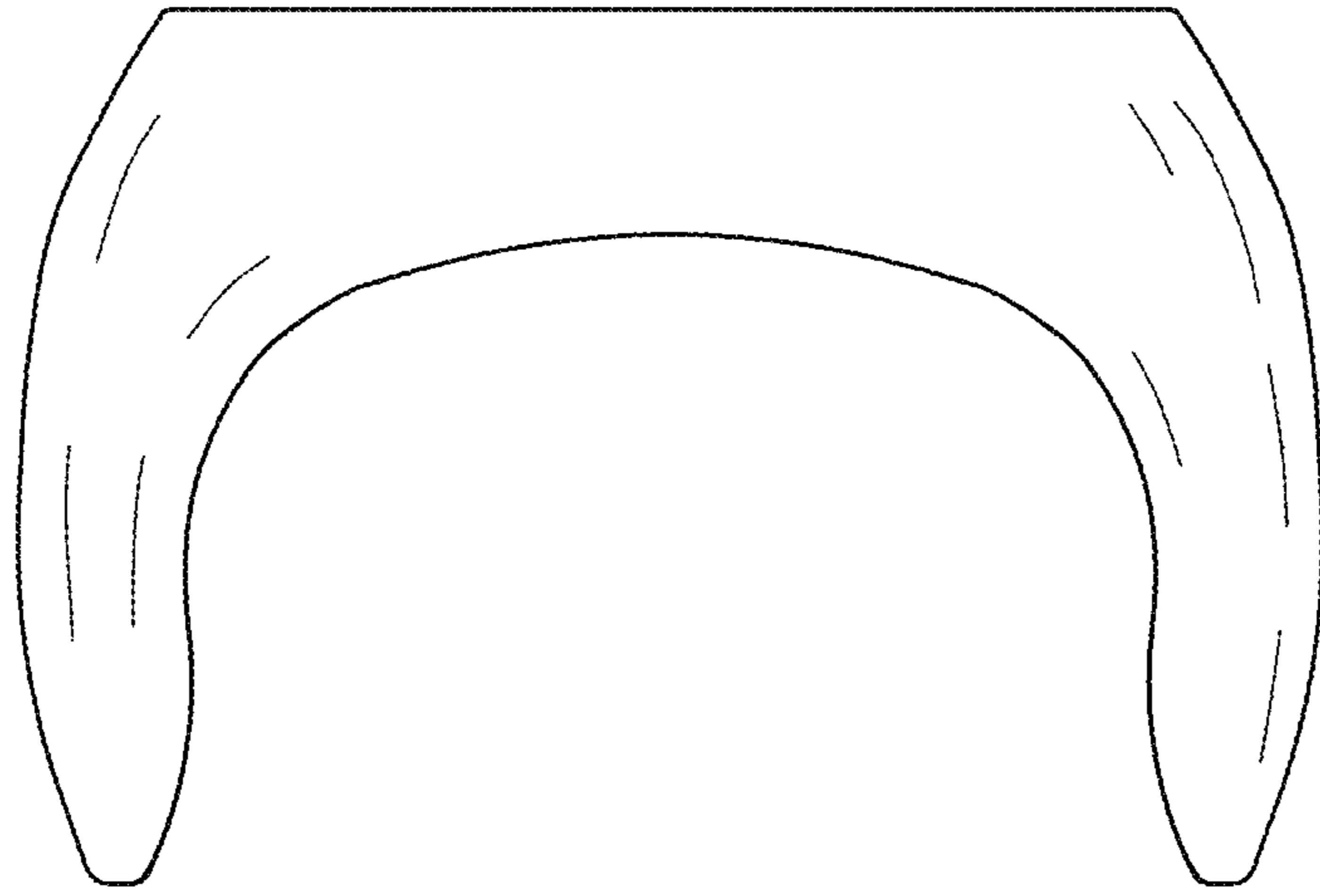

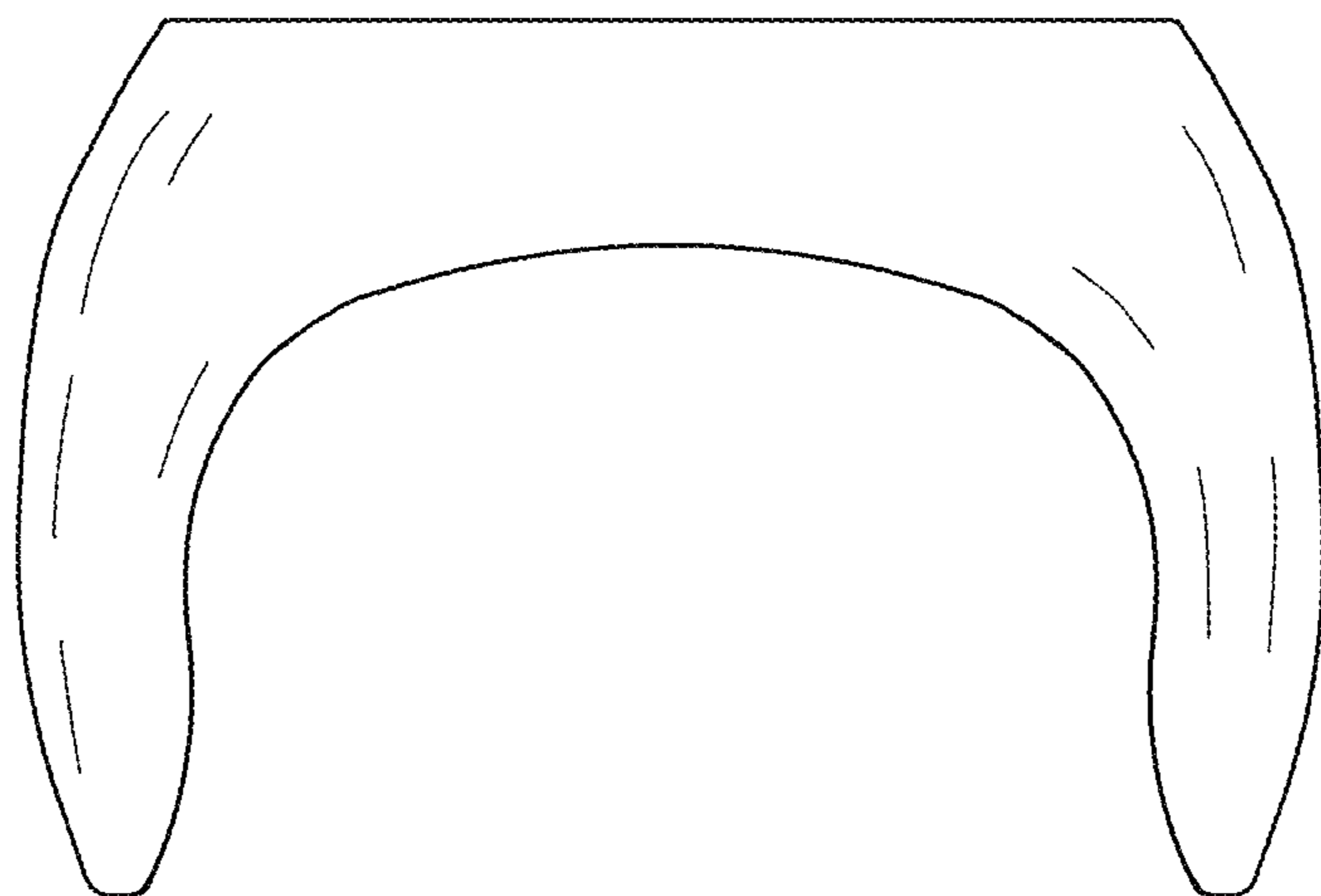

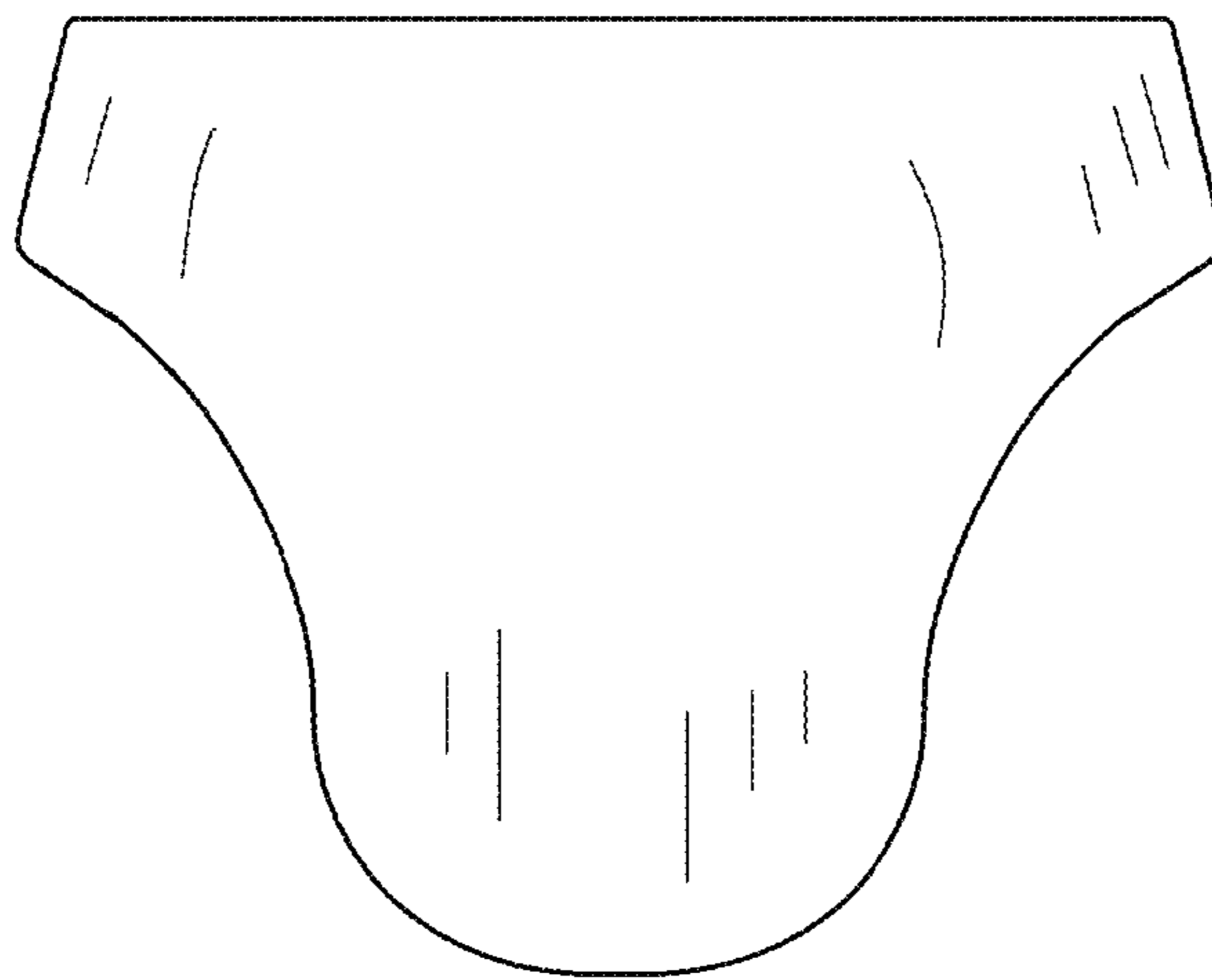

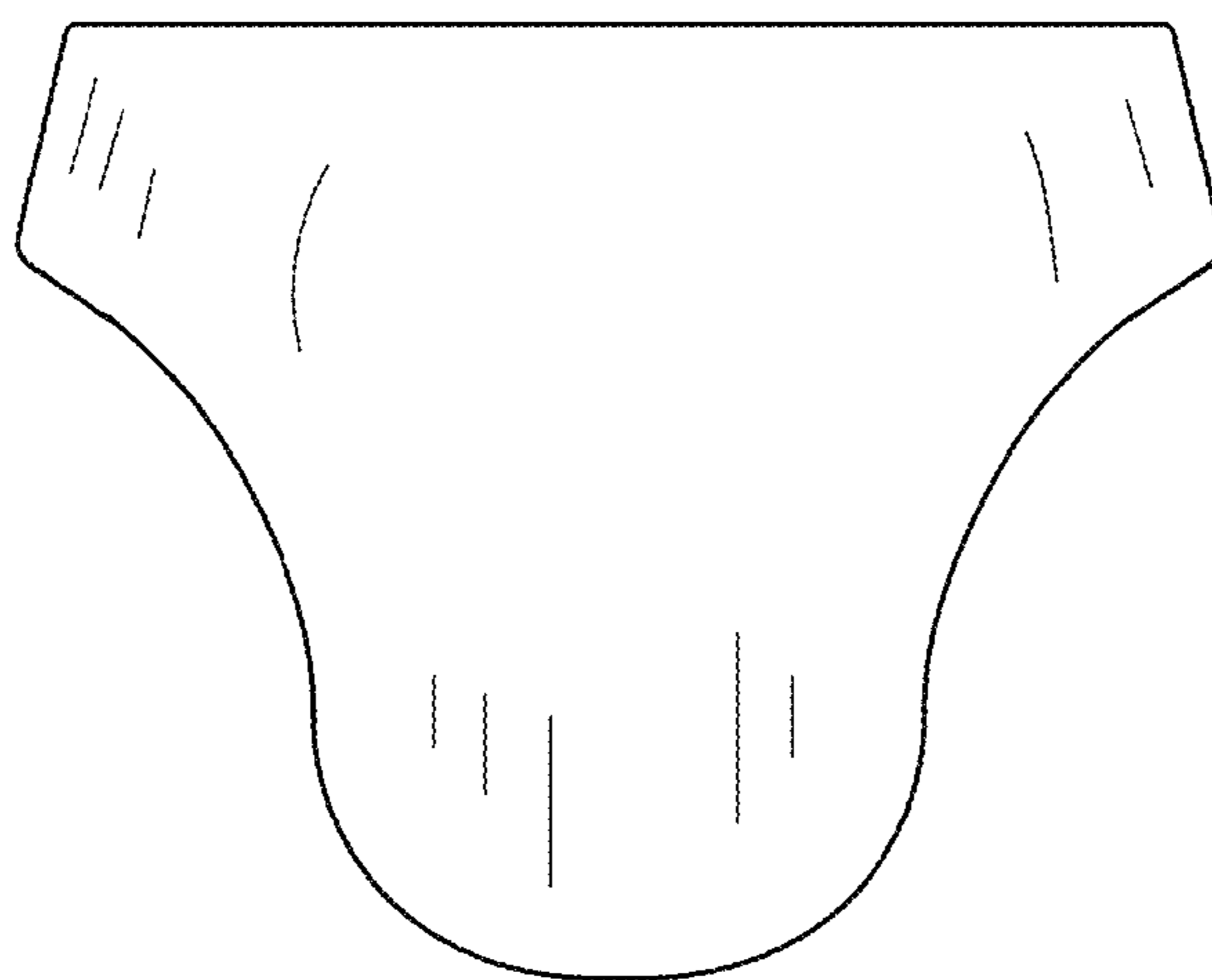

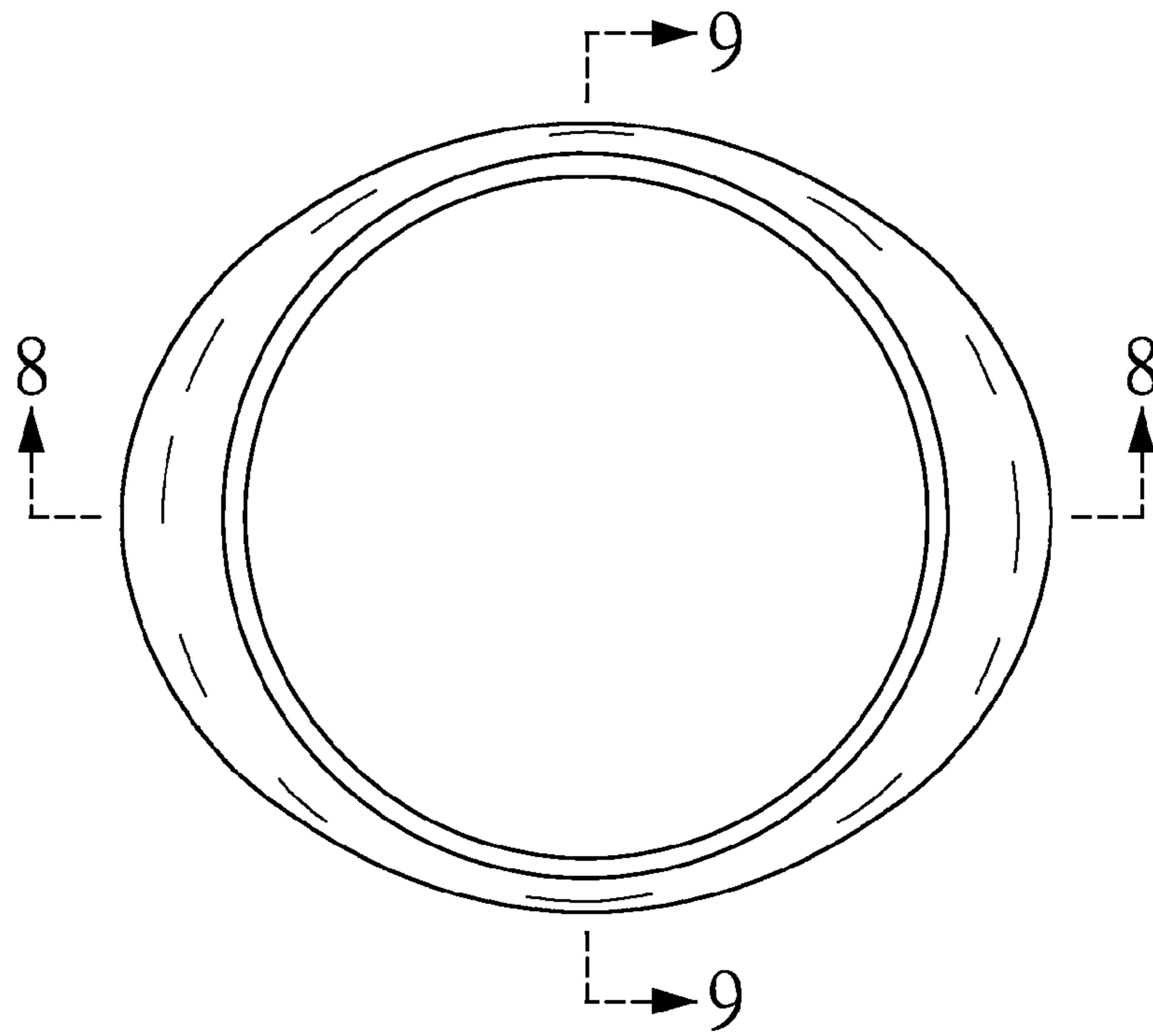

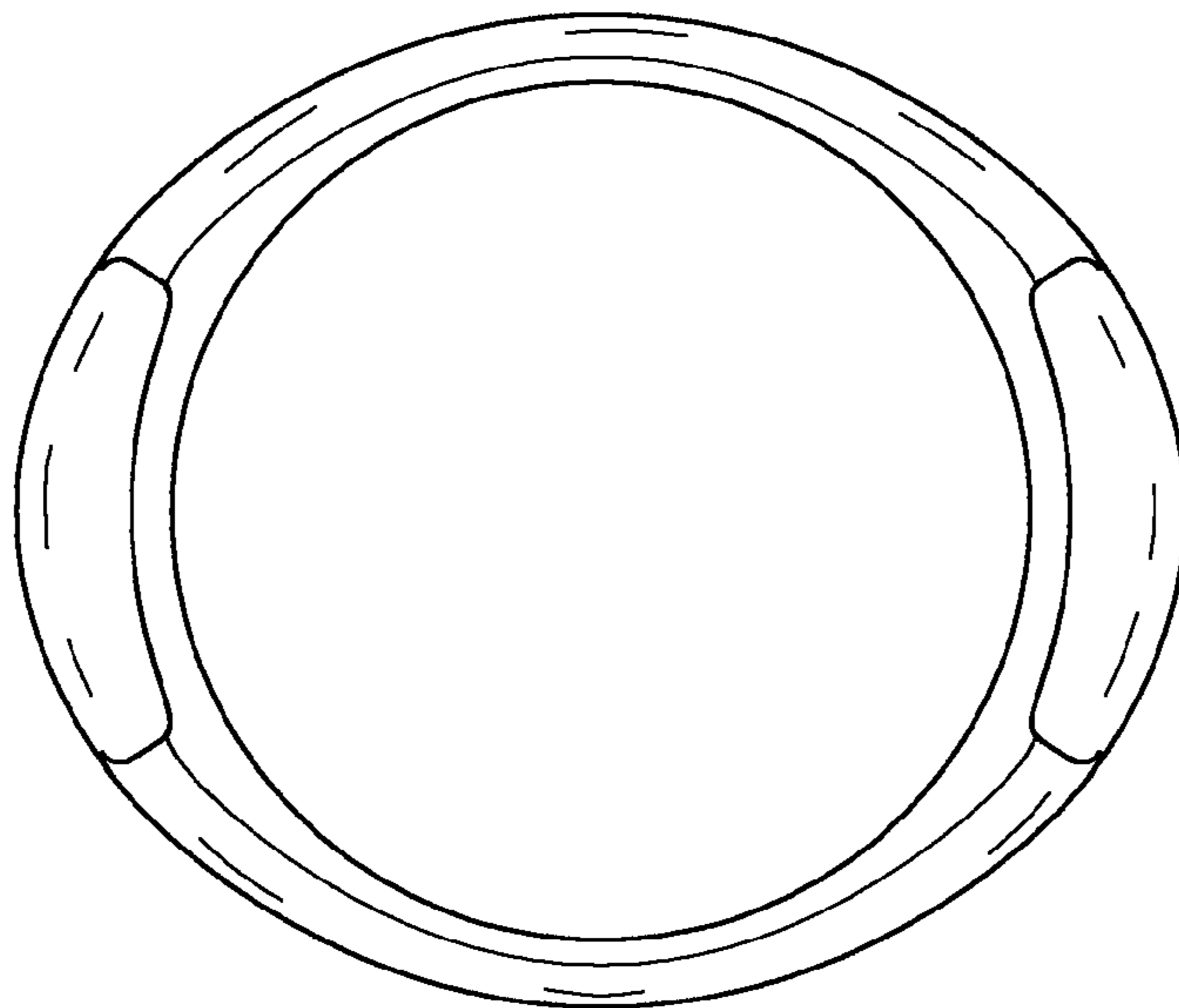

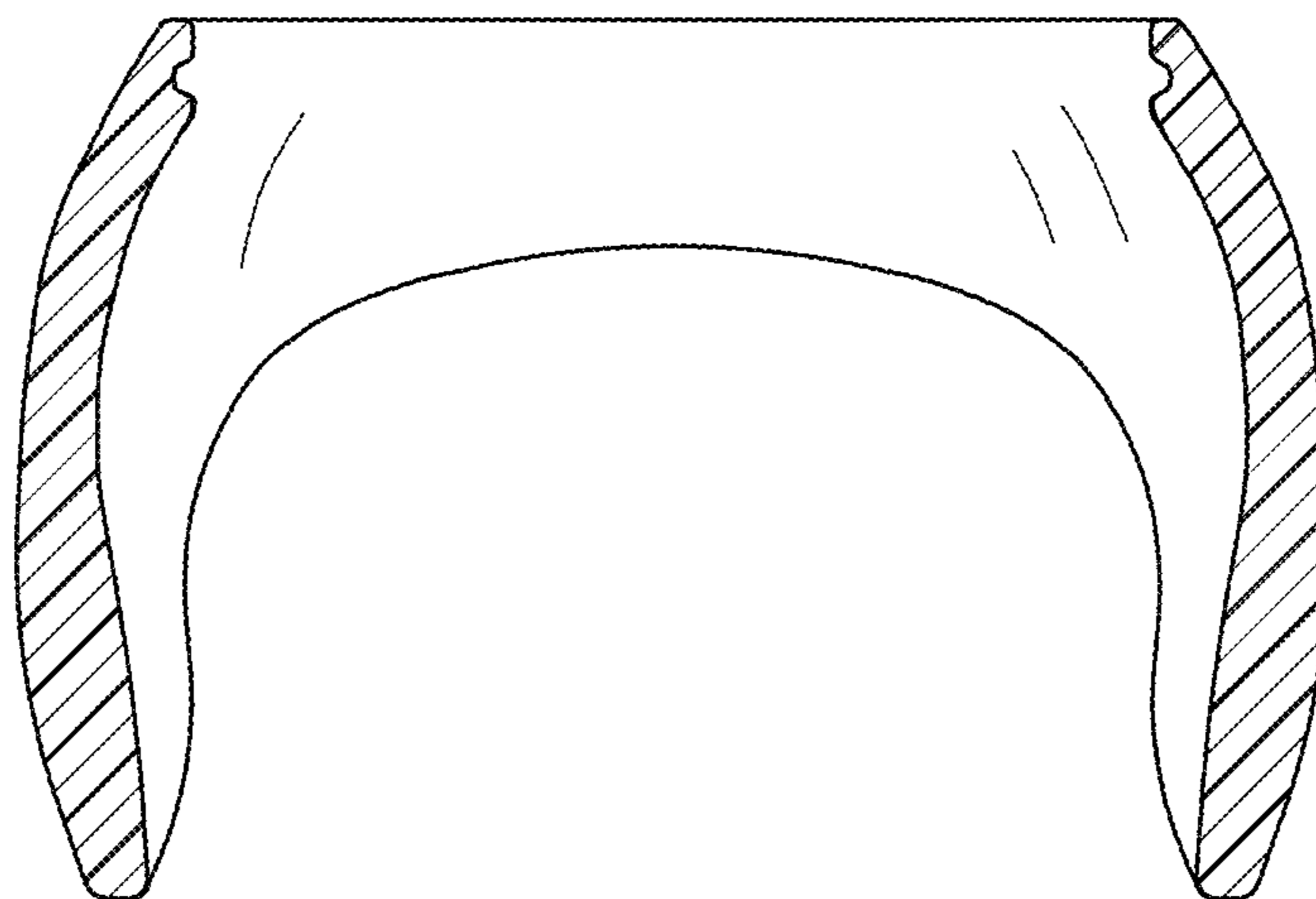

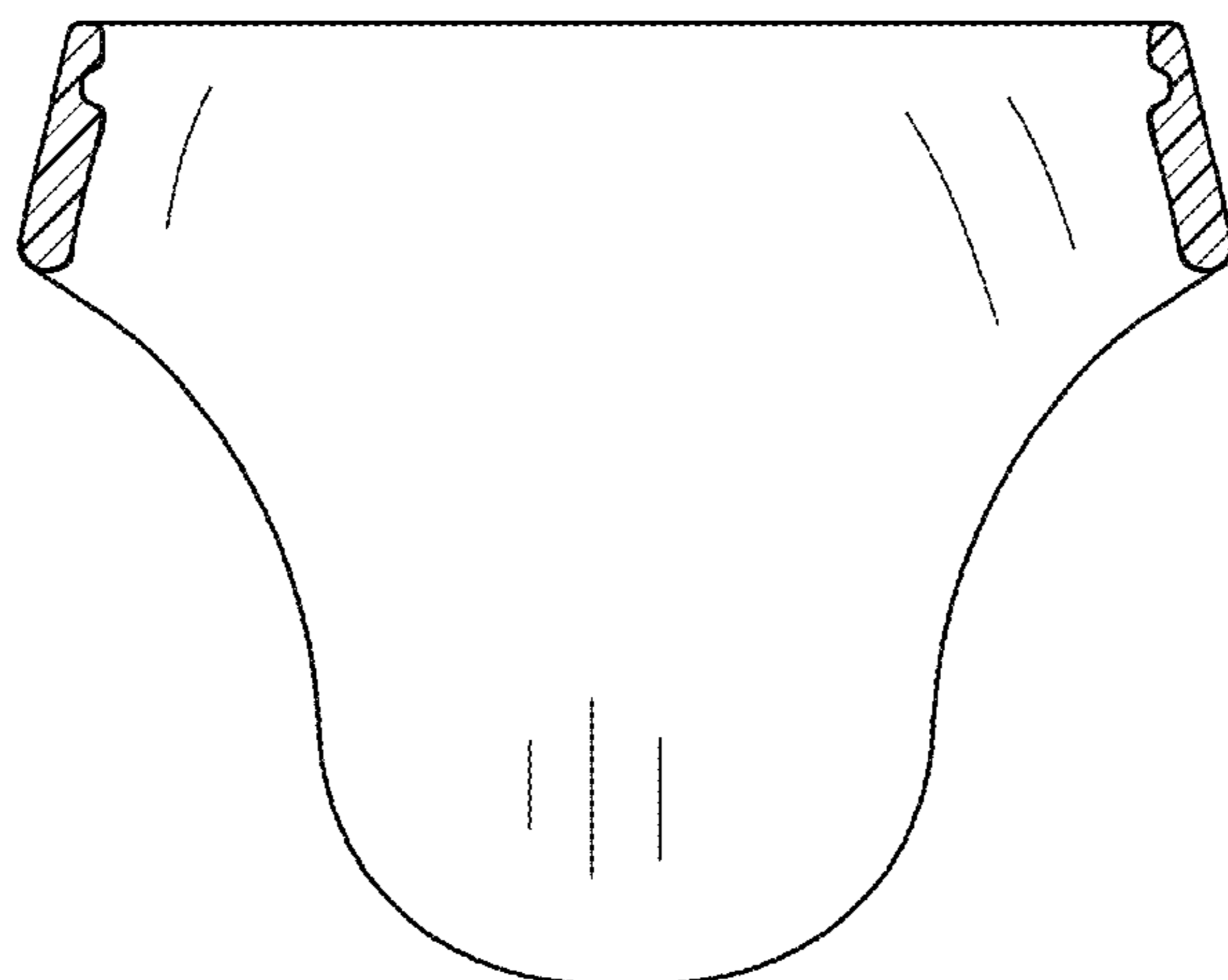

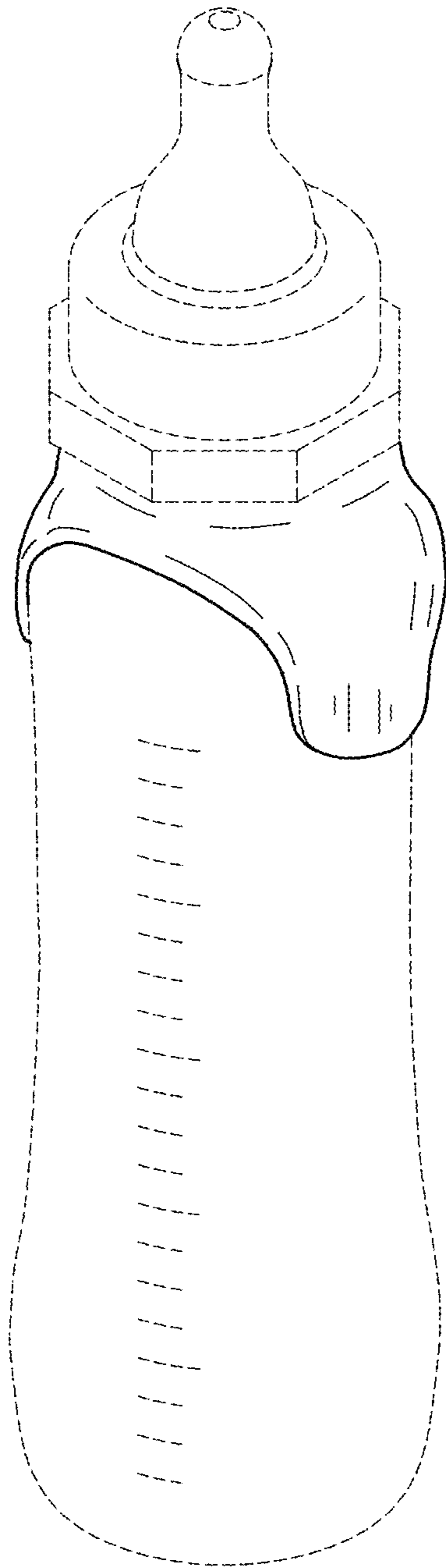
