FIG. 4 is a right side view of FIG. 1.

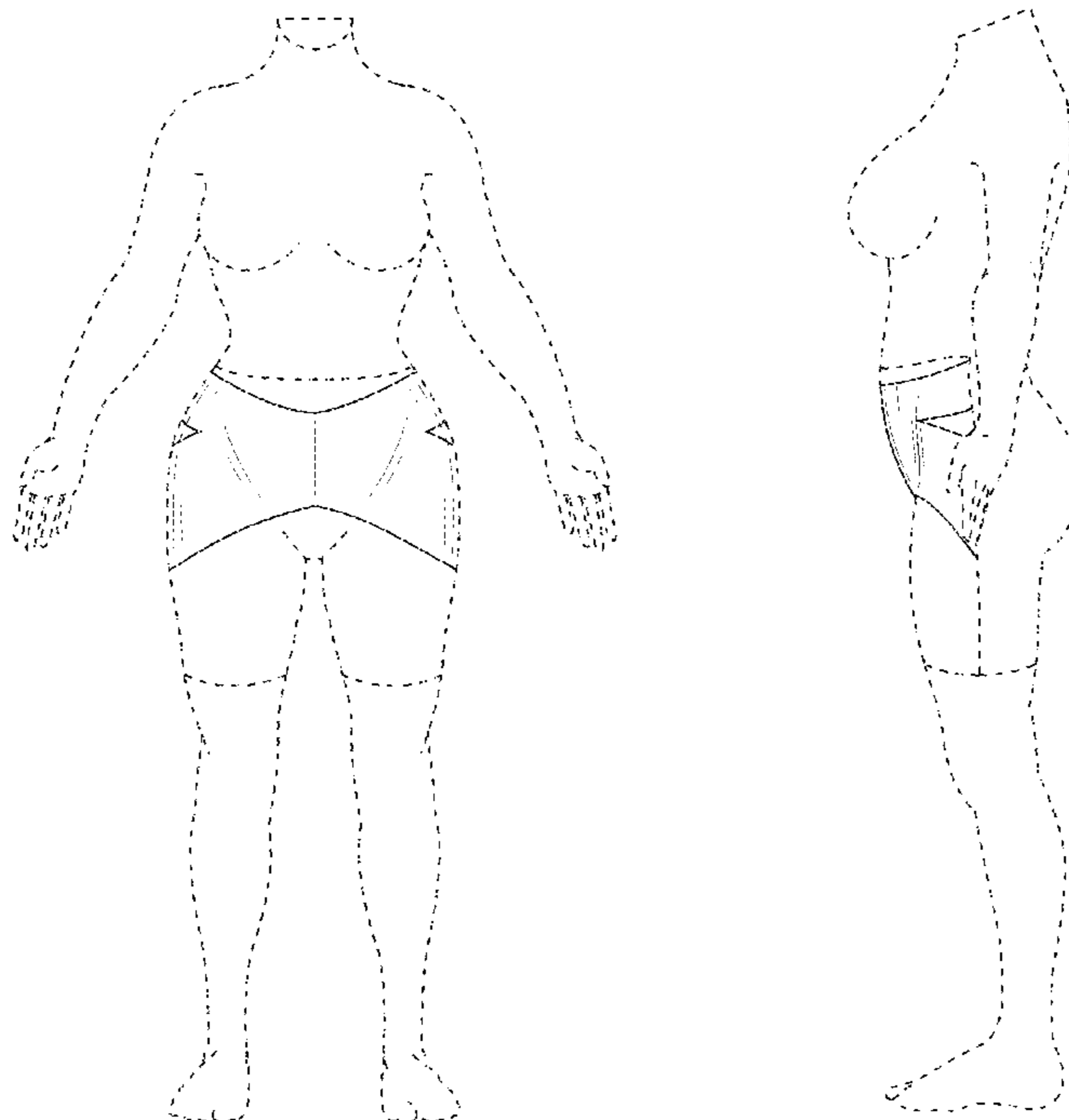
FIG. 5 is a left side view of FIG. 1.

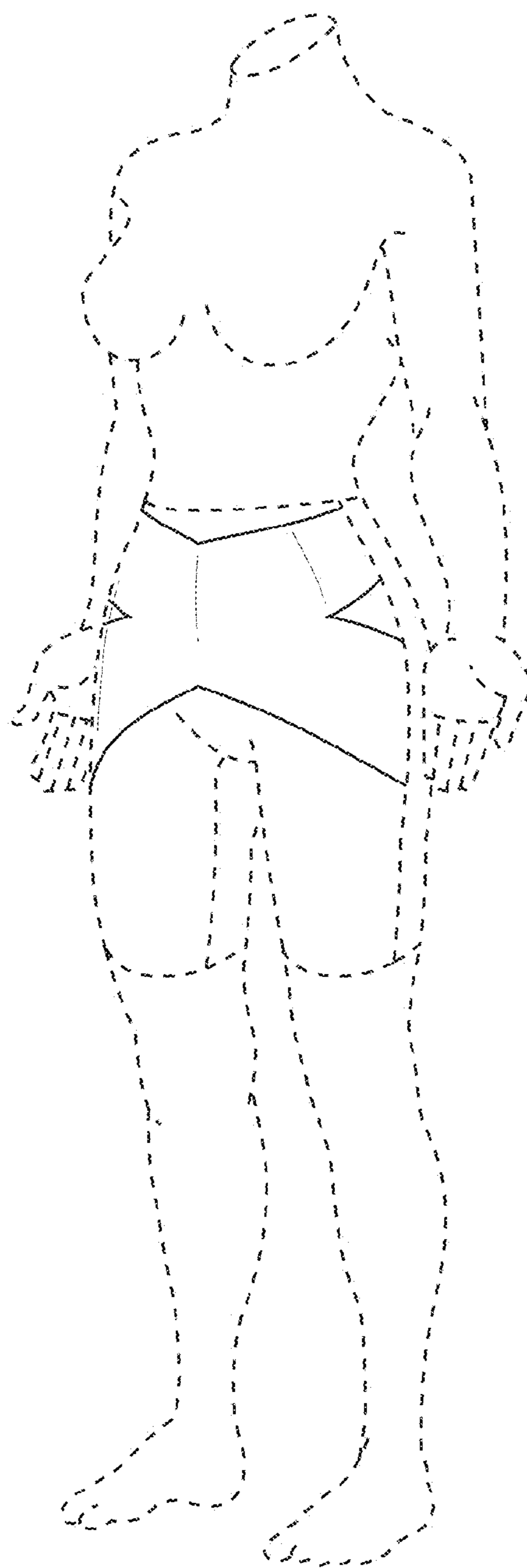
FIG. 6 is a top view of FIG. 1; and,

FIG. 7 bottom view of FIG. 1.

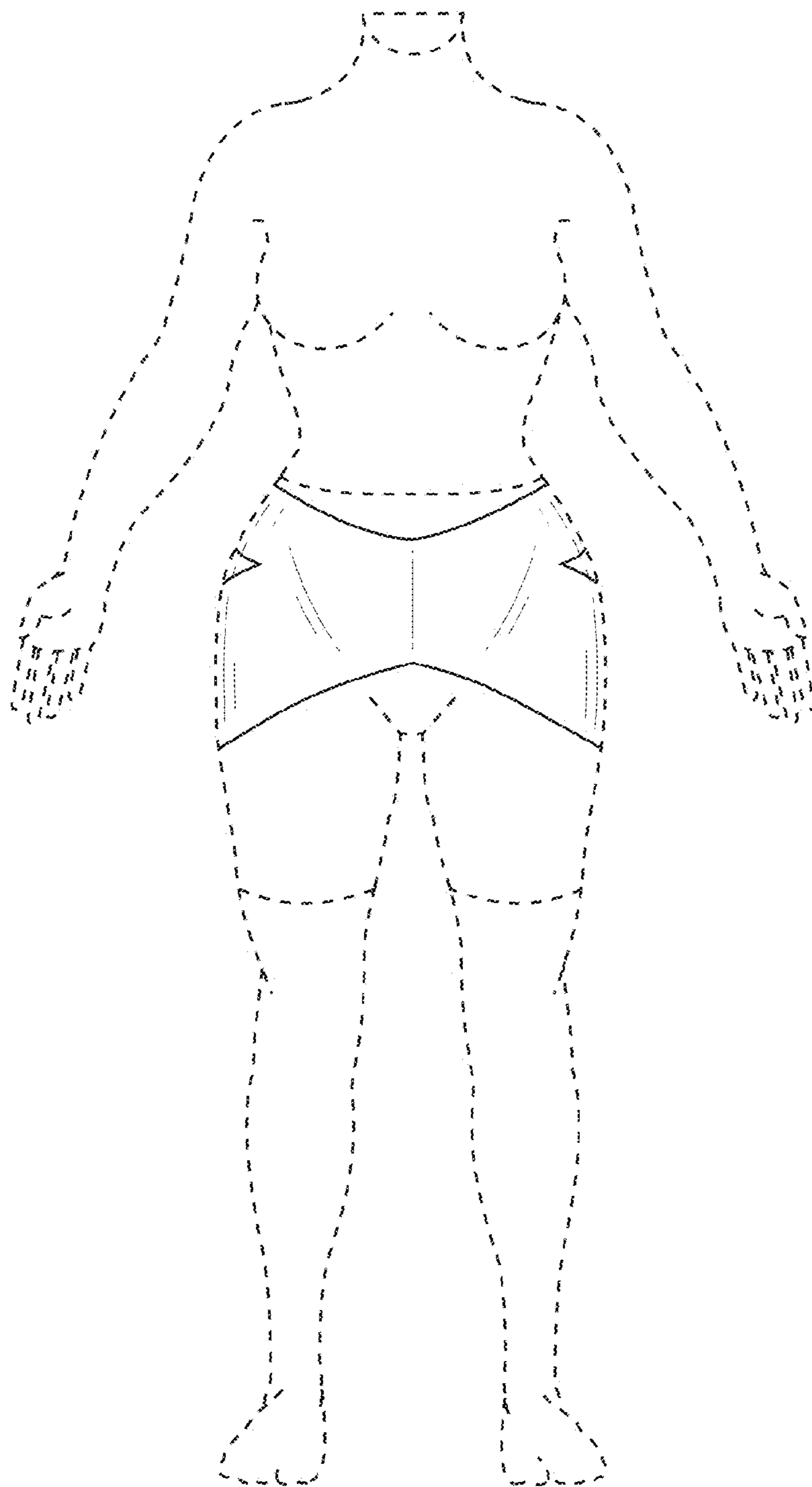
The broken lines, showing the remaining portions of the garment and portions of the human figure, illustrate the design as worn and form no part of the claimed design.

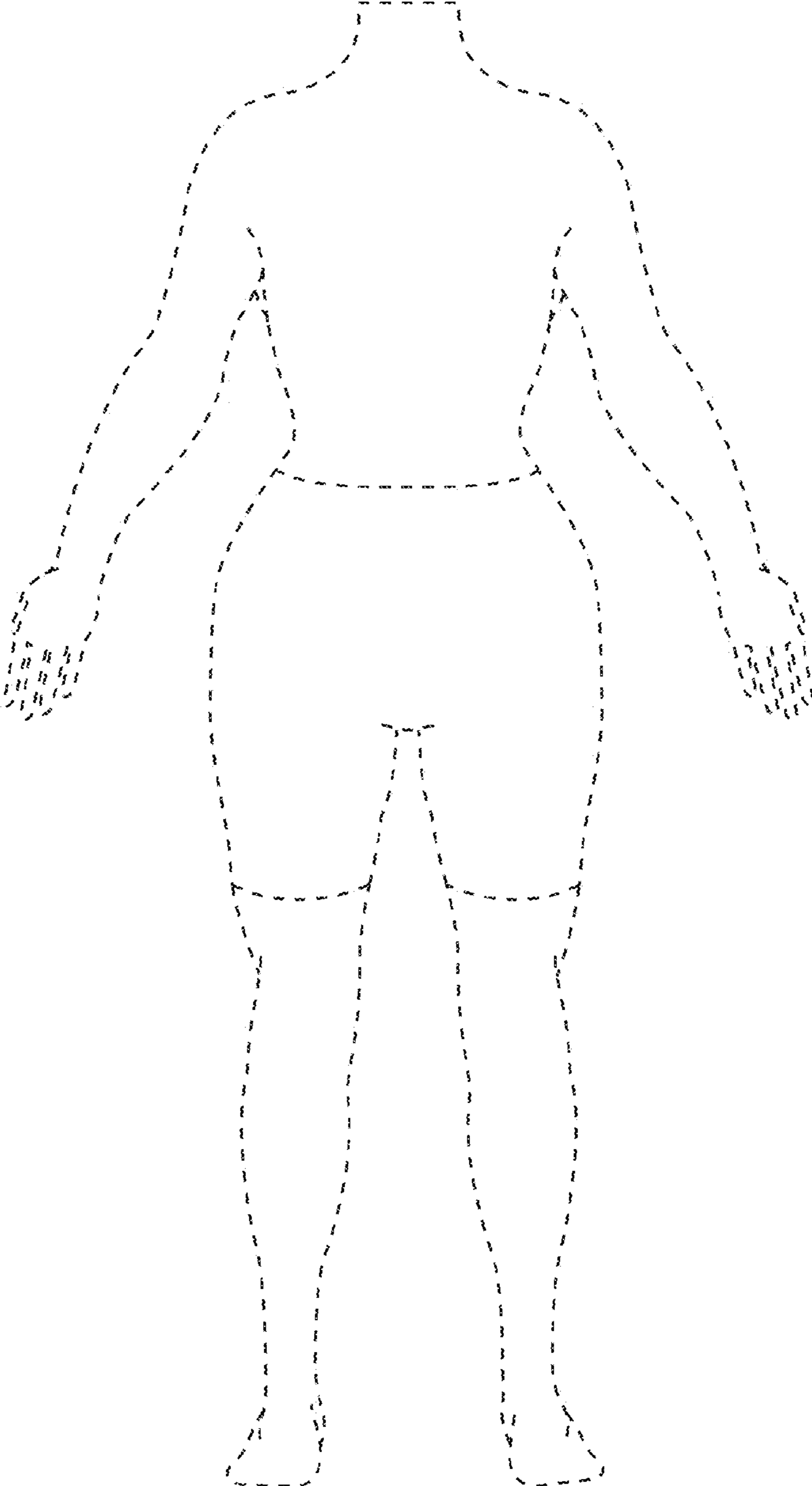




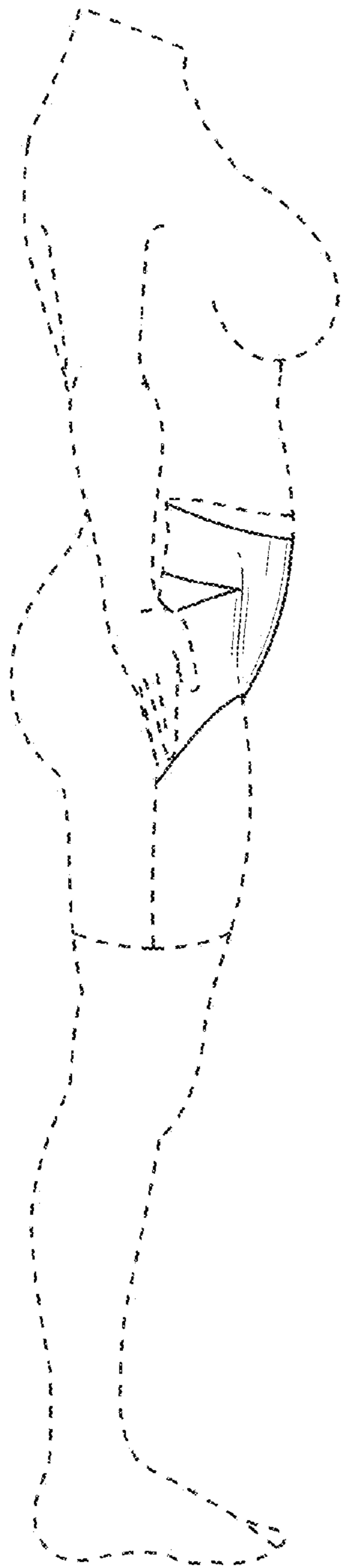

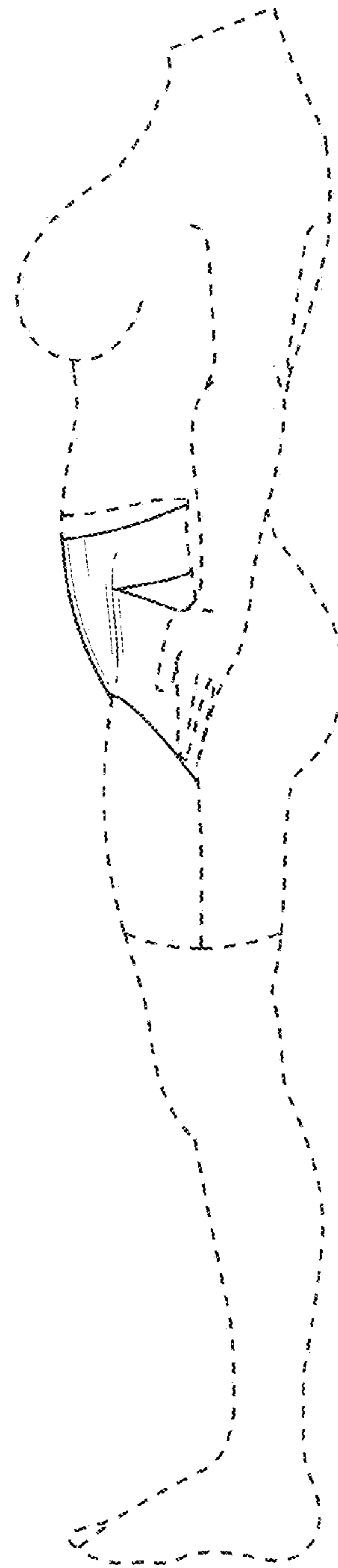

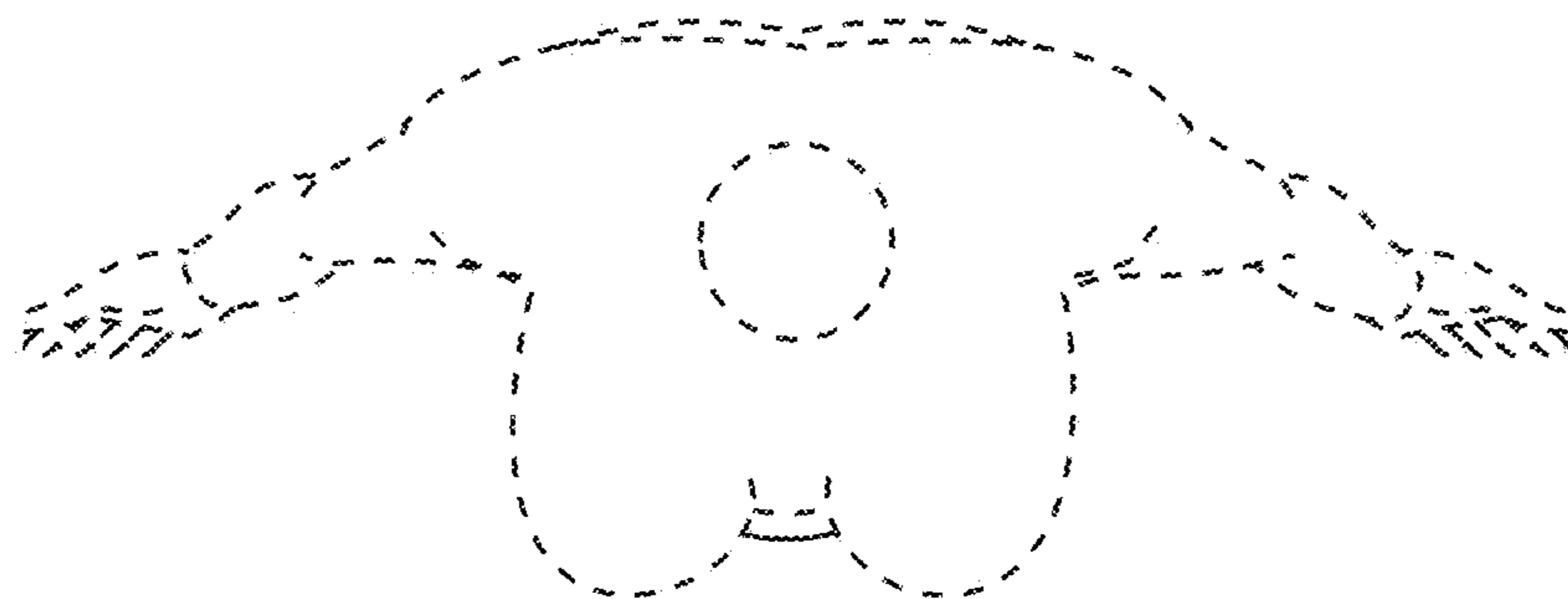

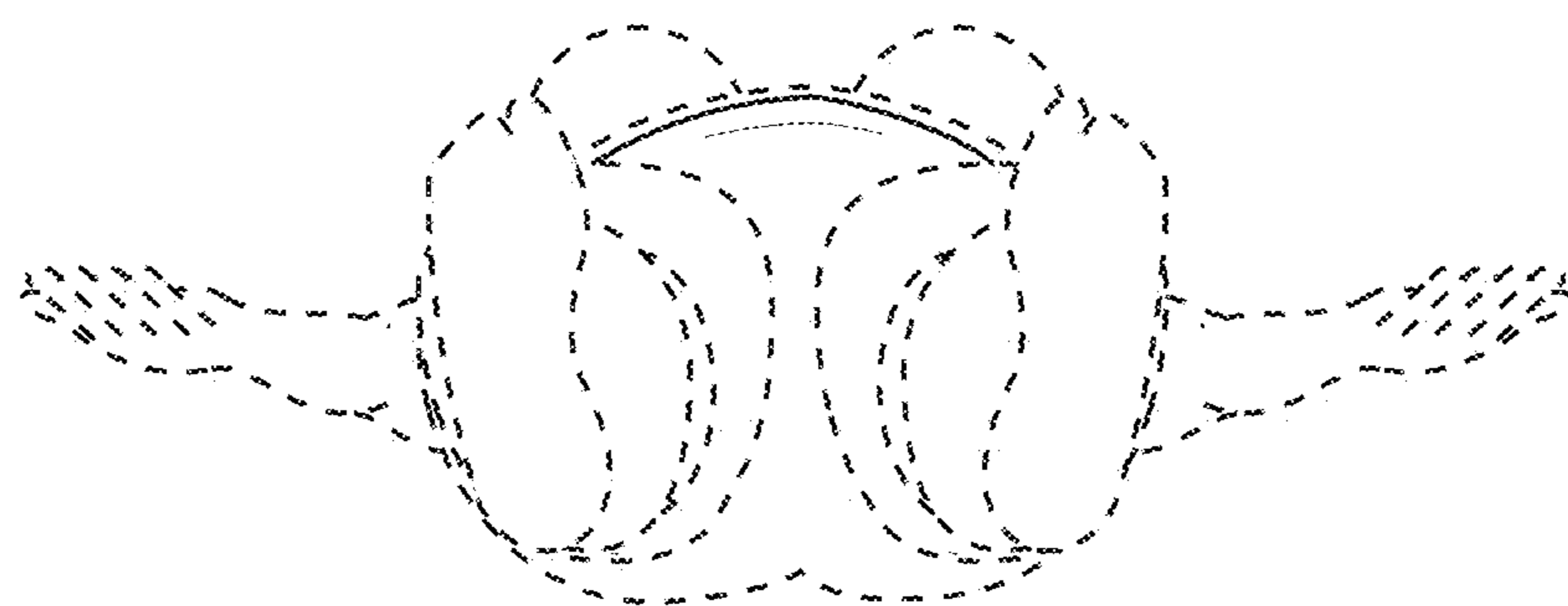
