(57) **CLAIM**
I claim the ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a shoe showing my new design; FIG. 2 is a rear view of the shoe shown in FIG. 1; FIG. 3 is a left side view of the shoe shown in FIG. 1; FIG. 4 is a right side view of the shoe shown in FIG. 1; FIG. 5 is a top view of the shoe shown in FIG. 1; FIG. 6 is a bottom view of the shoe shown in FIG. 1; and, FIG. 7 is a perspective view of the shoe shown in FIG. 1. The broken lines shown on the shoe represent thread stitching.

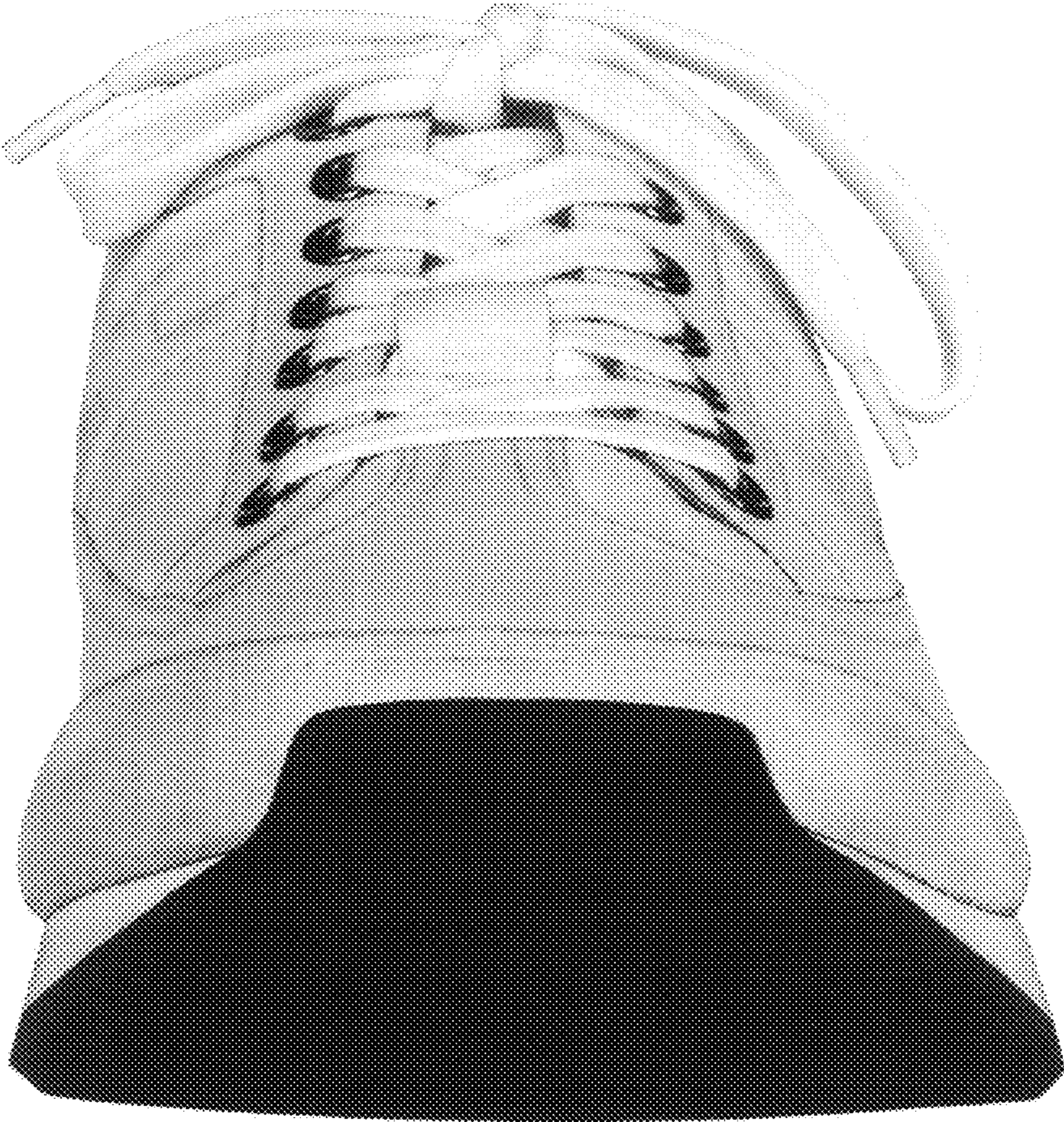

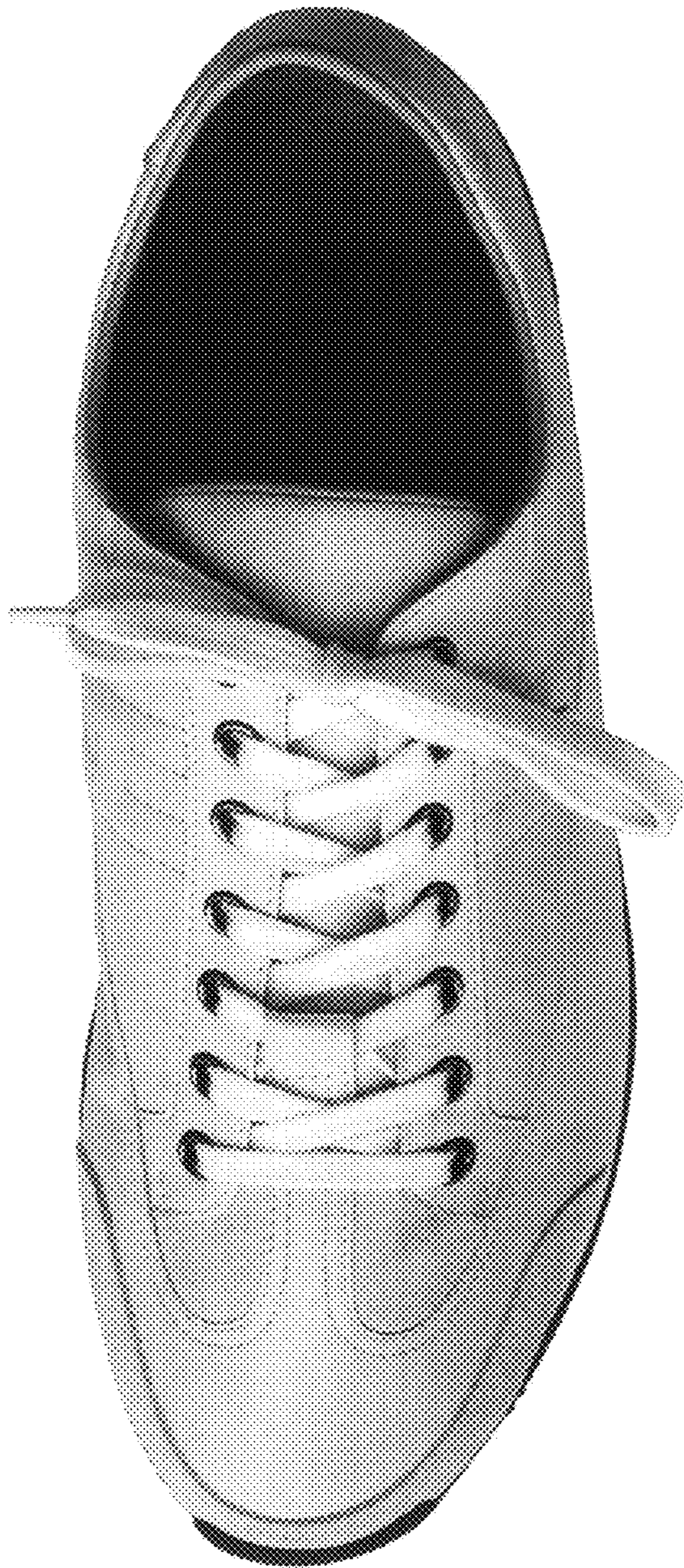
