The ornamental design for carrier for portable electronic devices, as shown and described.

DESCRIPTION

FIG. 1 is a left front perspective view of a carrier for portable electronic devices showing my new design;
FIG. 2 is a second left front perspective view thereof shown in a configuration of use;
FIG. 3 is a third left front perspective view thereof shown in an alternate configuration of use;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a left side elevational view thereof;
FIG. 8 is top plan view thereof; and,
FIG. 9 is a bottom plan view thereof.

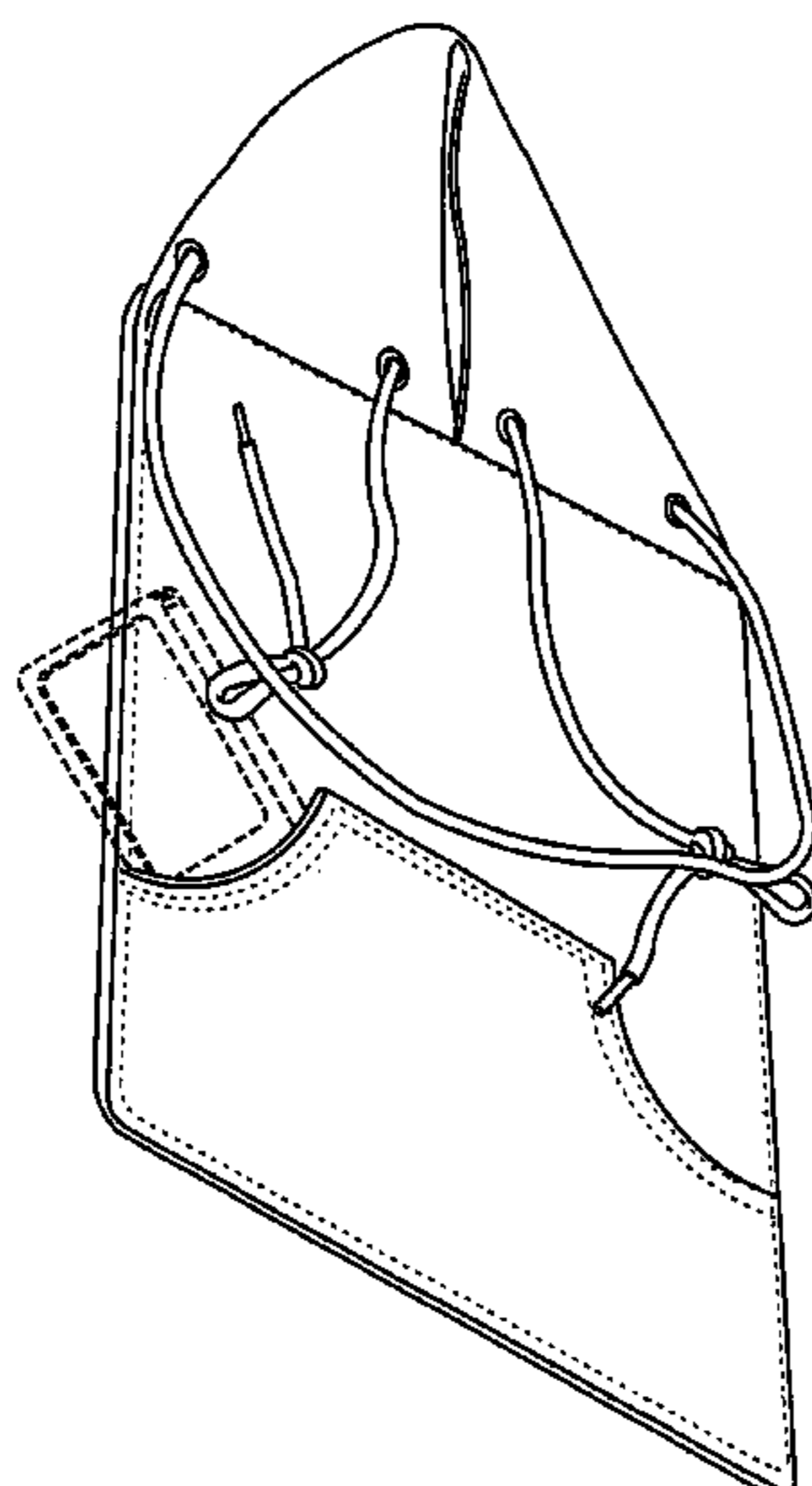

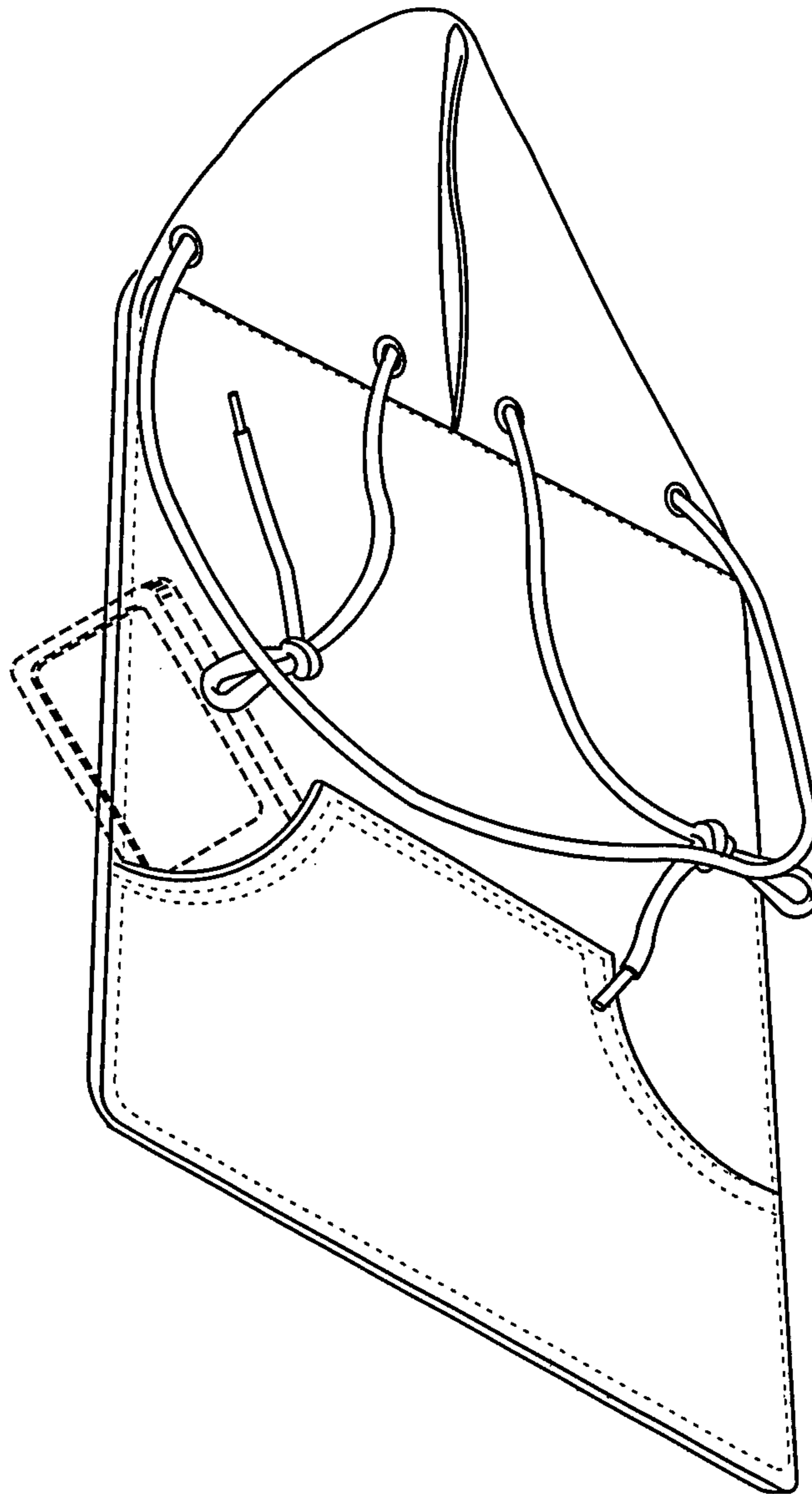

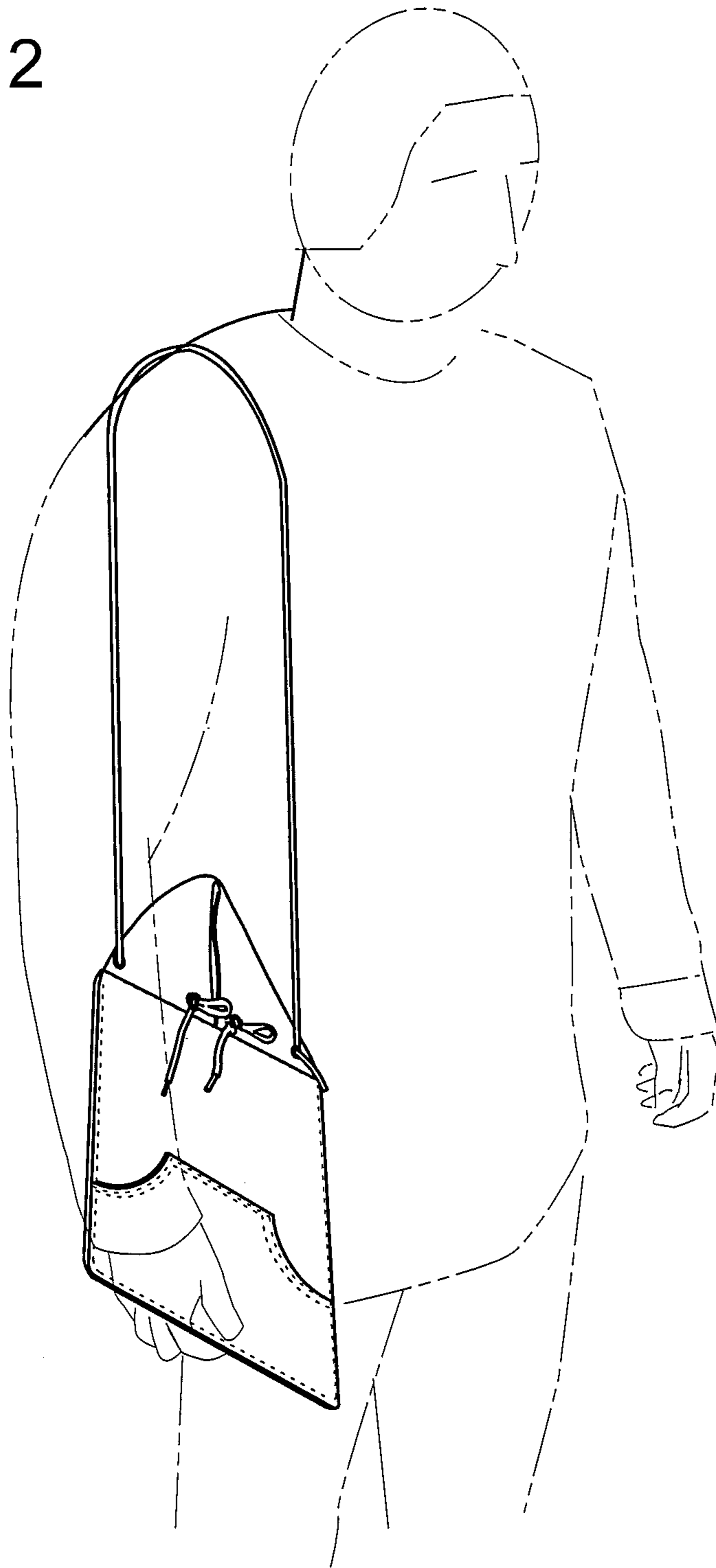

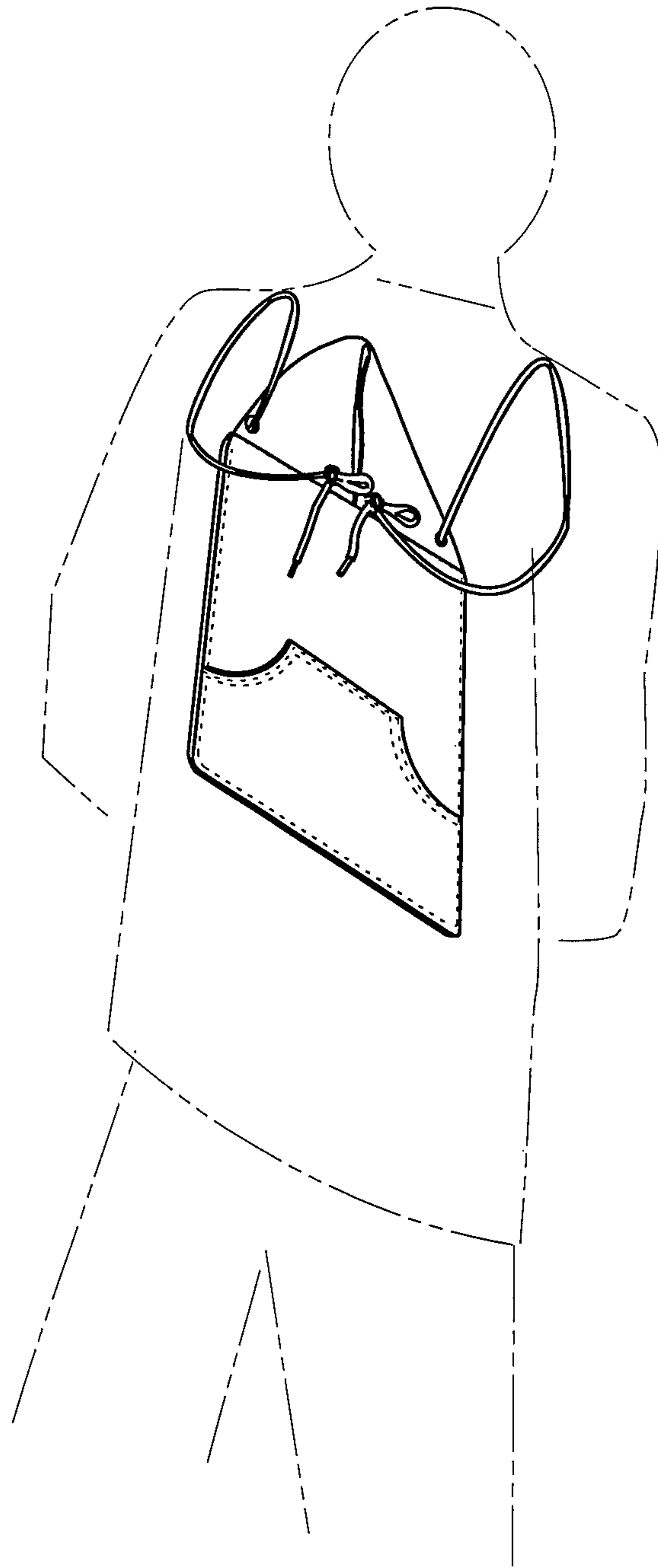

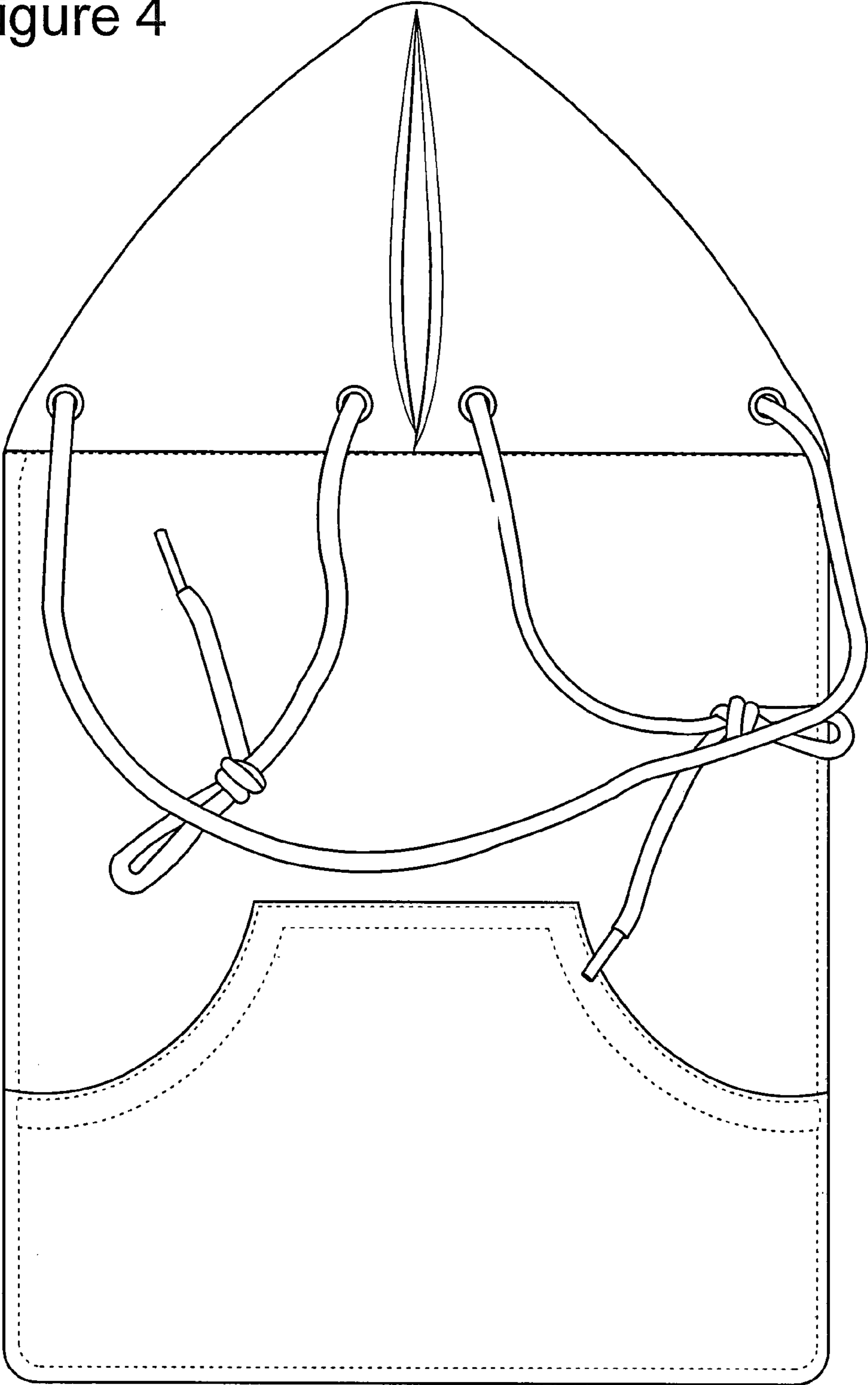

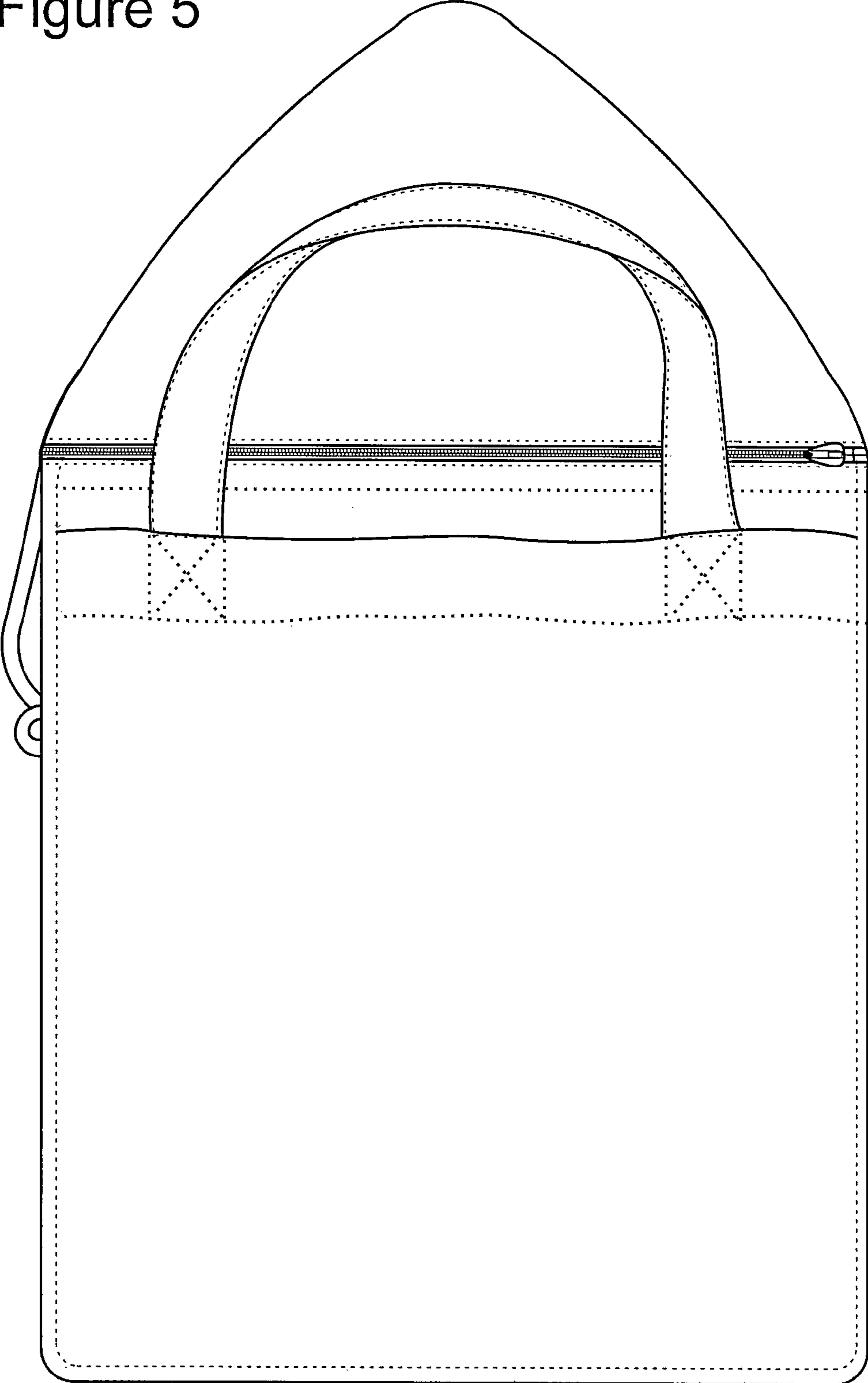

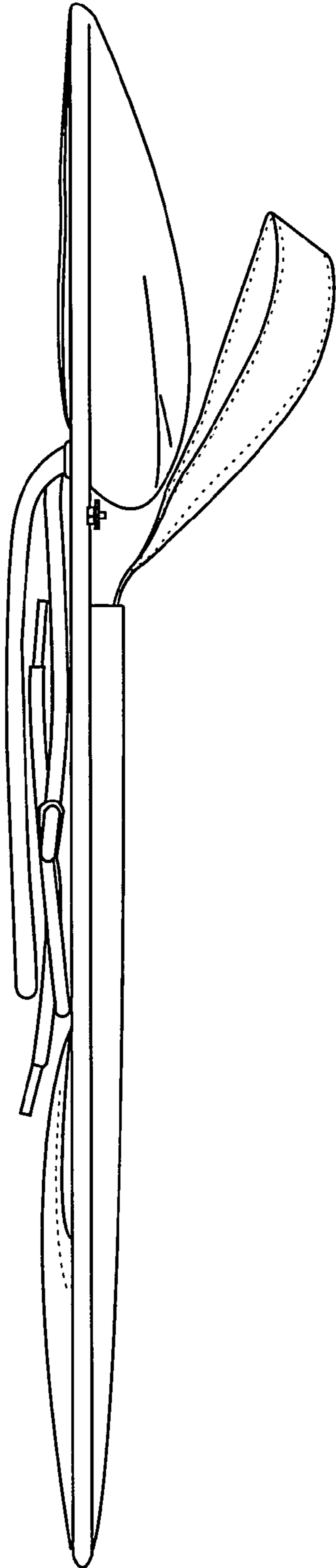

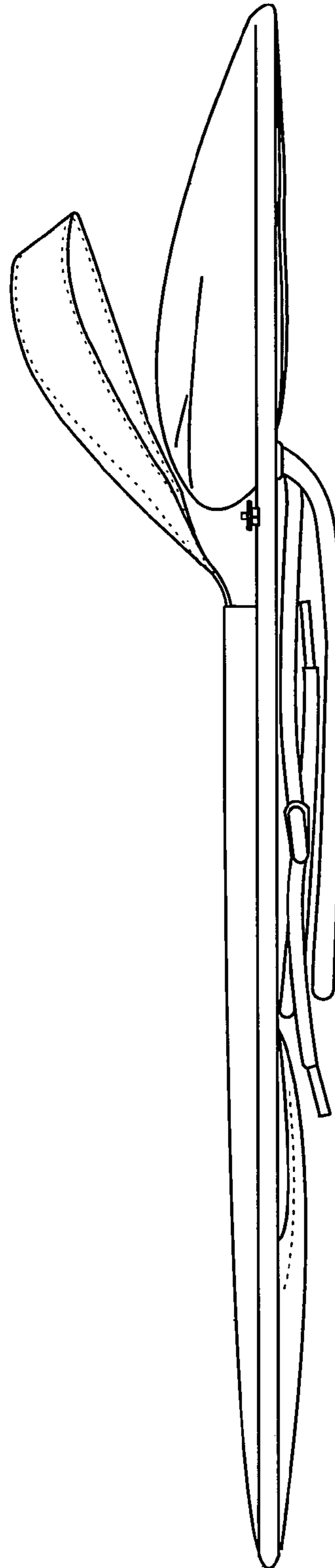

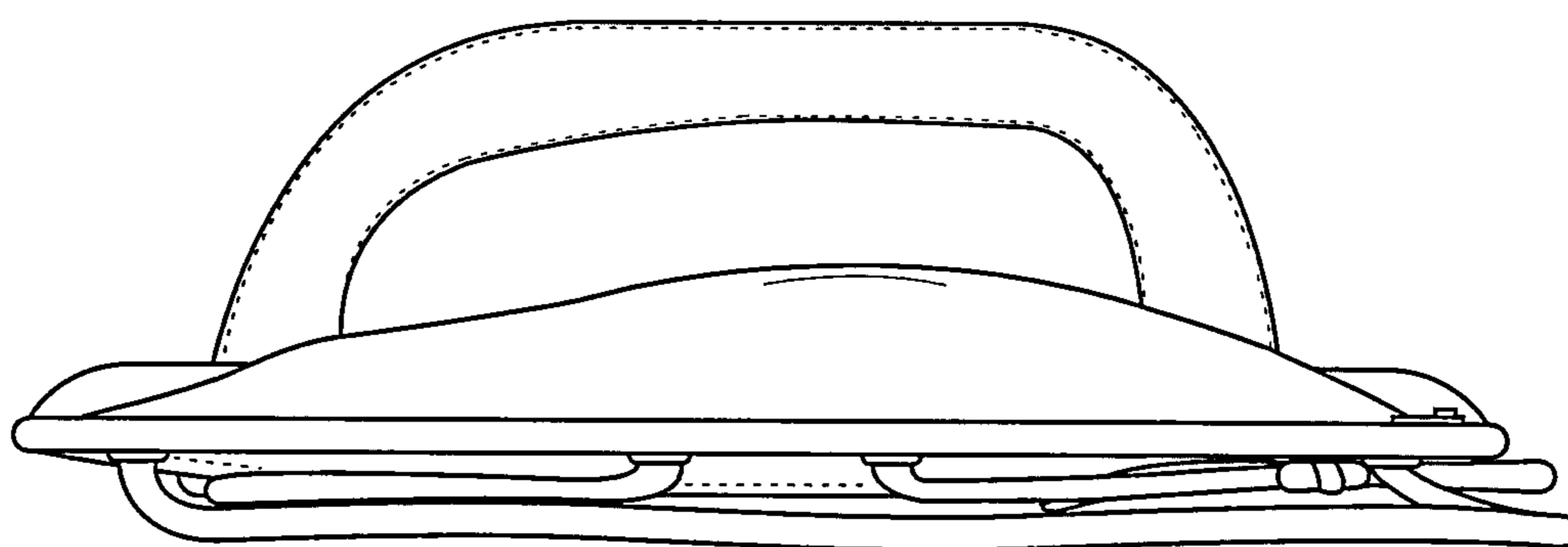
