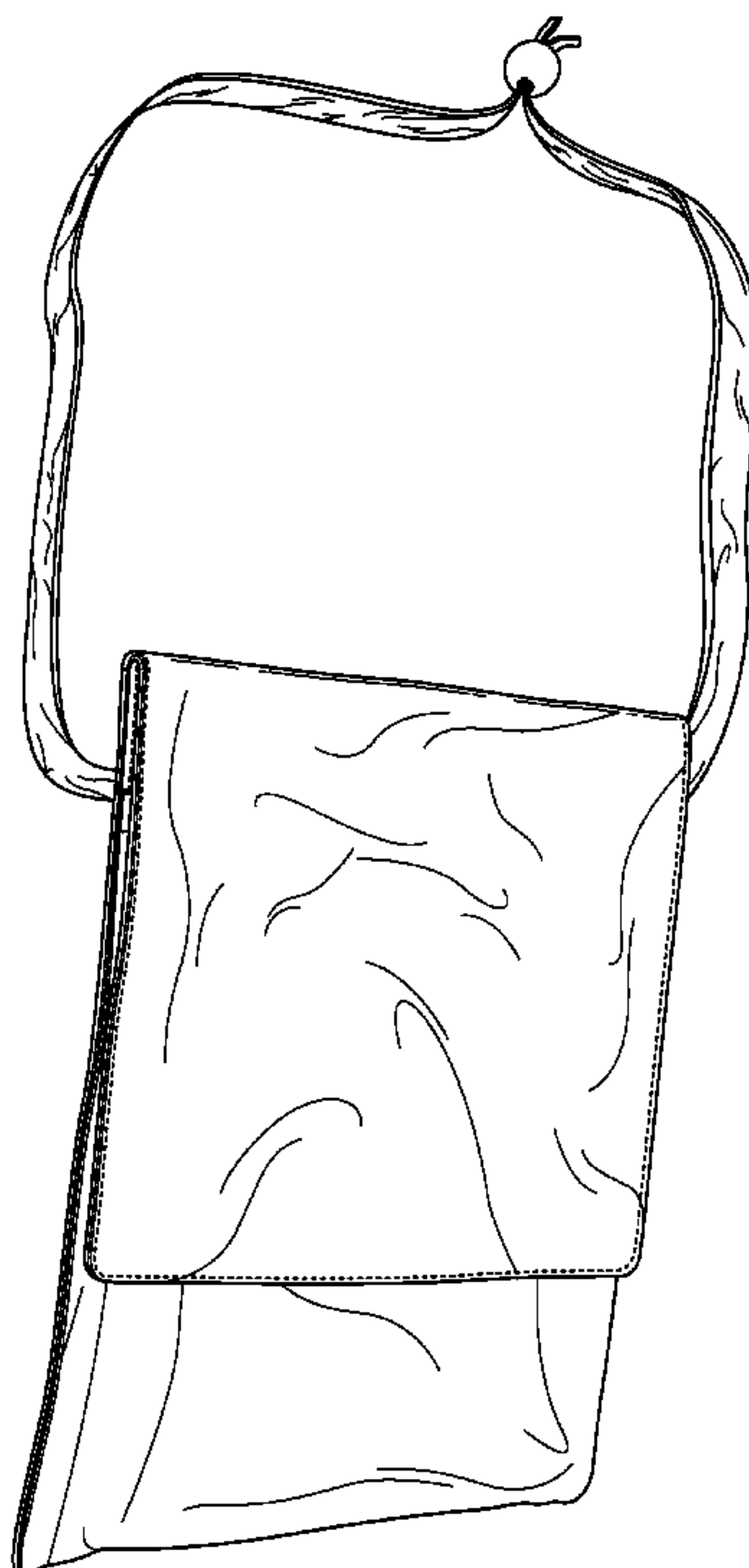
(57) **CLAIM**

The ornamental design for a pouch, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pouch according to our new design shown in a closed position;
FIG. 2 is a perspective view of the pouch of FIG. 1 shown in an open position;
FIG. 3 is a partial rear side perspective view of the pouch of FIG. 2;
FIG. 4 is a front view of the pouch of FIG. 2;
FIG. 5 is a rear view of the pouch of FIG. 2;
FIG. 6 is a right side view of the pouch of FIG. 2;
FIG. 7 is a left side view of the pouch of FIG. 2;
FIG. 8 is a top view of the pouch of FIG. 2;
FIG. 9 is a bottom view of the pouch of FIG. 2; and,
FIG. 10 is an exploded perspective view of another embodiment of the pouch of FIG. 2 without the strap.
The broken lines shown in the drawings are understood to represent stitching.

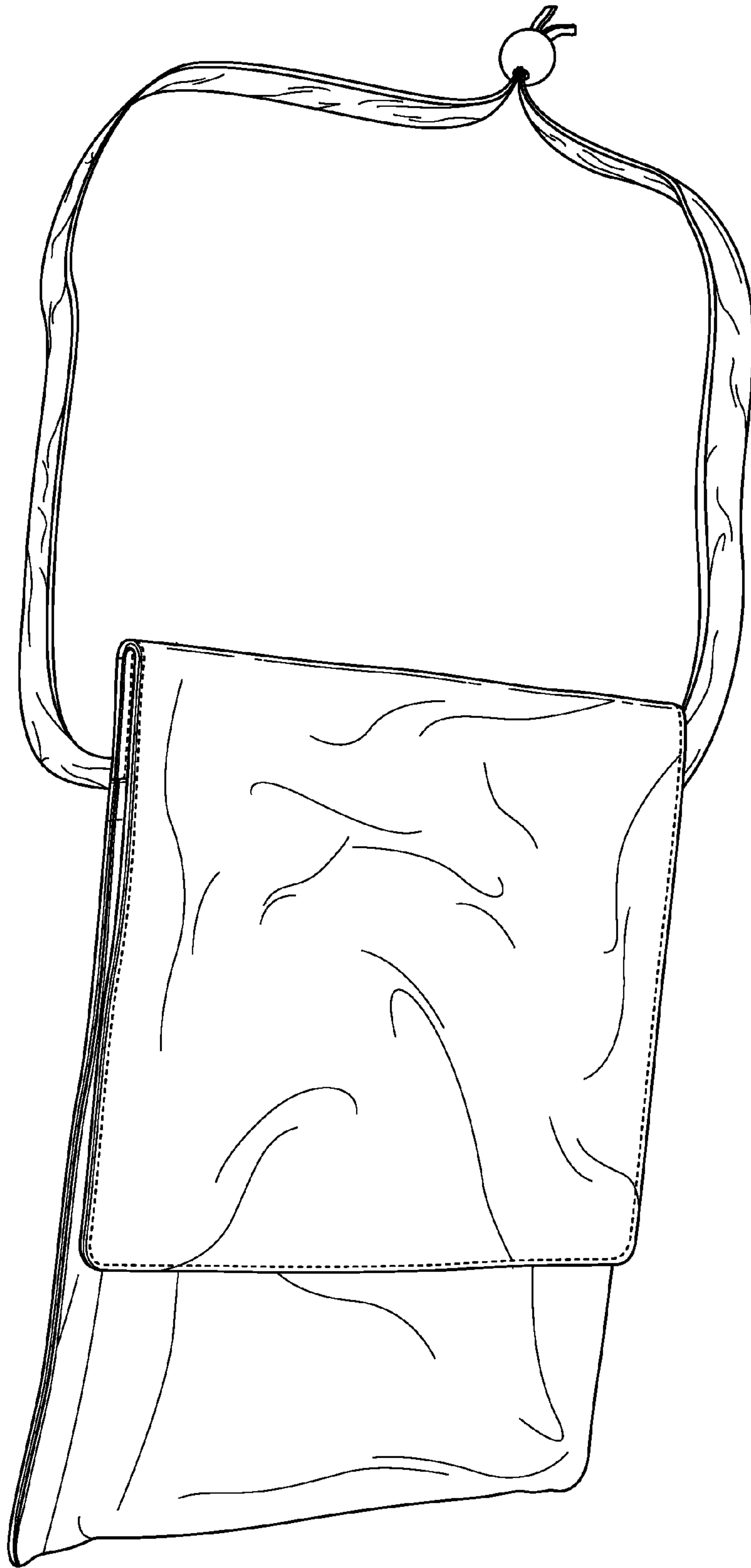

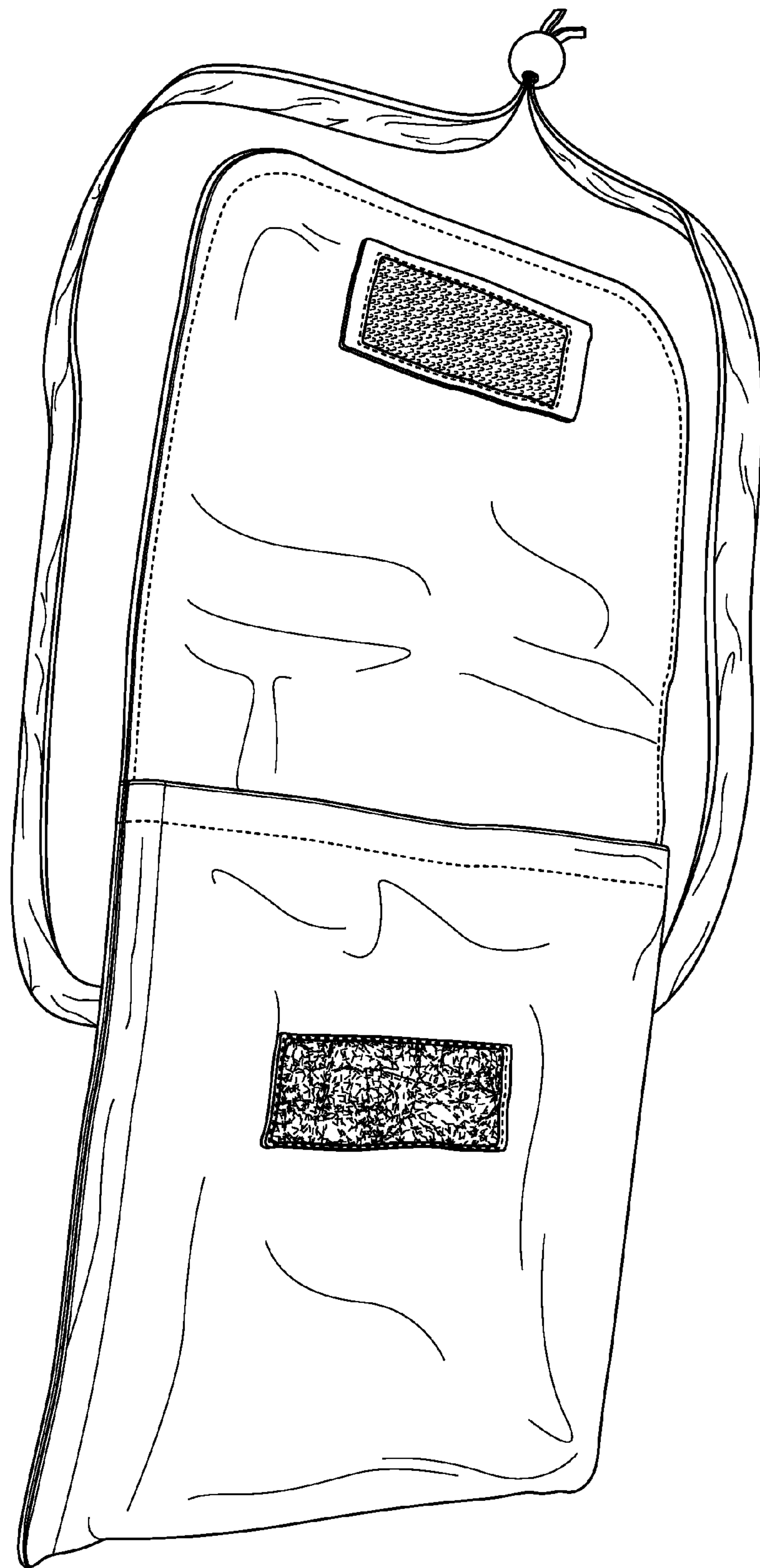

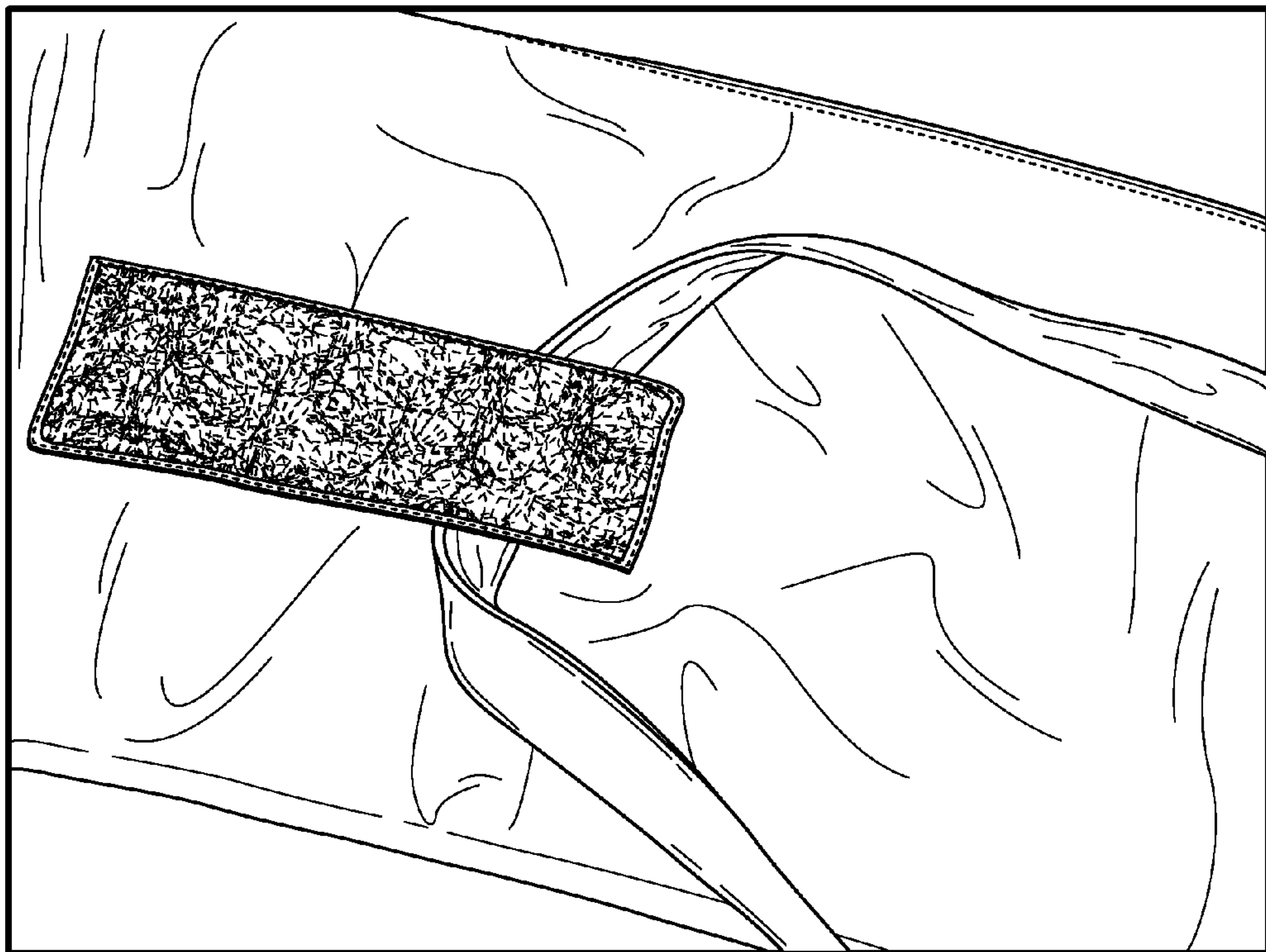

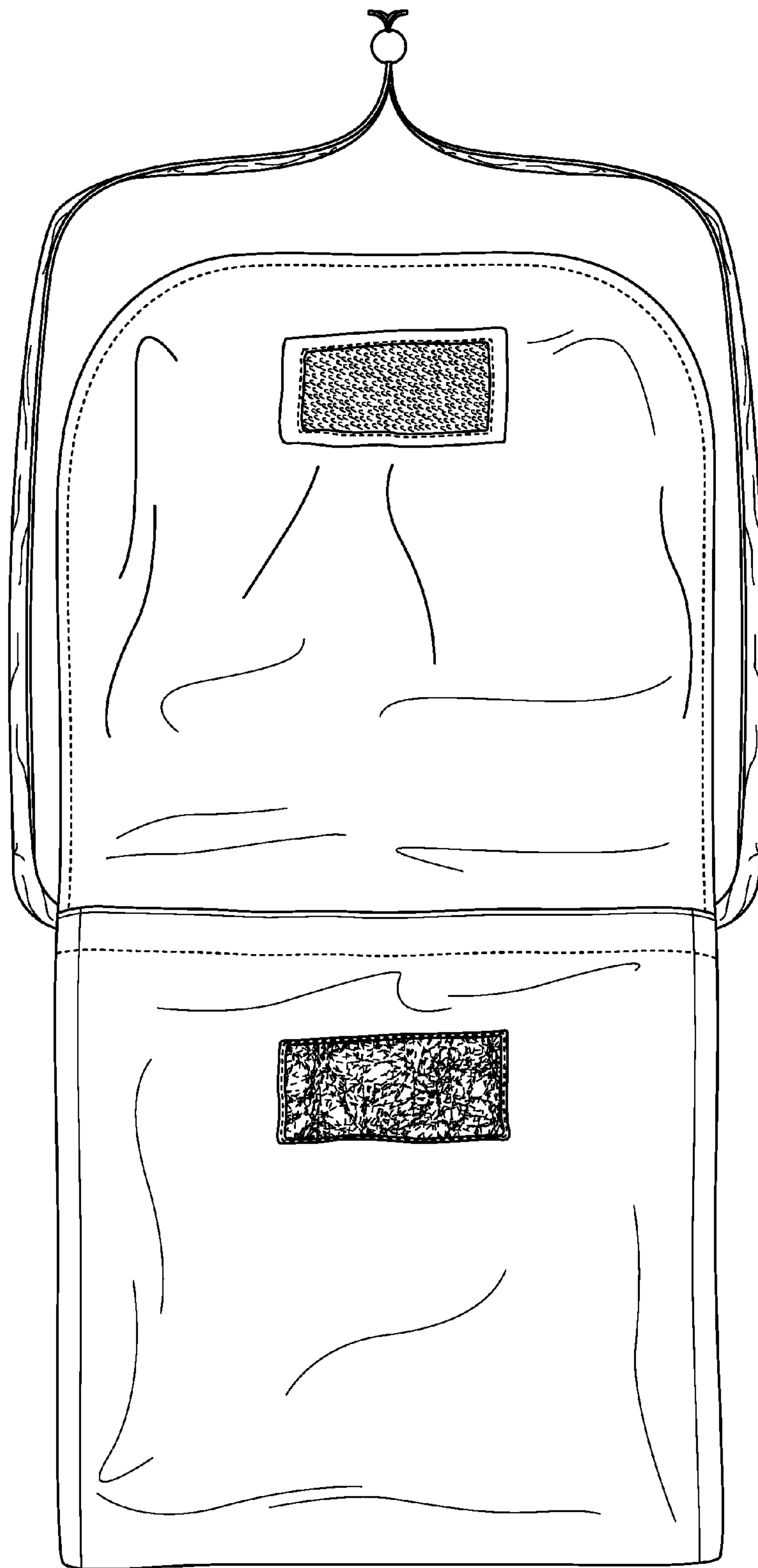

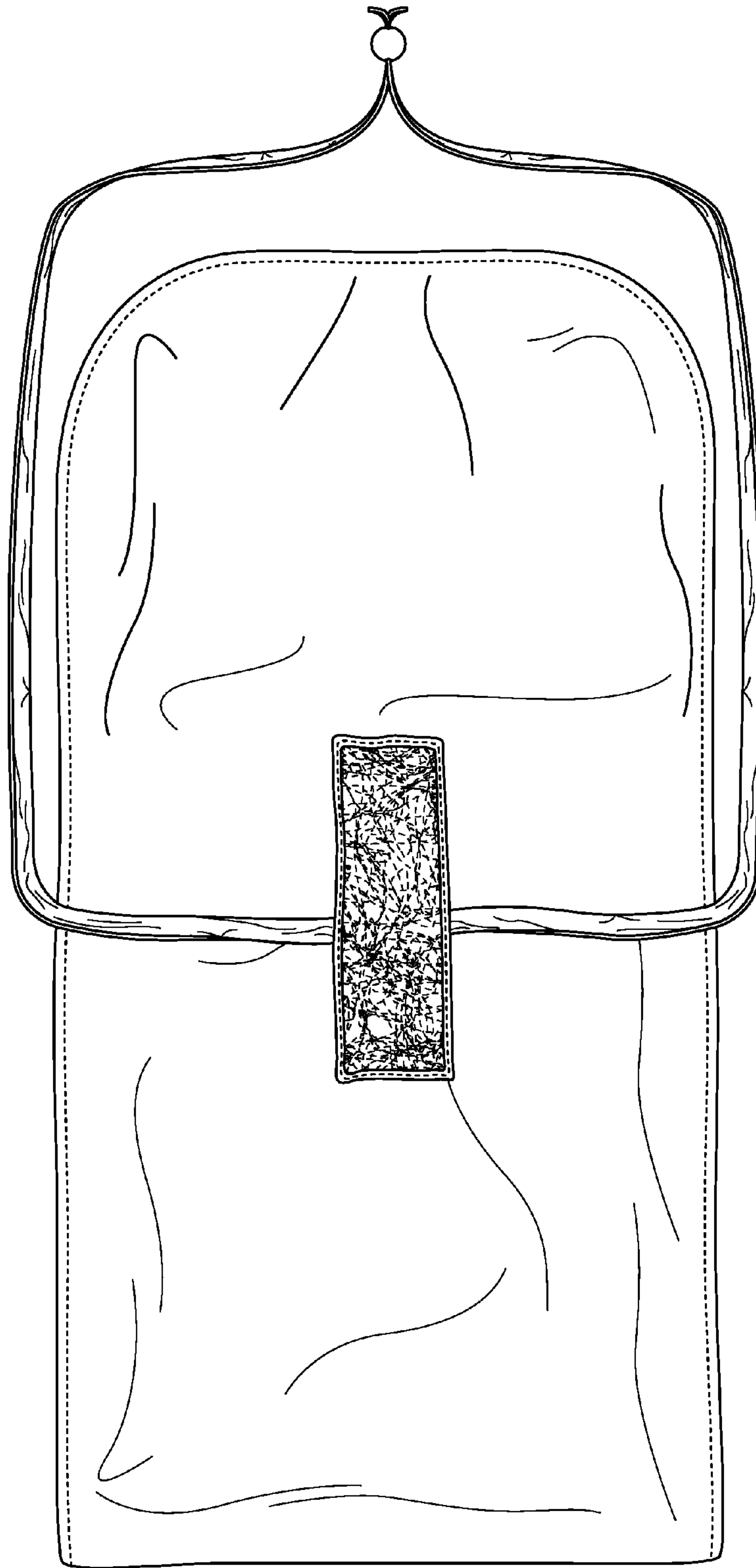

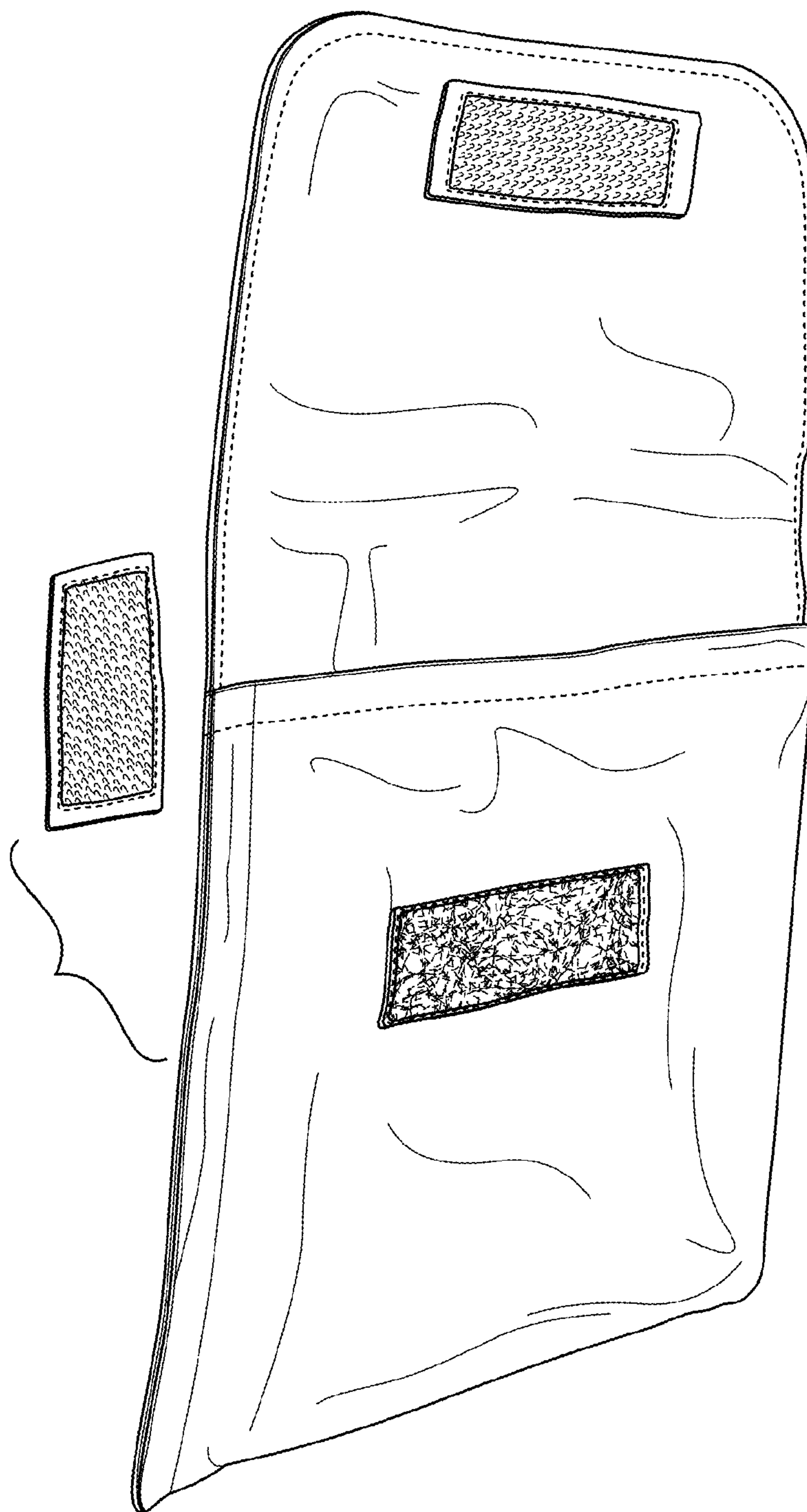
