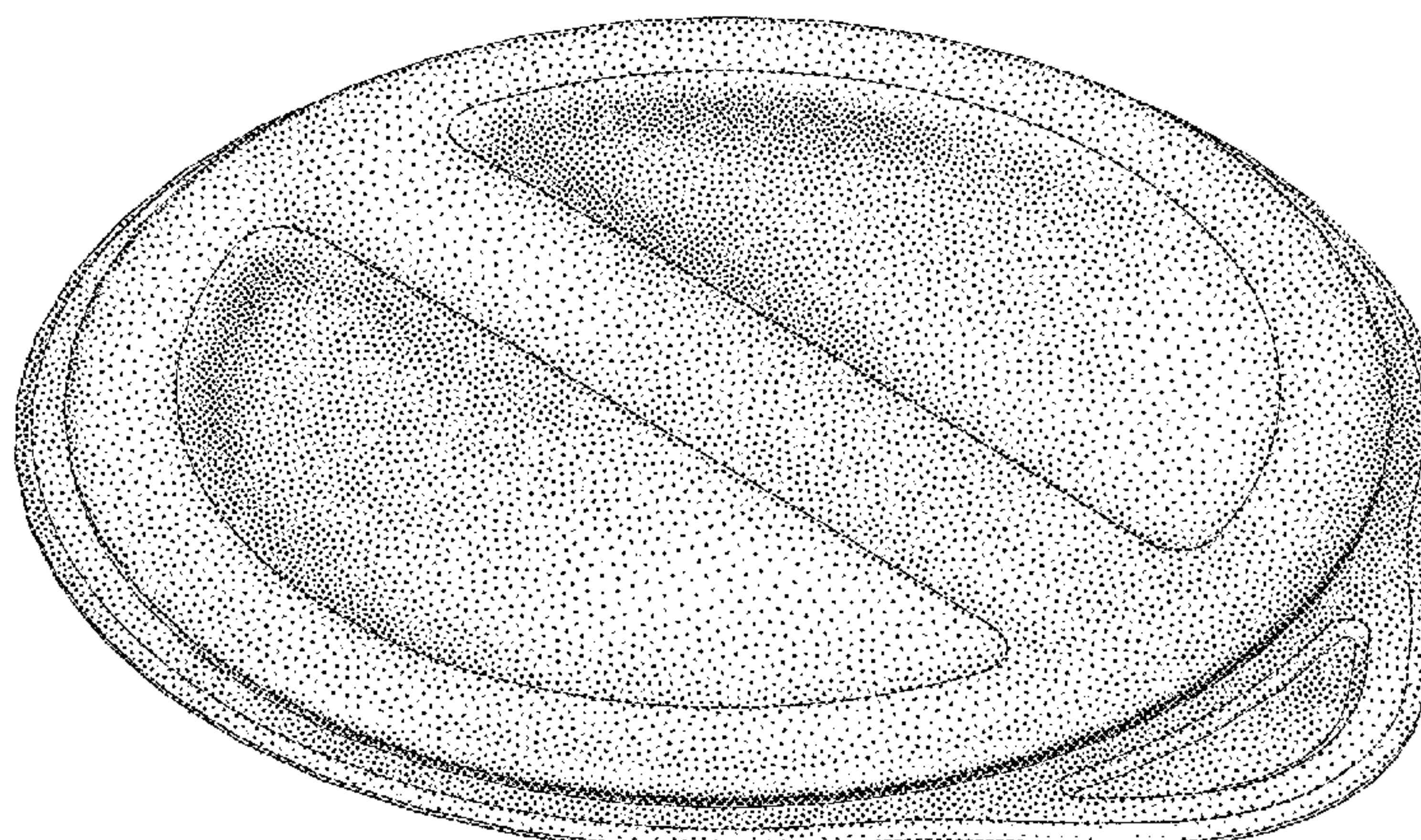
(57) **CLAIM**

We claim the ornamental design for an outside snap on lid for disposable stand mixer bowl liner, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the outside snap on lid for disposable stand mixer bowl liner of our design;  
FIG. 2 is a bottom perspective view of the outside snap on lid for disposable stand mixer bowl liner;  
FIG. 3 is a first side elevational view of the outside snap on lid for disposable stand mixer bowl liner;  
FIG. 4 is a second side elevational view of the outside snap on lid for disposable stand mixer bowl liner;  
FIG. 5 is a third side elevational view of the outside snap on lid for disposable stand mixer bowl liner;  
FIG. 6 is a top plan view of the outside snap on lid for disposable stand mixer bowl liner; and,

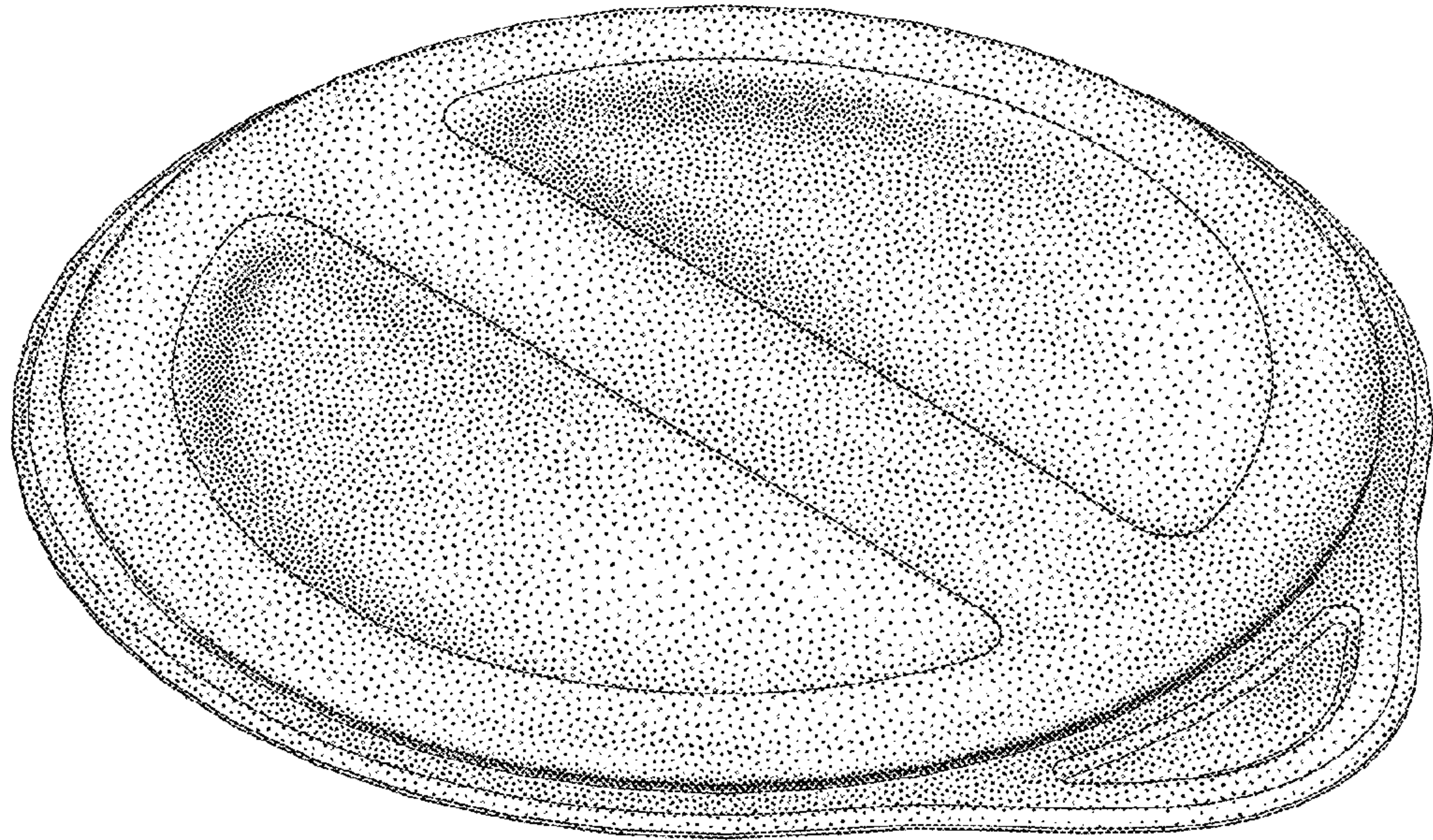

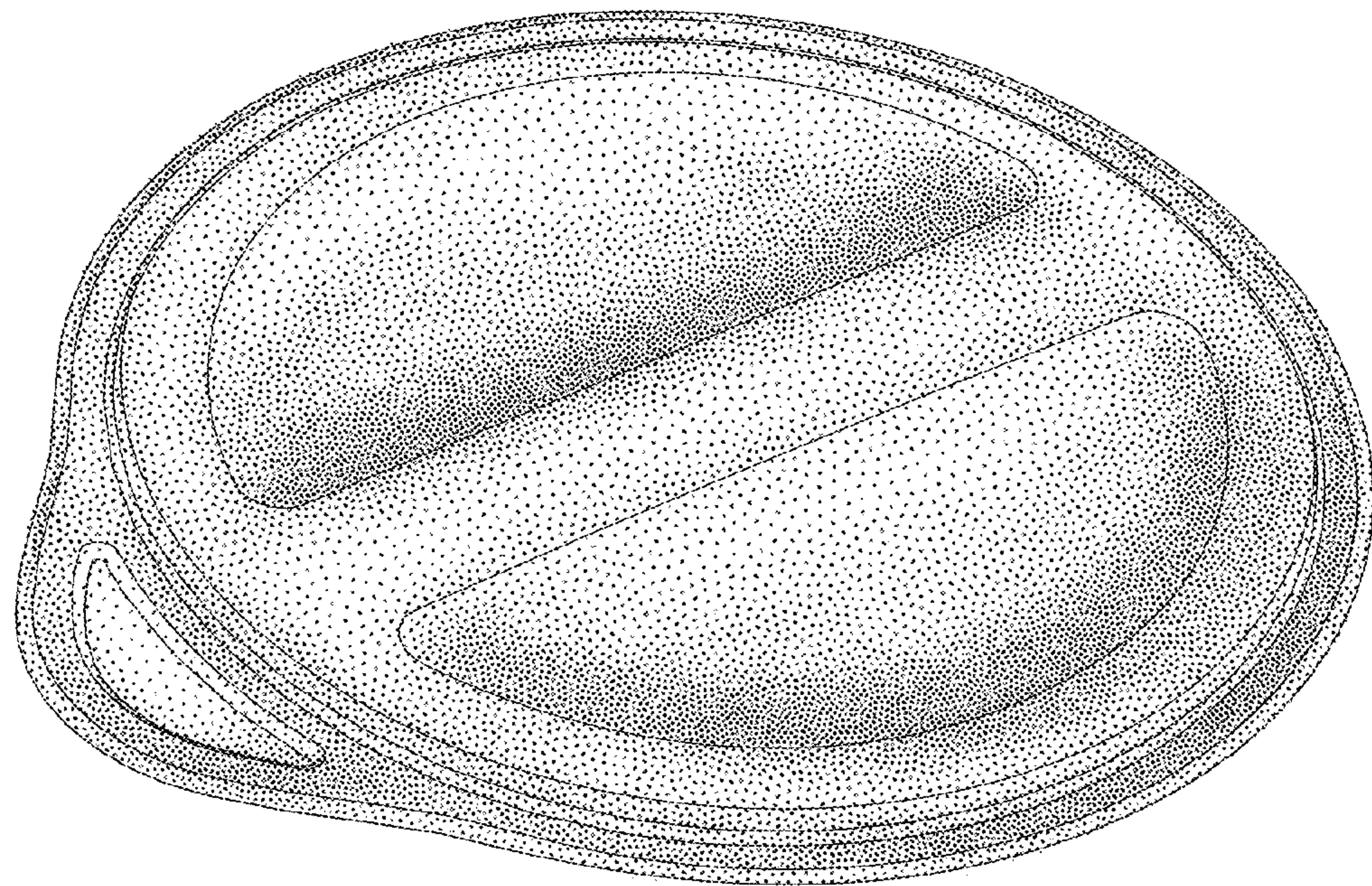

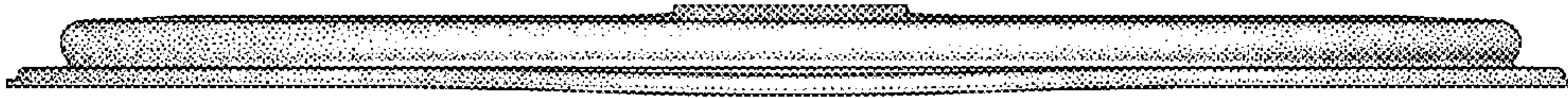

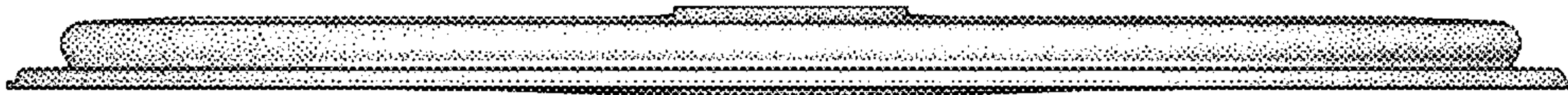

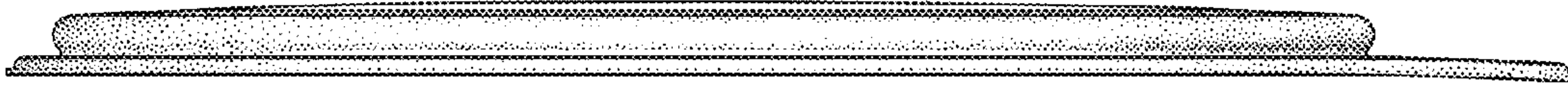

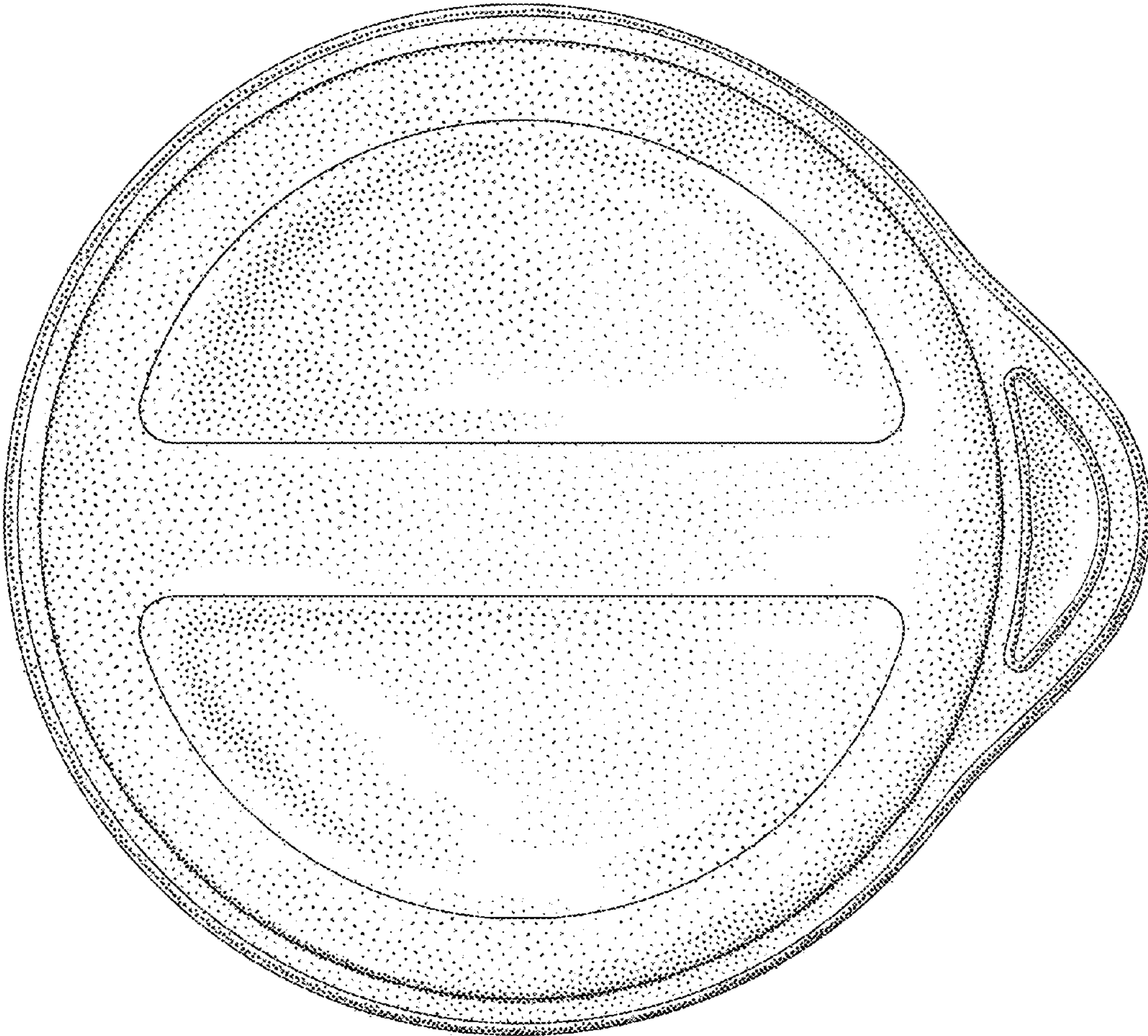

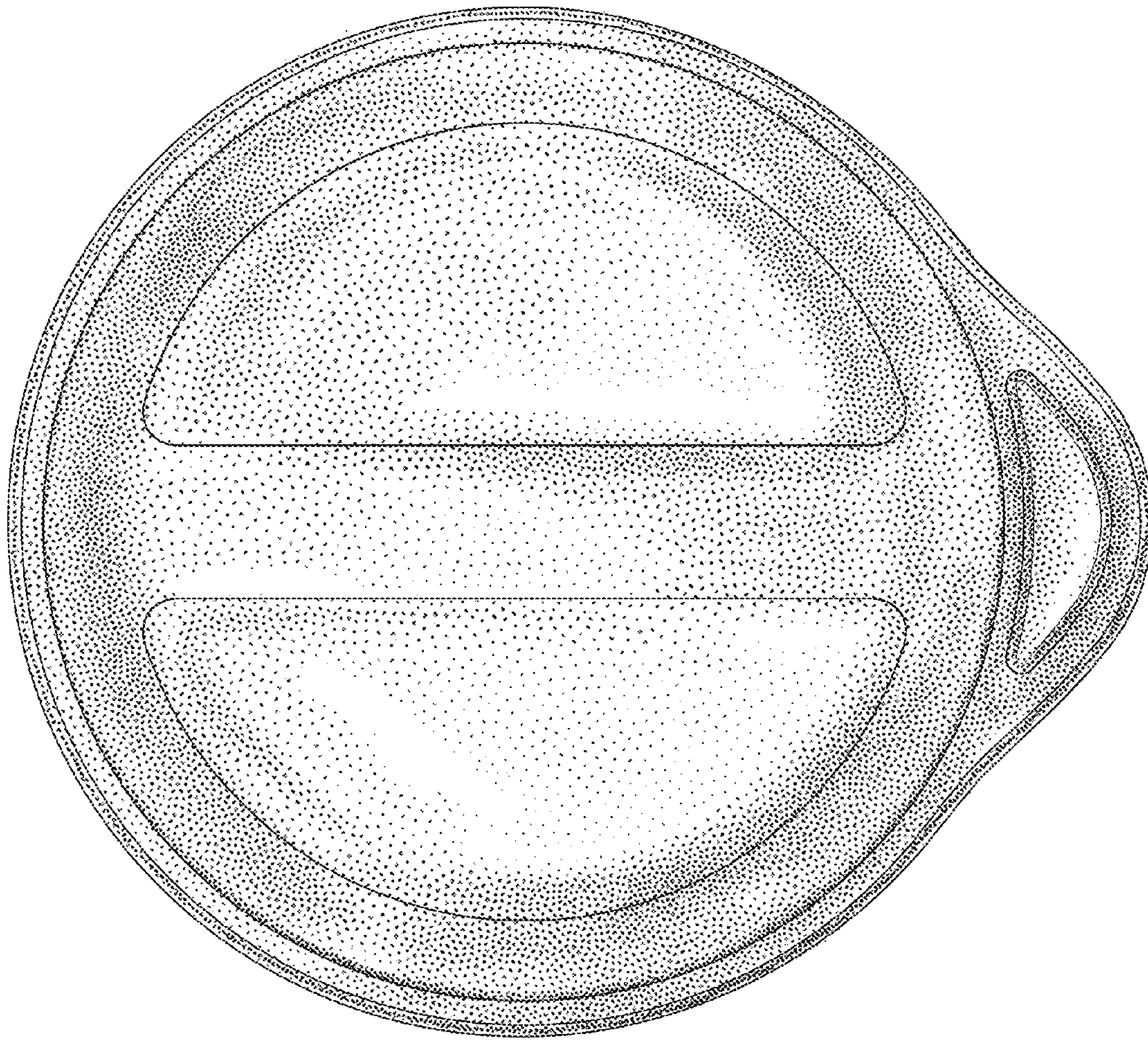
