FIG. 2 is a top plan view of the can opening tab with large head of FIG. 1.

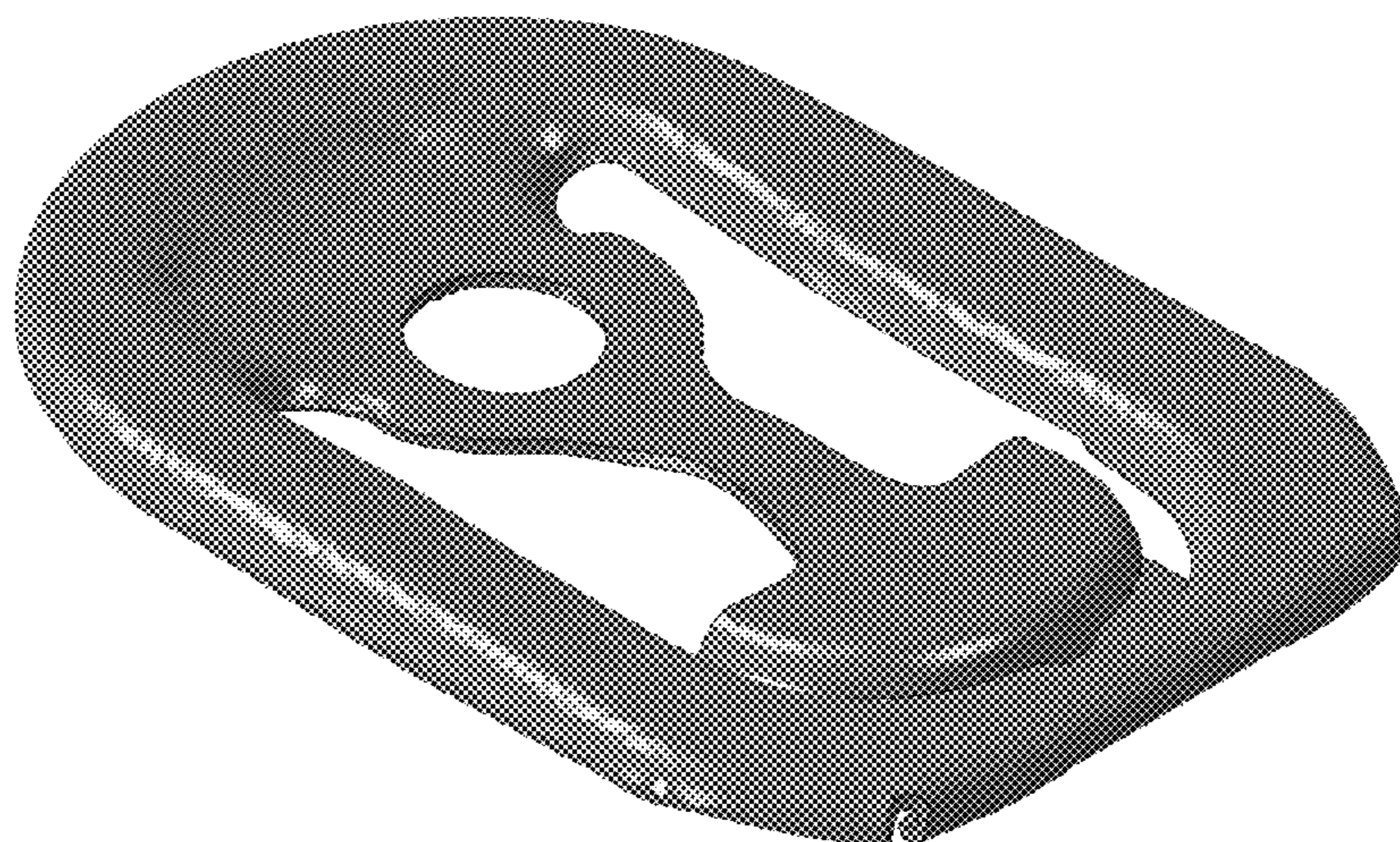
FIG. 3 is a bottom plan view of the can opening tab with large head of FIG. 1.

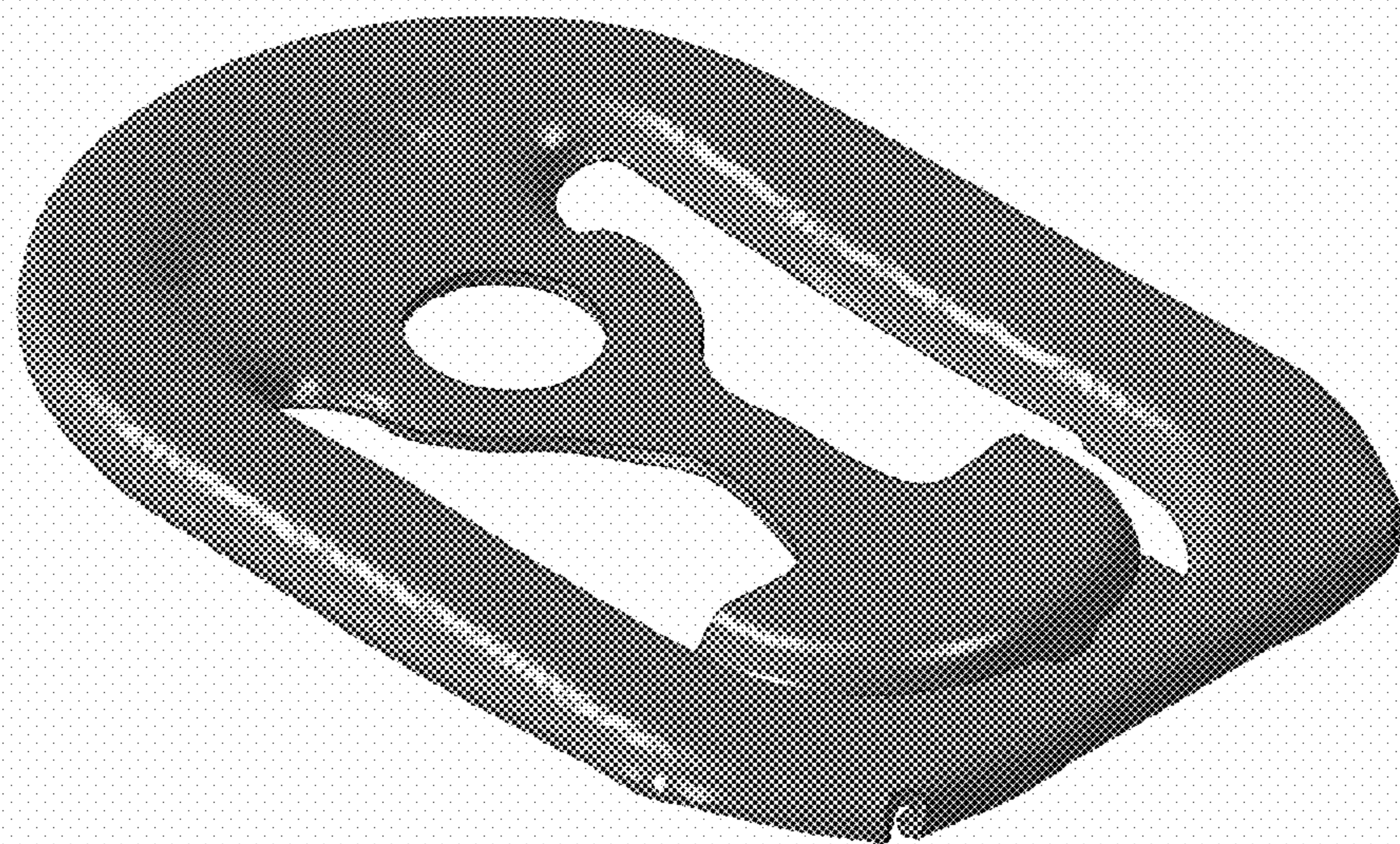

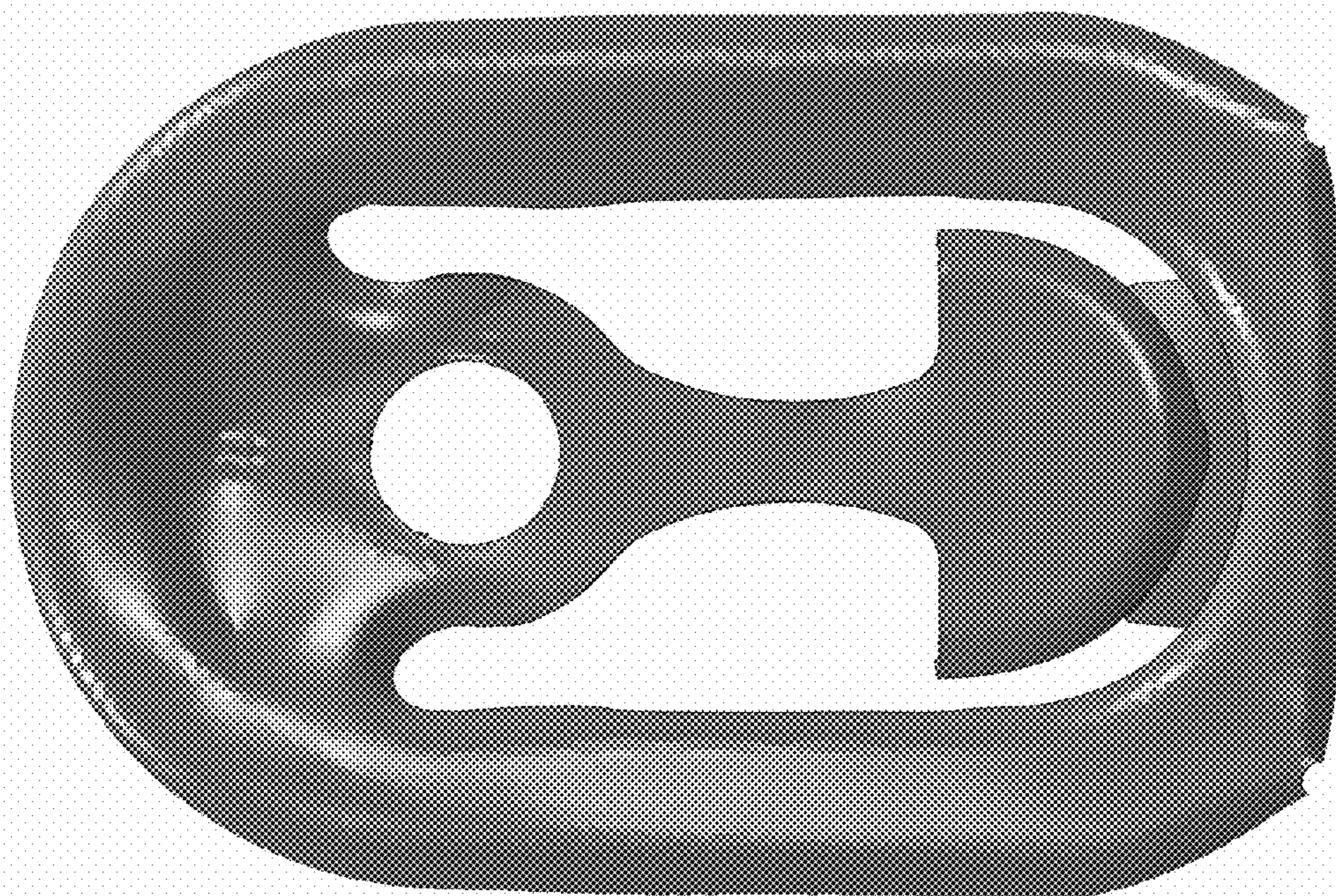

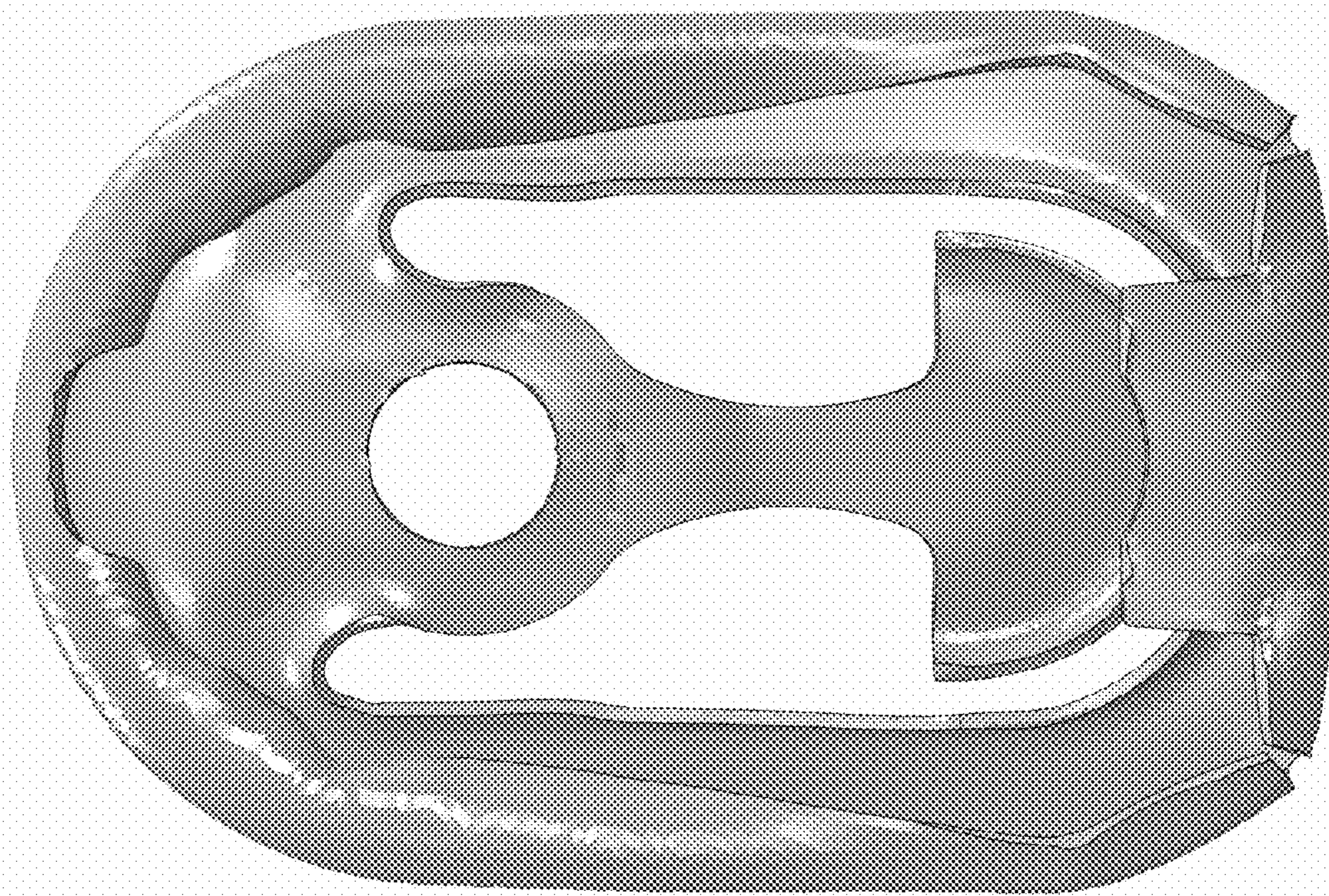

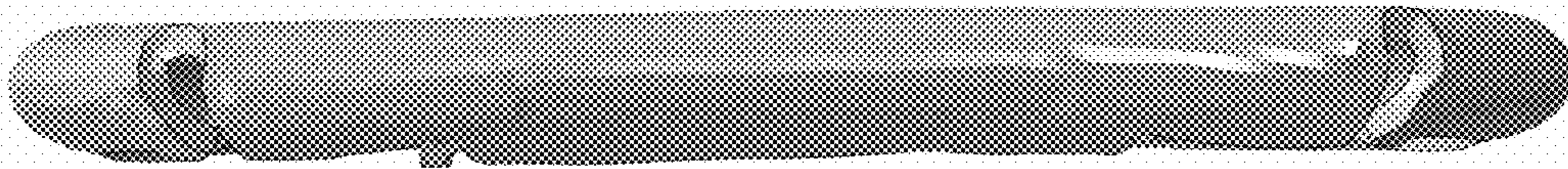

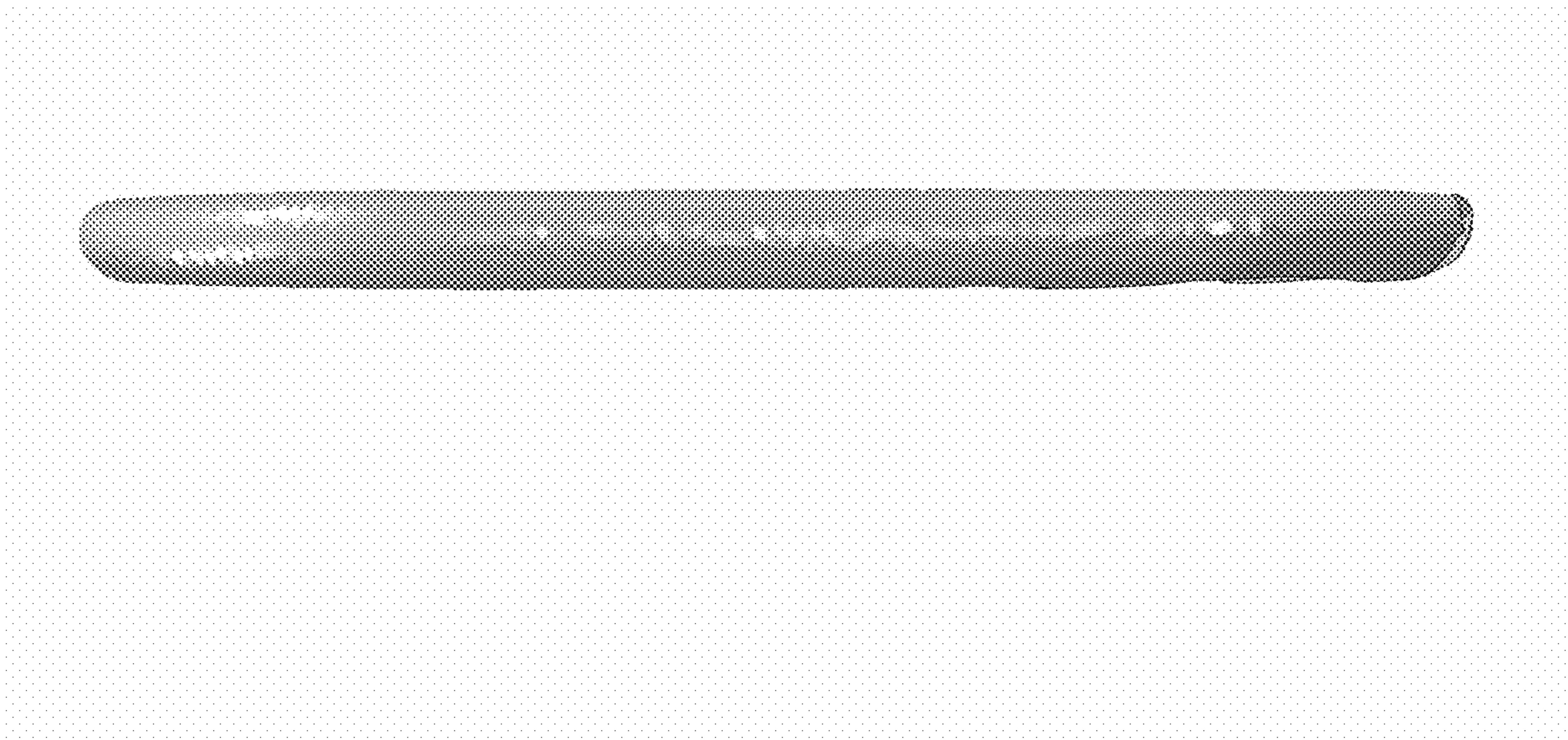
