FIG. 5 is a first side elevational view;

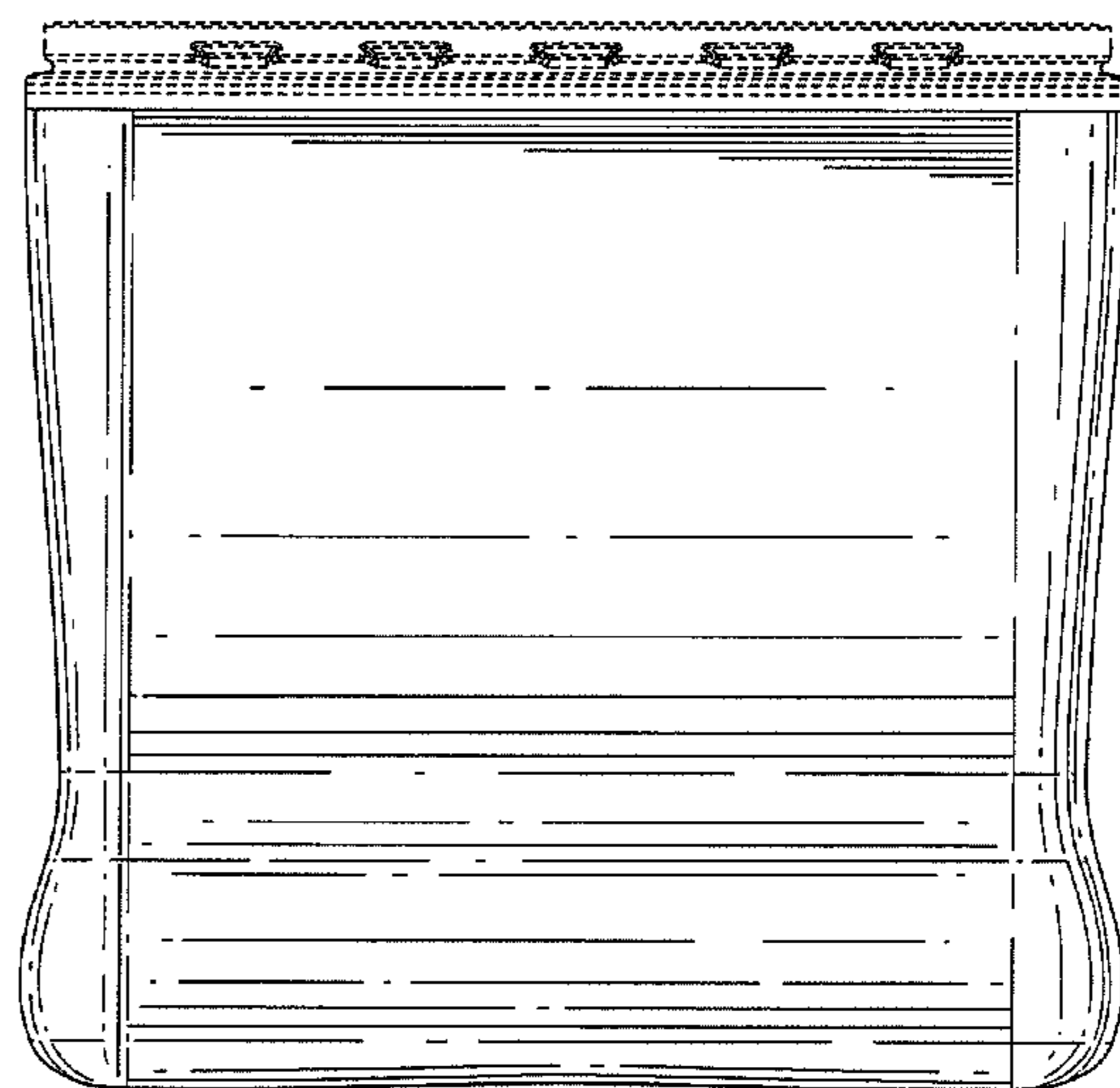
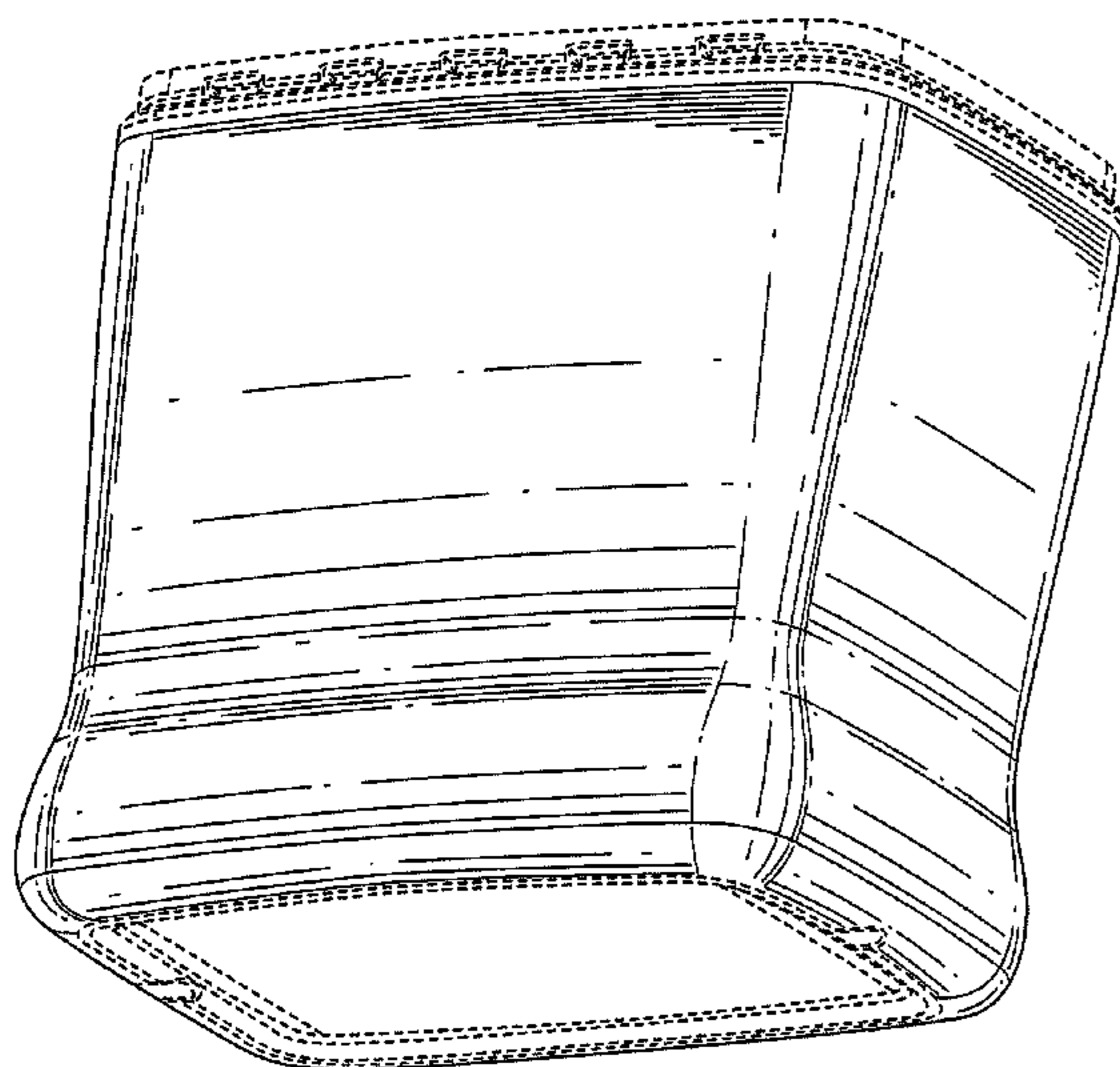
FIG. 6 is a second side elevational view;

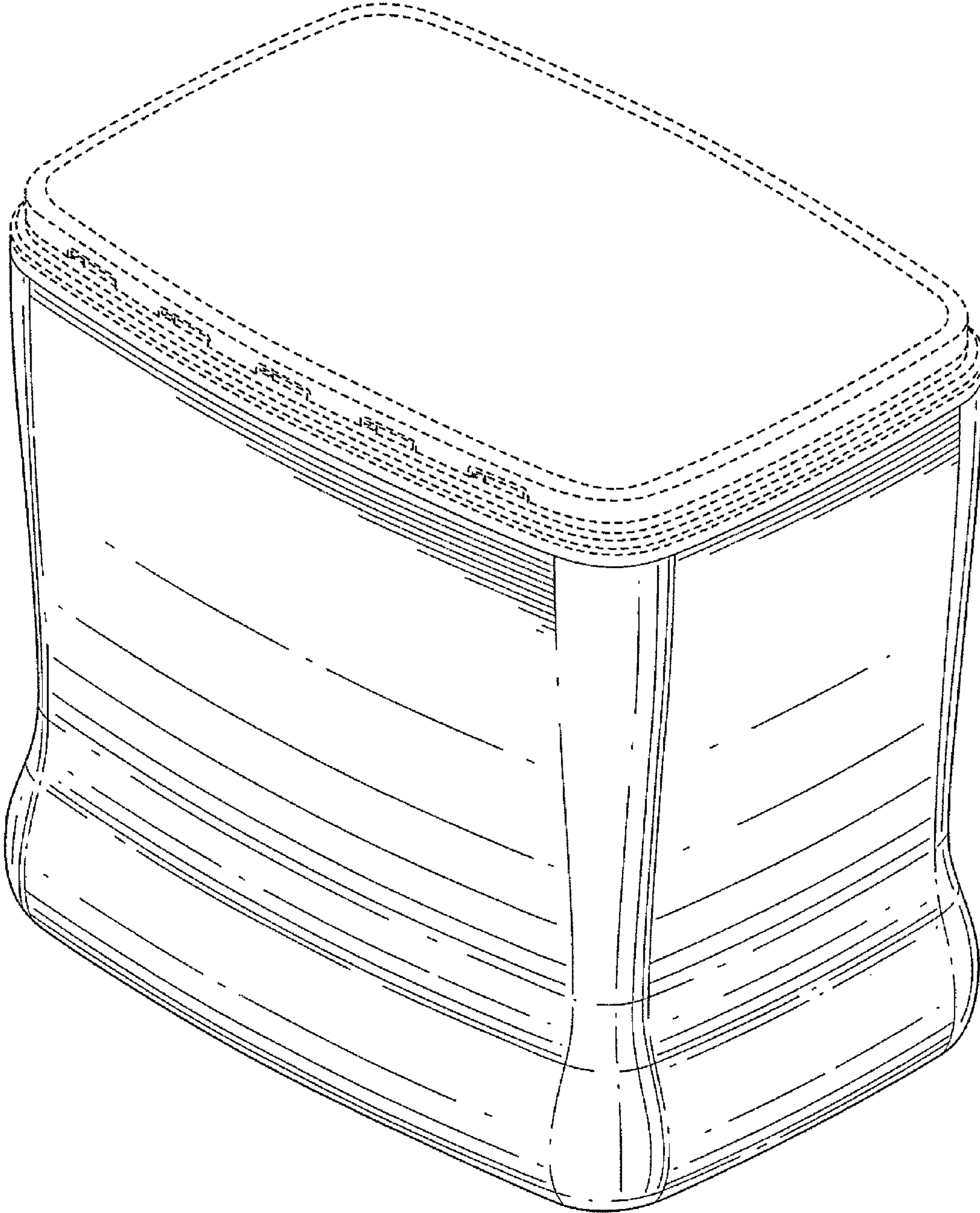

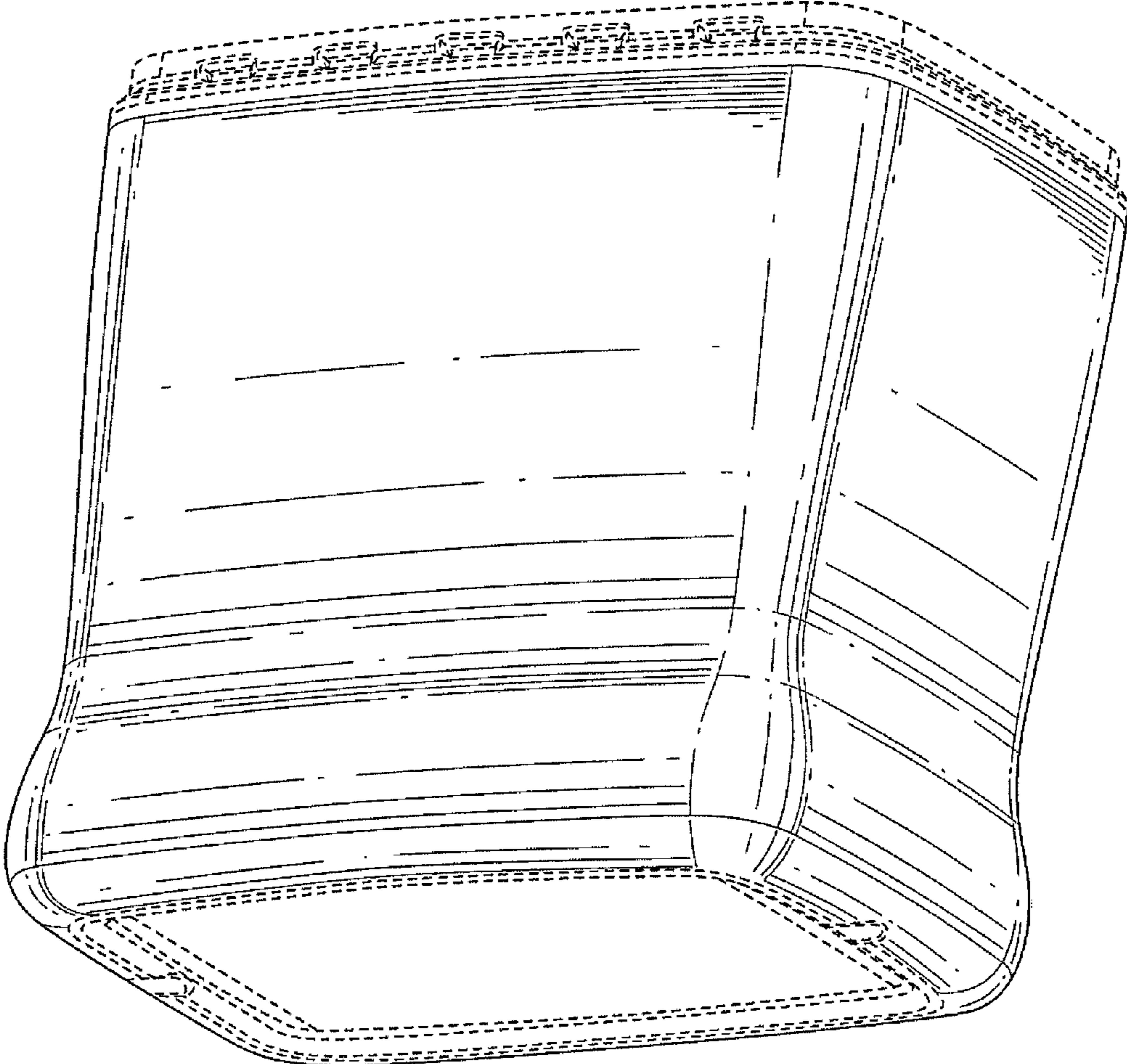

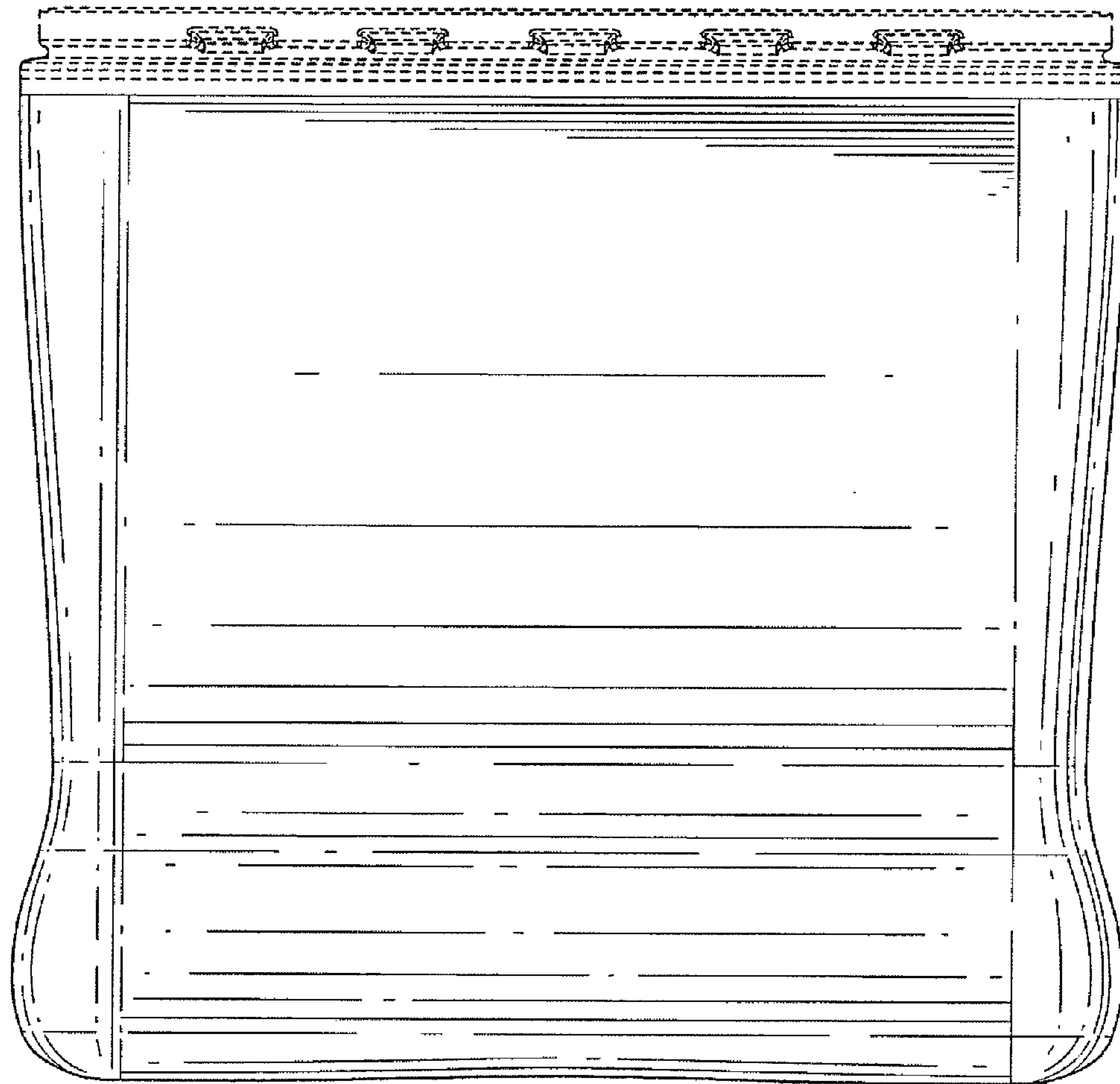

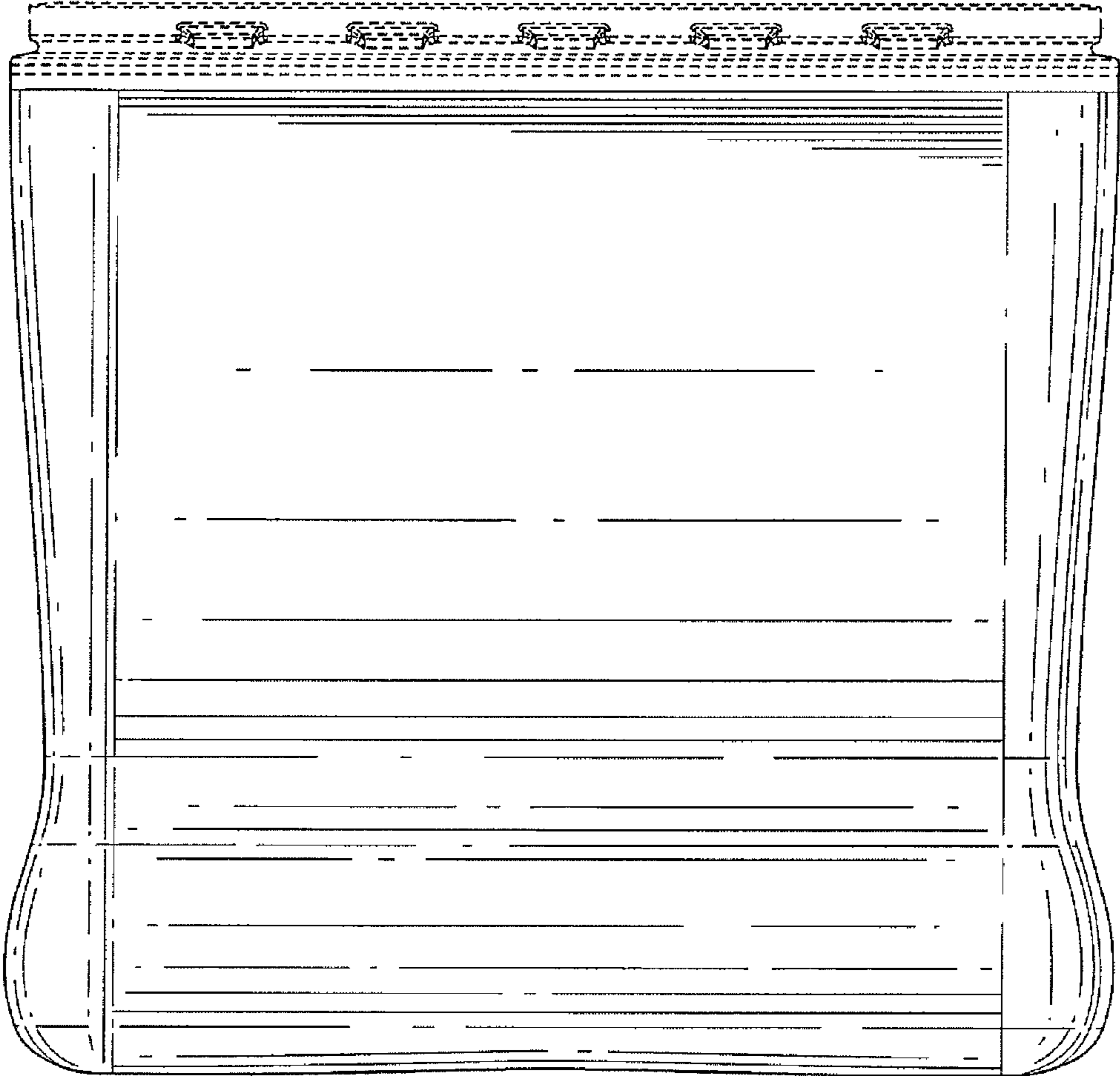

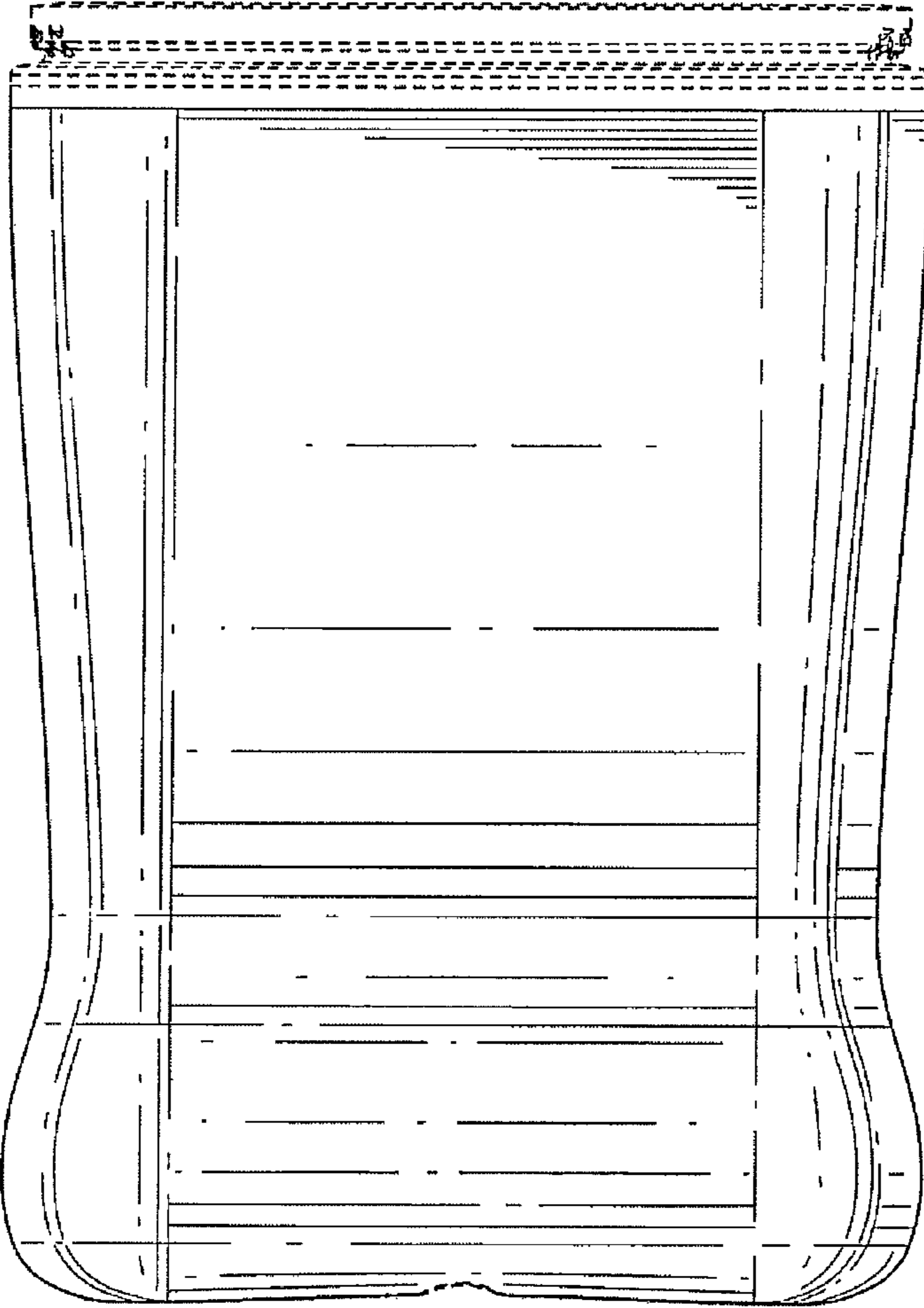

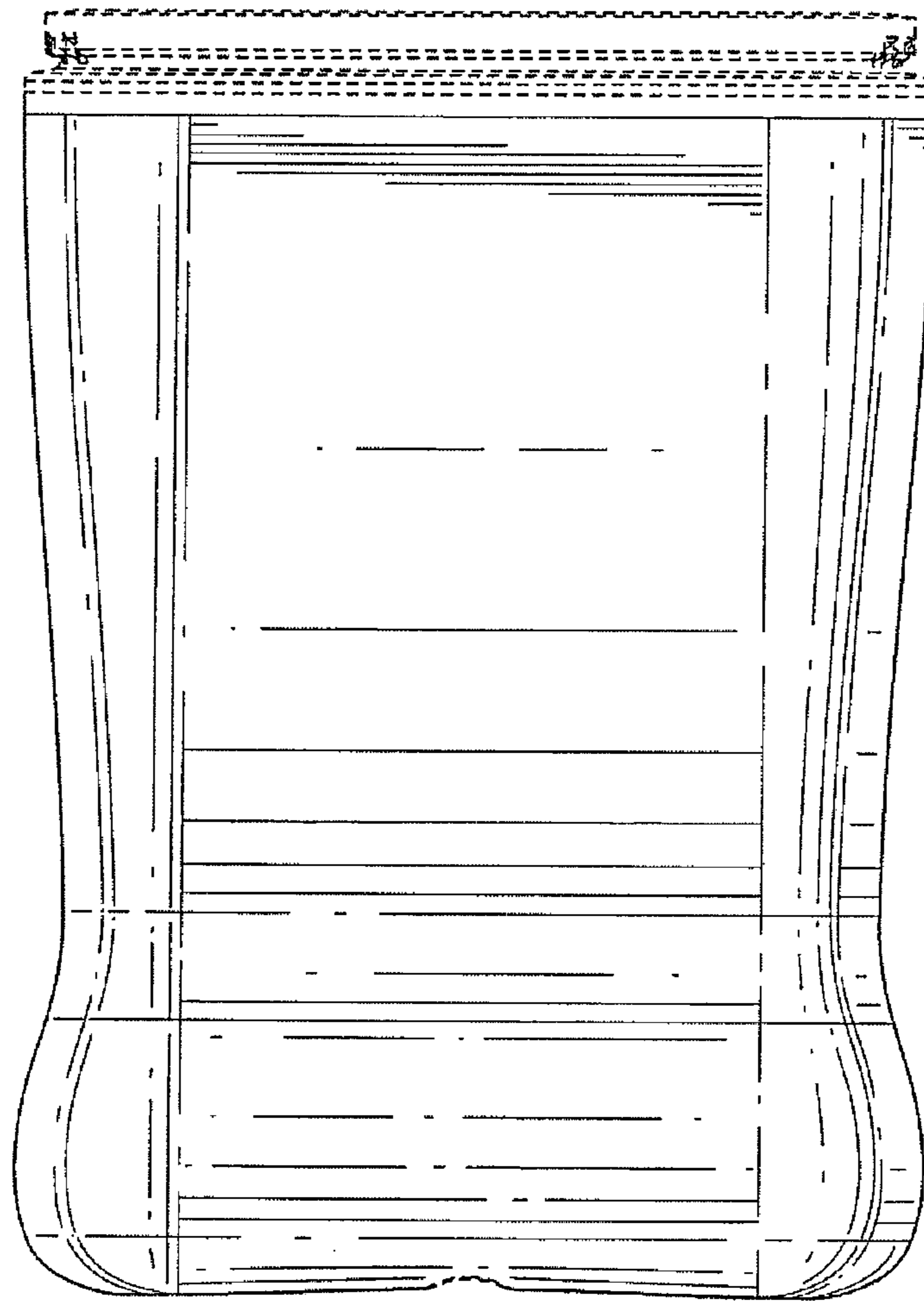

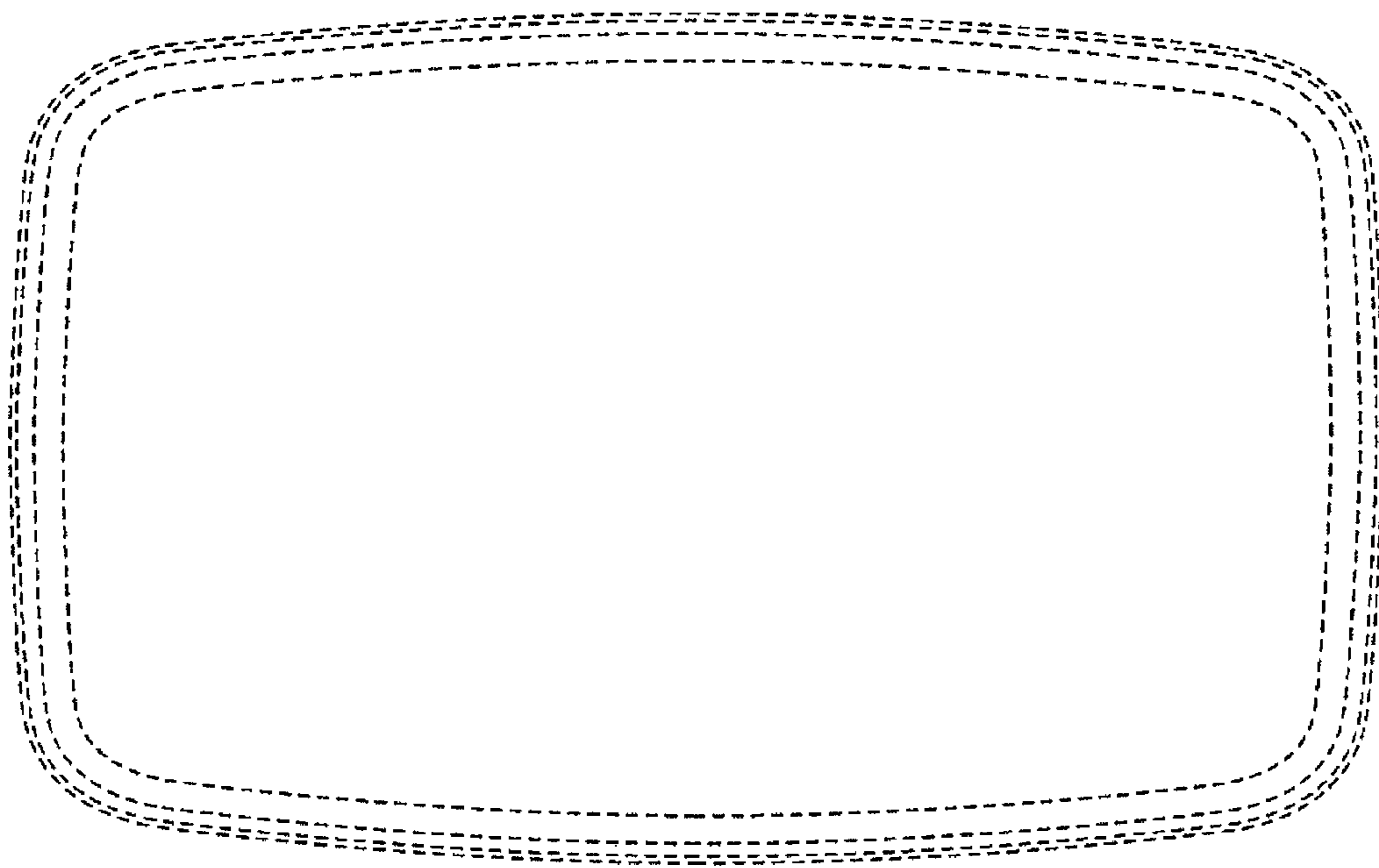

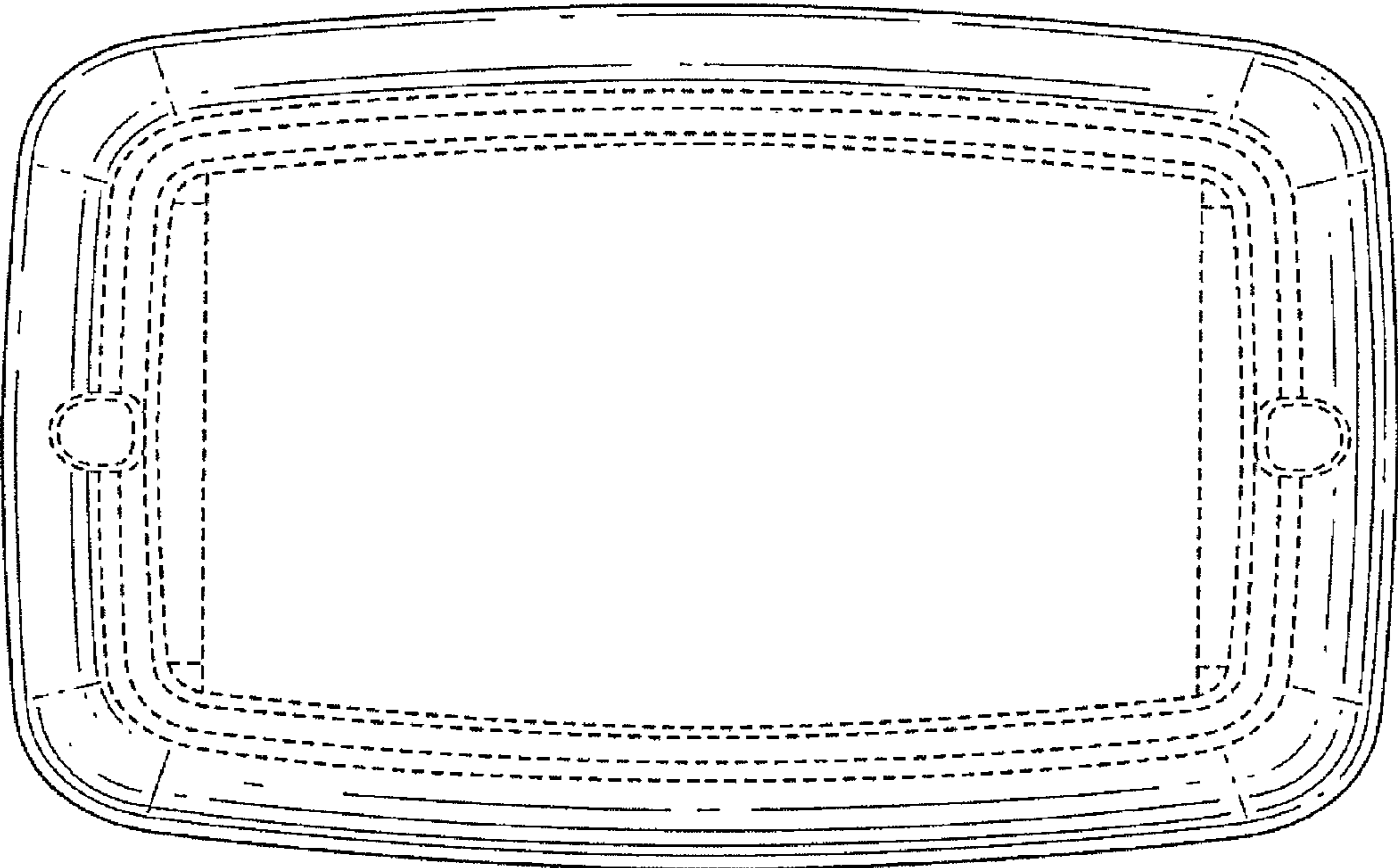
