(57) **CLAIM**

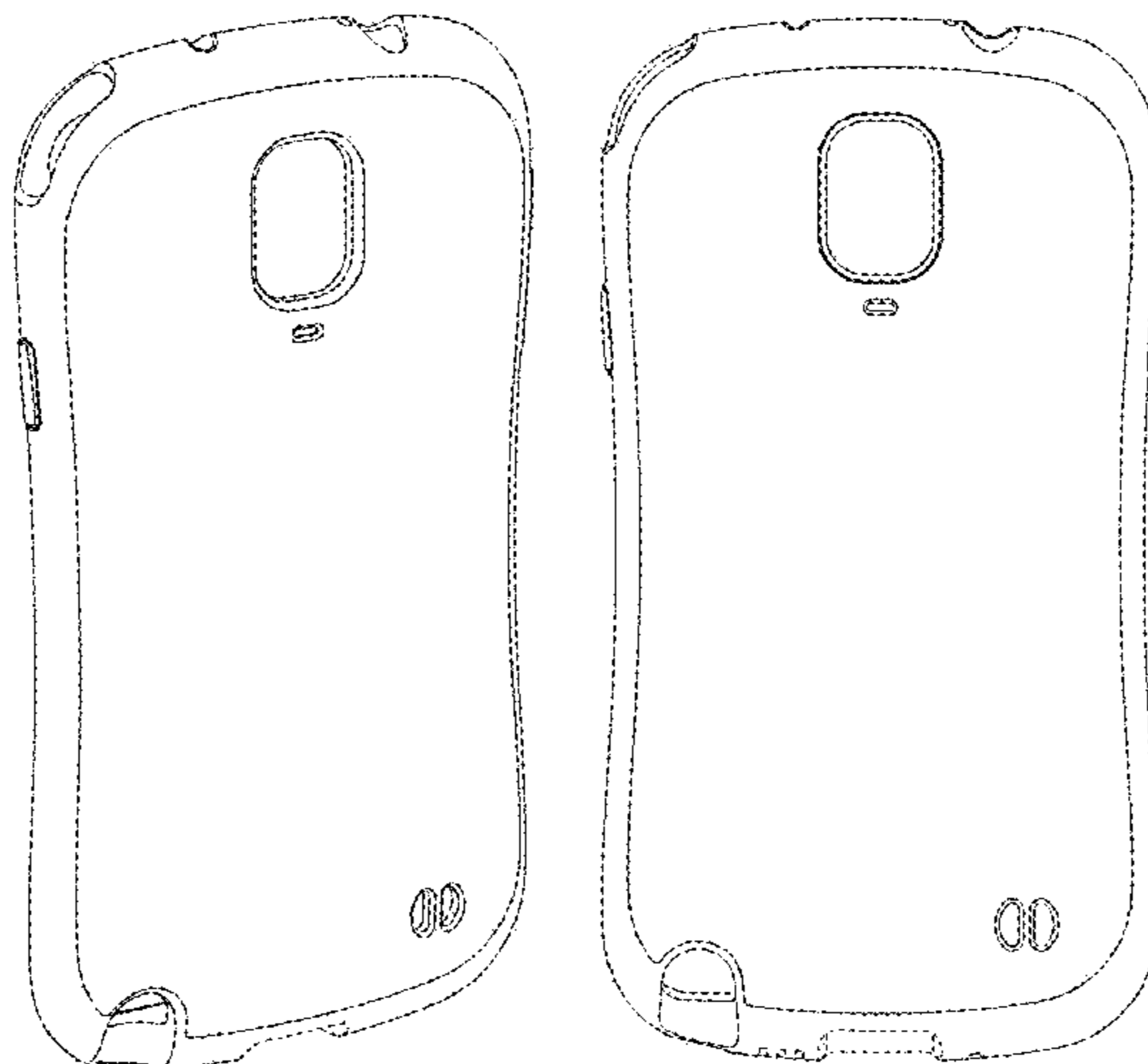
We claim the ornamental design for a smartphone case, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a smartphone case in accordance with the present design;  
FIG. 2 is a front view of the smartphone case shown in FIG. 1;  
FIG. 3 is a rear view of the smartphone case shown in FIG. 1;  
FIG. 4 is a left side view of the smartphone case shown in FIG. 1;  
FIG. 5 is a right side view of the smartphone case shown in FIG. 1;  
FIG. 6 is a top view of the smartphone case shown in FIG. 1; and,  
FIG. 7 is a bottom view of the smartphone case shown in FIG. 1.

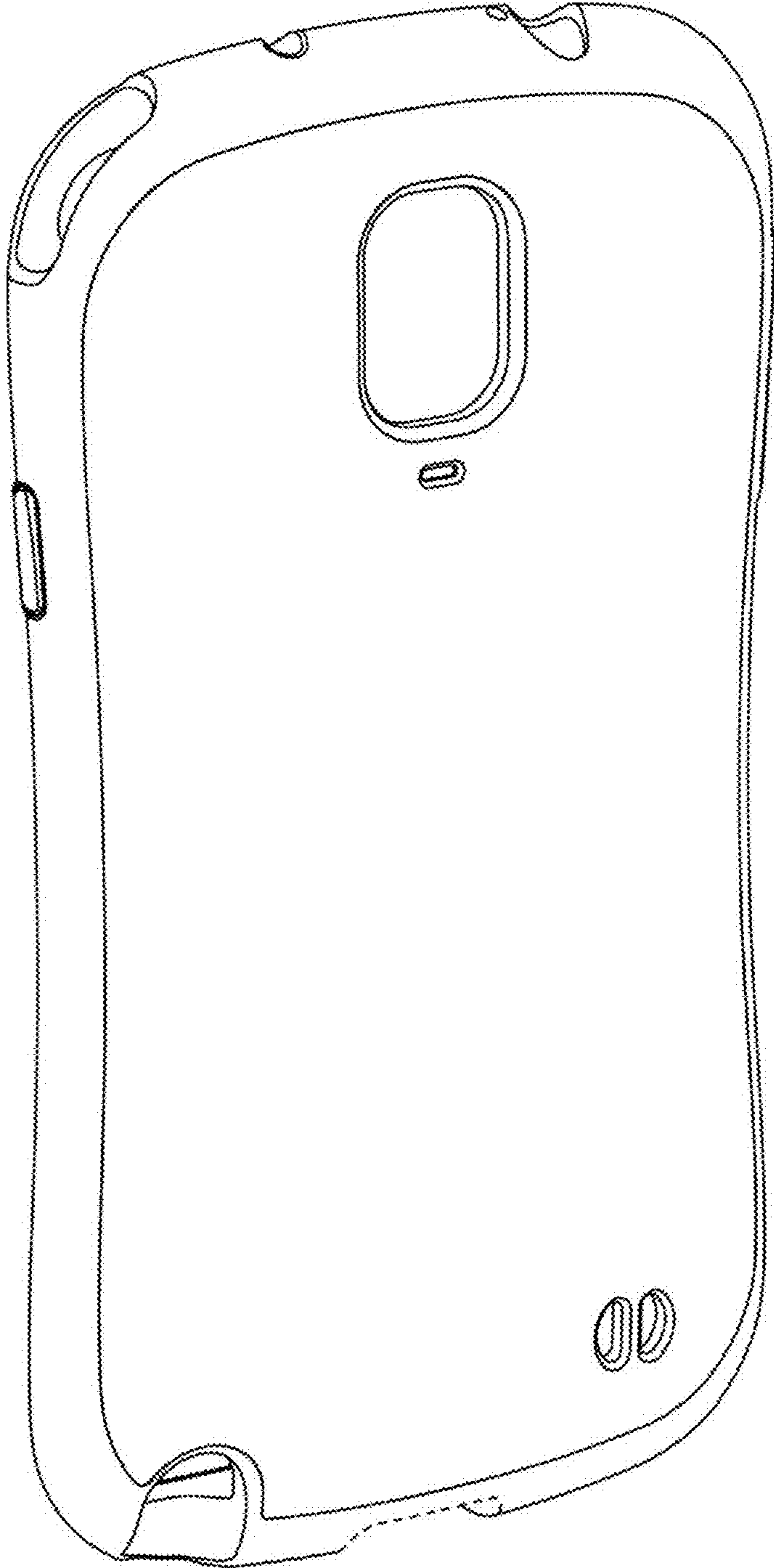

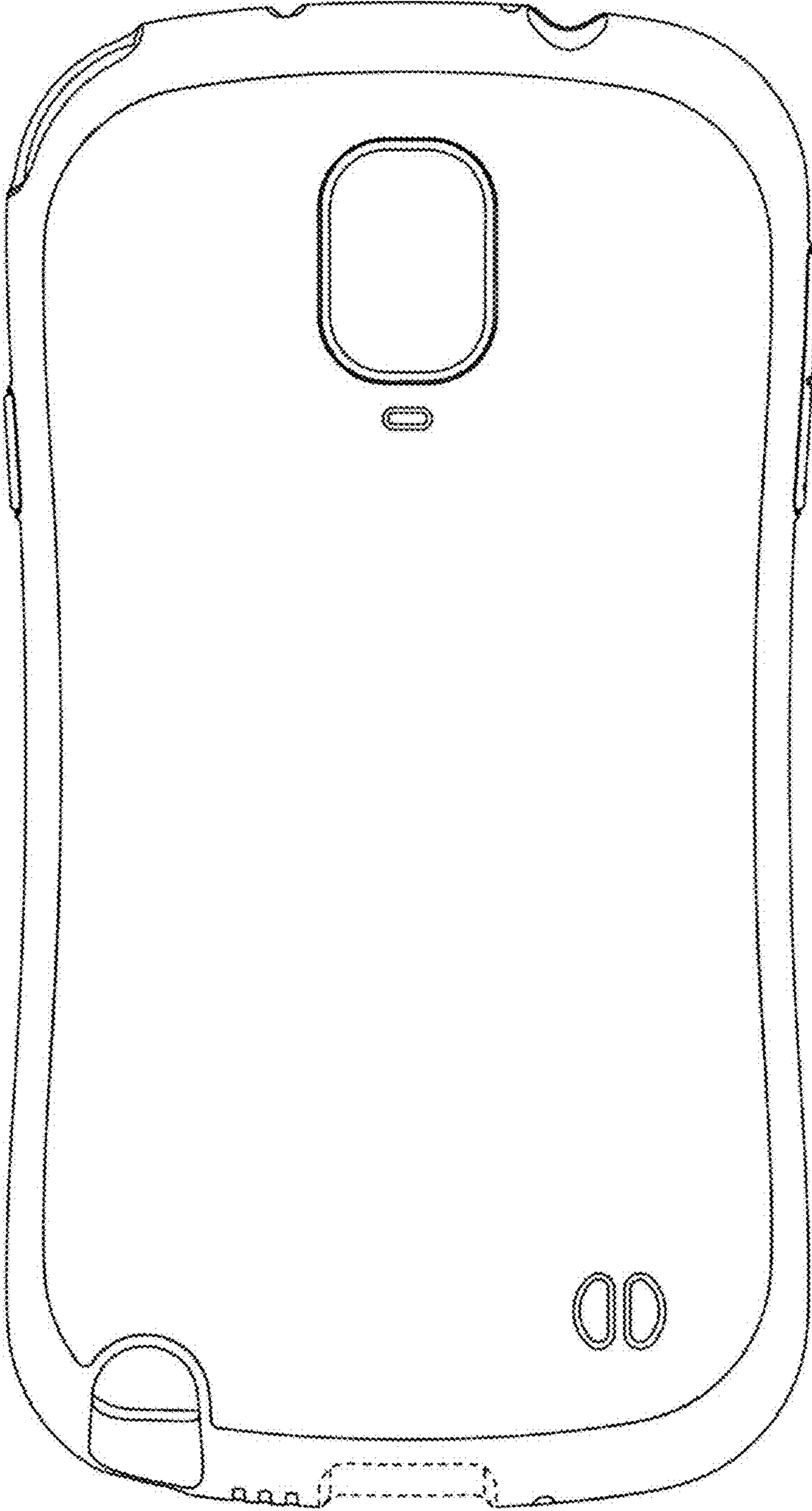

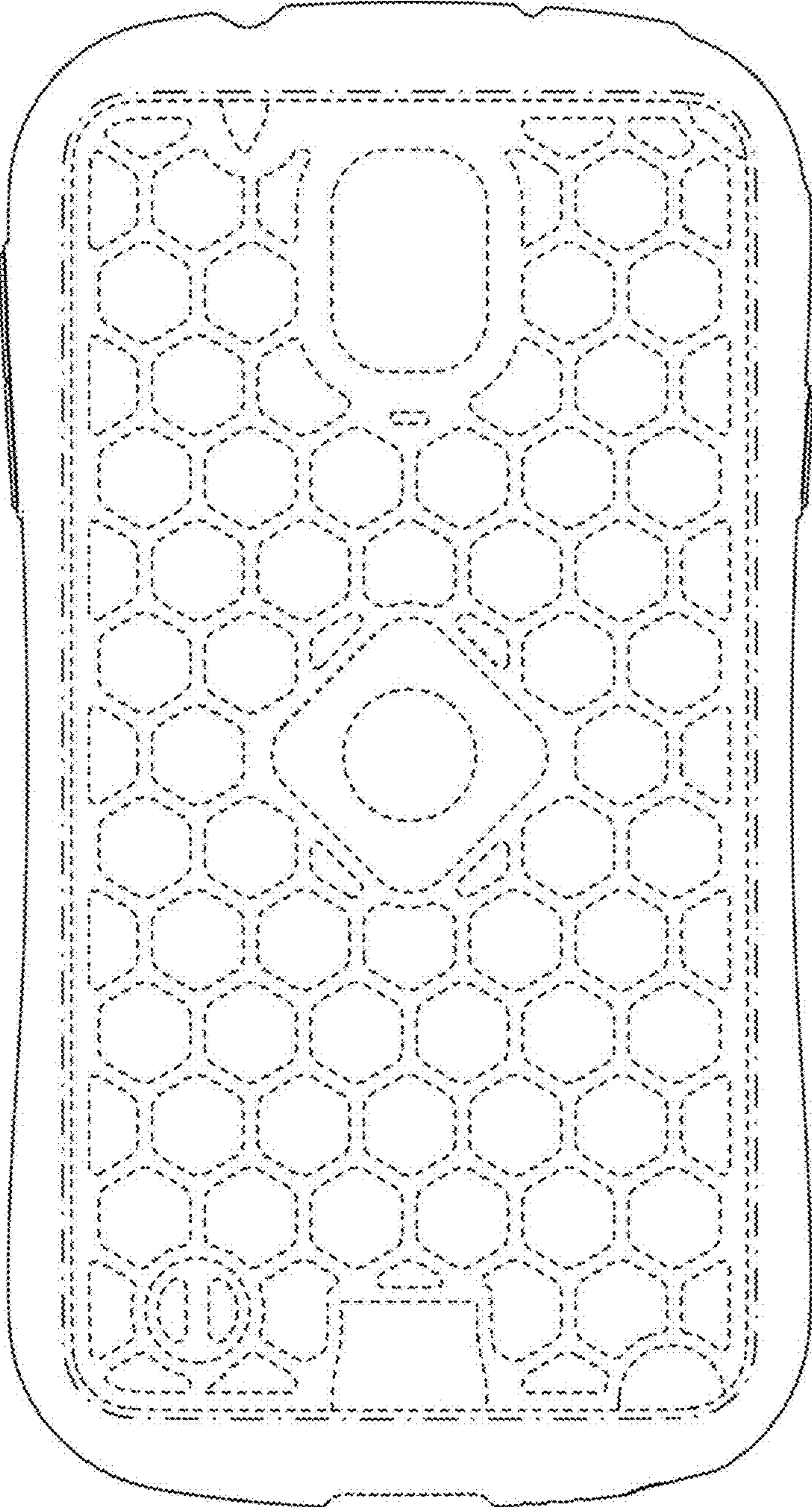

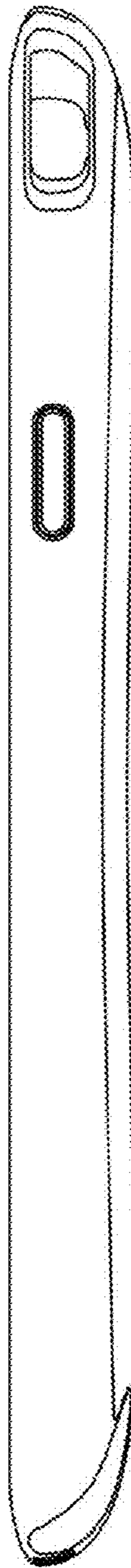

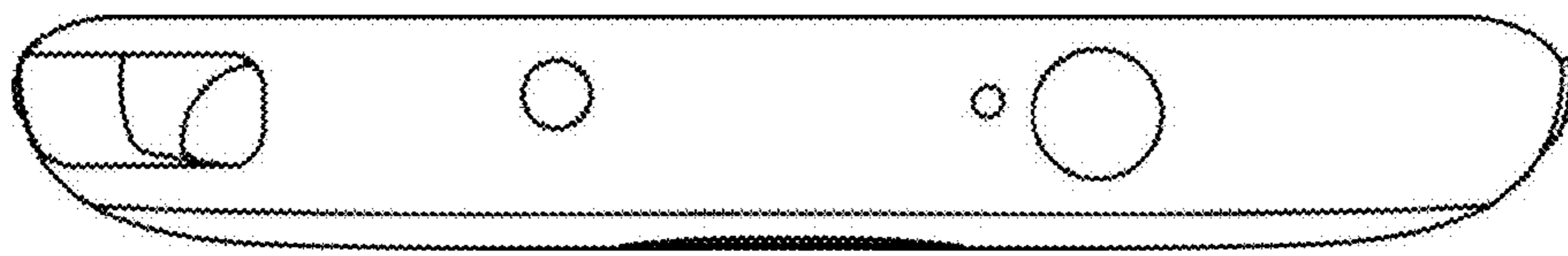

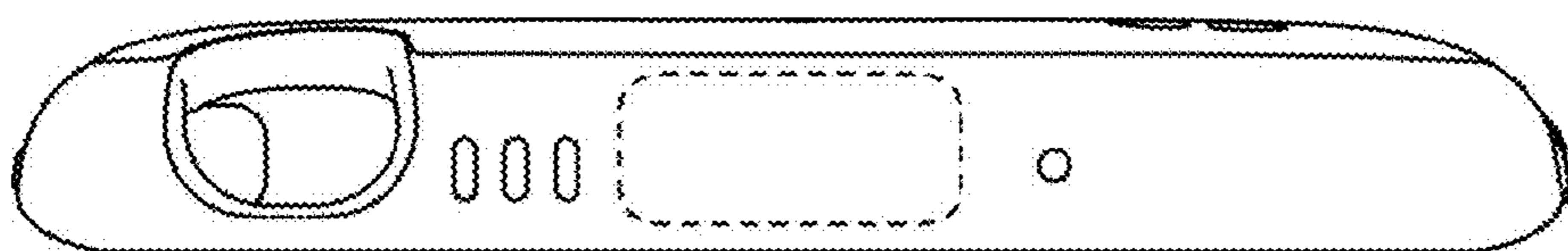
