(57) **CLAIM**

The ornamental design for a display screen with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen with graphical user interface showing the new design;

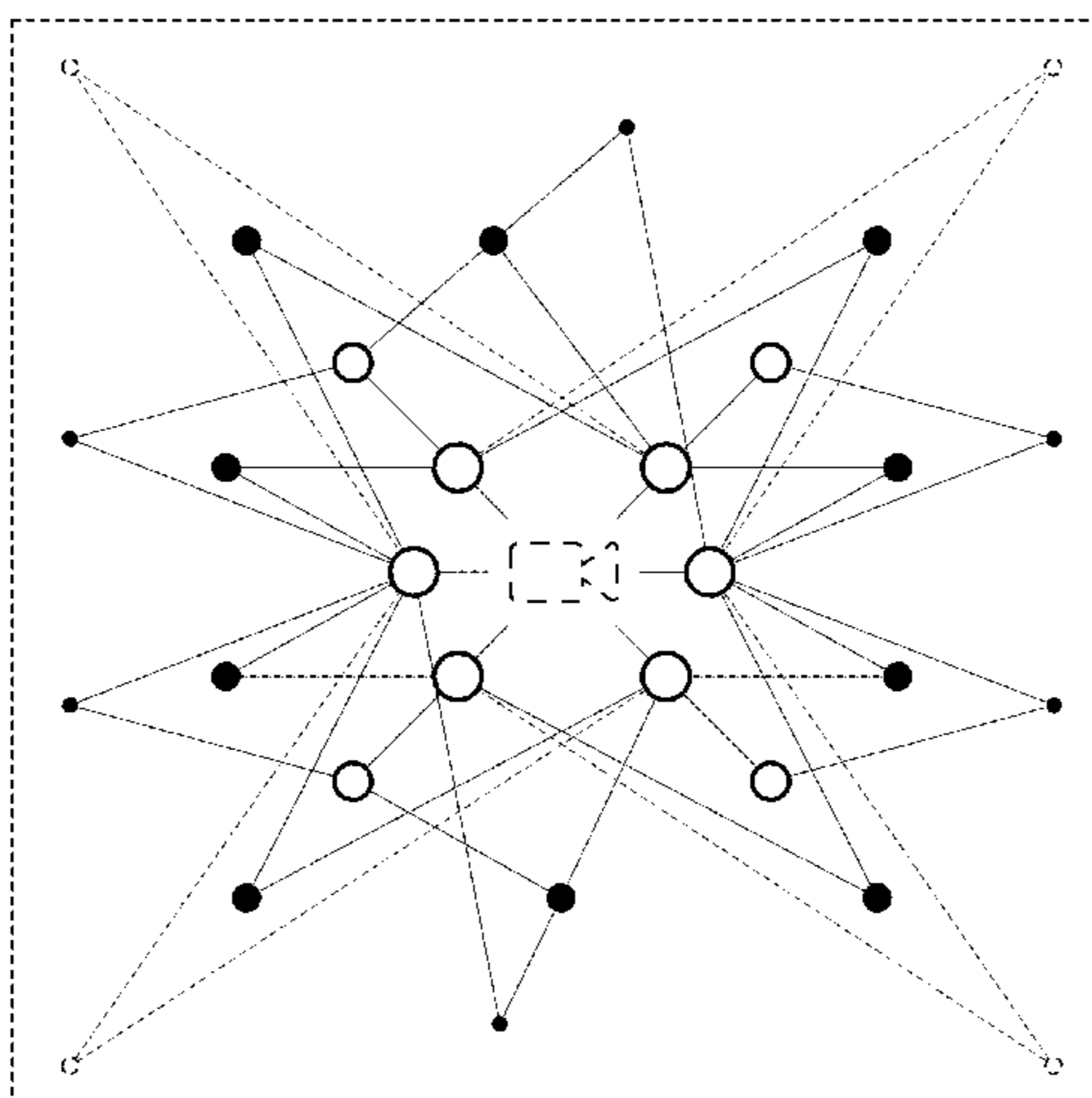
FIG. 2 is a front view of display screen with graphical user interface of FIG. 1 shown on a device;

FIG. 3 front view of a display screen with graphical user interface showing the new design with disclaimed content omitted; and,

FIG. 4 is a front view of display screen with graphical user interface of FIG. 3 shown on a device.

The broken line showing the central stylized camera icon, the four diagonal v's ending in circles, and the remainder of the display screen in FIGS. 1-4, and the remainder of the device in FIGS. 2 and 4 is for environmental purposes only and forms no part of the claimed design.

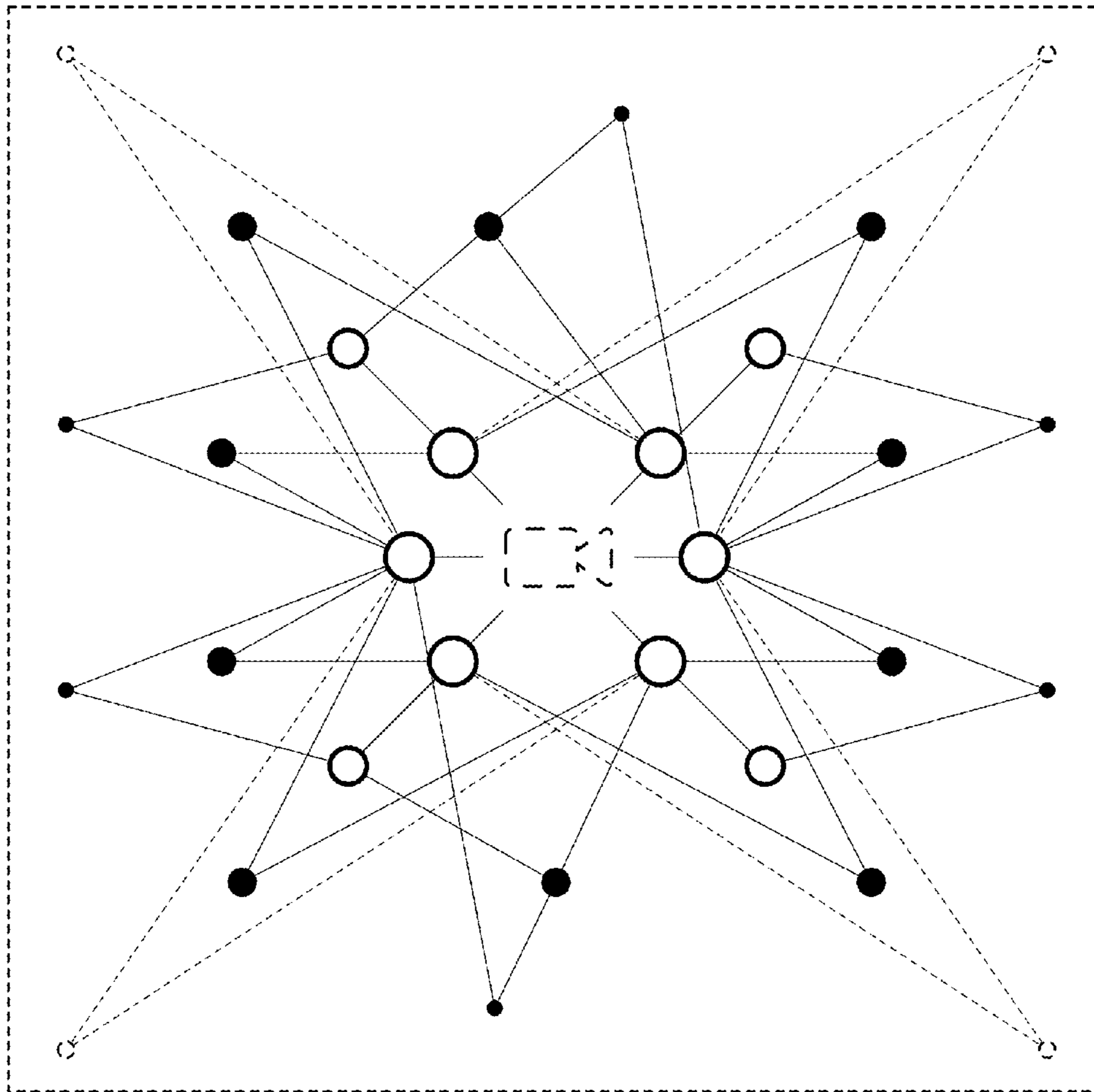

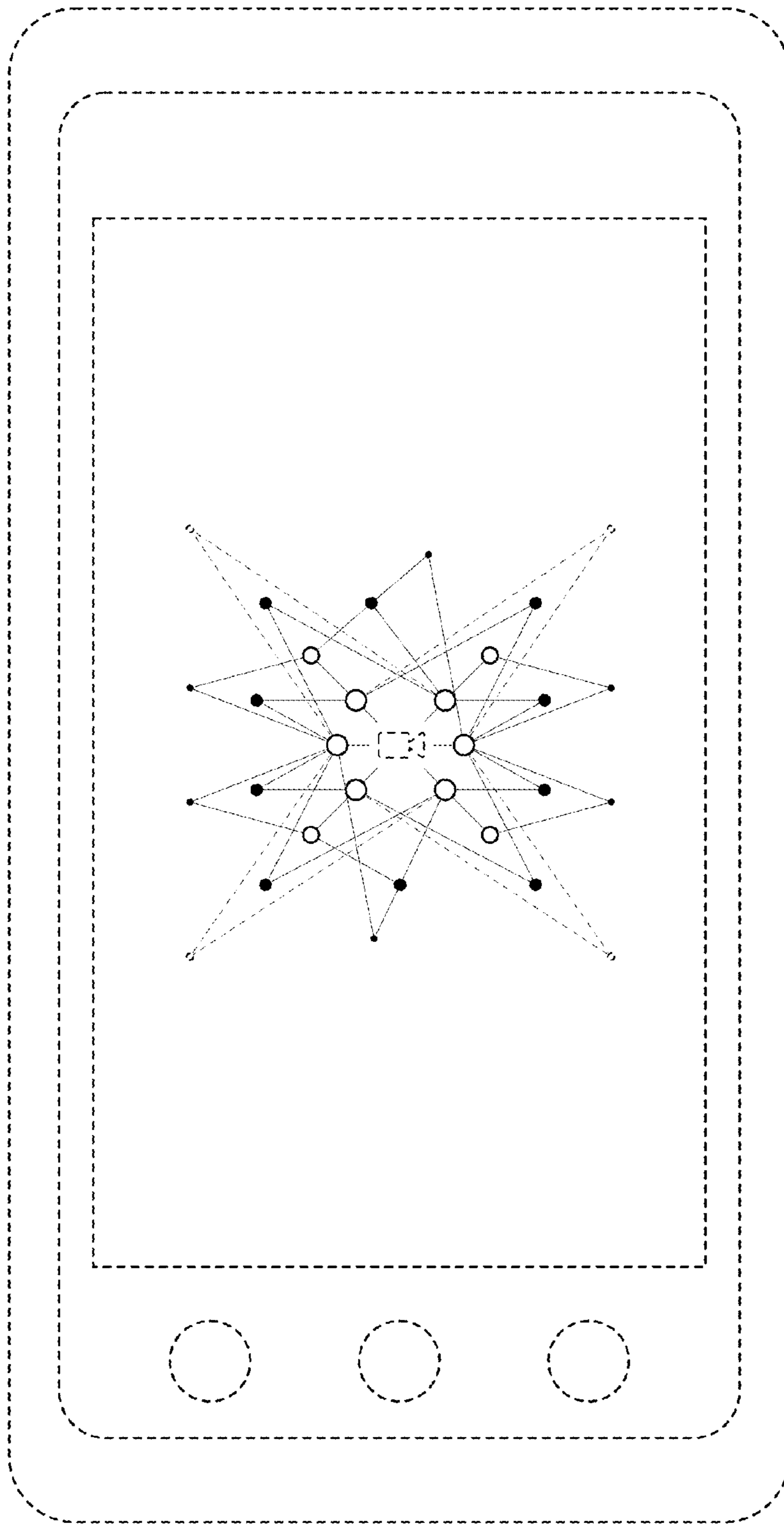

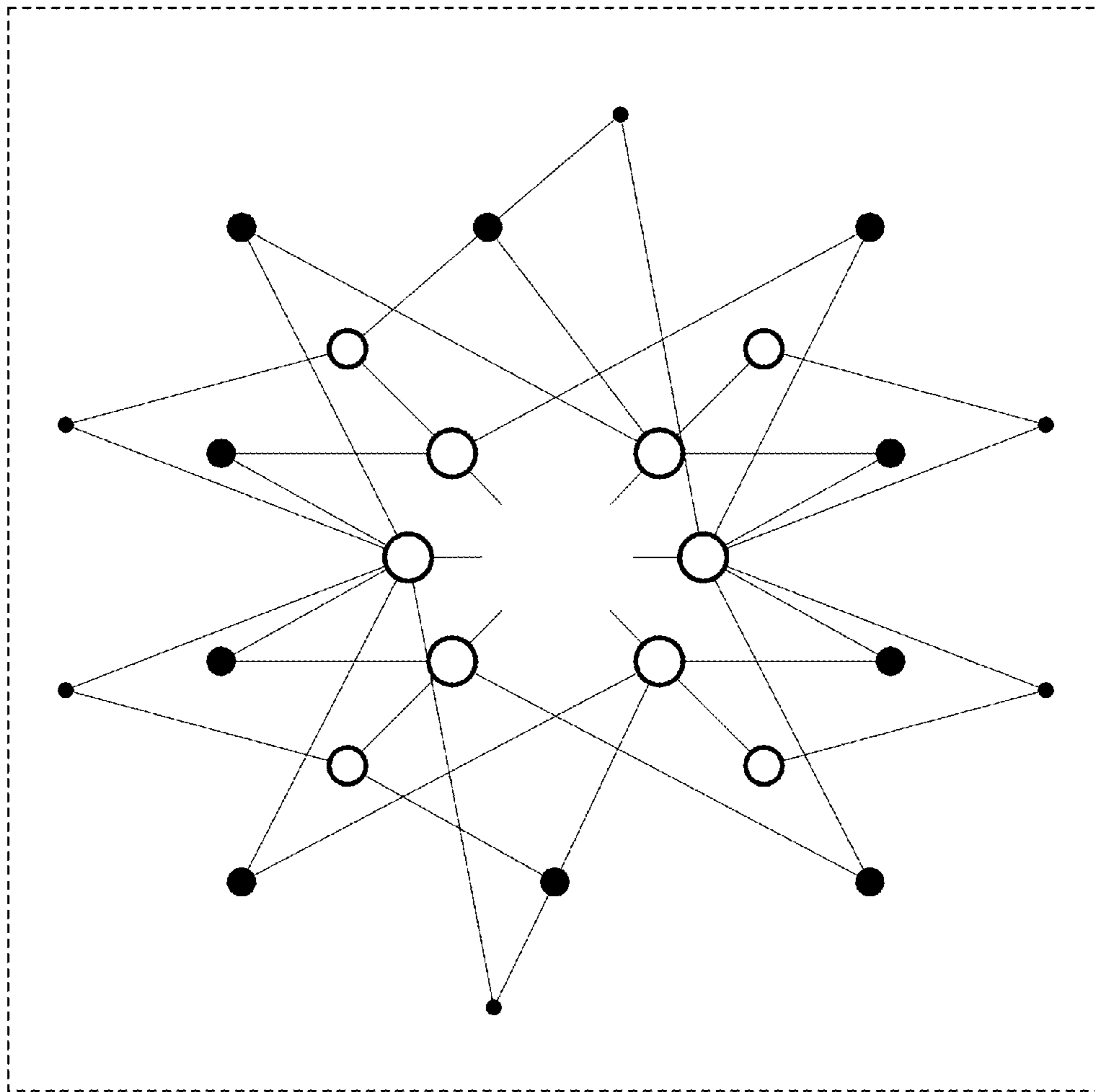

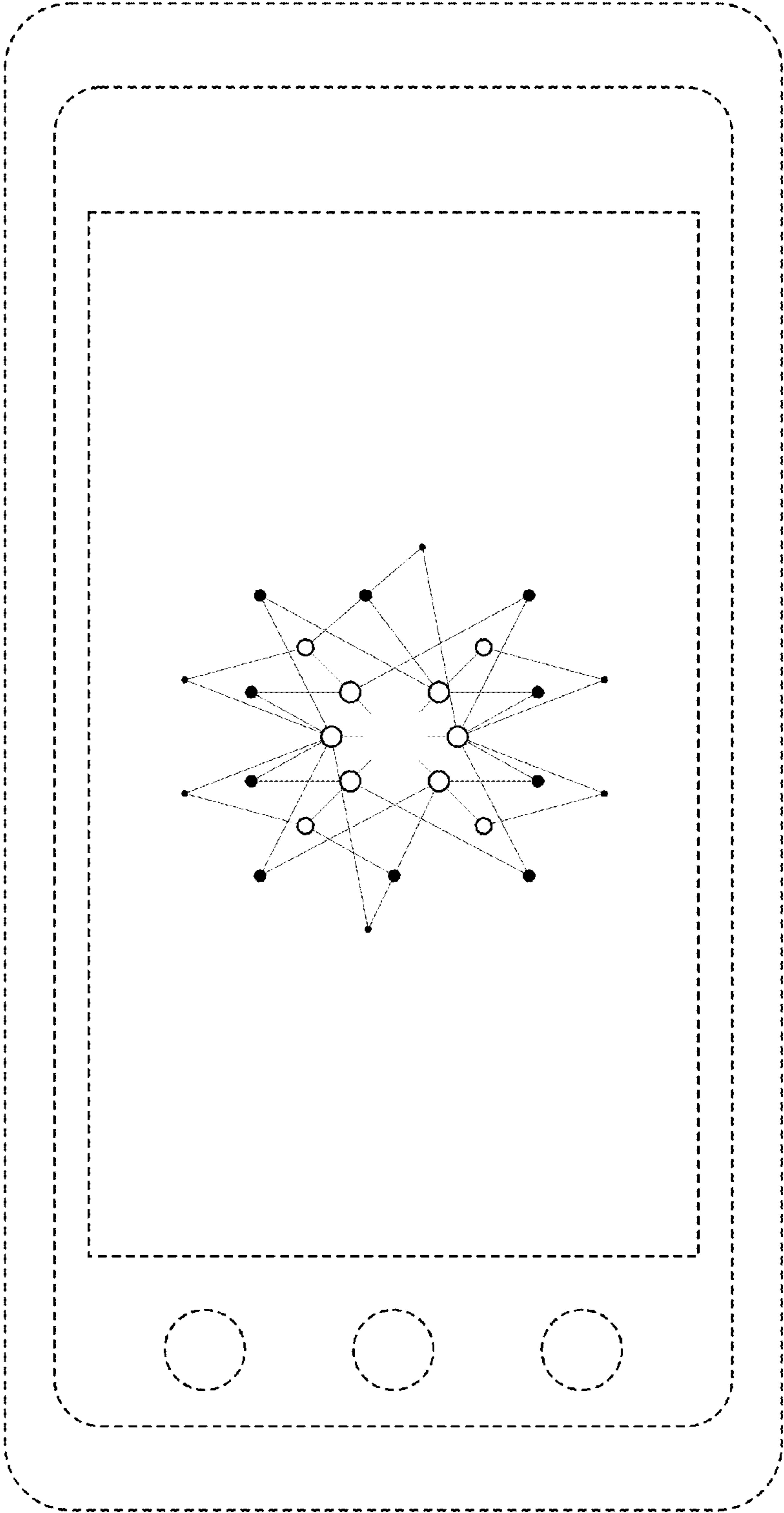
