(57) **CLAIM**

The ornamental design for an display screen portion with icon, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a generated image for a display screen or portion thereof showing my new design; and, FIG. 2 is a front view of the generated image of FIG. 1, in which a mobile terminal in broken lines is provided to illustrate an example environment.

The broken line drawing of the mobile terminal, and the symbols and otherwise images shown in broken lines in the generated image of FIG. 2 are for illustrative purposes only and form no part of the claimed design.

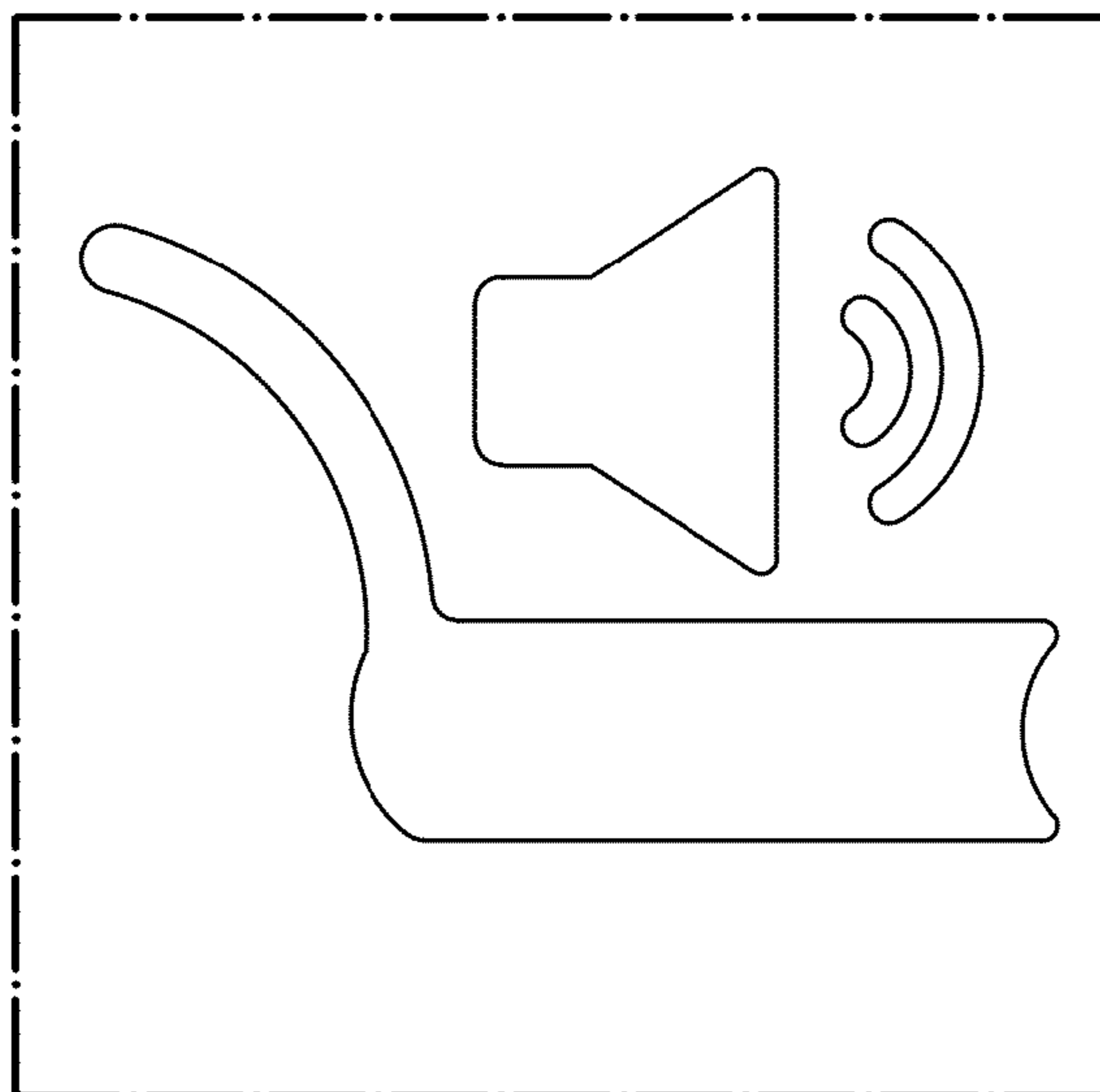

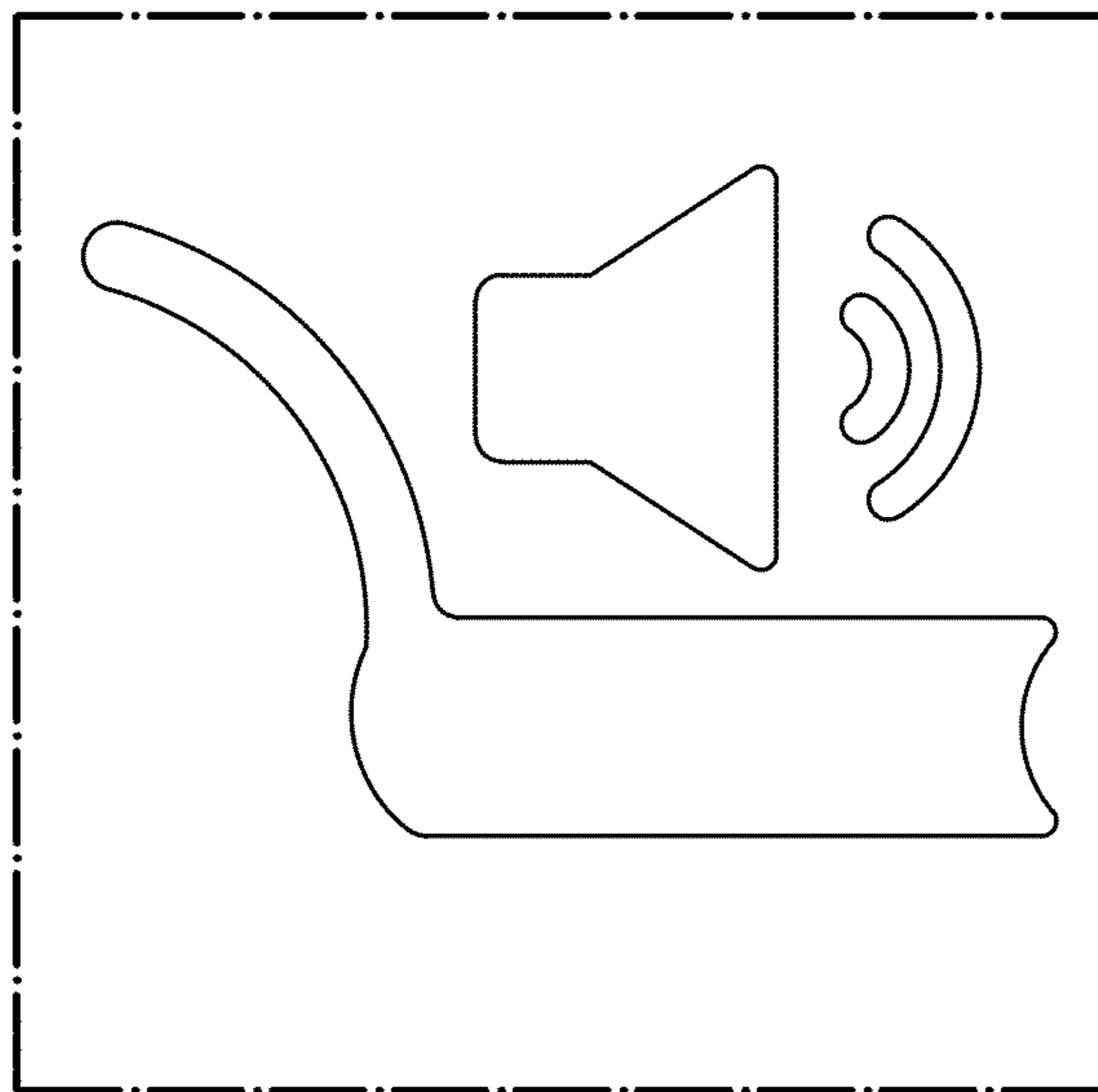
