(57) **CLAIM**

The ornamental design for a display screen with an icon, as shown and described.

DESCRIPTION

FIG. 7 is a front view of yet another display screen with an icon, showing the new design; and,

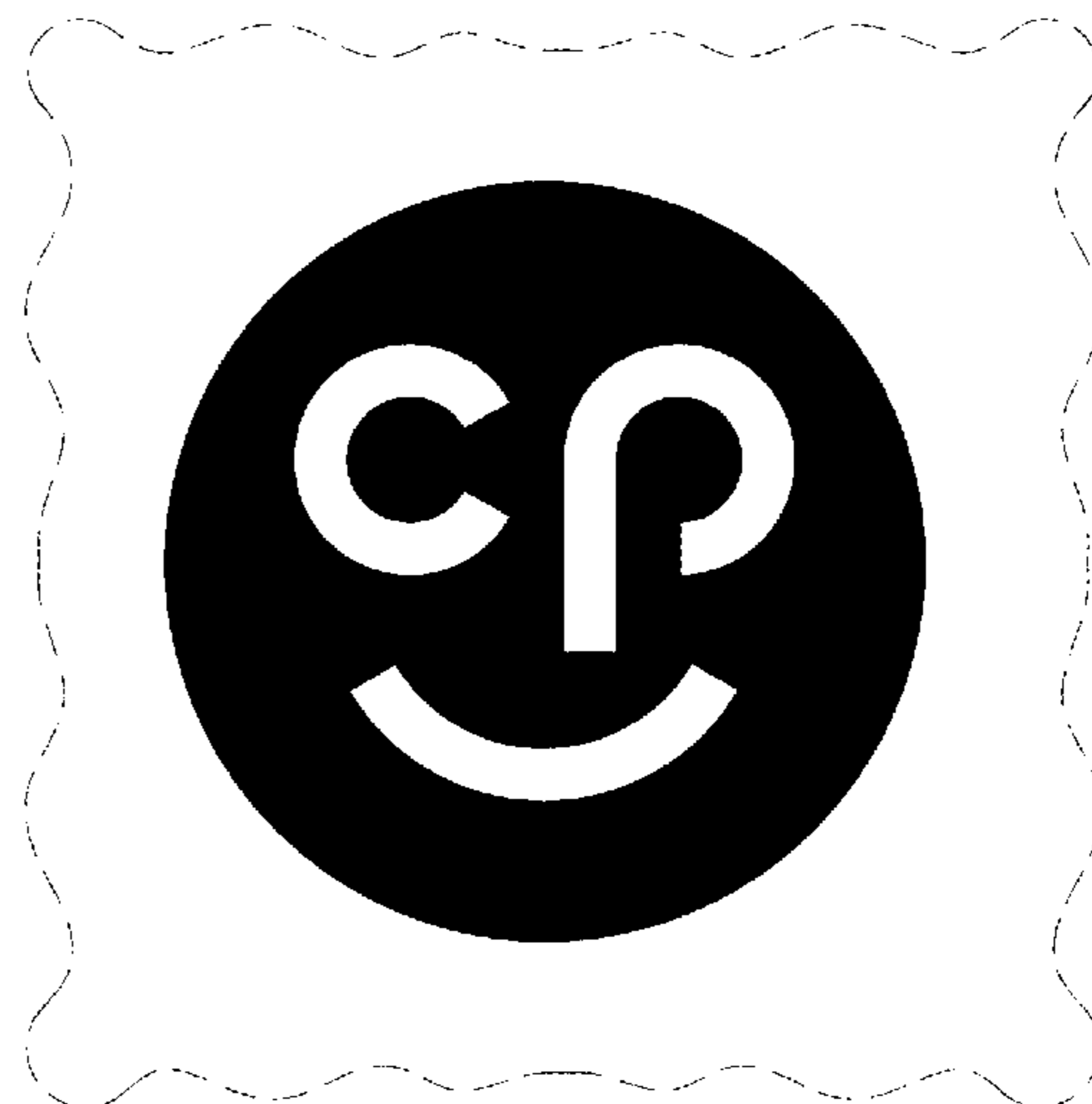
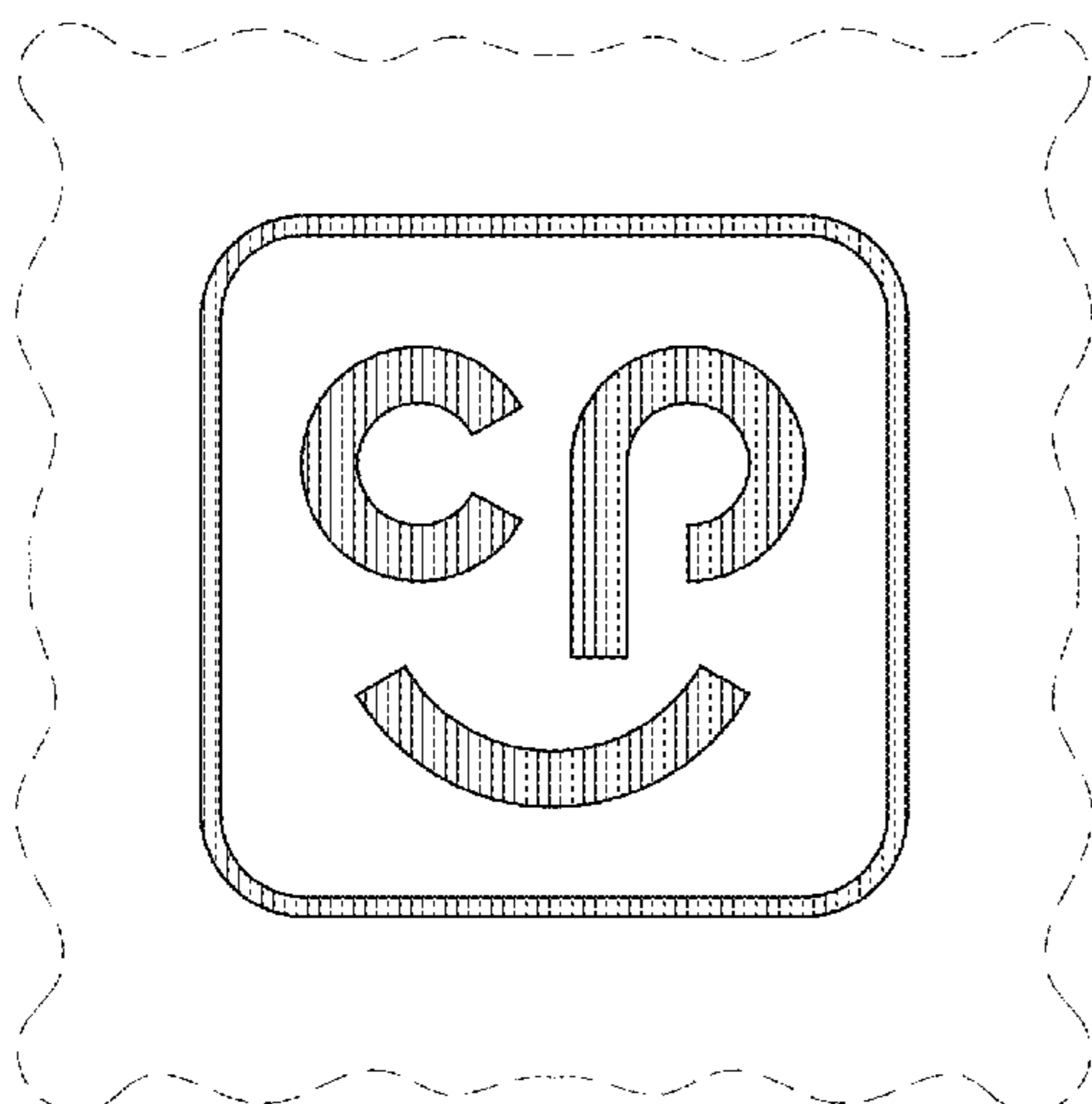
FIG. 8 is a front view of yet another display screen with an icon, showing the new design.

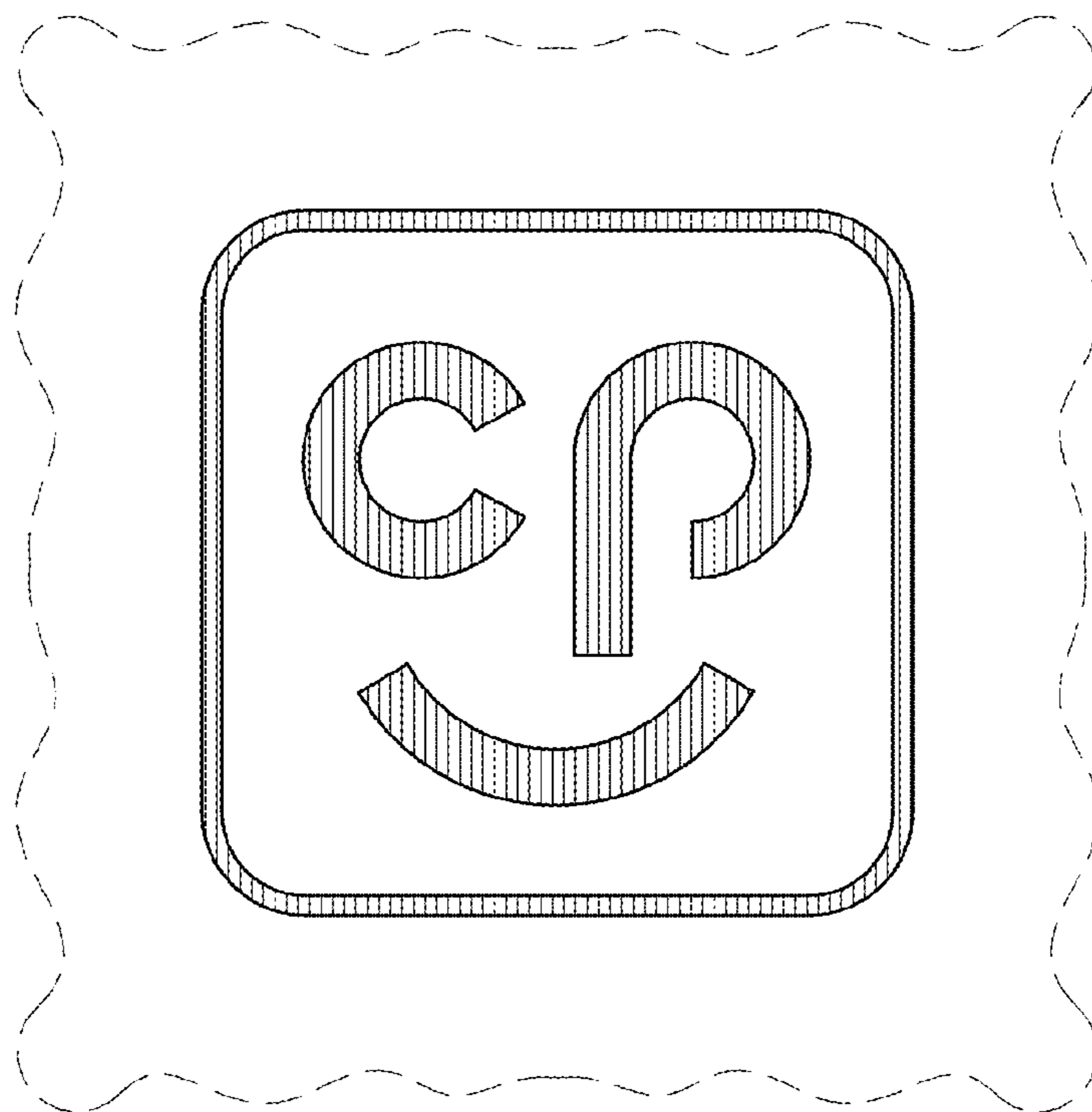

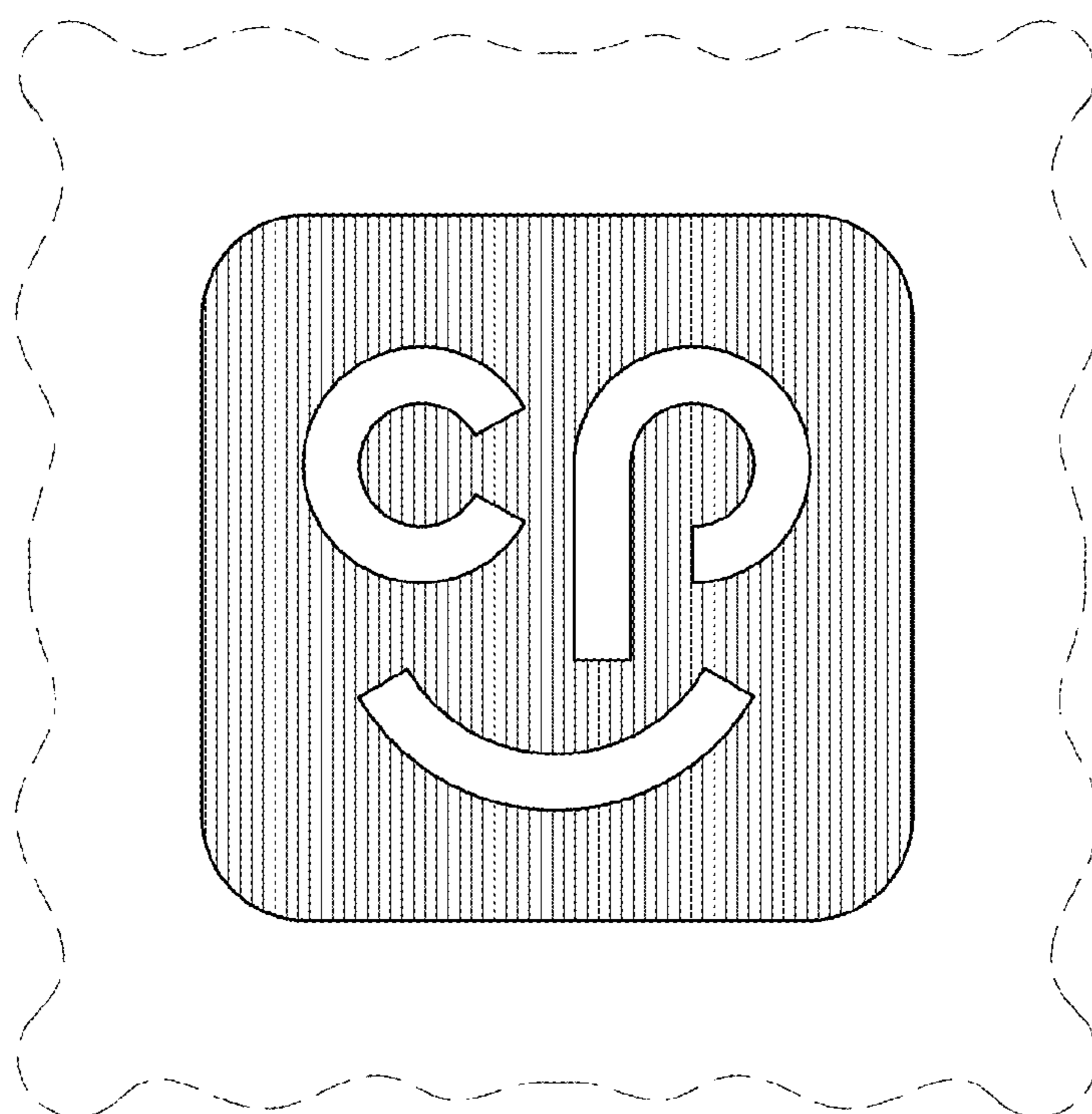

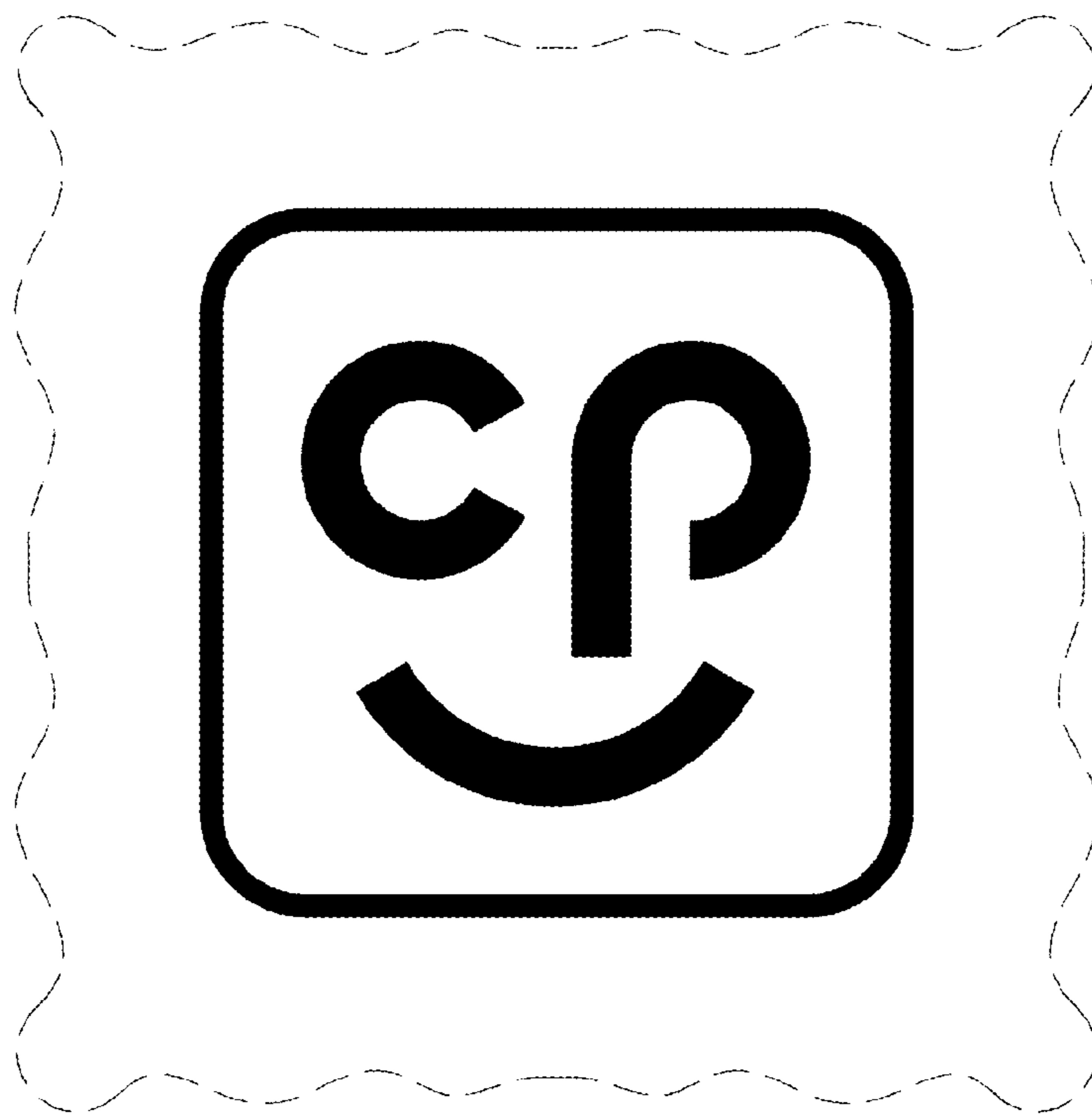

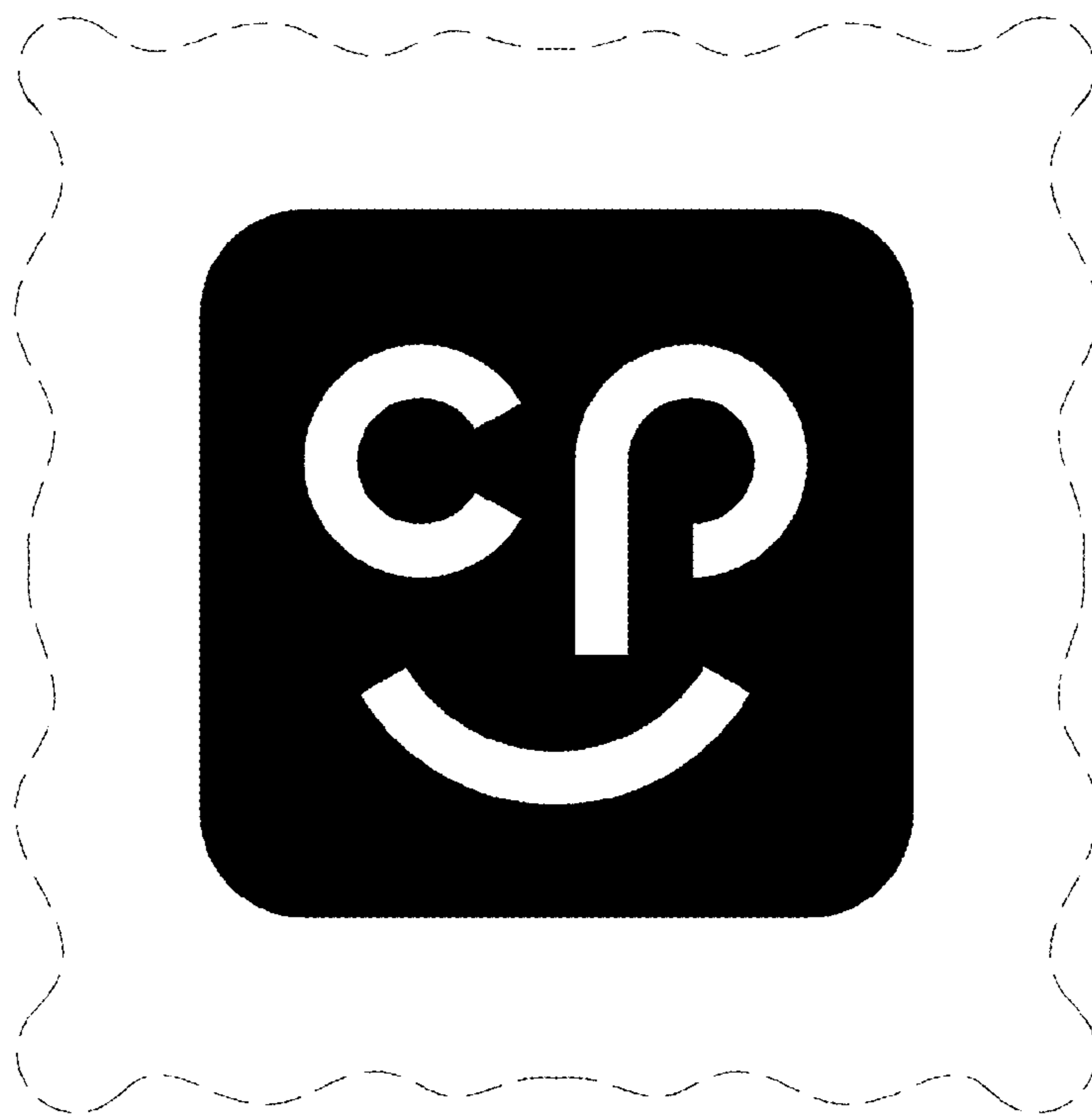

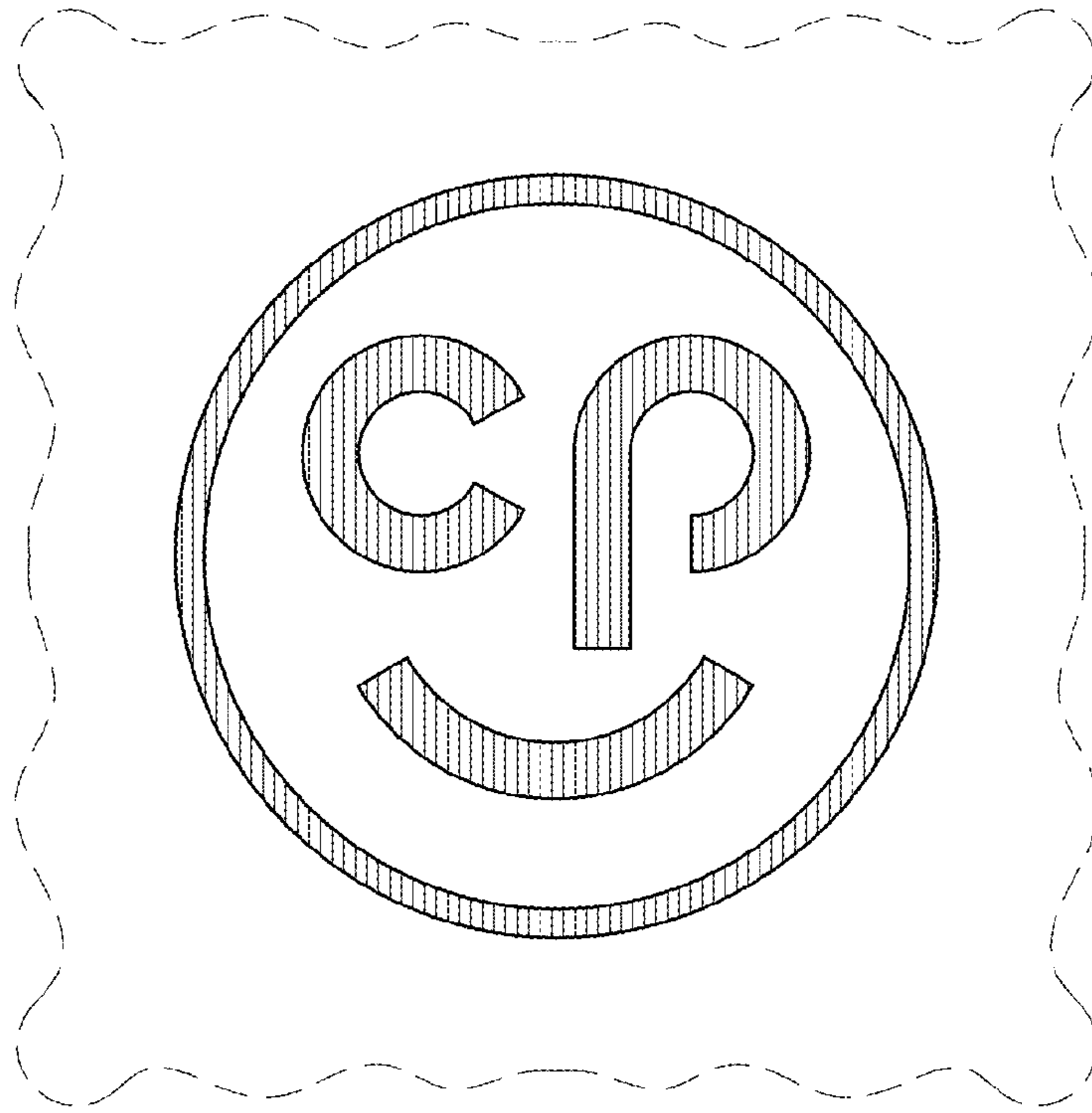

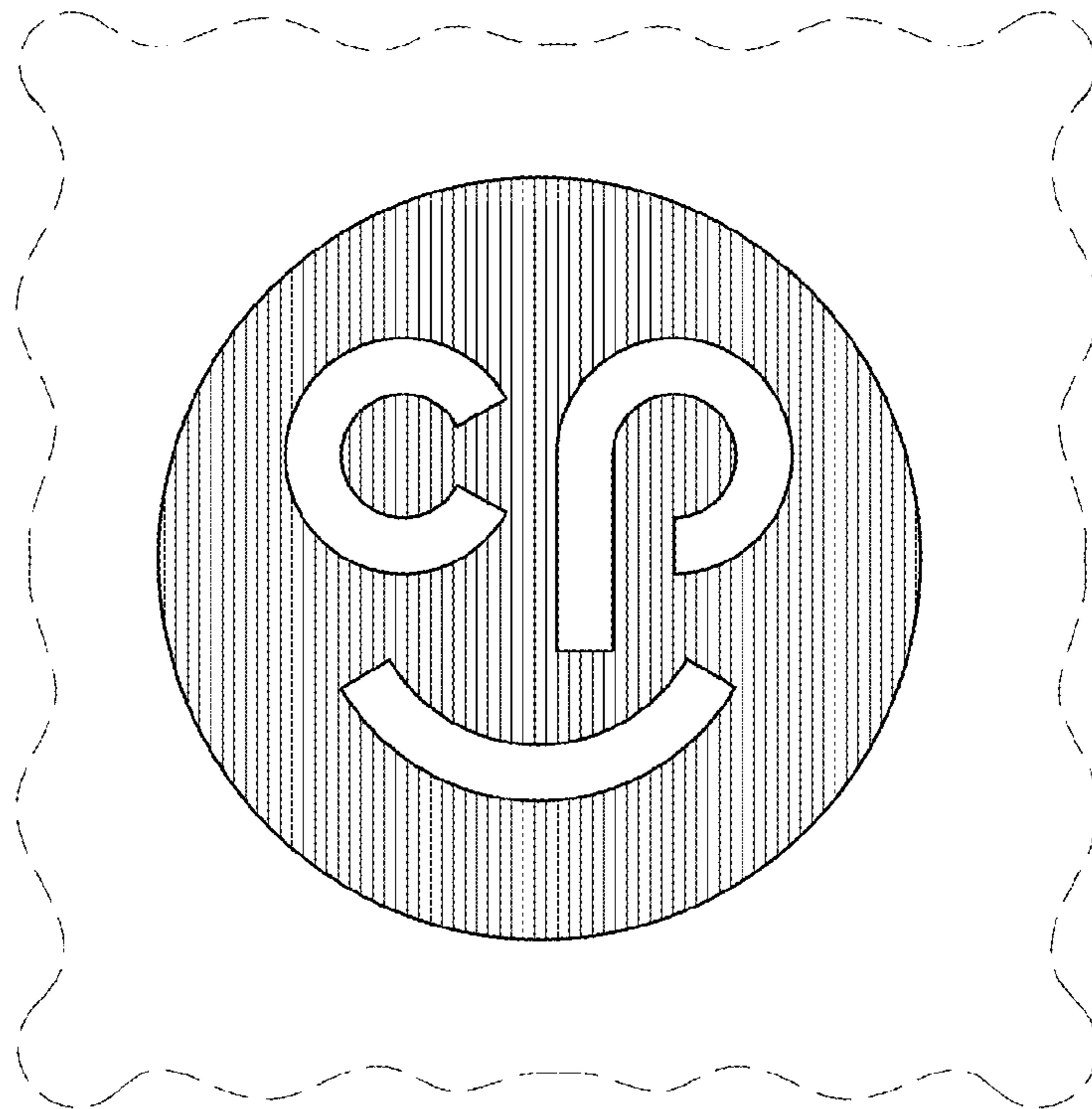

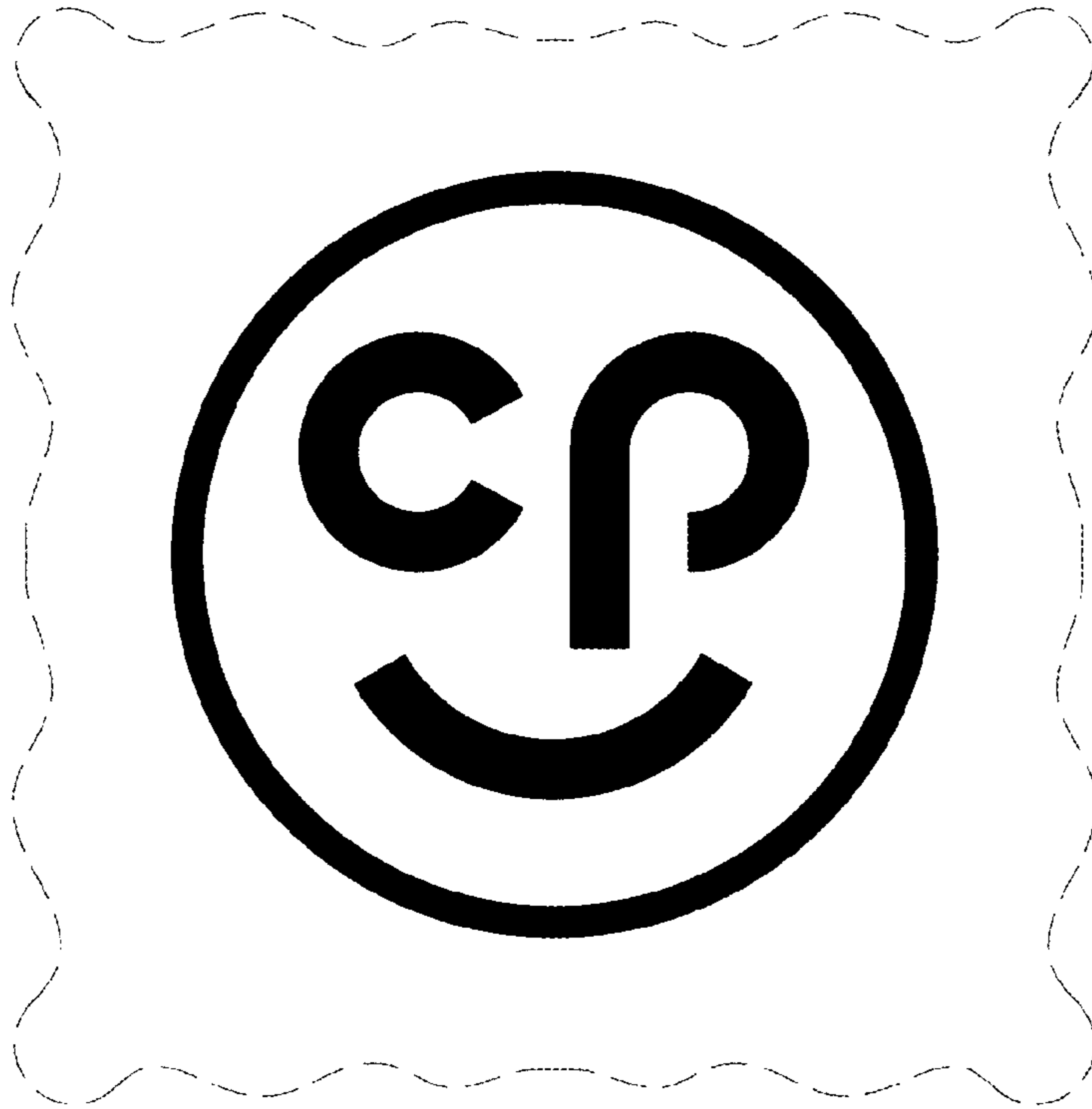

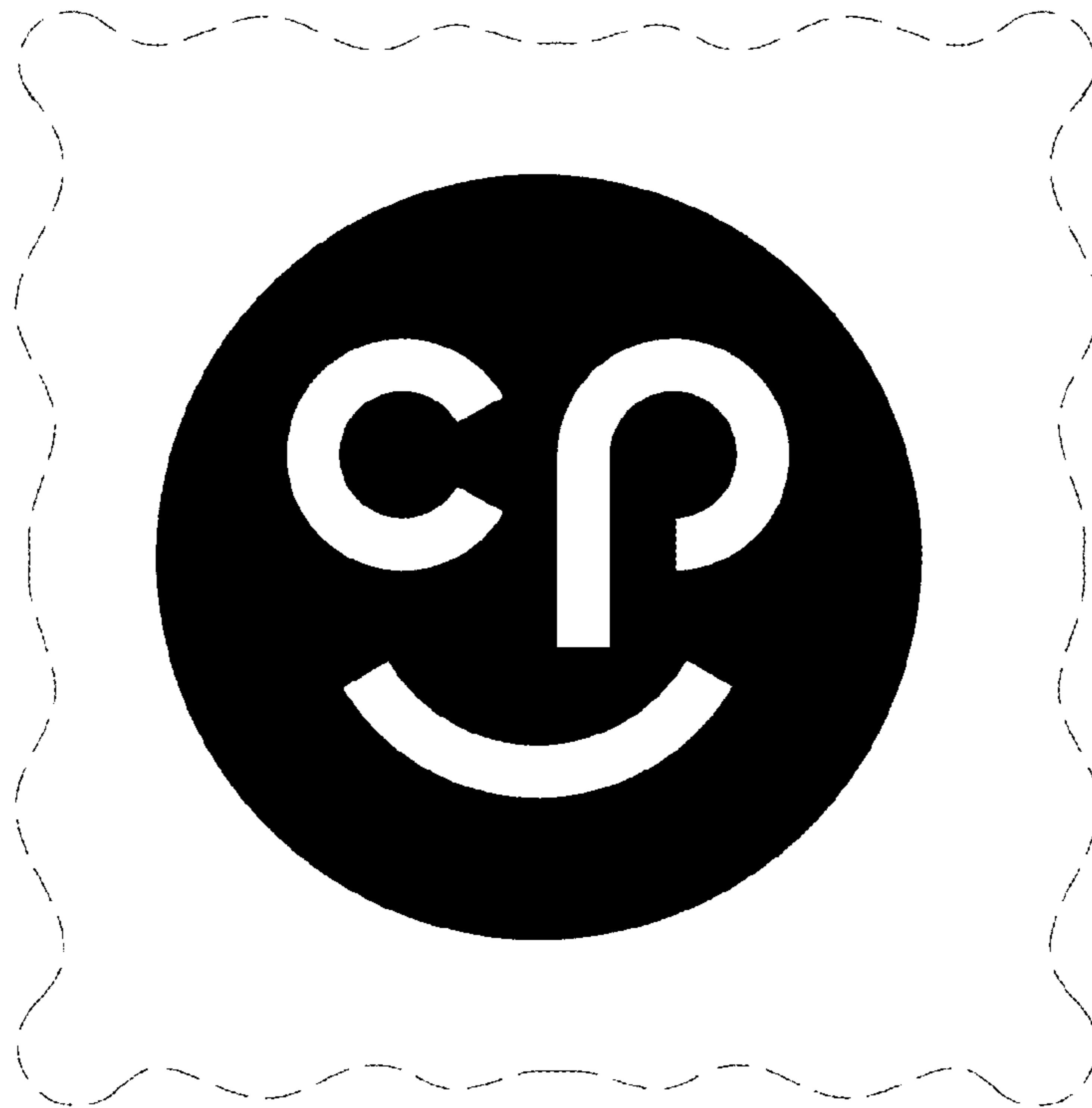
