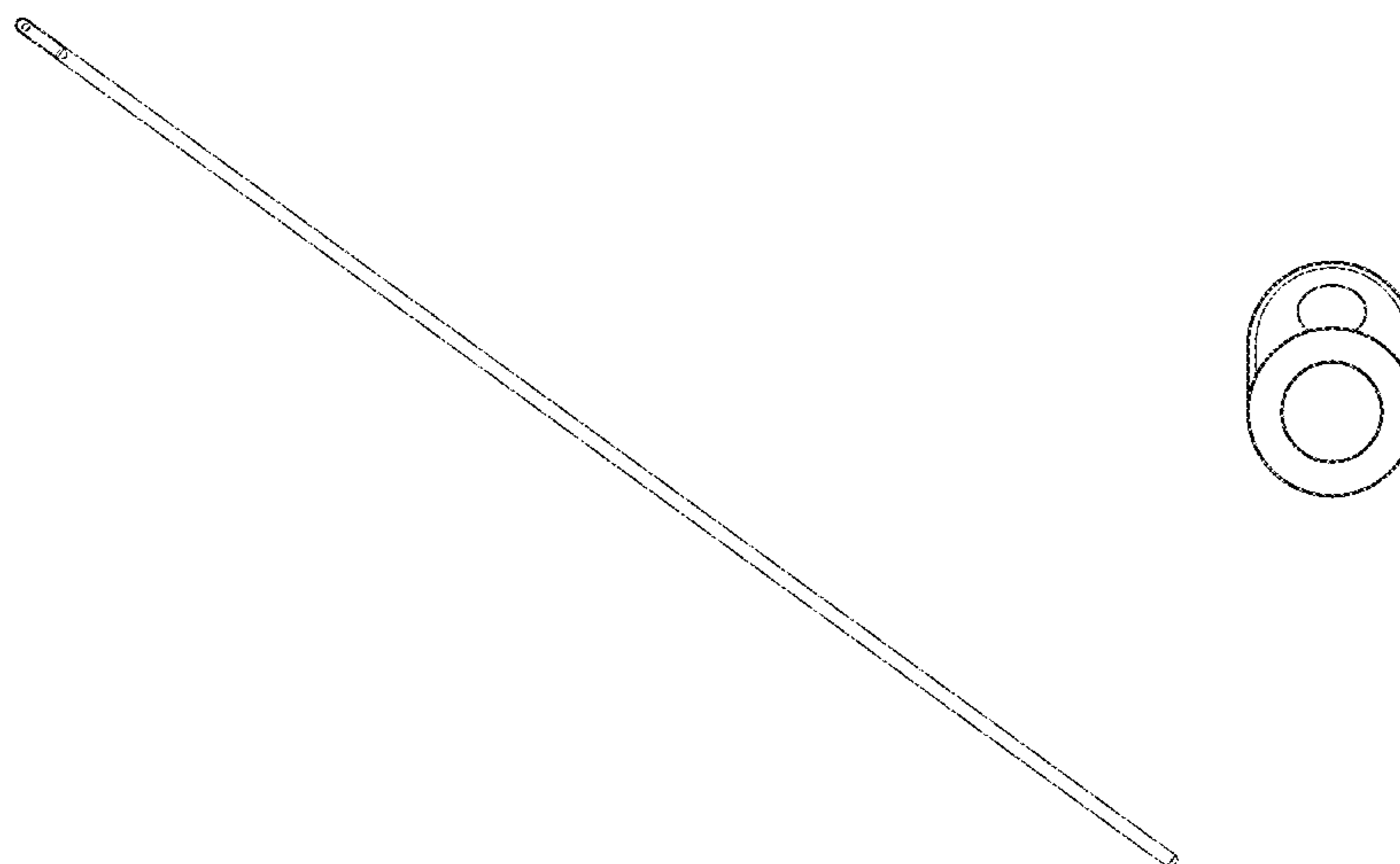

(57) **CLAIM**  
The ornamental design for a laparoscopic knot pushing device, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of the laparoscopic knot pushing device. FIG. 2 is a bottom view of a laparoscopic knot pushing device. FIG. 3 is a side view of a laparoscopic knot pushing device. FIG. 4 is an enlarged front view of a laparoscopic knot pushing device; and, FIG. 5 is an enlarged rear view of a laparoscopic knot pushing device.

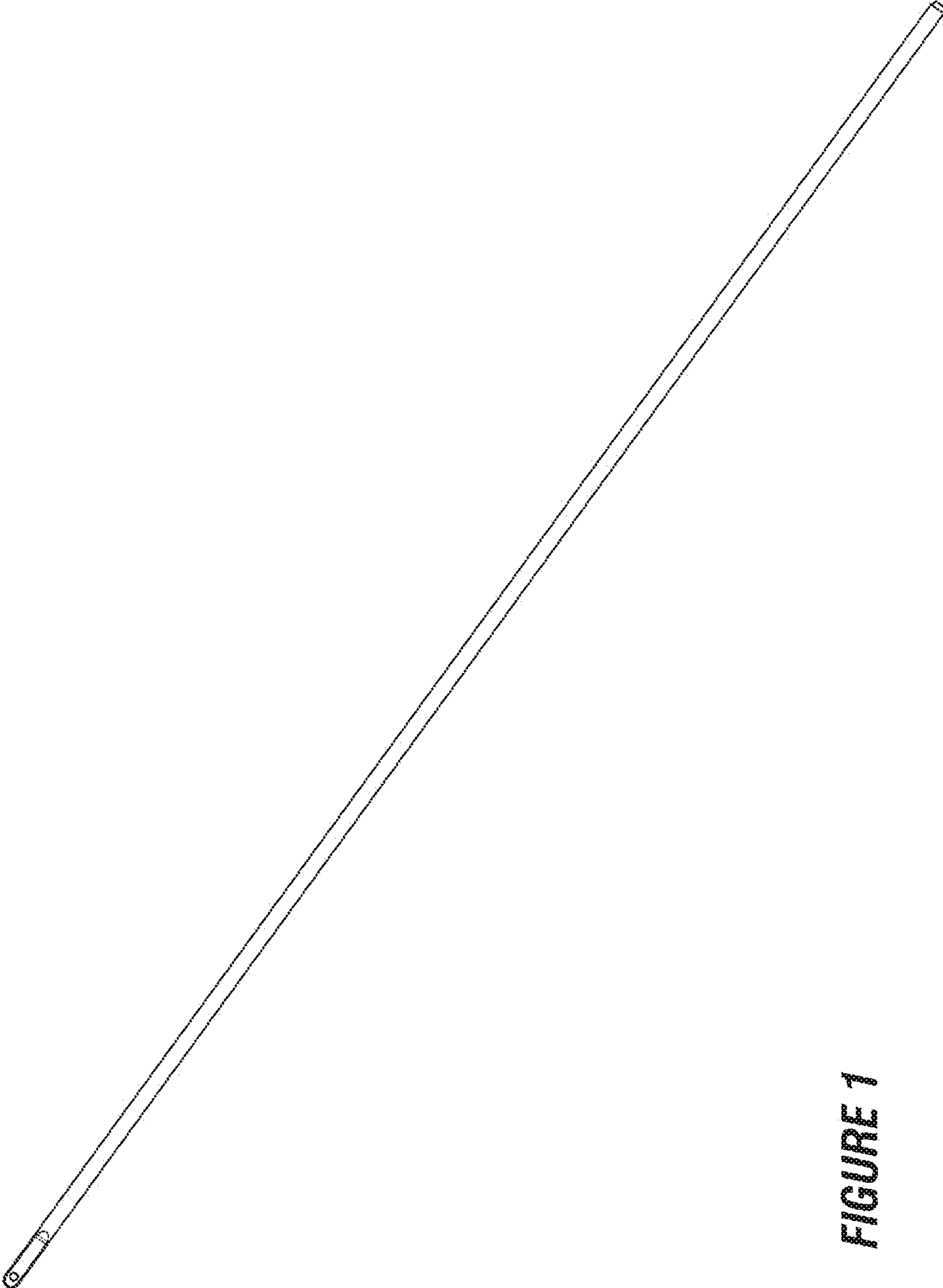

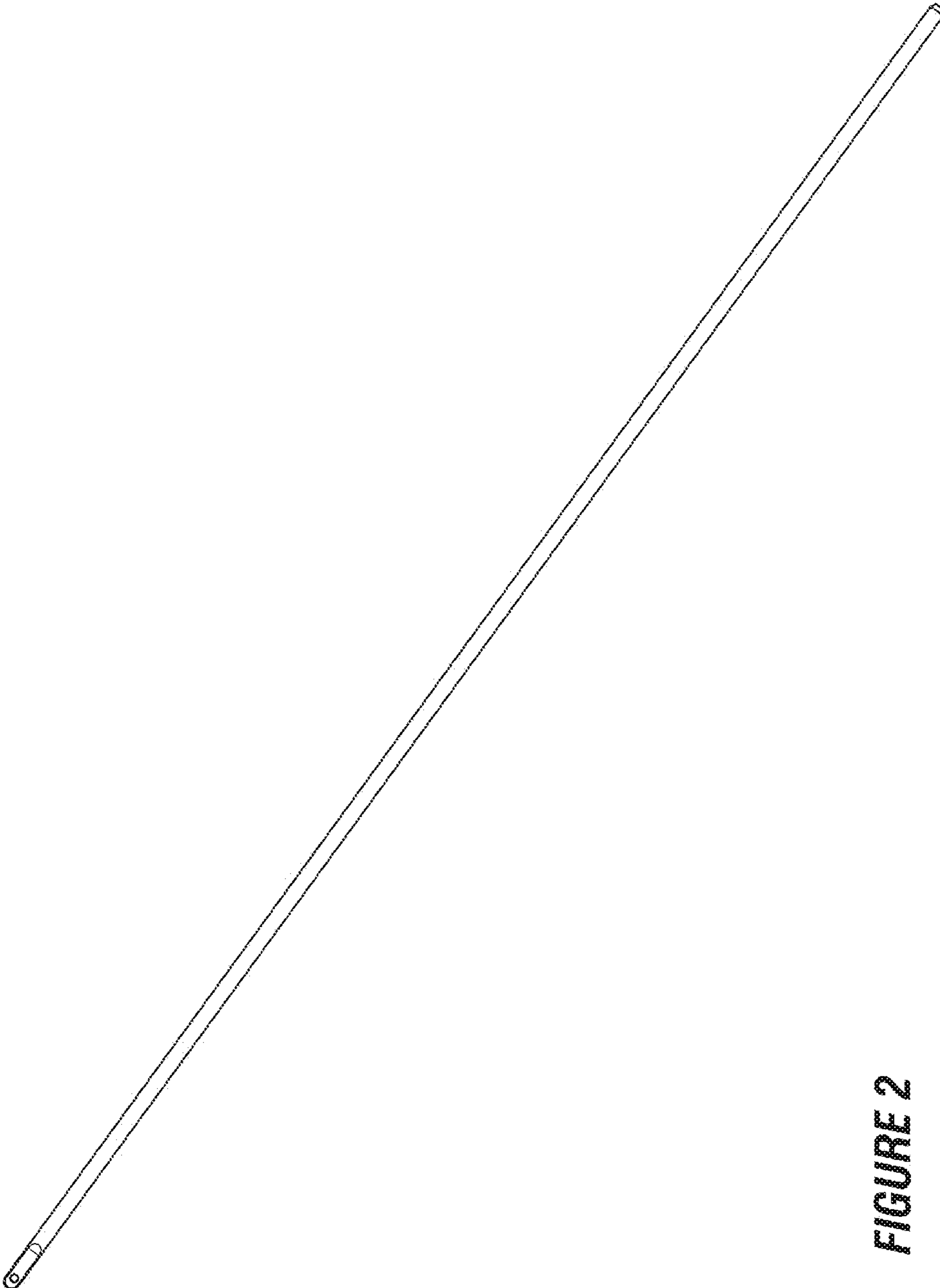

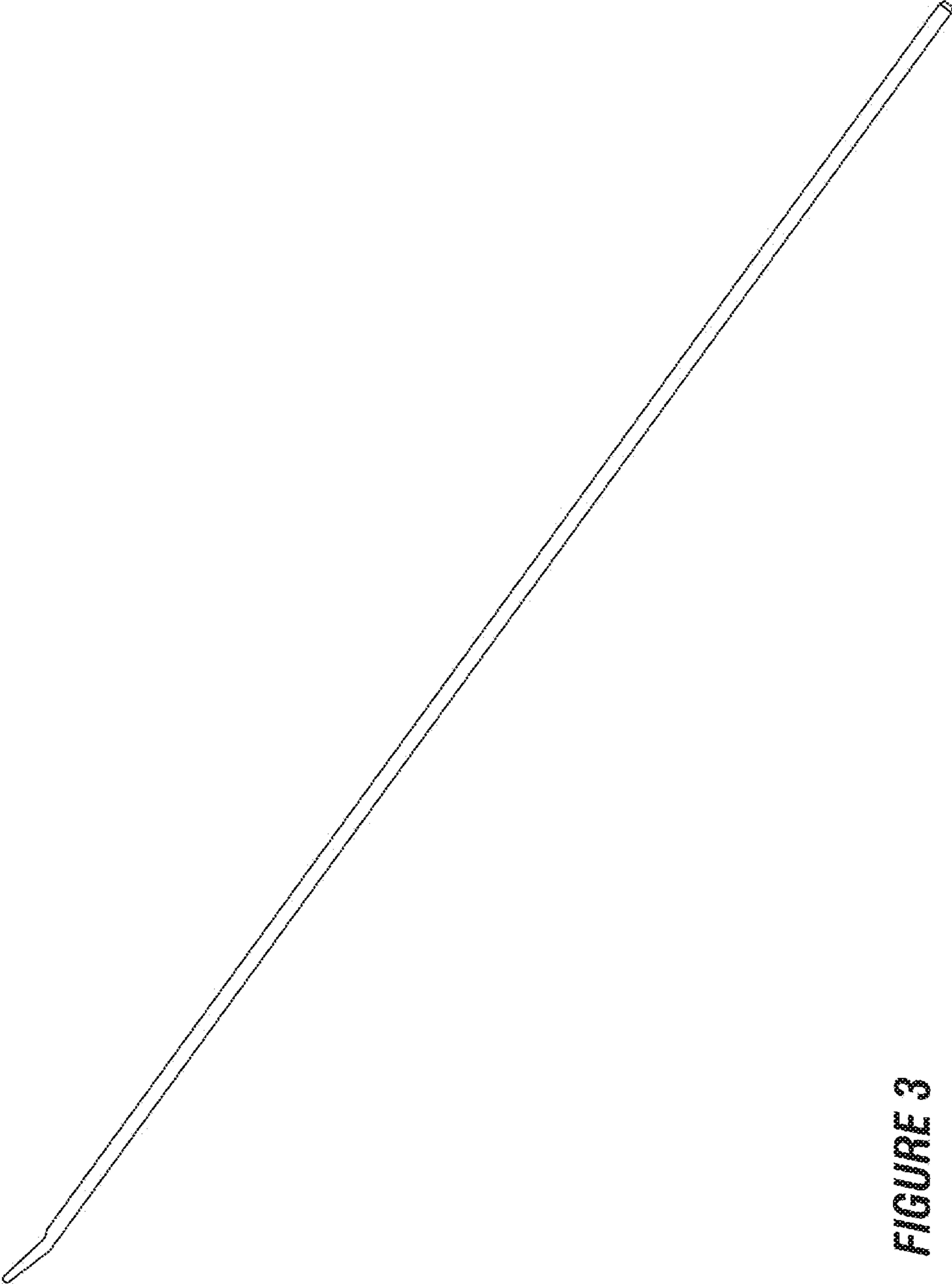
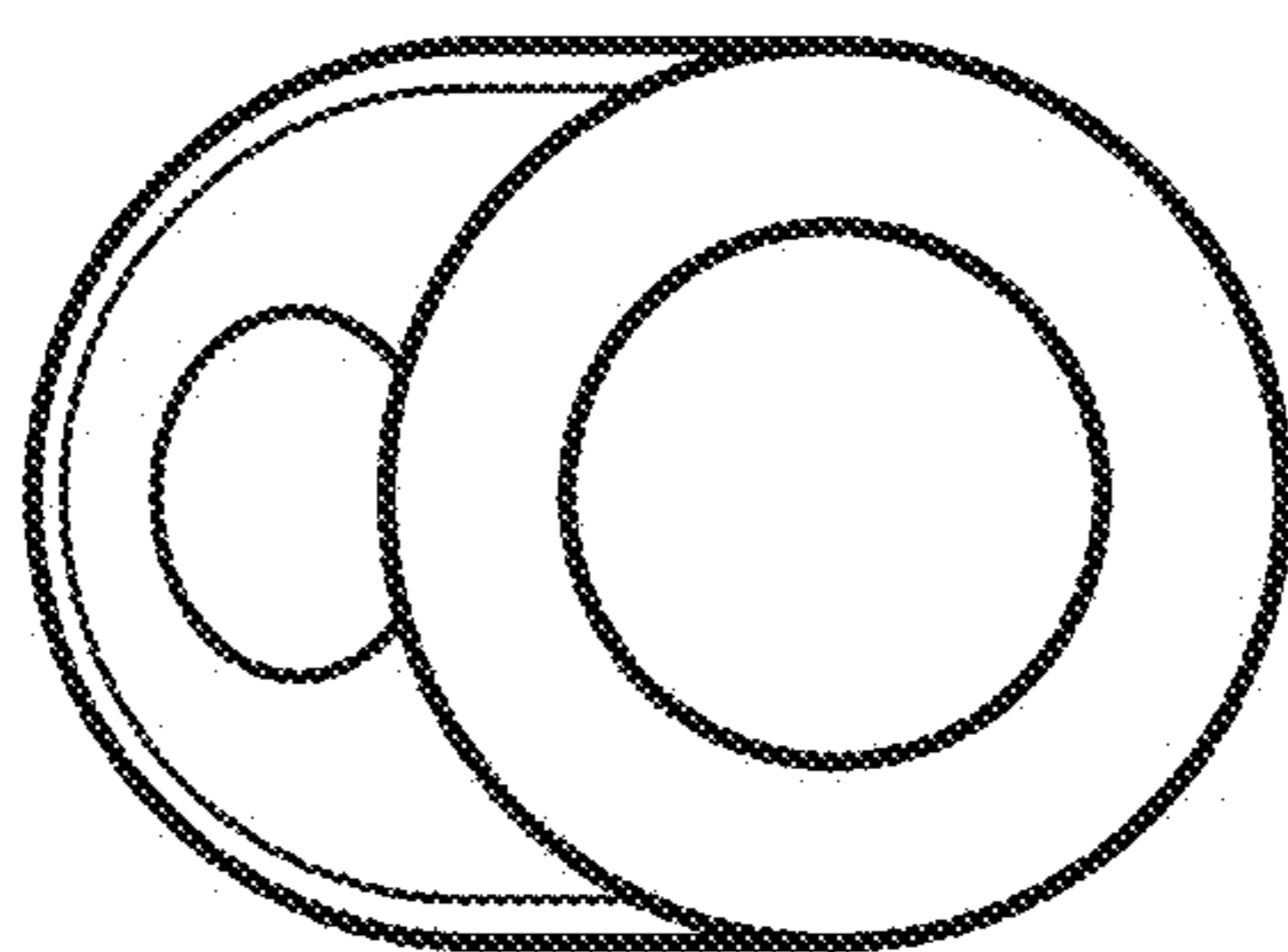
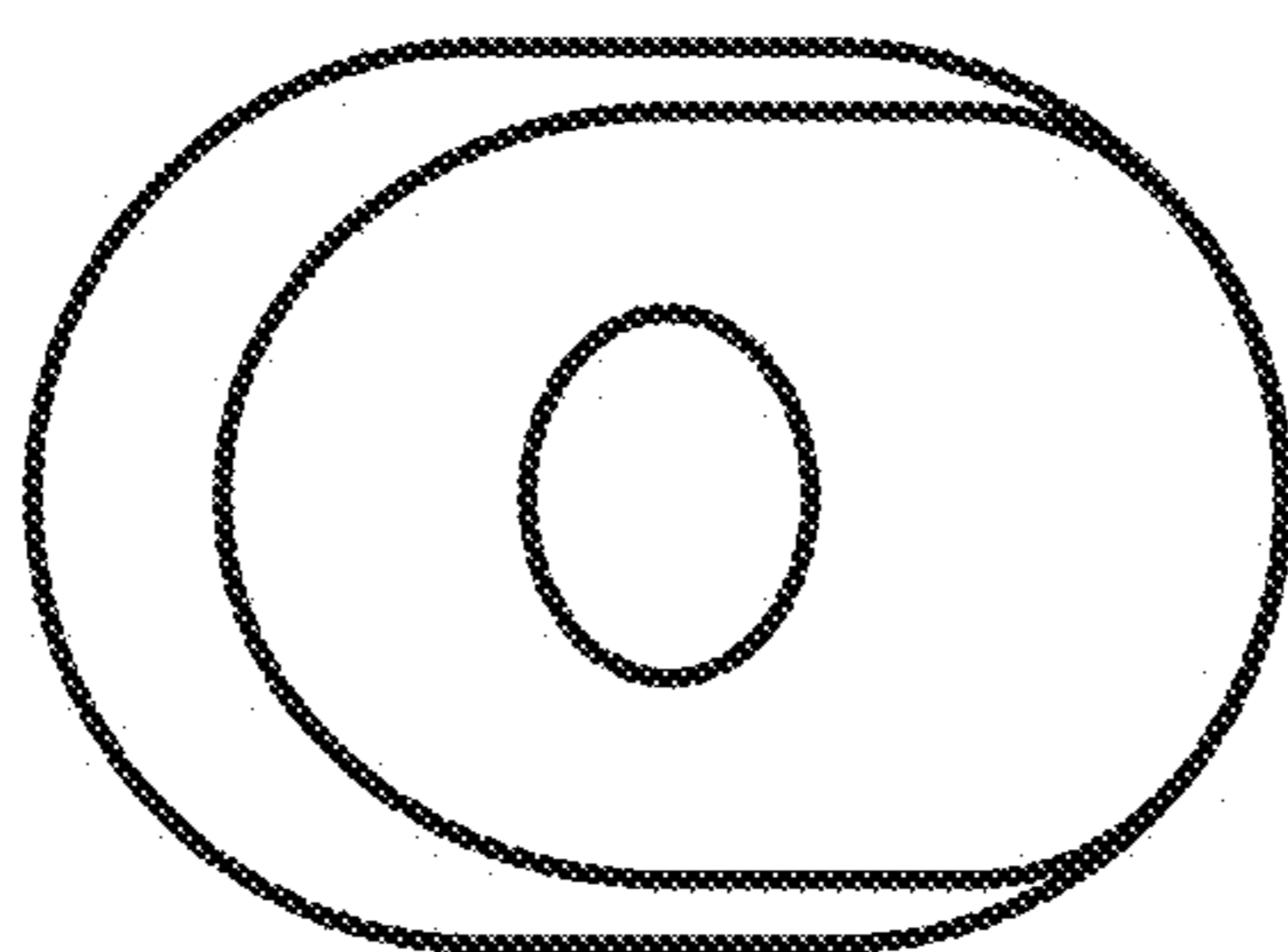
