DESCRIPTION

FIG. 1 is a top, front and right side perspective view of an animal carrier with seatbelt attachment showing my new design;

FIG. 3 is a rear elevation view thereof;

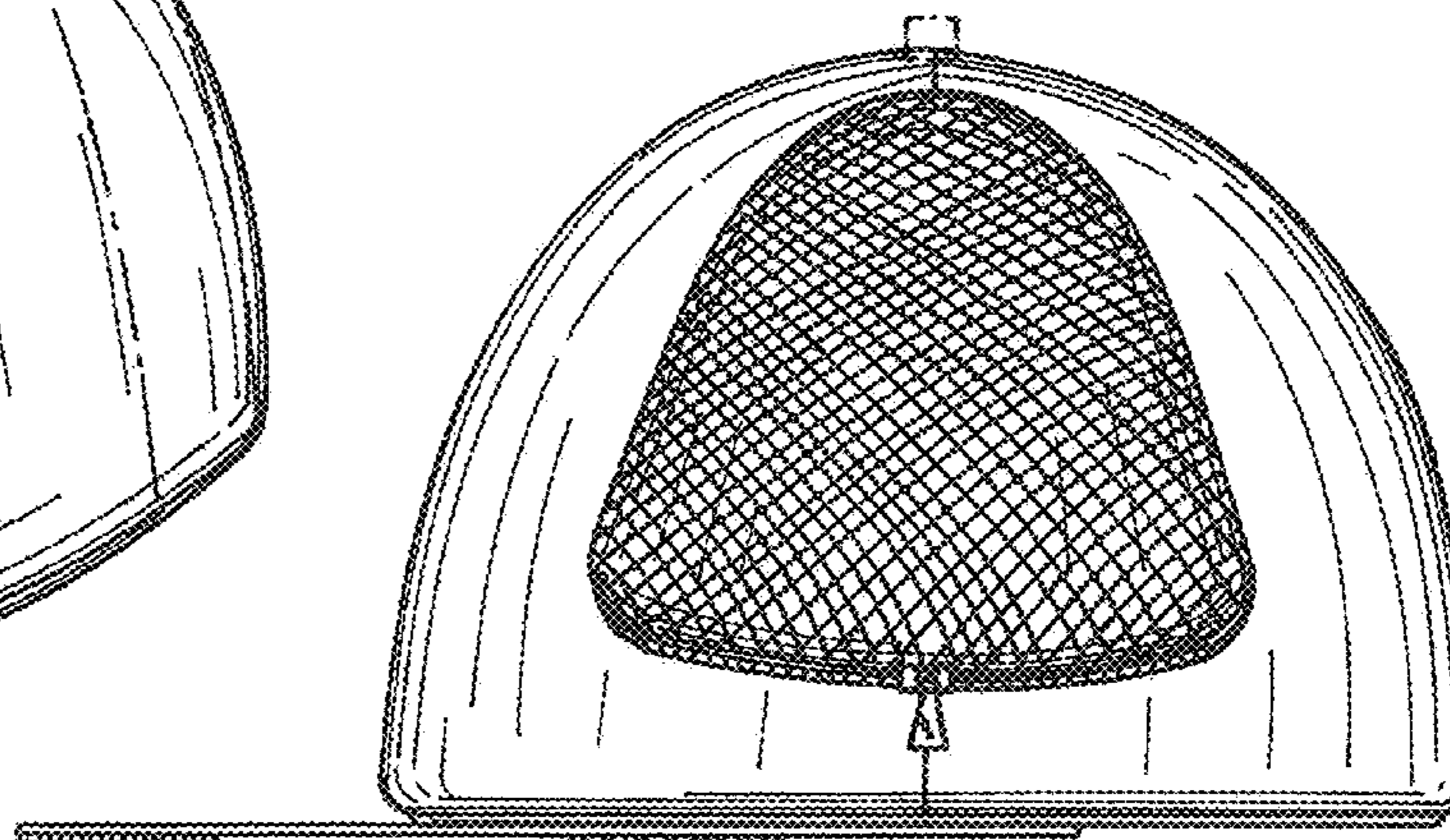
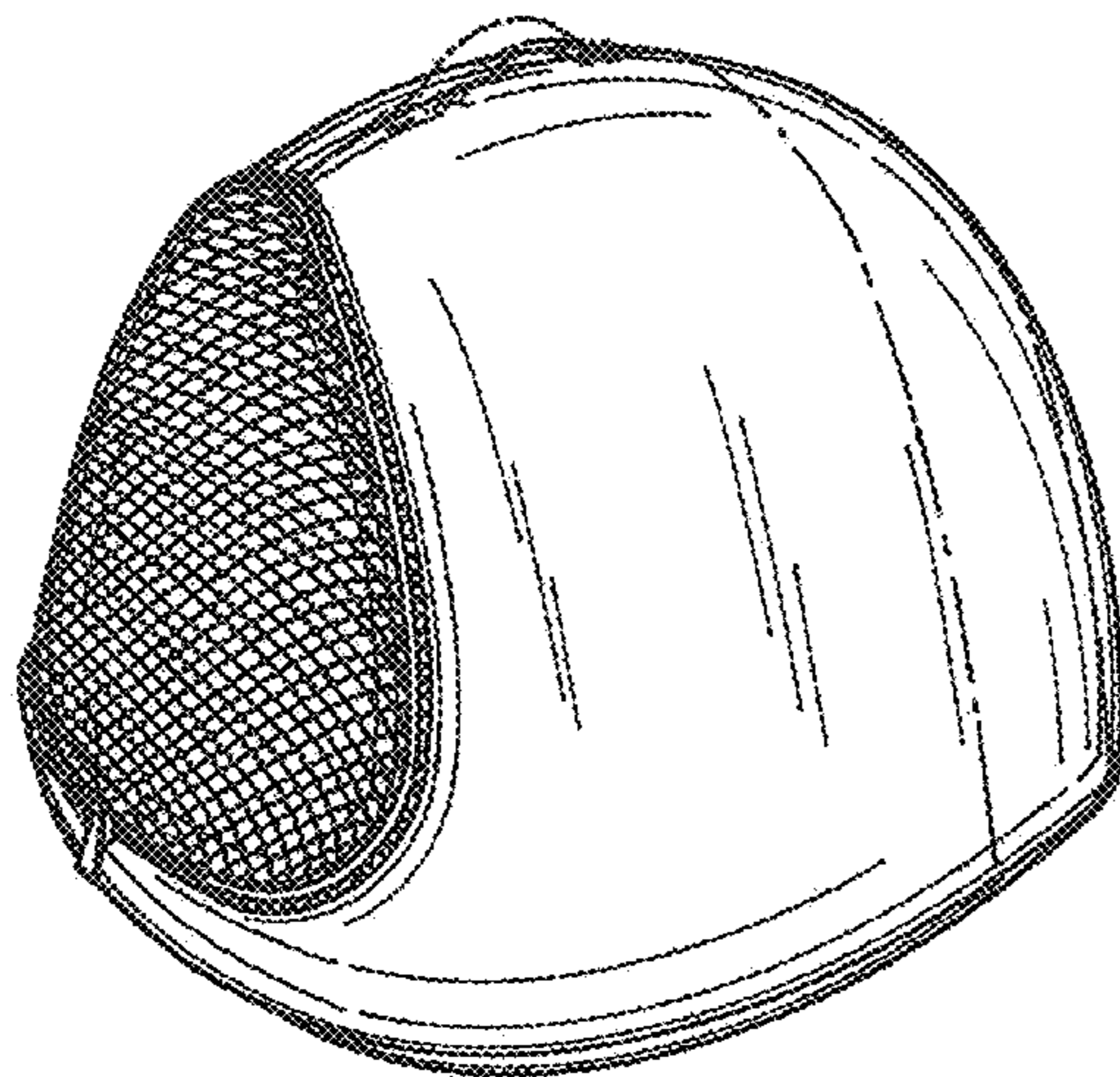
FIG. 4 is a right side elevation view thereof, the left side being substantially a mirror image of the right side shown;

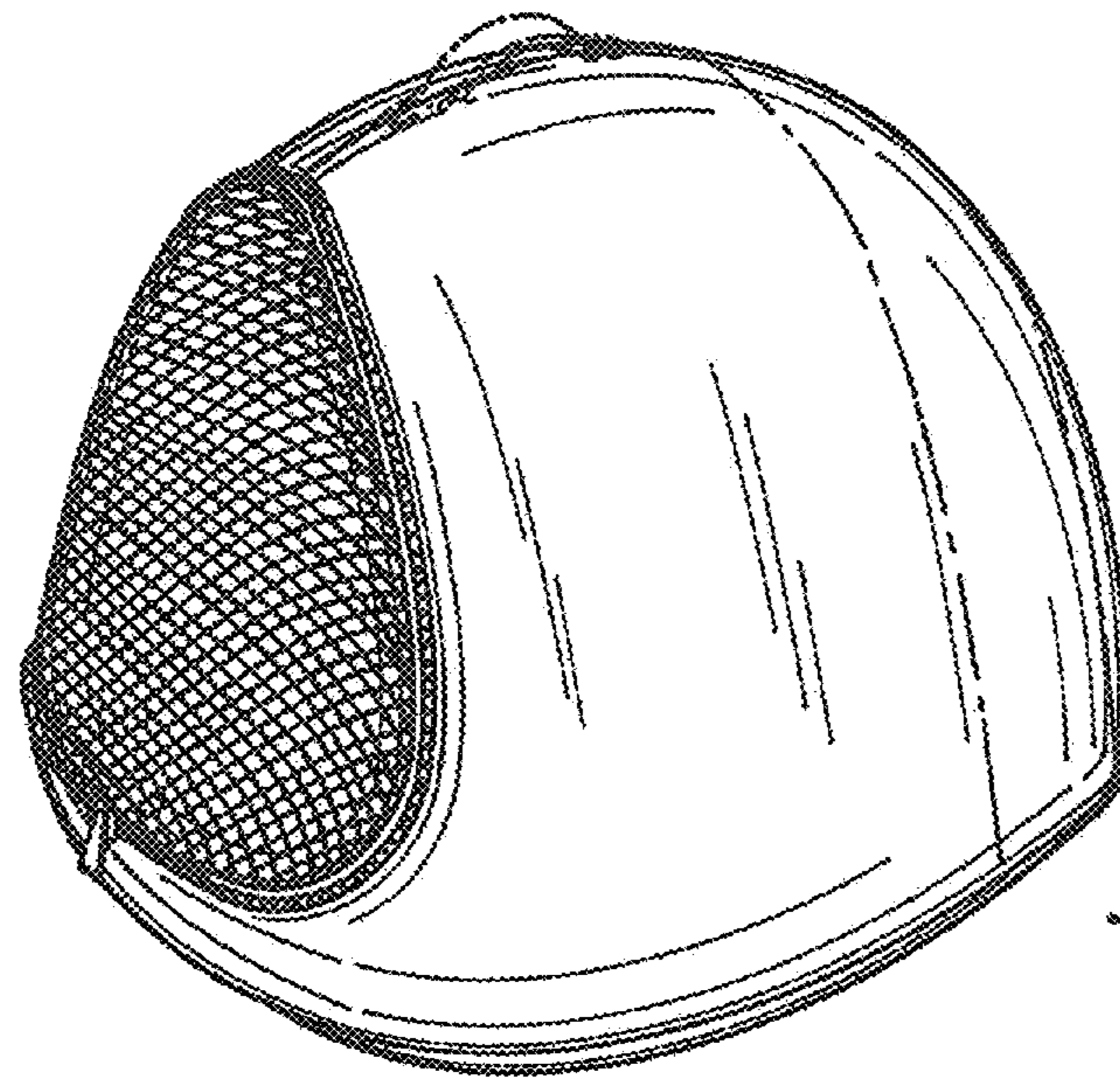

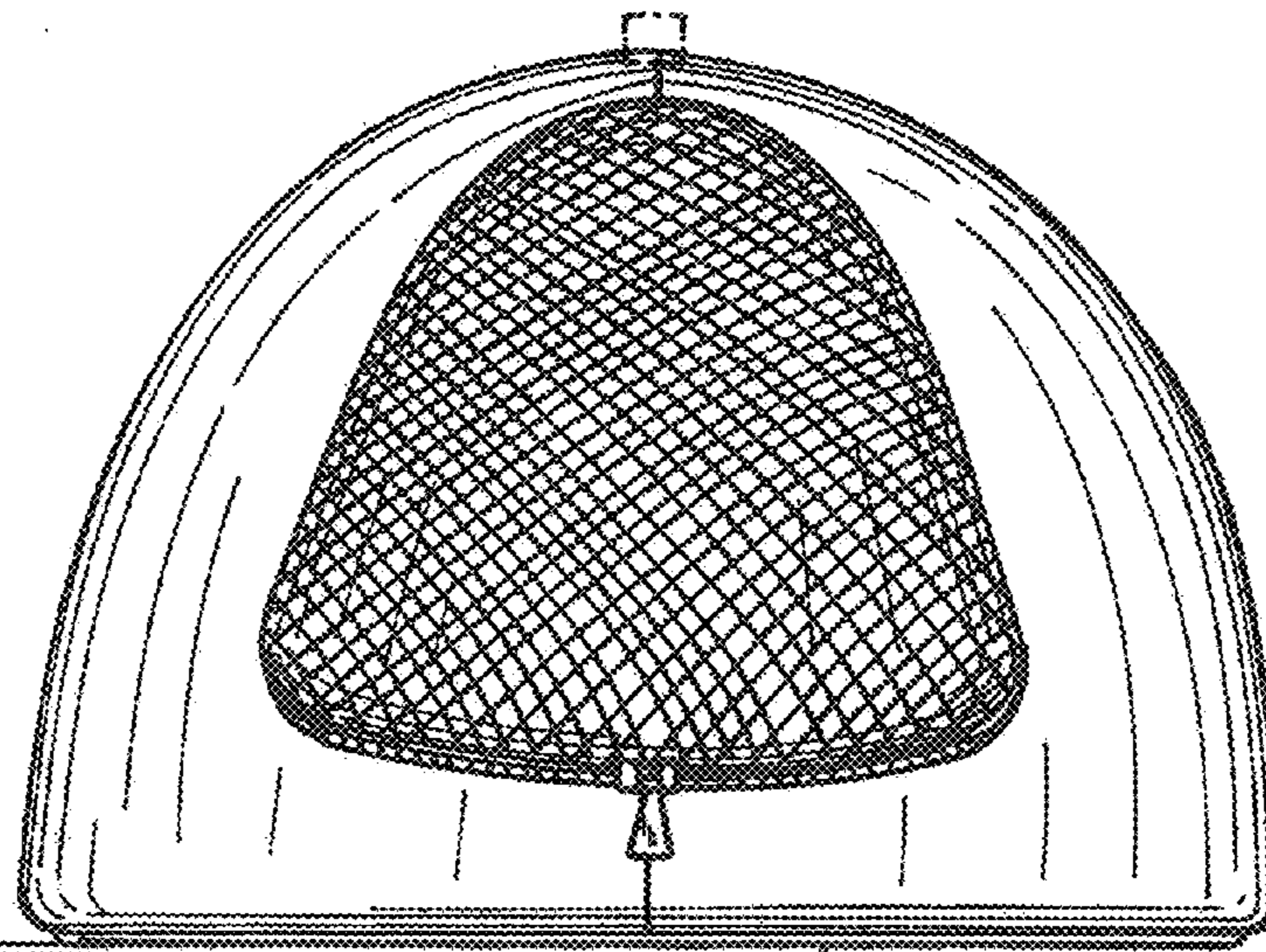

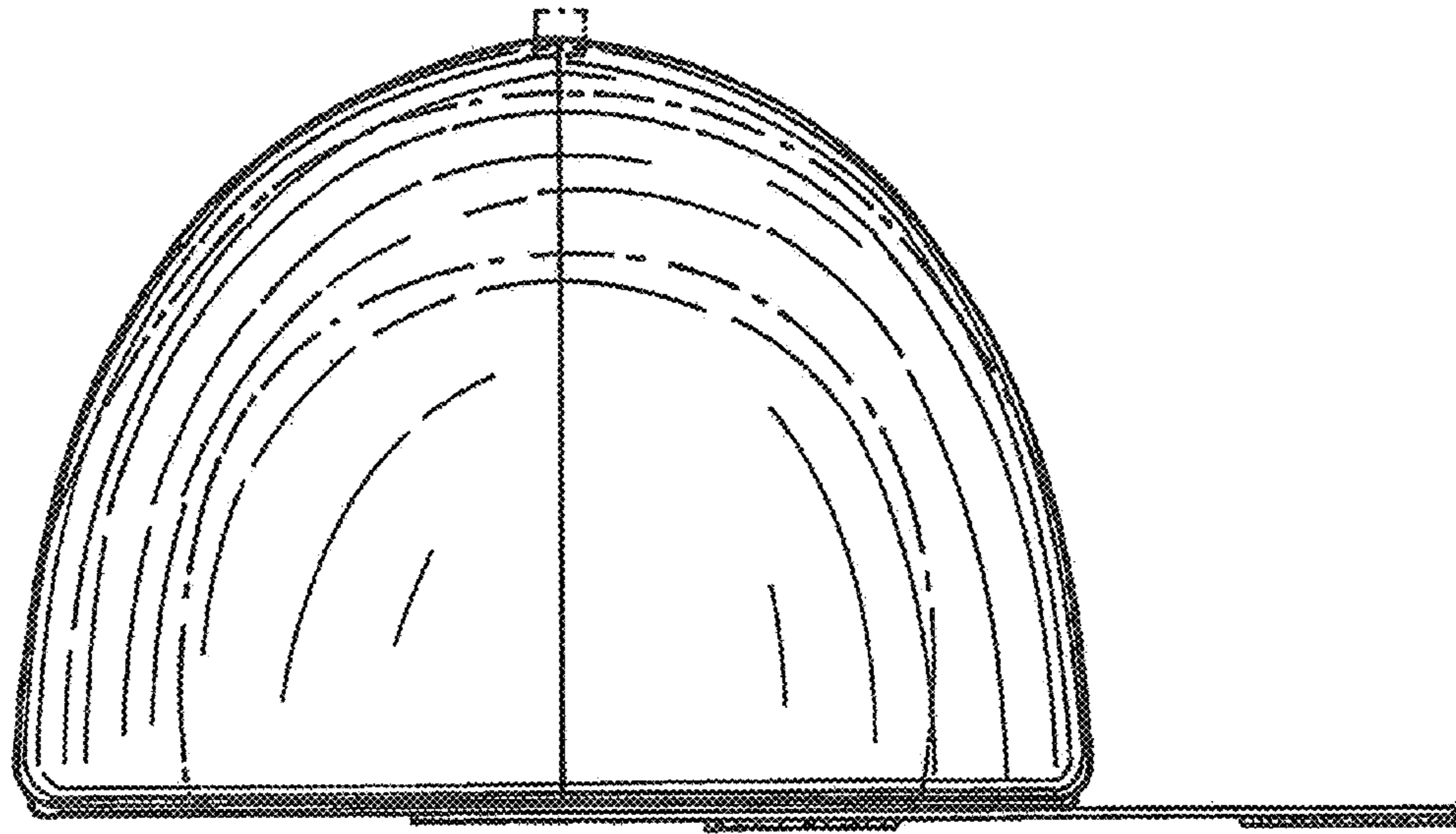

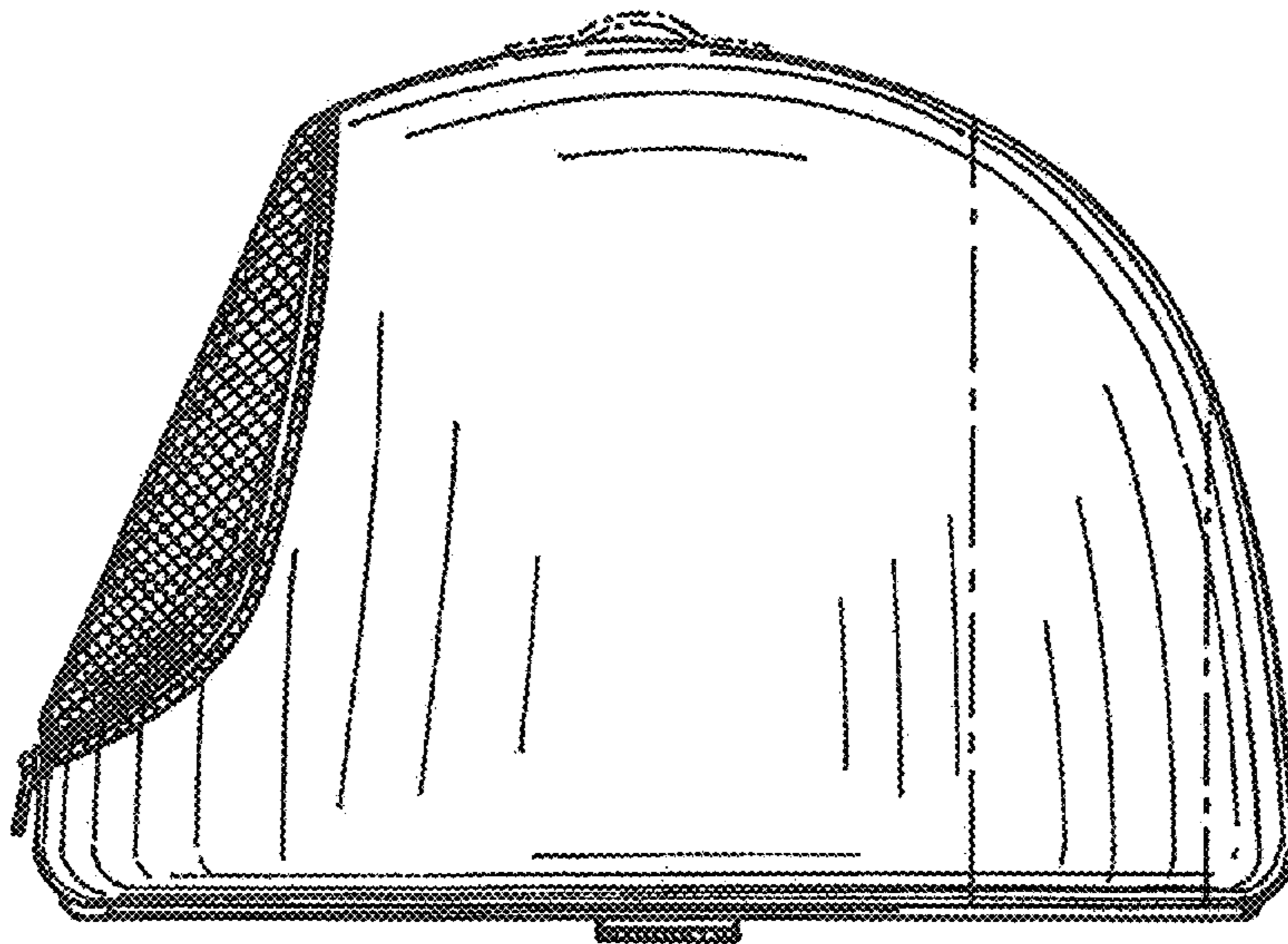

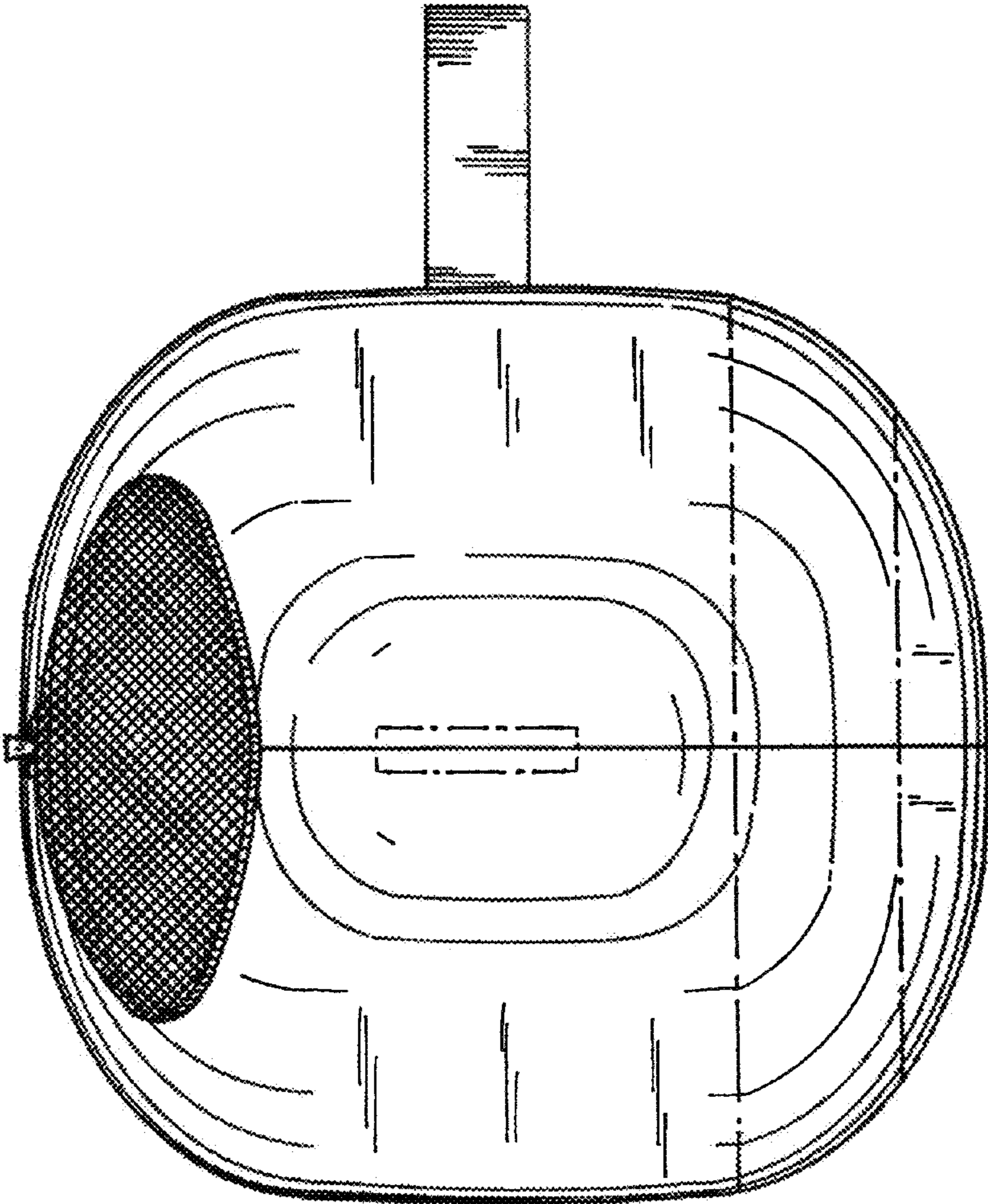

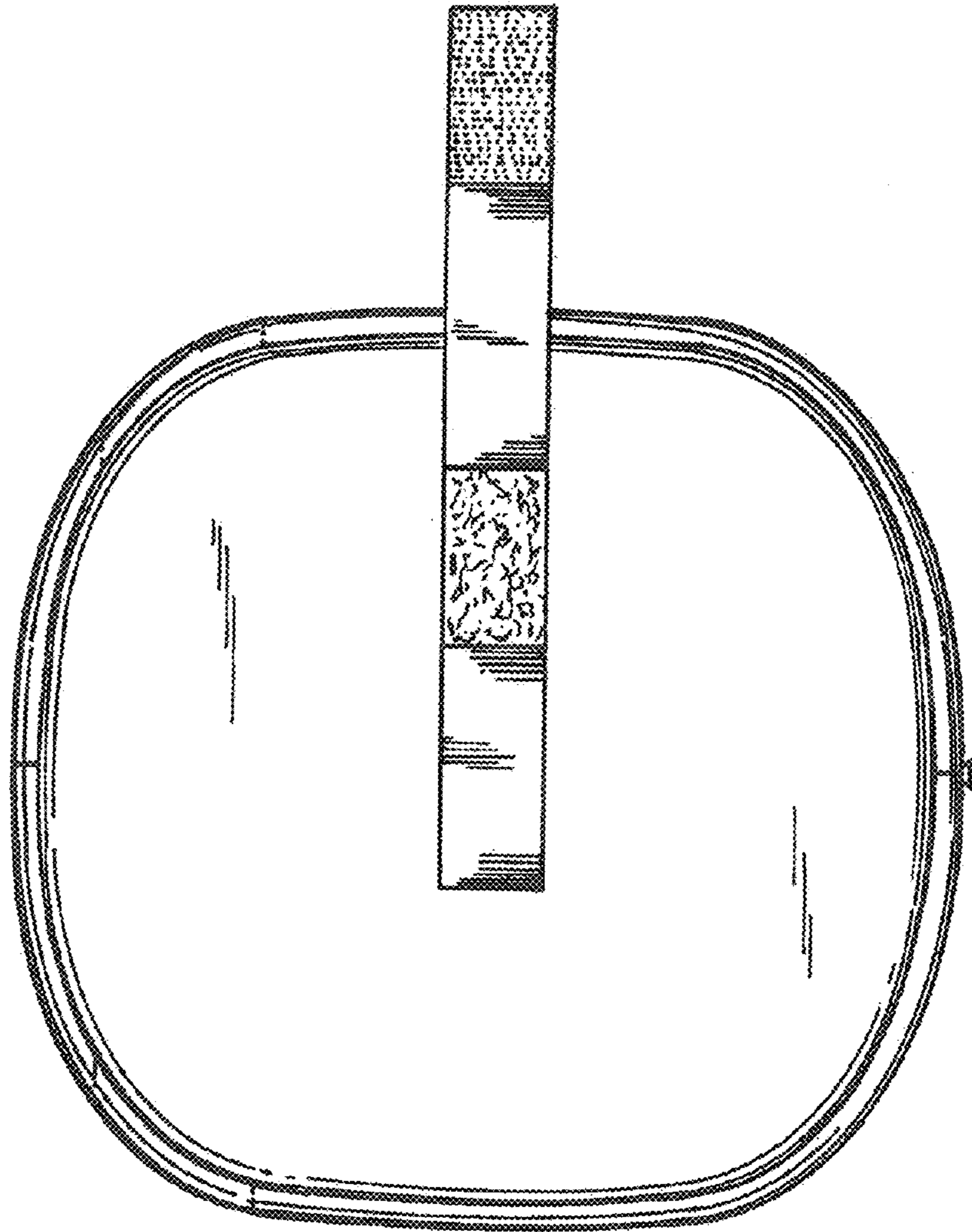
