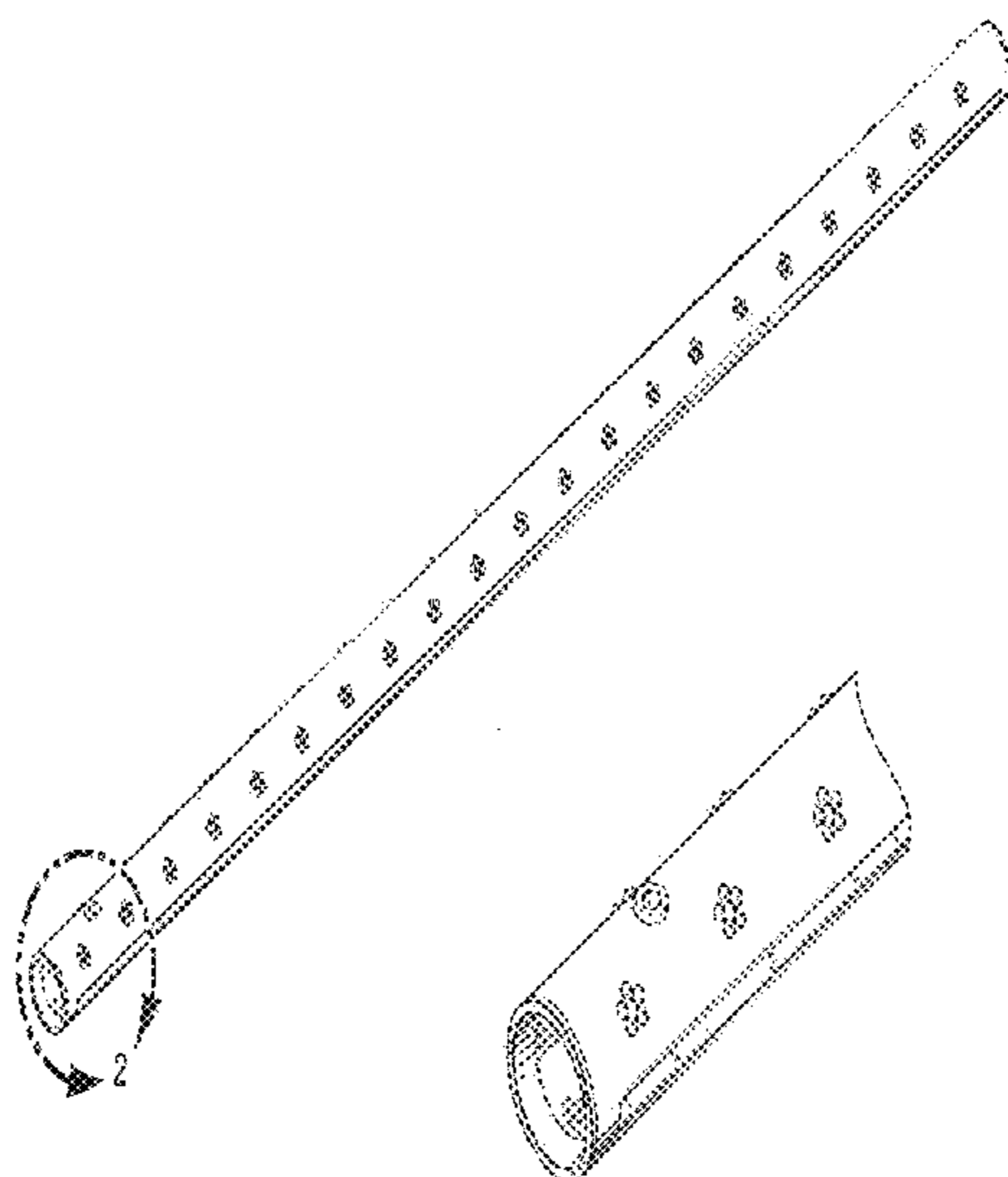
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a hummingbird feeder.
 FIG. 2 is an enlarged view of a portion of the hummingbird feeder of FIG. 1.
 FIG. 3 is a front view of the hummingbird feeder.
 FIG. 4A is a top plan view of a first half of the hummingbird feeder.

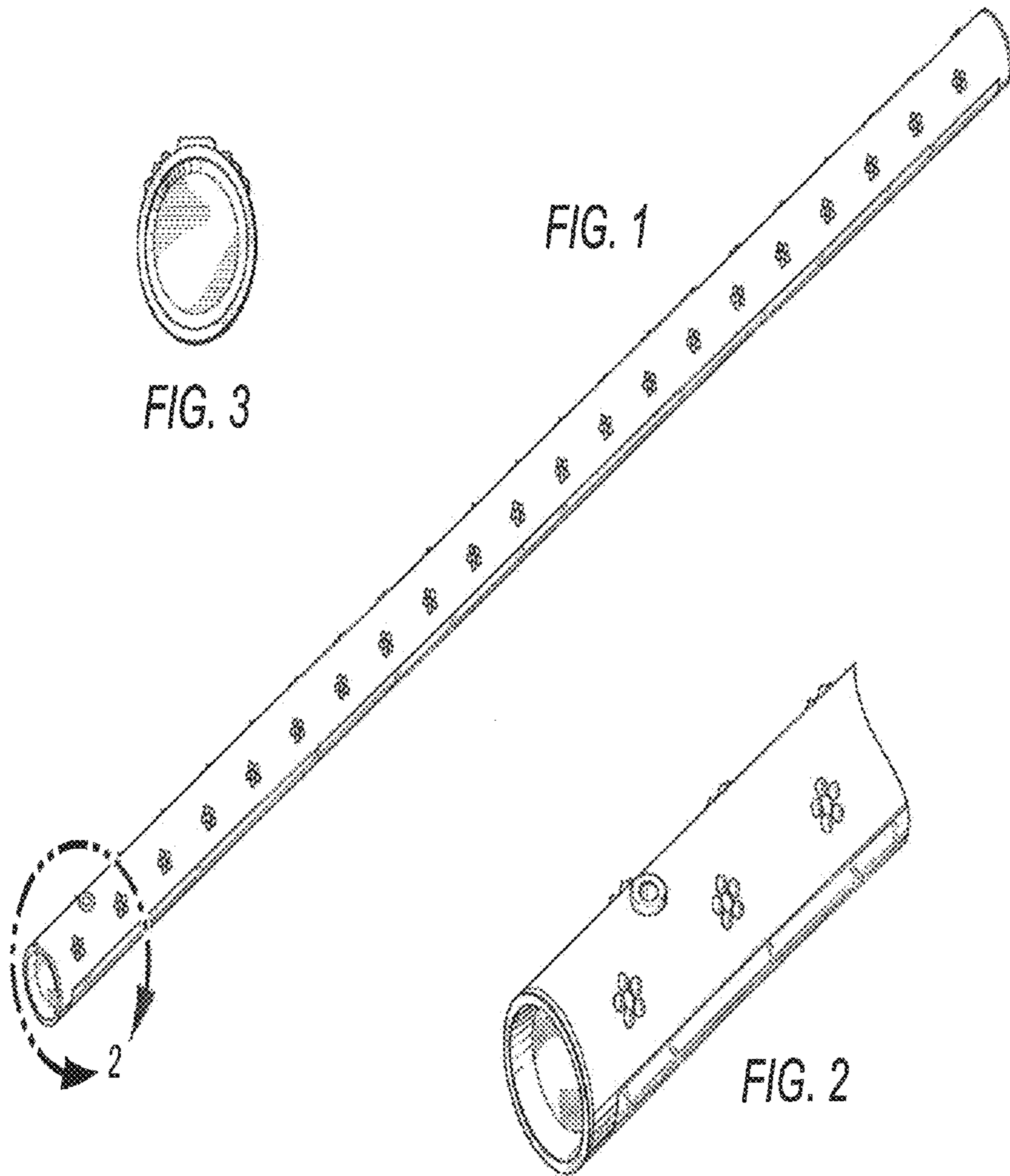

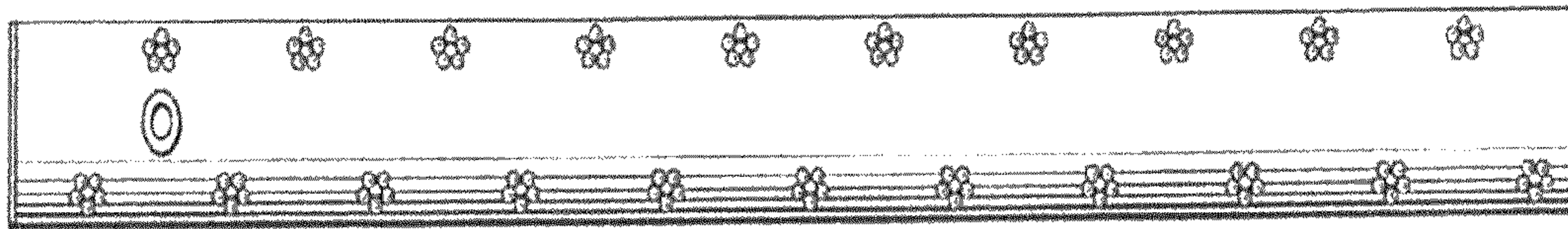

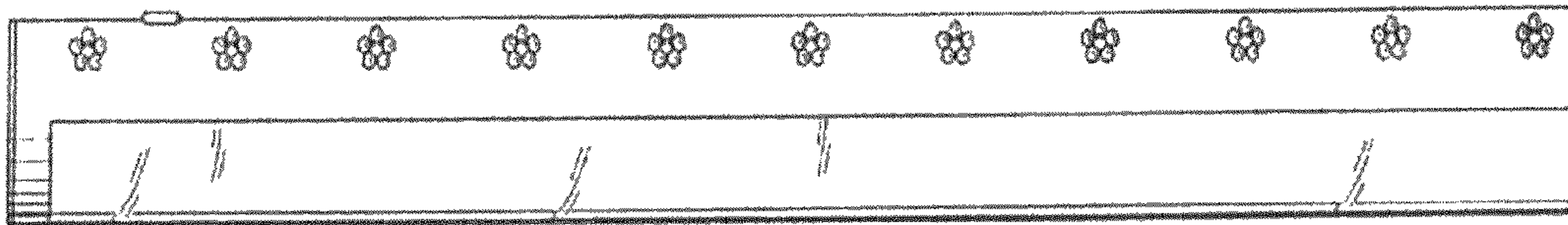

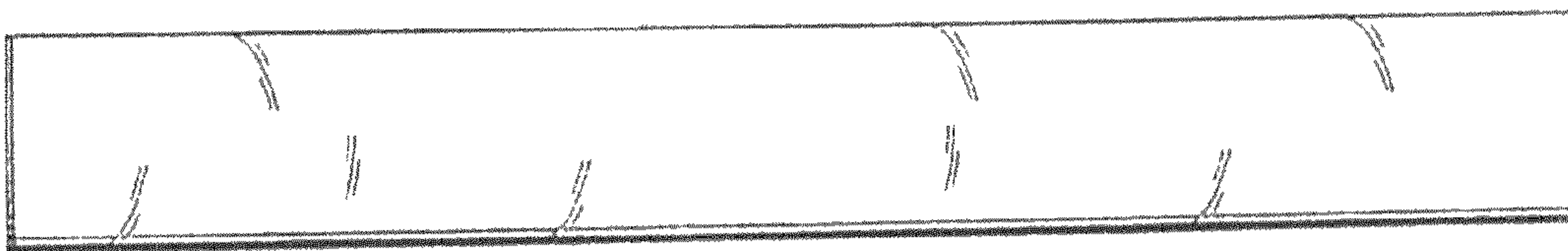

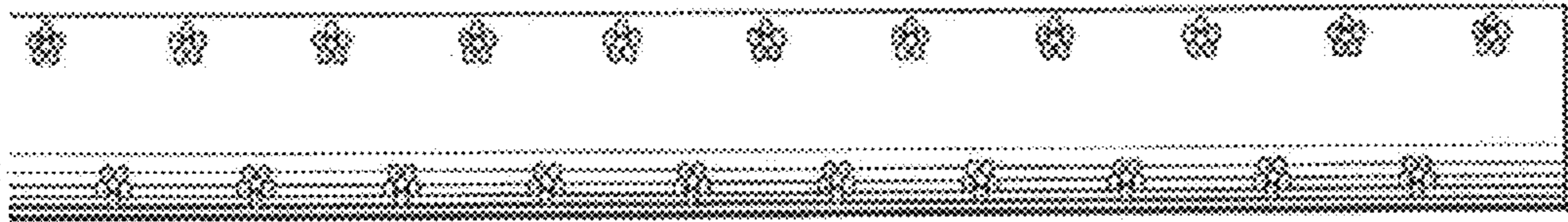

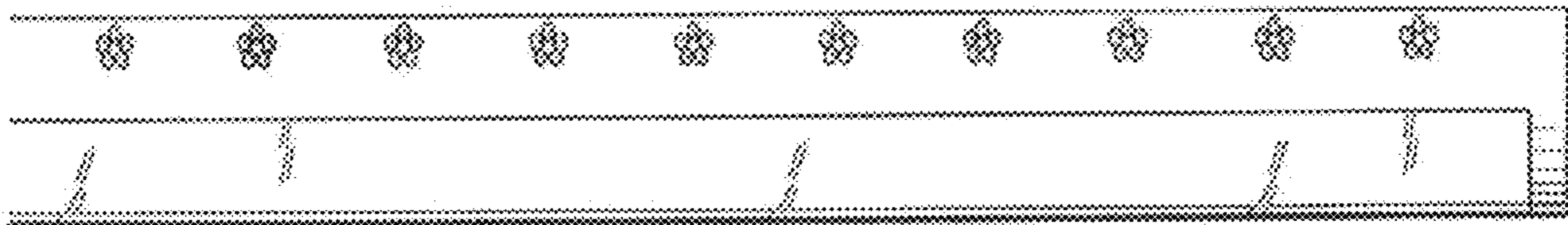

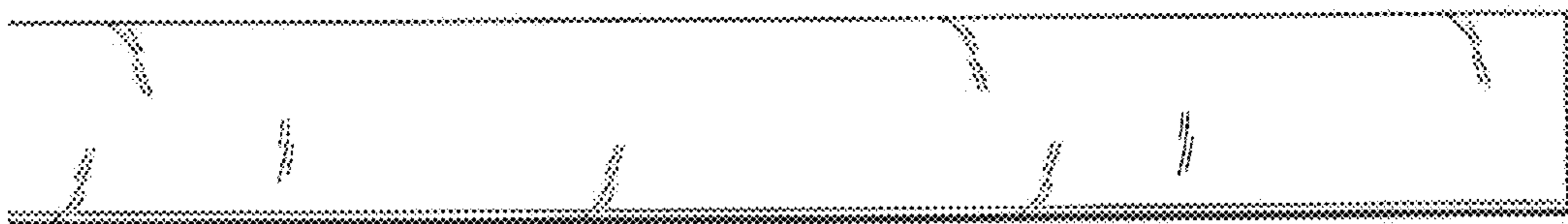
