(57) **CLAIM**

I claim the ornamental design for a pattern of apertures for an ironing surface cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an ironing surface cover showing my new design as seen from the front side; FIG. 2 is a perspective view of the same as seen from the rear side; FIG. 3 is a front view of the same; and, FIG. 4 is a rear view of the same. The broken lines showing the contour of the ironing surface cover in FIGS. 1-4 are for illustrative purposes only and form no part of the claimed design.

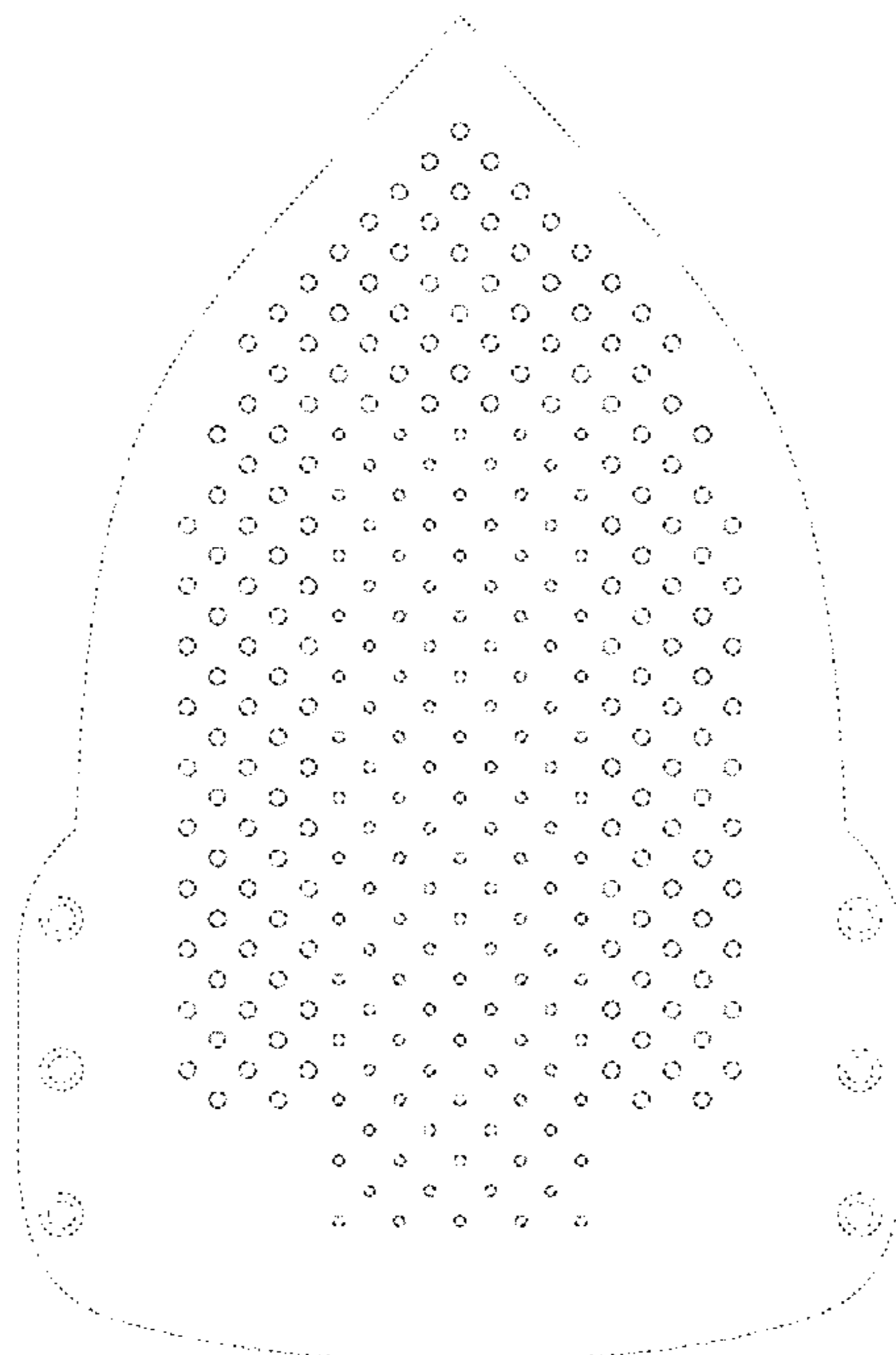

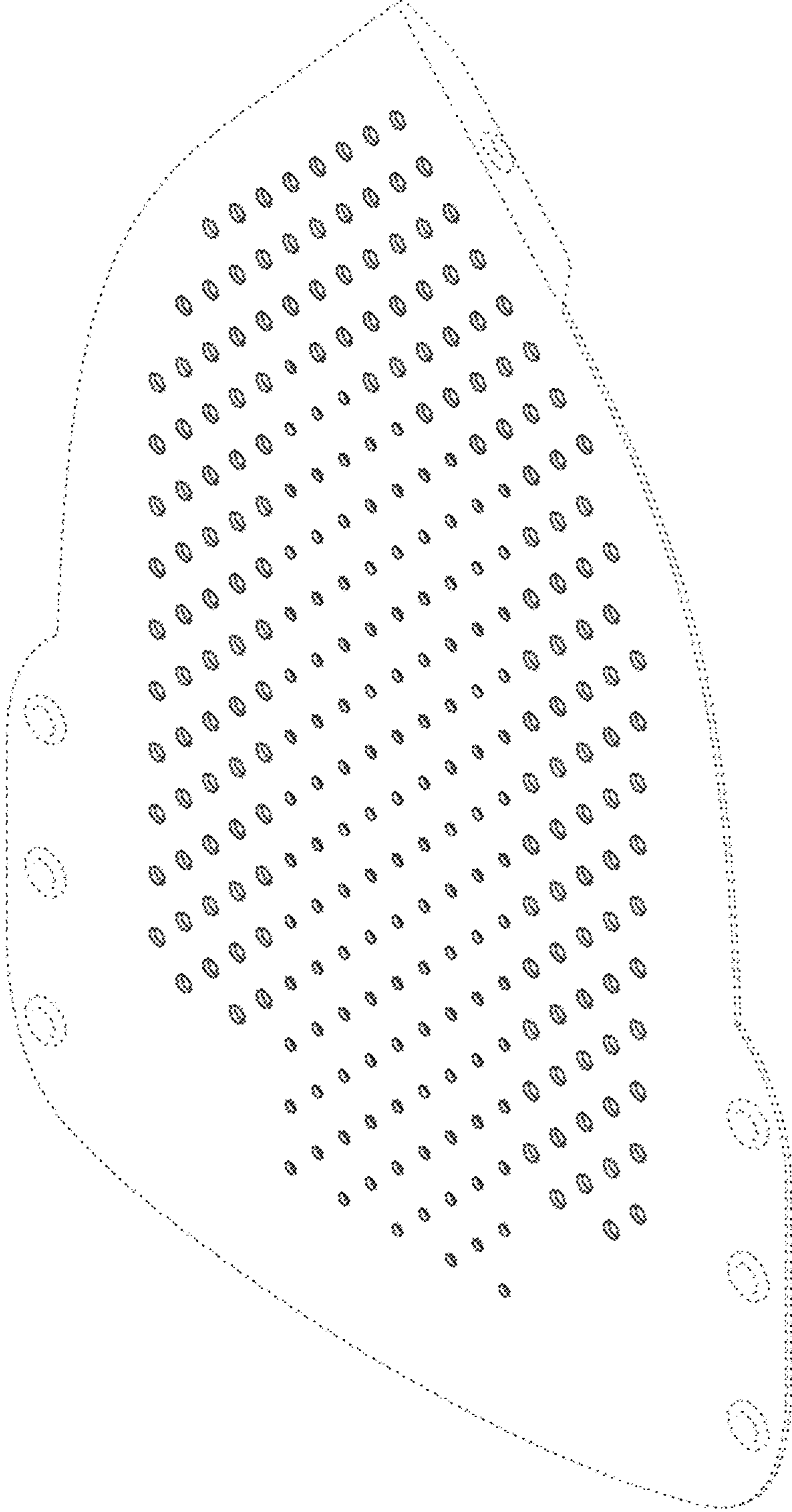

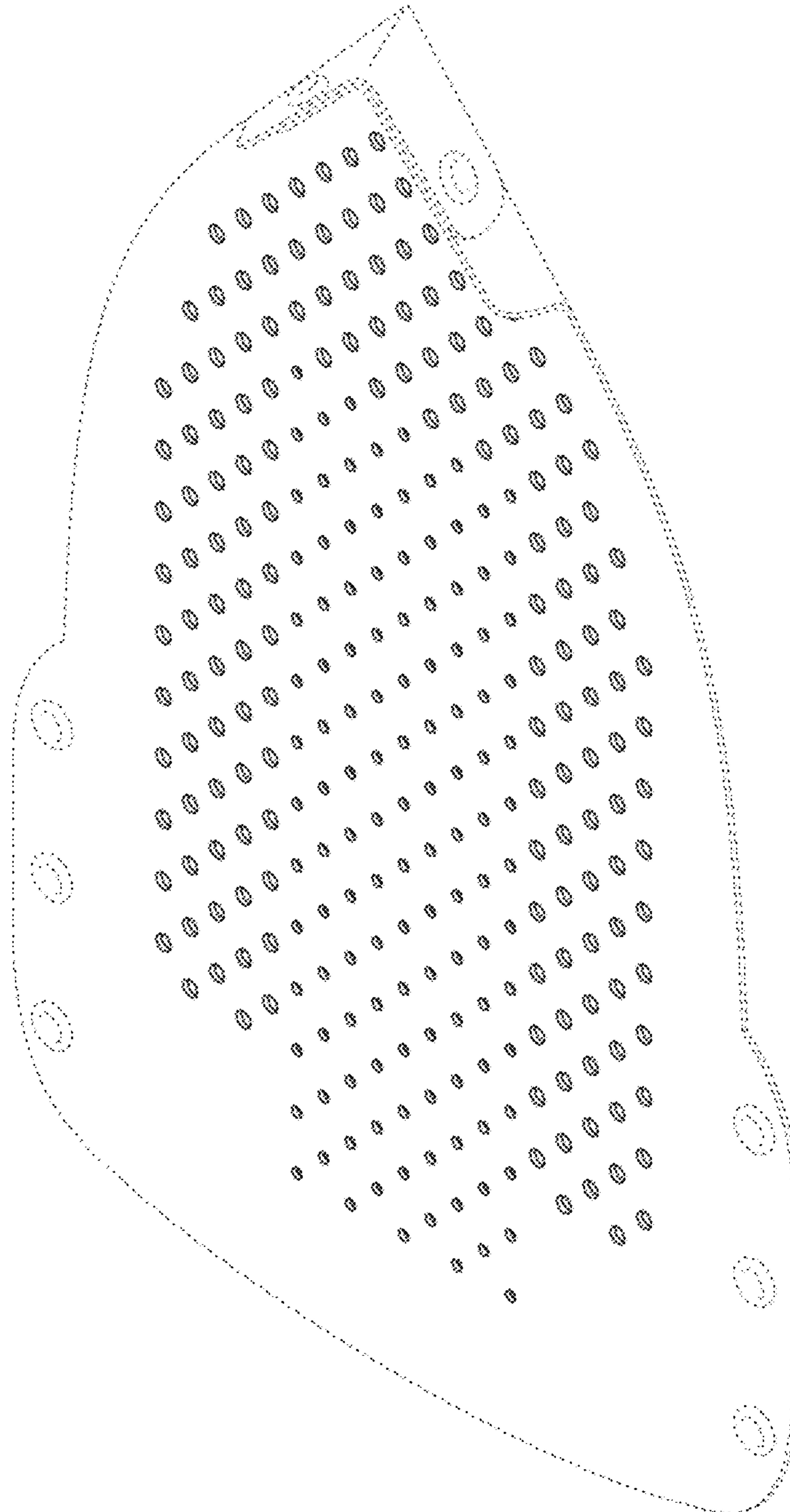

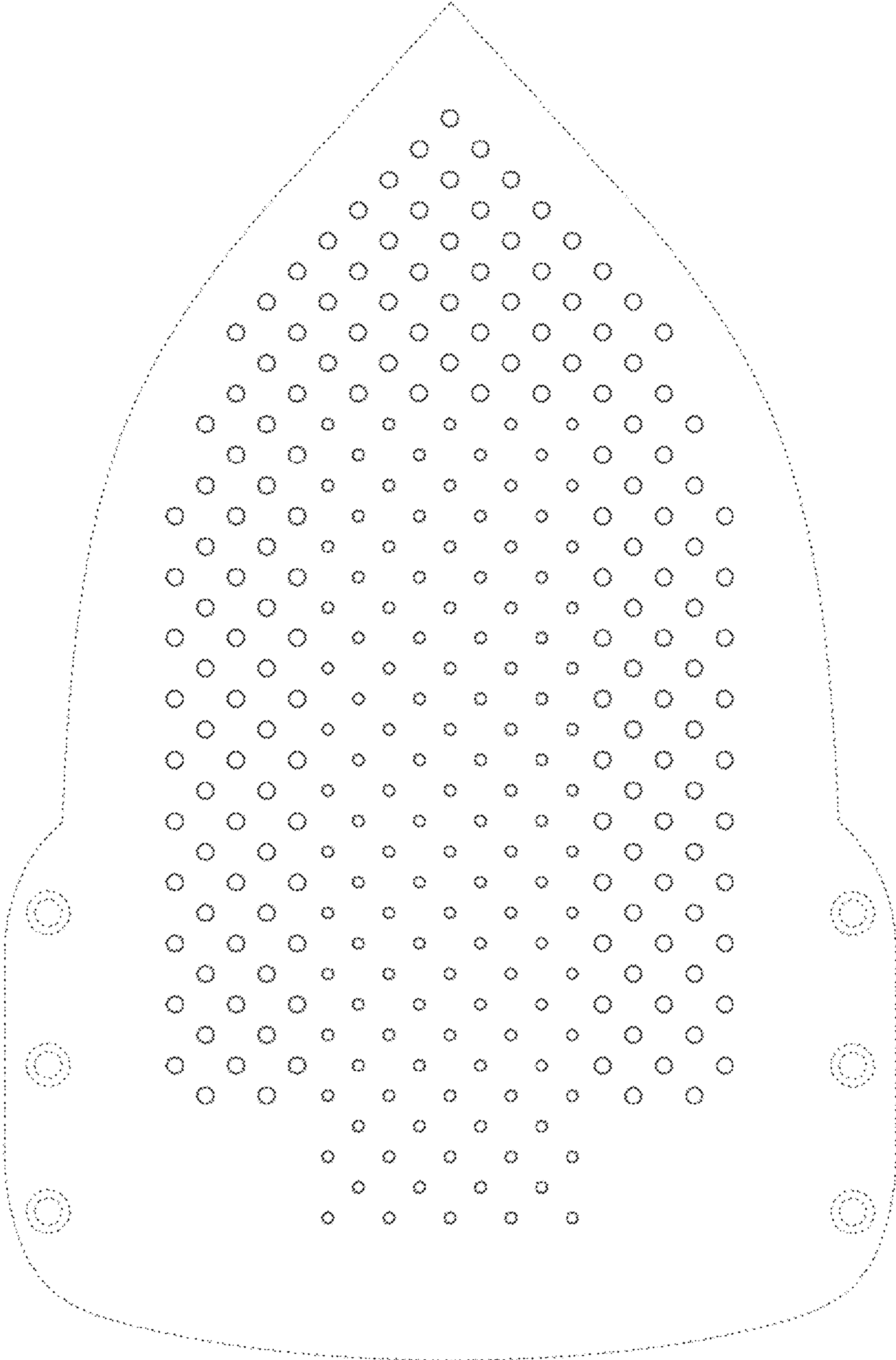
