(57) **CLAIM**

We claim the ornamental design for the segmented pastry product, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the segmented pastry product of our new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a side elevation view thereof, showing the side visible in FIG. 1;
FIG. 5 is a side elevation view thereof, opposite from the side shown in FIG. 4;
FIG. 6 is an end elevation view thereof, showing the end opposite the end visible in FIG. 1; and,
FIG. 7 is an end elevation view thereof, showing the end visible in FIG. 1.

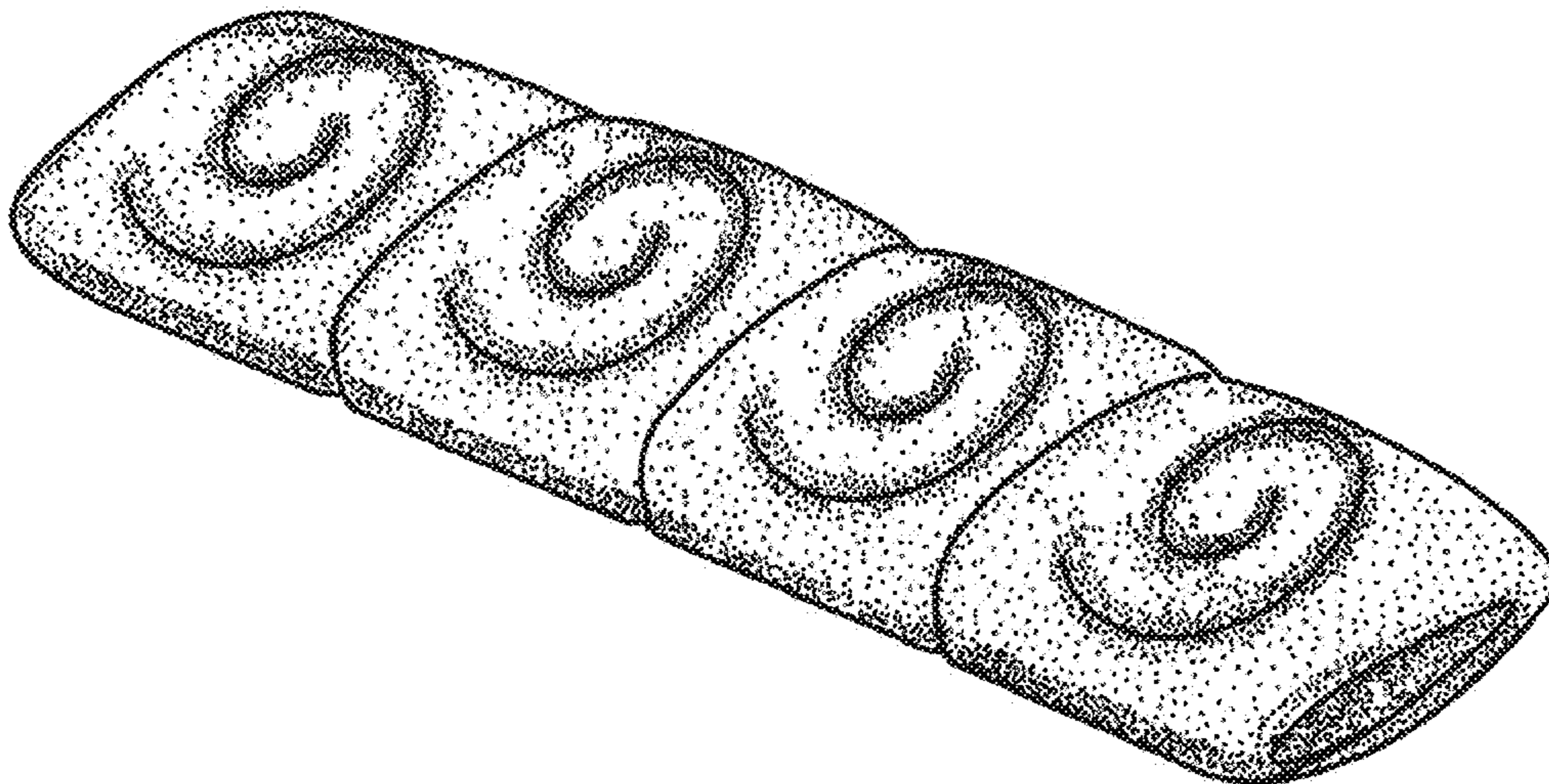

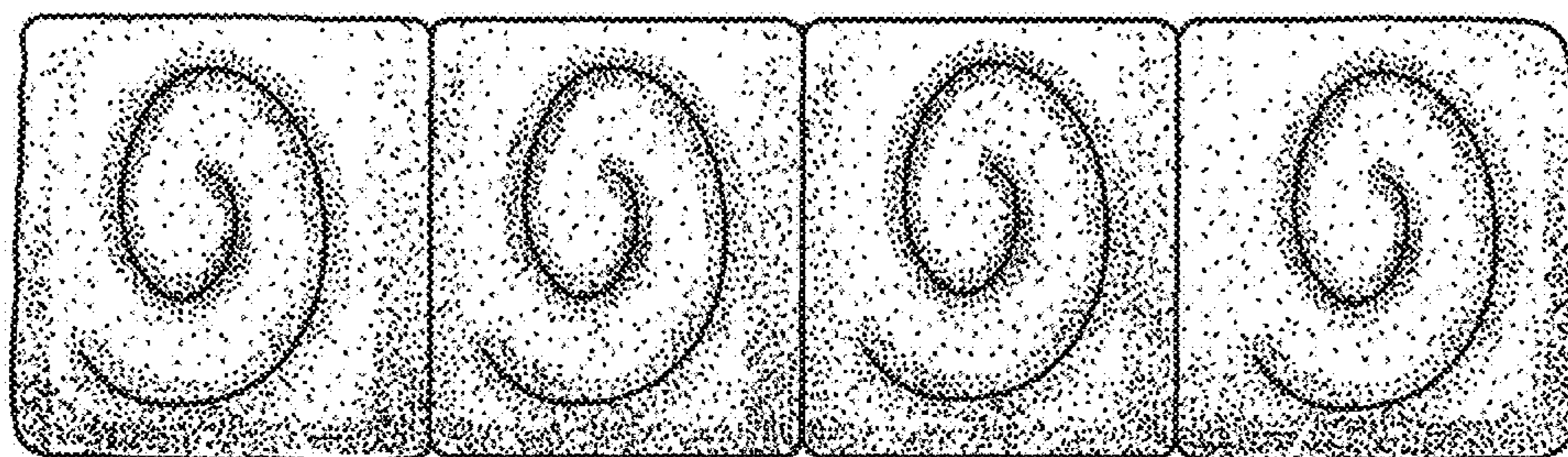
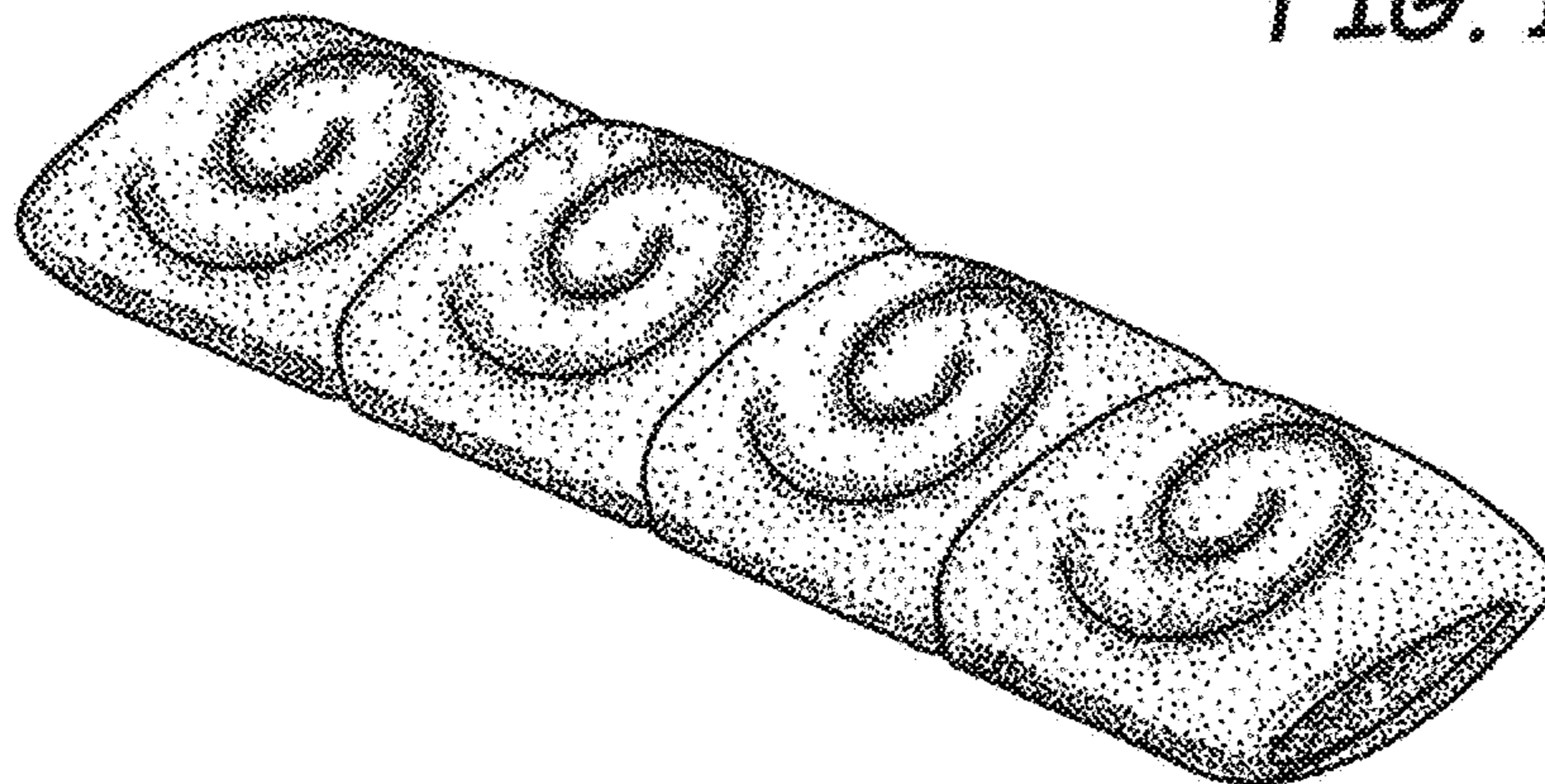

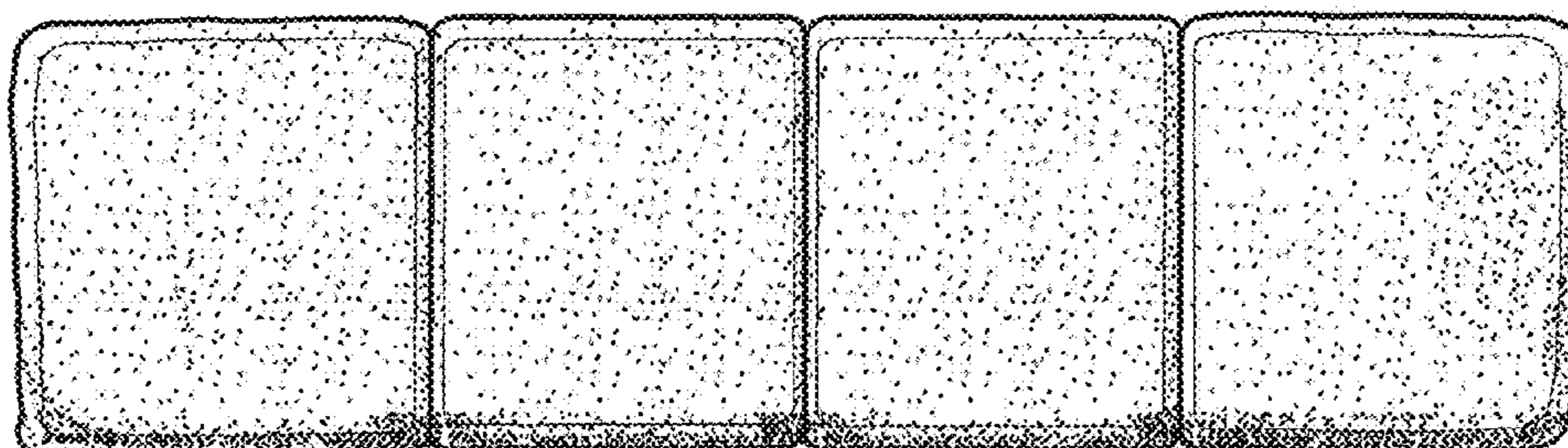

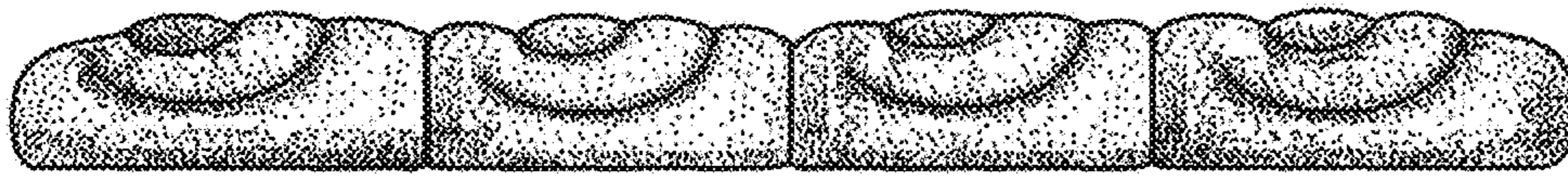

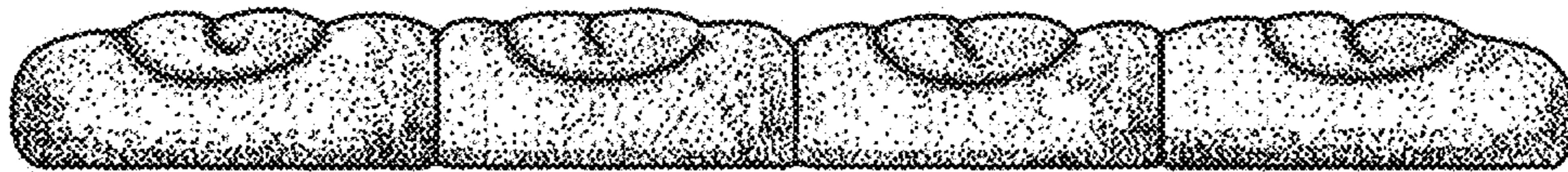

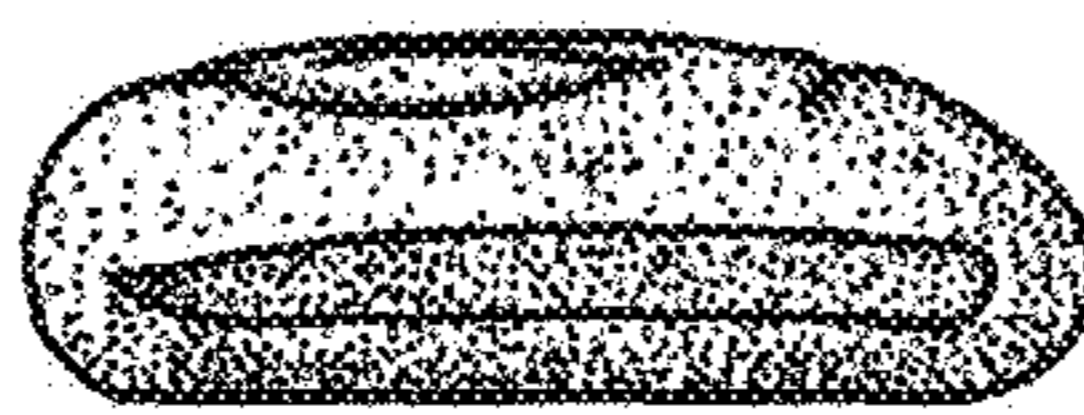
