The ornamental design for a cap, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the cap showing my design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is a rear perspective view thereof. The broken lines shown on the cap are lines of stitching that form no part of the claimed design.

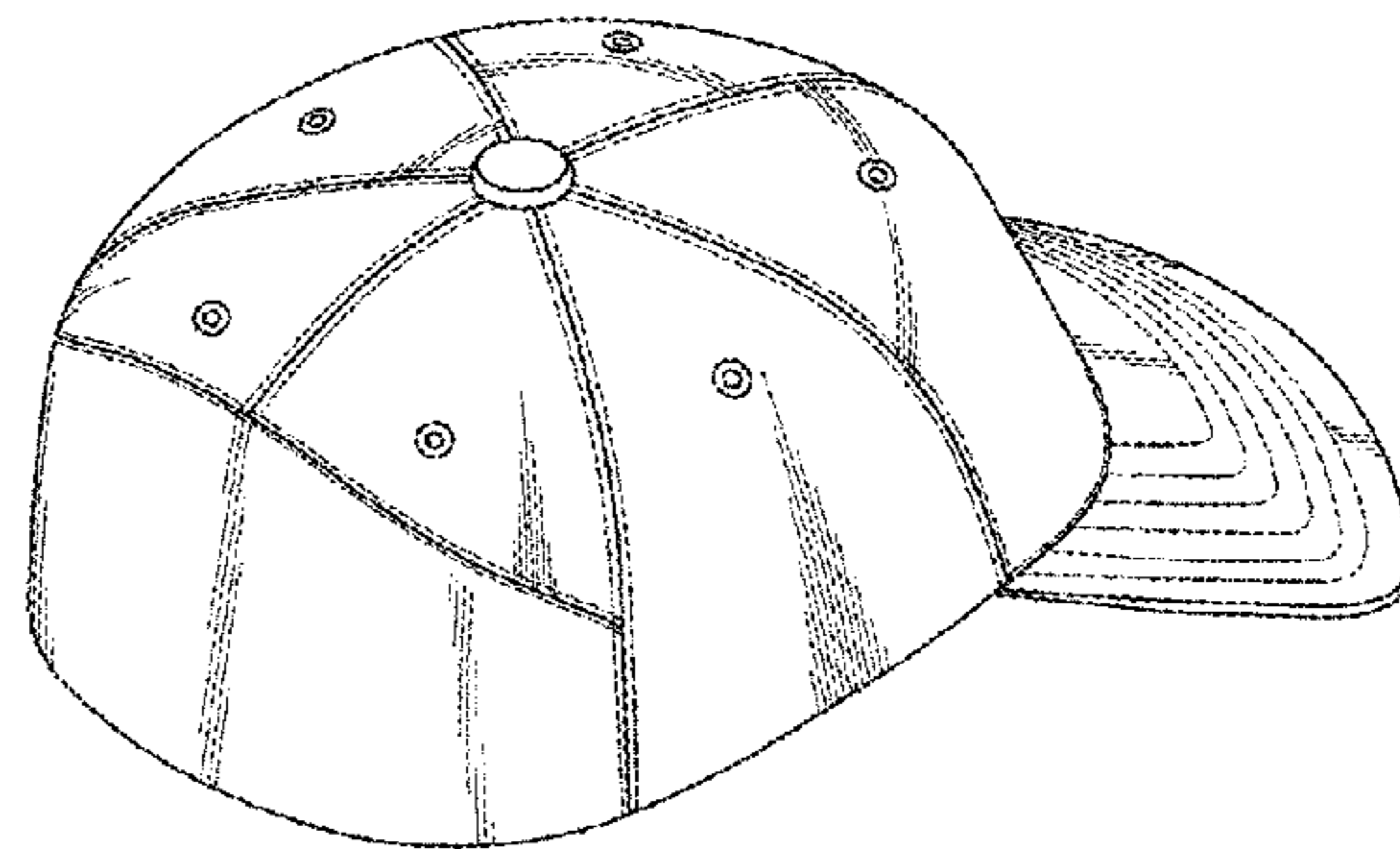
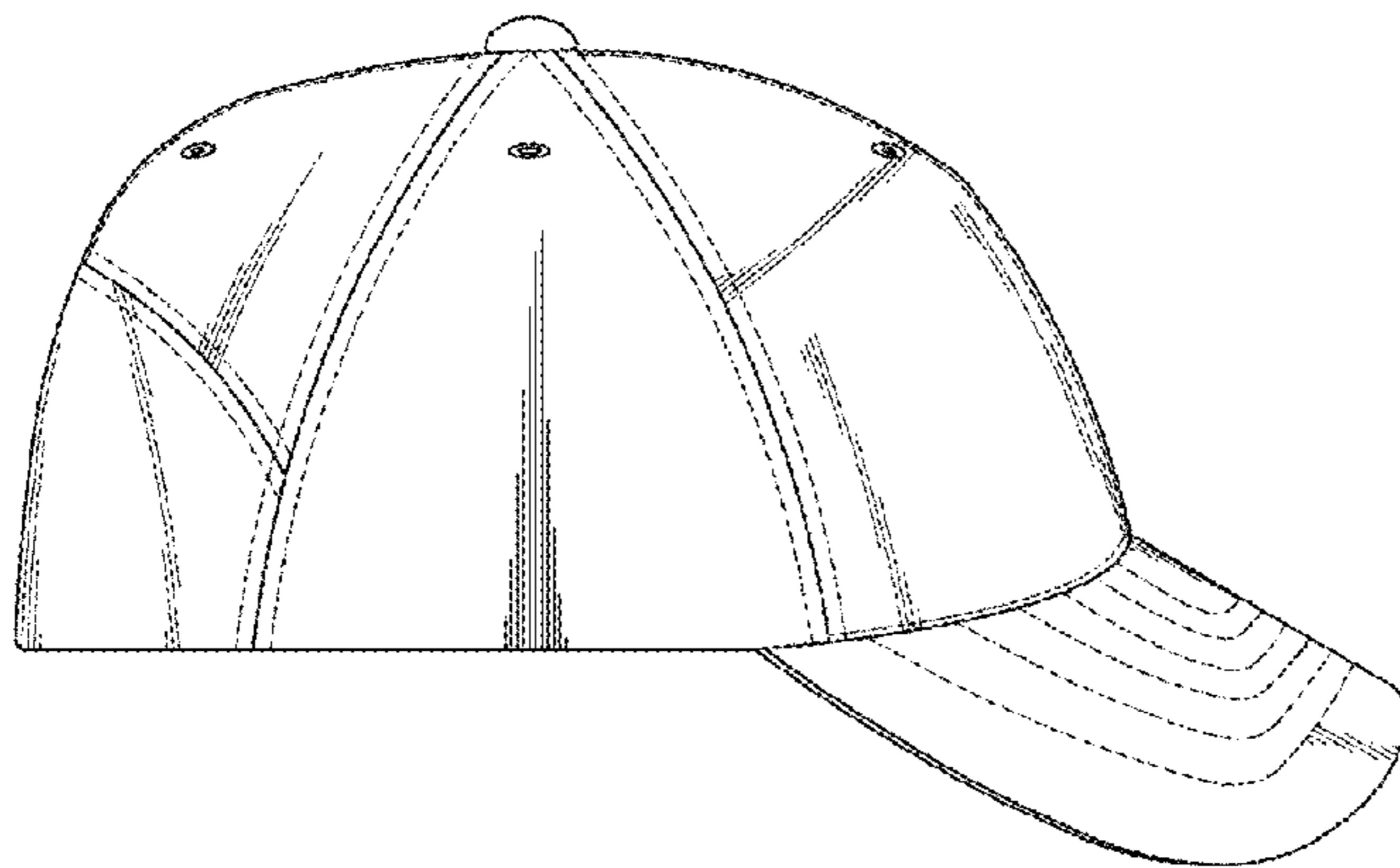

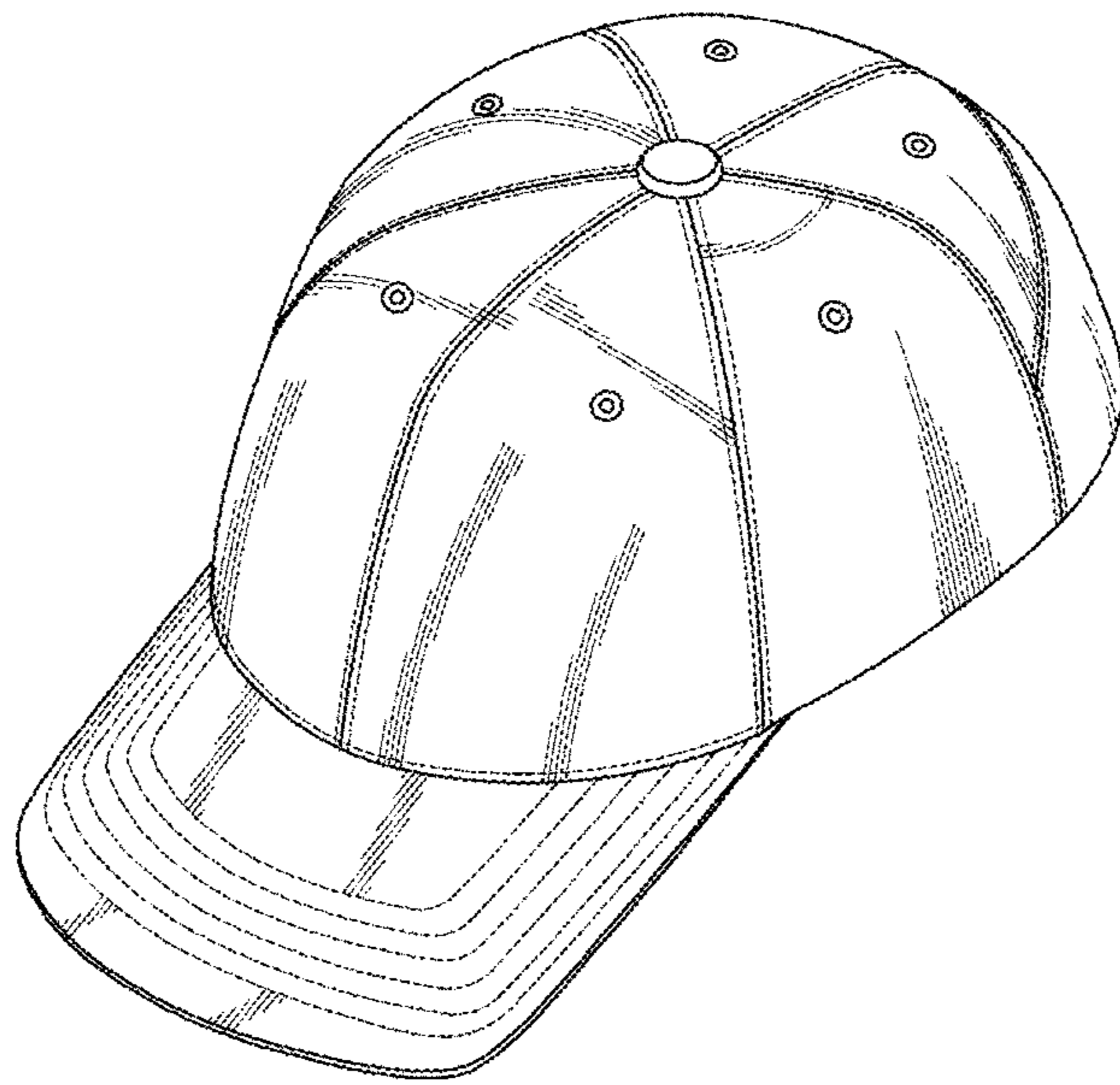

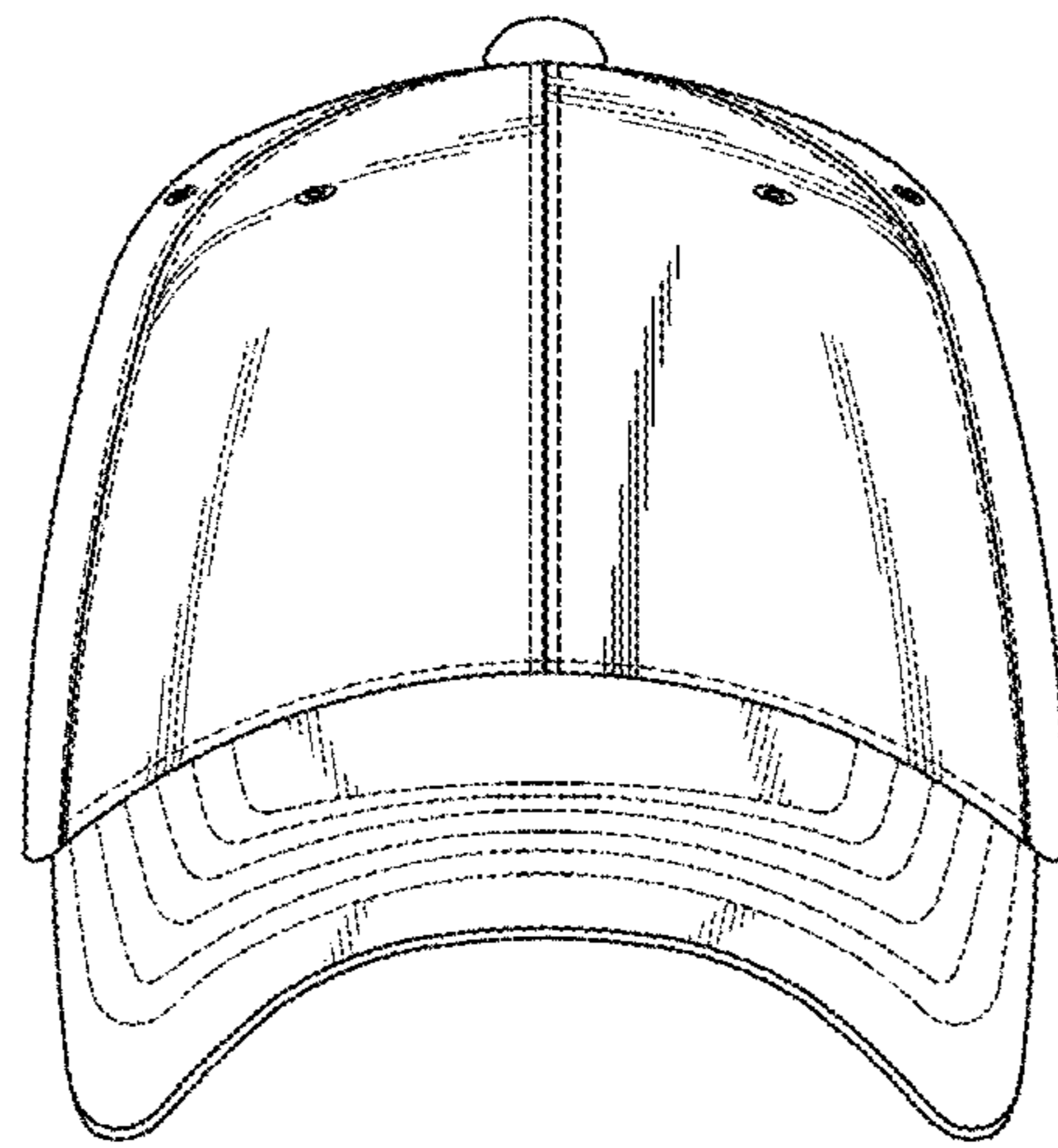

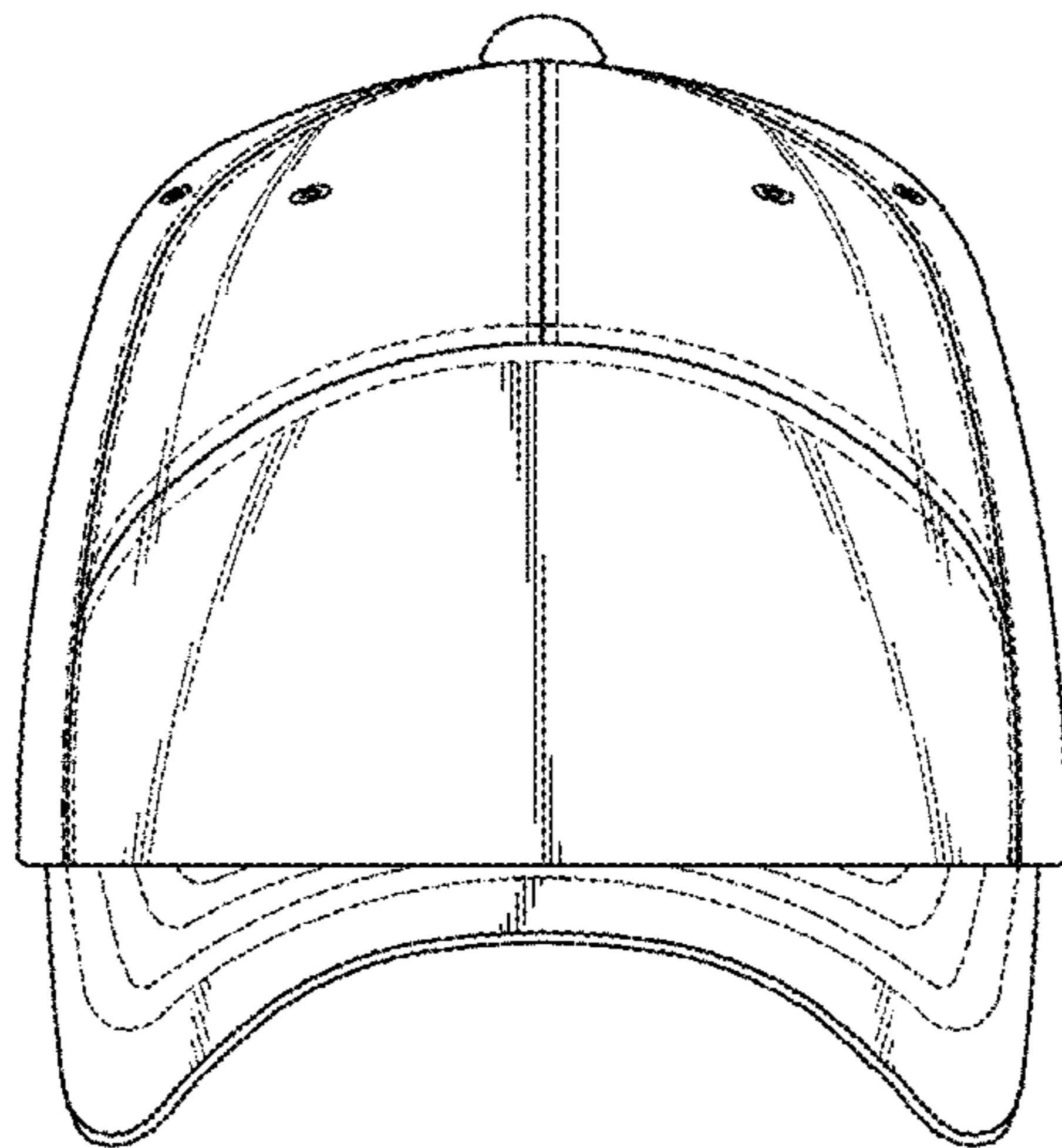

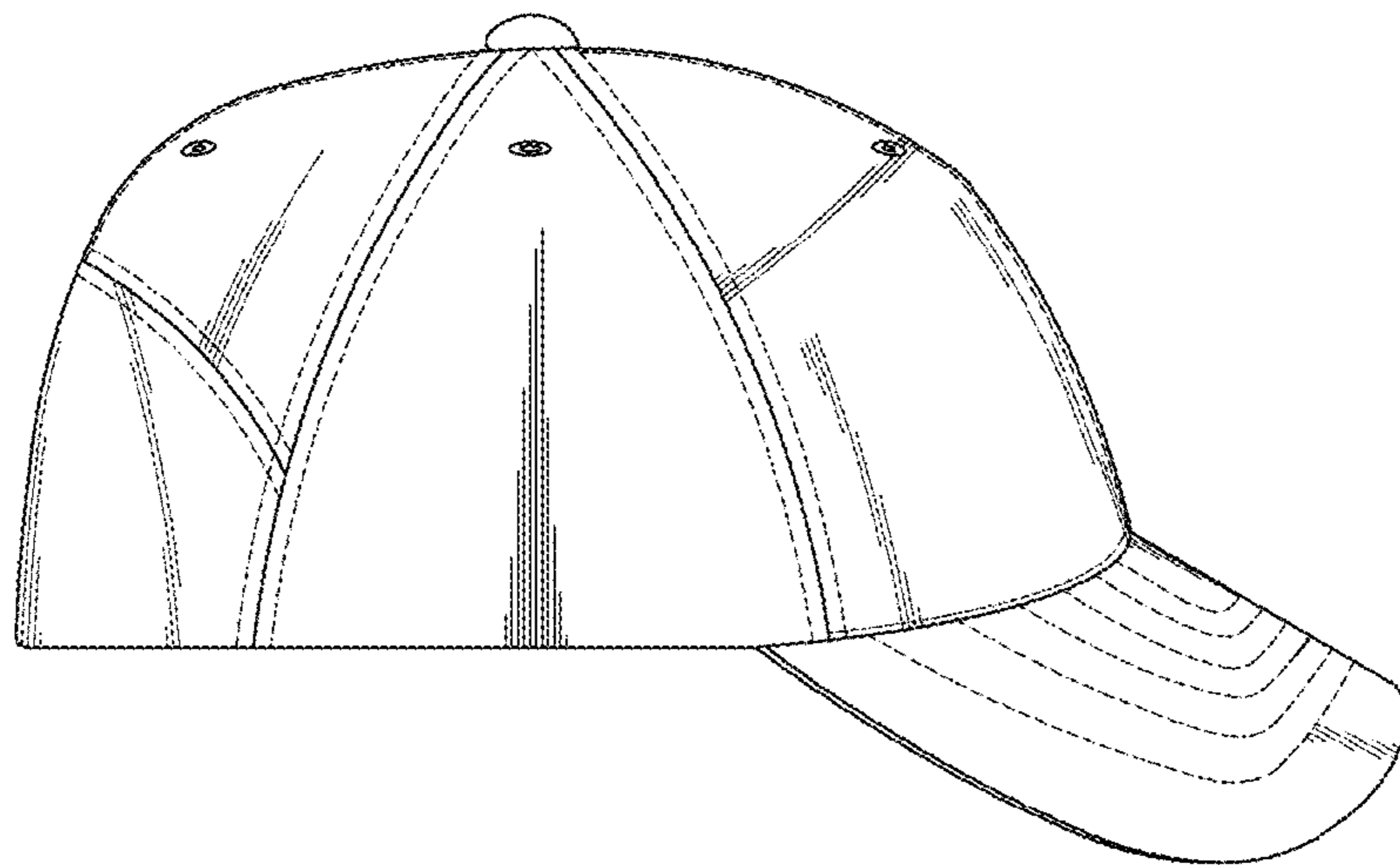

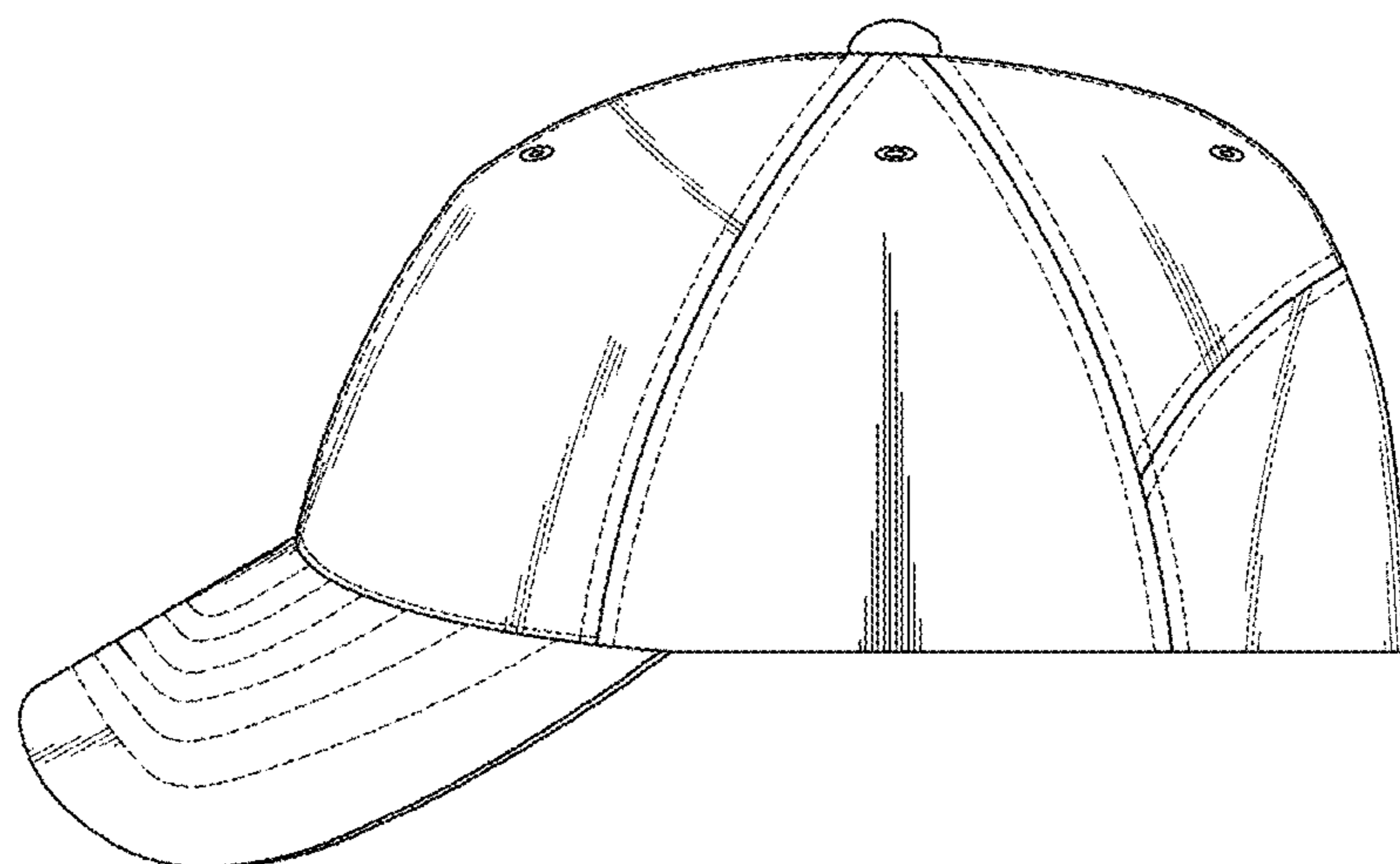

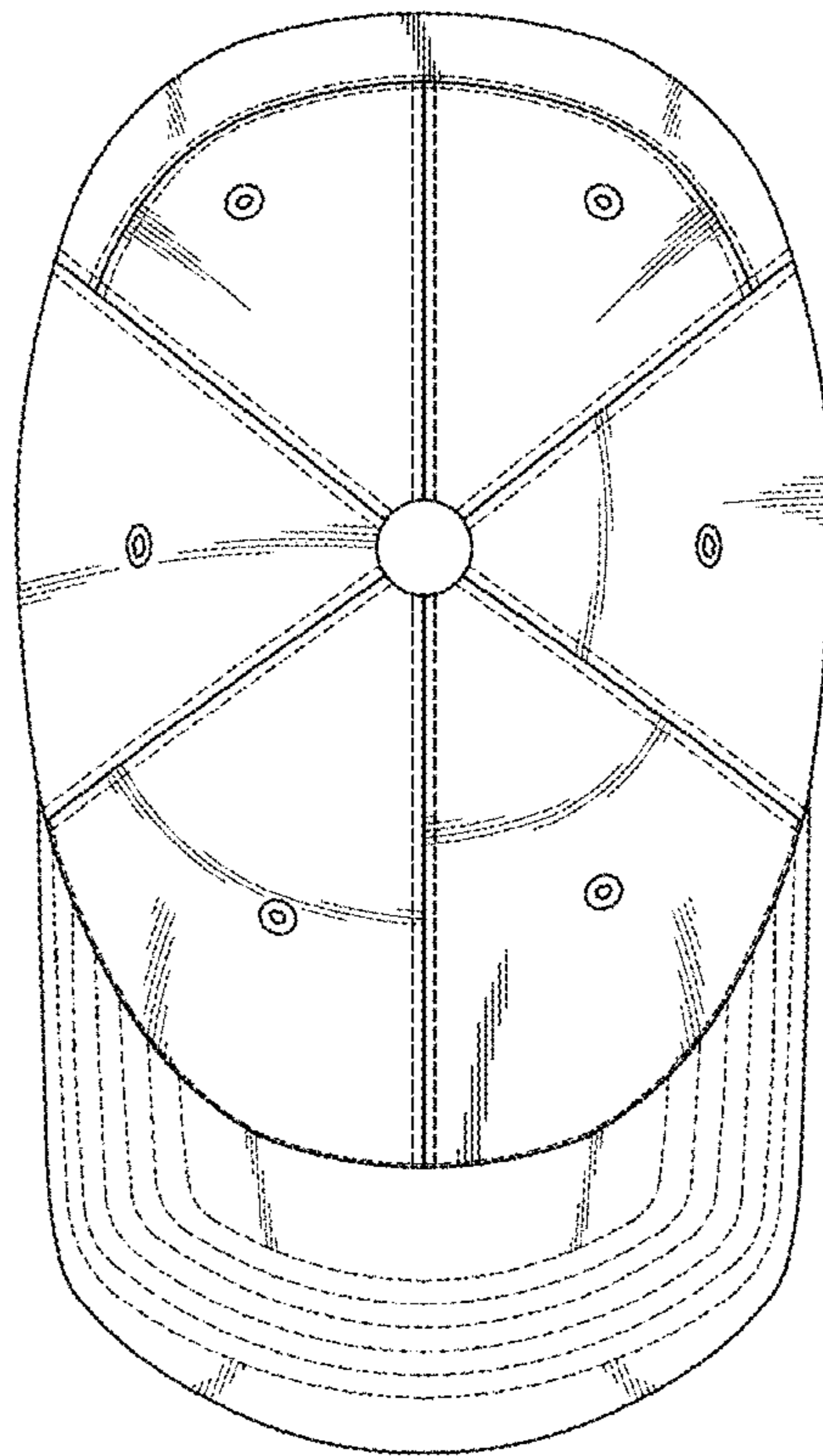

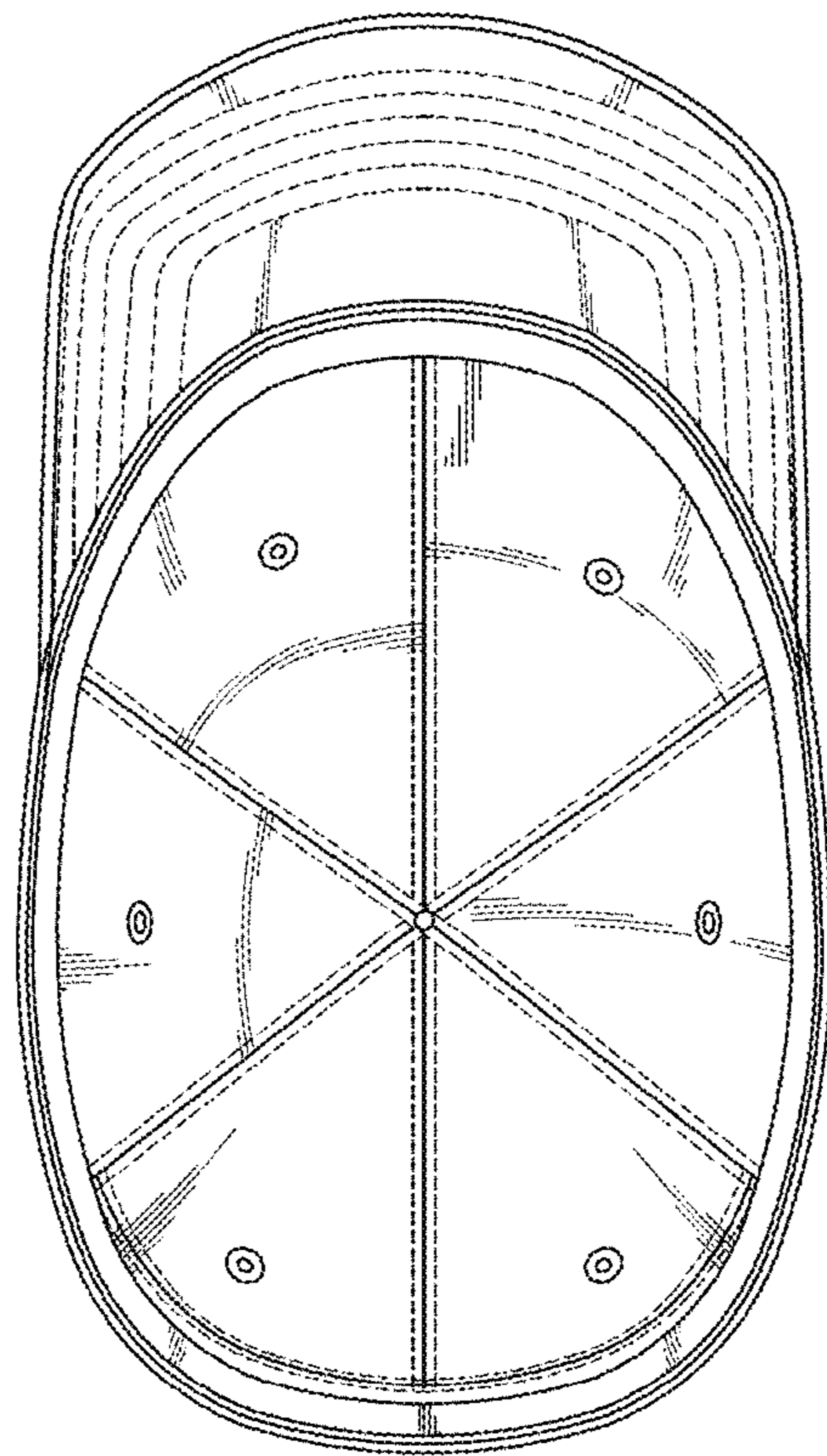
