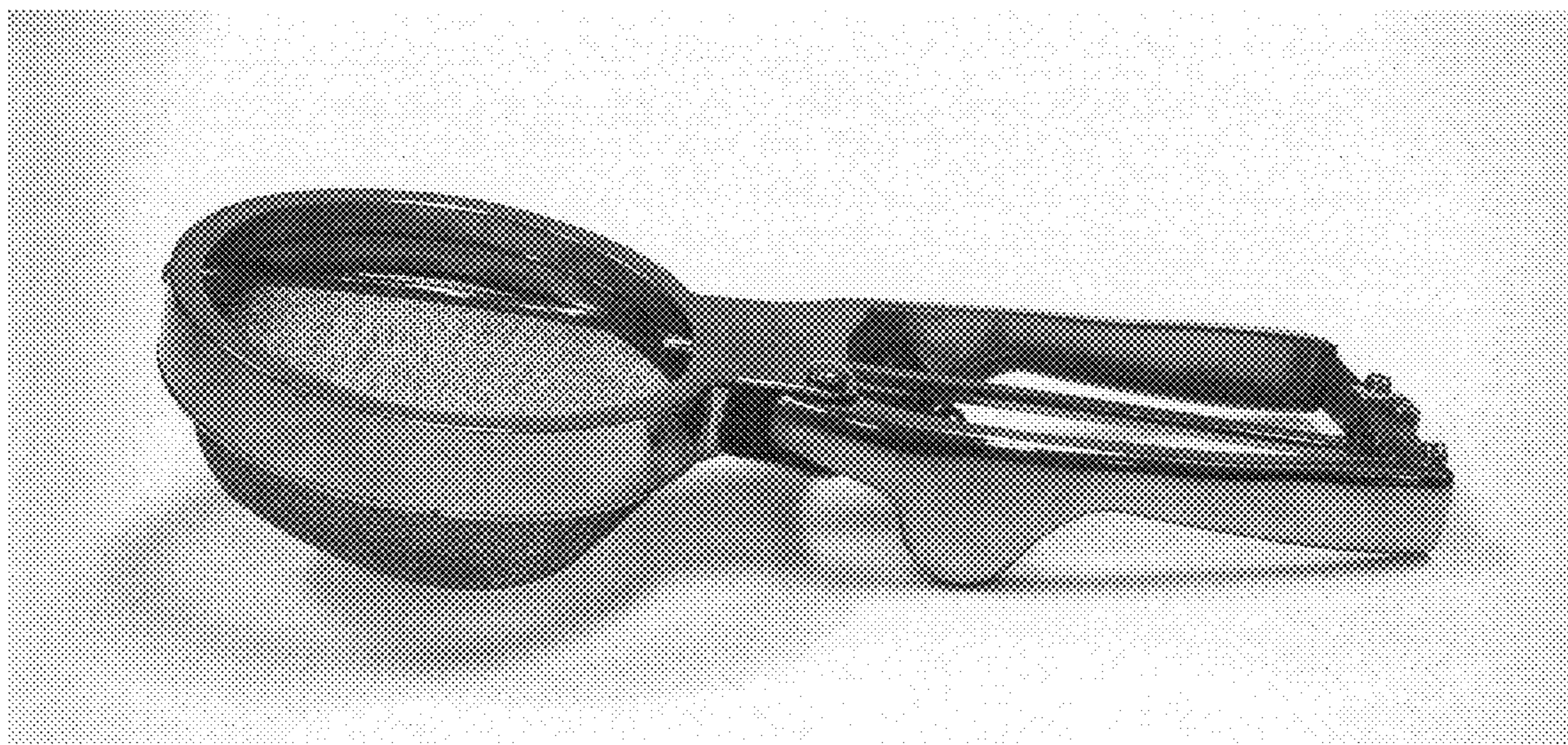
FIG. 1 is a view from the handle end of the bottom side of the duster embodiment of the invention.

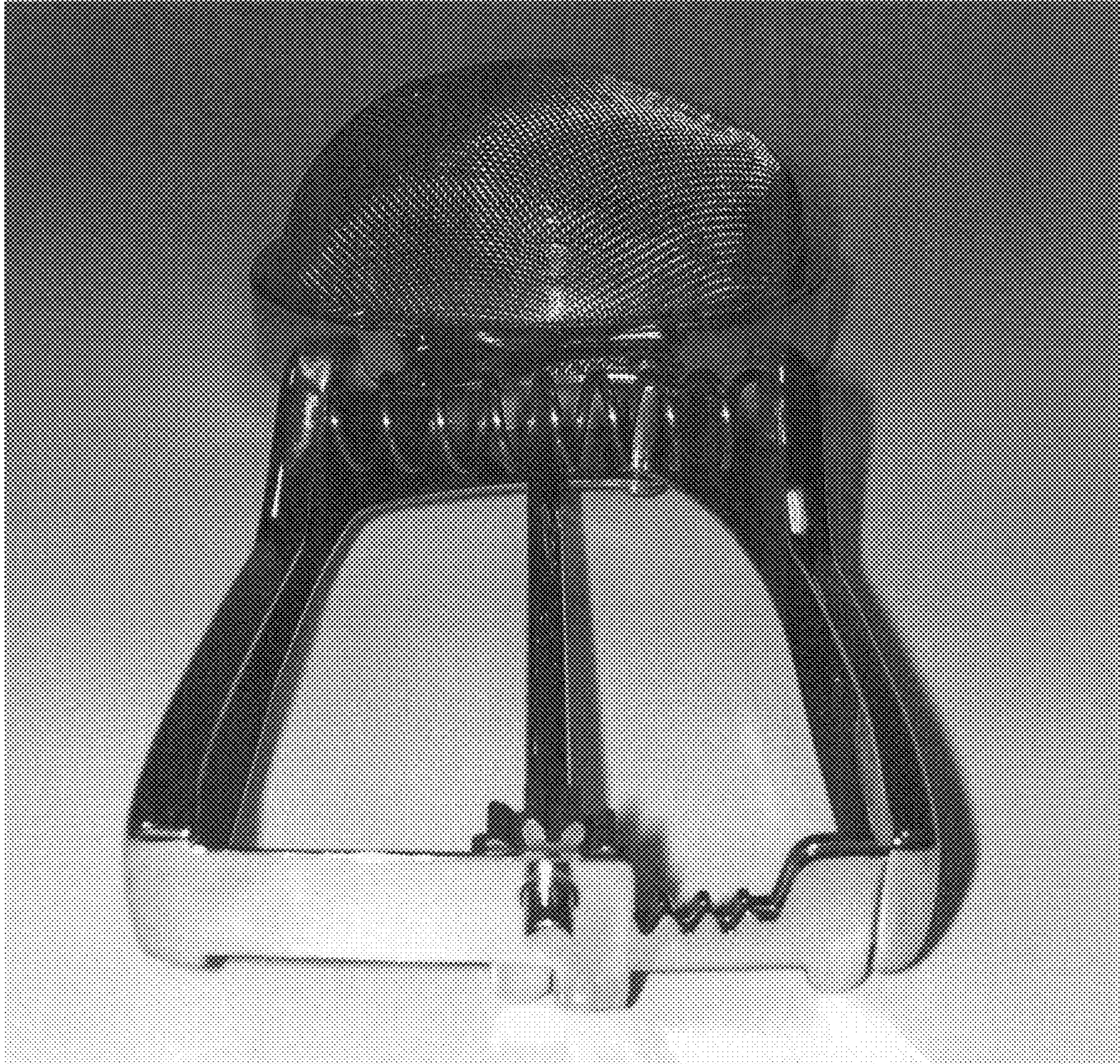

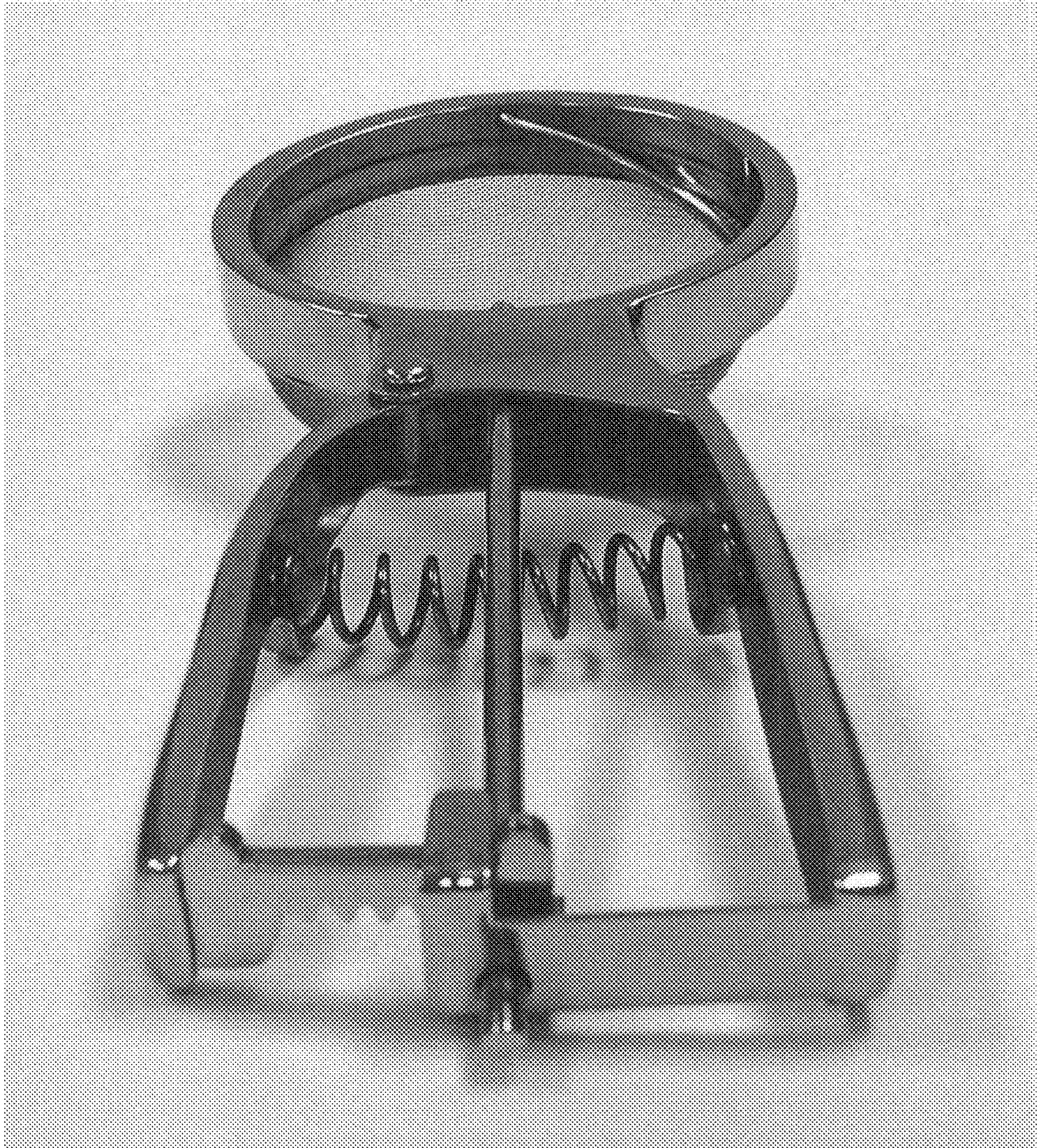

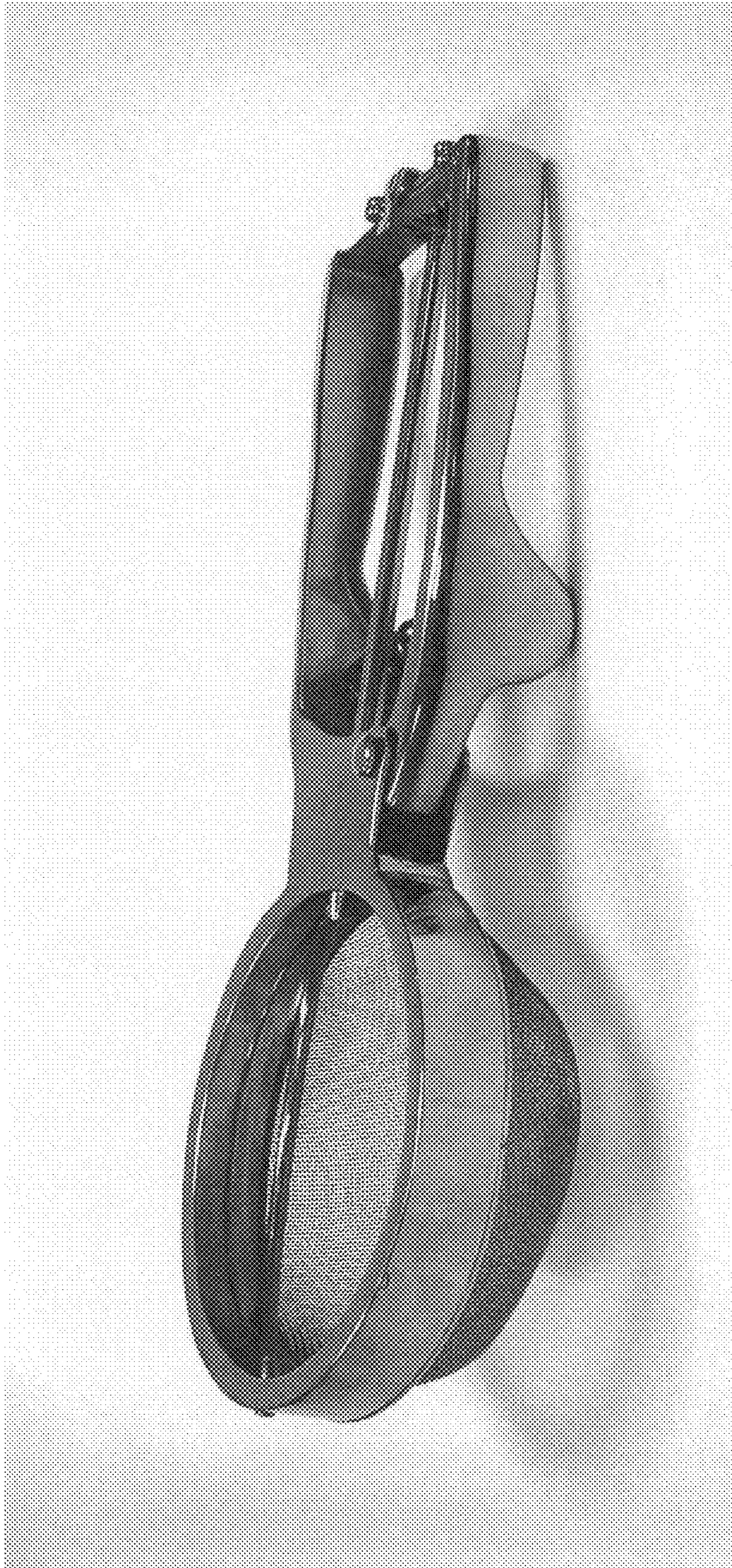

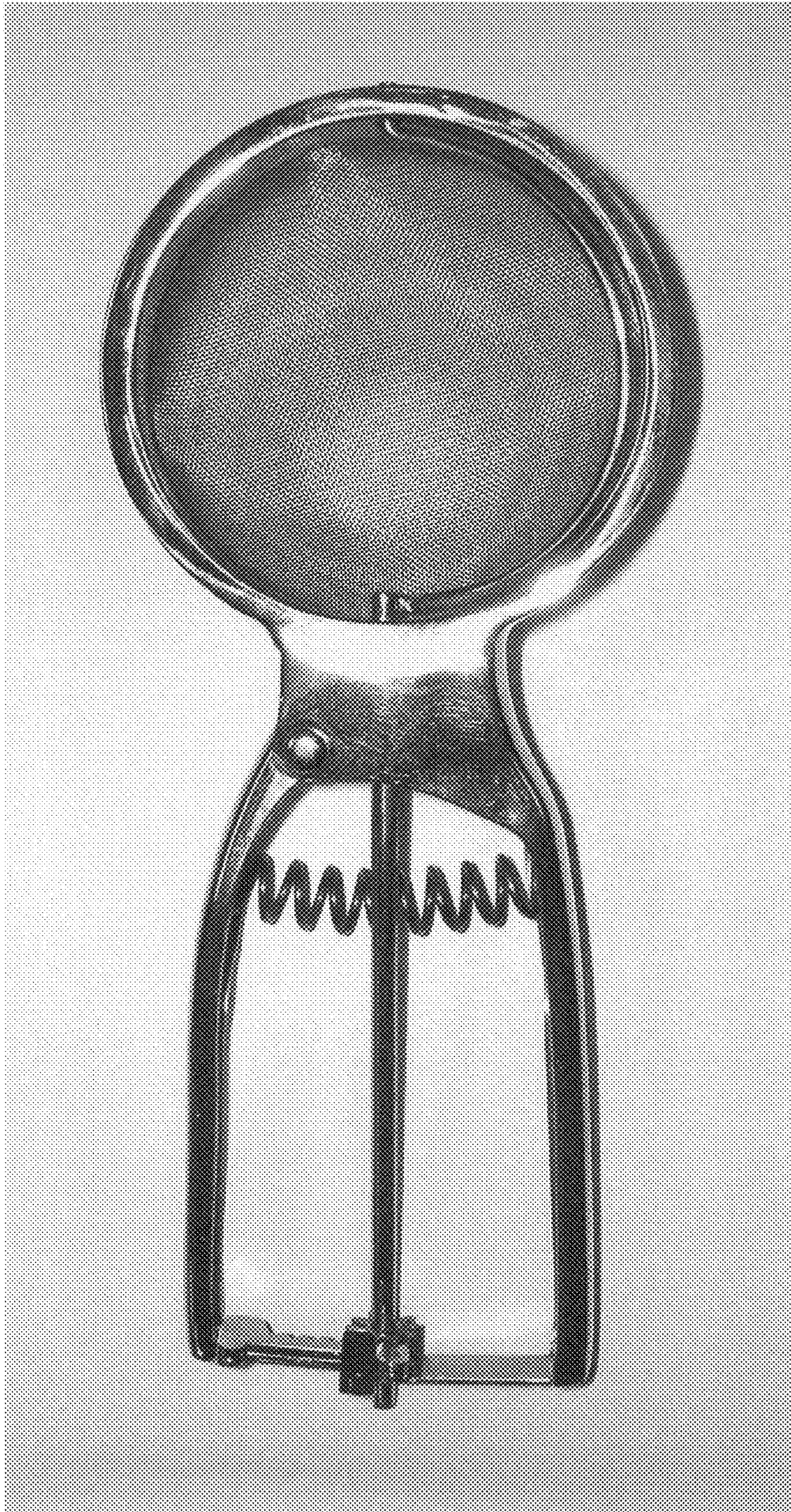
