(57) **CLAIM**

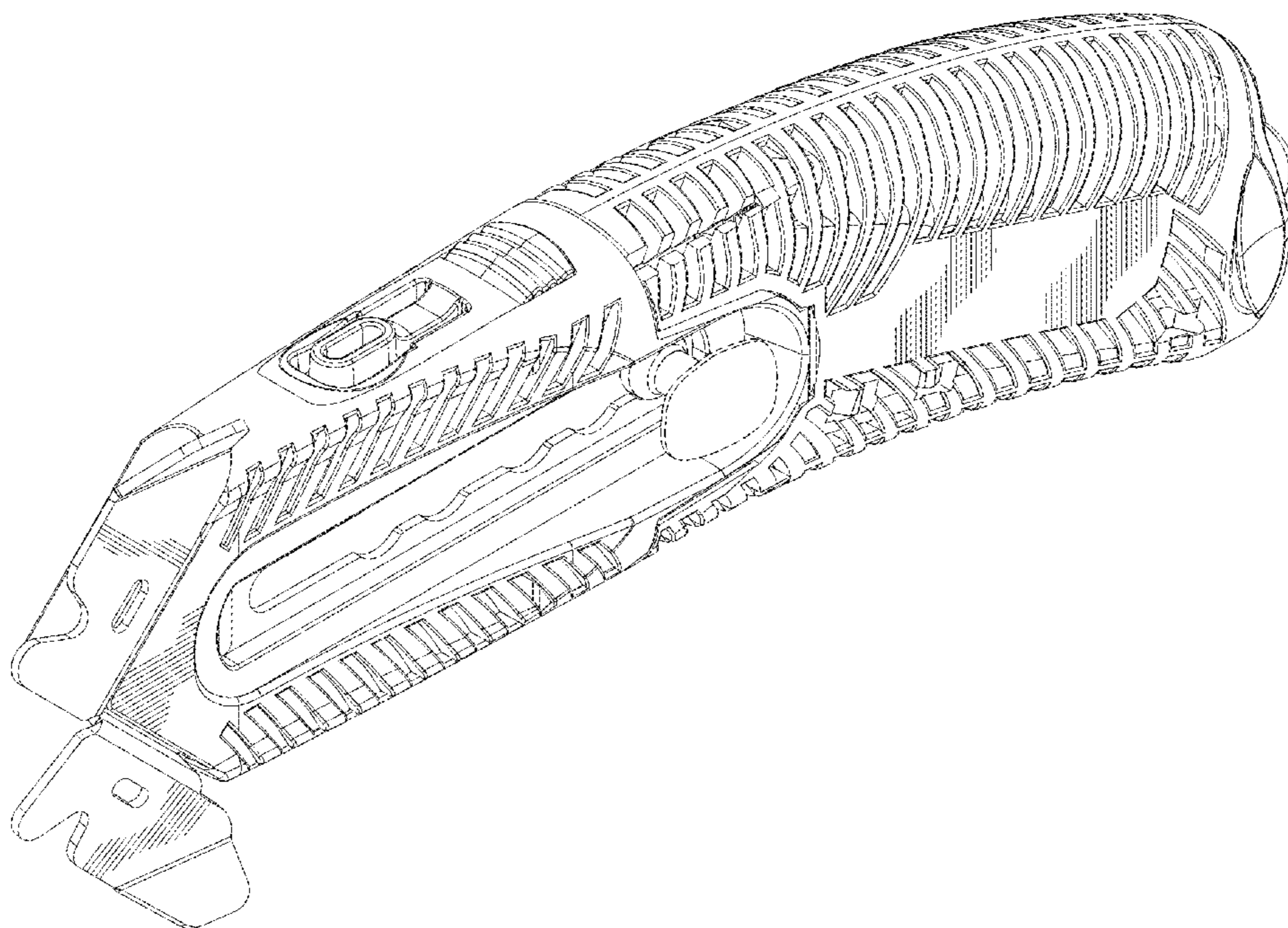
The ornamental design for a knife housing, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a knife housing showing our new design;

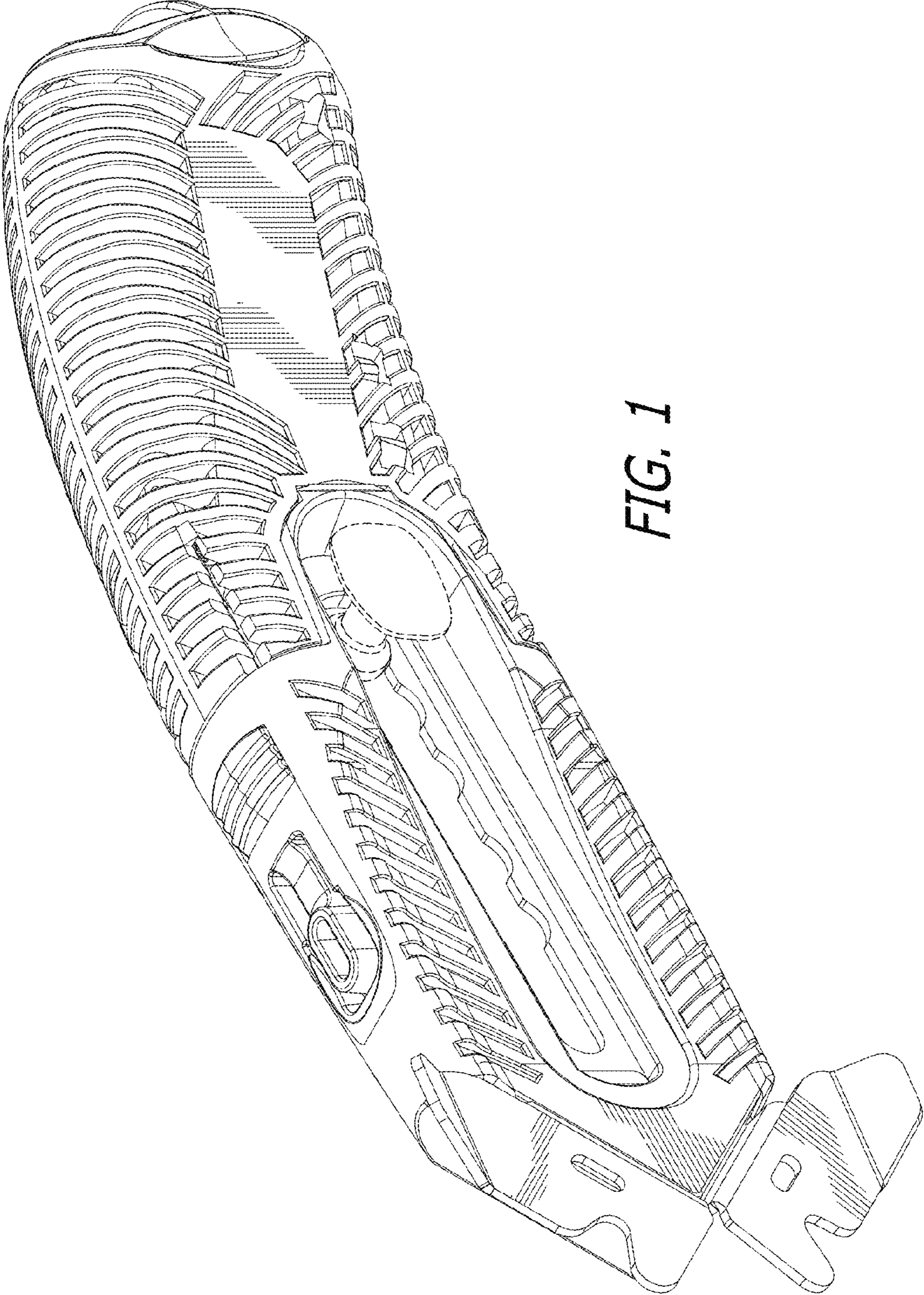

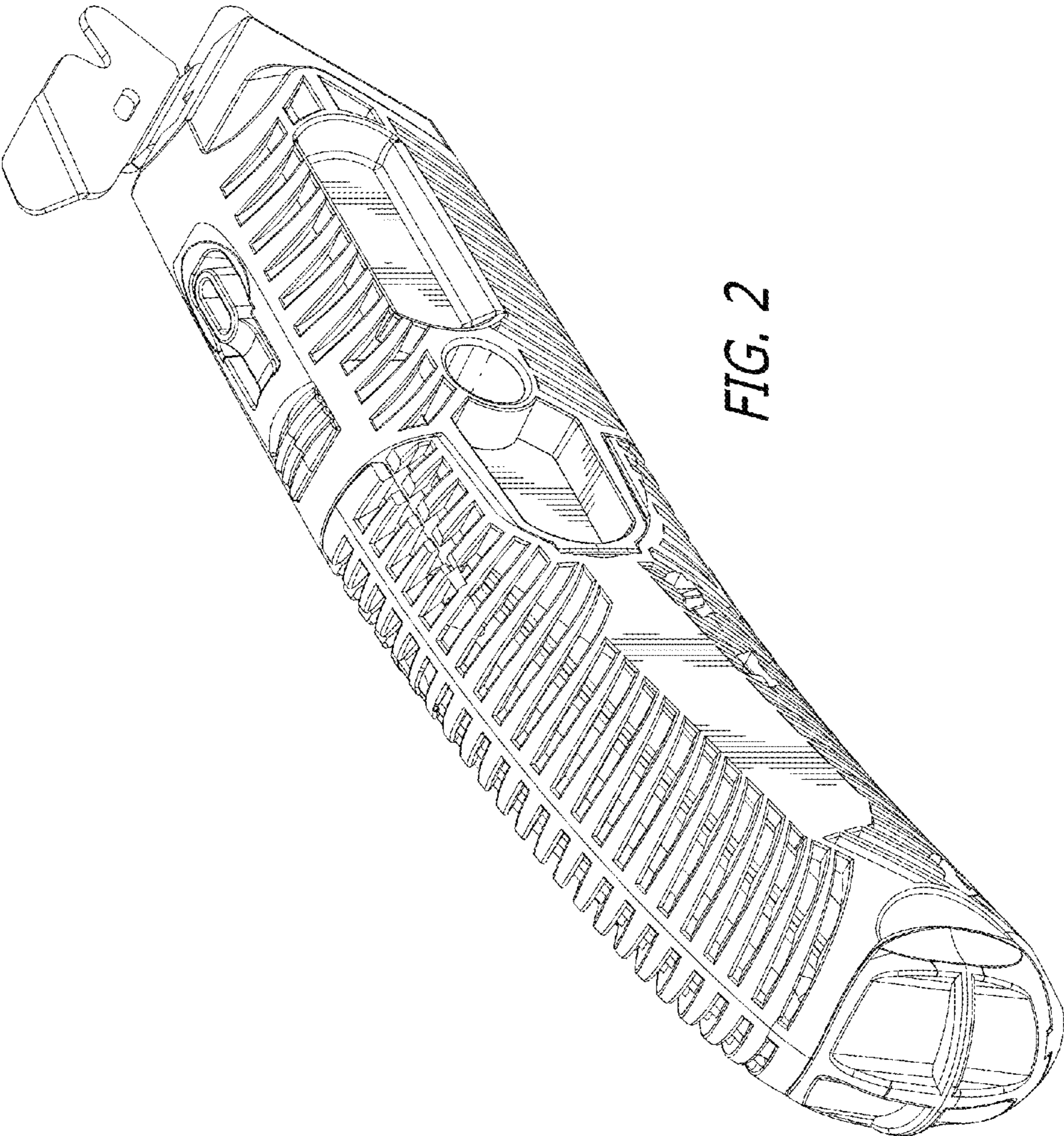

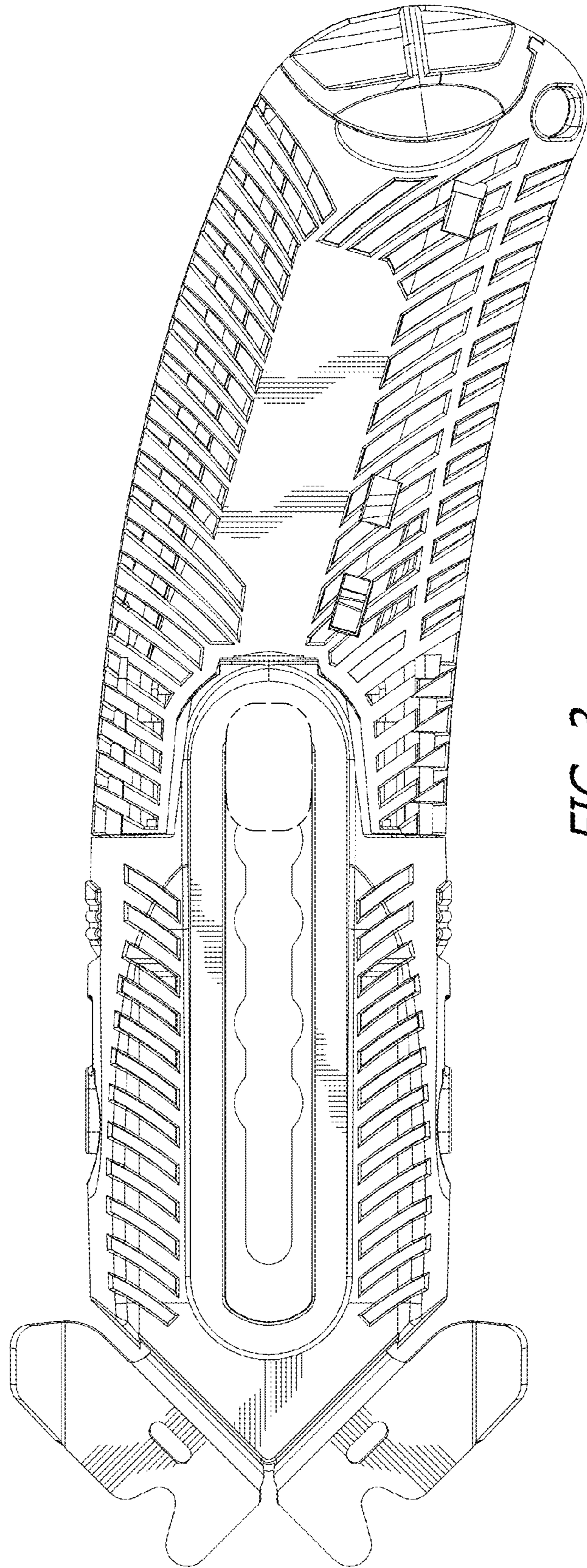

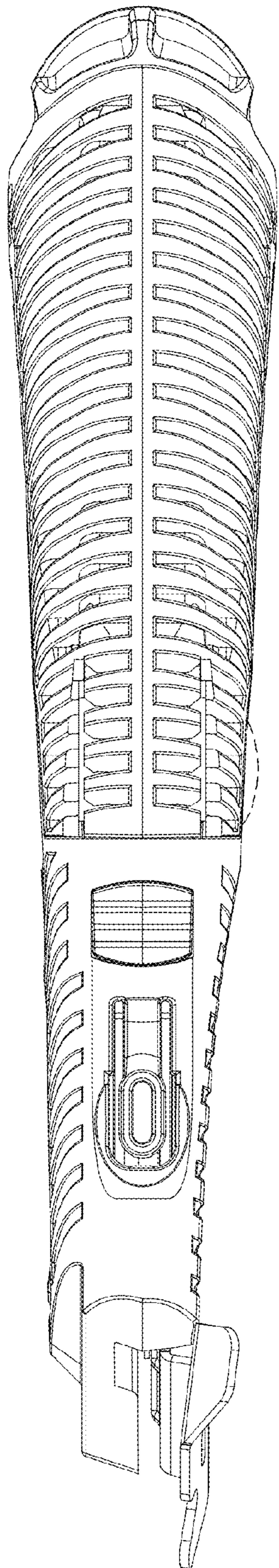

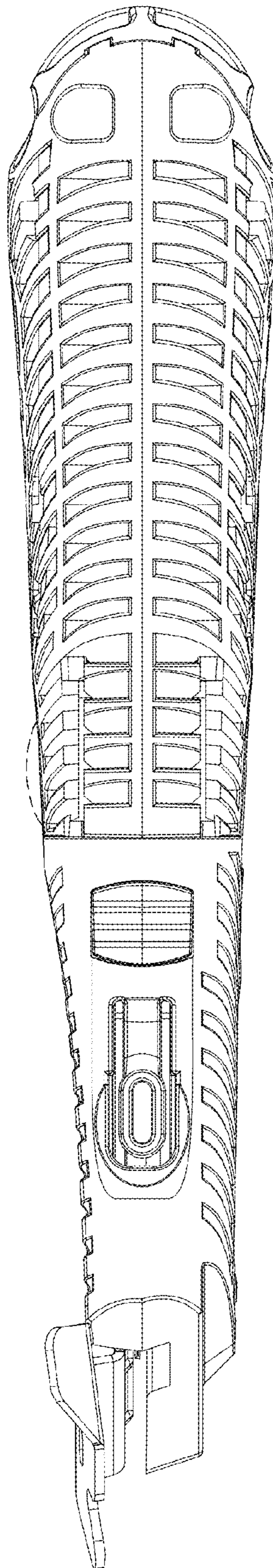

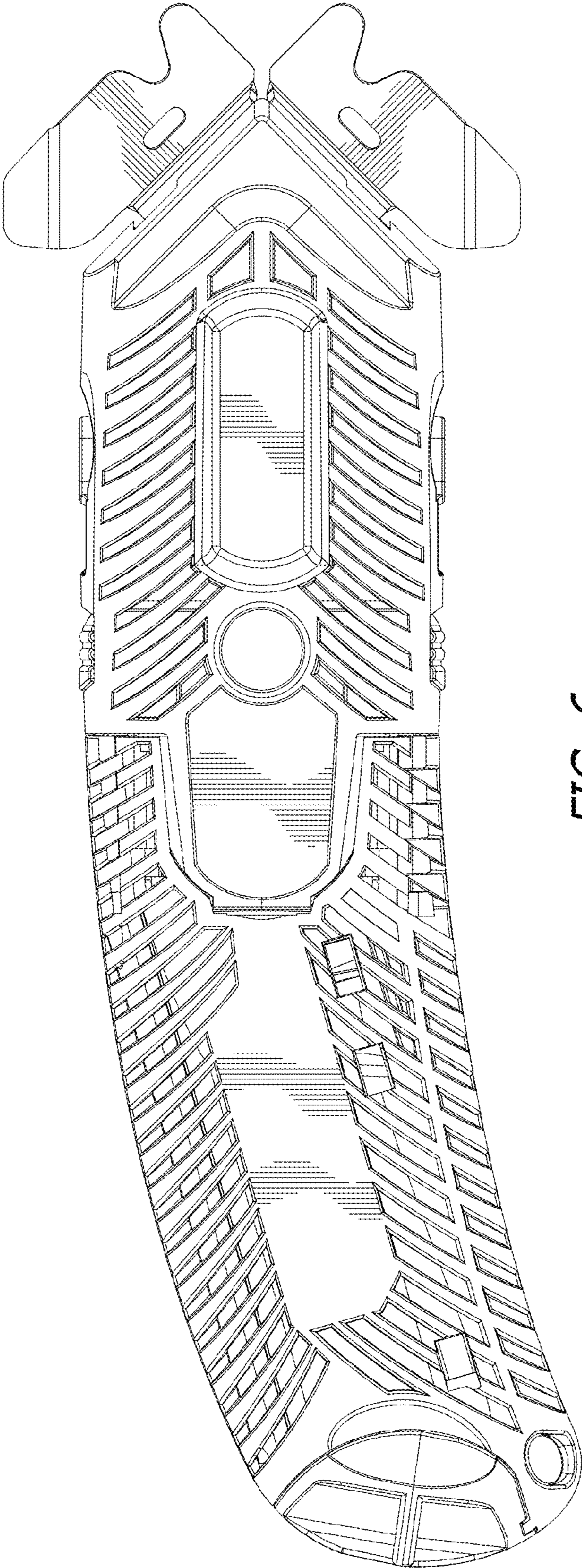

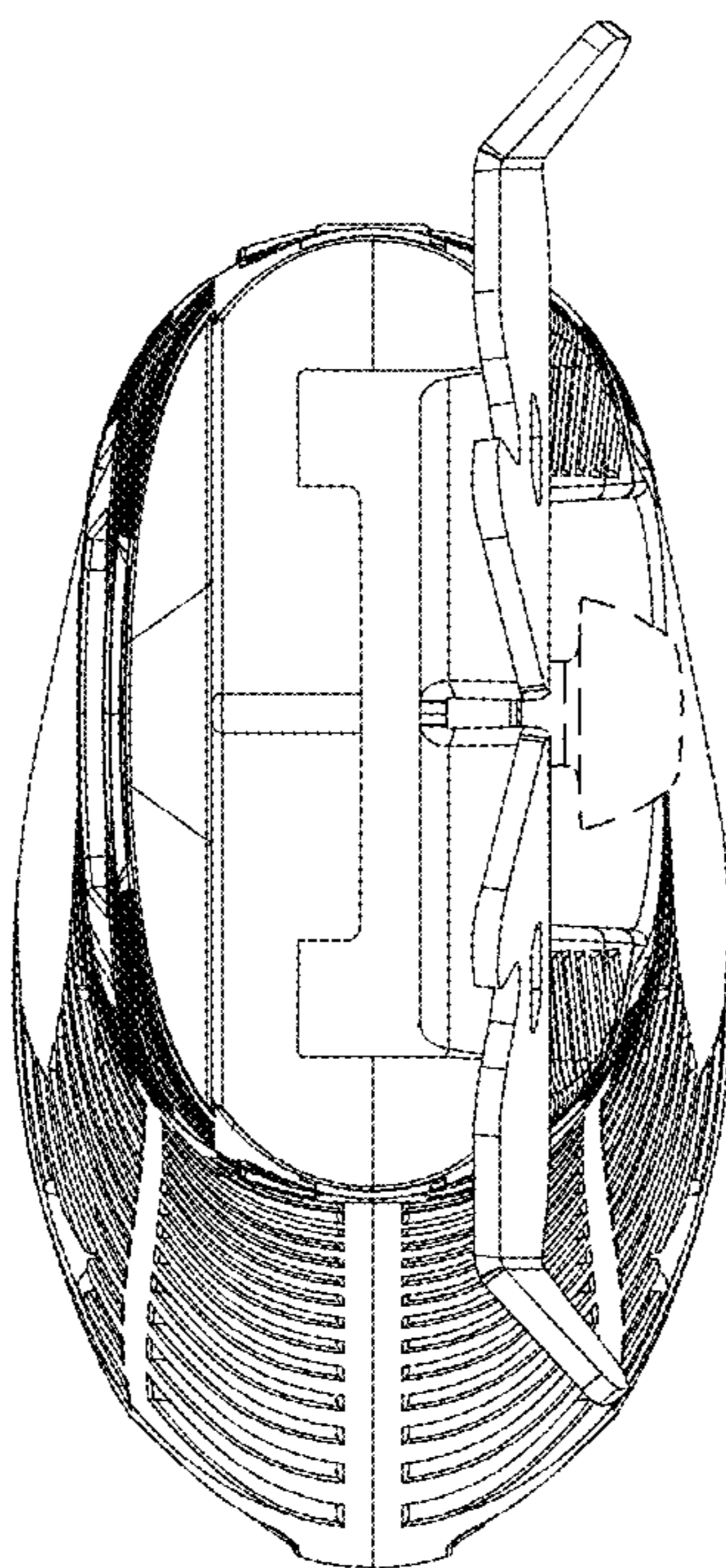

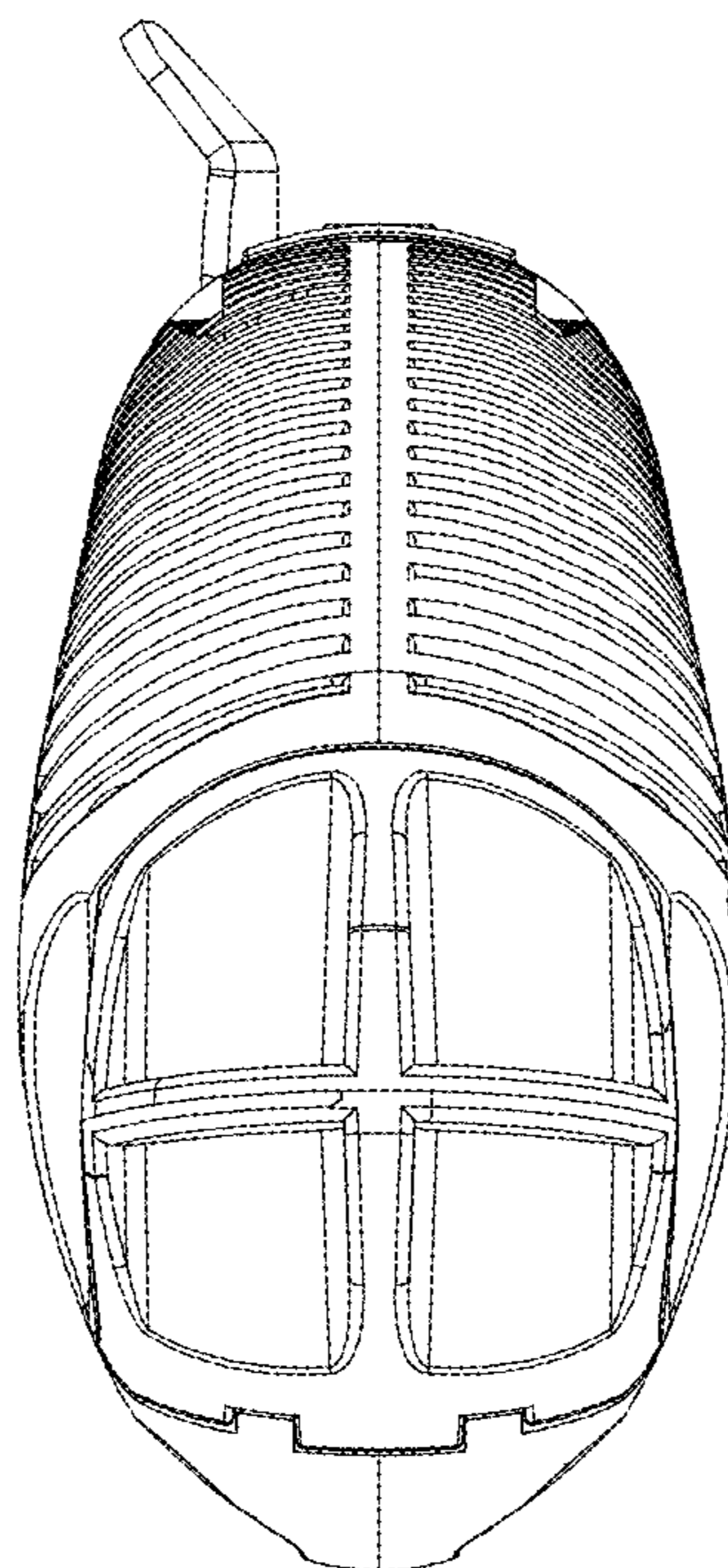
